## Large time o -equilibrium dynamics of a manifold in a random potential

We study the out of equilibrium dynam ics of an elastic manifold in a random potential using mean-eld theory. We not two asymptotic time regimes: (i) stationary dynamics, (ii) slow aging dynamics with violation of equilibrium theorems. We obtain an analytical solution valid for all large times with universal scalings of two-time quantities with space. A non-analytic scaling function crosses over to ultrametricity when the correlations become long-range. We propose procedures to test numerically or experimentally the extent to which this scenario holds for a given system.

The dynam ics of an elastic manifold in a quenched random potential is relevant for a large number of experimental systems. Examples are ux lattices in high—Tc superconductors [3], interfaces in random elds [4], charge density waves [5], dislocation in disordered solids [6], surface growth on disordered substrates [7]. The competition between elasticity and disorder produces a glass' state that may exhibit pinning, slow dynam ics and non linear macroscopic response (e.g., leading to zero linear resistivity in superconductors [8]). While there is a phenom enological picture based on scaling arguments (droplets) [3] no satisfactory analytical approach is available at present for the low-tem perature dynamics.

The statics of a d-dimensional elastic manifold embedded in a N dimensional space in the presence of a random potential was studied by Mezard and Parisi (MP) who applied a replica variational Gaussian approxim ation (Hartree) for N nite which becomes exact at N = 1 [9]. The replica symmetry breaking (RSB) solution captures some of the essential physics in nite N dim ension, such as sam ple-to-sam ple susceptibility uctuations [9,10], and predicts non trivial (Flory-like) roughness exponent . It allows for a theory [11] of the statics of the vortex glass state in superconductors relevant to experiments such as ux decorations. Other analytical approaches are based on RG methods [11{13] and it is as yet unclear whether they capture all the physics [14,15]. Despite the obvious interest of the static approach, it applies by construction to equilibrium (G ibbs m easure) properties, which may not hold for experimental times in a glassy system [16].

In this Letter we study, also within the Hartree approximation, the dynamics of this problem starting from a random con guration as in a temperature quench. We not that at low enough temperature there is an aging regime and that the system never reaches equilibrium. The correlation functions then depend not only on time dierences but also on the waiting time after the quench.

We obtain the two-time scaling with explicit space dependence, a new feature with respect to the mean-eld analytical results for glassy systems obtained so far [17{20]. Details will be presented elsewhere [21].

This treatment is exact for N = 1. At nite N it holds a priori only within the Gaussian variational ansatz. Whether the properties hold qualitatively for true nite N dimensional models cannot be answered analytically at present. The good qualitative agreement [17] of the MF dynamical analytical solution with experiments on spin glasses suggests that our results for N = 1 may be relevant for some systems related to the present model.

The main purpose of this Letter is to suggest, on the basis of the exact solution for in nite N , de nite predictions for the o -equilibrium dynamics which can be checked in numerical simulations and experiments. Our results provide a basis for a nite-N analysis. Remarkably, despite the system being out of equilibrium, some of the results of the replica calculation by MP,e.g., are shown to carry through to the dynamics, albeit with a different interpretation in terms of directly observable timedependent physical quantities.

The model of a manifold of internal dimension dembedded in a random medium of dimension N is described, in terms of an N component displacement eld , = (1; 2; :::; N), by the Hamiltonian [9]

is a m ass, which e ectively constraints the m anifold to uctuate in a restricted volume of the embedding space. V is a Gaussian random potential with correlations

W e consider the Langevin dynam ics

with h (x;t)  $(x^0;t^0)i=2T$  d  $(x^0)$   $(x^0)$   $(x^0)$ . We let the system evolve from a spatially translationally-invariant (STI) con guration at t=0. The system remains STI at subsequent times. We study the dynamics exactly for N! 1 and, for N nite, within the dynamical Hartree approximation which amounts to substituting V by an elective  $\hat{V}$  [9,20]. The equilibrium dynamics (a la Som polinsky [22]) was studied by K inzelbach and Homer for general d [23]. The case d=0 has been studied in Ref. [18] and an analytical solution at large time was given in Ref. [20].

also de ne the mean squared displacement D  $_{xx^0}(t;t^0)=1=N$   $h(\underline{(x;t)}\underline{(x^0;t^0)})^2i$  and the correlation  $B_{xx^0}(t;t^0)=1=N$   $h(\underline{(x;t)}\underline{(x;t^0)})(\underline{(x^0;t)}\underline{(x^0;t^0)})i$ . The brackets and overline represent the average over the thermal noise and the quenched disorder, respectively. The Fourier-transform  $B_k$  and  $R_k$  w.r.t. the space dierence x  $x^0$  are used below, and we denote with tilde equal space (x=0) two-time functions,  $B=\frac{1}{k}B_k$ .

A common choice is  $V(z) = (+z)^{\frac{1}{2}} = (2(1))$ . Short-range' (SR) correlations correspond to (1 d=2) > 1 and 'long-range' (LR) correlations to (1 d=2) < 1. The static solution [9] is characterized by two exponents: in the LR case, an ultram etric ansatz gives  $D_x^{\text{st}} = (-(x) - (0))^{\frac{1}{2}} = x^2$  with a roughness exponent  $L_R = (2 - d=2) = (1 + -)$  and a free-energy uctuation exponent. In the SR case a one step RSB ansatz gives  $S_R = (2 - d) = 2$ . Statistical rotational symmetry imposes in general E(x) = 2 + 2. The E(x) = 2 sine G ordon model is marginal and solved [11] by a one step RSB.

Aging. Let us describe the picture that emerges for large times and > 0. Equaltime quantities reach their asymptotic values which do not necessarily coincide with the equilibrium ones [17,21]. For two-time quantities we consider two dierent regimes of the times.

(i) A fler a large waiting-time  $t_w$ ,  $B_k$  (  $+t_w$ ;  $t_w$ ) rst grows with in a manner independent of  $t_w$ , from 0 up to the E dwards-A nderson parameter for the mode k de ned as  $b_k^1$   $\lim_{\, \mid \, 1} \, \lim_{\, t_w \, \mid \, 1} \, B_k \, ( \, +t_w \, ; t_w \, )$ . In this time regime the displacement is time-translation invariant (TTI); we denote it  $b_k^F$  ( ) =  $\lim_{t_w \, \mid \, 1} \, B_k \, ( \, +t_w \, ; t_w \, )$ . The response  $r_k^F$  ( ) =  $\lim_{t_w \, \mid \, 1} \, R_k \, ( \, +t_w \, ; t_w \, )$  satisfies uctuation dissipation (FDT)  $r_k^F$  ( ) = 1=(2T)@  $b_k^F$  ( ) ( ). The FDT-regime' is very much like an equilibration in a state, the manifold looks pinned with an elective mass  $\overline{M}$ , since  $b_k^1$  = (2T)=( $k^2+\overline{M}$ ) (for ! 0).

(ii) However, for all  $t_w$  and su ciently large ,  $B_k$  ( +  $t_k$ ;  $t_w$ ) continues to grow beyond  $b_k^1$  up to  $b_k^0$  lim  $_{!~1}$   $B_k$  ( +  $t_k$ ;  $t_w$ ). The growth of  $B_k$  now depends on  $t_w$ : the larger  $t_w$  the slower the motion of the system , it ages. Thus in this model pinning is a gradual process, the older the system the more pinned it is but it is not pinned forever. The aging time-regime is thus dened (for  $t_w$ ! 1) as the times such that  $B_k$  (+  $t_w$ ;  $t_w$ ) >  $b_k^1$ . We denote by  $b_k$  (+  $t_w$ ;  $t_w$ ) and  $t_k$  (+  $t_w$ ;  $t_w$ ) the displacement and response in the aging regime, where both TII and FDI are violated.

As regards the measurements of noise and susceptibility (i) corresponds to high frequencies while (ii) corresponds to low frequencies (scaling with the waiting time) such that noise and susceptibility depend on  $t_w$ . In a domain-growth process (i) corresponds to the fast thermal uctuations of the spins around their mean magnetisation while (ii) corresponds to the actual growth of the domains. An important measurable quantity is the susceptibility  $_k$  (t;t<sup>0</sup>) =  $_{t^0}^{t}$  dsR  $_k$  (t;s) of the mode k, i.e the total linear response to an external force of spatial modu-

lation k applied during the interval  $[t^0;t]$ . The results below in ply  $_k$  ( $t_w$  + ; $t_w$ ) = k  $^2$  F  $[k^2]_0$  ( $t_w$  + ; $t_w$ )] where  $_0$  ( $t_w$  + ; $t_w$ )  $^1$  is a running'e ective mass which exclusively depends on times through the local displacement,  $_0$  =  $_0$  [[b]], and goes to zero at large time separation . The typical internal distance  $[p]_0$   $[b]^1$  grows slower with as the age  $t_w$  increases.

We study ! 0 after the large-times limit. If one takes = 0 from the start, one must take into account di usion: B  $_{xx}$  (t;0)! 1 at large t since  $dkb_k^0 = 1$ . In addition to the aging regime de ned as t,  $t^0$ ! 1 with B  $_{xx}$  (t; $t^0$ ) xed, there is then a di usion regime where B  $_{xx}$  (t; $t^0$ )=B  $_{xx}$  (t;0) is xed [21]. Our results for B  $_k$  and R  $_k$  are expected to hold also at = 0 in the aging regime.

Generalization of equilibrium theorems, two-time scalings. Let us describe in more detail the aging regime as derived below. For large times, the precise manner in which TTI is violated is described by 'triangle' relations [17] involving any three times:

while the violation of FDT is given by:

where (2) means that  $X_k$  depends on the times only through  $B_k$  (t;t<sup>0</sup>). In order to complete this ansatz, we have to specify how  $f_k$  and  $X_k$  for dierent k are related to one another. This is done below in an algebraic manner, in plying no new hypotheses with respect to the d=0 case [17,20]. We not that

i.e. all k-m odes depend on times only through the dependence of one of them. Thus one can use any two-time function, e.g. B  $_{\circ}$  (t;t $^{\circ}$ ) or B  $^{\circ}$  (t;t $^{\circ}$ ) to parametrise the two-time dependence. We also show:

i.e. the values of all X  $_k$  are the same for times such that B  $_0$  takes the same value. We have also de ned X  $[5(t;t^0)] = r(t;t^0) = \theta_{t^0} \delta(t;t^0)$ . Eq. (4) implies that if X is time independent in the aging regime, then it takes the same value for all k. Hence, for the k-m ode susceptibility we have  $_k$   $(t;t^0) = _k$   $[k;_0$   $(t;t^0)]$ . These functional dependences are testable using two-time parametric plots. Their explicit forms for this model are determined below.

We not that: (i) in the FDT-regime  $B_k < b_k^1$ ,  $X_k [B_k] = 1 = (2T)$  (ii) in the aging-regime  $b_k^0 > b_k > b_k^1$  there are two distinct cases. For SR correlations  $X_k (b_k) = X$  and  $f_k$  has the form  $f_k (u;v) = \begin{vmatrix} 1 \\ k \end{vmatrix} (k (u) k (v))$ . This implies  $B_k (t;t^0) = k k (t) = k (t)$  where h(t) is increasing and independent of k. For LR correlations  $X_k (b_k)$  is a non-constant function of  $b_k$ . The function  $f_k$  is  $f_k (u;v) = m$  ax  $f_k (u;v)$ .

Form all solution for the spatial scaling. In order to extract the scaling properties of this model and to justify the above ansatz, we encode the correlation and response functions in the superspace order-parameter [25]. At the saddle point, using causality,  $Q_{xx^0}(1;2)$  reads

It is now easy to write the equation of motion for the order parameters, exact at the mean-eld level:

where B  $_{xx^0}(1;2) = Q_{xx^0}(1;1) + Q_{xx^0}(2;2)$   $2Q_{xx^0}(1;2)$ . Using space translational-invariance one inds that all fourier modes  $Q_k$  can be expressed in terms of the zero mode  $Q_{k=0}$   $Q_0$  through the operator relation:

This is (in an encoded notation) a scaling relation for the correlation and response functions involving the two times and spatial separation. Substituting Eq.(7) in Eq.(6) one can write a separate equation for each mode. Hence, we have mapped the problem of each  $B_k$  (t;t<sup>0</sup>),  $R_k$  (t;t<sup>0</sup>) into an elective d=0 problem with a complicated memory kernel [26]. Up to now we have made no approximations. A rest important result is that one can now solve numerically the equation for one of the modes and then recover the space dependence algebraicly from Eq.(7). The above property implies that an ansatz as in problem swithout space-dependence [17,20] applies to each mode  $B_k$  (t;t<sup>0</sup>),  $R_k$  (t;t<sup>0</sup>) and justimes Eqs. (1),(2).

Now, in the large time-limit any operator function  $F[Q_A]$  of an order parameter  $Q_A$  which can be parametrized by  $f_A; X_A$ , yields a new order parameter  $Q_B = F[Q_A]$  which can also, at long times, be parametrized in the same form with  $f_B; X_B$ . The explicit computation of  $f_B; X_B$  in term  $soff_A; X_A$  has been done in Ref. [19] and when applied to Eq. (7) yields explicit functional relations between  $Q_k, B_k$  and  $Q_0$  and, in particular, Eqs. (3),(4) for the components  $B_k, R_k$ .

One can extend this calculation to O (N) spherically constrained models by letting be a function of time and by imposing Q  $_{\rm xx}$  (1;1) = 1 for all t<sub>1</sub>.

Explicit calculations. We can now establish the large time equations in both regimes. In the FDT-regime  $r_k^F = x_F \ \theta \ b_k^F \ ($  ) with  $x_F = 1 = (2T)$  and one nds a single equation:

N eglecting the time derivatives in the lhs. of the full dynamical equations and integrating over the FDT regime (see [17,20]) one nds the equations for the aging regime:

At small ,  $b_k^F$  ( ) (1 exp (  $_k$  ))=(xA $_k$ ) with A $_k$  =  $k^2 + \overline{M}$  x $_F$  (0). When  $b_k^{int}$  1=(xA $_k$ ) there is a crossover to a slower regime where one can neglect the term s (d=d) and nd a power law behaviour:  $b_k^F$  ( ) =  $b_k^1$   $c(b_k^1)^2$  with determined by [23]:

Aging regime in short range models. Power law models are short range for >  $_{\text{c}}=$  2=(2 d) and d 2 W ith the ansatz X  $_k$  [b\_k (t;t^0)] = X Eqs.(9) and (10) reduce to a single equation for b\_k (t;t^0). One must have X =  $\overline{M}=(4V^0(\mathbb{S}^1))$ . As discussed above b\_k (t;t^0) =  $j_k^{-1}$  (h (t^0)=h (t)). Dening u = lnh (t) one has b\_k (t;t^0) = B\_k (u u^1) where 0 < u < 1 and B\_k (0) = b\_k^1 and B\_k (1) = b\_k^0. We obtain:

Rem arkably, this equation is form ally similar to Eq. (8) though in a completely dierent variable. Laplace transforming w.r.t. u one gets:

At the beginning of the aging regime u=1, we obtain  $B_k(u)=b_k^1-4V^0(6^1)(k^2+\overline{M})^2u$ , and thus for  $t^0=t$ :

At widely separated times u! 1 , the approach to  $b_k^o$  is described by a scaling form of  $k^2u$ :

Aging regime for long range models. These models are solved by the ultrametric ansatz  $b_k$  (t;t<sup>0</sup>) = max (b<sub>k</sub> (t;s);b<sub>k</sub> (s;t<sup>0</sup>)), which inserted in (9), (10) leads [21] to a single equation parametrized by B

after simple manipulations as in [20]. We have de ned  $\overline{M}$  [5] =  $4 \frac{R_{B_k^1}}{B} V^{00} (5^0) X^0 [5^0] dB^0$  and used (2)-(4). Taking a derivative w.r.t. B, using  $0 = K [b_k] = K^0 [5^0] b_k$ , dividing by  $K^0$  [5] and integrating over B, one gets:

It also implies the self-consistency condition  $1 = 4V^{00}(6)_{k}(k^{2} + M - M (6))^{2}$  which coincides with the marginality condition for the replicon. One also obtains

with  $a_d=(4-d)(4q)^{2=(4-d)}=2$ . This result, derived in a rather simple way, is form ally identical to the result of the statics [9] and is here shown to apply directly to the o-equilibrium dynamics. The self-energy of the statics [](u) is thus form ally identied with  $\overline{M}$   $\overline{M}$   $\overline{M}$ ).

One general prediction for the aging regime of manifolds is the existence of a scaling form for  $b_r(t;t^0)$  as a function of r and the two-times quantity  $b(t;t^0)$ :

which holds at large scales, ie large r and large, widely separated times. One has H [0] = 1. The Hartreem ethod yields a remarkably simple analytical form. Using 18 one nds [21]  $\theta_{\rm B}b_{\rm k} = 4V^{00}$  (5)= $(k^2 + (4V^{00}) c_{\rm d})^{\frac{2}{4-d}})^2$ , e.g in real space in d = 3 one has  $\theta_{\rm k}b_{\rm r} = \exp(V^{00}) (5) = (2)$ ).

In conclusion, we described, using the Hartree approximation, the features of aging of a manifold in a random medium. This provides a frame of reference for the analysis of data from experiments and simulations on realistic systems and will allow to determine in each case whether such a regime exists and up to what times.
