SpectralF bw, the Magnus Force, and the

Josephson-Anderson Relation

Abstract

We show that the spectral ow due to a moving vortex is identical to the phase slippage process, and conclude that its evaluation con rm s the results by the Berry's phase calculation of the M agnus force.

Consider a rectilinear vortex moving in a superconductor with a small velocity v_v relative to the background of the crystal lattice, both the Berry's phase[1] and the direct total transverse force [2] calculations lead to the M agnus force:

Here $_{s}$ is the super uid electron number density, $q_{v} = 1$ is the vorticity, and the vortex line is along the z-direction with the length L. The crystal lattice background of the superconductor is held at rest in the laboratory frame to avoid further complications. Looking from the point of view of the electron uid, a Fermi liquid, moving vortices cause phase slippages, generating a potential di erence. Therefore the electron uid also feels a force, corresponding to the measured electric eld. This process has been analyzed by Josephson [3] and Anderson [4]. Recently, it has been reanalyzed by the calculation of the spectral or mom entum ow in the electron uid [5, 6]. Since this spectral ow has a sign opposite to that of the M agnus force, one m ight be tempted to conclude that it cancels the M agnus force. The purpose of the present letter is to show that those two views of looking at the consequences of a m oving vortex are equivalent as the action-reaction forces. This equivalence m ust have been in plicitly contained in the literature, but it has not been explicitly stated yet. Instead, som e confusion still exists.[7, 8]

We start by studying the momentum ow in the electron uid due to a moving vortex trapped by a potential located at r_0 . The trapping potential can be arbitrarily weak, and just de nes the vortex position. The electron uid system is hom ogeneous other than this trapping potential, and the system of vortex-electron uid is translational invariant. The momentum ow in the electron uid due to the moving of the trapping potential, the moving of the vortex, is

Here the density matrix for the whole electron uid is governed by the equation $ih^{-}(t) = |\hat{H}; (t)|$, with \hat{P} the total momentum operator and \hat{H} the truncated Ham iltonian of the system : the lattice phonon induced e ective electron-electron interaction is treated as an attractive one, which gives arise to the superconductivity. One may include the lattice dynamics into the formulation. In this case, because the electron-lattice system consists of a clean superconductor, our following conclusion will remain unmodi ed. We externed that it can be evaluated near the vortex core by the spectral ow method and the results of the two calculations are equal as guaranteed by the momentum conservation law. We note that for a slow moving vortex, the adiabatic condition holds: At a given time the density matrix \hat{h} of the electron uid system can be approximated by its instantaneous equilibrium density matrix \hat{h} and the deviation $\hat{h}_1: \hat{h} = \hat{h} + \hat{h}_1$. Here \hat{h}_1 is determined by the equation $|\hat{H}; \hat{h}_1| = ih\hat{h}_0$, and

with $f_n = e^{E_n = k_B T} = ne^{P_n} e^{E_n = k_B T}$ the normalized Boltzmann factor and n the n-th eigenstate of the H am iltonian. The eigenenergies $fE_n g$ are independent of time. The time dependence of the density matrix is through the vortex position dependence of the wavefunction. Then we have, to the lowest order in the vortex velocity,

Here the operator r_{r_0} is the gradient with respect to the vortex position, and $v_v = \underline{r}_0$. Since the vortex position, or the position of the trapping potential, is the only reference point in the electron uid system, we have the identity

with r_j the position of the j-th electron in the system. Note that the total momentum operator is $\hat{P} = i \hat{P}_j r_{r_j}$ in r_R , Eq.(4) gives us

Following the same procedure as in Ref.[2], we rst reduce the N-body density to the onebody density matrix $_1$:

and N the total electron number. Then we use the Stokes' theorem to evaluate the integral far away from the vortex core, and obtain

which shows that the force felt by the electron uid has the same magnitude as the M agnus force, but with the opposite sign. We will return to this point below. In the integration leading to Eq.(9) we have used the fact that the integrand is the momentum density. The two-uid model has been employed to account for the fact that the momentum generated by the vortex corresponds to a supercurrent. The momentum ow calculation can also be performed near the vortex core by counting the ow of the energy spectrum, the so-called spectral ow method, and have been done in Ref.[5]. Them ain idea is that, by linearizing the tim e-dependent B ogoliubov-de G ennes equation near the Ferm i surface, a pseudorelativistic D irac equation will be obtained. This linearization reduces the original 3+1 dimensional problem to an elective 1+1 dimensional one. As a vortex moves, there is a continuous ow of the energy spectrum, emerging from (or sinking into) the Ferm isea. The spectral ow rate is proportional to the vortex velocity. By counting their contributions to the momentum, the same result as Eq.(9) has been arrived at in Ref.[5]. This procedure has been further veri ed by a model calculation.[8] The agreement between two seem ingly totally dierent ways, looking from a safe distance away from the core and watching the spectral ow near the core, of calculating the momentum ow may rst appear surprising. It has been, however, explicitly demonstrated in Ref.[9] in a slightly dierent context in the ³He-A phase that they are indeed the complementary two ways of keeping track of the same physics, and they are equal as a result of the momentum conservation in the electron uid system. In the present situation the link between those two ways has been discussed in Ref.[6]. It is the dierential form of the momentum ow :

with the electrochem ical potential as the sum of the chem ical potential $_{0}$, the uid kinetic energy and the electric potential $= _{0} + \frac{m}{2} v_{s}^{2} + e (+ \frac{1}{c} \frac{\theta}{c} R_{r} dr^{0} A (t;t))$, and the super uid velocity distribution m $v_{s} = hr$ $\frac{e}{c}A$. Here m and e are elective mass and charge of a Cooperpair, respectively, and is the phase of the superconducting condensate wavefunction. Eq.(10) is gauge invariant, and is a precise statement about the phase slippage process due to a moving vortex. Its various consequences have been explored by Josephson[3] and Anderson [4]. An identical equation for the special case of $v_{v} = v_{s}$ in the neutral super uid has been studied by Anderson [4]. We may call Eq.(10) the Josephson-Anderson relation.

It is clear now that a moving vortex feels a transverse force, the M agnus force; if one looks from the point of view of the electron uid, the uid also feels a force with the magnitude equal to but the sign opposite to the M agnus force. The two forces are acting on two di erent objects, the vortex and the electron uid, and are the action-reaction forces. In the following

we strengthen this point by a straightforward proof.

Wewrite Eq.(2) in its equivalent form of the Ehrenfest theorem :

This shows that the two forces under discussion are indeed the action-reaction forces. In the last equality we have used the form alde nition of the M agnus force [2].

The present result, the equivalence between the M agnus force and the spectral ow as action-reaction forces, m ay seem obvious. Nevertheless it has never been explicitly spelled out in the literature. Instead, some recent work have treated the spectral ow as a way to cancel the M agnus force [5, 7, 8], which is incorrect according to the present demonstration. It should be pointed out that the spectral ow is a counting of contributions from extended states. There is no involvement of the localized core states. This can be explicitly checked by expressing the one-body density matrix in Eq.(9) in terms of extended and localized states, and latter gives zero contribution, as having been noted in Ref.[2] in the evaluation of the M agnus force. Incidentally, in Ref.[5] the W ess-Zum ino term for a moving vortex has been identied as the same force as the one due to the spectral ow. Recent as well as earlier work have shown that the W ess-Zum ino term gives exactly the M agnus force [10, 11, 12, 6], not the spectral ow .

C om paring the Berry's phase calculation away from the vortex core with the spectral or m om entum ow counting near the vortex core, we nd that the form er only depends on a few global properties of a superconductor, namely the topology of a vortex, and the latter is a rather detailed calculation. The topological constraints behave like conservations laws. Results obtained under them should, and have to, be borne out by detailed calculations, which are concrete realizations. For the M agnus force, it is indeed the case.
