# E ect of Anisotropy on the Localization in a B ifractal System

#### Abstract

Bifractal is a highly anisotropic structure where planar fractals are stacked to form a 3dim ensional lattice. The localization lengths along fractal structure for the A nderson $m$ odel de ned on a bifractal are calculated. The critical disorder and the critical exponent of the localization lengths are obtained from the nite size scaling behavior. The num erical results are in a good agreem ent w ith previous results which have been obtained from the localization lengths along the perpendicular direction. This suggests that the anisotropy of the em bedding lattice structure is irrelevant to the critical properties of the localization.

R ecently, there has been much attention [1][6] to the critical properties of the localization in anisotropic system. For a 3-dim ensional cubic system w ith anisotropic hopping $m$ atrix, it seem $s$ now that there is a general agreem ent [6] that both the critical disorder ( $\mathrm{W}_{\mathrm{c}}$ ) and the critical exponent ( ) of the localization length are independent of direction of $m$ easurem ent and that such $m$ odel belongs to the universality class of the isotropic A nderson model.

On the other hand, bifractals [7,8] are constructed by stacking planar fractal lattioes along the $z$-direction so that they are of Euclidean structure only in the $z$ direction. A nisotropy in these system $s$ arises from the lattice structure itself. T herefore, it is by no $m$ eans obvious whether the critical properties obtained from the localization lengths along the xy-plane ( $x y$ ) are the sam e as those from the localization lengths along the $z$-axis $(z)$. There is a possibility that even a mobility edge, one of usefulconcepts in the localization theory, $m$ ay not exist in this intrinsically anisotropic system .

Therefore, in this Report, we study the critical disorder and the critical exponent along fractal structure, i.e. along the xy-plane, for a bifractal system. O ur results are in excellent agreem ent w ith those obtained from
$z^{\prime}$ 's, which have been reported in previous studies 80,9$]$, suggesting that the anisotropy of the em bedding lattioe structure is irrelevant to the critical properties of the localization. In our study, one of the bifractals introduced in the Ref. [8] is used as the m odel. We consider the A nderson H am iltonian gíven as
where the random site energies $i$ are chosen from a box distribution of $w$ idth $W$. The hopping energies $V$ are set to 1 throughout this work and hi; ji denotes the sum over nearest neighbor pairs of sites on the bifractal lattice. In Fig. 1 (a), the lattice is schem atically depicted. $T$ he cross section perpendicular to the $z$-axis is a variant of the Sienpinski gasket and $L$ is the num ber of the fractal lattices that have been stacked. The num ber of the iteration processes for the fractal lattice is denoted by $n$,
e.g. $n=2$ for $F$ ig. 1 (a). $T$ his is exactly the $m$ odel called as the B ifractal I in the Ref. [8]. The G reen's function coupling tw o comer sites of the largest triangle, $r$ and $r^{0}$, is denoted as $\mathrm{Gr}_{\mathrm{r} \mathrm{r}^{0}}(\mathrm{n} ; \mathrm{L})$. T hen the localization length along the $x y$-plane, $x y(L)$, can be de ned as follow s;

$w$ here $r$ and $r^{0}$ have the sam e $z$-coordinates.
$T$ hem ain point of the calculation is to $n d G_{r ; r^{0}}(n ; L$ )' $S$ for su ciently large value of $n$, which $m$ eans that one should calculate elem ents of the inverse of a very large random matrix, ( $E$ H). This is essentially the same problem as encountered in the transfer $m$ atrix $m$ ethod for quasi-1-dim ensional system s 10]. H ow ever a di erent recursive algorithm should be devised since we are considering a \quasi-2-dim ensional system ".

O ne can handle the problem by decim ating recursively the am plitudes of the sites characterized by the largest iteration num ber, as shown in Fig. 1 (b). Follow ing schem e is for the case of $L=1$ but the extension of the $m$ ethod for $L \quad 2$ is straightforw ard. Let $x(y)$ be a vector the elem ents of which are the am plitudes of the sites represented by the solid (em pty) circles in Fig. 1 (b). Then a $m$ atrix equation for $x$ and $y$ can be constructed in the form,

where $H_{x}(E) ; H_{y}(E)$ and $V_{X y}(\mathbb{E})$ are $m$ atrioes and contributions from rem aining sites other than shown in $F$ ig. 1 (b) are contained in a vector $z$. The vector 0 in the right hand side of Eq. (3) represents the fact that $y$ is directly coupled only $w$ ith $x$. In itially, when the sites have been indexed as in Fig. 1 (b), the explicit form $s$ of the three $m$ atrices are as follow s; (i) $H_{x ; i j}=i j\left(E \quad x_{i}\right)$, (ii) $\mathrm{H}_{\mathrm{y} ; \text { ii }}=\mathrm{E} \quad \mathrm{y}_{\mathrm{i}} ; \mathrm{H}_{\mathrm{y} ; 12}=\mathrm{H}_{\mathrm{y} ; 21}=\mathrm{H}_{\mathrm{y} ; 13}=\mathrm{H}_{\mathrm{y} ; 31}=$ $\mathrm{H}_{\mathrm{y} ; 25}=\mathrm{H}_{\mathrm{y} ; 52}=\mathrm{H}_{\mathrm{y} ; 34}=\mathrm{H}_{\mathrm{y} ; 43}=\mathrm{H}_{\mathrm{y} ; 46}=\mathrm{H}_{\mathrm{y} ; 64}=$ $\mathrm{H}_{\mathrm{y} ; 56}=\mathrm{H}_{\mathrm{y} ; 65}=\mathrm{V}$ and $\mathrm{H}_{\mathrm{y} ; \mathrm{ij}}=0$ otherw ise, (iii) $\mathrm{V}_{\mathrm{XY} ; 11}=\mathrm{V}_{\mathrm{XY} ; 12}=\mathrm{V}_{\mathrm{XY} ; 23}=\mathrm{V}_{\mathrm{Xy} ; 24}=\mathrm{V}_{\mathrm{Xy} ; 35}=\mathrm{V}_{\mathrm{Xy} ; 36}=$
V and $\mathrm{V}_{\mathrm{xy} ; i j}=0$ otherw ise. Elim inating the am plitudes of the intemal sites, i.e. $y$, we get

By perform ing the decim ation process ofE $q$. (4) for every triangle consisting of nine sites, the num ber of the whole eigenvalue equations reduces by a factor of three. T he 33 m atrix in the left hand side of Eq. (4) de nes the renorm alized hopping energies $w$ thin the sm allest triangles of the new lattioe and the renorm alized on-site term $s$. Since the hopping energies are m odi ed only within the sm allest triangle one can cast the $m$ atrix equation for the rem aining sites again in the form of Eq. (3). It should be also noted that at the rst step of the iteration, the elem ents of $V_{X Y}$ are independent of E as can be seen from iii), while after the decim ation process, i.e. Eq. (4), they becom e functions of E , in general. Therefore, the problem hasbeen reduced to another eigenvalue equation problem on the Sierpinskigasket w ith the iteration num ber sm aller than the original by 1 . N ow we can iterate the above procedure until 3 linear equations for the am plitudes of the 3 outerm ost sites are left in case of $L=1$. For general L, we have 3 L linear equations instead of 3 . T hen the inverse of the $m$ atrix constructed by the coe cients of the am plitudes is the $G$ reen's function for the outerm ost sites.

In principle, this algorithm can be iterated in nitely. H ow ever, one of the technicalproblem sin realcalculation is that som eo -diagonalelem ents of the $m$ atrix becom es very sm all com pared with, say, O (1) diagonal elem ents, as the iteration proceeds. In general, these sm all ele$m$ ents contain the essential in form ation for our problem since they are directly related to the G reen's function connecting two di erent sites far aw ay from each other. For exam ple, let's assume that the localization length is of order unity and the distance betw een two sites is, say, 1000 (lattice constant). Then the $G$ reen's function connecting the two sites is of order e $1000 \quad 10{ }^{430}$ while the diagonalelem ents of the $G$ reen's function are of order unity. Therefore one is investigating an asym ptotic behavior of vanishingly sm all m atrix elem ents while the order of $m$ agnitudes of som $e$ other elem ents of the $m a-$ trix is far $m$ uch larger than them. D irect $m$ anipulation of such $m$ atrix leads to loss of inform ation on the sm aller elem ents. O ne of possible techniques to overcom e this di culty is to decom pose the $m$ atrix into two parts as

where the $m$ atrix elem ents ofboth $A_{0}$ and $A^{0}$ are within the range safely handled by com puters. is a num ber and should be $m$ odi ed whenever the $m$ atrix is $m$ anipulated. W hen a m atrix is decom posed as the above, the inverse of the $m$ atrix can be calculated by the form ula

For our calculation, it tums out to be su cient to retain term $s$ up to second order in e.

W e calculate $\mathrm{xy}_{\mathrm{y}}(\mathrm{L})$ 's for $\mathrm{E}=0$ and several values of W in the range 4:0 W 9:0. In our calculation, the Sienpinski gasket w ith $\mathrm{n}=11$ ( $3^{12}$ sites/cross section) is used and $L$ is varied within the range 3 L 15. For a given set of param eters, con gurational averages are perform ed over 470 di erent realizations to control the uncertainty of $x y(L) w$ thin $1 \%$. Periodic boundary condition is im posed in the $z$-direction. The results are show $n$ in $F$ ig. 2. A sL increases, the renom alized localization length, xy ( $L$ ) $=\mathrm{L}$, increases for sm aller values of $W$, while for larger values it keeps decreasing. This im plies that in the $m$ acroscopic lim it, i.e., L! 1 , there exists a transition from an extended state to a localized state as $W$ varies, e.g., from 5.0 to 6.0. Estim ates of ${ }_{c}$ and are obtained by tting the data to the scaling form

$w$ here $a$ and $b$ are constants. Several sets of data for 4:5 W 7 and 7 L 15, have been tted to the equation (7) and nally we get $W_{c}=5: 79 \quad 0: 04$ and
$=2: 92 \quad 0: 14$. The errors are the dispersions betw een di erent sets of data. The scaling plot $w$ ith these values is shown in $F$ ig. 3. O ur num erical results are in good agreem ent w ith those obtained from the analysis of $z^{\prime}$ 's, i.e. $W_{c}=5: 8$ and $=3: 0$ 0:2 9] for the sam e m odel. $T$ his supports the idea that $W_{C}$ and are independent of the direction ofm easurem ent for this bifractal system.
$T$ hat $W_{c}$ 's are the sam e along the two directions indicates that there exists a well-de ned mobility edge in spite of the intrinsic anisotropy in this $m$ odel. In addition we can expect that the anisotropy is irrelevant to the localization transition in a som ew hat strong sense, that is, the critical properties of the localization is insensitive not only to the anisotropy in the energy param eters but also to that of the em bedding lattice structure.
