# In uence of D islocations in $T$ hom son's P roblem

#### Abstract

W e investigate $T$ hom son's problem of charges on a sphere as an exam ple of a system w ith com plex interactions. A ssum ing certain sym m etries we can work w ith a larger num ber of charges than before. W e found that, when the num ber of charges is large enough, the low est energy states are not those w ith the highest sym m etry. A s predicted previously by D odgson and M oore, the com plex pattems in these states involve dislocation defects which screen the strains of the tw elve disclinations required to satisfy Euler's theorem.


## I. IN TRODUCTION

The properties of real system s are often determ ined by a large num ber of interacting entities. Progress in understanding such system s relies on the astute com bination of analytical and num erical tools. This paper presents num erical studies on $T$ hom son's problem for num bers of particles m uch larger than have been studied in the past. Thom son's problem is to nd the low est energy of N C oulomb charges distributed on the surface of a unit sphere. A though the problem is simple to state, its solution is non-trivial, and num erical $m$ eans are required to treat the intenplay of frustration $w$ th ordering [国]. On a local scale, the charges are best distributed as a triangular lattice with six neighbours to each charge. O ver the whole sphere, how ever, Euler's theorem dictates that there m ust exist tw elve disclinations| charges with only ve nearest neighbours.

The problem ofconstructing a lattioe-like structure over a spherical surface has attracted attention in other contexts. A m odelw ith a sphericalgeom etry ofa tw o-dim ensionalelectron system in a perpendicular magnetic eld has been used to study the quantum H all e ect [5] and vortioes in a thin- $m$ superconductor [6[8]. The magnetic eld is due to a D irac $m$ onopole at the centre of the sphere. U sing num erical work on this model for vortioes, along w ith the continuum elasticity theory of topological defects on a curved surface (see Ref [9]), 这 was claim ed in Ref [8] that inchuding additional defects to the necessary tw elve disclinations could lower the energy of con gurations on the sphere. These defects are dislocations (essentially bound pairs of vefold and sevenfold disclinations) w ith a particular orientation. This im proved on the work of Ref []] where only the twelve disclinations were included, w th the result that the energy per particle of a lattice on a sphere was greater than for a at plane even in the therm odynam ic $\lim$ it of N ! 1 , because of the long range strains associated w ith the disclinations. The inclusion of dislocations allow the sam e therm odynam ic lim it to be recovered, as they $m$ ay screen these long range strains.

The continuum elasticity theory allow s the num ber of degrees of freedom to be reduced from the total num ber of particles to the num ber of disclination and dislocation defects.

Follow ing Ref 置］，if we consider the twelve disclinations to be xed at the comers of an icosahedron，the total elastic energy $\mathrm{E}_{\text {tot }}$ of the system can be w ritten as

where $\mathrm{E}_{12}$ is the interaction and selfenergy of the tw elve disclinations， $\mathrm{E}_{\mathrm{d}}$ is the selfenergy of a dislocation and the disclination \｛dislocation and dislocation \｛dislocation pairw ise inter－ actions are given by $\mathrm{E}_{\text {sd }}$ and $\mathrm{E}_{\mathrm{d}^{0} \mathrm{~d}}$ respectively．These energies vary in a non \｛trivialm anner $w$ th the ratio $R=l_{0} / N^{1=2}$ ，where $R$ is the radius of the sphere and $l_{0}$ is the $m$ ean lattice spacing．Sum $m$ ing up the results of 目］， $\mathrm{E}_{\text {sd }}$ increases m ore rapidly w th N than the self energy and the dislocation \｛dislocation energy．Depending on the orientation，it m ay also be negative so that dislocations could lower the total energy of the system．The energy landscape of a single dislocation has minim a along the lines that join the disclinations．

The values of $N$ w ith the $m$ ost stable ground states are those which are com patible w ith ioosahedral sym $m$ etry［7］．The structures of proteins（capsom eres）in the shells（capsids）of spherical vinuses are know $n$ to display icosahedral sym $m$ etry［1］，and it was in this context that these com patible num bers were predicted．Each possible structure is de ned by the translations along the triangular lattice vectors between each disclination（hf；kf），which gives a $\backslash \mathrm{m}$ agic＂num ber of $\mathrm{N}=10 \mathrm{P} \mathrm{f}+2$ particles where $\mathrm{P}=\mathrm{h}^{2}+\mathrm{k}^{2}+\mathrm{hk}$（ h and k are integers $w$ ithout com $m$ on factors，$f$ is an integer，and $P f$ is the triangulation num ber denoted by $T$ in the literature）11，12］．The sam e num bers and structures observed in nature （in particular $\mathrm{N}=72$ and 132）were found in the num erical work of $R$ ef 0 ］，and are also found in Thom son＇s problem．

A s T hom son＇s problem involves a sim pler interaction than the model of vortioes over a sphere，we have chosen it for num erical studies of ground states on a sphere with large $N$ ． B oth the num erical and analytical results of $R$ ef 置］suggested that sizes w ith N of order $10^{3}$ $m$ ust be reached before the dislocations $w$ ill be energetically favourable．This explains why they have not been seen in previous work on Thom son＇s problem，which has concentrated on nding the ground states for sm aller system sizes to very high accuracy． W e will not be
so concemed w ith locating the absolute ground state, but rather we will look for the general features of the low energy con gurations, especially the in uence ofdislocations on the total energy.

## II. NUMERICALMETHOD

To treat system s of charges w th $\mathrm{N} \quad 10^{3}$, a di erent approach is developed from earlier work on $T$ hom son's problem . The highest num ber used in this problem before was $\mathrm{N}=200$ using a genetic algorithm [7]. To reduce the num ber of degrees of freedom, we im posed certain sym m etries on the system : vefold rotational symmetry about a given axis and a tw ofold rotational sym $m$ etry about a penpendicular axis (these are sym $m$ etries possessed by an iossahedron). To do this, we rst keep two charges xed on the poles of the sphere. We then im pose the sym metries by placing clusters of ten charges, represented by $\mathrm{f}_{\mathrm{i}}$; i 9 , at the polar coordinates ( $i ; i+n \frac{2}{5}$ ) and ( $\quad i ; \quad i+n \frac{2}{5}$ ) for $n=0 ; 1 ; 2 ; 3 ; 4$.

The energy $\mathrm{E}_{\mathrm{T}}$ of the system is given by the relation

$T$ he rst term is the potentialenergy of the two charges on the poles (alw ays equal to $\frac{1}{2}$ for a unit sphere; the potential energy of two unit charges separated by a distance $d$ is given by $1=\mathrm{d}$ ), the rst sum is the potentialenergy of each cluster w ith the poles, the second sum is the potential energy of the charges in the sam e cluster and the last term is the energy of interaction of clusters $w$ th each other, where $N_{c}=(\mathbb{N} \quad 2)=10$ is the num ber of clusters. This reduction of the degrees of freedom by approxim ately a factor of ten allow s Thom son's problem to be tractable for thousands of charges.

It has been found num erically that the num ber ofm etastable states M increases w ith N as 13$]$
although this num ber $m$ ay be reduced som ew hat by the restrictions of sym $m$ etry we have im posed. A sw th the num ber ofchargeswe are considering, $M$ is extrem ely high, the num erical optim ization routine with arbitrary initial conditions $w$ ill only nd m etastable states, and give little inform ation on the properties of the ground state. To avoid useless searching of con guration space, we distribute the charges in som e strategic initial con gurations before allow ing them to relax.

In the relaxation process we em ploy an algorithm very sim ilar to that used by Erber and H ockney [] but we do not sim ply $m$ ove the charges in the direction of the electrostatic force. Instead each charge is $m$ oved to $m$ new places around the original position which lie on a cone of angle angle whose axis is the direction of the electrostatic force and the position w ith lowest energy is selected as the new position if its energy is lower than the original energy. If all of the $m$ places have a higher energy than the original the charge is not $m$ oved. We use $m=6$, having checked that the increase of this param eter does not change the results. W hen no charges can be m oved, the angle is decreased and the process is repeated. The program nishes when the energy reduction for every charge is less than a given num ber. Decreasing the size of that num ber increases the accuracy to which one know s the energy of the nal state.

## III. RESULTS

First, we have calculated the energy of the system swith 4002 and 5882 charges (w hich correspond to $T=400$ and $T=588$ ) w ith full iossahedral sym m etry, (see $F$ igure 1 for the case of5882 charges). W e then perturbed the initialcon guration by displacing som echarges on the line that join two disclinations. A fter relaxation, we found that the new states have less energy than those w ith full sym $m$ etry. W e can observe the appearance of dislocations in $F$ igure 2. To understand what is happening, note that charges aw ay from dislocations are in a less strained environm ent than in the case of the ioosahedral con guration.

W e have also calculated the energy for $\mathrm{N}=2132$ and 5792, w ith a special initial con-
guration. In this special con guration, we place the dislocations in a sym m etric fashion. W e put 5p (p an integer) dislocations around each disclinations on the lines that join disclinations (i.e. we put a total of 12 5p dislocations, gee gure 3) and let the system relax. W ith this initial con guration we obtain a new set of pseudo \{m agic num bers. $W$ e call them pseudo\{m agic as they $m$ ay not have ground states of lower energy than other num bers, but they do have the possibility of arranging the dislocations sym $m$ etrically. In $F$ igure 4 we show the nal state obtained after relaxation. $W$ e see that $w$ ith these system sizes, the disclination \{dislocation interaction energy is not clearly dom inant and the repulsion betw een dislocations is large enough to push the dislocations aw ay from the line that joins disclinations. W hile the system was relaxing the charge con guration was observed, and we could see how dislocations m oved over these lines. The pattems form ed by the dislocations $m$ ay be com plex, but the results predicted by D odgson and M oore 㔽] are seen to be em erging as N increases. W th larger system s we suspect that the dislocation-disclination energy w ill dom inate so that the lines of dislocations w ill becom e straighter.

## IV.CONCLUSIONS

In this work, we found that the $m$ ost sym $m$ etric states are not those $w$ ith low est energy in Thom son's problem for large system sizes. This is because the introduction of additional topologicaldefects| dislocations| reduces the strain energy aw ay from the disclinations, and the interactions between these defects allow s for com plex pattems. O ur results should be valid for spherical system $s$ w ith di erent interactions betw een the particles. For exam ple, if spherical viruses exist w th m uch larger num bers of protein units on the surface than has been found to date, sim ilar pattems w ith dislocations should be present or the surface would be forced to deviate from that of a sphere. D islocations in carbon nanotubes also play an im portant role as they determ ine their radius and helicity, and therefore control the electrical and $m$ echanical properties of these new $m$ olecules 14,15].
