## Pauli susceptibility of $A_{3}C_{60}$ (A = K, Rb)

The Pauli param agnetic susceptibility of  $A_{3}C_{60}$  (A = K, Rb) compounds is calculated. A lattice quantum M onte C arlo m ethod is applied to a multi-band Hubbard model, including the on-site C oulom b interaction U. It is found that the many-body enhancement of the susceptibility is of the order of a factor of three. This reconciles estimates of the density of states from the susceptibility with other estimates. The enhancement is an example of a substantial many-body e ect in the doped fullerenes.

The Pauli param agnetic susceptibility is interesting for several reasons. Firstly, is enhanced by many-body e ects relative to its value  $_0$  for noninteracting electrons, and  $=_0$  is one measure of the strength of the many-body e ects in the system. In the alkali-doped C<sub>60</sub> com pounds, A<sub>3</sub>C<sub>60</sub> (A = K, Rb) the C oulom b interaction U between two electrons on the same m olecule is large<sup>1</sup> com pared with the width W of the partly led  $\xi_u$  band, with typical estimates U=W 1:5 2:5.<sup>2</sup> In view of this large ratio, one expects very strong many-body e ects for these system s. Up to now, how ever, there seem s to be no unam biguous signature of such strong e ects.

Secondly,  $_0$  is related to the density of states N (0) at the Fermi energy, and values of N (0) can be extracted if the enhancement = 0 is known. N (0) is from in portant for the superconductivity and the electronphonon interaction , since theoretical calculations give =N (0), while som e experim ental (e.g., neutron<sup>3</sup> and Ram an scattering<sup>4</sup>) estimates give N (0) and others (e.g., photoem ission from  $C_{60}$  molecules<sup>5</sup>) give =N (0). The estimate of N (0) is therefore crucial for obtaining values of and for our understanding of the superconductivity. Typically, for K<sub>3</sub>C<sub>60</sub> band structure calculations give N (0) 6 9 states/ (eV -spin).  $^{611}$  E stim ates based on the speci c heat and the NMR relaxation rate give N (0) 5 6 states/ (eV -spin)<sup>12</sup> and N (0) 7:2 states/(eV-spin),<sup>13</sup> respectively. On the other hand, much larger values N (0) 10 16 states/ (eV-spin) for  $K_{3}C_{60}$  are deduced from the susceptibility  $I^{14}$  if m anybody e ects are neglected. A substantialm any-body enhancem ent (factor 2-3) for the susceptibility,  $^{14}$  could essentially reconcile these rather di erent estimates. On the other hand, density functional calculations in the localdensity approximation (LDA) nd that the enhancement is only about a factor of 1.3-1.4.13 W e note that N (0) here refers to densities of states de ned in som ewhat di erent ways depending on the experiment, as discussed below.

We have used a lattice quantum M onte Carlo  $m = 10^{13}$ ;<sup>2</sup> for calculating the Pauli susceptibility for a

multi-band Hubbard model of the system. For a sm all system with four C  $_{60}$  m olecules, we demonstrate that this method gives an accurate enhancement of the susceptibility. For realistic values of the parameters, the susceptibility is enhanced by about a factor of three, which essentially reconciles estimates of N (0) based on the susceptibility with other estimates.

In the presence of a small external magnetic edd H, the energy of the system can be written as

where M  $_B$  (N  $_{"}$  N  $_{\#}$ ) is the magnetic moment of the system, with  $_B$  being the Bohr magneton and N the number of electrons with spin  $. E_0$  (M) is the energy of the system with a moment M in the absence of an external eld. M inimizing the energy with respect to M, we obtain the susceptibility

In the following we therefore calculate  $E_0(M)$  for the interacting and noninteracting (U = 0) systems, from which we obtain the many-body enhancement =  $_0$ .

W e use a multiband Hubbard model of the A  $_3C_{\,60}$  compounds

where the  $\,$  rst term describes the three-fold degenerate  $t_{1u}$  states on the sites i and with orbital (m) and spin () indices. The second term describes the hopping between the sites, and the third term describes the Coulomb on-site interaction. Multiplet e ects and the electron-phonon interaction have been neglected. In  $A_{\rm 3}C_{\rm 60}$ , the  $C_{\rm 60}$  m olecules are preferentially in one of two possible orientations in an essentially random way.  $^{19}$  W e

take this into account by having a large cell, where each molecule takes one of the two preferred orientations in a random way, and the hopping matrix elements between two molecules take into account the orientations of these two molecules.<sup>20;21</sup>

To calculate the energy of the model in Eq. (3), we use a T = 0 projection lattice M onte C arlo m ethod, introduced by ten H aaf et al.<sup>18</sup> In this m ethod a trial function is constructed from a Slater determ inant, using a G utzw iller Ansatz.<sup>22</sup> An approxim ate ground-state is then projected out in a di usion M onte C arlo (DMC) approach, using a  $\setminus$  xed node" approximation. This m ethod has been used to study the condition for a M ott-H ubbard transition in A<sub>3</sub>C<sub>60</sub>.<sup>2</sup>

To test the accuracy of the DMC approach, we have rst applied the method to a cluster of four  $C_{60}$  m olecules. This cluster is so small that we can also obtain the exact solution for the model in Eq. (3), using exact diagonalization. We then calculate the coe cient

in Eq. (1) by considering the energy for N  $_{*}$  N  $_{\#}$  = 0 and 2. The DMC and exact results are compared in Table I. W e can see that the DMC m ethod is quite accurate in this case, and if a sim ilar accuracy is obtained for larger system s, it is quite su cient.

The enhancement of the susceptibility is sensitive to the density of states (DOS) close to the Ferm ienergy  $E_F$ . For smalland intermediate size clusters of  $C_{60}$  m olecules, the DOS depends on the orientations of the molecules, while for large clusters the DOS rapidly converges. Since we can only treat intermediate size clusters (32 64) molecules) in DMC, we have therefore chosen orientations which in a one-particle approximation give similar DOS close to  $E_F$  as for very large clusters.




FIG.1. The energy as a function of N  $\cdot$  N  $_{\#}$  M relative to the energy for M = 0. Second order curves have been tted to the energies. Results for U = 0, 0.5, 1.0, 1.5 and 2.0 eV are shown. The calculations are for 32 m olecules and the energy is in eV.

In Fig. 1 we show results for the total energy as a function of M N \* N \* for di erent values of U. The results can be rather well tted by parabolas, although the precise parameters of the parabolas have a certain dependence on the range of M considered. From these slopes we can immediately deduce values of the enhancement  $_0$  = is shown. It is immediately clear that the enhancement grows with U and that would diverge for U a bit larger than 2 eV, if no other transition (e.g., antiferrom agnetic) happened before. E stim ates of U are typically in the range 1–1.5 eV, giving an enhancement of the susceptibility by about a factor of three. Qualitatively

sim ilar results have been obtained for a Hubbard model without orbital degeneracy and in the limit of in nite dimensions.  $^{26}$

W ithin the Hartree-Fock approximation, the susceptibility behaves as

where the factor three comes from the three-fold degeneracy and N (0) is the density of states per spin, which here is about 5.5 states/ (eV-spin). Here we have assumed that the three orbitals are equivalent. The DMC results show a similar behavior, but with a prefactor in front of U, which is between a factor of four and ve times smaller. This large change in the prefactor illustrates the importance of correlation in these system s.

To deduce N (0) we need to know the Pauli (param - agnetic) susceptibility. M easurements using a SQUID m ay also contain a diam agnetic contribution, while EPR m easurements do not. In Table II we show various experimental results converted to N (0). From the SQUID results, diam agnetic contributions estimated by the respective authors have been subtracted, but the many-body enhancement has not been considered. We can see that the results range between 10 and 16 states/ (eV-spin). If we consider a many-body enhancement of a factor of three, as deduced above, these results would be reduced to about N <sup>susc</sup> (0) 4 5 states/ (eV-spin).




FIG.2. The inverse enhancement  $_0$ = of the susceptibility for a cluster with 32 m olecules as a function of the C oulomb interaction U (in eV). The band width is 0.66 eV.

Up to now we have not fully considered di erences in the de nition of the density of states N (0) deduced from di erent sources. Calculations of the electron-phonon interaction are usually based on band structure calculations, giving a density of states N<sub>0</sub> (0) for noninteracting electrons. The electron-electron interaction m odi es N<sub>0</sub> (0) to its interacting value N (0) (density of quasiparticle states), which should be used in the calculation of  $2^3$  This density of states enters in the speci cheat<sup>24</sup>

where the last factor is due to the electron-phonon interaction, assuming that the band width is large compared with the phonon frequency.<sup>25</sup> In the same approximation, the susceptibility can be written  $as^{24}$

where  $F_0^a$  is a Landau parameter and  $1=(1 + F_0^a)$  can be considered as a Stoner enhancem ent. Our calculation =chi<sub>0</sub> includes both the factors N (0)=N<sub>0</sub>(0) and  $(1 + F_0^a)$ . W ithin the present M onto C arlo technique it is not possible to calculate the speci c heat, and we can therefore not separate the two contributions. The value of N <sup>susc</sup> (0) deduced from the susceptibility, after dividing out many-body e ects, should therefore primarily be compared with the results obtained from band structure calculations. The band structure calculations have been perform ed for orientationally ordered system s and give N ord 6 9 states/(eV-spin). Sine the real system s have orientational disorder, we estim ate the corresponding density of states by solving the Ham iltonian (3) for U = 0 and orientational disorder. C om parision with calculations for ordered systems suggests a reduction of N (0) by about 15  $\,$  20% to N  $_{0}^{\rm disord}$  (0) 5 7 states/(eV-spin). This is in rather good agreem ent with N<sup>susc</sup> (0) 4 5 states/(eV-spin).

It is interesting that the estimate of N (0) 5 6 states /(eV - spin) based on the speci c heat<sup>2</sup> is comparable to

the noninteracting result N  $_{0}^{\text{disord}}$  (0) 5 7 states/ (eV spin). In contrast to what has been found for the nondegenerate Hubbard model in in nite dimensions $f^{26}$  this suprising observation suggests that the enhancem ent of the density of states is small in the  $A_3C_{60}$  compounds or that there may even be a reduction. If this is indeed the case, then the enhancem ent of the susceptibility would be a Stoner enhancement, and the N  $_{0}^{susc}$  (0) obtained from the susceptibility, after dividing out the many-body enhancement, could be compared with other experimental estimates of N (0). We then nd that these experin ental estimates are essentially brought in line with each other and with the band structure estim ates, giving N (0) 5 7 states/(eV-spin) for K<sub>3</sub>C<sub>60</sub>.

In our model and in the calculations of the susceptibility, we have neglected multiplet e ects and the electron-phonon interaction, which are now discussed. The electron-phonon interaction leads to an increase of the density of states at the Ferm i energy, due to the reduced dispersion of states within roughly a phonon energy of the Ferm i energy. This does not in uence the susceptibility, if the phonon energies are small compared with the electronic energies.<sup>27</sup> A lthough this assumption m ay not be entirely satis ed for  $A_3C_{60}$  and interesting effects may result from the nite band width,<sup>28</sup> we here neglect the e ects of the electron-phonon interaction on the density of states. Instead we focus on how the electron-phonon interaction in uences the moment form ation on the  $C_{60}$  m olecules.

If the multiplets are neglected but the electron-phonon interaction (Jahn-Teller e ect) is considered, the lowest spin 1/2 state is favored over the spin 3/2 state, according to calculations for the lowest state of each multiplicity for a free molecule.<sup>29</sup> The energy lowering of the spin 1/2 relative to the spin 3/2 state m ay be as large as 0.3 eV.<sup>30</sup> This suppresses the form ation of m oments and probably tends to reduce the susceptibility. On the other hand, the multiplet e ects should favor the form ation of m oments on the C <sub>60</sub> molecules, by giving preference to states with the spin 3/2.

The multiplet e ects lead to ve spin 1/2 states with the energy 3K and three spin 1/2 states with the energy 5K relative to the spin 3/2 state. Here K is the exchange integral between two  $t_{1u}$  orbitals, and we have assumed that the Coulom b integral ( $U_{xx}$ ) between equal

orbitals is 2K larger than the one  $(U_{xy})$  between di erent orbitals. To estim ate K, we have used a sim ple model, where the C oulom b integral between two 2p-charge distributions on two carbon atoms goes as  $e^2 = R$ , where R is the separation between the two atoms.<sup>31</sup> The on-site interaction was assumed to be 15 eV. W ithout screening we nd that K = 0.12 eV. This probably overestimates the multiplet e ects. An alternative estimate is obtained by using RPA screening of the C oulom b interaction. We then nd K = 0.030 eV. A similar result (0.024 eV) was also found by Joubert, using a density functional approach.<sup>32</sup>

From the numbers above it follows that there should be a partial cancellation between electron-phonon and multiplet e ects. Depending on which numbers are used, either e ect could be argued to be larger. If the electronphonon e ects win, this may lead to a som ew hat sm aller enhancem ent of the susceptibility than was found above (Fig. 2).

We have calculated the Pauli susceptibility of the doped fullerenes  $A_3C_{60}$  (A = K, Rb). The enhancement is of the order of a factor of three, which allows us to reconcile the estim ates of the density of states from the susceptibility with other estimates. This suggests that for  $K_{3}C_{60}$  N (0) 5 7 states/(eV-spin). This value is only slightly smaller than a value (N = 7:2) used recently to provide support for an electron-phonon m echanism driving the superconductivity in  $K_{3}C_{60}$ , but substantially smaller than some values used in early theoretical discussions. The susceptibility enhancement is appreciably larger than the one (factor 1.3-1.4) found in the LDA, and it is one of the st explicit examples of important many-body e ects, expected to be found in these systems. Comparison with Hartree-Fock calculations show s, how ever, that the enhancem ent is about four to ve times smaller than the HF result, illustrating the importance of correlation e ects.
