PHASE SEPARATION AND THREE-SITE HOPPING IN THE 2-D IM ENSIONAL t-J M ODEL

A bstract

We study the t-J model with the inclusion of the so called three-site term which comes out from the t=U! 0 expansion of the Hubbard model. We not that this singlet pair hopping term has no qualitative e ect on the structure of the pure mean eld phase diagram for nonmagnetic states. In accordance with experimental data on high-T materials and some numerical studies, we also not wide regions of phase coexistence whenever the coupling J is greater than a critical value $J_{\rm c}$. We show that $J_{\rm c}$ varies linearly with the temperature T, going to zero at T = 0.

In a recent paper [1] we have presented a new nite tem perature phase diagram for the nonmagnetic phases (dimer and ux) in the 2-dimensional t-J model below half-lling, which shows the existence of broad areas of phase coexistance (dimer-ux or ux-uniform), in accordance with experimental and numerical data on the possibility of separation into hole-rich and hole-poor regions [2, 3, 4].

It is well known that one can obtain the t-J model in the strong coupling regime (U t) of the one-band Hubbard model:

below half-lling. In (1) Latin indices label sites, the c_i 's are annihilation operators for a ferm ion on site i and spin = "; #, $n_i = c_i^{\gamma} c_i$ and (ij) denotes a sum over ordered nearest neighbor (n.n.) pairs.

The strong coupling lim it of (1) can be studied either by direct perturbation m ethods [5] or by canonical transform ations m ethods [6] (see also [7,8] for a detailed review). To lowest order in t=U, the H am iltonian that describes the H ubbard m odel on the subspace with no double occupancies (n_i 1) is given by:

and the symbol hiji denotes a sum m ation over unordered pairs of n.n. and (ijl) denotes a sum m ation where if l_i and both i and lare n.n. to j. The spin operators are de ned as

with $\sim = (1; 2; 3)$ being Paulim atrices.

The elective Ham iltonian contains a direct hopping term T_h that gives nonvanishing contribution only if the electron jumps from site i to an empty n.n. site j. So we expect the electron per cient to be reduced by a factor of order , being the doping fraction [9]. On the contrary H $^{(1)}$, which gives rise to a spin dynamics described by the standard AFM Heisenberg model, has not to be renormalized, since S_i S_j is nonzero only if both the sites i and j are singly occupied. H $^{(2)}$ is proportional to f_i and describes a double hopping process. Thus, one would be tempted to believe that it has to be

renormalized by a factor of 2 . However, it is not discult to see that the three-site hopping term H $^{(2)}$ gives nonzero contribution only for the situation in which the nal site 1 is empty and the intermediate site j is singly occupied. Then this term should be renormalized by a factor of (1) . Similar conclusions can be reached within dierent approaches [10, 11, 12].

For low doping the three-site term is smaller by a factor as compared with the AFM term and by a factor t = 0 as compared with the direct hopping term. That is why it is usually ignored and one is led to the t-J model [13]. However, the Hubbard Ham iltonian is often studied in a range of the parameter t=U not so small, especially in applications to high T_c materials for which one assumes t=U 0:1. In this regime the role of the three-site term cannot be neglected a priori.

Numerical works have recently shown that the three-site term is essential to avoid discrepancies between the one-particle spectra of the Hubbard and t-J model in the intermediate U regime [14]. A coording to [14], only after the inclusion of the three-site term, the t-J model can correctly describe the photoem ission experiments on cuprate oxides.

The three-site term describes the hopping of a singlet pair, which can be either rigid or with a ip of the spins. Both these processes preserve the local singlet bond and may be relevant for superconducting correlations, favoring superconducting states at the expense of an antiferrom agnetic phase [10].

Therefore, according to the discussion above, we approximate the e ect of the Gutzwiller projector by renormalizing each term of the Hamiltonian (2) with suitable factors depending on . Our new starting point is hence the Hamiltonian:

where we have introduced the four ferm ion matrix

In [1], we exam ined the so-called nonmagnetic phases for the t-J model, rst proposed by A eck and Marston [15], in the mean eld approximation and we have presented a nite temperature phase diagram (T versus the doping). In this paper we shall study how the phase diagram changes if we include the three-site hopping term.

To study the Ham iltonian (7) we can parallel the discussion in [1], where we have chosen to represent the partition function in the grand canonical ensemble by means of a functional integral over G rassmann elds and decoupled the four-ferm ion interaction by means of a Hubbard-Stratonovich transform ations over the auxiliary elds U_{ij} () = U_{ji}^{y} (). In the static approximation U_{ij} () U_{j} , the partition function reduces to:

being the chem ical potential.

We consider, as in [15], a pattern of link variables U_{ij} that adm its a symmetry for translations along the diagonal so that the matrix V depends only on the four parameters ;4) shown in Fig. 1 of [1]. As for the pure t-J model, the maltrix U can be easily diagonalized in m om entum space: if we include the three-site term it has eigenvalues

We notice that both the expression for the partition function (9) and for the eigenvalues of \mathbb{U} (13) are formally identical to the one for the pure t-J model we gave in [1], the only di erences being in the de nition of the matrix A and of the parameters is that appear in k. Thus, to study nonmagnetic phases in the mean eld approximation, we can borrow from the discussion of [1].

We rst discuss in detail the num erical solutions to the self-consistency equations for the case J=t= 1. For high tem perature and/or high doping the free energy is m in im ized by the uniform phase, characterized by U_i $U 2 R^+$, i = 1; ...; 4. For tem perature lower than T = J=4 we nd two phases: dim er and ux. The form er corresponds to two solutions of the form $U_1 \in U_2 = U_3 = U_4$; $U_j \ge 0$ with $y_1 = y_2$ and is stable in the lower range of dopings. In the ux phase the link variables U_i are all equal to a complex value Ue^{i} with 6 0. It is the lowest energy state in a range of doping that roughly



corresponds to that of high- T_c superconductivity. The pure mean eld diagram is shown in Fig. 1 (solid triangles).

Since the hole mobility is enhanced by the addition of the three-site hopping term, we expect disordered phases be favored with respect to the ordered ones. Moreover, the three-site term being proportional to (1), this elect should increase with doping in the region we considered. This is in fact what we ind in our mean eldicalculation. Fig. 1 shows the shifts of the phase boundaries for the usual t-J model (open circles) after the inclusion of the three-site term (solid triangles). The region of stability of the dimer phase shrinks in favor of ux phase, while the uniform con guration extends to considerably lower dopings at the expense of the ux one.

As we have observed also in [1], for T=0 our mean eld calculations are consistent with the ones carried out within a slave boson formalism in [16, 17]. In particular, we agree with [17] in nding a rst order phase transition between the dimer and the ux phases. Contrary to [17], we not that the ux-uniform phase transition is of the second order for any temperature. This can be seen from either Fig. 3 or Fig. 5 of [1]. In Fig. 3 of [1] it is possible to observe that, increasing , the angle , which distinguishes the ux phase from the uniform, decreases continuously from =4 to 0. In Fig. 5 of [1], it is easy to see that, at the transition point, there is no jump in the chemical potential, but

only a cusp. At this regard, we can also observe that the slope of these curves becomes steeper as the tem perature decreases. For T=0 this behaviour gives rise to numerical problems and probably this is the reason why in [17] the authors found a jump in the chemical potential and hence concluded that the ux-uniform boundary line describes a rst order phase transition.

The diagram of Fig. 1 is constructed without taking into account the possibility of coexistence of di erent phases. Indeed we not two ranges, belonging respectively to the dimer and the ux phase, where $\frac{\theta}{\theta} > 0$ [1, 18] which clearly indicate an instability towards phase separation. By means of the Maxwell construction on the chemical potential [4], we obtain two dierent regions corresponding to dimer—ux and ux-uniform phase coexistence. In the former, the hole-poor (hole-rich) part is in the dimer (ux) phase while in the latter the hole-poor (hole-rich) part corresponds to the ux (uniform) phase. The nalphase diagram is shown in Fig. 2.




Phase separation for nonmagnetic phases is also discussed in [17]. In the range of dopings relevant to high- T_c superconductivity, the authors of [17] found a wide region of phase separation between a half-lling dimer phase and a hole-rich uniform phase, while we not a smaller region of phase separation between a half-lling dimer phase and a ux phase corresponding to 0:09. This discrepancy is due to a different behaviour of the chemical potential as a function of . Indeed, within the large-N slave-boson formalism the

electronic chem ical potential gets shifted by the mean value of the Lagrange multiplier that enforces the constraint, while in the approach we adopted such a term is absent. Phase separation is a relevant issue because there is a considerable experimental evidence that many high-T_c superconductors have a regime in which phase separation between an AFM hole-poor region and a superconducing hole-rich region occurs [19]. Also, according to [20] an instability toward phase separation might explain the unusual properties of the normal state and superconductivity in copper oxides. This is why the above mentioned discrepancies between dierent approaches deserve a deeper investigation, which we plan to describe in a future work.

We want nally to give our contribution to the open question about the possibility that phase separation disappears once J=t is lowered below a critical value $J_c=t$. The determ ination of this quantity is important in order to understand if the t-J model can exhibit phase separation in the regime of high- T_c superconductors where 0.3 < J=t < 0.5. Theoretical studies, for T=0, based on dierent techniques, lead to contradictory results. Using a high temperature expansion the authors of [18] and the model phase separates only for J=t > 1, i.e. outside the region interesting for superconductivity. Similar results have been obtained in some numerical works [21]. On the contrary other authors and that phase separation occurs for all values of J=t. In particular this has been done by means of quantum Monte Carlo calculations [22], a combination of numerical

and analytical results [2, 3] and the above mentioned slave-boson approach [4, 17]. We calculated numerically the critical value J_c =t for several temperatures (T = 0 included) by observing the disappearance of the instability regions where $\frac{\theta}{a}$ > 0.

The results, plotted in Fig. 3, show that J_c =t varies linearly with the temperature and vanishes for T=0, both for the standard t-J model (dotted line) and with the inclusion of the three-site term (solid line). Thus, at zero temperature we not phase separation for all values of the interaction strength, in accordance with [3, 17, 22]. In addition, we can also conclude that at nite temperature there is always a nonzero critical value J_c =t below which phase separation disappears. In particular there is no phase separation in the region interesting for superconductivity for temperatures higher than T=0.07t.

Lastly, we observe that in one dimension some exact diagonalization and M onte C arlo results [23] suggest that the inclusion of the three-site term suppresses phase separation, which is instead present when such a term is not added [24, 25]. This seems not to be the case in two dimensions, at least at mean eld level. Indeed, our calculations show that phase separation is still present and the elect of the three-site term is not so dramatic.
