Therm odynam ics of dissipative quantum systems by e ective potential

Classical-like formulas are given in order to evaluate thermal averages of observables belonging to a quantum nonlinear system with dissipation described by the Caldeira-Leggett model \mathbb{P} hys. Rev. Lett. 46, 211 (1981); Ann. Phys. (N.Y.) 149, 374 (1983)]. The underlying scheme is the pure-quantum self-consistent harmonic approximation, which leads to expressions with a Boltzmann factor involving an elective potential and with a Gaussian average. The latter describes the elect of the uctuations of purely quantum origin. As an illustration we calculate the coordinate probability distribution for a double-well potential in the presence of various degrees of 0 hm ic dissipation.

The concept of e ective potential, meant to reduce quantum statistical mechanics calculations to classical oneswas rs introduced by Feynman [1,2]. He introduced a variational principle for the path-integral expression of the partition function | the Feynman-Jensen (FJ) inequality | and used it with a \free particle" trial action.

A signi cant in provement has been achieved by Giachetti and Tognetti [3,4] and independently by Feynman and Kleinert [5] using a quadratic trial action with the same variational principle. For nonstandard systems, where the FJ inequality is generally not valid, the pure-quantum self-consistent harmonic approximation (PQSCHA) gives a way to construct an elective Hamiltonian, thus recovering the phase-space concept and the classical-like formulas for thermal averages [6,7].

Several successful applications in dierent branches of condensed matter physics pointed out the power of the approach [7]. In the case of open systems, little work has been done for taking into account the quantum dissipation in the elective potential formalism; indeed, in a system-plus-reservoir model, only the expression of the elective potential for expressing the partition function as a conguration integral has been given, both for linear [8,9] and nonlinear coupling [10] with environmental oscillators.

By using the PQSCHA approach, that is equivalent to the variational method, we present here an accurate derivation of the density matrix of a nonlinear system interacting with a heat bath through the Caldeira-Leggett (CL) model [11]. This model considers the system of interest as linearly interacting with a bath of harm onic oscillators, whose coordinates can be integrated out from the path integral, leaving the CL Euclidean action

The kernel k(u) = k(h u) is a function that depends on temperature T = 1 and on the spectral density of

the environm ental bath [9]. The density matrix elements in the coordinate representation are expressed by Feynman's path integral as

where the path integration is de ned as a sum over all paths q(u), with $u \in [0; h]$, $q(0) = q^0$, and $q(h) = q^0$.

As suggested by Feynm an [2], we can rearrange the path integral (1) sum m ing over classes of paths that share the same average point

where $q[q(u)] = (h)^{-1} \frac{R_{-h}}{0} du \, q(u)$ is the average-point functional. Furtherm ore, as only paths with a xed average point q appear into the path integral (4), from action (1) we do not a trial action $S_0[q(u)]$ by replacing V q(u) with a trial quadratic \potential"

where the param eters w (q) and ! 2 (q) are now to be optimized, so that the trial reduced density $_0$ (q;q;q) at best approximates (q;q;q), for each value of q. Note that V_0 (q;q) is not related to a quantum observable, since it depends on q: so, the rst part of the trial action is also nonlocal.

The evaluation of the trial reduced density $_0$ ($q^0; q^0; q$), in spite of the fact that the action is quadratic, is rather tricky: on the one hand, the known general method of calculating them in imalaction fails since its min in ization gives rise to in nite order equations of motion, and, on the other hand, the method of Fourier expansion of the paths in terms of discrete M atsubara components conjude with the appropriate of the paths of the paths.

Now the paths in Eq. (6) can be Fourier expanded,

 $_{\rm n}$ = 2 n=(h) are the M atsubara frequencies and the $_{\rm 0}$ component is just q, as it appears from the inverse transform ation. The m easure of the path integral then becomes [2]

Here we have made use of the relation that connects the kernel k (u) with the Laplace transform (z) of the realtime m emory damping function (t) [9]

W hile it is trivial to manage the function that xes q, the end-point constraints are implemented by inserting the functions $q(h ") q^0$ and $q(") q^0$, and then using their Fourier representation. The calculation of 0 can then be carried forward by G aussian quadratures giving

Eventually, the lim it in " can be easily taken, and the result reads

Now, if $_0$ (q^0 ; q^0) { obtained using the last result in Eq.(3) { is taken as an approximation for the exact density matrix (q^0 ; q^0), we have a way to explicitly calculate any quantum thermal average by two Gaussian quadratures plus a single integral in q. A more convenient formalism deals with phase space: let us brie y show it.

The Weyl symbol for an observable 0 = 0 (p;q) is the phase space function 0 (p;q) that is defined in terms of the matrix elements in coordinate space as [13]

By m eans of a sim ple property of W eyl symbols the average of \hat{O} takes the form of a phase-space integral,

From Eqs. (3) and (18) the W eyl symbol for the trial density operator turns out to be

where the double bracket is the Gaussian average operating over p and , with moments $lh^2ii = (q)$ and $lhp^2ii = (q)$; the e ective potential is de ned as

In order to determ ine the functions w (q) and $!^2$ (q) we impose the PQSCHA condition, i.e., we require that the potential V (q) and the trial potential V_0 (q;q), together with their derivatives up to second order, have equal averages with respect to the reduced (diagonal) density $_0$ (q;q;q). The condition for the rst derivatives is overcome by the densition of the average point, so that we are left with

The latter condition must be solved self-consistently with the de nition of (q) in term s of ! 2 (q), Eq. (16). Now we have all the necessary ingredients to explicitly evaluate the e ective potential and all the therm all averages through the classical-like expression (22). As in the case of no dissipation, it can be seen that for the most usual potentials the self-consistent solution for (q) turns out to be always positive, even though ! 2 (q) can be negative [4,5]. Indeed, what matters is that , Eq. (16), is a decreasing function of ! 2 , with a divergence to +1 [which in the dissipative case happens at ! 2 ! 2 1 (1)].

In the case of 0 hm ic dissipation, corresponding to $(z) = -\cos t$ [i.e., the memory is Markovian, $(t) = -\cos t$

(t 0)], one can see that the (q-dependent) mean-square momentum (q), Eq. (17), is divergent in the 0 hm ic case. Correspondingly, also (q), Eq. (13) diverges. The physical reason for this, basically related to the uncertainty principle, is well discussed in Refs. [9,11]. Here we note that the coordinate mean-square uctuation (q) is still well de ned, and that the excitive potential can be made nite by subtraction of the inpartite but q-independent quantity $^1 \ln_1$, with $_1 = ^1 \ln_1 1 + (_n) = _n$. Therefore, Eq. (22) is still meaningful in the case of observables that do not depend on momentum .

For a given potential V (4), it is convenient to devise a characteristic energy scale (e.g., the barrier height for a double-well potential, the well depth for physical potentials that vanish at in nity, etc.) and a length scale (such that variations of V comparable to occur on this length scale) and write V (4) = v (4). In this way one better deals with the dimensionless coordinate $\hat{x}=4$. If x_m is the absolute minimum of v(x), the harm onic approximation (HA) of the system is characterized by the frequency ! 0 = $\sqrt[4]{(x_m)} = m^{-2}$; a dimensionless coupling parameter g for the system can be dened as the ratio between the HA quantum energy level splitting h! 0 and the overall energy scale ,

The case of weak (strong) quantum e ects occurs when g is small (large) compared to 1. In the following application we shall make use of the dimensionless variables only, i.e., energies are given in units of , lengths in units of , frequencies in units of !0, and so on; the reduced temperature is t=1=().

Let us then consider the double-well quartic potential

It has two degenerate symmetric minima in $x_m=1$, with $v^{(0)}(x_m)=8$. From the PQSCHA equations (24) and the de nitions (23) and (16) we obtain

and $_{\rm n}$ = (2 t=g)! $_{\rm 0}$ n . Equations (29) and (30) have to be solved self-consistently. This task is done numerically; exact reference data can be obtained only for = 0 by numerical solution of the Schrödinger equation.




FIG. 1. Con guration density P(x) = h(x x)i of the double-well quartic potential for g = 5, t = 1, and di erent values of the 0 hm ic damping parameter $= e!_0$. The led circles are the exact result for = 0; the dotted curve at = 1 corresponds to the classical lim it.




FIG.2. Same as gure 1, for g = 5, t = 2.

In Figs. 1 and 2 we report the shapes of the coordinate probability distribution P (x) = h (\hat{x} x)i in the case of 0 hm ic dam ping, (n) = !0 = const, at a very strong value of the coupling, g = 5; this gives a (nondissipative) ground state energy e0 = 1:394, and the rst excited level is e1 = e0 + 2:355. When dissipation is switched on P (x) tends towards the classical distribution P c = $e^{v(x)=t}$.




FIG. 3. A verage potential energy v = hv(x)i of the double-well quartic potential vs. temperature, for g = 5 and dierent values of $= = !_0$. The led circles are the exact result for = 0; the dotted curve at = 1 corresponds to the classical lim it.

Figure 3 shows typical results found for the average potential energy v(t) = hv(x)i. By comparing with the exact data at = 0 it appears that the PQSCHA gives very accurate results, in spite of the strong coupling. At lowest temperatures the PQSCHA tends to the ordinary self-consistent harmonic (or one-loop) approximation, since the elective Boltzmann factor tends to a function.

However, a more physical model should involve a non-Markovian memory damping function; in such a model there would be at least one more characteristic frequency scale (e.g., the frequency $!_D$ in the D rude model [9])

above which (z) rapidly vanishes. In this case all averages make sense, and whereas the averages of coordinate-dependent observables tend again to the classical behavior (in other words, the environment quenches the pure-quantum coordinate uctuations), those of momentum - dependent ones go in the opposite direction due to the momentum exchanges with the environment. Of course, the PQSCHA expressions are even more useful in these physical situations. Further details and applications, as well as the extension to the case of many degrees of freedom, will be given in a forthcoming paper.
