#### Abstract

: W e consider the action of the m odular group (2) on the set of positive rational fractions. From this, we derive a m odel for a classi cation of fractional (as wellas integer) H all states which can be visualized on two \visibility" diagram $s$, the rst one being associated w ith even denom inator fractions whereas the second one is linked to odd denom inator fractions. $W$ e use this $m$ odel to predict, am ong som e interesting physical quantities, the relative ratios of the $w$ idth of the di erent transvensal resistivity plateaus. A num erical sim ulation of the tranversal resistivity plot based on this last prediction ts wellw ith the present experim ental data.

[^0]I) Introduction

The quantum $H$ all e ect has been an intensive eld of theoretical and experim ental investigations, since the discovery of the two dim ensional quantized H all conductivity by [1] for the integer plateaus and by [2] for the fractional ones.

The pioneering theoretical contributions [ $3 \mathrm{a}-\mathrm{c}$ ] relating the basic features of the hierarchy of the H all plateaus w th the properties of a two dim ensional incom pressible uid $w$ th fractional charges collective excitations [3a] have triggered further works dealing $w$ th condensed $m$ atter theory [4], quantum eld theory 5] and $m$ athem atical physics [6]. It appears now that the two dim ensional electron system in the quantum H all regim e is associated w ith a com plicated phase diagram w ith a lot of possible transitions betw een the various phases, whose better understanding deserves further experim ental and theoretical studies.

A s far as the theoretical view point is concemed, tw o im portant ingredients underlying num erous w orks can be singled out: i) The ux attachem ent transform ation relating quantum Hallstates [7] forwhich the Chem-Sim ons theory is a suitable eld theory fram ew ork; ii) the hierarchical structure of the set of H all states [8]y w here particle-hole sym $m$ etry play an im portant role. The com bination of the above ingredients into a C hem-Sim ons-LandauG inburg theory has led the authors of [9] to propose a topology of the phase diagram (in the extemalm agnetic eld-disorderplane) togetherw ith an attem pt to explain the possible origin of superuniversality ruling the considered transitions.

It appears that (at least som e of) the above ideas can be form ulated in term ofm odular transform ations, that is, discrete sym $m$ etry transform ations acting on som e param eter space of the quantum $H$ all system and pertaining to the modular group or one of its subgroups. M odular transform ations in the fram ew ork of quantum $H$ alle ect have been considered from di erent view points [10].

In a recent work [11], two of us have constructed a classi cation of the quantum H all states based on arithm etical properties of the group (2) ofm odular transform ations acting on the three cusps fil $g, f 0 g$ and $f 1 g$ of its fundam ental dom ain in the $P$ oincare half-plane. The proposed classi cation reproduces and re nes the Jain hierarchical one [12]. In particular, it has been obtained fam ilies of quantum $H$ all uid states (plus the insulator state), each fam ily being generated from a m etallic state labelled by an even denom inator fraction $=(2 s+1)=2 r$.

Y given a basis of Laugh lin states, one can obtain elem ents of the set of $H$ all states through condensation of quasiparticles of other elem ents of the set

T he purpose of the present paper is to extract $m$ ore algebraic properties linked $w$ ith this classi cation, then to translate them into a graphical representation, called the visibility diagram [13] which generates Farey sequences [14] together w ith an associated diagram called the dual diagram. From this analysis, we predict a global organization of the various H all conductivity states stem $m$ ing from the action of (2) as well as som e im portant quantitative features of the $H$ all fractionalconductivity plateaus such as the relative ratios of their width (at least for not a to strong applied $m$ agnetic eld). Furthem ore, we obtain from a num erical construction a transverse resistivity plot which ts very well with the experim entaldata.

The paper is organized as follow s. In section II we present the usefull m aterial underlying our classi cation of the quantum H allstates. In section III, we introduce the visibility diagram together $w$ ith its associated dual diagram in connection $w$ ith the quantum $H$ all e ect. The corresponding physical inform ation encoded in these diagram $s$ is discussed in section IV where we also confront a num erical sim ulation of the resistivity plot stem $m$ ing from our construction to the experim ental data. F inally, we sum $m$ arize our results and conclude in section $V$.
II) The group (2) and the quantum H all states

In this section, we sum m arize the essential tools that will be needed in the sequel as well as som e of the $m$ ain results of the previous work [11] to which we refer for $m$ ore details.

Let P be the upper com plex plane and z a com plex coordinate on P ( $\operatorname{Im} z>0$ ). W e recall the inhom ogeneous m odular group (1) (=PSL (2;Z)) is the set of transform ations G acting on $P$ and de ned by:

The group (2) that w illbe the building block of the follow ing construction is a subgroup of (1). (2) is know $n$ in the $m$ athem aticallitterature as the principalcongruence unim odular group at level2. It is the set of transform ations $G$ acting on $P$ de ned by

For $m$ ore $m$ athem atical properties of (2), see e.g [15]. H ere, we notice that (2) is a com $m$ on subgroup of two other subgroups of (1) which have been already considered from di erent view point in connection to the quantum $H$ alle ect. The rst one, $s(2)$, is generated by $T^{2}$ and $S$ and is the natural sym $m$ etry group of the Landau problem on the torus; 辻 appears in the construction of the $m$ any body Landau states on the torus [16] in term of the C oulom b gaz vertex operators [17]. The second subgroup of (1), i (2), which contains (2), is related to the sim ilarity tranform ations used by Jain in his hierarchical $m$ odel [12]. Recall the ${ }_{\mathrm{T}}(2)$ is generated by T and .

Now, identify any fraction $\mathrm{z}=\mathrm{p}=\mathrm{q} \mathrm{w}$ ith a lling factor and select a given H all m etallic state labelled by $=\frac{(2 s+1)}{2 r} w$ ith $r \quad 0 ; \mathrm{s} \quad 0$. As shown in [11], there is a fam ily of transform ations $G_{n ; k} 2$ (2) (w ith $n$ and $k$ still satisfying (2.6)) which send $z=i l$ onto . Then, from the im ages $G_{n ; k}(0)$ and $G_{n ; k}(1)$ of 0 and 1 by the tranform ations $G_{n ; k}$, one obtains a (Jain-like) hierarchy of H all states surrounding the $m$ etallic state on the resistivity plots.

For exam ple, the double Jain fam ily $J_{1=2}^{i}$ of states surrounding the $m$ etallic state $=\frac{1}{2}$

can be easily recovered in our schem e from the im ages $G_{n ; k}^{1=2}(0)$ and $G_{n ; k}^{1=2}(1)$ w ith respectively n 0 for (2.7a) and $\mathrm{n}<0$ for (2.7b). N otioe that the construction separates the even denom inator H all fractions from the odd denom inator one so that it m ay be possible to take into account a possible particle-hole sym metry within the present schem e. O ther fam ilies surrounding any m etallic state (fraction $w$ ith even denom inator) can be
constructed in the sam e way so that all the experim entaly observed H all states can be taken into account in the present construction. This will be discussed further in section IV .

In the next section, we w illbe concemed with a diagram $m$ atic description of the classi cation of the quantum H all states $w$ hich perm its one to visualize the globalorganization of the various $H$ all conductivity states stem $m$ ing from the action of (2). To reach this goal, we rst introduce a convenient param etrization of the transform ations $\mathrm{G}_{\mathrm{n} ; \mathrm{k}}$. Indeed, it can be easily veri ed that the $\mathrm{G}_{\mathrm{n} ; \mathrm{k}}$ 's, for $\mathrm{xed}=(2 \mathrm{~s}+1)=2 r$, can be recast into the form

For a given , xing $b, d$ and varying $m$ from 1 to 1 , a com plete hierarchy of states is recovered as before [11] from $G_{m}(0)$ and $G_{m}(1)$. Furthem ore, one has

which re ects the fact that the sequence of H all uid fractions converges to the fraction labelling a given $m$ etallic state which de nes that sequence. This point has to be com pared to the generaltopology of the recently proposed phase diagram sfor the quantum H alle ect $w$ here, roughly, each $m$ etallic state (even denom inator state) appears to be surrounded by a de nite fam ily of H all liquid states (odd denom inator states). W e w ill discuss this point in section $\mathbb{I V}$.

From the above param etrization (2.8), we now construct a shift operator A 2 (2) corresponding to each $m$ etallic state , which acts on the uid states (and possibly on the insulator state $=0$ ). W e de ne this shiff operator $A$ (whidh depends only on ) as the follow ing operator product

The action of A to a given rational fraction $p=q$ equals to $G_{m}(0)$ or $G_{m}$ ( 1 ) gives another rational fraction equals respectively to $G_{m+1}(0)$ or $G_{m+1}(1)$, so that $A$ acts as a shift
operator, raising the num ber $m$ by one unit. The inverse operator (A ) ${ }^{1}$ perform $s$ the corresponding low ering in $m$.

The operators A satisfy the follow ing relations

where [A ] denotes the two by tw o m atrix corresponding to the $m$ odular transform ation A . Eqns. (2.14) and (2.15) are just a $m$ ere consequence of the de nition of the group (2). N otice that (2.14) re ects the parabolic nature of the transform ations A which $m$ eans that A $m$ ay have no $m$ ore than two xed points (which must be necessarily real [15]). Therefore, eqn.(2.13) m eans that the m etallic state $=(2 s+1)=2 r$ is actually the unique xed point for the shift operator A. This last property $m$ ay be extended to the case where $r=0$, which corresponds to the point at in nity on the realaxis.
III) V isibility diagram and dualdiagram .

W e are now in position to introduce a diagram $m$ atic description that we nd particularly usefill and predictive for the classi cation of the quantum H all states. This diagram $m$ atic tool, which pem its one to obtain quantitative results on the di erent quantum $H$ all states is called the \visibility diagram " and has been already used in other areas of physics [13]. W e w ill also introduce another diagram, hereafter called the dualdiagram, which willallow us to extract in a straighforw ard way som e of the inform ation encoded in the visibility diagram .

IIIa) T he visibility diagram .
This diagram is a sim ple pictorialdevice for the construction ofFarey sequences [14] of rational num bers, each one being associated to a given vertex of a tw o dim ensional square lattice.

Let us consider the tw o dim ensionalsquare lattioe depicted on $g .1$ where the vertioes are indexed by a couple of positive or nul relatively prim e integers (q;p). Since the action of (2) preserves the even or odd nature of $q$ and since a special role is played by the even denom inator fractions in the sequel, we nd convenient to use di erent sym bols (see $g$. 1) to separate the vertioes belonging to a row with q even from those belonging to a q odd row. T herefore, the visibility diagram is $m$ ade of the vertices of couples ( $q ; p$ ) of positive
integers which are not hidden by any other vertex for an observer located at the origin $(0 ; 0)$. $N$ otice that the origin is not considered as a visible point.

It is know $n$ in arithm etics that all the Farey ordered sequences $F_{n} ;(n=1 ; 2 ;:::$ of rational fractions $p=q$ w ith $p$ positive and $0 \quad q \quad n$ are in one to one correspondance $w$ ith the visible vertices $(q ; p) ; 0 \quad q \quad n$. Strictly speaking, for any Farey sequence $F_{n}, p$ and $q$ are required to satisfy $p \quad n$ and $q \in 0$; here, since $w e$ have in $m$ ind to apply the above $m$ achinery to the fractional quantum $H$ all e ect, we relax som ehow the above requirem ent, thus allow ing fractions $w$ ith $p>n$ (and form ally the \in nite fraction" $1 \quad 1=0() \quad(0 ; 1))$.

C orresponding to this identi cation, the group (2) acts on the vertioes of the visibility diagram in a rather sim ple way: it is actually represented by the linear action of two by tw o m atrioes on the two com ponents ( $q ; p$ ) of the vertioes, a property we will use in the follow ing.

N ow, it is easy to draw on the visibility diagram each fam ily of vertices corresponding to the previously introduced fractions $G_{m}(0)$ and $G_{m}(1)$.

Let us describe in details what kind of picture we obtain (see g2). First of all, for a given $=(2 s+1)=2, r=1$, the quantum $H$ all rationals num bers $G_{m}(0)$ and $G_{m}(1)$, where $m$ is any integer, are all located on each parallel sides of distinct unbounded bevelled left end side stripes. The two sides of each stripe start from the vertioes ( $1 ; \mathrm{s}$ ) and $(1 ; \mathrm{s}+1)$ and their slope is equal to $=(2 s+1)=2$, as it can be easily seen by using for instance (2.8) and (2.9) from which one obtains after som e algebra the equations de ning the two parallel sides of the stripes. They are given in the $(q ; p)$ plane by $P=\left(\frac{2 s+1}{2}\right) Q \quad \frac{1}{2}$ where the $m$ inus (resp. plus) sign refers to the side starting from the vertex ( $1 ; \mathrm{s}$ ) (resp.( 1 ; s+1)). $T$ his agrees $w$ th the generation $m$ echanism we gave previously for each Jain type fam ily [11]; recall that, as far as the action of (2) is concemed, the couple of cusps (fsg; fs + 1 g ) $m$ ay be substituted to the equivalent couple ( $f 0 g ; f 1 \mathrm{~g}$ ). Them etallic state itself is show n to be surrounded on the visibility diagram by the fam ily of uid states (and eventually by the insulator whenever $=1=2$ ) it generates. $W$ e will call such fam ilies $(=(2 s+1)=2)$ the principal stripes $(r=1)$.

G lued on each side of any principal stripe there is an in nite num ber of other secondary, tertiary... stripes ( $r=2 ; 3:::$ ). They are all sim ilar in shape to a principal one: Two in nite parallel sides, a bevelled left end side and each one labelled by a m etallic state

$$ the parallel sides of the stripe in such a way that each m etallic state nd itself isolated from the other $m$ etallic states by the $m$ em bers of its fam ily on a stripe of slope. . Starting

from the secundary stripes ( $r=2$ ), it is possible to construct fam ilies of tertiary stripes, quartenary stripes... and so on, fam ilies of stripes of any order. The equations de ning the two sides of a stripe of order $r$ are easily derived from (2.8) and (2.9). They are given in the $(q ; p)$ plane by $P=\left(\frac{2 s+1}{2 r}\right) Q \quad \frac{1}{2 r}$. A pecularity appears on the diagram conceming the H all insulator state $(=0)$. Its vertex representation is $(1 ; 0) ;$ clearly it pertains to a given fam ily, only for $=1=2 r\left(\begin{array}{ll}r & 1)\end{array}\right.$. This last property could have som e im portance for a possible direct phase transition betw een that state and another state. T he reader has certainly noticed that the quadrant p $0 ; q 0$ is not com pletely covered by stripes, a (half) stripe shaped region is left uncovered, it is de ned by p 0;0 q 1.W e shall also com e back on this last pecularity.

On any fraction of any given stripe acts the step operator A or its inverse in such a way that the $m$ etallic state $=(2 s+1)=2 r$ located at the lattice vertex $(2 r ; 2 s+1)$ is a xed point for A. The uid states (and eventually the insulator state) on the edge of the corresponding stripe are all transform ed am ong them selves under that action, any of them is in fact the im age of $G_{m}(0)$ or $G_{m}$ (1) under som e pow er ofA and its inverse. In fact, all the inform ation encoded in this diagram can be thoroughly reproduced by using the A and (A ) ${ }^{1}$ 's. This can be rephased by saying that the A 's are the algebraic counterpart of the graphical representation of the (tree-like) structures form ed by the $H$ all states on the above diagram.

IIIb) The dualdiagram
O bserve that the previous structure on the visibility diagram is a m ere consequence of a well-known theorem in arithm etics which states that, for any given two relatively prim e positive integers $p$ and $q$, there exist tw o other (necessarily relatively prim e) positive integers a and b satisfying pb qa $=1$ or pb qa $=1 . \mathrm{U}$ sing this theorem, it is easy now to realize that the set of ( $a ; b$ ) pairs stem $m$ ing from these later equations, for $x e d(p ; q$ ) and $q$ even, are all located on the two sides of the stripe labelled by $=\frac{p}{q}$ depicted on g2.

B ut one could instead consider q odd so that another structure can be obtained on the visibility diagram where now stripes labelled by $=\frac{\mathrm{p}}{\mathrm{q}} \mathrm{w}$ th q odd can be de ned as show n on g.3. W e w ill call this resulting structure the dual diagram. Indeed, it can be easily seen that any stripe on g 2 corresponds to a given direction on the dualdiagram (depicted by dotted lines on g.3), and conversely. This diagram will prove usefull to evaluate the relative ratios of the w idth of the H all plateaus.

IV ) Physical discussion.
$W$ e are now in position to extract som e physical inform ation from the two diagram s that have been de ned. W e rst identify any fraction $\mathrm{p}=\mathrm{q} w$ th the lling factor (whatwe im plicitely assum ed in the previous sections). Thispicture suggests that the (2) sym m etry transform ations act on som e param eter space describing the quantum H all system. Recall that the $m$ etallic (resp. liquid) states are labelled by fractions $w$ ith even (resp. odd) denom inator.

First ofall, keeping in $m$ ind the above identi cation, it is obvious that our construction treats on an equal footing integer and fractional states. N ow, consider the structure given on g. 2. O ne observes that each principal stripe bears self-sim ilar branched structure built from that stripe and all its descendants. $N$ otice that the resulting globalorganization of the states in the stripes agrees quite wellw th the experim entaly observed one. W e point out that our construction predicts the existence of an in nite num ber of fam ilies w ith selfsim ilar (tree-like) structure. A s far as the present experim ental situation is concemed, (see [18]), the Jain fam ily $=1=2$ corresponding on $g 2$ to the stripe $w$ ith the largest $w i d t h$, has the m ost num erous well established observed states $(\mathbb{N}$ obs 13$)$. The other observed fam ilies labelled respectively by $=3=2 ; 1=4 ; 3=4 ; 5=2 ; 5=4$ and corresponding respectively to stripes of decreasing width are associated to a decreasing num ber of observed states (respectively N obs $7 ; 6 ; 5 ; 4$ ). R oughly speaking, this suggests that the width of a stripe $m$ ay be related to the (experim ental) di culty to observe the associated states. N otioe that the insulator state $=0(=0=1$ in our picture) does not label any stripe.

N ow consider the action of the two generators of (2) given in (2.4) on the visibility diagram. $T^{2}$ can be interpreted as a Landau shift operator; corresponds to a ux attachm ent operator. On the visibility diagram, the action of $T^{2}$ on a vertex ( $q ; p$ ) gives rise to a vertical shift ( $q ; p$ ) ! ( $q ; p+2 q$ ) whereas the action of on ( $q ; p$ ) produces a horizontal shift ( $q ; p$ )! ( $q+2 p ; p$ ). Since ux attachem ent can be obtained by magnetic eld variation, a variation of the $m$ agnetic eld is associated on the visibility diagram w ith a corresponding horizontal shiff. Observe now that the stripes of the dual diagram are labelled by fractions with odd denom inator, each of which corresponding to a plateau in the H all conductivity. Putting all together, this suggests to identify (up to an overall dim ensionfull factor) the \horizontal" width of any stripe of the dual diagram de ned by the intercept of any horizontal line with that stripe with the width of the corresponding plateau. N otice that both integer and fractional plateaus are involved in this picture as already $m$ entioned at the beginning of this section.

It is a straighforw ard com putation to show that the \horizontal" width of any stripe labelled by $=p=q$ is equal to $2=p$. Then, the above identi cation leads to a prediction of
all the ratios of the w idths of the H all plateaus given by

where ( ) denotes the width of the plateau labelled by and can be expressed as

where the overall param eter o has dim ension of a magnetic eld. At this point, one im portant rem ark is in order. It is well known that the width of the plateaus decreases when the tem perature increases so that for su ciently hight tem perature the classical behavior for the H all resistivity is recovered. Therefore, if the above identi cation is correct, eqn.(4.1) should be valid only at zero tem perature.
$N$ evertheless, one $m$ ight already expect to obtain a reasonably good agreem ent $w$ ith the present (non zero tem perature) experim ental data. In order to check this, we have confronted the prediction (4.1) with an experim ental resistivity plot [19]. To do this, we have to x two param eters. The rst one is the width of a given transverse resistivity plateau which will determ ine the value of 0 . In the present num erical analysis, we choose to $t$ this value with the $=3=2$ experim ental plateau. T he second param eter is the position of the center of this choosen plateau on the to be determ ined resistivity plot. We assum e that this plateau is centered around its corresponding lling factor value $=3=2$. $T$ hese tw o requirem ents $w$ illdeterm ine com pletely all the $w$ idths and positions on the other plateaus. The num erical result is show n on $g .4$ and exhibits a good agreem ent with the corresponding experim entalplot ( g .5 ).
V) C onclusion.

In this paper we have exploited som e arithm etic properties linked w ith the classi cation of the quantum $H$ all states stem $m$ ing from the action of (2). These properties can be well synthetized in a graphical representation based on a visibility diagram, in which the resulting global organization of all the quantum H all states is found to form (treelike) self-sim ilar structures. In particular, this structure is in com plete agreem ent w ith the (experim ental) hierarchy of observed states.

Furtherm ore, we used som e of the arithm etic properties rooted in this construction together w ith a physical interpretation of the two generators of (2) to con jecture the (zero tem perature) ratios of the $w$ idths of the $H$ all plateaus. $M$ oreover, this suggests in
particular that the zero tem perature values of these ratios are universal. W e tried to confront the predictions obtained from this conjecture to the present (non zero tem perature) experim ental data by constructing num erically the corresponding resistivity plot. This latter is in good agreem ent w ith som e experim ental resistivity plot (see on g.5).

As it has been already m entionned in this paper, the (2) transform ations could be understood as an in nite set of discrete transform ations acting on som e param eter space of the quantum $H$ all system. Therefore, it should be interesting to use this (2) sym $m$ etry to construct a model for the quantum $H$ all e ect, for instance in the spirit of ref. [9] and rst of ref. [10]. On the other hand, it should be also interesting to inconporate the
(2) sym $m$ etry into a renorm alization group fram ew ork to study the possible relations it induces am ong the xed points that $m$ ight provide som e new insight on the possible origin of the superuniversality property shared by the observed transitions betw een H all states. $T$ hese questions are presently under study.
