# MODULAR GROUPS, VISIBILITY DIAGRAM AND QUANTUM HALL EFFECT

#### Abstract:

We consider the action of the modular group (2) on the set of positive rational fractions. From this, we derive a model for a classi cation of fractional (as well as integer) H all states which can be visualized on two \visibility" diagrams, the rst one being associated with even denom inator fractions whereas the second one is linked to odd denom inator fractions. We use this model to predict, among some interesting physical quantities, the relative ratios of the width of the di erent transversal resistivity plateaus. A num erical simulation of the tranversal resistivity plot based on this last prediction ts well with the present experim ental data.

## I) Introduction

The quantum Halle ect has been an intensive eld of theoretical and experimental investigations, since the discovery of the two dimensional quantized Hall conductivity by [1] for the integer plateaus and by [2] for the fractional ones.

The pioneering theoretical contributions [3a-c] relating the basic features of the hierarchy of the Hall plateaus with the properties of a two dimensional incompressible uid with fractional charges collective excitations [3a] have triggered further works dealing with condensed matter theory [4], quantum eld theory [5] and mathematical physics [6]. It appears now that the two dimensional electron system in the quantum Hall regime is associated with a complicated phase diagram with a lot of possible transitions between the various phases, whose better understanding deserves further experimental and theoretical studies.

As far as the theoretical view point is concerned, two important ingredients underlying num erous works can be singled out: i) The ux attachem ent transform ation relating quantum H all states [7] for which the Chem-Sim ons theory is a suitable eld theory fram ework; ii) the hierarchical structure of the set of H all states [8]y where particle-hole sym m etry play an important role. The combination of the above ingredients into a Chem-Sim ons-Landau-G inburg theory has led the authors of [9] to propose a topology of the phase diagram (in the externalm agnetic eld-disorder plane) together with an attem pt to explain the possible origin of superuniversality ruling the considered transitions.

It appears that (at least som e of) the above ideas can be form ulated in term of modular transform ations, that is, discrete sym metry transform ations acting on some parameter space of the quantum Hall system and pertaining to the modular group or one of its subgroups. Modular transform ations in the fram ework of quantum Hall e ect have been considered from di erent view points [10].

In a recent work [11], two of us have constructed a classi cation of the quantum H all states based on arithm etical properties of the group (2) of m odular transform ations acting on the three cusps fill g, f0g and f1g of its fundam ental domain in the Poincare half-plane. The proposed classi cation reproduces and re ness the Jain hierarchical one [12]. In particular, it has been obtained families of quantum H all uid states (plus the insulator state), each family being generated from a metallic state labelled by an even denom inator fraction = (2s + 1)=2r.

Y given a basis of Laughlin states, one can obtain elements of the set of H all states through condensation of quasiparticles of other elements of the set

The purpose of the present paper is to extract more algebraic properties linked with this classi cation, then to translate them into a graphical representation, called the visibility diagram [13] which generates Farey sequences [14] together with an associated diagram called the dual diagram. From this analysis, we predict a global organization of the various H all conductivity states stem ming from the action of (2) as well as some important quantitative features of the H all fractional conductivity plateaus such as the relative ratios of their width (at least for not a to strong applied magnetic eld). Furtherm ore, we obtain from a num erical construction a transverse resistivity plot which ts very well with the experim ental data.

The paper is organized as follows. In section II we present the usefullm aterial underlying our classi cation of the quantum H all states. In section III, we introduce the visibility diagram together with its associated dual diagram in connection with the quantum H all e ect. The corresponding physical inform ation encoded in these diagrams is discussed in section IV where we also confront a num erical simulation of the resistivity plot stem m ing from our construction to the experimental data. Finally, we sum marize our results and conclude in section V.

II) The group (2) and the quantum H all states

In this section, we summarize the essential tools that will be needed in the sequel as well as some of the main results of the previous work [11] to which we refer for more details.

Let P be the upper complex plane and z a complex coordinate on P (Im z > 0). We recall the inhom ogeneous modular group (1) (= PSL (2;Z)) is the set of transform ations G acting on P and de ned by:

The group (2) that will be the building block of the following construction is a subgroup of (1). (2) is known in them athem atical litterature as the principal congruence unim odular group at level 2. It is the set of transform ations G acting on P de ned by

For more mathematical properties of (2), see e.g [15]. Here, we notice that (2) is a common subgroup of two other subgroups of (1) which have been already considered from di erent view point in connection to the quantum Halle ect. The rst one,  $_{\rm S}$  (2), is generated by T<sup>2</sup> and S and is the natural symmetry group of the Landau problem on the torus; it appears in the construction of the many body Landau states on the torus [16] in term of the C oulom b gaz vertex operators [17]. The second subgroup of (1),  $_{\rm T}$  (2), which contains (2), is related to the similarity tranform ations used by Jain in his hierarchical model [12]. Recall the  $_{\rm T}$  (2) is generated by T and .

Now, identify any fraction z = p=q with a lling factor and select a given Hallm etallic state labelled by  $= \frac{(2s+1)}{2r}$  with r 0; s 0. As shown in [11], there is a fam ily of transformations  $G_{n,k} 2$  (2) (with n and k still satisfying (2.6)) which send z = i1 onto . Then, from the images  $G_{n,k}$  (0) and  $G_{n,k}$  (1) of 0 and 1 by the transformations  $G_{n,k}$ , one obtains a (Jain-like) hierarchy of Hall states surrounding the metallic state on the

can be easily recovered in our scheme from the images  $G_{n,k}^{1=2}(0)$  and  $G_{n,k}^{1=2}(1)$  with respectively n 0 for (2.7a) and n < 0 for (2.7b). Notice that the construction separates the even denominator H all fractions from the odd denominator one so that it may be possible to take into account a possible particle-hole symmetry within the present scheme. 0 ther families surrounding any metallic state (fraction with even denominator) can be

constructed in the same way so that all the experimentally observed H all states can be taken into account in the present construction. This will be discussed further in section  $\mathbb{N}$ .

In the next section, we will be concerned with a diagram m atic description of the classication of the quantum H all states which perm its one to visualize the global organization of the various H all conductivity states stem m ing from the action of (2). To reach this goal, we rst introduce a convenient param etrization of the transform ations  $G_{n,k}$ . Indeed, it can be easily veried that the  $G_{n,k}$ 's, for xed = (2s + 1)=2r, can be recast into the form

For a given , xing b, d and varying m from 1 to 1, a complete hierarchy of states is recovered as before [11] from  $G_m$  (0) and  $G_m$  (1). Furtherm ore, one has

which re ects the fact that the sequence of H all uid fractions converges to the fraction labelling a given m etallic state which de nest hat sequence. This point has to be compared to the general topology of the recently proposed phase diagram s for the quantum H alle ect where, roughly, each m etallic state (even denom inator state) appears to be surrounded by a de nite fam ily of H all liquid states (odd denom inator states). W e w ill discuss this point in section IV.

From the above parametrization (2.8), we now construct a shift operator A 2 (2) corresponding to each metallic state , which acts on the uid states (and possibly on the insulator state = 0). We de ne this shift operator A (which depends only on ) as the following operator product

The action of A to a given rational fraction p=q equals to  $G_m$  (0) or  $G_m$  (1) gives another rational fraction equals respectively to  $G_{m+1}$  (0) or  $G_{m+1}$  (1), so that A acts as a shift

operator, raising the number  $\tt m$  by one unit. The inverse operator (A )  $^1$  performs the corresponding lowering in  $\tt m$  .

The operators A satisfy the following relations

where [A] denotes the two by two matrix corresponding to the modular transformation A. Eqns. (2.14) and (2.15) are just a more consequence of the de nition of the group

(2). Notice that (2.14) rejects the parabolic nature of the transformations A which means that A may have no more than two xed points (which must be necessarily real [15]). Therefore, eqn.(2.13) means that the metallic state = (2s + 1)=2r is actually the unique xed point for the shift operator A. This last property may be extended to the case where r = 0, which corresponds to the point at in nity on the real axis.

III) V isibility diagram and dualdiagram .

We are now in position to introduce a diagram matic description that we nd particularly usefull and predictive for the classi cation of the quantum Hall states. This diagram matic tool, which permits one to obtain quantitative results on the di erent quantum Hall states is called the \visibility diagram " and has been already used in other areas of physics [13]. We will also introduce another diagram, hereafter called the dual diagram, which will allow us to extract in a straighforward way some of the information encoded in the visibility diagram.

IIIa) The visibility diagram .

This diagram is a simple pictorial device for the construction of Farey sequences [14] of rational numbers, each one being associated to a given vertex of a two dimensional square lattice.

Let us consider the two dimensional square lattice depicted on g. 1 where the vertices are indexed by a couple of positive or nul relatively prime integers (q;p). Since the action of (2) preserves the even or odd nature of q and since a special role is played by the even denom inator fractions in the sequel, we nd convenient to use di erent symbols (see g. 1) to separate the vertices belonging to a row with q even from those belonging to a q odd row. Therefore, the visibility diagram is made of the vertices of couples (q;p) of positive integers which are not hidden by any other vertex for an observer located at the origin (0;0). Notice that the origin is not considered as a visible point.

It is known in arithmetics that all the Farey ordered sequences  $F_n$ ; (n = 1;2;:::) of rational fractions p=q with p positive and 0 q n are in one to one correspondance with the visible vertices (q;p);0 q n. Strictly speaking, for any Farey sequence  $F_n$ , p and q are required to satisfy p n and q  $\in$  0; here, since we have in m ind to apply the above machinery to the fractional quantum Halle ect, we relax som show the above requirement, thus allowing fractions with p > n (and form ally the \in nite fraction" 1 1=0 () (0;1)).

Corresponding to this identication, the group (2) acts on the vertices of the visibility diagram in a rather simple way: it is actually represented by the linear action of two by two matrices on the two components (q;p) of the vertices, a property we will use in the following.

Now, it is easy to draw on the visibility diagram each fam ily of vertices corresponding to the previously introduced fractions  $G_m$  (0) and  $G_m$  (1).

Let us describe in details what kind of picture we obtain (see g.2). First of all, for a given = (2s + 1)=2, r = 1, the quantum H all rationals numbers  $G_m$  (0) and  $G_m$  (1), where m is any integer, are all located on each parallel sides of distinct unbounded bevelled left end side stripes. The two sides of each stripe start from the vertices (1;s) and (1;s + 1) and their slope is equal to = (2s + 1)=2, as it can be easily seen by using for instance (2.8) and (2.9) from which one obtains after som e algebra the equations de ning the two parallel sides of the stripes. They are given in the (q;p) plane by  $P = (\frac{2s+1}{2})Q = \frac{1}{2}$  where them inus (resp. plus) sign refers to the side starting from the vertex (1;s) (resp.(1;s+1)). This agrees with the generation m echanism we gave previously for each Jain type fam ily [11]; recall that, as far as the action of (2) is concerned, the couple of cusps (fsg;fs+1g) m ay be substituted to the equivalent couple (f0g;f1g). The m etallic state itself is shown to be surrounded on the visibility diagram by the fam ily of uid states (and eventually by the insulator whenever = 1=2) it generates. We will call such fam ilies ( = (2s + 1)=2) the principal stripes (r = 1).

G lued on each side of any principal stripe there is an in nite number of other secondary, tertiary... stripes (r = 2;3:::). They are all sim ilar in shape to a principal one: Two in nite parallel sides, a bevelled left end side and each one labelled by a metallic state

= (2s + 1)=2r. The states  $G_m$  (0) and  $G_m$  (1), with m any integer, are all located on the parallel sides of the stripe in such a way that each metallic state nd itself isolated from the other metallic states by the members of its family on a stripe of slope . Starting from the secundary stripes (r = 2), it is possible to construct families of tertiary stripes, quartenary stripes... and so on, families of stripes of any order. The equations de ning the two sides of a stripe of order r are easily derived from (2.8) and (2.9). They are given in the (q;p) plane by  $P = (\frac{2s+1}{2r})Q = \frac{1}{2r}$ . A pecularity appears on the diagram concerning the H all insulator state ( = 0). Its vertex representation is (1;0); clearly it pertains to a given family , only for = 1=2r(r 1). This last property could have some importance for a possible direct phase transition between that state and another state. The reader has certainly noticed that the quadrant p 0; q 0 is not completely covered by stripes, a (half) stripe shaped region is left uncovered, it is de ned by p 0; 0 q 1. We shall also com e back on this last pecularity.

On any fraction of any given stripe acts the step operator A or its inverse in such a way that the metallic state = (2s + 1)=2r located at the lattice vertex (2r;2s + 1) is a xed point for A . The uid states (and eventually the insulator state) on the edge of the corresponding stripe are all transformed among them selves under that action, any of them is in fact the image of a  $G_m$  (0) or a  $G_m$  (1) under some power of A and its inverse. In fact, all the information encoded in this diagram can be thoroughly reproduced by using the A and (A) <sup>1</sup>'s. This can be rephased by saying that the A 's are the algebraic counterpart of the graphical representation of the (tree-like) structures formed by the Hall states on the above diagram.

#### IIIb) The dual diagram

Observe that the previous structure on the visibility diagram is a mere consequence of a well-known theorem in arithmetics which states that, for any given two relatively prime positive integers p and q, there exist two other (necessarily relatively prime) positive integers a and b satisfying pb qa = 1 or pb qa = 1. U sing this theorem, it is easy now to realize that the set of (a;b) pairs stemming from these later equations, for xed (p;q) and q even, are all located on the two sides of the stripe labelled by  $= \frac{p}{q}$  depicted on g2.

But one could instead consider q odd so that another structure can be obtained on the visibility diagram where now stripes labelled by  $= \frac{p}{q}$  with q odd can be de ned as shown on g.3. We will call this resulting structure the dual diagram. Indeed, it can be easily seen that any stripe on g.2 corresponds to a given direction on the dual diagram (depicted by dotted lines on g.3), and conversely. This diagram will prove usefull to evaluate the relative ratios of the width of the Hall plateaus.

IV ) Physical discussion.

We are now in position to extract some physical inform ation from the two diagrams that have been de ned. We rst identify any fraction p=qwith the lling factor (what we implicitely assumed in the previous sections). This picture suggests that the (2) symmetry transform ations act on some parameter space describing the quantum Hall system. Recall that the metallic (resp. liquid) states are labelled by fractions with even (resp. odd) denominator.

First of all, keeping in m ind the above identi cation, it is obvious that our construction treats on an equal footing integer and fractional states. Now, consider the structure given on g. 2. One observes that each principal stripe bears self-sim ilar branched structure built from that stripe and all its descendants. Notice that the resulting global organization of the states in the stripes agrees quite well with the experim entally observed one. We point out that our construction predicts the existence of an in nite number of families with self-sim ilar (tree-like) structure. As far as the present experim ental situation is concerned, (see [18]), the Jain family = 1=2 corresponding on g.2 to the stripe with the largest width, has the m ost num erous well established observed states (N<sub>obs</sub> 13). The other observed families labelled respectively by = 3=2;1=4;3=4;5=2;5=4 and corresponding respectively to stripes of decreasing width are associated to a decreasing number of observed states (respectively N<sub>obs</sub> 7;6;5;4). Roughly speaking, this suggests that the width of a stripe m ay be related to the (experimental) di culty to observe the associated states. Notice that the insulator state = 0 (= 0=1 in our picture) does not label any stripe.

Now consider the action of the two generators of (2) given in (2.4) on the visibility diagram.  $T^2$  can be interpreted as a Landau shift operator; corresponds to a ux attachment operator. On the visibility diagram, the action of  $T^2$  on a vertex (q;p) gives rise to a vertical shift (q;p) ! (q;p + 2q) whereas the action of on (q;p) produces a horizontal shift (q;p) ! (q+2p;p). Since ux attachement can be obtained by magnetic eld variation, a variation of the magnetic eld is associated on the visibility diagram with a corresponding horizontal shift. Observe now that the stripes of the dual diagram are labelled by fractions with odd denom inator, each of which corresponding to a plateau in the H all conductivity. Putting all together, this suggests to identify (up to an overall dim ensionfull factor) the \horizontal "width of any stripe of the dual diagram de ned by the intercept of any horizontal line with that stripe with the width of the corresponding plateau. Notice that both integer and fractional plateaus are involved in this picture as already mentioned at the beginning of this section.

It is a straightforward computation to show that the  $\horizontal"$  width of any stripe labelled by = p=q is equal to 2=p. Then, the above identication leads to a prediction of all the ratios of the widths of the Hall plateaus given by

where () denotes the width of the plateau labelled by and can be expressed as

where the overall parameter  $_0$  has dimension of a magnetic eld. At this point, one important remark is in order. It is well known that the width of the plateaus decreases when the temperature increases so that for su ciently hight temperature the classical behavior for the Hall resistivity is recovered. Therefore, if the above identication is correct, eqn.(4.1) should be valid only at zero temperature.

Nevertheless, one m ight already expect to obtain a reasonably good agreement with the present (non zero temperature) experimental data. In order to check this, we have confronted the prediction (4.1) with an experimental resistivity plot [19]. To do this, we have to x two parameters. The rst one is the width of a given transverse resistivity plateau which will determ ine the value of  $_0$ . In the present numerical analysis, we choose to t this value with the = 3=2 experimental plateau. The second parameter is the position of the center of this choosen plateau on the to be determined resistivity plot. We assume that this plateau is centered around its corresponding lling factor value = 3=2. These two requirements will determine completely all the widths and positions on the other plateaus. The numerical result is shown on g.4 and exhibits a good agreement with the corresponding experimental plate (g.5).

## V) Conclusion.

In this paper we have exploited som e arithm etic properties linked with the classi cation of the quantum Hall states stem ming from the action of (2). These properties can be well synthetized in a graphical representation based on a visibility diagram, in which the resulting global organization of all the quantum Hall states is found to form (treelike) self-sim ilar structures. In particular, this structure is in com plete agreem ent with the (experim ental) hierarchy of observed states.

Furtherm ore, we used some of the arithmetic properties rooted in this construction together with a physical interpretation of the two generators of (2) to conjecture the (zero temperature) ratios of the widths of the Hall plateaus. Moreover, this suggests in

particular that the zero tem perature values of these ratios are universal. We tried to confront the predictions obtained from this conjecture to the present (non zero tem perature) experimental data by constructing numerically the corresponding resistivity plot. This latter is in good agreement with some experimental resistivity plot (see on g.5).

As it has been already mentionned in this paper, the (2) transform ations could be understood as an in nite set of discrete transform ations acting on some parameter space of the quantum Hall system. Therefore, it should be interesting to use this (2) symmetry to construct a model for the quantum Hall e ect, for instance in the spirit of ref. [9] and rst of ref. [10]. On the other hand, it should be also interesting to incorporate the

(2) sym m etry into a renorm alization group fram ework to study the possible relations it induces among the xed points that m ight provide some new insight on the possible origin of the superuniversality property shared by the observed transitions between H all states. These questions are presently under study.


