#### Abstract

$W$ e show that the $t J H$ am iltonian is not in general reduced to $H_{t} J=H(S ; f)$, $w$ here $S$ and $f$ stand for independent ( $[S ; f]=0) S U(2)$ (spin) generators and spinless ferm ionic (hole) eld, respectively. The proof is based upon an identi cation of the H ubbard operators w th the generators of the su (2j1) superalgebra in the degenerate fiundam ental representation and ensuing $S U$ (2 $\mathcal{j}$ ) path integral representation of the partition function $Z_{t}$ J. e-m ail:kochetov@ thsun1.̈̈nr.dubna su, fax num ber:(7) (096) (21)65084


## I. Introduction

It is by now w idely accepted that the J m odel, that is, the one-band H ubbard m odel in the large U -lim it, provides an adequate basis for the discussion of the essential physics for layered cooper oxide com pounds [1, 目]. An accurate description of the properties of charge carriers in high-tem perature superconductors arising from their interaction with the spin of the Cu atom s seem s to be crucial for the understanding of superconductivity in these $m$ aterials. Since there occurs a strong coupling betw een charge and spin degrees of freedom [3], the problem of a proper separation of spin and charge degrees of freedom in the $t \mathrm{~J}$ odel is of im portance in order to get an insight into an intenplay ofm agnetic and charge properties of relevant system $s$.

A popular approach has so far been that to introduce chargeless spinon and spinless holon operators in the fram ew ork of the slave ferm ion or slave boson $m$ ethod. The draw back of this approach is, however, that a certain local (at every lattioe site) constraint on spinon and holon operators is to be im posed in order to ensure the single occupancy of the electrons. A though the spinon and holon degrees of freedom are separated on the m ean eld level, they are strongly coupled by the gauge eld associated w ith uctuations around a m ean eld 4]. It has been recognized that while the rigorous im position of the constraint seem $s$ to pose a problem, its averaging, e.g., $m$ ean eld treatm ent results in a large error.

It seem $s$ therefore desirable to attem pt to explicitly form ulate the $t \mathrm{~J} \mathrm{~m}$ odelin term s of independent local spin and holon operators so that no constraint w ould be necessary. Som e recent developm ents point to the possibility to attain the goal starting from a new
kind of spin－ferm ion representation for the $H$ ubbard operators 5，6］．A though this rep－ resentation agrees w th the required com $m$ utation relations for the H ubbard operators，it im plies that the originalH ibert space is to be en larged，and as a result a certain constraint seem s to be necessary anyw ay to get rid of unphysical degrees of freedom．B esides，the en largem ent is not entirely xed in the scope of this approach．

In the present paper we show that the $t \quad J H$ am iltonian is not in general reduced to a polynom ialfunction ofindependentSU（2）（spin）and ferm ion（hole）variables，though that happens in the so－called linear spin wave approxim ation．W e address the problem from the general point of view，by considering the H ubbard operators as the generators of the su（2ㄱ）superalgebra and em ploying the ensuing $S U$（2才）path integral representation for the partition function．T he $S U(2 j)$ supersym $m$ etry happens to be the largest sym $m$ etry that underlies the $t \mathrm{~J} \mathrm{~m}$ odel［［ ］］．In essence，our approach is nothing but the geom etric quantization（also called the coherent state $m$ ethod）for quantum $m$ echanics associated w ith a sem isim ple Lie algebra 家，可，10］．It provides an e ective，in the sense it requires a $m$ in im alset ofvariables，description of a system $w$ ith a $H$ am iltonian that can be em bedded into a given $L$ ie（super）algebra．A s an exam ple，we m ay refer to the $S U$（2）path－integral representation of a partition function that has recently been em ployed to form ulate a non－ operator $m$ ean－eld diagram $m$ atic tednnique for the $H$ eisenberg $m$ odel 11］．$P$ ath integral associated with su（2j1）supercoherent states has proved to be helpful in order to justify the adiabatic approxim ation in the periodic A nderson model in the large $U$－lim it 12］．

The proof of the statem ent given in the abstract is quite simple，though it requires that som e necessary notation is to be introduced rst，so that a bulk of the paper serves to that purpose．Section II，as well as A ppendioes A，B and C are necessary to $m$ ake the proof given in section III quite transparent and plain．Section IV explains an exception that is provided by the linear spin wave theory．Section V contains som ecom ments on earlier results and concluding rem arks．

## II．t J m odel

Hence from now on the spin background is e ectively a ferrom agnetic one and one should not distinguish between sublattices anym ore. The original $H$ am iltonian (1) is then converted into

X ${ }^{0}$ appearing as a ferm ionic operator, whereas $X{ }^{0}$ correspond to bosonic degrees of freedom. In fact, representation $\mathrm{B}^{3}$ ) m eans that the X -operators are closed into the $u$ (2 1 ) superalgebra, which in view of (4) is reduced to the eight-dim ensional su (2ך1) superalgebra. To explicitly evaluate $\mathrm{H}^{\mathrm{cl}}$ one needs the SU (2j1) covariant sym bols of the generators.

Tuming back to the $t \mathrm{~J} m$ odel one notioes that the algebra of the X -operators can explicitly be identi ed w ith the degenerate ( $1=2 ; 1=2$ ) representation of su ( 271 ) in the follow ing way,

D im ension of this representation is equal to 3 as should be. It is also clear that Eq. A 2) holds true and hence we have explicitly identi ed the algebra of the $H$ ubbard operators $w$ th the degenerate fiundam ental (3 3 ) representation of the su (2ך1) superalgebra.

It is worth $m$ entioning that su (211) gives rise in a natural way to the slave ferm ion (slave boson) representation for the $H$ ubbard operators. T he latter appears as the so-called oscillator representation of the su (271) algebra [15]. For instance, let X 0 ; ; $0=1 ; 2 ; 3$ be a $m$ atrix corresponding to the operator $X$ in the $(1=2 ; 1=2)$ representation. $C$ onsider a com posite creation operator $d^{y}=\left(a^{Y} ; b^{y} ; f^{\mathrm{Y}}\right)$, where a and bstand forbosonic elds and $f$ for a ferm ionic one. $T$ hen, the slave ferm ion representation reads

where the last line is the com pleteness relation (4). In fact, this is nothing but a linear C asim ir operator of $u(2 j 1)$ whose eigenvalue xes a representation. T he low est possible value taken by the rhs and equal to 1 corresponds to the low est possible dim ension of the reprsentation space.

The su (2기) algebraic approach provides also a possible generalization of the standard $t \quad J H$ am iltonian to include particles w ith spin higher than $1=2$, which is necessary to properly form ulate a $1=s$ expansion. O ne possibility $m$ ight be to consider spin $s$ electrons,
which w ould correspond to the fundam ental representation of the su ( $2 \mathrm{~s}+1 \mathrm{j})$ ) superalgebra instead of su (2j1). An altemative procedure, since we are really interested in $s=1=2$, is to interpret the holes to be sites which have spin s $1=2$ [ $\beta$ ], so that the sites w thout a "hole" acquire spin (s $1=2$ ) $+1=2=s$. T he latter possibility am ounts to considering the $(q=s ; q=s)$ representation of $s u(2 j 1)$ rather than the $(q=1=2 ; q=1=2)$ fundam ental one. T he hole space is then identi ed w ith the set

## III. SU (2j1) path integral for the $t \quad J$ model

W ith the necessary background displayed above, one easily arrives at the $S U$ (2j1) path integral representation for the partition function

It m ight also be possible that a corresponding change of variables does not exist in principle, though both Eqs. 11) and (14) m ay contain the sam e physical in form ation, whidh would in tum $m$ ean that the path integral approach fails to provide a de nite answ er, which in itself is very unlikely.

O nce, on the other hand, one has succeeded w ith E q. 16) the next step to take w ould

N ote that there is one-to-one correspondence betw een $H_{S}$ f and its covariant sym bol 16]. $T$ he im portant point conceming this representation is that $z(t)$ and $z(t)$ can be considered to take values in $S^{2}$ in accordance w ith Eq. ( 3 ) ofA ppendix C. H ence, w e have succeeded in converting the $S U(2 \mathfrak{1})$ integral (11) into the $S U(2)$ and the purely ferm ionic ones. It is also seen from (19) and B.1, B 2) that $s(q)=q$, that is, we have arrived at the $S U$ (2) representation $w$ ith spin $s=q$. To sum $m$ arize, we have separated spin and charge variables at the kinem atical level. In other w ords, a possibility of the spin-charge variable separation for any $m$ odelexpressible in term $s$ of the $H$ ubbard operators depends solely on an explicit form of the H am iltonian.

Let us w rite down the function $\mathrm{H}_{\mathrm{t}}^{\mathrm{cl}} \mathrm{J}$ explicitly:

W hat conclusion can be drawn from this representation? Som e term $s$ can be view ed as covariant sym bols of spin-ferm ion interaction operators. For instance, the second line in Eq. 20) is sim ply a sym bol of the operator (see A ppendix B )

as well as there is no such $f(S)$ that would give rise to the square roots in the t-dependent term. It is also obvious that the change of the variables B.5) is of no use in order to get rid of the unw anted term $S$, and we nally conclude, there is no $H_{S} f$ such that Eq. 17) would hold.

To com plete the proof, two rem arks are in order. First, we com pare in fact classical actions (Lagrangians) (12) and (15) as well as related integration m easures (invariant volum e elem ents) rather than partition functions $Z_{t} J$ and $Z_{S}$. . This implies that a path integral does not seem to be indispensable for the above consideration. C lassical action can be obtained by standard m ethods. N am ely, given a (super)coherent state ji $w$ ith $z$ being a set of supercoordinates, one can obtain a corresponding action $A$ w the the help of equation

Second，it is not su cient for our purposes to m erely com pare $H$ am iltonians $H{ }_{t}^{c l}{ }_{\mathrm{J}}$ and $H_{S}^{\mathrm{cl}}$ ．The point is that canonical equations of $m$ otion that follow from the $H$ am iltonian action principle $A=0$ and read

## IV ．Linear sp in -w ave approxim ation

A $s$ is show $n$ in the preceding section it is in general im possible to reduce the $t \quad J$ ham iltonian to that of a spin－ferm ion interaction．N ow we dem onstrate how this can be achieved in the so－called linear spin－w ave（LSW ）approxim ation［17，18］，which e ectively corresponds to $s m$ all transverse uctuations of a spin around the $z$ axis．As is seen from Eq．B ．3），this $m$ athem atically means 立予 1 （in fact，文予 $=2 q \quad 1$ ）．The LSW theory has been successfiully exploited in thet J m odel，see the paper［1 $\$$ ］and references therein．

Here $f^{y}$ and $f$ stand for spinless hole operators，$n=f^{y} f$ ，while $S$ describes a local spin，$w$ ith $[5 ; f]=0$ ．It is im portant to recognized that $w$ hen deriving（24）we have not been forced to im pose any constraints（cf．Ref．［19］），since we have started o with Eq．［1］）that autom atically im plies no double occupied con gurations and $m$ ade no algebraic identi cations of the $\mathrm{H} u \mathrm{ub}$ bard operators with spin－ferm ion bilinears（cf．Ref． ［［］）．Representation（2324）coincides with that of Ref．19］，provided the $m$ ean－eld approxim ation $n_{i}=1$ ，where is the concentration of holes，is used．

A sim ilar $m$ ap has been em ployed in Ref．［G］except for a modi cation needed to explicitly recover the tim e－reversed sym metry of the $t \mathrm{~J} m$ odel．The latter is of no im portance for us here，so that later on we will keep referring to［5］，the $m$ ore so，as a trick suggested in［6］to consider an operator as a half－sum of the sam e operator taken in two di erent representations seem sto pose a problem．

It can be easily checked that Eqs．（25）recover correctly the algebra of the H ubbard operators w ithin the subspace（2d）．N evertheless，operators $S$ and $f$ cannot be considered as those describing independently a local spin and a holon．This results from the su（ 2 j ） （ $1=2 ; 1=2$ ）de ning relation（4）which in term s of（25）reads

This constraint is to be im posed in order to single out the three－dim ensional subspace 26） and plays the sam e role as Eq．（19）in the slave ferm ion representation does．

In this regard, basic results of $R$ ef. [5] where a $m$ otion of a hole has been investigated in representation (25) w ithout the constraint, should have been revisited.

then one would arrive at the representation 11) w ith a H am iltonian function describing a system quite distinct from the $t \mathrm{~J} \mathrm{~m}$ odel.

For the sake of com pleteness, it should be also mentioned that one can face an assertion that spin-charge degrees of freedom are separated in certain instances, e.g., when $\mathrm{H}_{\mathrm{t}} \mathrm{J}$ is treated on a m ean- eld level in a slave particle representation. This assertion is correct, though has nothing to do w ith Eq. 17). The point is that the above-m entioned separation holds for auxiliary elds related to electron spin and charge degrees of freedom. O nly som e xed com binations of those elds can be associated w th true spin variables. In the slave ferm ion representation (10) one has

whereas, for exam ple, operator a taken in itself cannot be identi ed w ith a spin variable. It would be therefore appropriate to refer th is case to as a spinon-charge separation rather
than the spin-charge one. Besides, this separation breaks dow $n$ beyond the $m$ ean- eld approxim ation.

To conclude, we have show $n$ that the $t \quad J H$ am iltonian cannot be in general reduced to that describing an interaction oftw o independent elds: localSU (2) spins and spinless ferm ions (holes), though this may occur in som e particular cases, e. $g$., in the linear spin wave approxim ation. The consideration is based upon a crucial fact that the $t \quad J$ H am iltonian can be em bedded into a representation of the su (2j) superalgebra, which provides us w th the SU (2게) path integral representation of the partition fiunction and, hence, w ith an e ective total action describing the system.

## A ppendix A

To m ake the exposition self-contained and for the reader's conven ience we place in Appendioes A, B and C som e inform ation conceming a de nition of the su (2翌) superalgebra and its representations as well as of related coherent states and path integrals.

A ppendix A serves to recapitulate the necessary ingredients conceming the su (2ㄱ) superalgebra and associated coherent states bearing in $m$ ind their relevance for the $t ~ J$ m odel.

To visualize a route in general, we start with som e prelim inary rem arks. G iven a Lie (super)algebra $g$ in an irreducible representation, one can construct associated (super)coherent states $j($ )i viewed as an overcom plete basis in the corresponding representation of a (super)group $G$, with ( ) specifying a point in the $G$ hom ogeneous (super)m anifold, an orbit of $G$ in the coadjoint representation [6, 9, 10]. G iven further a H am iltonian $H$ that appears as an elem ent of the $g$-enveloping algebra, one $m$ ay evaluate a partition function in the coherent-state basis, which naturally leads to a relevant coherent-state path integral 20, 14]. T he latter appears as a phase-space path integral and provides a quantization of $\mathrm{H}^{\mathrm{cl}}$ on a coadjoint onbit. The crucial point is that this quantization respects the underlying dynam ical (super)sym $m$ etry generated by $g$.

A $s$ is known, the $S U$ (2 11 ) supergroup in the fundam ental representation is the group of $(2+1)(2+1)$ unitary, unim odular superm atrices $w$ ith the $H$ erm itian con jugate operation. It is generated by even generators $f B ; Q_{3} ; Q_{+} ; Q \quad g$ and the odd ones $f W+; W \quad ; V_{+} ; V_{i}$ which satisfy the follow ing com m utation rules 21]:
