Non-Herm itian Ferm ion Mapping for One-Component Plasma

Abstract

The two-dimensional one-component logarithm ic Coulomb gas is mapped onto a nonherm itian fermionic eld theory. At = 2, the eld theory is free. Correlation functions are calculated and a perturbation theory is discussed for extending to other . A phase transition is found at the mean-eld level at large . Some results are extended to spaces of constant negative curvature.

1 Introduction

The problem of the statistical mechanics of a system of particles in a two-dimensional plane, all possessing the same sign of charge and interacting via a repulsive C oulom b interaction, has been looked at by a number of authors[1]. This is referred to as a one-component plasm a since all particles have the same sign of charge. The C oulom b interaction is logarithm ic in twodimensions which makes it possible to introduce a dimensionless inverse temperature such that the partition function of an N-particle system is equal to

where U (r) is some background potential and where z = x + it and $\overline{z} = x$ it are coordinates in the complex plane.

It is believed that at some of approximately 140 there is a rst order phase transition in the system [2]. Below the phase transition the system acquires long-range orientational order but does not acquire long-range positional order. The system is thus of interest as a model of crystallization. In the last section of the paper, we consider this model on a space of constant negative curvature. This may make it possible to look at e ects of frustration since it is not possible to form a hexagonal crystal lattice without defects on a negative curvature space[3].

This problem is exactly solvable at = 2 for a variety of background potentials. We introduce a new method of solving the problem, based on mapping to a non-herm itian eld theory, which may be easier to deal with for certain potentials. In addition, we look at a perturbation theory which perm its a mean-eld analysis of the phase transition in this theory.

2 Ferm ion M apping at = 2

As a a statistical mechanics system, the model, for a nite number of particles in a uniform background, is de ned by the partition function

We note that the factor $\overset{\emptyset}{\underset{i < j}{j_i}} z_j j$ in the partition function is equivalent to a correlation function in a free bosonic eld theory:

where the eld has the action $S = \frac{1}{2}^{R} dx dt (r)^{2}$.

We may then go to an in nite number of particles, and write the partition function as

It may be seen that, by perturbatively expanding the partition function in powers of $e^{i \frac{p}{4}}$, we recover the original statistical mechanics problem.

This equivalence between eqs. (2) and (4) is similar to the equivalence between the statistical mechanics of an plasm a consisting of both plus and minus charges and the eld theory of the sine-G ordon equation.

As is well known, the sine-G ordon equation at = 2 m appoints a problem of free massive ferm ions, while at other temperatures the equation m appoints the Thirring model, a model of

interacting massive ferm ions[4]. We will follow an analogous procedure in this case, leading to a non-herm it ian eld theory of ferm ions. All correlation functions will be given at = 2, while a perturbation theory in a four-ferm ion interaction will lead to other tem peratures.

Each term of the bosonic action translates into a given term of an action for relativistic fermions. The action S for the eld translates into $2 \text{ dx} \text{ dt }_{R}^{Y} @_{\overline{z} R} + {}_{L}^{Y} @_{z L}$. The term $e^{p \overline{4}} (x,t)$ translates into 2 a ${}_{L}^{Y} R$, where a is an ultraviolet cuto for the theory. The existence of only one kind of charge in the statistical mechanics theory leads to a non-herm itian eld theory.

It is seen that placing a charge in the statistical mechanics theory at a given point corresponds to turning a ferm ion at that point from a right-m over into a left-m over. The e ect of the neutralizing background charge is to turn left-m overs back into right-m overs via the anom aly. One may imagine the neutralizing background charge as a charge at in nity. We can write i as i \mathbb{Q}_t and integrate by parts to turn this into it \mathbb{Q}_t plus a boundary term. This then bosonizes into p^{p} -tJ_x, which is p^{-} t(p_{R}^{y} , p_{R}^{y}). This has the e ect of introducing a tim e-dependent chem ical potential which has di erent signs for the right- and left-m overs. If we in agine following the Hamiltonian evolution of the fermionic eld theory in in aginary time, right-moving particles are constantly converted into left moving particles, but the energy of the states keeps changing so that on average the number of holes in the negative energy sea is the same for the both chiralities. The e ect of the boundary term resulting from the integration by parts is that we must start at t = 1 with a state in which all right moving states (of both positive and negative energy) are led and all left-m oving states are empty and end at t = 1with a state in which all left-moving states are lled and all right-moving states are empty. Let us refer to the state at t = 1 as the state V . We will refer to the state at t = +1 as the state V^+ .

The nalaction for the ferm ion eld is

There are several ways of writing the background charge which correspond to choosing di erent gauges. The factor $p_{\overline{2}}$ is chosen to cancel a factor arising later from an integral of R dte $2 t^2$. It also serves to give the term in the action the correct dimensions. This factor is unimportant since the xed density of the background charge means, due to charge neutrality, that the number of particles in the statistical mechanics problem is xed and thus this factor just multiplies the partition function but does not a ect the physics.

3 Correlation Functions at = 2

We compute correlation functions for the ferm ionic eld and use them to then obtain correlation functions in the statistical mechanics problem. It will hopefully be clear in which theory a correlation function is being calculated.

We will compute propagators for the ferm ion eld as follows: we will rst compute the propagators for the case in which the two operators lie on the line t = 0. Then we will, in an appropriate gauge for the background charge, generalize to arbitrary position of the two operators.

In the operator form alism, we can write a two-point correlation function of elds (1); (2) as the expectation value

The term in the Hamiltonian, $R dx dt _L^y R$, can be written in Fourier components as $R \frac{dk}{2}a^y(k)_La(k)_R$. Each term in the integral is an eigenoperator of the rest of the Hamiltonian, with eigenvalue 2k + 4 t, and so it is easy to rewrite eq. (6) in terms of operators acting just at time t = 0 as follows

The simplest two-point function to compute is $h^{y}(k)_{L} a(k)_{R}$ i. In the expectation value of eq. (8), for each k the operators $a^{y}(k)_{L}$ and $a(k)_{R}$ must appear exactly once. It is clear then that $Z = \frac{Q}{k} e^{1}$. This is $\frac{Y}{e^{\frac{k^{2}}{2}}} e^{\frac{k^{2}}{2}}$ (9)

By inserting the operator $a^{y}(k)_{L}a(k)_{R}$ into the expectation value, we remove one term from the product of eq. (9). This term is $e^{\frac{k^{2}}{2}}$. Therefore, $ha^{y}(k)_{L}a(k)_{R}i = e^{\frac{k^{2}}{2}}$. In real space this is $\frac{q}{2}e^{\frac{\pi}{2}x^{2}}$, and in an appropriate gauge it becomes $\frac{q}{2}e^{\frac{\pi}{2}y^{2}}$.

We next compute the function $ha^{y}(k)_{L}a(k)_{L}$. We note that initially all left-moving states are unoccupied at t = 1. Then all states are occupied at t = 1. If the state with momentum k is occupied at t = 0 then this gives a contribution of 1 to the desired two-point function. If it is unoccupied, then there is a contribution of 0. Therefore the desired two-point function is

In real space, this is $\frac{1}{2 \text{ iz}} e^{-\frac{1}{2} \frac{\dot{r}}{J}^2}$, where an appropriate gauge must be used to extend correlation functions o the line t = 0.

The function in which both left-m oving operators are replaced by right-m oving operators is similar. The result is $\frac{1}{2 i \overline{z}} e^{-\frac{1}{2} j \cdot \hat{f}}$.

The most interesting two-point function to compute is $ha^{y}(k)_{R}a(k)_{L}i$. This requires that one $a^{y}(k)_{L}a(k)_{R}$ operator appear at time t < 0 and one must appear at time t > 0. Therefore, the two-point function is

where E i is the exponential integral function.

Having computed the propagators, it is trivial to compute correlation functions in the statistical mechanics theory. Let us compute the two-point particle correlation function at = 2.

This is obtained by the expectation value $h^{p} \overline{2}_{L}^{y}(0) = (0)^{p} \overline{2}_{L}^{y}(z) = (z)i$. There are two ways to pair o the operators in this expression using W ick's theorem . The result is

which agrees with the known result.

4 Perturbation Theory

By adding to the action of the ferm ionic theory a term of the form $(-)^2$, we will, due to the bosonization rules, change the value of . An attractive interaction will raise , while a repulsive interaction will lower . We will employ a simple mean-eld type procedure: the interaction will be decoupled into an interaction with an external gauge eld. Then, we will integrate out the ferm ionic eld to obtain an action for the gauge eld. It will be found that at su ciently high, nite the quadratic term in the action for the gauge eld will change sign. This will be identied as the location of a second order phase transition. It will then be argued that cubic term s appear in the action for the gauge eld, and will convert the phase transition to rst order.

For a given value of , the desired ferm ionic action is

We can write the interaction term by introducing an external gauge eld $A_{R,L}$. The action for the gauge eld plus the coupling between the gauge eld and the ferm ion eld is

It will turn out, when we compute various diagrams, that results will not be gauge invariant. This is unrelated with the particle choice of gauge we made to compute propagators, and instead is a result of the boundary conditions due to the neutralizing background eld. The theory is also not invariant under charge conjugation. This implies that Furry's theorem [5] need not hold, and we may obtain contributions from ferm ion diagrams with an odd number of photon vertices attached. This will then convert the second order transition into a weakly rst order transition.

Let us not compute the quadratic term s in the action for $A_{R,L}$ resulting from integrating out . There are three di erent types of diagram s which must be considered, which involve computing di erent current-current correlation functions. We may have to compute a correlation function involving two currents of the same chirality. This will be considered not. We may have to compute a correlation function involving currents of the opposite chirality. This correlation function splits into two pieces: one piece which may be obtained by naively calculating diagram s, and one piece which is a result of the need for a regulator eld to get rid of divergences.

The introduction of the quadratic term will change the action of the gauge eld, as a function of wavevector k, to

All that needs to be computed now are some current-current correlators.

The current-current correlation function $hJ_R(0)J_R(z)i$ is equal to $\frac{1}{(2z)^2}e^{-\frac{|z|^2}{2}}$. We must take the Fourier transform of this at a given momentum k. In order to do this, it is necessary to introduce a massive regulator eld. W ithout the term $e^{-\frac{|z|^2}{2}}$ in the correlator, the Fourier transform of $1=z^2$ is known to be $\frac{1}{4} \frac{k_L^2}{k_T^2}$, where k_L is equal to $k_x - ik_t$, k_R is equal to $k_x + ik_t$, and $\frac{|z|^2}{2} = k_L k_R$. The term $e^{-\frac{|z|^2}{2}}$ multiplies the rest of the correlator in real space and thus convolves with the correlator in Fourier space. The k-th Fourier component of the current-current correlator in momentum space is then $R = \frac{k_L}{4} \frac{1}{k_R} \frac{1}{4} \frac{k_R}{k_R} = \frac{\frac{|z|^2}{4}}{4}$. This integral can be performed analytically and the result is $\frac{1}{4} \frac{k_L^2}{k_T^2} (1 - e^{-\frac{|z|^2}{4}})$. It is seen that at large k the current-current correlator is unchanged from the correlator for a ferm ionic system with no non-herm itian term . The correlation function of two left-m oving currents is calculated in the sam e way, sin ply replacing k_L by k_R and vice-versa.

The naive contribution to the correlator of two currents of opposite chirality is given by $hJ_R(0)J_L(z)i$. This is $\frac{1}{4} \text{ Ei}(\frac{j}{2}z^2)$. The Fourier transform is $\frac{1}{4} \frac{R}{dx} dx dt \int_{1}^{R} \frac{da}{a} e^{ikx} e^{a(x^2+t^2)}$. Doing the integral over x and t rst, we obtain $\frac{1}{4} \int_{1}^{R} \frac{da}{a^2} e^{-\frac{jkz^2}{4a}}$. Changing from a to 1=a, this equals $\frac{k^2}{k^2}(1 e^{-\frac{k^2}{4}})$.

The necessity of introducing a massive regulator eld to compute the correlation function

of two currents of the same chirality gives an additional contribution to the correlation function of two currents of opposite chirality. This piece is in nitely short range, and so independent of k. It is equal to $\frac{1}{4}$. For the ferm ionic system with no non-herm itian term, such a piece is needed to maintain gauge invariance.

Even without looking closely at the Fourier transform of the current-current correlators, we may easily see that there will be an instability for nite at the level of the quadratic action for $A_{L,R}$. For the fermionic system with no non-herm it ian term, the quadratic term changes sign, for all k transverse to the direction of the gauge eld, at = 1, which corresponds to a

nite value of the attractive interaction. By adding the non-herm it ian terms to the action, we have altered the quadratic terms. The correlation function of two currents of the same chirality has been reduced, but the reduction decays exponentially for large k f. The correlation function of two currents of the opposite chirality has been increased by an amount which decays only algebraically for large k f. Thus, for su ciently large k f, the term which is added to the action of the $A_{L,R}$ eld is increased and the intability will occur at a lower value of the attractive interaction. This corresponds to an instability at a nite value of .

Let us locate the transition temperature in this lowest order theory. The response to a gauge eld is strongest when the eld is transverse. The response then is (sum ming all di erent term s and taking $A_R = A_L$)

This function is equal to $\frac{1}{2}$ at k = 0 and k = 1. The function increases in magnitude as k increases from 0, until it hits a maximum, then decreases again. Numerically, the maximum is at $k = 4.74711^{p}$. At this wavevector, we not that the theory goes unstable at a temperature of = 15:4036.

In a mean-eld approximation, in the absence of cubic terms, the instability discussed in the quadratic action for $A_{R,L}$, would lead to a second order transition. It will now be shown that cubic terms are non-vanishing and that this transition becomes rst order. Due to the complexity of the diagrams, we will not explicitly compute the cubic and quartic terms, and will simply show that the cubic term is non-vanishing.

In 2 dimensions Furry's theorem is very easy to prove for a massive or massless D irac eld. If we have a ferm ion loop with an odd number of vertices, we may imagine reversing the direction of the propagation of the ferm ion around the loop. This will change the sign of all propagators which preserve chirality (propagators of the form h_{R}^{y} rior h_{L}^{y} is of the ferm ion

eld, and preserve the sign of all propagators that change chirality. Since the ferm ion must have the same chirality after it goes around the loop, there are an even number of propagators which change chirality, and thus an odd number of propagators which preserve chirality. This means that the total sign of the diagram changes when reversing the direction of propagation around the loop and thus the total contribution from both directions is zero.

For the non-herm itian theory considered here, the above proof breaks down. When reversing the direction of propagation around the loop, we may change some propagators from h $_{\rm L}^{\rm Y}(z_1)_{\rm R}(z_2)$ it to h $_{\rm R}^{\rm Y}(z_2)_{\rm L}(z_1)$ i. Since the non-herm itian theory lacks charge conjugation invariance, these two propagators have dimensional erent values, and thus the two contributions do not cancel. Thism eans that cubic terms do appear in the action for A_{R,L} and the transition becomes

rst order. It should be noted that these cubic terms are intrinsically not gauge invariant, since they vanish in a gauge in which $A_L = 0$ or $A_R = 0$.

5 Extension to Curved Space

W e will also consider this model on a space of constant negative curvature. W e m ay de ne such a space in the half-plane given by Im (z) > 0, or equivalently, t > 0. W e will use a conform al gauge for the metric such that $ds^2 = \frac{2}{t^2} (dx^2 + dt^2)$. Then the scalar curvature R = 1.

It is easy to transcribe the action for the bosonic eld to this curved space and the result is

W hen going to a ferm ionic action, one must be slightly careful. The curved space means that in order to maintain the same ultraviolet cuto a when measured in length $p \frac{1}{ds^2}$ everywhere, the ultraviolet cuto when measured in length $p \frac{1}{dx^2 + dt^2}$ must vary proportional to t. Therefore, the operator $e^{\frac{p}{4}}$ (x,t) bosonizes into something proportional to (2 t) $\frac{y}{L}$ R

This means that the nal ferm ionic action for the curved space problem is

In this action, the density, , is dimensionless, as we have picked units in which the curvature is one. We can use 1= to measure the curvature of the manifold in units of particle spacing squared. As ! 1, we expect to recover the at space results. It is now possible to proceed as before and calculate propagators. We will simplify and sketch the calculation of only h $_{L}^{y}$ R i. We restrict to the line t = 1. The only new feature that emerges is that the nal state is dierent. The initial state, jV i, is still a state in which all right-moving states are occupied and all left-moving states are empty. The system starts in this state at time t = 0. However, there is no term left from the integration by parts at t = 1 and therefore the system ends in the vacuum state jV i which is the normal vacuum state for a the free ferm ion theory, where all negative energy states are lied and all positive energy states are empty.

Following a similar procedure as before, we move all $_{L}^{y}$ R operators resulting from the Hamiltonian evolution to the time t = 1. There, an operator $a^{y}(k)_{L}a(k)_{R}$ comes with the amplitude

This is equal to $\int_{0}^{\hat{R}} dt \frac{1}{t^{1-8}} e^{2k(t-1)}$, which is proportional to $e^{2k} \frac{1}{jt^{\frac{1}{3}}}$. Therefore, ha^y(k)_L a(k)_R i at t = 0 is proportional to $e^{2k} \frac{1}{jt^{\frac{3}{3}}}$. Due to the initial and nal states, j i and j i, the propagator is non-vanishing only for k < 0, when this Fourier transforms to $\frac{1}{(1-\frac{ix}{2})^{1+8}}$.

The result for the correlation function in the statistical mechanics problem, obtained from calculating h $^{y}(0)_{L}$ $(0)_{R}$ $(x)_{L}$ $(x)_{R}$ i, is

If we take a limit as goes to in nity, and appropriately rescale x to measure length in the local particle spacing, the correlation function turns back into a Gaussian, as in the at space case. Recall that the distance between two points on the line t = 1, located at x = 0 and x = x is, measured in the metric for the negative curvature space, less than x. In reality it goes logarithm ically with x for large x. Thus, the actual decay of correlations in the curved space problem is exponential, as would be expected from a high-tem perature expoansion. The slower decay of the correlations in the curved space case, exponential instead of Gaussian, indicates that screening is less elective than in at space.

6 Conclusion

A new formulation has been given of the one-component plasma problem. This provides an alternative way of deriving old results. This technique may turn out to be simpler than others for certain background potentials. In addition, the perturbation theory of this model in terms of ferm ionic operators is very di erent from the previously developed perturbation theory for the statistical mechanics theory [6], and may lead to easier calculations.

In particular, we located an instability of the theory at the quadratic level. It must be noted that the location of the second order transition in this theory, at = 15:4036, is approximately an order of magnitude lower than the actual location of a st order transition. A lso, the appearance of cubic term s, while converting the second order transition to rst order, will further lower the transition . This is evidence that the higher order corrections to the e ective action for the gauge eld are not negligible. How ever, the manner in which the transition tem perature is calculated makes this number very sensitive to small adjustments in the e ective action; one must calculate the response functions in the ferm ionic theory and then relate to the reciprocal of the change in the action for the gauge theory. The act of taking the reciprocalm akes this procedure less accurate. Unfortunately, we are also unable to understand the particular wavevector which goes unstable, as we do not see how to easily relate this wavevector to any spacing in a triangular lattice. In addition, since the order parameter is a vector, it is possible to construct a mean- eld state that breaks orientational sym metry but not translational sym metry (constant non-vanishing gauge eld). This would require that the rst wavevector to go unstable would be at k = 0. This does not happen yet at the one-loop level, though one would expect it would happen to higher orders.

However, we may hope that the perturbation series for the elective action of the gauge eld will be convergent, order by order in $(1=2 \ 1=)$, as the only actual instability of the theory is at = 1. This implies a radius of convergence of 1=2, and thus the theory should converge for 1 < < 1. A rguments like D yson's instability argument for the non-convergence of the perturbation series do not apply here since there is no instability near = 2[7]. To make this convergence more clear, it may help to adjust units so that the action for the gauge eld is

$$Z = \frac{s}{dx dt A_R A_L} + \frac{1}{4} \left(\frac{1}{2} - \frac{1}{2}\right) (A_R J_R + A_L J_L)$$

to avoid what may look like a singularity at = 2. Thus, a su ciently high order calculation in

this theory should yield the e ective action for the gauge eld, which can then be treated in a mean-eld fashion to, in principle, extract the transition properties with arbitrary accuracy. Of course, the series might diverge at the point of a second order phase transition due to infrared problem s, but since a rst order phase transition is expected to occur before the second order transition, this is not a problem.

Finally, the model has been considered on a curved manifold. The two-point correlations in the original statistical model have an exponential decay instead of a G aussian decay. Since the decay of this quantity relects the elects of screening, it seems that on a curved manifold the system screens less well. This may be due to an elect of frustration, introduced by the curvature. It would be interesting to extend the perturbation theory to a curved manifold, both to look at the RPA as well as to look at correlation functions away from = 2. It is believed from a perturbation theory for the original statistical mechanics model[6] that the correlation functions on a at space begin to show short-range order as soon as > 2. This means a low est order perturbation theory calculation for the curved space may show interesting frustration elects.
