# Non Herm itian Ferm ion M apping for O ne-C om ponent $P$ lasm a

A bstract

The two-dim ensional one-com ponent logarithm ic C oulom b gas is m apped onto a nonhem itian ferm ionic eld theory. At $=2$, the eld theory is free. Correlation functions are calculated and a perturbation theory is discussed for extending to other . A phase transition is found at the $m$ ean- eld level at large . Som e results are extended to spaces of constant negative curvature.

## 1 Introduction

The problem of the statistical $m$ echanics of a system of particles in a two-dim ensional plane, all possessing the sam e sign of charge and interacting via a repulsive C oulombinteraction, has been looked at by a num ber of authors [1]. This is referred to as a one-com ponent plasm a since all particles have the same sign of charge. The Coulomb interaction is logarithm ic in twodim ensions which $m$ akes it possible to introduce a dim ensionless inverse tem perature such that the partition function of an $N$-particle system is equal to

where $U(r)$ is som e background potential and where $z=x+$ it and $\bar{z}=x$ it are coordinates in the com plex plane.

It is believed that at som e of approxim ately 140 there is a rst order phase transition in the system 目]. Below the phase transition the system acquires long-range orientational order
but does not acquire long-range positional order. T he system is thus of interest as a m odel of crystallization. In the last section of the paper, we consider this m odel on a space of constant negative curvature. This may make it possible to look at e ects of frustration since it is not possible to form a hexagonal crystal lattioe $w$ ithout defects on a negative curvature space 3 ].

This problem is exactly solvable at $=2$ for a variety of background potentials. W e introduce a new $m$ ethod of solving the problem, based on $m$ apping to a non-herm titian eld theory, which may be easier to deal with for certain potentials. In addition, we look at a perturbation theory which perm its a m ean- eld analysis of the phase transition in this theory.

## 2 Ferm ion M apping at $=2$

A s a a statistical $m$ echanics system, the $m$ odel, for a nite num ber of particles in a uniform background, is de ned by the partition function

$W$ e note that the factor $\dot{\mathrm{K}}_{\mathrm{i}} \mathrm{z}_{\mathrm{j}} j$ in the partition function is equivalent to a correlation function in a free bosonic eld theory:

W em ay then go to an in nite number of particles, and write the partition function as

It $m$ ay be seen that, by perturbatively expanding the partition function in powers of $e^{p^{p}} \overline{4}$, we recover the original statisticalm echanics problem.

This equivalence betw een eqs. (1) and (4) is sim ilar to the equivalence betw een the statistical mechanics of an plasm a consisting of both plus and $m$ inus charges and the eld theory of the sine-G ordon equation.

A $s$ is well know $n$, the sine-G ordon equation at $=2 \mathrm{~m}$ aps onto a problem of free m assive ferm ions, while at other tem peratures the equation m aps onto the T hirring m odel, a m odel of
interacting m assive ferm ions[县]. W e will follow an analogous procedure in this case, leading to a non-herm itian eld theory of ferm ions. All correlation functions willbe given at $=2$, while a perturbation theory in a four-ferm ion interaction will lead to other tem peratures.

Each term of the bosonic action translates into a given term of an action for relativistic
 $e^{i^{p} \overline{4}}(x, t)$ translates into $2 a \underset{L}{y} \quad R$, where $a$ is an ultraviolet cuto for the theory. The existence ofonly one kind of charge in the statisticalm echan ics theory leads to a non-hem itian eld theory.

It is seen that placing a charge in the statistical $m$ echanics theory at a given point corresponds to tuming a ferm ion at that point from a right-m over into a left-m over. The ect of the neutralizing background charge is to tum left-m overs back into right-m overs via the anom aly. O ne $m$ ay im agine the neutralizing background charge as a charge at in nity. We can write i as i Gt and integrate by parts to tum this into itd $t_{t}$ phis a boundary term . This then bosonizes into ${ }^{\mathrm{P}} \mathrm{t}_{\mathrm{t}} J_{\mathrm{x}}$, which is $\mathrm{P}-\mathrm{t}(\underset{R}{\mathrm{Y}} \quad \mathrm{R} \quad \underset{R}{\mathrm{y}} \quad \mathrm{R})$. This has the e ect of introducing a tim e-dependent chem ical potential which has di erent signs for the right-and left-m overs. If we im agine follow ing the H am iltonian evolution of the ferm ionic eld theory in im aginary tim e, right-m oving particles are constantly converted into left $m$ oving particles, but the energy of the states keeps changing so that on average the num ber of holes in the negative energy sea is the sam e for the both chiralities. The ect of the boundary term resulting from the integration by parts is that we m ust start at $t=1$ with a state in which all right-m oving states (of both positive and negative energy) are lled and all left-m oving states are em pty and end at $t=1$ w ith a state in which all left-m oving states are lled and all right-m oving states are em pty. Let us refer to the state at $t=1$ as the state $V$. W e w ill refer to the state at $t=+1$ as the state $\mathrm{V}^{+}$.

The nalaction for the ferm ion eld is Z

There are several w ays of w riting the background charge which correspond to choosing di erent gauges. The factor ${ }^{\mathrm{P}} \overline{2}$ is chosen to cancel a factor arising later from an integral of ${ }^{R}$ dte ${ }^{2} t^{2}$. It also serves to give the term in the action the correct dim ensions. $T$ his factor is unim portant since the xed density of the background chargem eans, due to charge neutrality, that the num ber of particles in the statisticalm echanics problem is xed and thus this factor just multiplies the partition function but does not a ect the physics.

## 3 C orrelation Functions at $=2$

W e com pute correlation functions for the ferm ionic eld and use them to then obtain correlation functions in the statistical mechanics problem. It $w$ ill hopefully be clear in which theory a correlation function is being calculated.

W e w ill com pute propagators for the ferm ion eld as follow s: we will rst com pute the propagators for the case in whidh the two operators lie on the line $t=0$. Then we will, in an appropriate gauge for the background charge, generalize to arbitrary position of the two operators.

In the operator form alism, we can w rite a tw o-point correlation function of elds (1); (2) as the expectation value

The term in the H am iltonian, ${ }^{R} d x d t \underset{L}{Y} \quad R$, can be w ritten in Fourier com ponents as ${ }^{R} \frac{d k}{2} a^{y}(k)_{L} a(k)_{R}$. Each term in the integral is an eigenoperator of the rest of the $H$ am iltonian, $w$ ith eigenvahe $2 k+4$ t, and so it is easy to rew rite eq. 6) in term sof operators acting just at timet=0 as follow $s$

The sim plest tw o-point function to com pute is ha ${ }^{Y}(k)_{L} a(k)_{R}$ i. In the expectation value of eq. (宿), for each $k$ the operators $a^{y}(k)_{L}$ and $a(k)_{R}$ m ust appear exactly once. It is clear then ${ }^{R} p_{2} e^{2} t^{2}+2 k t d t$

By inserting the operator $a^{Y}(k)_{L} a(k)_{R}$ into the expectation value, we rem ove one term from the product of eq. (G). This term is $e^{\frac{k^{2}}{2}}$. Therefore, $h^{y}(k)_{L} a(k)_{R} i=e^{\frac{k^{2}}{2}}$. In real space this is $\overline{2} e^{q} \bar{x}^{2}$, and in an appropriate gauge it becom es $\overline{L_{2}} e^{\overline{2}} \bar{z}^{j}$.

W e next com pute the function $\mathrm{ha}^{\mathrm{Y}}(\mathrm{k})_{\mathrm{L}} \mathrm{a}(\mathrm{k})_{\mathrm{L}}$. W e note that intially all left m oving states are unoccupied at $t=1$. Then all states are occupied at $t=1$. If the state $w$ ith $m$ om entum $k$ is occupied at $t=0$ then this gives a contribution of 1 to the desired two-point function. If it is unoccupied, then there is a contribution of 0 . Therefore the desired two-point function is

T he function in which both left-m oving operators are replaced by right-m oving operators


The most interesting two-point function to com pute is ha ${ }^{y}(k)_{R} a(k)_{L}$ i. This requires that one $a^{y}(k)_{L} a(k)_{R}$ operator appear at timet<0 and one must appear at timet>0. $T$ herefore, the two-point function is

where $\mathrm{E} i$ is the exponential integral function.
H aving com puted the propagators, it is trivial to com pute correlation functions in the statisticalm echanics theory. Let us com pute the two-point particle correlation function at $=2$.
 to pair o the operators in this expression using $W$ idk's theorem. T he result is

## 4 Perturbation Theory

By adding to the action of the ferm ionic theory a term of the form ( $)^{2}$, we will, due to the bosonization rules, change the value of . A n attractive interaction will raise, while a repulsive interaction will lower. We will em ploy a sim ple m ean- eld type procedure: the interaction willbe decoupled into an interaction $w$ ith an extemal gauge eld. Then, we will integrate out the ferm ionic eld to obtain an action for the gauge eld. It will be found that at su ciently high, nite the quadratic term in the action for the gauge eld will change sign. Thisw ill be identi ed as the location of a second order phase transition. It w ill then be argued that cubic term $s$ appear in the action for the gauge eld, and $w$ ill convert the phase transition to rst order.

For a given value of , the desired ferm ionic action is

W e can write the interaction term by introducing an extemal gauge eld $A_{R} ; L$. The action for the gauge eld plus the coupling between the gauge eld and the ferm ion eld is

where we de ne $\Phi=: \underset{R}{y} \quad R$ : and $J_{L}=: \underset{L}{y} \quad$ L : and where $A_{R}$ is the complex conjugate of $A_{L}$. It will tum out, when we compute various diagram s, that results will not be gauge invariant. This is unrelated w th the particle choice of gauge we m ade to com pute propagators, and instead is a result of the boundary conditions due to the neutralizing background eld. The theory is also not invariant under charge conjugation. This im plies that Furry's theorem 目] need not hold, and we m ay obtain contributions from ferm ion diagram swith an odd num ber of
photon vertioes attached. This will then convert the second order transition into a weakly rst order transition.

Let us rst com pute the quadratic term $s$ in the action for $A_{R} ; L$ resulting from integrating out . There are three di erent types of diagram $s$ which must be considered, which involve com puting di erent current-current correlation functions. W em ay have to com pute a correlation function involving two currents of the sam e chirality. This will be considered rst. W em ay have to com pute a correlation function involving currents of the opposite chirality. This correlation function splits into tw o pieces: one piece which $m$ ay be obtained by naively calculating diagram s , and one piece which is a result of the need for a regulator eld to get rid of divergences.

The introduction of the quadratic term will change the action of the gauge eld, as a function of $w$ avevector $k$, to

All that needs to be com puted now are som e current-current correlators.
$T$ he current-current correlation function $h J_{R}(0) J_{R}(z) i$ is equal to $\frac{1}{(2 z)^{2}} e \quad \dot{k} \dot{J}^{2}$. W e $m$ ust take the Fourier transform of this at a given $m$ om entum $k$. In order to do this, it is necessary to introduce a m assive regulator eld. W ithout the term $e^{\dot{k} j^{2}}$ in the correlator, the Fourier transform of $1=z^{2}$ is know $n$ to be $\frac{1}{4} \frac{k_{L}^{2}}{k \mathcal{J}^{2}}$, where $k_{L}$ is equal to $k_{x} \quad i k_{t}, k_{R}$ is equal
 space and thus convolves w the correlator in Fourier space. The $k$-th Fourier com ponent of the current-current correlator in $m$ om entum space is then ${ }^{R}{d k_{L}}_{L} d k_{R} \frac{1}{4} \frac{l^{\prime}}{l_{R}} e^{\frac{j k}{4} j^{2}}$. This integral can be perform ed analytically and the result is $\frac{1}{4} \frac{k_{\mathrm{L}}^{2}}{\mathrm{k}^{2}}\left(\begin{array}{l}1 \\ \left.e^{\frac{\mathrm{kj}^{2}}{4}}\right) \text {. It is seen that at large } \mathrm{k}\end{array}\right.$ the current-current correlator is unchanged from the correlator for a ferm ionic system w th no non-herm itian term. The correlation function of two left-m oving currents is calculated in the sam e way, sim ply replacing $k_{L}$ by $k_{R}$ and vige-versa.

T he naive contribution to the correlator of two currents of opposite chirality is given by $h J_{R}(0) J_{L}(z) i$. This is $\overline{4} E i\left(\dot{\zeta}^{\prime}{ }^{\prime}\right)$. The Fourier transform is $\mu_{4}^{R} d x d t{ }_{1}^{R} \frac{d a}{a} e^{i k x} a\left(x^{2}+t^{2}\right)$.
 equals $\frac{k^{2}}{}\left(1 \quad e^{\frac{k^{2}}{4}}\right)$.

The necessity of introducing a $m$ assive regulator eld to com pute the correlation function
of tw o currents of the sam e chirality gives an additional contribution to the correlation function of two currents of opposite chirality. This piece is in nitely short range, and so independent of $k$. It is equal to $\frac{1}{4}$. For the ferm ionic system $w$ ith no non-herm itian term, such a piece is needed to $m$ aintain gauge invariance.

E ven w ithout looking closely at the Fourier transform of the current-current correlators, wem ay easily see that there willbe an instability for nite at the level of the quadratic action for $A_{L ; R}$. For the ferm ionic system w ith no non-herm itian term, the quadratic term changes sign, for all $k$ transverse to the direction of the gauge eld, at $=1$, which corresponds to a nite value of the attractive interaction. By adding the non herm itian term $s$ to the action, we have altered the quadratic term $s$. The correlation function of tw o currents of the sam e chirality has been reduced, but the reduction decays exponentially for large $k j$. T he correlation fiunction of two currents of the opposite chirality has been increased by an am ount which decays only algebraically for large $\mathrm{k}^{\jmath}$. Thus, for su ciently large $\mathrm{k} \jmath$, the term whidh is added to the action of the $A_{L ; R} \quad$ eld is increased and the intability will occur at a lower value of the attractive interaction. This corresponds to an instability at a nite value of .

Let us locate the transition tem perature in this low est order theory. $T$ he response to a gauge eld is strongest when the eld is transverse. The response then is (sum m ing all di erent term $s$ and taking $A_{R}=A_{L}$ )

$T$ his function is equal to $\frac{1}{2}$ at $k=0$ and $k=1$. The function increases in $m$ agnitude as $k$ increases from 0, until it hits a maxim um, then decreases again. $N$ um erically, the $m$ axim um is at $k=4: 74711^{\mathrm{P}}-$. At this wavevector, we nd that the theory goes unstable at a tem perature of $=15: 4036$.

In a $m$ ean- eld approxim ation, in the absence of cubic term $s$, the instability discussed in the quadratic action for $A_{R}$; , w ould lead to a second order transition. It $w$ ill now be show $n$ that cubic term $s$ are non-vanishing and that this transition becom es rst order. D ue to the com plexity of the diagram $s$, wew ill not explicitly com pute the cubic and quartic term $s$, and will sim ply show that the cubic term is non-vanishing.

In 2 dim ensions Furry's theorem is very easy to prove for a m assive or $m$ assless D irac eld. If we have a ferm ion loop with an odd num ber of vertices, we m ay im agine reversing the direction of the propagation of the ferm ion around the loop. This will change the sign of all
propagators which preserve chirality (propagators of the form $h \underset{R}{Y} R_{R}$ i or $h \underset{L}{y}$ Li) of the ferm ion eld, and preserve the sign of all propagators that change chirality. Since the ferm ion $m$ ust have the sam e chirality after it goes around the loop, there are an even num ber of propagators w hidh change chirality, and thus an odd num ber of propagators which preserve chirality. This m eans that the total sign of the diagram changes when reversing the direction of propagation around the loop and thus the total contribution from both directions is zero.

For the non-herm itian theory considered here, the above proof breaks down. W hen reversing the direction of propagation around the loop, we m ay change som e propagators from $h \underset{L}{Y}\left(z_{1}\right) \quad R\left(z_{2}\right) i$ to $h \underset{R}{Y}\left(z_{2}\right) \quad L\left(z_{1}\right) i$. Since the non herm itian theory lacks charge conjugation invariance, these two propagators have di erent values, and thus the two contributions do not cancel. Thism eans that cubic term $s$ do appear in the action for $A_{R} ; L$ and the transition becom es rst order. It should be noted that these cubic term s are intrinsically not gauge invariant, since they vanish in a gauge in which $A_{L}=0$ or $A_{R}=0$.

## 5 Extension to Curved Space

Wew ill also consider this model on a space of constant negative curvature. Wemay de ne such a space in the half-plane given by $\operatorname{Im}(z)>0$, or equivalently, $t>0$. W e will use a conform al gauge for the $m$ etric such that $d s^{2}=\frac{2}{t^{2}}\left(d x^{2}+d t^{2}\right)$. Then the scalar curvature $R=1$.

It is easy to transcribe the action for the bosonic eld to this curved space and the result is

W hen going to a ferm ionic action, one m ust be slightly carefiul. T he curved space m eans that in order to $m$ aintain the sam e ultraviolet cuto $a$ when $m$ easured in length $p \overline{d s}{ }^{2}$ everywhere, the ultraviolet cuto when m easured in length $p \overline{d x^{2}+d t^{2}} m$ ust vary proportional to $t$. Therefore, the operator ${ }^{R} e^{i^{i}} \overline{4}(x, t)$ bosonizes into som ething proportional to (2 t) $\frac{y}{L} R$
$T$ his $m$ eans that the nal ferm ionic action for the curved space problem is Z

In this action, the density, , is dim ensionless, as we have picked units in which the curvature is one. W e can use $1=$ to $m$ easure the curvature of the $m$ anifold in units of particle spacing squared. As ! 1 , we expect to recover the at space results.

It is now possible to proceed as before and calculate propagators. We will sim plify and sketch the calculation of only $h \underset{L}{Y} R i . W$ e restrict to the line $t=1$. The only new feature that em erges is that the nal state is di erent. T he initial state, NV i, is still a state in which all right-m oving states are occupied and all left-m oving states are em pty. $T$ he system starts in this state at tim e $t=0$. H ow ever, there is no term left from the integration by parts at $t=1$ and therefore the system ends in the vacuum state JV iwhich is the norm al vacuum state for a the free ferm ion theory, where all negative energy states are lled and all positive energy states are em pty.

Follow ing a sim ilar procedure as before, wem ove all $\underset{L}{y} \quad R$ operators resulting from the H am ittonian evolution to the time $t=1$. There, an operator $a^{y}(k)_{L} a(k)_{R}$ com es w th the am plitude

D ue to the initial and nalstates, $\ddagger V$ i and $f v i$, the propagator is non-vanishing only for $k<0$, when this Fourier transform $s$ to $\frac{1}{\left(1 \quad i \frac{x}{2}\right)^{1+8}}$.
$T$ he result for the correlation function in the statistical $m$ echanics problem, obtained from calculating $h \quad y(0)_{L} \quad(0)_{R} \quad(x)_{L} \quad(x)_{R}$ i, is

If we take a lim it as goes to in nity, and appropriately rescale x to m easure length in the local particle spacing, the correlation function tums badk into a G aussian, as in the at space case. Recall that the distance betw een two points on the line $t=1$, located at $x=0$ and $x=x$ is, $m$ easured in the $m$ etric for the negative curvature space, less than $x$. In reality it goes logarithm ically w ith $x$ for large $x$. Thus, the actual decay of correlations in the curved space problem is exponential, as would be expected from a hightem perature expoansion. The slow er decay of the correlations in the curved space case, exponential instead of G aussian, indicates that screening is less e ective than in at space.

## 6 C onclusion

A new formulation has been given of the one-com ponent plasm a problem. This provides an altemative way of deriving old results. $T$ his technique $m$ ay tum out to be sim pler than others for certain background potentials. In addition, the perturbation theory of this $m$ odel in term $s$ of ferm ionic operators is very di erent from the previously developed perturbation theory for the statistical $m$ echanics theory [6], and $m$ ay lead to easier calculations.

In particular, we located an instability of the theory at the quadratic level. It must be noted that the location of the second order transition in this theory, at $=15: 4036$, is approxim ately an order of $m$ agnitude low er than the actual location of a nst order transition. A lso, the appearance of cubic term s, while converting the second order transition to rst order, will further lower the transition. This is evidence that the higher order corrections to the e ective action for the gauge eld are not negligible. H ow ever, them anner in which the transition tem perature is calculated $m$ akes th is num ber very sensitive to $s m$ alladjustm ents in the e ective action; onem ust calculate the response functions in the ferm ionic theory and then relate to the reciprocalof the change in the action for the gauge theory. T he act oftaking the reciprocalm akes this procedure less accurate. Unfortunately, we are also unable to understand the particular w avevector which goes unstable, as we do not see how to easily relate this wavevector to any spacing in a triangular lattice. In addition, since the order param eter is a vector, it is possible to construct a $m$ ean- eld state that breaks orientational sym $m$ etry but not translational sym m etry (constant non-vanishing gauge eld). Thiswould require that the rst wavevector to go unstable would be at $k=0$. This does not happen yet at the one-loop level, though one would expect it would happen to higher orders.

H ow ever, we m ay hope that the perturbation series for the e ective action of the gauge eld w illbe convergent, order by order in (1=2 $1=$ ), as the only actual instability of the theory is at $=1$. This im plies a radius of convergence of $1=2$, and thus the theory should converge for $1 \ll 1$. A rgum ents like Dyson's instability argum ent for the non-convergence of the perturbation series do not apply here since there is no instability near $=2$ 7]. To make this convergence $m$ ore clear, it $m$ ay help to adjust units so that the action for the gauge eld is

to avoid what $m$ ay look like a singularity at $=2$. Thus, a su ciently high order calculation in
this theory should yield the e ective action for the gauge eld, which can then be treated in a $m$ ean- eld fashion to, in principle, extract the transition properties w ith arbitrary accuracy. O f course, the series $m$ ight diverge at the point of a second order phase transition due to infrared problem s , but since a nst order phase transition is expected to occur before the second order transition, this is not a problem .

F inally, the m odelhas been considered on a curved $m$ anifold. T he two-point correlations in the original statistical $m$ odel have an exponential decay instead of a $G$ aussian decay. Since the decay of this quantity re ects the ects of screening, it seem $s$ that on a curved $m$ anifold the system screens less well. Thism ay be due to an e ect of frustration, introduced by the curvature. It would be interesting to extend the perturbation theory to a curved $m$ anifold, both to look at the RPA as well as to look at correlation functions aw ay from $=2$. It is believed from a pertunbation theory for the original statisticalm echanics m odel[]] that the correlation functions on a at space begin to show short-range order as soon as $>2$. This m eans a low est order perturbation theory calculation for the curved space $m$ ay show interesting frustration e ects.
