# On-Line A daTron Learning of Unlearnable Rules

# Abstract

We study the on-line A daT ron learning of linearly non-separable rules by a simple perceptron. Training examples are provided by a perceptron with a non-monotonic transfer function which reduces to the usual monotonic relation in a certain limit. We nd that, although the on-line A daT ron learning is a powerful algorithm for the learnable rule, it does not give the best possible generalization error for unlearnable problem s. Optimization of the learning rate is shown to greatly improve the perform ance of the A daT ron algorithm, leading to the best possible generalization error for a wide range of the param eter which controls the shape of the transfer function.

The problem of learning is one of the most interesting aspects of feed-forward neural networks [1{3]. Recent activities in the theory of learning have gradually shifted toward the issue of on-line learning. In the on-line learning scenario, the student is trained only by the most recent example which is never referred to again. In contrast, in the o-line (or batch) learning scheme, the student is given a set of examples repeatedly and memorizes these examples so as to minimize the global cost function. Therefore, the on-line learning has several advantages over the o-line method. For example, it is not necessary for the student to memorize the whole set of examples, which saves a lot of memory space. In addition, theoretical analysis of on-line learning is usually much less complicated than that of o-line learning which often makes use of the replica method.

In m any of the studies of learning, authors assume that the teacher and student networks have the same structures. The problem is called learnable in these cases. However, in the real world we nd innumerable unlearnable problems where the student is not able to perfectly reproduce the output of teacher in principle. It is therefore both important and interesting to devote our e orts to the study of learning unlearnable rules.

If the teacher and student have the same structure, a natural strategy of learning is to m odify the weight vector of student J so that this approaches teacher's weight  $J^0$  as quickly as possible. However, if the teacher and student have di erent structures, the student trained to satisfy  $J = J^0$  sometimes cannot generalize the unlearnable rule better than the student with  $J^6 J^0$ . Several years ago, W atkin and R au [4] investigated the o -line learning of unlearnable rule where the teacher is a perceptron with a non-monotonic transfer function while the student is a simple perceptron. They discussed the case where the number of examples is of order unity and therefore did not derive the asymptotic form of the generalization error in the lim it of large number of training examples. Furthermore, as they used the replica method under the replica symmetric ansatz, the result may be unstable against replica symmetry breaking.

For such a type of non-m onotonic transfer function, a bt of interesting phenom ena have been reported. For example, the critical bading rate of the model of Hop eld type [5{7] or the optim all storage capacity of perceptron [8] is known to increase dram atically by nonm onotonicity. It is also worth noting that perceptrons with the non-m onotonic transfer function can be regarded as a toy model of a multilayer perceptron, a parity machine [9].

In this context, Inoue, N ishim ori and K abashim a [10] recently investigated the problem of on-line learning of unlearnable rules where the teacher is a non-monotonic perceptron: the output of the teacher is  $T_a(v) = \text{sign}[v(a - v)(a + v)]$ , where v is the input potential of the teacher v p(v(a - v)(a + v)), where v is the input potential of the teacher v n(v(a - v)(a + v)), where v is the input potential perceptron. For this system, di culties of learning for the student can be controlled by the width a of the reversed wedge. If a = 1 or a = 0, the student can be controlled by the width a of the reversed wedge. If a = 1 or a = 0, the student can learn the rule perfectly and the generalization error decays to zero as  $1^{=3}$  for the conventional perceptron learning algorithm and  $1^{=2}$  for the Hebbian learning algorithm, where is the number of presented examples, p, divided by the number of input nodes, N. For nite a, the student cannot generalize perfectly and the generalization error converges exponentially to a non-vanishing a-dependent value.

In this paper we investigate the generalization ability of student trained by the online A daTron learning algorithm with examples generated by the above-mentioned nonmonotonic rule. The A daTron learning is a powerful method for learnable rules both in on-line and o -line modes in the sense that this algorithm gives a fast decay, proportional to <sup>1</sup>, of the generalization error [11{13], in contrast to the <sup>1=3</sup> and <sup>1=2</sup> decays of the perceptron and H ebbian algorithm s. We investigate the perform ance of the A daTron learning algorithm in the unlearnable situation and discuss the asymptotic behavior of the generalization error.

This paper is organized as follows. In the next section, we explain the generic properties of the generalization error for our system and formulate the on-line A daTron learning. Some of the results of our previous paper [10] are collected here concerning the perceptron and Hebbian learning algorithms which are to be compared with the A daTron learning. Section

3

III deals with the conventional A daT ron learning both for learnable and unlearnable rules. In Sec. IV we investigate the e ect of optim ization of the learning rate. In Sec. V the issue of optim ization is treated from a di erent point of view where we do not use the parameter a, which is unknown to the student, in the learning rate. In last section we sum marize our results and discuss several future problem s.

## II.THE MODEL SYSTEM

Let us not x the notation. The input signal comes from N input nodes and is represented by an N -dimensional vector x. The components of x are random by drawn from a uniform distribution and then x is normalized to unity. Synaptic connections from input nodes to the student perceptron are also expressed by an N -dimensional vector J which is not normalized. The teacher receives the same input signal x through the normalized synaptic weight vector  $J^0$ . The generalization error is  $_g$  ( $T_a(v)S(u)$ ), where S(u) = sign(u) is the student output with the internal potential u  $\frac{p}{N}(J = x) = jJj$  and stands for the average over the distribution function

Here R stands for the overlap between the teacher and student weight vectors, R  $(J^{f} J) = J_{JJJ} J_{J}$ . This distribution has been derived from random ness of x and is valid in the lim it N ! 1.

The generalization error  $_{\rm q}$  is easily calculated as a function of R as follows [10]

where H (x)  $\binom{R_1}{x}$  Dtwith Dt exp  $(\frac{1}{2}=2)=\frac{p}{2}$ . It is important that this expression is independent of speci c learning algorithm. M in imization of E (R) with respect to R gives the theoretical lower bound, or the best possible value, of the generalization error for given a. In Fig. 1 we show E (R) for several values of a. This gure indicates that the generalization error goes to zero if the student is trained so that the overlap R becomes 1 for a = 1 and R = 1 for a = 0. If the parameter a is larger than some critical value  $a_1 = \frac{p}{2\log 2} = 1:177$ , E (R) decreases monotonically from 1 to 0 as R increases from 1 to 1. When a is smaller than  $a_{c1}$ , a local minimum appears at R = R  $q = \frac{q}{(2\log 2 - a^2) = 2\log 2}$ , but the global minimum is still at R = 1 as long as a is larger than  $a_{c2} = 0.80$ . If a is less than  $a_{c2}$ , the global minimum is found at R = R, not at R = 1. This situation is depicted in Figs. 2 and 3 where we show the optimal overlap R giving the smallest value of E (R) and the corresponding best possible value of the generalization error as functions of a. From these two gures, we see that the optimal overlap which gives the theoretical lower bound shows a rst-order phase transition at  $a = a_{c2}$ .

Therefore, our e orts should be directed to nding the best strategy which gives the best possible value of the generalization error for a wide range of the parameter a.

It may be useful to review some of the results of, Inoue, N ishim ori and K abashim a [10] who studied the present problem under the perceptron and H ebbian algorithms. For the conventional perceptron learning, the generalization error decays to zero as <sup>1=3</sup> if the rule is learnable (a = 1), whereas it converges to a non-vanishing value E (R = 1 2), where

exp ( $a^2=2$ ), exponentially for the unlearnable case. This value of E (R) is larger than the best possible value as seen in Fig. 3. Introduction of optimization processes of the learning rate improves the performance signicantly in the sense that the generalization error then converges to the best possible value when  $a > a_{c2}$ . For the conventional Hebbian learning, the generalization error decays to the theoretical lower bound as <sup>1=2</sup> not only in the learnable limit a! 1 but for a nite range of a,  $a > a_{c1}$ . However, for  $a < a_{c1}$ , the generalization error does not converge to the optimilar value.

### III.LEARNING DYNAM ICS

The on-line training dynamics of the A daTron algorithm is

where m stands for the number of presented patterns and g() is the leaning rate. It is straightforward to obtain the recursion equations for the overlap  $R^m = (J^m \quad [J]=jJ^m \quad jjJ^0 j$ and the length of the student weight vector  $I^m = jJ^m \stackrel{p}{\rightarrow} N$ . In the lim it N ! 1, these two dynam ical quantities become self-averaging with respect to the random training data x. For continuous time = m=N in the lim it N ! 1, m ! 1 with kept nite, the evolutions of R and lare given by the following di erential equations [10]:

Equations (4) and (5) determ ine the learning process. In the rest of the present section we restrict ourselves to the case of g = 1 corresponding to the conventional A daT ron learning.

## A.Learnable case

We rst consider the case of g() = 1 and a = 1, the learnable rule. We investigate the asymptotic behavior of the generalization error when R approaches 1, R = 1 ", "! 0 and

l = l<sub>0</sub>, a constant. From Eqs. (6) and (8), we nd  $E_{Ad}$  c<sup>p=2</sup> and  $G_{Ad}$  (c  $2 \overline{2}=$ )<sup>n=2</sup> with c = 8=(3  $\overline{2}$ ). Then Eq. (5) is solved as " = (2=k)<sup>2</sup> <sup>2</sup> with

U sing this equation and Eq. (2), we obtain the asymptotic form of the generalization error as

The above expression of the generalization error depends on  $l_0$ , the asymptotic value of  $l_1$ , through k. Apparently  $l_0$  is a function of the initial value of l as shown in Fig. 4. A special case is  $l_0 = 1=2$  in which case 1 does not change as learning proceeds as is apparent from Eq. (4) as well as from Fig. 4. Such a constant-lproblem was studied by Biehland Riegler [11] who concluded

for the A daT ron algorithm. Our formula (10) reproduces this result when  $l_0 = 1=2$ . If one takes  $l_0$  as an adjustable parameter, it is possible to minimize  $_g$  by maximizing k in the denominator of Eq. (10). The smallest value of  $_g$  is achieved when  $l_0 = c=2^p \overline{2}$ , yielding

which is smaller than Eq. (11) for a xed 1. We therefore have found that the asymptotic behavior of the generalization error depends upon whether or not the student weight vector is normalized and that a better result is obtained for the un-normalized case. We plot the generalization error for the present learnable case with the initial value of  $l_{init} = 0.1$  in Fig. 5. We see that the Hebbian learning has the highest generalization ability and the A daT ron learning shows the slowest decay among the three algorithms in the initial stage of learning. However, as the number of presented patterns increases, the A daT ron algorithm eventually achieves the smallest value of the generalization error. In this sense the A daT ron learning algorithm is the most e cient learning strategy among the three in the case of the learnable rule.

For unlearnable case, there can exist only one xed point  $l_0 = 1=2$ . This reason is, for nite a,  $E_{Ad}$  appearing in Eq. (4) does not vanish in the limit of large and  $E_{Ad}$  has a nite value for a  $\pm 1$  . For this nite E  $_{Ad}$ , the above di erential equation has only one xed point  $l_0 = 1=2$ . In contrast, for the learnable case,  $E_{Ad}$  behaves as  $E_{Ad} = c^{10=2}$  in the limit of ! 1 and thus dl=d becomes zero irrespective of lasym ptotically. We plot trajectories in the R-l plane for a = 2 in Fig. 6 and the corresponding generalization error is plotted in Fig. 7 as an example. From Fig. 6, we see that the destination of l is 1=2 for all initial conditions. Figure 7 tells us that for the unlearnable case a = 2, the A daT ron learning has the lowest generalization ability among the three. We should notice that the generalization  $^{1=2}$  for the error decays to its asymptotic value, the residual error  $m_{in}$ , as  $q_{min}$ Hebbian learning and decays exponentially for perceptron learning [10]. The residual error of the Hebbian learning  $m_{in} = 2H$  (a) is also the best possible value of the generalization error for  $a > a_{c2}$  as seen in Fig. 3. In Fig. 8 we also plot the generalization error of the A daTron algorithm for several values of a. For the A daTron learning of the unlearnable case, the generalization error converges to a non-optim alvalue E ( $R_0$ ) exponentially.

For all unlearnable cases, the R-l ow is attracted into the xed point (R  $_0$ ;1=2), where R  $_0$  is obtained from

The solution  $R_0$  of the above equation is not the optim al value because the optim al value of the present learning system is  $R_{opt} = 1$  for  $a > a_{c2}$  and  $R_{opt} = R = \frac{q}{(2\log 2 - a^2) = 2\log 2}$ for  $a < a_{c2}$  [10].

From Figs. 3 and 7, we see that the residual error  $m_{in}$  of the A daTron learning is larger than that of the conventional perceptron learning. Therefore, we conclude that if the student learns from the unlearnable rules, the on-line A daTron algorithm becomes the worst strategy among three learning algorithm s as we discussed above although for the learnable case, the on-line A daT ron learning is a sophisticated algorithm and the generalization error decays to zero as quickly as the o -line learning [14].

## IV.OPTIM IZATION

In the previous section, we saw that the on-line A daTron learning fails to get the best possible value of the generalization error for the unlearnable case and its residual error  $m_{in}$  is larger than that of the conventional perceptron learning or Hebbian learning. We show that it is possible to overcom e this di culty.

We now consider an optimization the learning rate g() [10]. This optimization procedure is dimensioned in the technique of K inouchi and Caticha [15]. As the optimial value of R which gives the best possible value of the generalization error is  $R_{opt} = 1$  for  $a > a_{c2}$ , we determine g() so that R is accelerated to become 1. In order to determine g using the above strategy, we maximize the right hand side of Eq. (5) with respect to g() and obtain  $g_{opt} = (E_{Ad}R - G_{Ad}) = RE_{Ad}$ . Using this optimial learning rate, Eqs. (4) and (5) are rewritten as follows

For the learnable case, we obtain the asymptotic form of the generalization error from Eqs. (14) and (15) by the same relation R = 1 ", "! 0 as we used for the case of g = 1 as

This is the same asymptotic behavior as that obtained by optimizing the initial value of l as we saw in the previous section.

Next we investigate the unlearnable case. The asymptotic form  $s of E_{Ad}$  and  $E_{Ad}R = G_{Ad}$ in the limit of ! 1 are obtained as

Then we get the asymptotic solution of Eq. (15) with respect to ", R = 1 ", as

As the asymptotic behavior of E (R) is obtained as E (R) =  $_g = 2H$  (a) + p = [10], we not the generalization error in the limit of ! 1 as follows

where 2H (a) is the best possible value of the generalization error for  $a > a_{c2}$ . Therefore, our strategy to optim ize the learning rate succeeds in training the student to obtain the optim all overlap R = 1 for  $a > a_{c2}$ .

For the perceptron learning, this type of optim ization failed to reach the theoretical lower bound of the generalization error for a exactly at  $a = a_{c1} = \frac{p}{2\log 2}$  in which case the generalization error is  $_g = 1=2$ , equivalent to a random guess because for  $a = a_{c1}$  optim al learning rate vanishes [10]. In contrast, for the A daT ron learning, the optim al learning rate has a non-zero value even at  $a = a_{c1}$ . In this sense, the on-line A daT ron learning with optim al learning rate is superior to the perceptron learning.

#### V.PARAMETER-FREE OPTIM IZATION

In the previous section, we were able to get the theoretical low er bound of the generalization error for  $a > a_{c2}$  by introducing the optim al learning rate  $g_{opt}$ . How ever, as the optim al learning rate  $g_{opt}$  contains a parameter a unknown to the student, the above result can be regarded only as a low er bound of the generalization error. The reason is that the student can get inform ation only about teacher's output and no know ledge of a or  $v = {p \over N} (J^0 x) = {p \over 2} J_{J}$ .

In realistic situations, the student does not know a or v and therefore has a larger value of the generalization error. In this section, we construct a learning algorithm without the unknown parameter a using the asymptotic form of the optimal learning rate.

### A . Learnable case

For the learnable case, the optim al learning rate is estimated in the limit of ! 1 as

This asymptotic form of the optim al learning rate depends on only through the length 1 of student's weight vector. We therefore adopt g() proportional to l, g() = l, also in the case of the parameter-free optimization and adjust the parameter so that the student obtains the best generalization ability. Substituting this expression into the dimential equation (5) for R and using R = 1 "with "! 0, we get

In order to minimize  $_{g}$ , we maximize F () with respect to . The optimal choice of in this sense is  $_{opt} = 3=2$  and we not in such a case

This is the same asymptotic form as the previous a-dependent result (16).

#### B.Unlearnable case

Next we consider the unlearnable case. The asymptotic form of the learning rate we derived in the previous section for the unlearnable case is

where we used Eq. (19) to obtain the right-m ost equality and we set the a-dependent prefactor of l as . Using this learning rate (26) and the asymptotic forms of  $E_{Ad}$  (R = 1 ";"! 0) and  $G_{Ad}$  (R = 1 ";"! 0) as  $E_{Ad}$  2H (a)+ $\frac{q}{2}$ = a and  $G_{Ad}$  4a "= $\frac{p}{2}$ + $E_{Ad}$  in the limit of ! 1, we obtain the dimension with respect to " from Eq. (5) as follows

This di erential equation can be solved analytically as

where A is a constant determ ined by the initial condition. Therefore, if we choose to satisfy  $4a = \frac{p}{2}$  1 > 0, the generalization error converges to the optim alvalue 2H (a) as

In order to obtain the best generalization ability, we minimize the prefactor of  $1 = p^{p}$  in the second term of Eq. (29) and obtain

For this , the condition  $4a = p \frac{p}{2}$  1 > 0 is satisfied. In general, if we take independent of a, the condition  $4a = p \frac{p}{2}$  1 > 0 is not always satisfied. The quantity b  $4a = \frac{p}{2}$  takes the maximum value  $4 = p \frac{p}{2}$  e at a = 1. Therefore, whatever value of a we choose, we

cannot obtain the <sup>1=2</sup> convergence if the product of this maximum value  $4=\frac{p}{2}$  e and is not larger than unity. This means that should satisfy  $>\frac{p}{2}$  e=4' 1:033 for the rst term of Eq. (28) dominate asymptotically, yielding Eq. (29), for a non-vanishing range of a. In contrast, if we choose to satisfy b 1 < 0, the generalization error is dominated by the second term of Eq. (28) and behaves as

In this case, the generalization error converges less quickly than (29). For example, if we choose = 1, we nd that the condition b > 1 cannot be satistical by any a and the generalization error converges as in Eq. (31). If we set = 2 (>  $p = \frac{p}{2} = 4 = 1.033$ ) as another example, the asymptotic form of the generalization error is either Eq. (29) or Eq. (31) depending on the value of a.

#### VI.CONCLUSION

We have investigated the generalization abilities of a simple perceptron trained by the teacher who is also a simple perceptron but has a non-monotonic transfer function using the on-line A daTron algorithm. For the learnable case (a = 1), if we x the length of the student weight vector as  $l = jI = \frac{p}{N} = 1=2$ , the generalization error converges to zero as 3=(2) as Biehl and Riegler reported [11]. However, if we allow the time development

of the length of student weight vector, the asymptotic behavior of the generalization error shows dependence on the initial value of 1. When the student starts the training process from the optim allength of weight vector 1, we can obtain the generalization error  $_{\rm g}$  4=(3) which is a little faster than 3=(2). As the student is able to know the length of its own weight vector in principle, we can get the better generalization ability  $_{\rm g}$  4=(3) by a heuristic search of the optim al initial value of 1. On the other hand, if the width a of the reversed wedge has a nite value, the generalization error converges exponentially to a non-optim al a-dependent value. In addition, these residual errors are larger than those of

the conventional perceptron learning for the whole range of a. Therefore we conclude that, although the A daTron learning is powerful for the learnable case [11] including the situation in which the input vector is structured [13], it is not necessarily suitable for learning of the non-m onotonic input-output relations.

Next we introduced the learning rate and optimized it. For the learnable case, the generalization error converges to zero as 4=(3) which is as fast as the result obtained by selecting the optim al initial condition for the case of non-optimization, g = 1. For this learnable case, the asymptotic form of the optimial learning rate is  $g_{opt}$  31=2. Therefore, for the on-line A daT ron learning, it seems that the length of the student weight vector plays an important role to obtain a better generalization ability. If the task is unlearnable, the generalization error under optimized learning rate converges to the theoretical lower bound 2H (a) as  $^{1}$  for  $a > a_{c2}$ . U sing this strategy, we can get the optimial residual error for a residual error [10].

We also investigated the generalization ability using a parameter-free learning rate. When the task is learnable, we assumed  $g_{opt} = 1$  and optimized the prefactor . As a result, we obtained g = 4=(3) which is the same asymptotic form as the parameter-dependent case. Therefore, we can obtain this generalization ability by a heuristic choice of ; we may choose the best by trial and error. On the other hand, for the unlearnable case, we used the asymptotic form of the a-dependent learning rate in the limit of  $! 1, g_{opt} = ! = .$  and optimized the coe cient . The generalization error then converges to 2H (a) as 1=2 for b > 1. If b < 1, the generalization error decays to 2H (a) as b = 2, where the exponent b = 2 is smaller than 1=2 because b < 1. Similar slowing down of the convergence rate of the generalization error by tuning a control parameter was also reported by K abashim a and Shinom oto in the problem of learning of two-dimensional blurred dichotomy [16].

In conclusion, we could overcome the disculty of the A daTron learning of unlearnable problem s by optimizing the learning rate and the generalization error was shown to converge to the best possible value as long as the width a of reversed wedge satis es  $a > a_{c2}$ . For the

parameter region  $a < a_{c2}$ , this approach does not work well because the optimal value of R is R instead of 1; our optimization is designed to accelerate the increase to R toward 1.

In this paper, we could construct a learning strategy suitable to achieve the a-dependent optim al value 2H (a) for  $a > a_{c2}$ . However, for  $a < a_{c2}$ , it is a very di cult but challenging future problem to get the optim al value by in proving the conventional A daT ron learning.















