Random matrix models with log-singular level con nement: method of ctitious fermions

A bstract

Joint distribution function of N eigenvalues of U (N) invariant random—m atrix ensemble can be interpreted as a probability density to nd N ctitious non-interacting ferm ions to be con ned in a one-dimensional space. W ithin this picture a general form alism is developed to study the eigenvalue correlations in non-G aussian ensembles of large random matrices possessing non-monotonic, log-singular level connement. An elective one-particle Schrodinger equation for wave-functions of ctitious fermions is derived. It is shown that eigenvalue correlations are completely determined by the Dyson's density of states and by the parameter of the logarithmic singularity. Closed analytical expressions for the two-point kernel in the origin, bulk, and soft-edge scaling limits are deduced in a unied way, and novel universal correlations are predicted near the end point of the single spectrum support.

1 Introduction and basic relations

Random matrices are the eld-theoretical models which study the universal features of physical phenomena resulting from the symmetry constraints only. This is the reason why quite dierent physical problems get a unied mathematical description within the framework of the random-matrix theory [1]. In particular, the applicability of so-called invariant matrix model given by the joint distribution function

ofN eigenvalues f g ofa large N $\,$ N $\,$ random m $\,$ atrix H $\,$ ranges from the problem of two-dim ensional gravity [2], through the spectral properties of the D $\,$ irac operator in quantum $\,$ chrom odynam ics [3], to the m esoscopic electron transport in norm al and superconducting quantum $\,$ dots [4, 5]. Here the eigenvalues f g belong to entire real axis, $\,$ 1 $\,$ 4 f g $\,$ 4 + 1 , and the partition function $\,$ 7 is determined from the norm alization condition $\,$ 8 N $\,$ 9 of f g = 1. Param eter

in Eq. (1) accounts for the sym metry of the problem , is a free parameter associated with a logarithm ic singularity, while v () is a non-singular part of the con nement potential

It is implied that dimension N of the matrix H is large enough, N 1. In this therm odynam ic lim it the matrix model Eq. (1) becomes exactly solvable.

Dierent physics, that is behind the model introduced, deals with dierent regions of spectrum that can be explored in the corresponding scaling limits. Up to now, the most study received the random-matrix ensemble Eq. (1) with U(N) symmetry (=2), where three types of universal correlations have been established in the origin [6,7], bulk [8,9,10,11], and soft-edge [12,13] scaling limits. Corresponding eigenvalue correlations are described by the universal Bessel, sine, and Gmulticritical kernels, respectively. Various scaling limits of the model Eq. (1) have been investigated by using dierent methods, so that a unied treatment of the problem of spectral correlations in U(N) invariant ensembles is still absent. The purpose of this paper is to present a unied approach allowing us to explore the spectral properties of the U(N) invariant matrix model Eq. (1) with elective log-singular level connement in an arbitrary spectrum range.

The following representation [1] of the joint distribution function $_{\rm N}$ (f g) is well-known in the random -m atrix theory:

As far as $_0$ takes the form of the Slater determ inant, $_{\rm N}$ (f g) can be thought of as a probability density to $\,$ nd N $\,$ non-interacting ctitious ferm ions in the quantum states $'_0; :::;'_{\rm N}$ $_1$ at the \spatial" points $_1; :::;_{\rm N}$. The \wavefunctions" of such ferm ions are uniquely determ ined by the set of polynomials P $_{\rm N}$ () orthogonal on the entire real axis with respect to the measure d () = exp f $\,$ 2V ()gd ,

holds. It follows from Eq. (3) that the joint distribution function $\,_{\rm N}\,$ (f g) can be represented as

is completely determined by the wave-functions ${\bf '}_{\rm n}$. Due to an additional constraint on the wave-functions of three successive quantum states that results from the recurrence equation Eq. (10) below, only the highly excited states, ${\bf '}_{\rm N}$ $_{1}$ and ${\bf '}_{\rm N}$, contribute to the two-point kernel in accordance with the Christo el-D arboux theorem [14]:

This form ula simpli es signi cantly the m athem atical calculations in the thermodynam ic lim it N $\,$ 1. E ective Schrodinger equation for ' $_{\rm N}$ ', that is the cornerstone of our uni ed approach, will be derived in the next Section.

2 E ective Schrodinger equation

In the particular case of the G aussian unitary ensemble (GUE) the wave-functions ' $_{\rm n}$ () are well-known. They are eigenfunctions of a ferm ion conned by a parabolic potential [1]. For general non-G aussian ensemble Eq. (1) the calculation of such elective wave-functions can be done by an extension of the

Shohat's method [15, 16] that previously has been used by the authors [13] to treat the problem of eigenvalue correlations in random -m atrix ensembles with non-singular, strong level con nement. This method allows us to map a three-term recurrence equation

for polynom ials P_n () orthogonal on the entire real axis with respect to the measure d () = expf 2V ()gd ;

onto a second-order di erential equation for corresponding ctitious wave-functions $^{\prime}$ $_{n}$. Coe cients c $_{n}$ appearing in Eq. (10) are uniquely determined by the measure d .

In order to derive an e ective Schrodinger equation, we note the following identity

with functions A_n () and B_n () to be determined from the following consideration. Since dP_n ()=d is a polynomial of the degree n 1, it can be represented [14] through the Fourier expansion in the terms of the kernelQ $_n$ (t;)= $P_{k=0}^{n-1}P_k$ () P_k (t) as:

Integrating by parts in the last equation we get that

Di erentiating Eq. (12), making use of the recurrence equation Eq. (10), and bearing in m ind relation Eq. (5) between $P_{\rm n}$ () and ' $_{\rm n}$ (), one can obtain an exact di erential equation for the wave-functions of ctitious ferm ions, that is valid for arbitrary n:

Previously, equation of this type was known in the context of the random-matrix theory only for GUE, where V () = $\,^2$ =2. For such a con nement potential both functions A_n and B_n can easily be computed from Eqs. (15) and (16), and are given by A_n () = $2c_n$ and B_n () = 0. Taking into account that for GUE $c_n=\frac{1}{n-2}$ we end up with F_n () = 0 and G_n () = 2n+1 2 . This allows us to interpret ' $_n$ () as a wave-function of the fermion con ned by a parabolic potential:

In principle, the e ective Schrodinger equation Eq. (18) applies to general non-G aussian random -m atrix ensembles as well, although the explicit calculation of F_n () and G_n () in this situation m ay be a rather complicated task. However, signi cant simplications arise in the thermodynam ic limit n=N 1.

To proceed with derivation of the asym ptotic Schrodinger equation, we have to specify the form of con nement potential V introduced by Eq. (2). Choosing the regular part V () to be an even function, we set

with $d_p>0$. The signs of the rest $d_k{'s}$ can be arbitrary, allowing for non-monotonic level conning, but they should lead to an eigenvalue density supported on a single connected interval (D_N ;+ D_N). Connement potential $V^{(\)}$ () determines its own set of orthogonal polynomials $P_n^{(\)}$ (), and functions $A_n^{(\)}$ and $B_n^{(\)}$ which are needed to construct an asymptotic second-order dierential equation for the function ${'}_N^{(\)}$ () = jj $P_N^{(\)}$ () expf v()g. Here

upper index re ects the presence of the log-singular component in V $^{()}$ (), and the restriction $> \frac{1}{2}$ takes place due to norm alization Eq. (11)].

In accordance with Eqs. (15) and (22) it is convenient to represent $A_{\rm N}^{(\)}$ in the form

In the above formulas A $_{\rm reg}^{(N)}$ and B $_{\rm reg}^{(N)}$ result from the regular component of con nem ent potential, while A $_{\rm sing}^{(N)}$ and B $_{\rm sing}^{(N)}$ are caused by its log-singular part. First, it is easy to see that A $_{\rm sing}^{(N)}$ () 0 due to evenness of the m easure d .

First, it is easy to see that A $_{\rm sing}^{(N)}$ () 0 due to evenness of the m easure d . Second, the exact expression for B $_{\rm sing}^{(N)}$ im m ediately follows from the recurrence equation Eq. (10), whence we get

Calculation of the regular parts $A_{reg}^{(N)}$ and $B_{reg}^{(N)}$ can be done along the lines presented in Ref. [13]. Then, we immediately obtain that $A_N^{()}$ () is expressed in terms of Dyson's density $_D$ () as follows:

where $D_N = 2q_N$ should be identied with the soft edge of the spectrum. [It is easy to see that a log-singular part of the con nement potential does not

contribute to the Dyson's density, so that in the therm odynam ic lim it there are no changes in D_N due to logarithm ic singularity of con nem ent potential]. Expression for B $_{reg}^{(N)}$ can be obtained by the use of the large N version of the identity Eq. (17), that yields

Now, having asym ptotic representations for $A_N^{(\)}$ and $B_N^{(\)}$ given by Eqs. (30) and (33), and taking into account Eqs. (18), (19) and (20), it is straightforward to obtain the following remarkable electric asym ptotic Schrodinger equation for the wave-functions $Y_N^{(\)}$ () = jj $P_N^{(\)}$ () expf v()g of highly excited states (N 1) of ctitious fermions:

A lso, due to Eq. (12), one can verify that the wave-functions of two successive quantum states are connected by the relationship

Equations (34) and (35) provide a general basis for the study of eigenvalue correlations in non-G aussian random -m atrix ensembles in an arbitrary spectral range. In particular case of G UE, the D yson's density of states is the celebrated sem icircle, $_{\rm D}^{\rm GUE}$ () = $_{\rm D}^{\rm 1D}$ $_{\rm D}^{\rm 2D}$ with D $_{\rm N}$ = $_{\rm D}^{\rm 1D}$. The square-root law for $_{\rm D}^{\rm GUE}$ () immediately removes the rst derivative d' $_{\rm N}^{\rm (1)}$ =d in Eq. (34), providing us the possibility to interpret the ctitious fermions as those connected by a quadratic potential (=0). As far as the semicircle is a distinctive feature of density of states in GUE only, one will always obtain a rst derivative in the elective Schrödinger equation for the non-G aussian unitary ensembles of random matrices. Therefore, ctitious non-interacting fermions associated with non-G aussian ensembles of random matrices live in a non-Hermitian quantum mechanics.

An interesting property of these equations is that they do not contain the regular part of con nement potential explicitly, but only involve the Dyson's density $_{\rm D}$ (analytically continued on the entire real axis) and the spectrum end point D $_{\rm N}$. In contrast, the logarithm ic singularity (that does not a ect the Dyson's density) introduces additional singular terms into Eqs. (34) and (35), changing signi cantly the behavior of the wave-function $^{\prime}_{\rm N}$ near the origin = 0. The in wence of the singularity decreases rather rapidly outward from the origin.

Structure of the e ective Schrodinger equation leads us to the following fundam ental statements: (i) Eigenvalue correlations are stable with respect to non-singular deformations of the connem ent potential. (ii) In the random-matrix ensembles with well-behaved connem ent potential the knowledge of Dyson's density (that is rather crude one-point characteristics coinciding with the real density of states only in the spectrum bulk) is su cient to determine the genuine density of states, as well as the nipoint correlation function, everywhere. The latter conclusion is rather unexpected since it considerably reduces the knowledge required for computing nipoint correlators.

3 Local eigenvalue correlations

E ective Schrodinger equation obtained in the preceding Section allows us to exam ine in a uni ed way the eigenvalue correlations in non-Gaussian ensembles with U (N) symmetry in dierent scaling limits. As we show below, it inevitably leads to the universal Bessel correlations in the origin scaling limit [6,7], to the universal sine correlations in the bulk scaling limit [8,9,10,11], and to the universal correlations in the soft-edge scaling limit [13]. Corresponding two-point kernels are given by Eqs. (40), (42) and (52), respectively.

3.1 Origin scaling lim it and the universal Bessel law

O rigin scaling lim it deals with the region of spectrum close to = 0 where con nem ent potential displays the logarithm ic singularity. In the vicinity of the origin the D yson's density can be taken as being approximately a constant, $_{\rm D}$ (0) = 1= $_{\rm N}$ (0), where $_{\rm N}$ (0) is the mean level spacing at the origin in the absence of the logarithm ic deformation of potential v. In the framework of this approximation, Eq. (34) reads

where a and b are constants to be determined later, and (0) = 2N (0) 2N + 1 (0). In accordance with Eq. (9), the two-point kernel can be written down as

where the unknown factor c can be found from the requirement K $_{2N}^{(=0)}$ (;) = 1= (0). This immediately yields us c = = (0). Form ula (40) is valid for arbitrary $> \frac{1}{2}$. Note, that a recent proof of universality of the Bessel kernel given in Ref. [7] was based on the Christo el theorem [14], that in posed an articial restriction on parameter to be only positive integer.

3.2 Bulk scaling lim it and the universal sine law

Bulk scaling lim it has been explored in a number of works [8, 9, 10, 11]. It is associated with a spectrum range where the con nement potential is well behaved (that is far from the logarithm ic singularity = 0), and where the density of states can be taken as being approximately a constant on the scale of a few levels. In accordance with this de nition one has

where s and s^0 should remain far enough from the end point D $_{\rm N}\,$ of the spectrum support.

Taking this lim it in Eq. (40), we arrive at the universal sine law

3.3 Soft-edge scaling lim it and the universal G multicritical law

Soft-edge scaling lim it is relevant to the tail of eigenvalue support where crossover occurs from a non-zero density of states to a vanishing one. It is known [17] that by tuning one cients d_k which enter the regular part v of connem ent potential [see Eq. (22)], one can obtain a bulk (Dyson's) density of states which possesses a singularity of the type

with the multicritical index m = 0;2;4; etc., and R $_{\rm N}$ being a well-behaved function with R $_{\rm N}$ (1) \in 0. [0 dd indices m are inconsistent with our choice that the leading coe cient d $_{\rm p}$, entering the regular component v () of connem ent potential, be positive in order to keep a convergence of integral for partition function Z $_{\rm N}$ in Eq. (1)]. Such an m th multicriticality can be achieved by many means, and the corresponding plethora of multicritical potentials V $^{\rm (m)}$ is given by the equation

So-called m in im almulticritical potentials which correspond to R $_{\rm N}$ = const can be found in Refs. [17, 18].

Below we demonstrate that as long as multicriticality of order m is reached, the eigenvalue correlations in the vicinity of the soft edge become universal, and are independent of the particular potential chosen. The order m of the multicriticality is the only parameter which governs spectral correlations in the soft-edge scaling lim it.

Let us m ove the spectrum origin to its endpoint D $_{\rm N}$, m aking the replacem ent

It is straightforward to show from Eqs. (34) and (35) that in the vicinity of the end point D $_{\rm N}$ the function $b_{\rm N}$ (s) = $^{\prime}{}_{\rm N}^{()}$ (D $_{\rm N}$) obeys the universal dierential equation

where b is an unknown constant again. It can be found by thing [12] the density of states K $_{\rm N}$ ($_{\rm S}$; $_{\rm S}$), Eq. (51), to the D yson's density of states $_{\rm D}$ ($_{\rm S}$), Eq. (43), near the soft edge provided 1 s N $^{1=}$. This yields us the value b = $c_{\rm N}^{-1}$ ($c_{\rm N}$ R $_{\rm N}$ (1)) $^{1=}$. Thus, we obtain that in the m th soft-edge scaling limit, Eq. (45), the two-point kernel K $_{\rm soft}^{\rm (m)}$ (s;s $^{\rm 0}$) = $\lim_{\rm N}$ $_{\rm 1}$ [K $_{\rm N}$ ($_{\rm S}$; $_{\rm S}^{\rm 0}$) d $_{\rm S}$ =ds] satis es the universal law

These G multicritical correlations are universal in the sense that they do not depend on the details of connement potential, but only involve such an \integral" characteristic of level connement as the index m of the multicriticality. In particular case of m=0, that is inherent in random-matrix ensembles with monotonic connement potential, the function G coincides with the Airy function, $G ext{ si}_2^3 = Ai(s)$, and the previously supposed universal Airy correlations [12]

It follows from Eq. (52) that the density of states in the same scaling lim it

Note that the leading order behavior as s! 1 is consistent with the jsj singularity of the bulk density of states, Eq. (43).

4 Concluding remarks

We have presented a general formalism for a treatment of the problem of eigenvalue correlations in spectra of U (N) invariant ensembles of large random matrices with log-singular level con nem ent. An important ingredient of our analysis is an elective one-particle Schrodinger equation [see Eqs. (18) and (34)] for ctitious non-interacting ferm ions naturally appearing in the determ inantal representation of the joint distribution function of N eigenvalues of large N Herm itian random matrix. The structure of the asymptotic equation Eq. (34) allowed us to conclude that: (i) Eigenvalue correlations are stable with respect to non-singular deform ations of con nem ent potential. (ii) In the random -m atrix ensembles with well-behaved con nement potential the knowledge of Dyson's density (that is rather crude one-point characteristics coinciding with the real density of states only in the spectrum bulk) is su cient to determ ine the genuine density of states, as well as the n point correlation function, everywhere. We have also demonstrated that elective Schrodinger equation contains all the inform ation about eigenvalue correlations in arbitrary spectrum range: the universalB esselkemelEq. (40) was found to describe eigenvalue correlations in the origin scaling lim it; the universal sine kernel Eq. (42) was revealed in the bulk scaling lim it; nally, we have shown that the soft-edge scaling lim it is described by the noveluniversalG multicritical kernelEq. (52).
