## Theory of directed localization in one dimension

W e present an analytical solution of the delocalization transition that is induced by an imaginary vector potential in a disordered chain [N.H atano and D.R.N elson, Phys.Rev.Lett.77,570 (1996)]. W e com pute the relation between the real and imaginary parts of the energy in the therm odynamic limit, as well as nite-size e ects. The results are in good agreement with numerical simulations for weak disorder (m ean free path large com pared to the wavelength).

In a recent Letter,<sup>1</sup> H atano and N elson have dem onstrated the existence of a mobility edge in a disordered ring with an imaginary vector potential. A non-H em itian H am iltonian containing an imaginary vector potential arises from the study of the pinning of vortices by columnar defects in a superconducting cylinder.<sup>2</sup> Their discovery of a delocalization transition in one and two-dimensional systems has generated considerable interest,<sup>3{5</sup> since all states are localized by disorder in one and two dimensions if the vector potential is real. Localization in this speci c kind of non-H em itian quantum mechanics is referred to as \directed localization",<sup>3</sup> because the imaginary vector potential breaks the sym metry between left-moving and right-moving particles, without breaking time-reversal sym metry.

The analytical results of Ref. 1 consist of an expression for the mobility edge plus a solution of the onedimensional problem with a single impurity. Here we go further, by solving the many-impurity case in one dimension. Most of the technical results which we will need were derived previously in connection with the problem of localization in the presence of an im aginary scalar potential. Physically, these two problem s are entirely di erent: an im aginary vector potential singles out a direction in space, while an imaginary scalar potential singles out a direction in time: A negative imaginary part of the scalar potential corresponds to absorption and a positive in aginary part to am pli cation. One m ight surm is that ampli cation could cause a delocalization transition, but in fact all states rem ain localized in one dimension in the presence of an imaginary scalar potential.6;7

Following Ref. 1 we consider a disordered chain with single-particle Ham iltonian

The operators  $c_i^y$  and  $c_i$  are creation and annihilation

operators, a is the lattice constant, and w the hopping parameter. The random potential  $V_j$  is chosen independently for each site, from a distribution with zero mean and variance  $u^2$ . For weak disorder (mean free path much larger than the wavelength), higher moments of the distribution of  $V_j$  are not relevant. The Ham iltonian is non-Hemmitian because of the real parameter h, corresponding to the imaginary vector potential. The chain of length L is closed into a ring, and the problem is to determine the eigenvalues " of H . If " is an eigenvalue of H , than also " is one | because H is real. Real " correspond to localized states, while com plex " correspond to extended states.<sup>1</sup>

To solve this problem , we reform ulate it in term softhe 2 transfer m atrix  $M_h$  (") of the chain, which relates wave am plitudes at both ends.<sup>8</sup> The energy " is an eigenvalue of H if and only if  $M_h$  (") has an eigenvalue 1. The use of the transfer m atrix is advantageous, because the e ect of the imaginary vector potential is just to multiply M with a scalar,

The energy spectrum is therefore determ ined by

T in e-reversal symmetry in plies det M<sub>0</sub> = 1. Hence the determ inantal equation (3) is equivalent to<sup>11</sup>

We seek the solution in the lim it L  $!\,$  1 .

Since M<sub>0</sub> is the transfer matrix in the absence of the imaginary vector potential (h = 0), we can use the results in the literature on localization in conventional one-dimensional systems (having an Hermitian Hamiltonian).<sup>9</sup> The fourm atrix elements of M<sub>0</sub> are given in terms of the rejection amplitudes r, r<sup>0</sup> and the transmission amplitude t by

where det  $S = rr^0$  f is the determ inant of the scattering matrix. (There is only a single transm ission amplitude

because of tim e-reversal sym m etry, so that transm ission from left to right is equivalent to transm ission from right to left.) The transm ission probability T = ff decays exponentially in the large-L lim it, with decay length :

The energy dependence of is known for weak disorder, such that kj = 1, where the complex wavenum berk is related to " by the dispersion relation

For real k, the decay length is the localization length  $_{\rm 0}\text{,}$  given by  $^{10}$

(Since  $_0$  is of the order of the m ean free path ', the condition of weak disorder requires ' large compared to the wavelength.) For complex k, the decay length is shorter than  $_0$ , regardless of the sign of Im k, according to<sup>7</sup>

W e use these results to simplify Eq. (4). Upon taking the logarithm of both sides of Eq. (4), dividing by L and taking the lim it L ! 1, one nds

where we have used that L<sup>1</sup> ln f ! L<sup>1</sup> ln jf jas L ! 1 for any complex function f(L). For complex k, the absolute value of detS is either < 1 (for Im k > 0) or > 1 (for Im k < 0). As a consequence, ln jl detS jrem ains bounded for L ! 1, so that the right-hand-side of Eq. (10) vanishes. Substituting Eq. (9), we nd that complex wavenum bers k satisfy

Together with the expression (8) for the localization length  $_0$ , this is a relation between the real and im aginary parts of the wavenumber. U sing the dispersion relation (7), and noticing that the condition kj 1 for weak disorder im plies jIm kj Rekj we can transform Eq. (11) into a relation between the real and im aginary parts of the energy,

The support of the density of states in the complex plane consists of the closed curve (12) plus two line segments on the real axis,  $^{12}$  extending from the band edge

w to the mobility edge ". The real eigenvalues are identical to the eigenvalues at h = 0, up to exponentially sm all corrections. The energy "<sub>c</sub> is obtained by putting Im " = 0 in Eq. (12), or equivalently be equating<sup>1</sup> 2<sub>0</sub> to  $1=j_1j$  hence

The delocalization transition at "\_c exists for hj> h\_c =  $\frac{1}{2}u^2 = w^2 a$ .

In Fig. 1a, the analytical theory is compared with a numerical diagonalization of the Ham iltonian (1). The numerical nite-L results are consistent with the large-L lim it (dashed curve). To leading order in 1=L, uctuations of Im " around the large-L lim it (12) are governed by uctuations of the transm ission probability T. (Fluctuations of L<sup>1</sup> hT are of order L<sup>1=2</sup>, while the other uctuating contributions to Eq. (4) are of order L<sup>1</sup>.) The variance of lnT for large L is know  $n_i^{13}$

where Ei is the exponential integral. Equating jm kj=  $hj+\frac{1}{2}L^{-1} \ln T$ , we nd varjm kj=  $\frac{1}{4}L^{-2}$  var  $\ln T$  and thus

where =  $2jhj_0$  1. In Fig. 1b we see that Eq. (15) agrees well with the results of the num erical diagonalization. The uctuations Im " are correlated over a range Re" which is large compared to Im " itself, <sup>14</sup> their ratio Im "= Re" decreasing / L <sup>1=2</sup>. This explains why the complex eigenvalues for a speci c sample appear to lie on a sm ooth curve (see Fig. 1a). This curve is sample-speci c and uctuates around the large-L lim it (12).

In conclusion, we have presented an analytical theory for the delocalization transition in a single-channel disordered wire with an imaginary vector potential. We nd good agreement with numerical diagonalizations, both for the relation between the real and imaginary parts of the energy in the in nite-length limit and for the nitesize e ects. In the absence of the imaginary vector potential, the transfer matrix approach used in this paper has been very successful for the study of localization in disordered wires with more than one scattering channel. We expect that such an extension of the theory is possible for non-Herm itian systems as well.

- $^{12}$  O nem ight wonder whether the line segm ents at real " could extend into the interior of the curve (12) of com plex ".This is not possible in the large-L lim it since hj 1=2  $_0>0$  for com plex " [see Eq. (11)], while real eigenvalues of H appear only if hj 1=2  $_0<0$ . This last inequality follows from Eq. (10), which for real " equates hj 1=2  $_0$  to a quantity L  $^1$  hj detSjwhich oscillates between 1 and 0 as L ! 1 .
