C oexistence of H aldane gap excitations and long range antiferrom agnetic order in m ixed-spin nickelates R_2B aN iO $_5$.

The spin dynam ics of the S=1 N i-chains in m ixed-spin antiferrom agnets $P\,r_2\,B\,aN\,iO_5$ and $N\,d_x\,Y_{2}\,_x\,B\,aN\,iO_5$ is described in term sofa simple G inzburg-Landau Lagrangian coupled to the sublattice of rare-earth ions. Within this framework we obtain a theoretical explanation for the experimentally observed coexistence of Haldane gap excitations and long-range magnetic order, as well as for the increase of the Haldane gap energy below the Neelpoint. We also predict that the degeneracy of the Haldane triplet is lifted in the magnetically ordered phase. The growth of the transverse gap is shown to follow from the magnon repulsion. The theoretical results are consistent with the available experimental data.

Much excitement in the eld of low-dimensional quantum magnetism was caused by the theoretical work of Haldane, who predicted an energy gap in the excitation spectrum of a 1-dim ensional Heisenberg antiferrom agnet (1-D HAF) with integer spin [1]. At the beginning this came as a surprise, since for the half-integer-spin 1-D HAF the excitation spectrum was known to be gapless. Very soon Haldane's conjecture was con med by many num erical and experim ental studies [2], and the \Haldane gap" phenom enon is by now rather well understood. A very challenging outstanding problem now is to study the quasi-1-D case, when 3-D magnetic interactions are su ciently strong to destroy the Haldane singlet and produce long-range m agnetic order at low tem perature, yet som e purely quantum -m echanicale ects are preserved, thanks to the dom inance of 1-D interactions. Much experim ental and theoretical work in this direction was done on CsN iC & [3] and isostructural integer-spin compounds [4]. The result was a profound understanding of the connection that exists between Haldane excitations and \normal" spin waves. In CsNiCl for example, the triplet of 1-D Haldane gap modes is readily observed above the Neeltem perature T_N . As T_N is approached from above, the gap vanishes at the 3-D m agnetic zone-center, driving a soft-mode transition. In the ordered phase two of the three modes become conventional gapless spin waves, while the third \longitudinal" mode, not accounted for by the linear spin wave theory, persists as a gapped excitation.

Recently in a series of inelastic neutron scattering studies of quasi-1D m ixed-spin antiferrom agnets with the general form ula R₂BaN iO₅ (R = Pr, Nd or Nd_xY_{1 x}) Zheludev et al. [5] dem onstrated that the scenario realized in CsN iCl₃ is by no means universal. In R₂BaN iO₅ com pounds 3-D magnetic ordering produces nite static moments on both the S = 1 N \mathring{T}^+ and the R³⁺ magnetic ions [6], yet the 1-D gap excitations propagating on the Nichains are only weakly a ected: they persist in the ordered phase as gapped modes and coexist with conven-

tional acoustic spin waves all the way down to T = 0. These excitations show no signs of softening at the transition point at any wave vector. In the entire phase diagram they have a purely 1-D dynam ic structure factor that is practically indistinguishable from that of Haldane excitations in Y 2B aN iO 5 [7], a \clean" Haldane-gap m aterial, where only the Ni-sites are magnetic, and no longrange ordering occurs. In R₂BaN iO₅ the only signi cant (and rather unexpected) e ect of 3-D ordering is that the gap energy increases in the ordered phase, the increase being roughly linear with (T_N T). The survival of 1-D quantum spin excitations in the ordered state is indeed rem arkable since the transition temperatures are rather high, and are quite comparable to the gap energy. The purpose of this letter is to explain the coexistence of long-range order and Haldane gap excitations in R₂BaN iO₅ m aterials. We propose that, contrary to the case of CsN iCl, in these compounds Ni-chains do not interact between them selves, but in stead each is coupled to the sublattice of magnetic R-ions. We derive the experim entally observed growth of the gap below $\,T_N\,$ using a sim ple G inzburg-Landau Lagrangian [8]. In addition, we predict that the degeneracy of the Haldane excitations is partially rem oved in the ordered phase and notice an intriguing analogy between this gap splitting in R₂BaN iO₅ m aterials and the fam ous H iggs m echanism of lifting the m ass degeneracy in particle physics.

Integer spin chains are traditionally described in term s of the Lagrangian of the Non-Linear Sigma Model (NLSM). In this approach one approximates the eld of spin site-operators S_i ($S_i^2 = s(s+1)$), retaining only the Fourier components near $k_x=0$, and [1]. This is accomplished by a change in real space variables

where both elds k (i), and n (i) change slow ly on the scale of one lattice spacing. A coording to this de nition, k (i) is the unit vector in the direction of local staggered m ag-

netization, and $\mathfrak{I}(i)$ is the component of local magnetization perpendicular to $^{\iota_{\iota}}(i)$ ($^{\iota_{\iota}}(i)$) $\mathfrak{I}(i)=0$). In the lim it of large s three components of $^{\iota_{\iota}}$ commute with each other, while the commutation rules of \mathfrak{I} remain nontrivial. It can be shown that the correct dynamics for the new variables follows from a NLSM Lagrangian:

where $^{\prime}$ is subject to the constraint $^{\prime}$ = 1. Here g = 2=s is a dim ensionless coupling constant, m easuring the strength of quantum uctuations, and v = 2Js is the spin wave velocity. The magnetic moment I is given by 1= 1=qv ~ @ ~=@t. Thism apping of the 1-D HAF to the NLSM (2) becomes exact for integers! 1, but it gives a m eaningful and qualitatively correct approxim ation even for s = 1. From this description it can be derived that in 1+1 dim ensions any strength of quantum uctuations g is su cient to destroy long range correlations between spins. A nite correlation length is always accompanied by a gap = v= in the spin excitation spectrum. For half-integer 1-D HAF the topological term not included in the Lagrangian (2) prevents the appearance of the nite correlation length, and spin correlations remain scale-free. But for integers this gap, commonly known as the Haldane gap, is present. It has a small g (large s) asym ptotics of $\exp(2 = g) = \exp(s)$. For the s = 1 HAF the Haldane gap was found numerically to be = 0.41J [9].

The non-linear sigm a model is not very convenient for practical calculations. To simplify things further we follow the approach of A eck [8], and replace the Lagrangian of N LSM with that of the quantum G inzburg-Landau model

where for convenience we have $\sin u$ ltaneously changed variables to $\tilde{}=1=\frac{p}{g}$ $\tilde{}_{k}=\frac{1}{s-2}$ $\tilde{}_{k}$. The new Lagrangian follows from (2) if the constraint $\tilde{}_{k}^{2}=1$ is relaxed, making the vector of staggered magnetization soft, and phenomenological quadratic and quartic terms are introduced. The coe cient in front of the quadratic term is selected to reproduce the correct value of the gap (in NLSM this gap is generated dynamically), while the only condition in posed on the quartic term is that >0, ensuring the overall stability for large \tilde{j} \tilde{j} . The physical meaning of Eq. (3) is rather transparent. It describes the propagation of a triplet of magnons (excitations of local staggered magnetization) with a given spin wave velocity v, and gap . The quartic term describes the repulsive magnon-magnon interaction.

The Lagrangian (3) was successfully used to qualitatively explain the behavior of coupled 1D spin chains in CsNiCl₂ [8]. In this case the i-th chain is described by Eq. (3) with $^{\sim}$! $^{\sim}$ i, while the interchain coupling is given by $2sJ^{0}$ $_{i}$ $_{i+1}$. On the mean-eld level the behavior of the excitations is the following: the gap is reduced by the interchain coupling to $^2_{eff} = ^2$ (T) $4vZ sJ^0$, where Z is the number of chains coupled to a given chain. The O (3) sym metry is spontaneously broken for 2 (T) < 4Z svJ $^0\cdot$ pIn this case j~j has a nonzero expectation value of $$^{(4vZ\,sJ^0}-^2(T\,))=4v$$. The gap naturally grows with temperature and eventually wins over the interchain exchange, restoring the 0 (3) sym m etry. The Neel tem perature is determined by the condition 2 (T_N) = 4vZ sJ 0 . It is important to understand what happens to the triplet of magnons below $\,T_N\,$. As T_{N} is approached from above, the gap in all three excitations at the positions of future magnetic Bragg peaks decreases and hits zero at T_{N} . Below T_{N} two excitations corresponding to the two Goldstone modes of the Neel order param eter rem ain gapless. At the sam e tim e the longitudinal branch re-acquires the gap along with a nite lifetim e due to decay into two gapless modes.

The \traditional" scenario [8] described above is in agreem ent with experim ental ndings in CsN iCl3. However, for R₂BaNiO₅ we can expect a dierent picture. The structure of these materials is such that there are no strong direct superexchange paths between the Ni chains, which explains why in isostructural Y2BaNiO5 no magnetic ordering is observed [7]. On the other hand, magnetic rare earth ions substituted for Y are coupled between them selves. To a good approximation one can assume that these sites form a separate sublattice which orders at rather high tem peratures ($T_N = 48$ K for $N d_2 B a N i O_5$). The coupling J^0 between the N i and R sublattices is weak, yet nite. The nite ordered moments on the N i-sites m ay be interpreted as the singlet-groundstate N i-chains being polarized by a staggered exchange eld from the magnetically ordered sublattice of R-ions. To describe this e ect an \external eld" term should be added to the Ginzburg-Landau Lagrangian (3). It is given by $J^0 n^{\frac{1}{2}} = H_s^{\infty}$, where n is the staggered moment of the R sublattice. Such a term explicitly breaks the 0 (3) sym metry and causes ~ to acquire a nonzero expectation value along Hs. As a consequence, the degeneracy of the triplet of Haldane gap excitations is partially lifted. The energy gap in the magnon, polarized parallel to H's, is dierent from that in the two transversalbranches. Both gaps can be derived from P { the potential energy density of the Lagrangian:

The usual formula for this is $^2 = v = (^2P = (^2 - 1)^2)$. It gives

Here $_0$ is the expectation value of j j determ ined by m in im ization of (4) through

or, approxim ately, $_0$ ' vH $_{\rm s}=\frac{2}{0}$. Note that both energy gaps are increased compared to their value in the absence of the staggered eld. This observation relies on the fact that >0, i.e. a repulsive magnon-magnon interaction. It is precisely the positive , which guaranties the stability of Eq. (6) and of the Lagrangian (3) itself, and, therefore, should be satis ed.

As we mentioned in the introduction, the Lagrangian of NLSM is traditionally used to describe the behavior of quantum spin chains. The e ect of the staggered magnetic eld in NLSM, coupled to the staggered magnetization via the term in h=g, was studied by Nelson and Pelcovits [10] using renormalization group methods. Their RG ow indicates that indeed the gap increases (the correlation length decreases) in strong enough elds. The one loop corrections calculated by them do not give a definite answer about the behavior of the correlation length in weak elds. Using our results for the Ginzburg-Landau Lagrangian we can conclude that the correlation length decreases in this case as well.

Our predictions for the energy gap can be qualitatively understood by working with the original Heisenberg Hamiltonian and treating the staggered eld as a weak perturbation. Let us denote the Haldane ground state by 15 i and label the lowest-energy triplet excitaas \pm ; + 1i, \pm ; 0i and \pm ; 1i, accordtions at q = ing to their value of Sz. Let us now consider the relevant matrix elements of the staggered eld operator $\hat{H}_s = H_s^{-1}$ (1) $^j S_j^z$. These are non-zero only between states with momentums diering by exactly . In particular, hG jf s jG i, as well as the matrix elements between any two of the £;+1i, £;0i or £; 1i states are strictly zero. As a result, there are no rst-order corrections to the spin gap at q = . To calculate the 2-nd order correction E_G to the ground state energy we can use the well-known fact that the triplet of Haldane modes pretty much exhausts the spectral weight at q = . Thus, only the mixing of Gi with singleparticle excitations needs to be considered. Since H's conserves the z-com ponent of total spin, its only nonzero matrix element is the one between Gi and E;0i. The correction to the ground state energy is thus given by $E_G = \frac{jhE;0j\hat{H}_sjGi\hat{j}}{}$. We now proceed to calculate the energy corrections for the three excited states at q = . Two e ects need to be considered: i) their mixing with the ground state and ii) theirm ixing with 2-particle excited states. Let us rst assume that there is no repulsion between magnons, and that doubly-excited states

at q=0, which we label as 2E;+1;0i, 2E;1;0i, and 2E;0;0i, are produced by adding two non-interacting q= excitations to the system . Second order corrections to the energies of singly-excited states are then given by:

An increase of the energy gap below the transition point is exactly what was observed in neutron scattering experiments on Nd₂BaNiO₅, Nd_xY₂ x BaNiO₅, and Pr₂BaNiO₅ [5]. The data were taken on powder samples or single crystals of small size, which obviously made resolving the mode splitting below T_N impossible. In the powder measurements at least, the observed gap always corresponds to the lowest-energy mode. In Fig. 1 we show the combined data from all experiments, plotting the increase of the square of gap energy (relative to that m easured in Y_2BaNiO_5 [11] at the same temperature) against the square of staggered magnetization of the Ni sublattice. The data are consistent with the predicted linear dependence. Moreover, data points for dierent compounds seem to collapse onto a single curve, even though the Neel tem peratures vary considerably. The mechanism is therefore insensitive to the details of exchange in the R-sublattice, and between Ni and R sublattices.

In a much obscured from the e ect of staggered eld has been previously observed in the well-known Haldane-gap material NENP [12]. In this compound applying an external uniform eld H produces a weak e ective staggered component due to some special structural features. On top of a very pronounced linear splitting of the Haldane triplet by the uniform eld for each mode one observes a slight energy shift that is positive and quadratic with H. This shift was attributed to the weak staggered eld component that for NENP is inseparable from the uniform one [13]. Numerical calculations have con med this conclusion [14]. Note that unlike in NENP, in R₂BaNiO₅ systems we are able to see the elect of staggered eld much more clearly, since the dominant uniform eld component is absent.

It is interesting to mention that the e ect of gap increase and splitting due to interaction with another sublattice has a close analogue in the eld of particle physics.

It is very sim ilar to the Higgs mechanism by which the mass degeneracy in a multiplet of elementary particles is lifted. As in our case, the splitting of masses (energy gaps relative to a vacuum of particles) is a result of spontaneous sym m etry breaking, produced by the interaction with Higgs particles. The three Nichain Haldane excitations of di erent polarizations play the role of a multiplet of particles of initially equal masses (quarks for exam ple), while the conventional acoustic spin waves, referred to as mixed R-Niexcitations by Zheludev et al. play the role of the elusive Higgs particle, which is massless in our case. This analogy should not be taken too seriously due to the di erences in Ham iltonians: it is the SU (2) sym m etry which is spontaneously broken by the Higgs mechanism, and the term describing the coupling between matter and Higgs particles is more complicated than a simple H_s term in our case. Nevertheless, the essence of the e ect is the same: spontaneous sym metry breaking caused by interaction with some external eld lifts the degeneracy of masses (gaps).

In conclusion, we have provided a simple theoretical explanation for the coexistence of long range magnetic order and H aldane gap excitations in R $_2\text{B}$ aN iO $_5$ system s. The N i-chain gap modes are described in terms of a simple G inzburg-Landau Lagrangian. The increase of the gap below the N eel temperature, previously observed experimentally in several compounds, in mediately follows from this approach. The qualitatively new prediction is that the degeneracy of the Haldane triplet is lifted below the transition point. The magnon polarized along the vector of staggered magnetization has a larger gap than the two others magnon branches. Experimental tests of this prediction, including inelastic neutron scattering experiments on large high-quality single samples, are planned for the near future.
