Insulating P hases of the d = 1 H ubbard m odel

A theory is developed for the T = 0 M ott-H ubbard insulating phases of the d¹ H ubbard m odel at $\frac{1}{2}$ -lling, including both the antiferrom agnetic (AF) and param agnetic (P) insulators. Local m om ents are introduced explicitly from the outset, enabling ready identication of the dom inant low energy scales for insulating spin- ip excitations. D ynam ical coupling of single-particle processes to the spin- ip excitations leads to a renorm alized self-consistent description of the single-particle propagators that is shown to be asymptotically exact in strong coupling, for both the AF and P phases. For the AF case, the resultant theory is applicable over the entire U-range, and is discussed in some detail. For the P phase, we consider in particular the destruction of the M ott insulator, the resultant critical behaviour of which is found to stem inherently from proper inclusion of the spin- ip excitations.

1. IN TRODUCTION

Since its inception m ore than thirty years ago [1], the Hubbard m odel has become the canonical m odel of interacting fermions on a lattice. Although possibly the simplest m odel to describe competition between electron itinerancy and localization, with attendant implications for a host of physical phenomena from m agnetism to m etal-insulator transitions, its simplicity is super cial and an exact solution exists only for d = 1 dimension [2].

Recently, M etzner and Vollhardt $[\beta]$ have pointed to the importance of the opposite extreme, d = 1. In suppressing spatial uctuations, the many-body problem here simpli es considerably, reducing to a dynamical single-site m ean-eld problem. M otivated in part by the expectation that an understanding of the d = 1 limit will serve as a starting point for system atic investigation of nite dimensions, and by the knowledge that some important vestiges of nite-d behaviour remain inherent in the d = 1 limit, intense study of the $\frac{1}{2}$ -lled d = 1H ubbard m odel on bipartite lattices has since ensued; for recent detailed review s, see R efs [4,5,6].

The true ground state of the model is an antiferrom agnet (AF) for all interaction strengths U > 0. One aim of the present work [7] is to develop a theory for the d = 1 AF which, in contrast to previous theories for the AF phase [8,9,10], is reliable over the entire U -range, and in particular becomes exact in the U ! 1 strong coupling lim it both at $\frac{1}{2}$ - lling where the H ubbard model m aps onto the AF H eisenberg model, and in the one-hole sector where it reduces to the t-J model [11]

The majority of previous work [4,5,6] on the d = 1 Hubbard model has focused on the paramagnetic (P) phase that results, even for T = 0, simply by neglecting the magnetic ordering (or suppressing it via frustration [5]). One highlight of this work has been the emergence of a detailed description of the M ottm etal-insulator transition, although here too the picture is not complete: for example, a munderstanding of the mechanism by which the T = 0 M ott insulating solution is destroyed, and even whether it is continuous or rst-order, remains elusive [5,12]. A second aim of this paper is to focus on the insulating state of the P phase, and to develop a theory for it on a footing essentially identical to that for the AF, which likew ise becomes exact in strong coupling and which permits an analysis of the destruction of the M ott insulator.

In seeking to develop a 'uni ed' description of the AF and P insulating phases, we adopt a rather di erent approach to that taken in previous work [4,5,6] by introducing explicitly, and from the outset, the notion of site localmoments. To this end we consider rst a conventional T = 0 m ean - eld approach to the problem in the form of unrestricted Hartree-Fock (UHF), togetherwith a random phase approximation (RPA) for transverse spin excitations of the mean-eld state. Despite the limitations of such an approach per se, its importance resides in enabling identi cation of key low energy scales for insulating spin- ip excitations. Since spatial uctuations are suppressed for d = 1, the low energy spin-ip excitations are found to be Ising-like and (for each phase) characterized by a single scale, !s. This has a simple physical interpretation. For the AF, $!_s = !_p (U)$ is essentially just the energy cost of ipping a spin in the Neel ordered background; the ubiquity of antiferrom agnetism for all U > 0 leads naturally to $!_p > 0$ for all U, with !p 1=U as U ! 1 as one expects in the Heisenberg lim it. For the P phase by contrast, where m agnetic ordering is absent, the fact that a given spin is equally likely to be surrounded by "- or #-spins and thus (for d = 1) has as many "- as #-spin neighbours, ensures that the corresponding spin-ip energy cost $!_s = 0$ for all U in the insulating state.

Identi cation of the low energy spin- ip scales, while crucial to the present work, is prelim inary: to transcend the lim itations of the conventional static' mean- eld approach, single-particle processes must subsequently be coupled dynam ically to the transverse spin- ip excitations. It is this which, in leading as we shall describe to a self-consistent description of the single-particle G reen functions, enables the aim s outlined in the preceding paragraphs to be achieved.

The Hubbard Ham iltonian, in standard notation, is

with the (ij) sum over nearest neighbour sites on a bipartite lattice of coordination number Z : a Bethe lattice (on which in practice we shall largely focus), or a d-dimensional hypercube. To ensure a non-trivial limit as d! 1 [3], the hopping is scaled as t = t = 2Z. The paper is organised as follows. UHF+RPA, and the spin-

ip scales referred to above, are discussed in x2. Em – phasis is also given here to simple physical arguments which, in highlighting both the de ciencies and virtues of UHF + RPA, indicate what is required to go beyond it; particular attention being given in this regard to UHF for the P phase, in view of its close relation to the early work of H ubbard [13] and the Falicov-K in ballm odel [14].

D ynam ical coupling of single-particle processes to the transverse spin excitations is considered in x3, leading (x3.1) to a renorm alized self-consistent approximation for the (T = 0) single-particle G reen functions upon which we subsequently concentrate. In x32 the strong coupling behaviour is exam ined analytically, and shown to be asymptotically exact for both the P and AF phases. Results are given in x3.3, focusing in particular on singleparticle spectra for the AF from strong to weak coupling, and on a discussion of the localization characteristics of the single-particle excitations {the latter being quite subtle, and pointing to the delicacy of the lim it U ! 1 for the AF phase. For the P insulator, single-particle spectra are discussed brie y in x3.3, before considering the destruction of the M ott insulating solution in x4. The single-particle gap is found to close continuously, with an exponent = 1, at a critical $U_c = 3.41t$. The origins of this behaviour are found to stem from inclusion of the $!_s = 0$ spin- ip scale in the interaction self-energies, pointing to the importance of such throughout the entire insulating regime, and not solely in obtaining the exact strong coupling lim it. The results of x4 are in good agreem ent with recent num erical work [12], as discussed in x5.

2. CONVENTIONAL MEAN FIELD APPROACH

W e focus on the zero tem perature single-particle G reen functions, de ned by

com ponents. The essential feature of d¹ is that the corresponding interaction self-energy is site-diagonal [3,15], \sim_{ij} ; (\cdot) = $_{ij}\sim_i$ (\cdot); here, and throughout, \cdot denotes frequency relative to the Ferm i level, viz $\cdot = ! U=2$. G _{iii}; (\cdot) m ay be written as

where $S_{\rm i}~$ is the ${\rm in~edium}~\prime$ self-energy \mid which alone survives in the non-interacting lim it $\mid~$ expressing hopping of

-spin electrons to neighbouring sites. Sim ple application of Feenberg's renorm alized perturbation theory [16,17] shows that, for d = 1 but regardless of lattice type, S_i is a functional solely of the fG_{jj}; g. The functional dependence is particularly sim ple for the Bethe lattice (BL) on which we concentrate, namely

with $t_{ij} = t = \frac{p}{2Z}$ the nearest neighbour hopping element. Note that this is quite general; no assumption has been m ade about m agnetic ordering or otherwise.

W e consider now a conventional mean-eld approach to the single-particle G reen functions.

2.1 U H F

For both the AF and P phases, a Hartree-Fock approximation | by which we emphasize is here meant spin unrestricted Hartree-Fock (UHF)| is the simplest non-trivialm ean eld approximation, in which the notion of site local moments ($_i$), regarded as the rst e ect of electron interactions, enters from the outset. In the AF case, the localm om ents are naturally ordered in an A/B 2-sublattice Neel state, with $_i = _j j$ for site i in the A/B sublattice respectively [18]. For the P phase by contrast, the localm om ents are random ly oriented: a site is equally likely to be A-type as B-type [19]. In either case the essential | and limiting | feature of UHF is that it is a static approximation, with solely elastic scattering of electrons and !-independent interaction self-energies approximated by

For the AF phase, the UHF G reen functions (G $^{0}_{ii}$; G 0 with = A or B) follow from Eqs (22,23) for the BL as

where the h edium' self-energy part re ects the 2sublattice structure of the Neel state. Eqs (2.4) are a closed set, with the UHF localm om ent j j= j_0 j found self-consistently via the usual gap equation (see e.g. [20]), which may be written form ally as

The sole di erence to Eq. (2.4) occurs in the medium self-energy (see Eq. (2.2b)), since the nearest neighbours to any site are equally likely to be A - or B -type sites. Eqs (2.6) are a closed set for $G^{0}(+)$ and the $G^{0}(+)$ in the P phase; the UHF local moment is again found from Eq. (2.5).

For either phase there are two basic symmetries, viz

re ecting the " = #-spin symmetry $(G_{A}^{0} (!) = G_{B}^{0} (!))$ and particle-hole symmetry $(G_{A}^{0} (!) = G_{A}^{0} (!))$ respectively; and note therefore from Eq. (2.6) that $G^{0}(!)$ is naturally independent of the spin, .

We add further that UHF yields the correct atom ic lim it (where $j_0 j = 1$) for either phase, as is clear from Eqs (2.4,2.6,2.7) with t = 0.

A.Antiferrom agnet

UHF for the AF has been widely studied since the early work of Penn [18]. Here we mention only that for any d > 1 the exact ground state of the $\frac{1}{2}$ -lled Hubbard model on a bipartite lattice is an AF insulator for all U > 0, and this is qualitatively well captured at UHF level: for all U > 0, the mean-eld ground state is a 2-sublattice Neel AF, with a gap in the single-particle spectrum D⁰($\frac{1}{2}$) given by (U) = U j j Fig. 1 shows D⁰($\frac{1}{2}$) at U=t = 4 for the d¹ BL.

The de ciencies of UHF are how ever m ost clearly seen in strong coupling, U ! 1, where for the AF the singleparticle spectrum reduces to D⁰($\frac{1}{2}$) = $\frac{1}{2}$ [($\frac{1}{2} + \frac{U}{2}$) + ($\frac{1}{2}$)] | as for the atom ic lim it, t = 0. The physical origin of this is sim ple: consider for exam ple the upper H ubbard band in strong coupling, and imagine adding an "-spin electron to a site (B-type) already occupied by a #-spin. Since UHF is an independent (albeit interacting) electron approxim ation, only the added "-spin can potentially hop to nearest neighbour (NN) sites. But it cannot do so in the strong coupling lim it, since for the AF allNN's to the #-spin B-site are "-spins (A-type). The added "-spin thus e ectively bees' the #-spin site as an isolated site, hence the emergence of atom ic lim it behaviour as the strong coupling lim it at UHF level. But while physically transparent, this behaviour is w rong. In strong coupling, and for the 1-hole sector appropriate to the lower H ubbard band (or 1-doublon sector for the upper H ubbard band), the H ubbard m odelm aps onto the t-J m odel [11]

where the hole m oves in a restricted subspace of no doubly occupied sites ($c_i^y = c_i^y$ (1 n_i)); and in the uctuating spin background provided by the H eisenberg part of \hat{H}_{tJ} , with NN exchange coupling $J_1 = 4t^2=U$. A lthough it is exact in the atom ic lim it, UHF by itself can evidently say essentially nothing about the strong coupling lim it.

B.Param agnet

UHF for the T = 0 param agnetic phase warrants separate discussion, in part because of its very close relation to two other well known approaches. The rst is that due to Hubbard [13], with 'spin-disorder scattering' only. This is often called the Hubbard III (H III) approxin ation, and we here refer to it thus (noting that 'resonant broadening' contributions are additionally included in Ref. [13]). HIII is equivalent to UHF, but with a saturated localm om ent. Thus, with j j= 1, the resultant cubic equation for G^0 ($\stackrel{!}{\cdot}$) on the d^1 BL, obtained from Eqs (2.6,2.7) above, coincides precisely with the H III approxim ation for any U; see eg Eq. (34) of Ref. [21]. A lthough Hubbard's original form alism is very di erent, its physical content is that of a static approximation to an alloy analogy description [22]; a close relationship to UHF is thus to be expected.

The second connection is to the Falicov-K im ball (FK) m odel [14], a simpli ed version of the Hubbard m odel in which electrons of only one spin type are m obile, and which for d^1 is exactly soluble [23,24,25]. For the paramagnetic phase of the FK m odel the single particle G reen function reduces precisely to that of H III for any U [22], ie to the above-m entioned cubic for G^0 (+) on the d^1 BL; see eg Eqs (7.3) and (4.4) of Ref. [25].

For the P phase, Fig. 1 shows the UHF D⁰(\ddagger) for U=t = 4 on the d¹ BL, contrasted to its AF counterpart. O rdering or otherwise of the preform ed local m om ents clearly has a signi cant e ect on the spectra. In the AF ordered case, for exam ple, the interior edges of the H ubbard bands have characteristic square-root divergences, while for the P phase all band edges vanish with square-root behaviour. M ore signi cantly, while the 2sublattice structure of the N eel ordered state ensures a band gap = U j jfor allU > 0, the single-particle UHF gap vanishes in the P phase at a critical U_c ' 1:9t given by U_cj (U_c)j = 2t | or correspondingly U_c = 2tfor H III/FK | signalling an insulator{m etal transition. U H F / H III fails of course in the m etallic phase, there being no well-de ned Ferm isurface or quasiparticles [22,26]. T his is inevitable for any inherently static approximation with a frequency-independent self-energy ~ , since the essence of Ferm i liquid behaviour is the inelasticity of electron scattering near the Ferm i level, $\frac{1}{2} = 0$ [27].

However, even in the P insulating phase of interest here, UHF/HIII is de cient. As for the AF this is seen m ost clearly in strong coupling, U ! 1, where although the centres of the Hubbard bands are separated by U, each has a non-vanishing width. In the strong coupling P phase, and for the one hole (doublon) sector corresponding to the lower (upper) Hubbard band, the Hubbard m odelm aps onto the t-J m odel (Eq. (2.9)) in a random spin background; and the exact full bandwidth of either band is given for the d¹ BL by [28,29]

Note that this is also the single-particle bandwidth in the other extrem e of the non-interacting limit, re ecting physically that in strong coupling the hole/doublon behaves essentially as a free particle [30].

In contrast, the strong coupling bandwidth at UHF/HIII level is

UHF or HIII does not therefore give the exact strong coupling lim it for the Hubbard model, contrary to what has been suggested recently [31]; but, as is clear from the above discussion, gives instead the strong coupling lim it of the FK model [25]. The physical origin of Eq. (2.10b) is however both simple and revealing. Consider again the upper Hubbard band in strong coupling, and im agine adding an "-spin electron to a B-type #-spin site. Within a static approxim ation such as U H F / H III, only the added "-spin can hop; and it can do so in the rst instance to any of #-spin NN 's (B-type sites) on ly | the e ective coordination number for which is $Z_e = \frac{1}{2}Z$. Since Z_e for the propagating "-spin electron is reduced by a factor of 2 below the full coordination number, and since the bandwidth of the $d^1~$ BL is proportional to $\ensuremath{^\circ}\xspace{\rm Z_e}$, the strong coupling UHF/HIII width is thus dim inished by

 $\frac{1}{2}$ from the corresponding non-interacting value which, as in Eq. (2.10a) above, is also the exact strong coupling lim it; Eq. (2.10b) thus results.

The distinction between Eqs (2.10a) and (2.10b) is however qualitative, and not solely a matter of degree, re ecting the need to take seriously | even in strong coupling | the correlated dynamics of the electrons. W henever, say, an "-spin electron is added to a site occupied by a #-spin electron, the added "-spin can indeed propagate in the P phase, scattering elastically o successive neighbouring #-spins; and as sketched

above this is well captured at UHF/HIII level. But, having added the "-spin to a #-spin site, the latter can itself clearly hop o the site | to a neighbouring "-spin site | leaving behind it a spin-ip on the original site. The energy cost for the spin- ip is zero, since we are considering the P phase where, for d¹, a given spin is equally likely to be surrounded by " or # spins and has asm any " as #-spin neighbours (whence there is no 'exchange penalty' for a spin-ip). Thus, whether the added "-spin or the #-spin already present hops o the site, the initially created doublon propagates as a free particle [30]; Eq. (2.10a) thus results. To describe correctly the electron dynam ics, both types of process above | and therefore the interference between them must be included. A static approxim ation such as UHF/HIII cannot handle this, since such dynam ics reside in the frequency dependence of the full interaction self-energy \sim_i ($\frac{1}{2}$), as considered in x3.

2.2 R P A

In contrast to single-particle spectra | probing states one hole or particle away from $\frac{1}{2}$ -lling | RPA probes uctuations about the mean-eld state, and thus excitations of the $\frac{1}{2}$ -lled state itself. For the insulating phases, with a gap to charge excitations, transverse spin excitations are of lowest energy. These are reected in the transverse spin polarization propagators $_{ij}^{+}$ (t) = ihT fS_i⁺ (t)S_j gi and $_{ij}^{+}$ (t), given within RPA by

where $[+ (!)]_{ij} = + (!)$, $[l]_{ij} = + (!)$, $[l]_{ij} = + (!)$ and $[l]_{ij}$ is the pure UHF transverse spin polarization bubble. Eq. (2.11a) leads directly to a familiar diagram matic bubble sum'. A lternatively, since the interaction is solely on-site, this may be recast as a ladder sum' of repeated particle-hole interactions in the transverse spin channel, as shown in Fig. 2; bare UHF propagators are denoted by solid lines, and the on-site interactions (conserving spin at each vertex end) by wiggly lines. From the basic sym m etries (Eq. (2.8)), it follows that + (!) = + (!) = + (!)for i = A or B; and + + (!) = + + (!).

For nite-d, interm ediate sites in the ladder sum for $_{ii}^{+}$ (Fig. 2) are in general di erent from i. But since $_{ij}^{0}$ (Fig. 2) are in general di erent from i. The spectral density of transverse spin excitations is naturally relected in Im $^+_{ii}$ (!), as now considered for the AF and P phases.

A.AF phase

For the AF, Fig. 3a shows Im $_{\lambda\lambda}^+$ (!) at U=t = 4 for the d¹ Bethe lattice. Two distinct features are apparent: a low frequency spin- ip pole (discussed below), and a high energy Stoner-like band. The latter consists sim ply of weakly renorm alized Hartree-Fock excitations across the gap in the m ean- eld single-particle spectrum. Spectral density for the Stoner bands does not therefore begin until precisely j! j = U j j (see Fig. 1), and their m axim um density occurs for j! j' U. This is as found also for nite-d, see eg Ref [32].

The central feature in Fig. 3a is a low -! pole at !p, located via Eq. (2.11b) from $U^{0} + (!_{p}) = 1$, and occurring for all U > 0 (Fig. 3a, inset). This is the sole rem nant, for d¹, of the spin wave-like component of the transverse spin spectrum studied recently at RPA level [32]; and which, for nite d and any U > 0, is naturally gapless. Physically, the single spin- ip pole at !p re ects the general suppression of spatial uctuations for d¹: it corresponds simply to the energy cost of ipping a spin in the AF background. This is particularly clear in strong coupling, where the Stoner bands are elim inated entirely. Here, as is well known [20,33], the RPA transverse spin spectrum reduces (for any d) to the linear spin wave spectrum of the nearest neighbour AF Heisenberg m odel, with exchange coupling $J_1 = 4t^2 = U = 2t^2 = ZU$, onto which the $\frac{1}{2}$ - lled Hubbard model maps rigorously. And for d^1 it is straightforward to show that the resultant linear spin wave spectrum collapses to an Ising-like spin- ip pole at $!_{p}^{1} = Z J_{1} = 2 = t^{2} = U$. Further, since linear spin wave theory for the Heisenberg model is exact for d¹ [34], it follows that in strong coupling UHF+RPA gives the exact spin excitation spectrum of the $\frac{1}{2}$ - led Hubbard model.

The occurrence of the single $!_p$ -pole is robust to further renorm alization of particle-hole lines in $^+_{ii}$ (!), as discussed in x3.3. We stress further that to capture it requires the full ladder sum of repeated p-h interactions shown in Fig. 2: retention solely of the bare' polarization bubble diagram will clearly not su ce.

The necessity of including the AF spin- ip scale will be evident when discussing the T = 0 single-particle spectra, x32,3. Here, we illustrate brie y its importance at nite tem perature, as re ected in the Neeltem perature T_N (U). Molecular eld theory is exact for the Heisenberg model in d^1 [35]; thus, in strong ∞u pling, $T_N = Z J_1 = 4 = \frac{1}{2} ! \frac{1}{p}$. At nite U, we expect T_N (U) $\frac{1}{2}!_p$ (U) to yield a good estimate of the Neel tem perature in a U-regim e where therm al properties are dom inated by the low-lying spin- ip excitations. Jarrell and Pruschke [36,37] have obtained the nite-T phase diagram for the d¹ hypercubic lattice via quantum M onte Carlo (QMC). The therm al param agnetic phase above T_{N} (U) is found to be metallic for U=t < 3 and insulating for $U = t^{>} 3$ (with a small crossover' regime); it is thus in the latter region that we expect $T_N / \frac{1}{2}!_p$. This is borne out. Fig. 4 shows the QMC $T_{\rm N}$ (U) for the d^1 hypercubic lattice, together with the corresponding $\frac{1}{2}!_{\rm p}$ (U) and the exact strong coupling asymptote $T_{\rm N}$ = $\frac{1}{2}!_{\rm p}^1$. B.P phase

For the T = 0 P phase, Fig. 3b shows Im $\frac{1}{AA}$ (!) at U=t = 4 for the d^1 Bethe lattice. Compared to its AF counterpart (Fig. 3a) the key di erence is that the spin- ip pole occurs at ! = 0, re ecting the fact that the energy cost for a spin- ip is zero in the param agnetic insulator, as argued physically in x2.1b. The form al origin of this at RPA level is seen readily by noting that the bare transverse spin polarization bubble (Fig. 2, diagram (a)) is given by

N ote again, as for the AF case, that the full ladder sum of particle-hole interactions in the transverse spin channel is required to capture the ! = 0 spin- ip pole. Further, although we have shown explicitly its existence within RPA, the occurrence of the zero-frequency spin- ip scale is naturally a general feature of the d¹ param agnetic insulating phase where, locally, the ground state is a doubly degenerate local moment (as for the single-im purity Anderson m odel embedded in an insulating host) [5].

For both phases, the evident virtues of the RPA for excitations of the $\frac{1}{2}$ -lled state contrast sharply with the de ciencies of the single-particle spectra at UHF level, x2.1. This itself hints at what is necessary to describe the single-particle spectra successfully: single-particle processes must be coupled dynam ically to the transverse spin excitations, re ected in the frequency dependence of the self-energy. This is now considered.

It is helpful to separate the full interaction self-energies ~ (+) as

The symmetries rejected in Eqs (3.5,3.6) play an important role in the following analysis. For the P phase,

note also the physical interpretation of Eq. (3.3) for G (\cdot): view ing the param agnet in term s of random ly oriented local moments, where a site is equally likely to likely to be A type as B type, we can consider Eq. (3.3) as a con gurationally averaged G reen function. This is a natural alloy analogy interpretation but, unlike the static approximation to such inherent in UHF or HIII, it is formally exact since no approximation to the interaction self-energies has thus far been made.

3.1 Self-consistent renorm alization

O ur aim now is to develop a speci c approximation to the self-energy which in particular (a) becomes exact in strong coupling, ensuring thereby a controlled limit; and (b) is constructed in renormalized form, enabling a self-consistent solution for the single-particle G reen functions.

A relevant diagram contributing to i is shown in Fig. 5, employing the same diagram matic notation as Fig. 2. Using deliberately a strong coupling term inology, its physical interpretation is as follows (with t > 0for convenience): at t = 0 a (=)"-spin electron, say, is added to site i, thus creating a bloublon'; at $t_1 > 0$ the (=)#-spin electron already present on site i hops from ito j, and at $t_2 > t_1$ an "-spin hops from j to k; the entire path is then retraced. The diagram thus describes motion of the doublon (or hole for t < 0) from i! j! k via a correlated sequence of alternating spin hops, creating behind it a string of ipped spins. All ladder interactions of the resultant on-site particle-hole pair | which re ect the on-site spin- ip created by motion of the doublon/hole are shown explicitly for site i in Fig. 5; from which it is seen that their sum is exactly $U^2 _{ii}^{+}$, with $_{ii}^{+}$ (!) (= $_{ii}^{+}$ (!)) the RPA transverse spin propagator discussed in x2.2 (cfFig. 2).

It is precisely correlated dynam ics of the sort exem plied by Fig. 5 that we seek to include and generalize in the frequency-dependent (+). To this end we rst dene an undressed (or self-consistent host) G reen function by

This is shown diagram matically in Fig. 6 (a), as obtained simply from Eq. (3.7) using the Dyson equation for the full Green function G_{ii}; expressed in terms of the UHF propagators and self-energy insertions. As seen from the gure, the implicit sum over intermediate sites j;k etc. is thus restricted to exclude site i itself (unlike the full G_{ii}; where the site sums are free). While including all interactions on sites j \in i, G_{ii}; thus excludes all interactions on site i beyond the simple rst-order UHF contribution to \sim_i . The latter is of course subsumed into the UHF G reen functions (as in x2.1), which here constitute the bare' propagators; and in this important sense the above de nition, Eq. (3.7), of the host propagator di ers from that of eg Refs [21,36,37,38,39,40] (which would be recovered if we set the site local moment j = 0).

To generalize the processes contained in Fig. 5, we renormalized the self-energy as shown in Fig. 6(b), replacing the -spin particle lines connecting the starred vertices i in Fig. 5 by the self-consistent host G reen function G_{ii}; ; the in nite set of diagram s thus retained in i follows simply by direct iteration of Fig. 6(b) using Fig. 6 (a) for G_{ii}; . This renorm alization is adopted for the following reasons. (i) It ensures that an on-site spin-ip occurs only when the doublon/hole hops o a site, and that its outward path is self-avoiding. W ith reference to Fig. 5 for example, site j f i is guaranteed, likewise $k \in j$; while term s with k = i vanish for d^1 , being at least 0 (1=d) since G_{ij}^0 0 (d^{m=2}) for sites i and jmth nearest neighbours. (ii) In addition, the resultant site restrictions further prevent the need to include a class of partially cancelling exchange diagram s, as illustrated simply in Fig. 7 (where a sum over j f i is im plicit). Since j 🗧 i is guaranteed, the exchange diagram (Fig. 7(b)) is at least 0 (1=d) and thus vanishes for d^1 , while the direct' diagram (Fig. 7(a)) is 0 (1). If, how ever, j = i was included in the direct diagram, its exchange counterpart would also be 0 (1) and would thus need to be retained.

We focus now on the lower Hubbard band (LHB) in strong coupling, viz ! 0 U ! 1; the upper Hubbard band follows trivially by symmetry. The G^+ (! 0) are likew ise pure real, with G_{B}^{+} (!) 0 (1=U) and G_{A}^{+} (!) 0 (1=U³) (as may be show n using Eq. (3.10) together with the analogue of Eq. (3.12) for G^+ (!); together with G^+ (!) = $\frac{1}{2} [G_{a}^+ + G_{b}^+]$, they too may be neglected. And from Eq. These are the equations for the corresponding t-J $_z$ m odel on the Bethe lattice, for an AF and random spin

background respectively (see eg [11,41]); the t-J_z m odel itself is naturally equivalent for d¹ to the t-J m odel since the spin excitations are purely Ising-like. W e add in passing that a m uch m ore detailed asym ptotic analysis, picking up constant term s O (1=U), leads to the bare'! in the denom inators of Eqs (3.15) being replaced by ! + !_p and ! + $\frac{1}{2}$!_p respectively for the AF and P phases. These shifts, neglected in the brief analysis above, re ect sim ply the presence of the trivial charge term s in the t-J m odel (see Eq. (2.9)); they are irrelevant to our subsequent discussion.

Since the t-J lim it emerges correctly in strong coupling, the present theory is thus asymptotically exact. Consider for example the P phase, noting that for the U = 0 non-interacting lim it the G reen function $G_0(!) = ReG_0(!)$ i sgn(!) $D_0(!)$ is given by

And since G (!' 0) = $\frac{1}{2}G_{A^{u}}$ (!) as above, the total low er H ubbard band spectrum in strong coupling is D_{L} (!) = $\frac{1}{2}D_{0}$ (!), see also x2.1b; (the normalization factor of $\frac{1}{2}$ naturally rejects the fact that the remaining half of the single-particle spectrum occurs in the upper H ubbard band centred on ! = U, viz D_{U} (!) = $\frac{1}{2}D_{0}$ (U !)). Note further that the Feenberg (In edium ') and interaction self-energies contribute equally to the $\frac{1}{2}t^{2}G_{A^{u}}$ (!) denominator in Eq. (3.15b) for the P phase. Physically, this rejects the fact discussed in x2.1b that, upon adding a spin electron to a site, it is equally probable for either the added spin or the

-spin electron already present to hop o the site. At UHF/HIII level, in contrast, only the form er can by construct occur (= 0): the analogue of Eq. (3.15b) is then G^0_{A} (!) = [! $\frac{1}{4}t^2G^0_{A}$ (!)] ¹, producing an incorrect strong coupling bandwidth of 2t as argued physically in x2.1b.

The AF case itself is discussed further in the following section since, in contrast to the P phase, the approach to strong coupling is subtle and physically revealing. Here we simply add that (i) in contrast to the P phase, the $\frac{1}{2}t^2G_{A^{"}}(! + !_p)$ denom inator in Eq. (3.15a) for the AF stems solely from the interaction self-energy $_{A^{"}}(!)$. Thus at UHF/H III level atom ic lim it behaviour arises (incorrectly), viz $G_{A^{"}}^{0}(!) = 1=!$, as argued physically in x2.1a. (ii) A lthough obtained explicitly for the Bethe lattice, Eq. (3.15a) holds equally for the hypercubic lattice in strong coupling. This is because retraceable paths, which by construct are the only self-energy paths for a Bethe lattice, are for the d¹ hypercube also the only paths which restore the N eel spin con guration; see also [29].

3.3 Results

At nite U the basic self-consistency Eqs. (3.2) and (3.8a), are solved numerically. We consider is the AF phase.

A.Antiferrom agnet

For U=t = 10, Fig. 8 shows the resultant lower H ubbard band, $D_{\rm L}$ (!) = 1 Im G (!); from particle-hole sym m etry the upper band follow sby re ection about the Ferm i level, $D_{\rm U}$ (!) = $D_{\rm L}$ (U !).

For the same $!_p$ -value (Fig. 3a, inset), Fig. 8 shows also the corresponding t_{J_z} lim it spectrum from Eq. (3.15a). As is well known [11] the t_{J_z} spectrum is discrete (and to illustrate relative intensities is thus shown with height proportional to integrated weight). Physically, this re exts the fact that the hole is pinned by the string of spin- ips its motion creates, leading therefore to spatially localized single-particle excitations and hence a discrete spectrum; m athem atically, it is re exted in convergence of the continued fraction in plicit by iteration of Eq. (3.15a).

A lthough the U=t = 10 spectrum evidently bears a close resemblance to its t-J_z counterpart, it is by contrast continuous. This persists for any nite U: with increasing interaction strength the individual sub-bands in D_L (!) centre ever closely on their t-J_z counterparts, and their integrated spectral weights tend to those of the t-J_z lim it; but they retain a nite width, re ecting delocalization of the hole. The peculiarities of U ! 1 are further evident in the t-J_z model itself, Eq. (3.15a). For any !_p > 0 the t-J_z spectrum is discrete, while for !_p = 0 (as in Eq. (3.15b) for the P phase) the spectrum is continuous: the point !_p = 0 thus corresponds to a transition from localized to extended single-particle excitations, and since !_p ! t²=U as U ! 1 it is clear that U = 1 is a singular point.

W hile the physical mechanism leading to delocalization of the hole at any nite U is not of course inherent in the t-J_z modelEq. (3.15a) itself, it is readily inferred. Consider the Neelspin con guration and imagine removing, say, an "-spin electron from an A-type site, i. The nearest neighbours (NN) to any "-spin site all all #-spins. Hence to leading order in U | the t-J_z limit| the hole initially moves via a NN #-spin electron hopping onto site i, creating thereon a spin- ip (with an associated exchange energy penalty); and the subsequent motion of the hole via such a correlated sequence of alternating NN spin hops, in leaving behind a string of upturned spins, would by itself render the hole spatially con ned.

At large but nite U there is how ever a sm all but nonvanishing probability am plitude, of order t²=U, for an "spin electron on a second NN site, also A-type, to hop to site i via an intervening #-spin site: the hole thus moves two lattice spacings, to the second NN A -type site. Unlike the $\ t-J_z$ processes" above, this does not entail a spin- ip with concom itant exchange penalty: the hole moves freely.

This mechanism evidently leads to hole delocalization and, in tandem with the $t-J_z$ processes, produces the strong coupling spectrum. Its form al origins reside in the passage from Eq. (3.10a) to Eq. (3.15a) for the AF lower Hubbard band in strong coupling, where the Feenberg part of the self-energy $S_{A, "}(!) = \frac{1}{2}t^2 G_{B, "}(!)$ was neglected. As seen readily from the asymptotics of x3.2, the leading corrections to $\text{Im } S_{A^{"}}$ (! 0) are Im $S_A (!) = (t^2 = 2U)^2$ Im $G_A (!)$. It is these that embody the delocalization described above, and lead to spectral broadening (contributions to $\operatorname{ReS}_{A'}$ (!) are O (1=U) and lead simply to residual energy shifts). Further, note that since the energetic width of the spectral broadening is naturally the smallest energy scale in strong coupling, the principale ect on the bare' $t-J_z$ spectrum is a small resonant broadening of the individual $t-J_z$ lines. This is seen in Fig. 8, and becomes clearer still with further increasing U.

To ourknow ledge, the above mechanism is the only one which can lead to hole delocalization for the d^1 AF in strong coupling; and for the reasons already given in x32 applies to the hypercubic as well as the Bethe lattice. In nite-d it is for example well known that Trugm an paths [42] lead to hole delocalization for the hypercubic lattice, but such processes are 0 (d⁴) and do not therefore contribute in d¹ [29].

As U is decreased, the spectra continue to exhibit essentially strong coupling behaviour down to modest interaction strengths of U=t 2 3, and can thus be understood quantitatively starting from the t-J_z limit. This is shown in Ref. [7] (see eg F ig. 3(b) therein).

W ith further decreasing U how ever, the spectra evolve continuously to a weak coupling form that show s no trace of rem nant t-J_z-like behaviour. The spectral gap closes only in the non-interacting lim it whence, correctly, the system is an AF insulator for all U > 0. The full spectrum D ($\frac{1}{2}$) = D_L + D_U is shown in Fig. 9 for U=t = 1, together with the corresponding UHF spectrum to which (as one expects) it is qualitatively closer, although the single-particle gap $_{g}$ is reduced to 0.42 of the UHF gap = U j $_{o}$ j.

Two further renorm alizations have been performed to check the veracity of the above results. First, note that although the G reen functions have been obtained self-consistently via Eq.s (3.2,3.8), the single-particle propagators occurring in the RPA $_{AA}^{+}$ that enters the self-energy kernelEq. (3.8a), are then selves bare UHF propagators; see Fig. 2. To ensure the theory is robust, we have thus additionally renormalized the single-particle lines entering $_{AA}^{+}$ in terms of both the (self-consistent) full G reen functions G and the host G reen functions G. The results in either case di er only quantitatively, and at low U, from those just described; see also below.

The second renorm alization concerns the localm om ent j jwhich, in the calculations above, has been set to its UHF value j₀ j. In weak coupling, van Dongen [43] has exam ined perturbatively the N eel tem perature and the m om ent magnitude j j (the order param eter) for the d¹ hypercubic lattice, and has shown that even for U ! 0+ these are reduced by a factor q of order unity (q' 0.28 [43]) below their corresponding UHF values. The present theory is not of course perturbative (eg the em ergence of the AF spin- ip scale is intrinsically non-perturbative), but it is certainly closer in spirit to van D ongen to renorm alize the m om ent beyond UHF level. This is quantitatively im portant at low U, and is achieved by requiring that j jbe determ ined fully self-consistently via (cf Eq. (2.5))

For illustration Fig. 9 shows the Bethe lattice spectrum at U=t = 1, obtained with both j j and $_{AA}^{+}$ renormalized (the latter in terms of the full G reen functions). The gap $_{g}$ is further diminished, the ratio $g = _{g}$ = being 0:15; while the local moment j j is likew ise reduced below its UHF counterpart, such that $m = j \neq j_{0} j$ 0:39. It is not unfortunately feasible to obtain num erically accurate estimates of g and m as U ! 0 (since j j and rapidly become exponentially small). But for U=t = 1 the UHF moment itself is accurately represented by its asymptotic U ! 0 lim it, $j_{0}j=8$ 2exp[t= 2U 1], so the above result form m ay be reasonably close to its limiting value.

B.Param agnet

To obtain correctly the strong coupling lim it for either phase is, as has been shown, fairly subtle. But in contrast to the AF, the approach to strong coupling for the param agnetic phase is not. Fig. 10 shows the full spec-¹sgn ($\stackrel{!}{\leftarrow}$) Im G ($\stackrel{!}{\leftarrow}$) ($\stackrel{!}{\leftarrow}$ = ! U=2) for the trum D (!) = P phase at U=t = 8, 6 and 4, compared to the strong coupling t- J_z lim it from Eq. (3.15b). For U=t = 8, the strong coupling lim it has in practical terms been reached: the Hubbard bands are essentially symmetrically centred on $\frac{1}{2}$ = U=2 respectively, with widths W $W_1 = 2 \frac{1}{2}$ t and a band gap of $g = \frac{1}{g}$ = W $2^{5}\overline{2}t$; even for U=t = 6 the departure from the U asymptotic spectrum is relatively minor. With further decreasing U, however, the individual bands become increasingly asymmetric; and the gap tends to zero more rapidly than $\frac{1}{\alpha}$, signalling the collapse of the insulating phase. This we now discuss, adding that throughout the insulating regime the local moments are well developed $(j j^{>} 0.95)$, as in M ott's conception of a M ott insulator [44].

Fig. 11 shows the resultant band gap, $_{g}$ (U), for the param agnetic insulator as a function of U=t . $_{g}$ (U) is found to vanish continuously at a critical U_c = 3:41t. D etailed num erical analysis shows the corresponding exponent to be unity,

and we note that the width of the critical regime is quite narrow: the behaviour Eq. (4.1) is seen clearly for $(U \quad U_c)^{<0.05t}$, corresponding to gaps $_g(U)^{<0.1t}$.

The continuous closure of the gap is intimately connected to the divergence of low-frequency dynamical characteristics of the system. Consider rst the self-energy \sim_{A} ($\frac{1}{2}$). At frequencies $\frac{1}{2}$ [$\frac{1}{2}$ + ; $\frac{1}{2}$ +] inside the spectral gap ($_{g} = 2\frac{1}{2}$ +), \sim_{A} ($\frac{1}{2}$) \sim_{A}^{R} ($\frac{1}{2}$) is pure real with a leading low $\frac{1}{2}$ expansion

It is instructive to compare the above results with those obtained from both the simple HIII approximation discussed in x2.1B, and with the resonance broadening contributions [13] additionally included, which we refer to as $H III^0$. For H III, $A = \frac{1}{2}U$ and $\beta j = 0$ | the approximation is purely static. Eq. (4.6) becomes a cubic for G ($\frac{1}{2}$), leading as is well known to $_{\rm q}$ (U U)³⁼² [13]. As is clear from Eq. (4.8) with $\beta j = 0_{b}$ the transition occurs when $A^2(U_c) = \frac{1}{2}t^2$, i.e. $U_c = \frac{P}{2}t$, and U) $\frac{1}{g^{2=3}}$. The H III⁰ approximation **(**U jıj can also be shown to be of the form Eq. (4.6), but with a \ddagger -dependent \sim_{A} (\ddagger) given by \sim_{A} (\ddagger) = $\frac{U}{2}$ + t²G (\ddagger) at low frequencies (which is su cient to analyze the criticalbehaviour); so that $A = \frac{U}{2}$ and $\beta j = t^2 j_1 j$. Since $\sim_{A^{"}}$ (!) is a simple linear function of G (!), Eq. (4.6) again becomes a cubic for G ($\stackrel{,}{\cdot}$); and, as for HIII, the gap exponent = $\frac{3}{2}$ [13]. Eq. (4.8) with $\beta j = t^2 j_1 j$ yields $j_1 j = (A^2 \quad \frac{1}{2}t^2) = (A^2 \quad \frac{3}{2}t^2)$. The transition thus

occurs when $A^2(U_c) = \frac{3}{2}t^2$, i.e. $U_c = \frac{p}{6t}$ as is well known [13]; and, again, j₁ j (U U) $\frac{1}{g}g^{2=3}$.

Both H III and H III⁰ are thus in the same universality class, rejected more generally in the fact that in either case scaling of the form Eq. (4.10) can be shown to hold, but with an exponent of $=\frac{1}{3}$. G ros [45] has recently extended H ubbard's hierarchical equation of motion decoupling scheme to higher order. The critical exponents are unchanged from those of H III/H III⁰; and the value of U_c itself is barely changed from its H III⁰ value of U_c=t ' 2.45. From the above discussion it is apparent that the present theory belongs to a di erent universality class from that of H III or its extensions.

In direct analogy to the AF phase discussed in x3.3, we have tested the robustness of our results by further self-consistently renormalizing single-particle lines in the polarization propagator $_{AA}^{+}(!) = {}^{0}_{AA}^{+}=(1 \quad U^{0}_{AA}^{+})$ that enters the self-energy kernel, Eq. (3.8a). To illustrate what this involves, consider renormalizing ${}^{0}_{AA}^{+}$ (and hence $_{AA}^{+}$) in terms of the self-consistent host G reen functions G . The resultant ${}^{0}_{AA}^{+}$ (!) is then given generally by Eq. (2.12), with the bare (UHF) G reen functions G_{A}^{0} now replaced by G_{A}^{-} . For ! = 0 in particular, Eq. (2.14) likew ise holds, but with the bare D_{A}^{0} (!) replaced by the renormalized spectral densities D_{A}^{-} (!) im G_{A}^{-} (!) im G_{A}^{-} (!) im G_{A}^{-} (!)

As discussed in x2,3 the key feature of the param agnetic insulator is the zero-frequency spin- ip scale. To preserve this, the local moment j j in Eq. (4.12) is itself renormalized to ensure that at each step of the self-consistent iteration scheme U⁰ $_{\lambda\lambda}^{+}$ (! = 0) = 1 (and we note that throughout the entire insulating regime, the resultant moment j j is also self-consistent in the sense of Eq. (3.17) to < 1% accuracy). The results of this further renormalization are found to dier negligibly from those we have reported above.

Finally, to demonstrate the importance of the $!_s = 0$ spin- ip scale, we have eliminated it: both by (a) neglecting its contribution to $_{A''}(!)$ in Eq. (3.8b), retaining only $_{A''}^{\text{Stoner}}(!)$; and (b) replacing $_{AA}^{+}$ by $_{AA}^{0}$ in the self-energy kernel Eq. (3.8a). Results obtained from (a) and (b) are very similar, but di er qualitatively from those reported above. In particular, although the self-energy remains !-dependent, the resultant critical behaviour is found to be that of H III/H III⁰ | the gap closes continuously, but with an exponent $= \frac{3}{2}$. This points clearly to the necessity of including the !s = 0 spin- ip scale throughout the entire insulating phase: not only in achieving the correct strong coupling limit (as in x3.2), but also in describing the destruction of the insulating state.

5. D ISC U SSIO N

W e now discuss the present work, particularly in relation to the iterated perturbation theory ($\mathbb{P}T$) approach [21,38,39,40,46], use and application of which has been extensive [5]. A lthough our theory of the M ott-H ubbard insulating phases, with its explicit em phasis on localm oments, is conceptually and technically distinct from $\mathbb{P}T$, som e general points of m arked contrast are evident.

For the antiferrom agnetic phase we have emphasized the importance of the $!_p$ spin- ip scale, inclusion of which is necessary to obtain even qualitatively reasonable results throughout essentially the entire range of interaction strengths, and in particular to recover exact strong coupling asymptotics. However IPT does not appear to capture the AF spin- ip scale, presumably because it om its repeated particle-hole interactions of the sort shown in Fig. 2 (which, as in x2.2A, are required to pick up the spin- ip). This is seen, for example, from the known inability of IPT to describe correctly the Udependence of the Neel temperature [5], particularly in the H eisenberg' regime.

For the param agnetic insulator, the results of x4 also disagree qualitatively with those obtained from IPT; see in particular [40] and the review [5]. W ithin IPT the param agnetic insulating solution is found to break down discontinuously (at a critical $U_{c1} = 3.67t$, where the IPT gap $_{\rm g}(U_{c1}) = 0.3t$), and $j_1 j$ (Eq. (4.10)) remains nite at the transition.

The same authors [12] have recently exam ined the insulator via exact diagonalization (ED) on clusters of $n_s = 3$, 5 and 7 sites, extrapolated to $n_s ! 1$ assuming $1=n_s$ scaling behaviour. The resultant data suggest a continuous closure of the gap at a $U_{c1}=t=3.04$ 0.35 and are consistent with $_g$ (U) (U U); see also [5]. Further, and independently of the gap analysis, the behaviour of j₁ jhas also been examined by ED [12], noting (see Eq. (4.10)) that a divergence in j₁ jim plies a continuous closure of the gap: $1=j_1j$ is found to show good scaling behaviour, and to scale to zero when n_s is extrapolated to 1.

The present theory evidently agrees with the inferences drawn from ED. These concur with our predictions (x4) that the gap closes continuously and with an exponent = 1, that j_1 jdiverges, and (less in portantly) the value of U_c itself; note moreover that the ED gap [12] is in rather good agreem ent with the present work over a wide U range. As described in x4, inclusion of the !_s = 0 spin ip scale is central in describing the destruction of the M ott insulator. That IPT appears unreliable close to U_c [5] thus suggests an incom plete inclusion of the e ects of this spin scale | which cannot be entirely absent since IPT does give the correct strong coupling spectrum [47]| although in physical terms the origin of the spin- ip scale within IPT is not transparent.

To conclude, we have developed in this paper a theory for the T = 0 M ott-H ubbard insulating phases of the d¹ Hubbard model, encompassing both the antiferromagnetic and paramagnetic insulators. The microscopic perspective it a ords hinges on the importance of low energy scales for insulating spin- ip excitations. Their existence is physically natural within the explicit local moment picture intrinsic to the theory, and inclusion of them is required not only to obtain the strong coupling limits of the single-particle spectra | which are captured exactly | but more generally to describe the entire insulating regimes, including for the paramagnetic phase in particular the destruction of the M ott insulator.

Let us also note what we have not considered: the m etallic state of the param agnetic phase. But a glim pse of what is required to describe the metal within the present fram ework is evident from Fig. 12. For U=t = 3:5, close to the critical U_c of x4, this shows the spectral density of transverse spin excitations Im $_{AA}^{+}$ (!) (here obtained, as described in x4, with 0 $^{+}_{_{AA}}$ renorm alized in term s of the G_{λ}). The ! = 0 spin-ip pole characteristic of the param agnetic insulator is evident, and persists down to Uc. C learly, how ever, the spectral edges of the Stoner-like bands are them selves approaching ! = 0. This they do at $U = U_c$, and for $U < U_c$ in the metallic phase the insulating spin- ip pole at ! = 0 is replaced by a resonance at a sm all non-zero frequency $! = !_{K}$, indicative of the K ondo-like physics known to dom inate the correlated m etal [5,6]. Extension of the present approach to describe the metal, encompassing the K ondo spin-scale in such a manner that the correlated state is correctly a Ferm i liquid, will be described in a subsequent paper.


























