# P article-hopping M odels of V eh icular T ra c: D istributions of D istance $H$ eadw ays and D istance B etw een Jam s

A bstract
W e calculate the distribution of the distance headw ays (i.e., the instantaneous gap betw een successive vehicles) as well as the distribution of instantaneous distance betw een successive jam $s$ in the $N$ agel-Schreckenberg ( N S) m odelofvehiculartra $c . W$ hen them axim um allowed speed, $\mathrm{V}_{\mathrm{m}}$ ax, of the veh icles is larger than unity, over an interm ediate range of densities of vehicles, our M onte C arlo (M C) data for the distance headw ay distribution exhibit tw o peaks, which indicate the coexistence of "free- ow ing" tra cand tra c jam s. O ur analytical argum ents clearly rule out the possibility of occurrence ofm ore than one peak in the distribution of distance headw ays in the N S m odelwhen $\mathrm{V}_{\mathrm{m}}$ ax $=1$ as well as in the asym m etric sim ple exclusion process. M odifying and extending an earlier analytical approach for the $\mathrm{N} S \mathrm{~m}$ odelw ith $\mathrm{V}_{\mathrm{m}} \mathrm{ax}=1$, and introducing a noveltransfer $m$ atrix technique, we also calculate the exact analytical expression for the distribution of distance betw een the jam $s$ in this $m$ odel; the corresponding distributions for $\mathrm{V}_{\mathrm{m}}$ ax $>1$ have been com puted num erically through M C simulation.

## 1. IN TRODUCTION:

The motion of each vehicle in tra $c$ is in uenced by others around it; the statistics and dynam ics of tra c ow [1-5] crucially depend on these "interactions" betw een the vehicles. H ow ever, the dynam ics of vehicles is m ore com plicated than that of interacting particles [6] because of the dependence on hum an behaviour; usually, the driver has the aim of reaching his destination safely in the shortest tim e and can also learn from experience. N evertheless, signi cant progress has been $m$ ade in $m$ odelling tra $c$ by extending the concepts and techniques of statistical $m$ echanics $[4,5]$ by capturing som $e$ of the com $m$ on and essential features of the driving habits of the individual drivers.
$T$ he theoreticalm odels of tra c can be broadly divided into tw o classes: (i) continuum models, and (ii) car follow ing m odels; the form er is the analogue of the "hydrodynam ic" m odels of uids while the latter is the analogue of the " $m$ icroscopic" $m$ odels in statistical $m$ echanics. The older version of the carfollow ing theory [7] w as form ulated $m$ athem atically using di erential equations for describing the tim e evolution of the positions and speeds of the individual vehicles in tim e, which w as treated as a continuous realvariable. In the m odem versions, nam ely, the particle hopping m odels, not only the position and speed of the vehicles but tim e also is assum ed to be discrete. Som e of these particlehopping m odels [8] m ay be regarded as stochastic cellular autom ata [9].
$T$ he distance headw ay is one of the $m$ ost im portant characteristics of vehicular tra $c$. It is de ned as the distance from a selected point on the lead vehicle to the sam e point on the follow ing vehicle. U sually, the front edges or bum pers are selected [3]. O ne of the aim s of this paper is to calculate the distributions of the distance headw ays in the steady state, using a class of particle-hopping models, which are known to capture some of the essential features of tra c
ow on highw ays. $W$ e also report analytical as well as num erical results on the distribution of instantaneous distance betw een successive vehicular jam s in the steady state of these $m$ odels.

W e de ne them odels and the characteristic quantities of interest in section 2. W e com pute the distance headw ay distribution in section 3 and the distribution ofdistance betw een jam $s$ in section 4 . W e sum $m$ arize the results and conclusion in section 5 .
2. THEMODELSAND CHARACTERISTIC QUANTITIESOF IN TEREST:

In allthe " m icroscopic" m odels under our consideration, a lane is represented by a one-dim ensionallattice ofL sites (i.e., a chain ofL equispaced points). E ach of the lattice sites can be either em pty or occupied by a "vehicle". There is an "exclusion principle", nam ely, that no tw o vehicles can occupy the sam e lattice site sim ultaneously.

The ratio of the num ber of occupied lattioe sites to the total num ber of lattice sites is de ned as the density of the vehicles on the lane. T he density is tim e-dependent for a nite lattice w ith open boundaries where vehicles enter from one end and leave from the other. In this paper we shall consider only
idealized single-lane highw ays w ith periodic boundary conditions. Therefore, in this geom etry of the highw ay, the tim e-independent density c of the vehicles is $\mathrm{N}=\mathrm{L}$ where $\mathrm{N}(\mathrm{L})$ is the total num ber of vehicles in the tra C .
2.1. The A sym m etric Sim ple Exclusion P rocess:

O ne of the sim plest dynam icalm odels of interacting particle system $s$ is the so-called asym $m$ etric sim ple exclusion process (A SEP) which $m$ ay be regarded as a caricature of vehicular tra $c$. The rules for updating the positions of the particles in the A SEP are as follow s: one particle is picked at random and m oved forw ard by one lattice site if the new site is em pty. In this random sequential update, it is the random picking that introduces stochasticity (noise) into the m odel. A though speeds of the particles do not explicitly enter into the rules, the e ective speed of a particle in the A SEP can take only tw o values, nam ely, 0 and $\mathrm{V}_{\mathrm{m} \text { ax }}=1$.
2.2. The N agel-Sch reckenberg M odel:

W e now recall the "rules" describing the dynam ics of vehicles in the N agelSchreckenberg $(\mathbb{N} S)$ m odel [8] where the speed $V$ of each vehicle can take one of the $V_{m ~ a x ~}+1$ allow ed integer values $V=0 ; 1 ;::: ; V_{m ~ a x}$. At each discrete tim $e$ step $t!t+1$, the arrangem ent of $N$ vehicles is updated in parallel according to the follow ing rules. Suppose, $V_{n}$ is the speed of the $n$-th vehicle at tim $e t$.

Step 1: A cceleration. If, $\mathrm{V}_{\mathrm{n}}<\mathrm{V}_{\mathrm{m}}$ ax , the speed of the n -th vehicle is in creased by one, i.e., $\mathrm{V}_{\mathrm{n}}$ ! $\mathrm{V}_{\mathrm{n}}+1$.

Step 2: D eceleration (due to other vehicles). If d is the gap in betw een the $n$-th vehicle and the vehicle in front of it, and if $d \quad V_{n}$, the speed of the $n$-th vehicle is reduced to d 1 , i.e., $\mathrm{V}_{\mathrm{n}}$ ! d 1.

Step 3: Random ization. If $V_{n}>0$, the speed of the $n$-th vehicle is decreased random ly by unity (ie., $V_{n}$ ! $V_{n} 1$ ) w ith probability $p(0 \quad p \quad 1)$; $p$, the random deceleration probability, is identical for all the vehicles and does not change during the updating.

Step 4: Vehicle m ovem ent. Each vehicle is moved forw ard so that $X_{n}$ ! $X_{n}+V_{n}$ where $X_{n}$ denotes the position of the $n$-th vehicle at timet.

In the literature on tra $c$ ow, the relation betw een the average ux of the vehicles and their density is usually referred to as the "fundam ental relation". $T$ he qualitative features of the fundam ental relation of the NS m odel are very sim ilar to those of the em pirically derived fundam ental relation for real traf-
c. $c_{m}$, the density corresponding to the $m$ axim um ux, is usually called the optim um density.
2.3. De nitions of $D$ istance $H$ eadw ay and $D$ istance B etw een Jam s:

The num ber of em pty lattioe sites in front of a vehicle is taken to be the $m$ easure of the corresponding distance headw ay. If the instantaneous speed of a vehicle is zero, then it is part of a tra c jam. The num ber of lattioe sites in betw een tw o such "jam $m$ ed" vehicles is taken as the $m$ easure of the distance betw een the tw o corresponding instantaneous jam s to which they belong, provided none of the sites betw een these two sites is occupied by any other "jam $m$ ed"
vehicle (the sites in between $m$ ay, of course, be either em pty or occupied by vehicles w ith non-zero instantaneous speed).

W e have calculated both the distributions for the NS m odel analytically when $\mathrm{V}_{\mathrm{m} \text { ax }}=1$. H ow ever, for the NS m odelw ith $\mathrm{V}_{\mathrm{m}}$ ax $>1$ our results in this paper have been obtained by com puter sim ulation as analytical calculations becom e too com plicated to carry through.
3. RESULTS ON D ISTANCE HEADWAY D ISTRIBUTION :
3.1. $D$ istance $H$ eadw ay $D$ istribution for $V_{m ~ a x ~}>1$ :

NS claim ed that $V_{m}$ ax $=5$ is a very realistic choige and, therefore, $m$ ost of the subsequent works on the NS m odel have been carried out for this particular value of $\mathrm{V}_{\mathrm{m}}$ ax. B esides, the m ost com m on choige forp is $0: 5$. T herefore, w e begin presentation of our results by plotting the distribution of distance headw ays in the NS m odel in $g .1$ (a) for $V_{m a x}=5, p=0: 5$. For sm all values of the density c, the gap distribution exhibits a single peak; interestingly, the gap distribution van ishes for gap sizes sm aller than the corresponding value of $V_{m}$ ax. This im plies that, at low densities, the vehicles arrange them selves in such a m anner as to $m$ aintain a gap, which is at least as large as $V_{m a x}$, so that free ow of the vehicles can take place. W ith the increase of the density of the vehicles the distribution still exhibits a single $m$ axim um, although the m ost probable gap becom es sm aller, provided the density is su ciently low. H owever, as c approaches $\mathrm{C}_{\mathrm{m}}$, a second peak appears at a gap of unit lattice spacing; this new peak is a consequence of the congestion of the vehicles. $W$ th the further increase ofdensity the new peak becom es higher at the cost of that at the larger gap and, eventually, as c! 1, the distribution approaches a -fiunction at unity.

A re the characteristics of the distribution in $g .1$ (a) m erely special feature of the chosen value $V_{m}$ ax $=5$ or generic features of the NS m odel irrespective of the speci c value of $V_{m ~ a x}$ ? In order to answer this question let us plot the distribution ofdistance headw ays in the N $S \mathrm{~m}$ odelfor another value of $\mathrm{V}_{\mathrm{m}}$ ax , say, $V_{\mathrm{m} \text { ax }}=3$ in $g .1$ (b) wherep is chosen to be $0: 5 \mathrm{as}$ in g .1 (a). T he characteristics of the distribution and the trend of its variation $w$ ith density are very sim ilar to those in $9.1(a)$.

N ow we shall show that the occurrence of two peaks in the distribution of distance headw ays depends on $p$. For exam ple, for the same p as in g.1, nam ely, $p=0: 5$, the distribution does not show the occurrence of tw o peaks for any value of the density $\mathrm{c} w$ hen $\mathrm{V}_{\mathrm{m}}$ ax is 2 (see g 2 (a)). Nevertheless, the tw o-peak structure of the distribution over a regim e of density is observed even for $\mathrm{V}_{\mathrm{m}} \mathrm{ax}=2$ provided p is large enough (see $\mathrm{g} 2(\mathrm{~b})$ ).
3.2. $D$ istance $H$ eadw ay $D$ istribution for $V_{m}$ ax $=1$ :

D oes the distance headw ay distribution in the NS m odel exhibit tw o peaks also for $\mathrm{V}_{\mathrm{m}}$ ax $=1$ ? In order to establish the absence of any such tw o-peak structure in the gap distributions, irrespective of the density of the vehicles, in the NS m odel for $V_{m}$ ax $=1$ and in the ASEP we next derive the corresponding exact analytical expressions.

For the convenience of their analytical calculations, Schreckenberg et al.[10]
changed the order of the steps in the update rules in such a manner that it does not in uence the steady-state properties of the $m$ odel. They assum ed the sequence of steps 234 1, instead of 123 4; the advantage is that there is no vehicle w ith $V=0 \mathrm{imm}$ ediately after the acceleration step and this reduces the num ber ofpossible states of a ste by one. For exam $p l e$, if $V_{m ~ a x ~}=1$, V can take only the value 1 at the end of a sequence of steps $2 \quad 3 \quad 4 \quad 1$ and Schreckenberg et al[10] could use a binary site variable to describe the state of each site; $=0$ represented an empty site and $=1$ represented a site occupied by a vehicle (w ith speed $V=1$ ). In this notation, the probability of nding an $n$ cluster in the con guration ( $1 ; n$ ) in the steady state can be denoted by the sym bolP $\mathrm{P}_{\mathrm{n}}(1$; n ).

A though the sequence of steps $2 \quad 3 \quad 4 \quad 1$ and the description of the congurations in term s of the binary variable can be used also for our analytical calculation of the distance headw ay distribution in the NS m odelw ith $\mathrm{V}_{\mathrm{m}}$ ax $=1$ these, how ever, w ould be indequate for our analyticalcalculation of the distribution of distance betw een jam s in the sam em odel, as we shallexplain in the next section. T herefore, for the convenience of extension of the approach in the next section we now slightly m odify the notation. W e use the site variable $s$, instead of , to denote the state of each site ; $s=1$ represents an em pty site whereas $s=1$ represents a site occupied by a vehicle (with speed $V=1$ ). But, for the calculation of the distance headw ay distribution, we adopt the sam e sequence as in ref.[10], i.e., 234 1. Therefore, in this section, the site variable $s$ can take either of the only tw o allow ed values, nam ely, +1 and 1.

Suppose, $P$ ( $j$ ) is the probability of nding a gap ofsize $j$ in front of a vehicle. Stated $m$ ore precisely, $P(j)$ is the conditionalprobability of nding $j$ em pty sites in front of a site which is given to be occupied by a vehicle, i.e.,

where $P$ is the probability of occurrence of the argum ent con guration where the underlined part is xed.

In the $m$ ean eld approxim ation we neglect all correlations betw een the vehicles. Therefore, in this approxim ation, the probability on the right hand side of equation (1) can be factorized and, hence, the gap distribution is

M ean- eld approxim ation is know $n$ to be exact for the A SE P [11-13] and, therefore, the right hand side of equation (1) is the exact analytical expression for gap distribution betw een the particles in the A SEP ; note that $P_{m} f a(j)$ does not exhibit tw o peaks sim ultaneously at any value of c (see g.3).
$M$ ean eld results can be im proved by taking into account the correlation between the vehicles. In general, this is achieved by dividing the lattice into clusters of length $n$ which am ounts to taking the e ect of correlation upto $n$
nearest neighbours [10]. In the n-cluster approxim ation, we divide the lattioe into segm ents or clusters of length $n$, such that tw o neighbouring clusters have ( $n$ 1) sites in com $m$ on. For the case of $V_{m}$ ax $=1$ one expects strong correlation only betw een vehicles at nearest-neighbout lattice sites and, therefore, from now onw ards, we carry out all our analytical calculations for this case only in the 2 -cluster approxim ation.

In the 2 -cluster approxim ation [10], the probability of nding a gap of j sites, can now be written as [14]

where the conditional probabilities $P_{2}\left(s_{i} 1{\dot{j_{i}}}_{i}\right)$ and $P_{2}\left(s_{i+1} \dot{\mathrm{j}}_{i+2}\right)$ are given, interm s of the 2 -cluster probabilities $\mathrm{P}_{2}\left(\mathrm{~s}_{\mathrm{i}} ; \mathrm{S}_{\mathrm{i}}\right)$ and $\mathrm{P}_{2}\left(\mathrm{~s}_{\mathrm{i}+1} ; \mathrm{S}_{\mathrm{i}+2}\right)$, by the relations

Schreckenberg et al.[10] pointed out that only one of the four 2-cluster probabilities $\left.P_{( }+1 ;+1\right) ; \mathrm{P}_{2}(+1 ; 1) ; \mathrm{P}_{2}(1 ;+1) ; \mathrm{P}_{2}(1 ; 1)$ is independent. Solving the $m$ aster equation for $P_{2}(+1 ; 1)$ they found that

U sing the expressions (6)-(11) in the equations (3)-(5) we get [14]

where $y=P_{2}(+1 ; 1) . T$ he distribution (12) is the exact analytical expression for the distance headw ay distribution in the NS m odel when $V_{m}$ ax $=1$ and it also does not exhibit tw o peaks sim ultaneously at any value ofc (see g.4). The di erences betw een the exact gap distributions for the A SEP and the N S m odel
w ith $\mathrm{V}_{\mathrm{m} \text { ax }}=1$ arise from the fact that parallel updating in used in the NS m odel in contrast to the random sequential updating in the A SEP $[8,10]$.
$T$ he tw o-peak structure of the gap distribution has been interpreted as a signature of "tw o-phase coexistence" in a recent study of a continuum m odel [15]. W e believe that an identical interpretation can be given also for the occurrence of tw o-peak structure in the gap distribution of the discrete NS m odel; the two coexisting phases being the "free- ow ing phase" and a "jam m ed" phase. In the context of particle-hopping $m$ odels, the tw o-peak structure of the gap distribution was rst discovered during a com puter sim ulation of a tw o-lane m odel [16] but no analytical calculations w ere attem pted. O ur com parison here w th the exact analytical expressions for $V_{m}$ ax $=1$ clearly establishes qualitative di erences betw een the distributions for $V_{m}$ ax $=1$ and those for $V_{m}$ ax $>1$; there is only one peak in the gap distribution for all densities w hen $\mathrm{V}_{\mathrm{m}}$ ax $=1 \mathrm{w}$ hereas for $V_{m ~ a x}>1$ tw o peaks appear in an interm ediate regin e of density of vehicles. In this paper we have indirectly inferred the coexistence of the tw o dynam ical phases in the NS m odelw ith $\mathrm{V}_{\mathrm{m}}$ ax $>1$ over a p-dependent range of densities by com puting the distance headw ay distribution which is, traditionally, one of the im portant characteristics of vehicular tra c. Very recently, Lubeck et al.[17] have proposed a new m ethod, based on the "localdensity distribution", in an attem pt to characterize the free- ow ing and jam $m$ ed phases quantitatively and to locate the region of coexistence of these phases on a "phase diagram " of the N S m odel.
4. RESULTS ON THE DISTRIBUTION OF DISTANCE BETW EEN JAMS:
4.1. D istribution of $D$ istances betw een Jam $s$ for $V_{m a x}=1$ :

A ccording to our de nition, each of the jam $m$ ed vehicles has a speed $V=0$. $T$ herefore, for the calculation of the distribution of distance between the jam s the site variable $s \mathrm{~m}$ ust be allowed to take one of the three allowed values, nam ely, $s=1$ if the site is em pty, $s=1$ if the site is occupied a vehicle whose instantaneous speed is $V=1$ and $s=0$ if the site is occupied by a vehicle which is instantaneously jam $m$ ed, i.e., has a speed is $V=0$. Since $s$ can now take three values, nam ely, 1;0; 1, we have a total of nine 2 -cluster probabilities. Therefore, in the case of the sequence $2 \quad 3 \quad 4 \quad 1$ of the steps in the N S m odel, we have the equations

in addition to the equations (8)-(11).
Since there is no vehicle w ith speed V $=0$ after the step (1) of the N S m odel, we cannot use the sequence $2 \quad 3 \quad 4 \quad 1$ for the calculation of the distribution of distance betw een jam s. Instead, we use the sequence 41023 , ie., we calculate the required tw o cluster probabilities after the step 3 of the NS m odel [18]. In order avoid any confusion betw een the tw o-cluster probabilities $\mathrm{P}_{2}\left(\mathrm{~s}_{\mathrm{i}} ; \mathrm{S}_{\mathrm{i}+1}\right)$ associated w ith the sequence 234 1, which we considered in
section 3, and those associated w ith the sequence $4 \quad 1 \quad 2 \quad 3$ we denote the latter by the sym bol $p_{2}\left(s_{i} ; s_{i+1}\right)$; we shall use the expressions for $P_{2}\left(s ; s^{0}\right)$ to calculate those for $p_{2}\left(s ; s^{0}\right)$.

In the 2 -cluster approxim ation, the probability of a distance $k$ betw een tw o successive jam $s$ is given by

W hat is the physicalm eaning of the probability of gap $k=0$ between tw o jam s? Shouldn't two jam med vehicles with vanishing gap be regarded part of the sam e jam ? Indeed, the equation (15) clearly show sthat $\mathrm{P}_{2 \mathrm{c}}(\mathrm{k}=0)$ is the total fraction of the vehicles which are sim ultaneously in the jam $m$ ed state.

The required 2 -cluster probabilities $p_{2}(a ; b)$ can be calculated from the expressions for $P_{2}(c ; d)$, as expressed by the follow ing equations [18]

The distribution (49)-(50) is in excellent agreem ent with the corresponding results of M C simulation (see gs.5 (a) and (b)).
4.2. D istribution of $D$ istance betw een Jam $s$ for $V_{m}$ ax $>1$ :
$W$ e have com puted the distribution of the distance betw een jam s num erically through M C sim ulation for severalvalues of $V_{m}$ ax $>1$; som etypicaldistributions for $V_{m}$ ax $=5$ are show $n$ in 9.6 . The lower is the density the $m$ ore signi cant is the di erence betw een the distributions for $V_{m a x}=1$ ( g .5 ) and for $\mathrm{V}_{\mathrm{m} \text { ax }}=5$ ( g .6 ). T his, of course, is a consequence of the fact that the higher is the density the fewer are the vehicles which can attain speeds larger than unity.
5. SUM M ARY AND CONCLUSION:

In this paper we have calculated the distance headw ay distribution and the distribution of the distance between the jams in the NS m odel of vehicular tra c on single-lane highw ays. W e have derived analyticalexpressions for these distributions in the special case $V_{m}$ ax $=1$; but obtained only num erical results for $V_{m a x}>1$ by carrying out com puter sim ulation. O ur results indicate the coexistence of "free- ow ing" and jam m ed tra c over a p-dependent range of densities provided $\mathrm{V}_{\mathrm{m} \text { ax }}>1$.

In the analytical approach followed in this paper one stores the inform ation on the state of occupation of each site; therefore, this form alism is som etim es called a "site-oriented" approach. Very recently a "car-oriented" form alism of analytical calculations for the N S m odel has been developed. Since this new "car-oriented" approach takes into account longer range correlations than in the "site-oriented" approach, it would be interesting to recalculate analytically the distance headw ay distribution and the distribution of distance betw een the jam $s$ in the NS m odel using this new form alism.
