M odi cation of the Landau-Lifshitz Equation in the Presence of a Spin-Polarized Current in CMR and GMR M aterials.

W e derive a continuum equation for the m agnetization of a conducting ferrom agnet in the presence of a spin-polarized current. Current e ects enter in the form of a topological term in the Landau-Lifshitz equation . In the stationary situation the problem m aps onto the motion of a classical charged particle in the eld of a m agnetic m onopole. The spatial dependence of the m agnetization is calculated for a one-dim ensional geom etry and suggestions for experim ental observation are m ade. W e also consider tim e-dependent solutions and predict a spin-wave instability for large currents.

Phenom ena associated with spin-polarized currents in layered m aterials and in M n-oxides have attracted high interest recently. E orts are strongly concentrated on theoretical and experim ental investigation of large m agnetoresistance, which is of great value for future applications. Exam ples of the e ect are GMR in layered m aterials (see review [1]), spin value e ect for a particular case of a three-layer sandwich and CMR in the m anganese oxides (see review [2]).

The dependence of resistivity on magnetic eld is explained conceptually in two steps: rst the magnetic eld changes the magnetic con guration of the material and that in turn in uences the current. Of course, as for any interaction there must be a back-action of the current on the magnetic structure. The existence of such backaction was explored in [3,4]. Several current-controlled m icro-devices utilizing this principle were proposed [3]. In both papers layered structures with m agnetization being constant throughout the magnetic layers were considered. In the present paper we derive the equations for a continuously changing magnetization in the presence of a spin-polarized current. This equation takes the form of a Landau-Lifshitz equation with an additional topologicalterm, and adm its a useful analogy with a mechanical system . W e discuss several solutions in one-dim ensional geometries. Our equations also can be viewed as a continuum generalization of [3,4] for layer thickness going to zero.

Consider a current propagating through a conducting ferrom agnet. Conducting electrons are viewed as free electrons interacting only with local magnetization M. The motion of each individual electron is governed by the Schroedinger equation with a term $J_{\rm H}~$ M, where $J_{\rm H}~$ is the value of the Hund's rule coupling or in general of the local exchange. Since spin-up electrons have lower energy a nonzero average spin of conducting electrons (1=2)h i develops. An angular momentum density (h=2)h i is then carried with the electron current so we have a ux of angular momentum. This leads to a nonzero average torque acting on the magnetization which

can de ect it from the original direction (see gure 1).




FIG.1. Experimental setting: spin-polarized current enters a half-in nite magnet from the left. O riginally the magnetization is aligned along the easy-axis kz. However if the incoming electrons are spin-polarized in a dimentidirection, their interaction with the magnetization leads to a demection of the magnetization.

P ropagation of a current in a ferrom agnet should be described by a system of two equations: one for the m otion of conducting electrons and another for the m agnetization. We derive here the second equation in the lim it of small space-time gradients and present several solutions. The case of very large J_H ! 1 is considered, m eaning a complete polarization of electron spins in the ferrom agnet. This case can be often realized in experiment. In the layered structures m agnetic layers can be m ade of a m aterial with large band splitting, like H eusler alloys, in which the spin opposite to m agnetization direction can not propagate. In the CMR m aterials large H und's rule coupling is well known [2] and constitutes the basis for a double-exchange m echanism governing their m agnetic ordering.

Schroedinger Equation: the conducting electrons are considered noninteracting with an " = p^2 =2m energy spectrum :

We diagonalize the matrix M (r;t) with a local spin

rotation = U (r;t) . The spinor describes the electron in the coordinate system with z-axis being parallel to the local magnetization. Retaining only the rst order terms in gradients and using ! 0 for J_H ! 1 we reduce (1) from a system of two equations to one equation for $_+$ spin amplitude:

The last term in (2) can be transformed (M = M n):

where $A^{m \text{ on}}(n)$ is a function satisfying the following equations:

If we view $n^2(r;t) = 1$ as a sphere, $A^{m \text{ on}}$ has the sim – ple interpretation of the vector potential due to a magnetic m onopole located at the center of the sphere. The m onopole term is known to appear from $U_+ r_i U_+$ in the theory of Berry phase and is used by other CMR theories in di erent forms (see [5]). Equation (3) has a form of a Schroedinger equation in a magnetic eld expanded up to the linear term in A^e , with vector potential $A_i^e = (i h_i^2 = 4m) A_{m \text{ on}}^k r_i n^k$. It describes the m otion of the conducting electrons in the given eld n (r;t). C onversely it gives the interaction between the current and the magnetization. The form of equation is the same as for an electrom agnetic interaction, and hence we can write by analogy:

where j is an electric current.

M agnetization m otion is described by Landau-Lifshitz equations which are obtained from the energy functional. A fler adding (4) to the usual energy density of a ferrom agnet with uniaxial anisotropy along the axis , we obtain:

with K > 0 corresponding to easy-axis and K < 0 to easy-plane m agnets. The equations of m otion then take the form :

where the last term in f is new and describes the e ect of the current. The system of (3) and (6,7) constitute a complete set of equations for a magnet with current. Equations (6,7), generalizing the Landau-Lifshitz equation in the presence of a current, are the central result of this work.

Since magnetization corresponds to angular momentum $L = h=g_B M$, an equation of the angular momentum ux continuity follows from (7):

The ux $_{ki}$ consists of two parts: one due to the spatial derivatives of magnetization and another due to the motion of conducting electrons. In our situation the spins of moving electrons are parallel to n. That is why their contribution is factorized in the form (h=2) (j=e)n_k.

C onsider the stationary case in an experimental setting shown on gure 1. For the stationary process the rh.s. of equation (6) vanishes. The current propagates along the \hat{y} direction. All spatial derivatives reduce to r ! r_y. For the reasons in mediately following we will denote di erentiation with a prime to get a resemblance to a time derivative in notation r_y n n⁰. From (7) we get an equation on n (r;t):

Since n in the stationary case depends on y only, we can interpret y as a ctitious time; together with $n^2 = 1$ equation (10) can then be interpreted as the equation of motion for a particle of a mass J con ned to the surface of a unit sphere and experiencing two forces:

(a) a force of magnitude K (n) parallel to the anisotropy axis,

(b) a Lorentz force, due to a eld $H_{m \text{ on}} = Q \left(\frac{j}{e}\right)n$ of a magnetic monopole positioned in the center of the sphere. The vector product ensures that only tangential components of the total force act on the particle. The norm al component is compensated by the reaction forces. Such an anology enables one to visualize the soluctions of the original equation (10) as trajectories of a massive particle on the sphere.

The equation of particle motion in the eld of a magnetic monopole (10) has two rst integrals [7].

Together they give a way to solve (10) for arbitrary initial conditions. Expressing everything through the Euler angles f (y); (y)g (de ned on gure 1) of the vector n, we obtain:

The problem for is solved by the implicit function:

afterwards can be found from the rst equation in (13).

A ssume that deep inside the magnet (y ! 1) the magnetization resumes its original direction along the anisotropy axis n ! ; n^0 ! 0. From this the values of the st integrals can be found and substituted into (13). Natural length and current scales appear in the calculation:

through which the material parameters J;K;M enter the problem . Their values for dimensional are given in the following table:

The integral (14) can be then expressed in elementary functions but the form ula is long and will be detailed in a later paper. Instead, the results are presented on gure 2. It is seen that m agnetization relaxes in a distance

 $10 \ensuremath{\mathtt{L}}_m$ which is about the width of the dom ain wall in the material.

In the \particle picture" the motion starts at some point A on the trajectory, yet to be determined from the b.c. on the normal metal - magnet interface, and ends on the N orth pole. The particle has just enough energy to climb the potential hill and come to rest on the top. The particle trajectory is bent by the monopole eld. In the absence of the monopole the particle would go along the meridian.

The boundary condition on the metal-magnet interface, y = 0 is derived from the continuity of the angular momentum ux. Such condition ensures that there is no torque concentrated on the boundary consistent with the assumption of slow spatial changes of the magnetization.




FIG.2. M agnetization de ection angle (y). Curves correspond to di erent values of current, $_0 = =2$; p = 0.5. Inset: trajectory of particle on the sphere for $j = j_0$. Starting point A corresponds to the conditions of the main graph.

The relection of the down-spin electron component occurs on the length scale of the electron wavelength. On this distance magnetization is almost constant and solving the one-particle relection problem we not the jump of the electron ux component in the ý direction $i \qquad iy$ to be:

where is the average injected ux. From (9) the ux inside the magnet is:

In the m etal, only the electron part of the ux is present. Then continuity gives the boundary condition:

Note that it involves both the vector n and its derivative on the boundary.

Condition (18) can be transformed into a system of two algebraic equations and an inequality:

where = $e, \cos_0 = e$; $x = _0 ny = e$ The parameter p = e = j; p 2 [0;1=2], describes the \degree of polarization" of the incident electrons. The inequality in (19) is a geometrical constraint on x and y arising from their de nition.

The trajectory is determined by three parameters: $(j=j_0;p;_0)$. We can plot a domain of existence of a solution to (19) in the 3-D space of these parameters. A typical 2-D section of this diagram for constant $_0$ is shown in gure 3. A solution is absent in the regions B and C which means that for larger currents and spinpolarizations no sm ooth stationary solution approaching the easy-axis direction at in nity is available. Either a non-stationary solution or a solution which never approaches will be realized in that region.




FIG.3. A typical2-D section of the phase diagram plotted for $_0 = = 3. A$: dom ain of existence of a solution to (19); B: no solution, b.c. at y = 0 can not be satis ed; C:no solution, b.c. at y ! 1 can not be satis ed and spin wave instability occurs.

T im e-dependent solutions of equation (7) can be found in some cases. We again assume the current j to be uniform . We rewrite equation (7) through n (r;t):

and suppose n_0 (r) solves [g n_0] = 0, i.e. represents a static solution in the absence of the current. Then

where $!_0 = K'$, is a solution of (20) for a nonzero current. For instance a moving B loch wallw ill be a solution when current is owing perpendicular to it (provided pinning is absent).

A nother particular solution is a spin wave in the presence of a current. We search for a solution (7) in the form of a spin wave: f = const; = kr ! tg. This gives the spectrum :

As we see, the current changes the energy gap of spin waves and shifts the position of the minimum :

where is the angle between j and k and $!_0 = K$ is the gap of spin wave in an anisotropic ferrom agnet. For large enough current $j > 4^{\circ} \frac{1}{2} j_0$ an instability occurs. That is also the condition which leads in the region C on gure 3 to the loss of any trajectory approaching at in nity as the integral (14) becomes undetermined. A spin-wave instability is also predicted in other models of spin-polarized transport [4].

D iscussing possible experiments we note that the characteristic current is large, but such densities are in fact common for layered metallic structures and j j₀ is experimentally possible. In this regime the calculated magnetization profile (gure 2) shows a deviation of

 20° on the boundary. D etection of the e ect is di cult because the spatial resolution of existing probes exceeds L_m . For a quantitative measurement of the de ection angle on the boundary, element speci c X-ray magnetic circular dichroism (MXCD) [11] could be used. A single layer of di erent magnetic element can be put on the boundary in the process of the lm growth. Such a layer will not much disturb the overall magnetization pro le. The MXCD signal of the additional layer could be separated from the M n signal and thus (0) can be measured. The time-dependent approach developed here can be applied to other experimental geometries, e.g. to nd the continuum analogies for the devices proposed in [3].
