Field-induced incom m ensurate-to-com m ensurate transition in $Ba_2CuGe_2O_7$.

We report an observation of a commensurate-incommensurate phase transition in the D zyabshinskii-M oriya spiral antiferrom agnet $Ba_2CuGe_2O_7$. The transition is induced by an external magnetic eld applied along the c axis of the tetragonal structure, i.e., in the plane of spin rotation. Bulk magnetic measurements and neutron di raction experiments show that the transition occurs in a critical eld H_c 2:1 T.Experimental results for the period of the magnetic structure and magnetization as functions of magnetic eld are in quantitative agreement with our exact analytical solution for D zyabshinskii's model of commensurate-incommensurate transitions in spiral magnets.

A m ong relatively unusual and exotic m agnetic interactions in solids is the D zyaloshinskii-M oriya (D-M) asym – m etric exchange interaction.^{1,2,3} U nlike the conventional H eisenberg exchange coupling, it is proportional to the vector product of interacting spins, and is perm itted by sym m etry only in non-centric crystal structures. It results from relativistic spin-orbit corrections³ to the ordinary superexchange m echanism⁴ and therefore is usually weak compared to antiferrom agnetic sym m etric exchange. This is why only few m aterials in which D-M interactions play an important role have been found so far. The best known examples are cubic FeG e^{5,6} and M nSi,^{7;8;9} where D-M terms in the H am iltonian cause an instability of ferrom agnetic order tow ards the form ation of an incom m ensurate spiral structure.

This paper deals with the properties of $Ba_2CuGe_2O_7$, a newly investigated system in which D-M coupling plays a key role. Originally the magnetic properties of this quasi 2-dim ensional (2D) antiferrom agnet (AF) were investigated as part of the ongoing search for new singlet ground state compounds, triggered by the discovery of a spin-Peierls transition and other extraordinary magnetic properties of CuGeO 3.^{10;11} W hile some new materials related to $CuGeO_3$, e.g., $CaCuGe_2O_6^{12;13}$ and $BaCuSi_2O_6$,¹⁴ have dim erized ground states and energy gaps in their spin excitation spectra, $Ba_2CuGe_2O_7$ undergoes a transition to a magnetically ordered phase below T_N 32 K and the magnetic excitations are gapless spin waves.¹⁵ Even though the magnetic properties of $Ba_2CuGe_2O_7$ can be adequately described in terms of classical spins, they are rather intriguing: the magnetic structure is an incommensurate spin-spiral. By perform ing detailed measurements of the spin-wave dispersion

we have previously dem onstrated that this spiral ordering m ay not be caused by competing exchange interactions.¹⁵ Since $Ba_2CuGe_2O_7$ has a non-centric crystal structure, we have suggested that the incommensurate magnetic phase is a result of D zyaloshinskii-M oriya interactions.

The crystal structure of $Ba_2CuGe_2O_7$, as well as the spiral spin arrangement in the magnetically ordered phase, were discussed in detail in our previous work,¹⁵ and only the essential features are reviewed here. The m agnetic (S = 1=2) Cu^{2+} ions are arranged on a square lattice in the (a;b) plane of the tetragonal structure [space group $P42_1m$ (No. 113), lattice constants a = 8:466 A, c = 5:445 A]. The in-plane interactions between spins are established through GeO₄ tetrahedra that, together with the Cu²⁺ ions, form distinct Cu-Ge-O layers. These layers are well isolated by interstitial nonmagnetic planes of Ba^{2+} ions. Only nearest-neighbor in-plane antiferrom agnetic exchange interactions are im portant (J 0:48 m eV). Interplane coupling is ferrom aqnetic and substantially weaker (J_2) 0:013 m eV). In the ordered phase the spins lie in the (1;1;0) plane and the propagation vector for the spiral is (1 + ;; 0) where = 0:027 [Fig. 1 (a)]. The magnetic structure is a distortion of a N eel spin arrangem ent: a translation along the (1;1;0) direction (hereafter referred to as the x axis) induces a rotation of the spins by an angle = $\frac{2}{2}$ 9:7 in the $(1;\overline{1};0)$ plane (relative to an exact antiparallel alignm ent). A long the $(1;\overline{1};0)$ direction (y-axis) the spins are perfectly antiparallel. Nearest-neighbor spins from ad jacent Cu-planes are aligned parallel to each other.

The mechanism by which D-M interactions can stabilize the spiral structure in $Ba_2CuGe_2O_7$ is illustrated in Fig. 1(b). The D-M energy for two interacting spins S_1 and S_2 may be written as $(S_1 S_2)$ $D^{(1;2)}$, where D ^(1;2) is the so-called D zyaloshinskii vector attributed to the oriented bond between the two spins and $\ "denotes a vector product. For spins lying in the (1;1;0) plane the only relevant component of the vector D is D_y. The symmetry of the structure is such that for two subsequent Cu-pairs (1;2) and (2;3) along the (1;1;0) direction D_y^(1;2) = D_y^(2;3) Fig. 1(b)]. A nite value for D energetically favors a 90 angle between subsequent spins. Since AF exchange favors an angle of 180, the total energy is minimized at some intermediate angle that is de ned by the ratio of exchange and D-M interactions strengths.$

How can the mechanism described above be veri ed experimentally? If one could force the spins into the (0;0;1) plane for example, D_v would become inactive, due to the nature of the vector product, and the incom mensurate spiral would disappear. The z-component of D, i.e., the (0;0;1)-projection, on the other hand, would become relevant. As shown in Fig. 1(b), for the D_{z} , unlike for D $_{\rm v}$, sym m etry dictates a change of sign from one Cu-Cu bond to the next: $D_z^{(1;2)} =$ $D_{z}^{(2;3)}$. As a result, D-M interactions would tend to distort the N eel spin arrangement towards a weak-ferrom agnet (canted) structure, that is commensurate with the crystal lattice. In practice forcing spins into the (a;b) plane can be achieved by applying an external magnetic eld along the c-axis of the crystal. Indeed, in structure with zero net magnetic moment spins tend to align perpendicular to the external eld, which in the simplest case leads to spin- op transitions in conventional antiferrom agnets. In other words, if the proposed model for D-M interactions in $Ba_2CuGe_2O_7$ is correct, we expect a eld-induced com m ensurate-incom m ensurate m agnetic transition (C I) in this material.

In the present paper we report an experimental observation of such a phase transition in $Ba_2CuGe_2O_7$ by means of bulk magnetization and neutron di raction measurements. We nd that the phase transition is of rather unusual character and is the rst \clean" realization of D zyaloshinskii's model for C I transitions in spiral magnets induced by a magnetic eld applied in the plane of spin rotation.¹⁶ W e also present an exact continuouslimit solution to D zyaloshinskii's model. For the particular case of $Ba_2CuGe_2O_7$ theoretical predictions are in quantitative agreement with experimental data. A short preliminary report on this work is published elsewhere.¹⁷

II. EXPER IM EN TAL PROCEDURES

Transparent, slightly yellow ish single-crystal sam ples were prepared using the oating-zone method. Magnetization measurements were performed with a conventionalDC-squid magnetometer in the temperature range $2\{300 \text{ K} \cdot \text{Two sets of neutron scattering experiments were$ carried out on the H4M (thermal beam) and H9 (coldbeam) 3-axis spectrometers at the High Flux Beam Reactor (HFBR) at Brookhaven National Laboratory on an irregularly shaped 4 4 m \vec{m} single-crystal sam – ple with a mosaic spread of 25° . In the rst set of measurements on H 4M (experiment I) the H –T phase diagram was determined using neutrons of incident energy E_i = 14:7 m eV with a (20° 40[°] 20[°] 40[°]) collimation setup and two PG Iters. The second set of measurements was done on H 9 (experiment II) and the

eld-dependence of the m agnetic propagation vector was studied using $(60^{0} 40^{\circ} 60^{\circ} \text{ sam ple } 1^{\circ} 80^{\circ})$ collimations, an E_i = 4:6 m eV neutron beam and a Be-liter in front of the sam ple. In both experiments the use of a pum ped ⁴He cryom agnet allowed us to work in the tem – perature range 1.3{5 K and m agnetic elds up to 6.5 T. The sam ple was always mounted with the (h;k;0) zone in the scattering (horizontal) plane and the eld was applied along the vertical direction (c-axis of the crystal).

The sample we used in prelim inary experiments shattered when it was cooled down in the cryom agnet for the second time. We therefore tried to mount the new crystal as strain-free as possible. The new sample was wrapped in alum inum foil that was attached to a thin Al-plate. This technique has one serious draw back. As will be explained below, a good alignment of the crystallographic caxis with the magnetic eld is crucial. Unfortunately, the described mounting procedure does not allow to maintain an alignment of better than 1.Before the sam ple is put into the cryostat, an alm ost perfect alignment is achieved. It is upon cooling to base tem perature that the undesirable m isalignment occurs. In experiment I the (1; 1;0) and (1;1;0) crystallographic directions form ed angles of 1:5 and 1 with the horizontalplane, respectively, as measured in situ at low tem perature. In experim ent Π these angles were 1 and less than 0:3, respectively.

III. EXPER IM ENTAL RESULTS

A.M agnetization

The rst evidence of a eld-induced magnetic phase transition in $Ba_2CuGe_2O_7$ was found in bulk magnetic measurements. The longitudinal magnetization data collected at T = 2 K is plotted against magnetic eld H applied along the a or c crystallographic axes in the insert in Fig. 2. For H jja no anom alies are observed. In contrast, when the eld is applied along c, M (H) has a broad step-like feature around H = 2 T. The anom aly is best seen in the plot (H) that was obtained by numerically di erentiating the experimental magnetization curve (Fig. 2, main panel).

B.Neutron di raction

The phase transition is best observed in neutron di raction experim ents. Figure 3 (experim ent II) shows

som e elastic scans along the (1 + ; ;0) direction m easured in $Ba_2CuGe_2O_7$ at T = 1:4 K. The di erent scans correspond to di erent values of magnetic eld applied along the c-axis. In zero eld [Fig. 3(a)] the magnetic peak is positioned at = 0.027^{15} . The incom m ensurability parameter decreases gradually with increasing H. Around H = 1.8 T an additional peak appears at the N eelpoint (1;0;0). At the same time the intensity of the satellite at (1 + ; ;0) starts to decrease rapidly and the rate at which changes with eld is increased [Fig. 3(b)]. On further increasing the eld the central peak gains intensity and the satellite eventually vanishes at som e critical eld H_c 2:3 T [Fig. 3(c)]. At higher elds only the N eel (commensurate) peak is seen, all the way up to the highest eld available experim entally. The intensities of the (1 + ;; 0) satellite and the (1;0;0) peak are plotted against tem perature in Fig. 3(d). M easured (T) is shown in solid circles in Fig. 4.

C.Dom ains and sam ple alignm ent

The eld-dependent behavior is extrem ely sensitive to the alignment of the crystallographic caxis with the applied eld. The limitations of the sample-mounting technique em ployed, together with technical im possibility of adjusting the alignm ent in situ at low tem perature, are therefore a serious experim ental com plication. This problem is closely linked to the issue of magnetic domains. In the tetragonal symmetry two spiral structures with propagation vectors (1 + ; ; 0) and (1 + ; ; 0):0) are allowed. Zero- eld cooling produces dom ains of equal volume. If the sample is cooled in an H = 1 T eld, that is rem oved only at low tem perature, only one dom ain is present. Since we are able to exactly measure (but not adjust!) the orientation of the sample in situ, we could determ ine that it is the dom ain for which the plane of the spiral form s a larger angle with the applied eld that is stabilized. This behavior can easily be explained. If the plane in which the spins are con ned is not parallel to the external eld, the system can gain som e Zeem an energy without sacri cing much D-M or exchange energy: all spinsm ay tilt slightly in the direction of the eld com ponent norm alto the spin plane, producing a cone structure with practically no change in the angles between neighboring spins. The dom ain for which the spin plane form s a larger angle with the applied eld is thus energetically more favorable. Note that in the commensurate (higheld) structure there are also two possible dom ain types, with spins in the (1;1;0) or (1;1;0) planes.

The data shown in Fig. 3 were collected on a eldcooled sample and the satellites correspond to the more misaligned (1 + ;; 0) domain (domain A, 1 tilt). No satellites were observed in the (1 + ;; 0) domain (domain B, < 0.3 tilt) in any elds in eld-cooling experiments. When the measurements at T = 1:4 K were done on a zero eld cooled sample, we observed that scattering intensities originating from both domains remain comparable in elds up to 1:7 T.At higher elds the N eel peak appears and domain B is rapidly destroyed. Applying a su ciently large eld thus brings us back to the situation where the entire crystal is a single magnetic domain.

D.Phase diagram

The experimental H T phase diagram for $Ba_2CuGe_2O_7$ is shown in Fig. 5. The I-O-II line corresponds to the appearance of the magnetic rejection at the commensurate (1;0;0) position. The III-O-IV line shows where the satellite peaks disappear. Both the O-II and the O-IV lines were measured in a eld-cooled sam – ple and the misalignment of the corresponding domain was 1:5 (experiment I).

In the high- eld phase the structure is commensurate, with a propagation vector (1;0;0). This may be the signature of N eel order or (see introduction) a canted \weak ferrom agnetic" structure. In the low- eld region the structure is incommensurate with a propagation vector (1 + ;;0). Only one domain is present since, as mentioned, eld-cooling was used. Note that except for the incommensurability of the low- eld phase, the phase diagram strongly resembles that of an easy-axis Heisenberg antiferrom agnet in external eld applied along the easy axis.

In the II-O -IV region the N eelpeak coexists with the incom m ensurate satellite. It would seem that in them isaligned domain the eld-induced transition is of rst order and that the II-O -IV region corresponds to a m ixedphase state. Indeed, at T = 1.4 K we have observed som e eld-hysteresis: on sweeping the external eld down from H = 4 T the N eel component vanishes and the satellite appears at slightly lower elds, than in the case when the H is gradually increased from zero. We believe that in a perfectly aligned sample the transition m ust be of 2nd order, in which case the II-O -IV region is replaced by a single line.

E.M easurem ents of (H)

A courate m easurements of the eld-dependence of were performed in experiment II where one domain was tilted by 1 (domain A) and the other almost perfectly aligned (domain B). M easurements for domain A could easily be done at base temperature (1.4 K) in a eld-cooled sample (Fig. 4, solid circles). Additional data for domain A were collected at T = 2.4 K. At this tem - perature (H) was found to follow the same curve as at T = 1.4 K to within experimental error.

For dom ain B experiments in the interesting eld region, where starts to decrease rapidly with increasing H, could not be perform ed at low tem perature: the domain itself is destroyed in elds higher than 1:7 T (see above). Nevertheless, (H) for dom ain B could be measured in a zero- eld-cooled sam ple at T = 2:4 K, i.e., just at the tem perature of the critical point 0 in the phase diagram . At this tem perature the B-dom ain survives up to the critical eld and the N eel com ponent does not appear before the (1 + ;;0) peak vanishes. Apparently even at 2:4 K dom ain wall pinning is su ciently strong and kinetics su ciently slow to make the energetically less favorable (better aligned) dom ain metastable even in high elds. This does not happen at low temperature: the com m ensurate structure em erges in a 1st-order transition and presum ably the therm odynam ic force that destroys the better aligned dom ain is larger. Som e typicalscans for dom ain B at T = 2:4 K are shown in Fig. 6. The dashed line shows experimental Q-resolution. The (1+; ;0) satellite is resolution-lim ited at H < 1:95 T Fig. 6 (a)] and starts to gradually broaden at higher elds [Fig. 6(b,c)]. The experimental (H) is plotted in open circles in Fig. 4. W e clearly see the sensitivity of the system to even a minor tilt of the applied eld relative to the caxis. W hile at low elds (H) for domains A and B coincide, there is a substantial discrepancy near the transition point.

F.Critical indexes

In our previous work we have reported measurements of the order-parameter critical exponent = 0:145(0:005) for the zero- eld transition from param agnetic (PM) to spiral states. Having discovered the com m ensurate phase, we have in addition determ ined for the PM ! commensurate transition at H = 3.66T. The intensity of the (1;0;0) magnetic re ection is plotted T)= T_N in a log-log plot in Fig. 7 (open against (T_N) circles). Fitting the data with a power-law dependence we obtain H = 4T = 0.185 (0.005). The previously measured tem perature dependence of the (1:0273;0:0273;0) Bragg intensity at H = 0 is shown in solid symbols in Fig. 7. Although the experim entally determ ined critical indexes are rather close to each other, in our data we clearly see that = 0.145 is incompatible with the 4 T m easurem ent (Fig. 7, dashed line).

IV.THEORY

In the introduction section we have qualitatively show n how D-M interactions stabilize the m agnetic spiral in $Ba_2CuGe_2O_7$ and why applying a eld along the caxis of the crystal should result in a commensurate structure. We shall now develop a quantitative description of a D-M spin-spiral in an external magnetic eld. The general expression for the free energy of such system was obtained by D zyaloshinskii,¹⁶ who also predicted the CI transition and obtained analytical expressions for the critical properties [at (H $_{\rm c}$ H)=H << 1]. In the present work we extend D zyaloshinskii's approach and derive analytical expressions for the period and the uniform magnetization of the spiral valid throughout the phase diagram . W e start by considering a simple, yet illustrative, case of a classical spin chain at T = 0.

A.Classical spin chain with D-M interactions.

Let us consider the 1-D case: a uniform chain of classical spins with isotropic (Heisenberg) antiferrom agnetic exchange. In addition, we include a D zyaloshinskii energy term with the D vector pointing along the arbitrary chosen y-axis. The system is then characterized by the following H am iltonian (energy functional):

It is straightforward to show that to take full advantage of the D zyaloshinskiiterm, the spins have to be conned to the (x;z) plane. The total interaction energy of a pair of spins is given by $E = 2JS^2 \cos + DS^2 \sin = S^{2^{L}} \frac{4J^2 + D^2}{4J^2 + D^2} \cos()$, where is the angle between the spins, and = $\arctan D = 2J$ 1, provided J D. The classical ground state is therefore an AF spiral, where the angle between subsequent spins is equal to +

Physically interesting behavior occurs when an external magnetic eld is applied perpendicular to the D zyaloshinskii vector D, e.g., along z-axis. In this case one-phas to take into account the Zeeman energy H g B $_{\rm n}$ Sz, where g is the gyrom agnetic ratio and B is the Bohrm agneton. D enoting by $_{\rm n}$ the angle the n-th spin S_n form s with the z-axis, we can rewrite the

energy functional as:

In Eq.(2) we clearly see the competing term s that drive the CI transition. The J-term favors an incommensurate (spiral) structure, where the phases $_n$ of subsequent spins di er by +. The e ect of the magnetic eld is more subtle. For H $_J$ the spins tend to align parallel to the eld. For H $_J$ how ever, the system still can gain some Zeem an energy without sacri-

cing much of its exchange energy. This is achieved in a spin- op state, where all spins are roughly perpendicular to the magnetic eld and slightly tilted in its direction. The external eld thus favors a commensurate spin- op structure, but it can only be realized by sacri cing some D zyaloshinskii energy. Indeed, the energy di erence between the spin- op con guration and the spiral state is $J'(1 \cos)$ $H'^2=8J'$. The spin op state become senergetically favorable in elds $H' > H'_c$ 2 J'. This is

the simpli ed physical picture already discussed in the introduction section. The above crude arguments does not take into account the distortion of the spiral by the applied eld. The exact result for our model, $H_c = J$ is derived below.

B.Exact ground state in the continuous lim it

It is convenient to change angle variables so that

The ground state satis es the extrem al conditions $@H = @_n = 0$, which gives us the following set of equations:

These equations can be solved in the continuous limit. We shall look for a solution in the form $_n = (n) + (1)^n \# (n)$, where both (n) and # (n) are functions that only slow ly change on the scale of a single lattice spacing. From Eq. (5) we obtain the extrem al condition that should be satis ed in an energy minimum :

The rst of these equations is the fam ous sine-G ordon equation, which allows for exact soliton solutions. The trivial no-soliton "solution to Eqs. (6,7) is (n) = =2, and #(n) = H'=4J'. This is precisely the spin- op phase, realized in strong enough magnetic eld. Less trivial is the one-soliton solution:

For = 0 the energy of the one-soliton state will be always higher than that of the soliton vacuum (spin- op state). In the general case, substituting (8) into the energy functional (4), we nd the energy di erence between the one-soliton and soliton-free state: $E_1 = E_0 = H^* - J^*$. the energy of a single soliton is negative and solitons spontaneously \condense". This process will eventually saturate, due to the mutual repulsion of solitons, and the ground state will be a periodic \soliton lattice".

At the non-negligible soliton density the interaction starts to change the shape of individual solitons and has to be taken into account explicitly. Fortunately the general solution of the sine-G ordon equation is known:

where K and E are the complete elliptic integrals of the rst and second kind, respectively.

Equation (13), as well as the expression for H $_{\rm c}$ Eq. (9)] were derived in Ref.16. In the present work we go one step further and determ ine which of the solutions given by Eqs. (11,12) indeed correspond to the ground state at any particular H < H $_{\rm c}$. Unlike that in Ref.16, our treatment is not limited to the narrow critical region (H $_{\rm c}$ H)=H $_{\rm c}$ < 1. Taking the partial derivative of the energy functional (13) with respect to , and substituting identities for derivatives of elliptic integrals 18 after som e algebra we get:

Equations (14) and (16) provide us with (H) in a parametric form. The ratio (H) = (0) is plotted against $H = H_c$ in Fig.8. The insert schem atically shows the spin structure for $H = 0, 0 < H < H_c$, and $H > H_c$.

At low density soliton repulsion is exponentially sm all and the system close to the transition point is extremely sensitive to any perturbations of the original H am iltonian, that will tend to pin down the soliton lattice in one of the metastable con gurations. As H ! H_c 0, the soliton density decreases as $1=j\ln(H_c + H)$; is very rapidly.¹⁶ The transition is thus almost rst order [the critical exponent = 0 in (H) (H + H)].

The soliton lattice at H $\stackrel{6}{=}$ 0, unlike the pure sinusoidal spiral at H = 0, has higher Fourier harmonics at $_{2n+1}$ = (2n + 1) (H). The know ledge of the exact ground state enables us to calculate these harmonics analytically. For the B ragg intensity (square of the am - plitude) of the strongest 3rd harmonic, for example, one gets

This ratio of intensities is plotted against (H)= (0) in Fig. 9. Except very close to H $_{\rm c}$ all harm onics are much weaker than the $\,$ rst one.

A swe derived a parametric expression for (H), so we can also obtain an exact parametric form for the uniform magnetization $M = (0E=0H \cdot From Eqs. (14,15))$, and the identities for derivatives of elliptic integrals¹⁸ one gets:

The magnetization curve is continuous at the critical eld. On the other hand, its derivative with respect to H (the eld dependent susceptibility) diverges when H_c is approached from below.

C.G eneralization to nite tem peratures and higher dim ensions

The results obtained in the previous chapter can be easily generalized to the cases of higher system dimensionality and nite temperatures. We follow the approach developed by D zyaloshinskii in R ef. 16 and introduce the expression for the free energy of a general almost antiferrom agnetic spiral in an external magnetic eld. We generalize the results derived for the 1-D chain in the previous section to obtain analytical expressions for the period and the magnetization of the structure valid not only in the critical region, but troughout the phase diagram.

Since the period of the spiral is long, nearest neighbor m agnetic m om ents are alm ost opposite to each other. This enables us to approximately describe the structure in term s of position dependent staggered m agnetization L (r). To take fulladvantage of the D-M interaction, L (r) m ust be perpendicular to the D-M vector, and therefore be con ned to the x z plane. We further assume that the m agnitude jL (r) j does not depend on r. This sim – pli cation is justiled since the Zeem an energy, which at H c is of order of D-M interaction energy, is much smaller than the energy of isotropic exchange. The local m agnetic structure is thus fully de ned by the angle (r), that L (r) form s with the z-axis. The total <code>\elastic"</code> free energy per single C u plane, associated with spin-spin interactions, can then be written as:

Equation (20) is given in the form suitable for describing a single Cu plane in Ba₂CuGe₂O₇. $_{s}$ (T) is the so-called spin sti ness at given temperature, = $_{ab}$ is the in-plane nearest neighbor Cu-Cu distance, and is the spin sti ness anisotropy factor, de ned as $(_{c}=_{ab})^{2}=_{j}J_{c}=_{j}j_{a}J_{a}J_{j}$ 1=37 in Ba₂CuGe₂O₇. Coordinates x, y, and z run along (1,1,0), (1,1,0), and (0,0,1) directions, respectively. The spin sti ness at zero temperature is given by $_{s}(0) = 2JS^{2} \cdot I^{9}$ As T approaches T_{N} the spin sti ness decreases as $J_{c}(r)f_{a}^{2}$ and vanishes precisely at T_{N} .

In taking into account the external magnetic eld, it is convenient to introduce the quantities $_{\rm k}$ (T) and $_{\rm 2}$ (T), the magnetic susceptibilities of the system with respect to a eld that rotates along with the spiral structure and is always parallel or perpendicular to the local staggered magnetization, respectively. As in a usual antiferrom agnet, these susceptibilities do not diverge at $T_{\rm N}$. In the paramagnetic phase (at $T > T_{\rm N}$), $_{\rm k}$ (T) = $_{\rm 2}$ (T). At zero temperature the classical result is $_{\rm 2}$ (0) = (g $_{\rm B}$)²=(8dJ 2),¹⁹ and $_{\rm k}$ (0) = 0.

The full expression for the free energy density in the presence of magnetic eld H applied along z-direction is:

At T = 0 and d = 1 Eq.(21) coincides with the expression for the energy of a spin chain derived in the previous section.

The equilibrium con guration of (r) m inimizes the free energy and therefore satis as a generalized form of Eq. (6):

For a 4-nn AF like $Ba_2CuGe_2O_7$ at T = 0 we can use ? = $(g_B)^2=16J^2$, $_k = 0$, and $_s = J_{ab}S^2$. Substituting these expressions into Eq. (23) we obtain

a factor of $\frac{p}{2}$, compared to the 1-D case [Eq. (9)]. This factor is due to the fact that in 2 dimensions each spin is antiferrom agnetically coupled to four, rather that two nearest neighbors, and the overall structure is sti er. Unlike antiferrom agnetic in-plane interactions, ferrom agnetic coupling between adjacent Cu-planes in $Ba_2CuGe_2O_7$ does not change $_2$ or the expression for the critical edd.

The tem perature dependence of H $_{\rm c}$ can be easily understood within the mean-eld (MF) approximation. In this framework $_{\rm ?}$ is T-independent, $_{\rm k}$ decreases with $T_{\rm N}$ T and $_{\rm ?}$ = $_{\rm jj}$ at T = $T_{\rm N}$. The eld ective strength of exchange coupling, represented by JS² in Eq. (23) goes as the square of the order parameter, i.e., as $T_{\rm N}$ T (the MF order-parameter critical exponent = 0.5). Substituting these values in Eq.(23), we ind that within the MF approximation H $_{\rm c}$ is independent of tem perature. This result is the same as for the spin- op eld in a conventional easy-axis H eisenberg antiferrom agnet.

F inally, we can generalize the expression (19) for the magnetization. W ith new parameters in the sine-G ordon equation we get:

for H_c . For $H > H_c$ one has $M = {}_{?}H$. The eld dependent susceptibility (H) = dM = dH is given by:

At H = 0 this expression gives (0) = (2 + 1) + 2 = 2: the structure is a uniform spiral, which electively averages out the susceptibility for all directions in the spin plane. The susceptibility diverges at H_c as $1 = (H_c - H_c) + 10^2 (H_c - H_c)$.

V.D ISCUSSION

A.D-M interactions in $Ba_2CuGe_2O_7$

W e have shown that the spiral spin arrangement in $Ba_2CuGe_2O_7$ is due to the in-plane component D_v of

the Dzyaloshinskii vector D for nearest-neighbor Cu²⁺ ions. It is rather di cult to experim entally determ ine whether or not the out-of-plane component D $_z$ is also active. In the spin- op phase the predicted canted weakferrom agnetic structure di ers from a N eel state only in that it gives rise to additional magnetic peaks coincident with nuclear Bragg re ections. The latter are much stronger than any magnetic scattering intensities, and m ake m easurem ents of the ferrom agnetic com ponent all but impossible. In the spiral phase however, if $D_z \in 0$, satellites of type (h + ;k + ;l) should be observable around ferrom agnetic zone-centers, in addition to the principalm agnetic peaks positioned around the AF zonecenters. In prelim in any experiments at T = 1.5 K we have indeed observed extrem ely weak elastic features at reciprocal-space positions (2 + ; ; 0) and (1 + ; 1 + ; 0). So far we have not investigated the possibility of these features being artifacts due to nuclear-m agnetic double scattering.²⁰ W e plan to resolve this uncertainity in future experiments.

B. The com m ensurate-incom m ensurate transition

Studies of CIphase transitions have a long history, dating back to pioneering works of Frenkel and K ontorova²¹ and Frank and van der Merwe.²². Since then CI transitions were discovered and studied experimentally in a number of such seemingly unrelated systems as noble gas monolayers adsorbed on graphite surface²³, charge density wave $m \text{ aterials}^{24}$, ferroelectrics²⁵ and rare-earth magnets²⁶ (For comprehensive reviews see for example Ref.²⁷). As a rule, CI transitions result from a com petition between two distinct terms in the Ham iltonian that have di erent \built-in "spatial periodicities and are often referred to as potential and elastic energy, respectively. The potential energy by de nition favors a structure commensurate with the crystal lattice. Such is the interaction between gas atom s and the graphite m atrix in intercalated and adsorbed system s. The elastic term is intrinsic to the system where the transition occurs, and has a di erent \natural" built-in period. For adatom son graphite this term represents their mutual interaction. In our case of a Heisenberg AF with D-M interactions it is the H \cos_n term in Eq. (2) that plays the role of an e ective potential, forcing the spins in the plane, and thus favoring a commensurate structure. The competing elastic term is $J\cos(n+1)$), and the \natural" n periodicity is set by the angle .

In m any known realizations of C I transitions, such as adsorbed gas m onolayers, it is the period set by the elastic term that can be varied in an experiment to drive the transition, whereas both the strength and the period of the potential remain constant. In other systems, am ong them rare-earth m agnets, both the elastic term (exchange coupling between spins) and the potential (m agnetic anisotropy) can be changed, but only indirectly, by varying the tem perature. In both cases one typically observes a \devil's staircase" phase diagram (for a review see for example R ef. 27): the incom m ensurate structure tends to lock onto rational fractions of the period of the potential. Instead of a continuous C I transitions one gets a series of com m ensurate-com m ensurate transitions between di erent lock-in states.

The interest of D zyaloshinskii's model for CI transitions is that it is driven by a changing strength of the potential alone, with both built-in periods remaining constant. The experimentalist has a convenient handle on the potential term that he can vary by simply adjusting the external eld. Since the \built-in" periods do not change, the transition is continuous with no \devil's staircase" behavior.

The other advantage of the present realization of CI transitions lies in the fact that the potential energy has a pure sinusoidal form as a function of the angle (x). The model can be exactly solved and a quantitative com parison of theory and experiment are possible for the entire phase diagram. In most other CI system sone knows only that the potential energy is a periodic function with a given period, determined by the underlying lattice, while its exact functional form remains undetermined. Quantitative com parison of experiment and theory in this case is restricted to the narrow critical region close to the transition point.

It is important to note here that while eld-induced CI transitions have been previously observed in a number of magnetic insulators with incommensurate structure^{28;29;30;6} for various reasons none of them is well described by Dzyaloshinskii's model. In FeGe (Ref. 6) the problem is that in the high-symmetry cubic structure applying even a very sm allm agnetic eld rearranges the spins so that the spin rotation plane is perpendicular to the eld direction, in violation of D zyaloshinskii's requirem ent. Instead of a 2-nd order D zyaloshinskiitansition one gets a 1st-order spin- ip transition from the incom m ensurate phase directly into the papram agnetic state. A lthough this does not happen in compounds like R bM nB $r_3^{28;29}$ and C sFeC l_3^{30} , the phase behavior there is seriously complicated by the quantum e ects and frustration in the triangular spin lattice.³¹

In the following paragraphs we shall demonstrate that the experimental data on the CI transition in $Ba_2CuGe_2O_7$ agrees with our solution to D zyabshin-skii's model at the quantitative level. $Ba_2CuGe_2O_7$ thus appears to be the rst system that exhibits a D zyabshinskii-type transition in its original form.

C.Estim ates for the critical eld

The appeal of the theory presented above is that it allows for an exact solution. Its major limitation of course is that it is based on a classical, rather than quantum spin model. Nevertheless, our theoretical predictions seem

to be in excellent agreement with what is experimentally observed in $Ba_2CuGe_2O_7$, even at the quantitative level. To begin with, the model gives the correct value for the critical eld H_c. The in-plane exchange param eter J = 0:48 m eV was previously determ ined by m easuring the spin-wave dispersion spectrum $,^{15}$. The exchange energy per bond is then $J = 2JS^2$ 0:24 m eV.Theqvalues were measured in ESR experiments: $q_a = 2.044$ and $q_c = 2.474.^{32}$ By substituting (0) = 0.027 into Eq. (24) we immediately obtain $H_c = 3:3 T$, that should be compared to the experim entalvalue H_c 2:1 T.Considering that for the theoretical estimate we used predictions for T = 0 and ignored quantum e ects, a 30% consistency is quite acceptable.

D. The soliton lattice

The most intriguing prediction of our theory for CI transition in $Ba_2CuGe_2O_7$ is that the spin structure close to the phase transition is no longer an ideal spiral, but rather should be viewed as a lattice of solitons, i.e., domain walls separating regions of N eel-like spin arrangement. The soliton lattice is a distinguishing characteristic of all CI systems. Several comprehensive reviews on the subject exist, among them papers by Bak^{27} and Pokrovsky et al.³³ The basic physicalm echanism is quite simple. When the potential term is su ciently large, but still smaller than the critical value, it is favorable for the system to have large \commensureter regions. The elastic energy from the \incommensurater term in the Ham iltonian is partially released by forming domain walls or phase slips that separate \commensurater domains.

From the experimental point of view the soliton lattice concept has three important consequences. The

rst is that the incom mensurability parameter is eld-dependent, and ! 0 continuously as H ! H_c (Fig. 8). Moreover, the transition itself is very unusual: continuous, yet logarithm ically steep at H_c . The experimental

(H) data collected for the well-aligned dom ain (Fig. 4, open circles) can be nicely t by the theoretical curve shown in Fig. 8, treating (0) and H_c as adjustable parameters. A very good agreement is obtained with (0) = 0:027(1) and $H_c = 2:13(2)$ T at T = 2:4 K (solid

line in Fig. 4). All the way up to (H) = (0) 2=3 the theoretical curve follows the experim etal points closely. In the very proximity of H_c how ever, a deviation is apparent. This is to be expected: the soliton lattice becomes in nitely soft at the transition point and pinning to structural defects leads to a saturation of (H) at H! H_c and e ective broadening of magnetic Bragg re ections (Fig. 6). The alm ost-rst-order transition is very fragile. A small m isaligned domain as a rst-order transition with a m ixed-phase region and a substantially di erent form of (H) in the vicinity of H_c .

Inherently related to the unusual logarithm ic phase

transition is an anomaly in the magnetic susceptibility at H_{c} . We have used the theoretical expression (25) to

t the experimental (H) shown in Fig. 2. Since we cannot explicitly take into account the quantum and therm al spin uctuations, we have treated $\frac{1}{10}$, $\frac{2}{2}$, and H $_{c}$ as independent thing parameters. In addition, we allowed for a linear term vH in (H) that is present in both the H ja and H jc data. This term empirically accounts for intrinsic non-linearities in magnetization curves in the quantum (quasi) 2-dimensionalAFH eisenbermodel (Ref. 34, esp. Fig. 5), that in our case e ectively modify the local susceptibilities $_{?}$ and $_{k}$ at high elds. The t is shown in a solid line in Fig. 2. The values of the tting parameters are: $_{jj} = 0.89 \quad 10^5 \text{ em u/g}$, $_{?} = 3.43 \quad 10^{5} \text{ em u/g, } v = 1.72 \quad 10^{10} \text{ em u/g, and}$ $H_{c} = 1.88 \text{ T}$. This value for H_{c} obtained from magnetization at T = 2 K is slightly lower than $H_c = 2:13(2)$ T obtained from neutron di raction at T = 2.4K.

F inally, an important feature of the magnetic structure at nite elds is that it no longer is an ideal sinusoidal spiral. As discussed above, this distortion is characterized by higher-order Bragg harm onics, that should be observable in neutron di raction experiments. Although we have spent som e tim e looking for the 3rd order m agnetic satellite during experiment Π_{r} at T = 2.4 K and for several values of applied eld, we were so far unable to nd it. The reason is probably the lack of intensity. As can be seen from Fig. 9, the relative intensity of the 3rd harm onic is very sm all except in the imm ediate proxim ity of H_c, where the 1st satellite itself is broadened and weakened. We would like to emphasize here that the form of (H) and the existence of higher-order harm onics are in essence one and the same e ect. Since theory agrees so well with experiment as far as (H) is concerned, we are con dent in that satellites are present and will be observed in future experimentale orts.

E.System dim ensionality

We nally comment on our measurements of critical exponents. In our previous work we have shown that there are several hints, including the tem perature dependence of magnetic susceptibility, to that $Ba_2CuGe_2O_7$ should prim arily be considered a 2-dim ensional antiferrom agnet. This is further con med by them easured orderparam eter critical exponent = 0:184 for the PM ! com m ensurate transition, i.e., substantially sm aller than in standard 3-D m odels, where > 0:3 for H eisenberg, X Y and even Ising systems. One could naively expect that at high external elds the critical index would be smaller than at H = 0, since the symmetry of the corresponding Ham iltonian is smaller. Exactly the opposite is observed experim entally. The only suggestion that we can make at this point is that B a₂C uG e₂O 7 falls into a com pletely different universality class than conventionalm agnets. C onsidering the nature of the spiral phase and D-M interactions, we may be dealing with one of the chiral universality classes.³⁵ To obtain further insight into the critical properties of $Ba_2CuGe_2O_7$ further eld-dependent measurements of the of and other critical indexes are required.

No matter what the observed critical exponents are, the long-range magnetic ordering is still a purely 3dimensional phenomenon. For a CI occurring at nite tem perature dimensionality is known to play a key role. In a purely 1D system at non-zero tem perature the ground state will be destroyed, since the energy required to create a soliton is nite while the entropy gain proportional to lnL is in nite in therm odynam ic lim it. Solitons will be spontaneously created at any tem perature and no sharp transition will occur. In two dimensions, the e ect of therm al (or quantum) uctuations is more subtle. For a general case Pokrovskii, Talapov and Bak have dem onstrated that the e ective soliton-soliton interaction is altered by uctuations.³³ The short range exponential repulsion exp (r) is replaced by a long range term $1=\hat{r}$. This modi es the behavior close to the transition point, making the phase transition a usual second order-type $(H_c \quad H)^{1=2}$. Only in 3 dimensions the rewith (H) sults that we have derived for the ground state should remain valid at nite temperatures. The transition in this case is of alm ost rst order, with logarithm ic \corrections" near the transition point making it continuous.

F. Ideas for future experim ents

Ba2CuGe2O7 is a very interesting system, yet it is relatively easy to investigate experim entally. The Heisenberg exchange constants are sm all, so the m agnon dispersion relations could be measured in the entire Brillouin zone. D-M interactions are relatively strong and the incom mensurability parameter (0) is su ciently large to be 2 T is also readily accessible easily measurable. H_c in most types of experiment, even those that require the use of di raction-adapted horizontal- eld magnets. The work on $Ba_2CuGe_2O_7$ is far from being completed. The rst priority is to nd the higher-order harm onics of the incom m ensurate m agnetic peaks and study the tem perature dependence of their intensities. One should also look for satellites around ferrom agnetic zone-centers to see if there is a weak-ferrom agnet distortion of the spiral structure. The e ect of magnetic eld applied in the (a; b) plane is worth investigating. The critical behavior is not fully understood and accurate eld-dependent m easurem ents of all critical indexes are highly desirable. Finally, it would be interesting to look at dynam ical propeties of the soliton lattice. Near the critical eld the solitonsoliton interaction is extremely weak, which gives rise to spin waves with very low velocity.

VI.CONCLUSION

We have observed a rare type of CI transition in an antiferrom agnetic insulator with D zyaloshinskii-M oriya interactions. The transition is driven exclusively by the changing strength of the commensurate potential. The latter is directly controlled in an experiment by varying the magnetic eld. A transition of this kind was envisioned over three decades ago by D zyaloshinskii, and we have now found that $Ba_2CuGe_2O_7$ exhibits it in its original form. In addition, we have extended D zyaloshinskii's theoretical treatment to derive exact parametric equations for the eld dependence of magnetization and incommensurability vector.


FIG. 5. Measured magnetic phase diagram of $Ba_2CuGe_2O_7$. The eld is applied along the c-axis of the crystal.


FIG.6. Elastic scans measured along the (1 + ; ; 0) direction in Ba₂CuGe₂O₇ at T = 2:4 K for several values of m agnetic eld applied along the caxis of the crystal. For this dom ain the (1;0;0) component does not appear before the critical eld is reached.


FIG.7. M easured B ragg intensity of the (1;0;0) (open circles, H = 3:66T, T_N = 3:5 K) and (1 + ;;0) (solid circles, H = 0, T_N = 3:2 K) m agnetic B ragg re ections. The solid lines lines are power-law ts to the data. The dashed line is an aid to the discussion in the text.


FIG.8. Theoretical eld-dependence of the magnetic propagation vector , obtained from an exact solution of a classical 1-dim ensional antiferrom agnet with D zyaloshinskiiM oriya interactions in the continuous limit. Insert: schematic representation of the spiral phase (H = 0), soliton lattice (0 < H < H_c) and the spin-op commensurate state (H > H_c).

FIG.9. Theoretically predicted Bragg intensity of the 3rd Fourier harm onic of the soliton lattice plotted as a function of (H) = (0).











