# D ynam ics of D iblock C opolym ers in D ilute Solutions

#### Abstract

In the present work we consider the dynam ics of freely translating and rotating diblock (A \{ B), G aussian copolym ers, in dilute solutions. U sing the previously developed multiple scattering technique $e^{1,1 \cdot[13} \mid$ applied to the study of suspensions of spheres and polym ers| we have com puted the di usion and the friction coe cients $D_{A B}$ and $A_{B}$, respectively, and the change $A B$ in the viscosity of the solution as functions of $x=\frac{N_{A}}{N}$ and $t=\frac{l_{B}}{l_{A}}$, where $N_{A}, N$ are the num ber of segm ents of the A block and of the whole copolym er, respectively, and $l_{A}, l_{B}$ are the $K$ uhn lengths of the A and B blocks. Speci c regim es that $m$ axim ize the di erence betw een the di usion constants of copolym ers $w$ ith distinct $t$ values, which lead to increasing the e ciency of separation processes, have been identi ed.


## I. IN TRODUCTION

Currently, due to both the practical signi cance and the theoretical challenge, there is a sustained interest in the study of transport properties of copolym ers in solution, $m$ ainly in relation to electrophoresis and associated phenom ena. B asically, one $w$ ishes to tag the $m$ acrom olecules of interest $w$ ith a neutral chain to $m$ ake the friction coe cient of the resulting ob ject m, plecular w eight dependent for allm easurem ent conditions, in order to increase the e ciency of the separation process ${ }^{44^{4}}$ A $s$ there are experim ental regim es for which the $m$ olecular weight dependence, is lost and the separation is very weak if not im possible (for a recent calculation for polyelectrolytes see M uthukum ariv), a broader understanding of the dynam ics of com posite ob jects in solution becom es critical.

To gain insight in the dynam ical behavior of an arbitrary heterogeneous polym er in solution, we will address a sim pler, nevertheless ilhum inating problem : consider tw o linear, $G$ aussian polym ens A and B, w ith lengths/num ber of segm ents $L_{A} / N_{A}$ and $L_{B} / N_{B}$, respectively, and $K$ uhn lengths $l_{A}$ and $l_{B}$, joined to form a com posite chain (A $\{B$ ) of total length $L=L_{A}+L_{B}$ and total num ber of $m$ onom ers $N=N_{A}+N_{B}$. In this paper we calculate the di usion and the friction coe cients of the diblock copolym er A \{B and the change in the viscosity of the solution due to the copolym er in dilute solutions, as functions of the dim ensionless variables $t=\frac{l_{B}}{l_{A}}$ and $x=\frac{N_{A}}{N}$.

O ur calculations are based on the cluster expansion theory and on the ective $m$ edium hypothesisitit T hem ain simplifying assum ption is the absence of excluded volume interaction. O ther approxim ations and features of our m odel are:
a) no interaction betw een the polym er chains except the hydrodynam ic interaction is present.
b) the solvent is incom pressible and the steady state lim it is considered.
c) the solution is assum ed in nitely difuted (one chain lim it).
d) the usual preaveraging approxim ation average hG $\left(r ; r^{0}\right) i$, is em ployed.
e) the hydrodynam ic interaction is enforced by using stick boundary condition.
$T$ he $m$ odel is not lim ited by the $G$ aussian nature of the tw o polym er com ponents, because the $K$ uhn lengths $l_{A}$ and $l_{b}$ could be ective quantities $m$ odeling chains $w$ ith excluded volum e and Coulom bic interactions (assertion valid in the hydrodynam ic lim it; at short distances the fractal structure of the polym er becom es transparent). A lso, even if the diblock, eepolym er could be regarded as a particular exam ple of a branched polym er, extensively studied in the literature, w ith interesting consequences in the calculations |he structure factor of the copolym erm ust be com puted now using
a bivariate $G$ aussian probability distribution function. F inally, the present approach allow s for obtain ing exact results, albeit num erical except som e lim its, and no approxim ation of $K$ irkw ood $R$ isem an type is necessary.

C onceming the outline of the paper, we next develop schem atically $\mid$ em phasizing the new elem ents| the underlying


## II. CALCULATION OF THESTEADY-STATEVELOCITYFIELD: INFINITEDILUTION LMIT

The dynam ical properties of the system can be deduced from the know ledge of the average velocity eld at any point in the solution. A s this type of com putation is already very well docum ented ${ }^{\prime} \mathrm{G}$ we w ill show detailed derivations only when necessary.

B rie $y$, the $m$ ain steps of our com putations are: rst wew rite the velocity eld in the solution in the presence of the copolym er; we apply the boundary condition to elim inate the unknown friction forces betw een the polym er and the uid and then we average over the random position and the con guration of the chain; next we construct the cluster expansion in term s of the selfenergy ( H artree Fock diagrams) of the uid and we express it as a function of the known (m easurable) physical param eters of the system; nally, we use the selfenergy to extract| both analytically and num erically $\mid$ the quantities of interest.

A ssum ing that the diblock copolym er A \{ $B$ w ith totalnum ber of segm ents $N$ is im $m$ ensed in an ideal, incom pressible uid obeying the linearized, tim e independent $N$ avier-Stokes equation (w th the solvent density equal to one), we can write the equation follow ed by the velocity eld $v(r)$ everyw here in the suspension as

where $F(r)$ and $p(r)$ are som e extemal force producing the $o w$ and the pressure, respectively, 0 is the kinem atic shear viscosity coe cient and $s=(s)$ is the force exerted by the bead located at $R_{s}=R$ ( $s$ ) upon the uid, $s$ being the arclength along the chain (for notational convenience $w e w i l l$ subsequently $w$ rite $s$ as a subscript). The form al solution of Eq. (2.11) is readily given by the integral representation (equivalent to the single layer solution of standard boundary $m$ ethods)

As mentioned, the dynam ics of the copolym er chain and of the uid are coupled through the no-slip boundary condition

In this section we present the detailed derivation of the transport properties of the system. T he essential aspect is the com putation of the structure factor, which involves, for the diblock copolym er case, the use of a bivariate $G$ aussian probability distribution function. This calculation is presented in A ppendix $\mathbb{A}_{\mathrm{A}}$. For any operator A ( $\mathrm{s} ; \mathrm{s}^{0}$ ) depending on the arclength variables $s$; $s^{0}$ we w ill use the follow ing Fourier representation (R ouse $m$ odes expansion in polym er language) :

$W$ e rem ark that at sm all $x$ values and $t \quad 1=4$ a maximum in $\frac{D_{A B}}{D_{A}}$ occurs. A lso, $D_{A B}$ exhibits a change in curvature when the $t$ param eter goes from $t<1$ to $t>1$, which motivated us in calculating the separation curves
$\left(D_{A B}=D_{A}\right)$, de ned as the di erence betw een two values of the ratio $D_{A}=D_{A}$ corresponding to distinct values of $t$, as a function of $x$. These curves are displayed in $F$ ig. ${ }_{n}$. Physically, the behavior of the di usion coe cient of the diblock copolym er opens the way to control the process of separation of $m$ acrom olecules by tagging the targets $w$ ith other weight-controlled polym ens. In particular, one can think of m odifying the di usion coe cient of a given polym er chain $A$ by attaching to it another polym er $B$, w ith thaving a prescribed value. There is also a range of the $x$ values that $o$ ers an increased $e$ ciency of the separation. This dom ain is $m$ uch $m$ ore localized for $t<1$ than for $t>1$, but the absolute value of the peak of $\left(D_{A B}=D_{A}\right)$ is highest when one com pares| at the sam $e x$ ratio| tw ocopolym ers $w$ ith $t$ greater and sm aller than one. This is reasonable| $t s m$ all $m$ eans $l_{A} b i g$, so even $s m$ all variations in $x$ have $m$ ore signi cant e ects than for pairs of copolym ers w th $t$ com parable to one.
 Because the $\bar{G}_{p^{0}}$ tensor, due to the diblock structure of the copolym er with di erent $\bar{K}$ uhn lengths, is not diagonal in the $p$ index, the calculation of the friction coe cient is m ore di cult. In general, one needs to decompose the $G{ }_{p p}{ }^{1}$ $m$ atrix in its diagonaland non-diagonalparts and then to use a B om expansion up to the desired ordellis. From a practical point of view, it is reassuring that, checking once again the validity of the $K$ irkwood $R$ isem an approxim ation by com puting А в neglecting all the non-diagonalelem ents of ${ }_{\mathrm{pp}}{ }^{0}$, we obtain a very good agreem ent w ith the exact num erical evaluations. T his aspect is illustrated in $F$ ig. ${ }^{\prime} \bar{G}, \mathbf{i}$ w here the continuous lines represent the calculation done using only the diagonal elem ents $\mathrm{G}_{\mathrm{pp}}$ only.
$B$ ased on this nding, in $F$ ig im ation is plotted against $x$ at various $t$ values. Sim ilar to the observations in the di usion case, we notioe that the intrinsic viscosity $[A B]=\left[A\right.$ ] attains a minim um $m$ atching the $m$ axim um of $D_{A B}=D_{A}$ from $F$ ig. useful for som e technological processes where a control of the viscosity of a solution is desired.

## IV. CONCLUSIONS

In this paper we have considered the stationary dynam ics of an in nitely diluted solution of freely translating and rotating $G$ aussian diblock copolym ers. T he copolym er chain consists of two com ponents A and B, w ith K uhn-lengths $h_{A}$ and $l_{B}$ and num ber ofsegm ents $N_{A}$ and $N_{B}$, respectively. There is no excluded-volum e interaction and the solution is described by the linearized $N$ avier-Stokes equation. The hydrodynam ics is coupled to the chain dynam ics by the no-slip boundary condition.

E xtending to our case the cluster expansion theory of polym ers and spheres, we developed explicitly the necessary theoreticalelem ents and we obtained analytically and calculated num erically the follow ing physicalquantities of interest: the di usion coe cient $D_{A B}$, the friction coe cient A $\quad$ and the intrinsic viscosity [ $A$ b ]. T he results have been displayed graphically as functions of the dim ensionless variables characterizing the problem, $x=\frac{N_{A}}{N}$ and $t=\frac{l_{B}}{l_{A}}$.

Even for the simple system studied here, an interesting behavior of $D_{A B}$ and implicitly of the other quantities, em erged. Them ain nding of the present work is that by adjusting $x$ (the $m$ olecularm ass ratio) and t param eters we can control the process ofseparation ofdiblock copolym ers (or, $m$ ore generally, com bined objects) under hydrodynam ic ow. To ilhustrate this aspect we constructed separation curves by taking the di erence ( $\mathbb{A}_{\mathrm{A}}$ ) = $\mathrm{D}_{\mathrm{AB}}\left(\mathrm{x} ; \mathrm{t}_{1}\right)$ $D_{A B}\left(x ; t_{2}\right)$ and representing it as a function of $x$ and the pair $t_{1} t_{2}$, which allows us to identify both the absolute $m$ axim a and the ranges of $x$ that $m$ axim ize the di erence ( $\mathbb{D}_{A B}$ ) for given $t_{1}$ and $t_{2}$. A s an im miate extension of the present work, an application of our approach to the process of electrophoretic separation is in progress.
$T$ he form alism presented is applicable in $m$ ore general contexts not lim ited to $G$ aussian chains. For exam ple, when excluded-volum e or C oulom bic interactions are present we can capture their e ects| in certain conditions| by renorm alizing the $K$ uhn-lengths $l_{A}$ and $l_{B}$ to som ee ective values. A s an additionalobservation, the usualK irkw oodR isem an approxim ation is not necessary. But, rather surprisingly, our calculations have shown rigorously that one can still safely apply it.
