# G eneralized calculation of m agnetic coupling constants for M ott-H ubbard insulators: A pplication to ferrom agnetic C r com pounds

U sing a Rayleigh-Schrodinger perturbation expansion of multi-band Hubbard models, we present analytic expressions for the super-exchange coupling constants between magnetic transition metal ions of arbitrary separation in Mott-Hubbard insulators. The only restrictions are i) all ligand ions are closed shell anions and ii) all contributing interaction paths are of equal length. For short paths, our results essentially con m the Goodenough-K anamori-Anderson rules, yet in general there does not exist any simple rule to predict the sign of the magnetic coupling constants. The most favorable situation for ferrom agnetic coupling is found for ions with less than half lled d shells, the (relative) tendency to ferrom agnetic coupling increases with increasing path length. As an application, the magnetic interactions of the Cr com pounds Rb<sub>2</sub>CrCl<sub>4</sub>, CrCl<sub>2</sub>, CrBr<sub>3</sub> and CrI<sub>3</sub> are investigated, all of which except CrCl<sub>3</sub> are ferrom agnets.

#### I. IN TRODUCTION

The understanding of the magnetic properties of the nonm etallic 3d-transition m etal com pounds is not satisfying though they have been investigated intensively experimentally and theoretically. In particular there exists only a qualitative understanding of magnitude and sign of the magnetic coupling on the basis of the so-called G codenough-K anam ori-Anderson (GKA) rules. In this paper we present a more system atic way of calculating the magnetic coupling constants of these materials based on the concept of super-exchange. We also test ourm ethods by applying them to a sub-class of the rare class of ferrom agnetic 3d insulators, i.e. to C r com pounds, where the GKA rules apparently do not apply.

In nonmetallic, magnetic 3d-transition metal oxides and halides the spins are localized in the incompletely

led 3d shells of the transition m etal sites, hence-forw ard called m agnetic sites. This is a consequence of large correlation e ects. They are M ott-H ubbard insulators<sup>1</sup> and are thus described by a H ubbard-type m odel of the form

Here i is the energy of a dorbital at the magnetic site i and 1 that of an orbital at the ligand site 1.  $t_{\rm il}$  represents the hopping from the orbital  $_{\rm i}$  to 1,  $t_{110}$  that from 1 to  $0_{10}$ . (1) we neglect the Coulomb interaction at the ligand ions and between di erent sites. W e will also use the approxim a-= U and I =  $J_H$  . These restrictions tion U = U could be loosened but we do not expect qualitatively different results. W e note that the atom ic part of the H am iltonian (1) has been used very satisfactorily in ligand eld theory for, e.g. the interpretation of optical data of such com pounds.<sup>2</sup>

Anderson has introduced the concept of superexchange where the hopping of spins between the different sites leads to the coupling of the total spins  $S_1$ and  $S_2$  of the magnetic sites 1 and 2.<sup>3</sup> As is known from experimental results<sup>4,5</sup> the interaction is described very wellby the H eisenberg H am iltonian

The interpretation of the interaction due to kinetic exchange (di erent from C oulom b exchange) is re ected in the form ulation of the GKA rules.<sup>6</sup> In a simpli ed version they read

A) If the hopping of a spin from a singly occupied  $_1$  of the ion M  $_1$  to the singly occupied

orbital  $_2$  of the ion M  $_2$  is possible, the interaction between the spins in  $_1$  and  $_2$  is antiferrom agnetic.

B) W hen a spin can hop from the singly occupied orbital 1 to an unoccupied orbital of M 2, a ferrom agnetic contribution to the interaction results, which is weaker than the antiferrom agnetic one from rule A.

W ith the use of these rules the sign of the coupling constant can be predicted in many cases. Especially, the GKA rules explain why most of the non-metallic 3dtransition-metal compounds do not show a macroscopic magnetic moment. This is related to the fact that orbital ordering is usually needed for a ferrom agnetic interaction to occur. One prominent example are the CuF<sub>2</sub>-planes of K<sub>2</sub>CuF<sub>4</sub>, where the Jahn-Teller e ect causes orbital order, of alternating  $z^2 = y^2$  and  $z^2 = x^2$  hole orbitals, which completely suppresses the usually dominant antiferrom agnetic interaction.

However, in many cases the GKA rules are not helpful to decide which one of two competing interactions dominates. Such a case is  $Rb_2CrCl_4$ , where, again due to the Jahn-Teller e ect, an analogous orbital ordering as in  $K_2CuF_4$  occurs. Nevertheless, the nearest neighbor, singly occupied  $3x^2 r^2$  and  $3y^2 r^2$  orbitals exhibit a strong anti-ferrom agnetic coupling via p ligand orbitals, completely absent in the case of  $K_2CuF_4$ . The fact, therefore, that  $Rb_2CrCl_4$  is also a ferrom agnet, is by no means a simple consequence of the GKA rules. Similarly, there is no obvious GKA argument for the fact that the isostructural tri-halides CrBr<sub>3</sub> and CrI<sub>3</sub> are ferrom agnets.

In our paper we present a more detailed theory of super-exchange based on the Ham iltonian (1) which allows the calculation of both anti-ferrom agnetic and ferrom agnetic coupling constants for hopping paths via arbitrarily m any ligands.

We test our theory by applying it to the ferrom agnetic insulators mentioned above and show that a reasonable choice of parameters in (1) will lead to magnetic coupling constants which agree with experiment both in magnitude and sign.

In section II we use perturbation theory to determ ine the coupling constants for pairs of d-ions which are linked via an arbitrary number of ligand ions. First we present the interaction of spin $\frac{1}{2}$  pairs, where the spins are exchanged along a chain of ligands each possessing one unoccupied orbital. We investigate both the direct superexchange between two singly occupied d orbitals and the two indirect processes where spin-free (empty or doubly occupied) d orbitals at the magnetic sites are involved. We then generalize these results to the case of spin exchange via several paths of the same order – here we distinguish between equivalent and inequivalent paths. Finally we give an expression for the coupling of two d-ions with arbitrary (integral) occupation which are coupled via P di erent paths with N unoccupied ligands each. The application of these results to  $Rb_2CrCl_4$  and the Crtri-halides is discussed in section III.

Throughout the paper we will adopt the hole picture since the ligands usually are anions with a lied p shell.

## II. SUPER-EXCHANGE

In perturbation theory the coupling between the total spins  $S_1$  and  $S_2$  of two magnetic ions results from the exchange of the spins in the singly occupied orbitals. Since we do not consider spin-dependent interactions like spin-orbit coupling in (1), the spin Ham iltonian is isotropic and in the lowest order we get

Here,  $_1$  and  $_2$  denote the half-led orbitals at the sites 1 and 2. A ssum ing a strong H und interaction, the ground-state has maximum spin and the replacement

appears to be justiled. Eq. (3) can then be written as

We begin with the coupling of spin $\frac{1}{2}$  pairs. The generalization to pairs with larger total spins is possible with the help of Eq. (5).

W e distinguish three cases :

A: Direct interaction of two singly occupied orbitals  $_1$  and  $_2$  without the involvement of another dorbital. In general, the resulting coupling will be anti-ferrom agnetic, the coupling constant will therefore be called  $J^A_{1,2}$ .

FE: Indirect interaction of  $_1$  and  $_2$  via one ore more empty d'orbitals involving the H und interaction. The coupling constant is always negative and will be called  $J^{\rm FE}$ .

FD: Indirect coupling of  $_1$  and  $_2$  via one ore m ore doubly occupied d orbitals involving the H und interaction. The coupling constant is negative, in general, and will be called  $J_{_{12}}^{FD}$ .

#### A . super-exchange via one ligand

We rst consider the direct coupling of two equivalent magnetic ions 1,2 with singly occupied orbitals  $_1$ ,  $_2$  via one ligand with an empty hole orbital, see Fig. 1 a). Fourth order perturbation theory is the low est contributing order. There exist six possibilities of exchanging the

spins which dier in the sequence of spin exchange. In the following these sequences will be called channels. For each channel three intermediate states mexist. Two of them contain only singly occupied sites (one spin at the ligand and the other at one of the magnetic ions). In the third state the two spins occupy the same ion. The excitation energy of the singly occupied states is the charge transfer energy  $_{1}$  (  $_{2}$ ) when the magnetic ion 1 (2)  $_{\rm i}$  , when the ligis singly occupied. We have  $_{i} =$ and is empty, which is the usual case in the hole picture. Note, that when transform ing to the electron picture, the num erical value of , rem ains unchanged, but the orbital energies have to be renorm alized. If one of the m agnetic ions is doubly occupied, the excitation energy is U (1, 2), if it is the ligand we have , + <sub>2</sub>. The matrix elements between the states are the hopping integrals given by (1) and each channel yields the same factor  $(t_1)^2$   $(t_2)^2$ . Note that the energy denominators  $(E_0 E_m)^1$  are negative, but an additionalm inus sign occurs because of the exchange of the spins.

The total contribution of the six channels is

 $t^1$  represents the elective hopping from one to the other magnetic ion via the ligand.  $J^A$  is always non-negative and leads, because of the Pauli principle, to an antiparallel ordering of  $S_1$  and  $S_2$ .

For the indirect coupling of the spins at the m agnetic sites, an interm ediate state with a total spin larger than that of the ground state has to be generated at one of the m agnetic ions. Thus, there has to exist at least one spin-free orbital (empty or doubly occupied) at this ion, which is the case for m ost 3d ions except those in high spin  $d^5$ 

con guration. Then an inter-orbital on-site exchange can take place, leading to a negative coupling constant.

The interm ediate high spin state can occur in two ways. FE: If the spin-free orbital at the magnetic ion, where the direct exchange takes place, is empty, the spin from the half-led orbital of the other magnetic ion can hop into it. FD: If the spin-free orbital is doubly occupied, one of the spins can hop to the empty ligand, energetically preferred is the one anti-parallel to the ground state spin. B oth cases lead to a polarization of the ligand which is parallel to the spin of the magnetic ion in case FE and anti-parallel to it in the case FD. W e will begin with the investigation of FE.

W e assume a system of two magnetic ions M  $_1$  and M  $_2$  with only one singly occupied orbital and one empty orbital each. Also, the intermediate ligand is empty, see Fig.1 b).

There exist only two possibilities for exchanging the spins. For each, the spin from the half lled orbital of one magnetic ion has to migrate to the empty orbital of the other ion, where the on-site exchange of the spins takes place, leading to the preference of the ferrom agnetic state. Sim plifying  $_1 = _2 =$  and  $_1 = _2 =$  the coupling constant is given by

t  $_i$  (t  $_i)$  represents the hopping-integral from the orbital  $_i$  (  $_i)$  to the ligand. W e note that  $J^{\rm FE}\,$  is proportional to  $J_H$  .

 $J^{FE}$  contains two di erent hopping contributions, each of which is independent of the orbital of that site where the H und interaction takes place.  $J^{FE}$  is non-positive and leads to a parallel orientation of the spins  $S_1$  and  $S_2$ . This mechanism has been proposed by GKA to explain the occurrence of ferror agnetic coupling in non-m etallic

com pounds.<sup>6</sup> Yet, since  $FE_1 j = A_1$ , it is necessary that  $t_{1,2}^1$  of Eq.8 disappears or is very smallat least.

For case FD we consider a system of two equivalent magnetic ions M<sub>1</sub> and M<sub>2</sub> with one singly occupied orbital and one doubly occupied orbital each, see Fig.1 c). As above, the ligand is empty.

In contrast to case FE there are now 22 (= 2 11) channels, instead of two, all leading to a ferror agnetic coupling. The main di erence between the channels is whether the spin of or one of the spins of rst hops to the ligand. Putting  $_{i}$  = and  $_{i}$  =

 $J^{FD}$ <sup>1</sup> is non-positive and therefore leads to a parallelorientation of the spins. The expression is quadratic in the e ective hopping-integrals t and the factor FD<sub>1</sub> is positive (U; <sub>L</sub> > 0). The coupling constants  $J_{1,2;1}^{FD,1}$  are independent of the orbital of the H und interaction site. W e note that FD<sub>1</sub> > FE<sub>1</sub>. As a consequence, the ferrom agnetic interaction should be m ore favorable for cases of a doubly occupied d orbital than for those of empty ones. This has already been pointed out by Anderson.<sup>8</sup>

#### B. super-exchange via N ligands

In the follow ing we consider the interaction via N unoccupied ligands with one orbital each. W e will assume hopping only between nearest neighbors along the chain of N  $\,+\,2$  atom s and we investigate again the cases A , FE and FD .

Case A requires a perturbation expansion up to order 2(N + 1). There are  $\frac{2(N + 1)}{N + 1}$  possibilities (channels) to exchange the spins. To take account of all channels we use a simple m ethod to generate them. For this purpose each channel will be written as a sequence of num bers

which represents the order of the hopping. Here  $p_1$  stands for the hopping from M $_1$  to the rst ligand,  $p_2$  for the hopping from the rst to the second ligand,  $p_{N+1}$  for the hopping from the last ligand to M $_2$ ,  $p_{N+2}$  for the hopping back from M $_2$  to the N th ligand, see Fig. 2. The arrangement of the numbers in this sequence has to full 11 the restriction that the left as well as the right halfmust contain numbers of increasing m agnitude. In the case of an expression of sixth order the numbers 1 to 6 have to be distributed. Therefore a possible sequence is

First a spin from M<sub>1</sub> hops to the rst ligand (1) and from there to  $l_2$  (2). Then the spin from M<sub>2</sub> hops to  $l_2$ (3) such that the two spinsmeet at  $l_2$ . Next M<sub>2</sub> becomes singly occupied again (4). The last two processes are the hopping from  $l_2$  to  $l_1$  (5) and then back to M<sub>1</sub> (6). Not possible is the sequence

since the ligands are empty and thus the hopping from  $l_2$  to  $l_1$  cannot occur rst.

The structure of Eq.21 is the same as that of Eq.9 for ligand. Again,  $J^{A\,;N}$  is the product of a non-negative hopping-term and a positive energy factor  $A_N$ . Thus we have anti-ferrom agnetic coupling. C om paring  $A_N$  with  $A_1$  indicates that  $J^{A\,;N}$  is reduced as com pared to  $J^{A\,;1}$ , because  $t^N << t^1$ . For large N this is partly com pensated by  $A_N > A_1$ .

Case FE involving an empty M orbital, can be handled in the same way. Nevertheless the structure of the sequences is somewhat di erent since the H und interaction has to be taken into account. The sequences contain 2N + 3 numbers which are ordered as follows

The central number indicates when the H und interaction at a speci c magnetic ion (either M  $_1$  or M  $_2$ ), takes place, see Fig. 2. There is an additional restriction for the ordering of the p . Both the series  $p_1 ::: p_{N+1}$  and  $p_{N+3} ::: p_{2N+3}$  as well as the triple  $p_{N+1}$   $\dot{p}_{N+2}$   $\dot{p}_{N+3}$  have to contain numbers of increasing size. For this reason there is only one channel left. W hen two ligands are present this is

Then, the interaction constant is given by

 $J_{1}^{FE} \stackrel{N}{\underset{2}{\stackrel{1}{\atop}}_{1}}$  is non-positive and, because of  $FE_N = FE_1$ , it is much smaller than  $J_{1}^{FE} \stackrel{N}{\underset{2}{\stackrel{1}{\atop}}_{1}}$  for large N, since  $t^N << t^1$ . There is no compensation from an increasing number of channels.

Case FD: Here we nd a rapidly growing number of channels. In sixth order these are 142. For this reason we restrict our investigation to the case of equivalent  $(l_k = 8k)$  ligands in the chain.

The sequences introduced in Eq.22 can also be used here. Yet the restrictions are modiled. The series  $p_1:::p_{N\,\,+\,1}$  and  $p_{N\,\,+\,3}:::p_{2N\,\,+\,3}$  have to contain numbers of increasing magnitude, while the center triple  $p_{N\,\,+\,1}\,\dot{p}_{N\,\,+\,2}\,\dot{p}_{N\,\,+\,3}$  now contains numbers of descending size.

 $J^{\text{FD}\ ;N}$  is non-positive as is  $J^{\text{FD}\ ;1}$ . As it contains term s of order N $^2$  it will compensate the decreasing m agnitude of the hopping term s  $t^N$ , even m ore than for the case A.

The structure of FD $_{\rm N}\,$  can be made plausible by comparison with  $A_{\rm N}$ . The perturbation series that was needed to calculate  $J^{\rm A}\,$  has the order  $2{\rm N}\,$ +2, when N ligands are present, i.e. it contains products of  $2{\rm N}\,$ +2 factors. The corresponding ferrom agnetic interaction additionally includes the H und interaction in  $\,$ rst order. This factor can be introduced at  $2{\rm N}\,$ +1 positions into the product of  $(2{\rm N}\,$ +2) factors. In case of a U-channel in  $A_{\rm N}$ , i.e. when the spins meet at a magnetic ion, there is only one term of order U $^2$ , i.e. for  $p_{\rm N}\,_{+2}$  =  $2{\rm N}\,$ +1.. The other 2N cases lead to terms of order (U $\,$ ) $^1$ . Then there are N ligand channels, here each of the  $2{\rm N}\,$ +1

W e have restricted the discussion of the coupling via m ore than one ligand to the case of ligands of the sam e type, i.e. they are either all anions or all cations. The generalization to the case of m ixed-type paths rem ains work to be done.

## C. super-exchange via various paths

So far we have discussed the super-exchange via one path. But clearly several paths of the sam e order can exist along which the spins can be exchanged. A schem atic view of this situation is shown in Fig. 3.

W e distinguish between equivalent and non-equivalent paths. Paths p and p<sup>0</sup> are called equivalent when Q<sup>p</sup> =  $Q^{p^0}$  holds, with  $Q^p = A_N^p$ , FE $_N^p$  or FD $_N^p$ . The additional paths can arise by introducing further ligand orbitals or by adding further ligand atom s.

The interaction constant for a multi-path system is calculated by combining the contributions of the individual paths. The exchange takes place in two di erent ways. The rst one is the use of only one path, forth and back, as before. The second one is a ring exchange using two di erent paths forth and back.<sup>9</sup>

A gain we consider the direct coupling of two half led orbitals for the cases A, FE and FD. A ltogether we nd the following expressions

In all above cases the existence of several equivalent paths only leads to a new e ective hopping  $T^{P,N} = \prod_{p=1}^{P} t^{N,p}$ . In particular the sign of the coupling constant remains unchanged, though the e ective hopping T and thus the coupling m ay vanish when an appropriate set of parameters is chosen.

In case where the di erent paths are inequivalent this can lead to a ferrom agnetic coupling resulting from direct super-exchange as has been discussed in a previous paper.<sup>10</sup>

#### D .total interaction

The total interaction J of two magnetic ions with total spins  $S_1$  and  $S_2$  is obtained from Eq. (5) as the sum of the interaction of the half-lled orbitals

The factors N  $_{\rm i}$ , denoting the number of singly occupied orbitals at M  $_{\rm i}$ , result from the assumption of an orbital-independent on-site exchange.

W e will use equation (32) to calculate the coupling constants of two magnetic ions with arbitrary (integral) occupation which are coupled via unoccupied ligands in the fram e of a Hubbard-model. We note that we are restricted to the case that all contributing paths are of the sam e order.

### III.FERROM AGNETIC COM POUNDS

In this section we apply our theory to selected insulating ferrom agnets, i.e. to  $Rb_2CrCl_4$  and the Crtri-halides $CrCl_3$ ,  $CrBr_3$  and  $CrI_3$ . In none of these cases an obvious argument along the GKA rules can be found for the occurrence of ferrom agnetism.

### A.R $b_2$ CrC $l_4$

This compound is a quasi-two-dimensional ferrom agnet with a Curie temperature  $T_{\rm C}$  = 52.4 K  $^{11}$  Values of  $J_k$  = 1.04  $10^2\,$  eV and  $\frac{J_2}{J_k}$  = 3 10  $^4\,$  are reported.  $^{11}$  The moments lie in the CrCl2-planes and are almost parallel.  $^{11;12}$ 

The crystal structure is analogous to that of  $K_2 C u F_4$ . The parent structure is of K  $_2$ N  $\mathbb{F}_4$ -type, a body centered tetragonal lattice with a = b = 5:086 A and c = 15:72A.<sup>12</sup> The Cl ligands form an alm ost perfect octahedron around the  $Cr^{2+}$  ions; yet, because of the d<sup>4</sup> con guration, a strong Jahn-Teller distortion takes place in order to rem ove the degeneracy of the eq-orbitals, singly occupied in  $Cr^{2+}$ . The distortion leads to elongation of the ligand cage along the y and x axes, respectively, and correspondingly to contractions in the zx and zy planes, respectively.<sup>12</sup> The sam e distortions are found in  $K_2CuF_4$ .<sup>13</sup> Yet there is one important di erence. W hile for  $K_2CuF_4$  (d<sup>9</sup> con guration of  $Cu^{2+}$ ) with its occupied d holes of alternatingly z<sup>2</sup>  $x^2$  and  $z^2$   $y^2$  type, the GKA rules can be applied in an obvious manner (the hopping between those orbitals is identically zero by sym metry, and ferrom agnetism results), no such rules apply for the occupied  $e_g$ -orbitals of the  $C r^{2+}$  ions which are of  $3y^2$   $r^2$  and  $3x^2$   $r^2$  type, respectively. This orbital order has been established by neutron measurements.<sup>14</sup> Consequently, -type hopping is possible between neighboring orbitals. In addition, there exists -type hopping between the singly occupied  $t_{2g}$ -orbitals. All these hopping processes favor an anti-ferrom agnetic coupling. Nevertheless, the planar coupling is ferrom agnetic. We

note that  $K_2 C u F_4$  and  $R b_2 C r C l_4$  also show ferrom agnetic coupling along the c-direction.

In the hole picture for  $Cr^{2+}$ , one of the  $e_g$ -orbitals is doubly occupied. The other one is singly occupied (as are the  $t_{2g}$ -orbitals) and alternates due to the orbitalordering. When we dene the hole state by

The rst two terms represent  $J^A$ , where the rst one, containing the factor (pd )  $^4$ , represents the coupling due to the  $t_{2g}$  orbitals. When we assume the banonical' ratio pd =pd 0:4, the  $\xi_g$  orbitals contribute less than 1=3 to  $J^A$ . Note that any mixed terms (pd )  $^2$  (pd )  $^2$  etc. do not exist, since the  $e_g$  and  $t_{2g}$  orbitals are decoupled by symmetry. The third term represents  $J^F$ , which contains a factor  $J_H$  =U 0:1. Yet, on the other hand, the geometry of the -hopping provides a factor 3=2 (com pared to 1=8 in term 2). In addition, the large number of channels in FD  $_2$  leads to a reduction of the elective energy denominator by approximately a factor of 2.

As a consequence, a net ferrom agnetic coupling is obtained. This result is rather stable, when energy and hopping parameters are varied within reasonable limits. We note that this situation may change, when further octahedral distortions occur which mix the  $t_{2g}$  and  $e_g$ orbitals. Probably, there exists an easy axis single ion anisotropy, favoring spin alignments either along the y or the x axis. The ferrom agnetic nearest neighbor coupling will then produce the alm ost com plete alignment of spins.

For the related case of  $KCrF_3$ , with the same structure of Cr planes as in Rb<sub>2</sub>CrCl<sub>4</sub> suggesting the same orbital structure of the Cr ions, the puzzle of ferrom aqnetic intra-planar coupling has been studied previously by other researchers.<sup>15;16</sup> T hey have assum ed direct hopping between the magnetic sites and have suggested that  $\frac{1}{4}$  should occur, in contrast to the ndings values of in  $Rb_2CrCl_4$ , which yield =  $\frac{1}{6}$ .<sup>14</sup> N ote that the neglect of ligand orbitals strongly reduces the number of ferrom agnetic channels – there is only one left as FD  $_0$  = FE  $_0$ holds. The coupling  $J^A$ , which vanishes only for  $= \frac{1}{3}$ , is relatively large for  $= \frac{1}{6}$  and wins over FD<sub>0</sub>. A further, even m ore questionable consequence is the fact that, neglecting the ligands, the energy change due to the octahedraldistortion is of the same order as the magnetic interaction. W hen the ligands are included, the energy gain due to the Jahn-Teller distortion dom inates over any magnetic energies. An analogous d<sup>4</sup> system with planar ferrom agnetic coupling is LaM nO 3. A gain we think that simplied coupling estimates neglecting the ligands are not appropriate.17

An analysis of the inter-planar coupling has not been performed. On the one hand our formalism is not applicable to the situation with occupied and unoccupied ligands. On the other hand the number of spins is large (16 in the hole picture) such that a numerical calculation is very extensive. But we expect a similar behavior as in  $K_2CuF_4$ , where a reduction of  $J^A$  due to destructive interference with a possible sign change and a more or less unmodi ed  $J^F$  was obtained.<sup>10</sup> Furtherm ore, for  $Rb_2CrCl_4$  the spin-free orbital is doubly occupied and therefore the case FD holds, which always leads to larger ferrom agnetic coupling than the case FE.

The Crtri-halides with rhom bohedral sym metry (R3) contain two formula units per trigonal unit cell. The two Cratom s occupy equivalent positions, so do all six halide atoms. They form triple layers Ha-Cr-Ha which are stacked along the c-axis. In the central Cr layer, the Cratoms form a honeycomb lattice like a single layer of graphite. It is helpful to view this plane as a closed packed triangular arrangement of two Cr atoms (I and II) and of a vacancy V in the center of the honeycomb. Both the Cr atom s and the vacancy are surrounded by edge sharing octahedra of halide atom s. As a result, the two halide planes above and below are closed packed triangular layers with a stacking sequence A-B (see Fig. 4). The triple layers are now repeated along c in such a way that the vacancies V successively shift by  $\frac{1}{2}$  (a b + c), where a and b are the basal plane lattice vectors ( $a = b_{r}$ a  $b = \frac{1}{2}$ ) and c is the cax is vector of the corresponding hexagonal unit cell. The motion of V from positions A to B to C to A (see Figs. 4 and 5) leads to a packing of

the halide planes along c of the form A -(C r)-B -(em pty)-A-(Cr)-B-(empty)-A-(Cr)-B etc. As a consequence, the interlayer space B - (em pty)-A also consists of halide octahedra. O ne can de ne a perfect octahedral closed packed halide lattice by requiring that all octahedra are regular (rhom bohedral angle = 60). This would lead to the same separation of A and B planes whether or not a Cr layer is intercalated. It is clear how ever that the interplanar distances are quite di erent, see Tab. III. The lattice param eters of the Crtri-halides are given in Tab. II, som e relevant atom ic separations are listed in Tab. III. Note that for our calculations of magnetic coupling constants it was advantageous to start from an 'ideal' rhom bohedral lattice by assuming regular octahedra around the Cratom s. In the real lattice, there exists a compression of the octahedra enclosing the Crplane. As a result, the octahedra surrounding the empty layer are considerably elongated along the c direction. There are two further types of distortion allowed by the R 3 sym metry, which, however, appear to be of minor e ect.

1) The Crplanes buckle, i.e., the Cr(I) and Cr(II) atom s lie respectively above and below the plane, as de ned by the vacancy positions (deviation from 1=3 of the lattice parameter u, see Tab. II).

2) There are some m inor shifts in the halide positions (lattice parameters x deviating from 1/3 or 2/3 values and y deviating from zero). These shifts result partly from a relaxation of the octahedra around the vacancy V and partly from the Cr buckling. Note that a slight rotation of the V octahedra follow s, which should lead to optical activity along the c axis.

O fthe three com pounds, the lattice structure of C rB  $r_3$  has been investigated m ost extensively.<sup>18;19</sup> H ere, the internal lattice param eters x,y,z,u are known, while for C rI<sub>3</sub> these quantities have not been determ ined. For C rC  $l_3$ , M orosin and N arath report a low tem perature transition from an orthorhom bic to the R 3 near T = 225 K and give values for x,y,z,u.<sup>20</sup> T he di erence of the two structures are di erent stacking arrangem ents of the C r trihalide planes. To our know ledge, the C rC  $l_3$  structural phase transition has not been con rm ed by other groups. T here is evidence that C rC  $l_3$  rem ains orthorhom bic to low tem – perature into the anti-ferrom agnetic phase.<sup>21</sup>

All three com pounds exhibit strong intra-planar ferrom agnetic coupling. This feature is to be expected from the GKA rules, as the CrHa-Cr angle for the nearest neighbor (fourth order) super-exchange paths (leading to the coupling constant  $J_1$ ) is rather close to 90 - it is 94 for CrCl<sub>2</sub> and 93 for CrBr<sub>3</sub>.

The inter-planar coupling is anti-ferrom agnetic for C rC b, while it is ferrom agnetic for the other two materials. The critical temperatures are  $T_N^{C\,1} = 16.8$  K,  $T_C^{B\,r} = 32.5$  K and  $T_C^{I} = 68$  K.<sup>22</sup> N ote that an easy plane anisotropy is reported for C rC b, while easy axis anisotropies occur in C rB r<sub>3</sub> and C rI<sub>3</sub>.<sup>22</sup>

From analyses of magnetic susceptibility data intraplanar coupling constants  $J_k$  have been obtained. The

values reported in Ref. 4 are  $J_k^{\rm C\ l}$  = -4.1 meV ,  $J_k^{\rm B\ r}$  =

6:4 m eV and  $J_{r}^{I}$  = 10:5 m eV. On the other hand, Sam uelsen et al. have carried out neutron m easurem ents of spin wave dispersion curves for CrBr<sub>3</sub>.<sup>18</sup> They have been able to extract several near neighbor coupling constants, in particular for the inter-planar coupling. For the intra-planar coupling, they report  $J_1 =$ 7**:**6 m eV and  $J_3 = 0.13 \text{ meV}$  (next nearest neighbor, sixth order super-exchange). Note that  $jJ_k^{Br}j < jJ_1 + 2J_3j$ . Since the  $J_1$  value of Ref. 18 probably is the most reliable experim ental quantity available, we have used the relation  $J_1$  =  $1.2J_k^{B\ r}$  to scale  $J_k^{C\ 1}$  and  $J_k^{I}$  accordingly and have assumed  $J_1^{Cl} = 4:3 \text{ meV}$  and  $J_1^{I} = 12:4 \text{ meV}$ . Note that we use the de nition of J of Eq. 5, leading to a multiplication by a factor of nine of the values originally given by Refs. 4 and 18.

There exist three di erent inter-planar coupling constants of sixth order super-exchange, labeled  $J_2$ ,  $J_4$  and  $J_5$  by Sam uelsen et al.  $J_2$  is the vertical Cr(I)-Cr(II) coupling constant,  $J_4$  represents another I-II coupling, while  $J_5$  stands for I-I or II-II couplings (see Fig. 6). The values given by R ef.18 are  $J_2$  = 0.22 m eV,  $J_4$  = 0.06 m eV and  $J_5$  = 0.12 m eV.

In the follow ing we present results of calculations for the coupling constants  $J_1$ ,  $J_2$ ,  $J_4$  and  $J_5$  using the theory of Section II.W e have not included  $J_3$ , as we mainly focussed on the question of inter-planar coupling.

The electronic structure of the Cr ions depends on the ligand position. Because of alm ost perfect octahedra the three singly occupied states are alm ost  $t_{2g}$ -like and the two doubly occupied ones have mostly  $e_g$  character, as can be found from diagonalizing the d-states in the ligand ekd. Note that Cr<sup>3+</sup> is not a Jahn-Teller ion. The three empty p-states of the halides are treated as degenerate.

The intra-planar coupling of two nearest C r ions takes place via two ligand ions, see Fig. 5. From Eq. (32) the exchange interaction is given by

with the elective hoppings T  $_{1_{2}}^{1}$  and T  $^{1}$  and the energy factors A<sub>1</sub> and FD<sub>1</sub>, Tabs. V, VI. The elective hoppings are calculated corresponding to their de nition in Eq. (29). For the energy denom inators, we have neglected the energy di erence between e<sub>g</sub> and t<sub>2g</sub> like states.

The hopping parameters from Tab. IV are found by a tting process, where the charge-transfer energy was determ ined by adjusting  $J_1^{H\ a}$  to the experimental values as given above, while U and  $J_H$  were kept xed. We note that the order of magnitude and tendency of the  $_{H\ a}$  and the value for U agree with those given by Zaanen.<sup>1</sup> These values are also consistent with those found for Rb<sub>2</sub>C rC l<sub>4</sub>.

The calculation of the inter-planar coupling is very complicated. On the one hand up to six ligands with three orbitals each are involved in lowest order exchange. On the other hand there are three occupied ground state orbitals. For the calculation of  $J_2$ ,  $J_4$  and  $J_5$  we need the direct (here anti-ferrom agnetic) and the indirect (ferrom agnetic) coupling constant in sixth order. Each of these couplings is mediated via several paths. Nevertheless, because we have assumed that all ligand orbitals are equivalent, this only leads to the introduction of an elective coupling as was discussed above.

The vertical interplanar coupling  $J_2$  is mediated via six halide ions with three orbitals each. The halide ions form an (empty) octahedron elongated along the caxes, see Fig. 5. Three halide ions are ligands of the lower Cr ion and the other three those of the upper one. The couplings  $J_4$  (I-II) and  $J_5$  (I-I,II-II) are mediated via four halide ions where to each Cr belong two ligands, see Fig. 5.

For the coupling constants we get from equations (29) and (32)

Thus we have to determ ine the elective hopping integrals  $T_{1}^{2}$ ,  $T_{1}^{2}$ , and  $T_{1}^{2}$  and the energy factors  $A_{2}$  (H a) and FD<sub>2</sub> (H a) (independent of the path).

The term s T<sup>2</sup> depend on the individual C r-halide and halide-halide hopping integrals. In particular, the ratio (pp )= (pp ) of the halide-halide hopping integrals m ay modify the relative magnitudes of the J<sub>2</sub>, J<sub>4</sub> and J<sub>5</sub> couplings. The values for T<sup>2</sup> for the inter-planar couplings are shown in Tab. V and the resulting energy factors as well as the values of the J<sub>2</sub>, J<sub>4</sub>, J<sub>5</sub> coupling constants are given in Tab. V I. For C rB r<sub>3</sub> these numbers com pare well with the neutron data of R ef. 18, though the ratio J<sub>4</sub>=J<sub>5</sub> is not very good. Note that the Vertical' J<sub>2</sub> always is relatively large and anti-ferrom agnetic. In the case of C rB r<sub>3</sub> andn C rI<sub>3</sub>, this coupling is over-com pensated by the ferrom agnetic J<sub>4</sub> and J<sub>5</sub> couplings. This is also found for C rC l<sub>8</sub> unless the ratio j(pp )= (pp ) jw as shifted from the usual range of 3  $_{\overline{D}}$ 5 to an extrem ely large value of

 $_{i=2;4;5} z_i J_i > 0$ . If so, the inter-36, such that  $J_{c} =$ planar coupling is probably anti-ferrom agnetic for C rC ls with this set of parameters. (But note, that  $J_c$  can not be identied with the inter-planar coupling J<sub>2</sub> in a model with two couplings  $J_k$  and  $J_2$ .<sup>23</sup>) Nevertheless, we think that j(pp) = (pp) = 36 is outside the range of physically m eaningful param eters. Thus we suspect that there may indeed exist a di erence in the low tem perature structures of  $C \ rC \ b$  and the other two materials. We nally note that the dom inant magnetic coupling constant of these materials is the intra-planar  $J_1$  (4th order superexchange). A swe pointed out in Sec. II A, the FD -type coupling should cause a minority spin polarization on the halide ligands, as observed in the neutron study of spin density distributions in C rB r<sub>3</sub> by R adhakrishna and B row n  $^{19}$ 

## IV . C O N C LU S IO N

N onm etallic transition-m etal oxides and halides appear to be the most prom inent m embers of the fam ily of M ott-H ubbard insulators. In this paper we have generalized the expansion of extended H ubbard m odels by a R ayleigh-Schrodinger perturbation series into H eisenberg m odels, with the goal to determ ine general expressions for the super-exchange coupling constants. Each part of this series that corresponds to an exchange of the spins in the half-lled orbitals  $_1$  and  $_2$  of two m agnetic ions M  $_1$  and M  $_2$  gives a contribution to the (isotropic) coupling constant J =  $_{12}$  J  $_{12}$  of the H eisenberg H am iltonian

Here  $S_i$  denotes the total spin at the magnetic site M<sub>i</sub>. This form of the elective spin H am iltonian follows from the assumption of a relatively strong H und interaction at the magnetic sites such that  $S_i = \sum_{i=1}^{N} S_i$ .

The couplings J<sub>12</sub> are built from two di erent parts. E ither the exchange takes place involving only the d orbitals 1 and 2. This direct super-exchange' interaction is anti-ferrom agnetic (A) in general. Or 'indirect superexchange' occurs, which involves an additional, empty (E) or doubly occupied (D), d orbital. In this case, because of the Hund interaction, the coupling is negative in general. These general results correspond to the Goodenough-Kanam ori-Anderson (GKA) rules as stated in the introduction, yet quantitative results - and this m ay include the sign of the coupling constant - depend strongly on details of the involved exchange process. The simplest cases are those when only one specic path via ligands occurs. Then, each hopping integral enters quadratically the expressions for the coupling constants J. Therefore, the sign of J is given by kind of superexchange, direct (+) or indirect (). The magnitude of J depends on i) an elective energy denom inator  $E_0$ and ii) on an elective term t, such that  $J^Q = t^2 = E_Q$ . Here Q = A;FE;FD represents the dimensional possibilities of super-exchange and t =  $\binom{N+1}{k=1} t_k = N$ , where N denotes the num ber of ligands involved in the exchange and the  $t_k$  the corresponding hopping integrals. is a characteristic energy of an excited state with  $t_k =$ 1. Thus t decreases rapidly with increasing path length N . 1=E  $_{\rm Q}$  , which we also call Q  $_{\rm N}$  , is strongly in uenced by the num ber of exchange channels. This num ber depends on the specic super-exchange A, FE, or FD, each of which exhibits a di erent dependence on N . FE  $_{\rm N}$  is independent of N , there are always only two channels. A  $_{\rm N}$ is of the form  $A_N = 2$  (1=U + N = ) and FD  $_N$  includes in addition a term quadratic in N . For N = 1 one nds  $FE_1 < FD_1 < A_1$ , mainly because  $FE_N$  and  $FD_N$  contain an additional factor  $J_{H} = U \cdot W$  ith growing number of ligands we may nd cases  $A_N < FD_N$ . As a consequence, when N > 1, the interaction of ions with more than half-lled d-shells should exhibit a bigger tendency

towards ferrom agnetic coupling than those with less than half-led d-shells (hole picture, empty ligands).

The exchange can also take place via several (P) interfering paths. The structure of a coupling constant resulting from P paths with N ligands each is  $J^{\mathbb{Q}}(P) = \frac{1}{2} P_{pp^{0}=1}^{P} (\mathbb{Q}_{N}^{p} + \mathbb{Q}_{N}^{p^{0}}) t^{p} t^{p^{0}}$ . Here p and p<sup>0</sup> indicate the various paths. The energy denom inators  $\mathbb{Q}_{N}^{P}$  are the same e as in the case of P = 1, yet the hopping factors no longer enter quadratically into the expressions for the elective hopping integrals. In the presence of inequivalent paths  $(\mathbb{Q}_{N}^{p} \notin \mathbb{Q}_{N}^{p^{0}})$  this leads to the possibility of a ferrom agnetic coupling of two spins by direct super-exchange as was discussed in Ref. 10. When all P paths are equivalent, the  $J^{\mathbb{Q}}$  are again quadratic in the elective hopping, i.e. the sign is xed, but the magnitude may be strongly in uenced by interference. This behavior always occurs for case FE, since FE<sub>N</sub> is independent of N.

From the above considerations we see that even the sign of the coupling cannot be guessed except in the sim – plest cases, even if the orbital order at the magnetic sites is know n. For better quantitative estimates, a reasonable know ledge of hopping integrals, of charge transfer gaps and of U parameters is required. These num bers are accessible, in principle, via total energy calculations using constrained density functional theory, see e.g. Ref. 24. O ur present studies are based on such evaluations for  $La_2CuO_4$ .

In order to test the quality of our treatment, we have investigated som e ferrom agnetic Cr com pound insulators, where the GKA rules cannot be applied in any simple fashion. In  $Rb_2CrCl_4$ , with the same structure as  $K_2 C u F_4$ , orbital order of the  $C r^{2+}$  ions occurs because of the Jahn-Teller e ect. However, for the rst nearest neighbor (1NN) intra-planar coupling, the direct super-exchange  $J_A$  does not vanish, in contrast to the case of  $K_2 C u F_4$ . Nevertheless, we nd  $j J_{FD}^1 j > J_A^1$ , for various reasons as discussed above and in detail in chapter 3. A loo the quantitative result agrees well with experiment. Concerning the inter-planar coupling, we believe that  $Rb_2CrCl_4$  is rather sim ilar to  $K_2CuF_4$  which has been studied previously.<sup>10</sup> W e note that some of the N = 2 super-exchange paths involve both empty (C1) and doubly occupied (Rb<sup>+</sup>) ligands. Such cases, which m ay occur in ternary com pounds, are not covered by our present theoretical treatm ent.

The Cr<sup>3+</sup> ions of the Cr tri-halides Cr Cl<sub>3</sub>, CrBr<sub>3</sub> and CrI<sub>3</sub> are not Jahn-Teller ions and, thus, do not exhibit orbital ordering. The 1NN intra-planar coupling involves two equivalent N = 1 paths with Cr-Ha-Cr angles close to 90. The FD coupling dom inates the A coupling, both due to the 90 angles and, also because of the very m any FD channels. The inter-planar coupling takes place via three di erent N = 2 contributions, J<sub>2</sub>, J<sub>4</sub> and J<sub>5</sub>. Each of the couplings is mediated via a variety of paths. U sing reasonable hopping param eters we get good agreem ent with the values J<sub>2</sub>, J<sub>4</sub>, J<sub>5</sub> as measured by neutron scattering in the case of CrBr<sub>3</sub>. Further we obtain ferrorm agnetic coupling for both  $C\,rB\,r_3$  and  $C\,rI_3$ . In the case of  $C\,rC$  L we suspect that the low temperature structure is not R 3.

W e com e to the conclusion that the perturbational calculation of the coupling constants in the non-metallic 3d-transition-m etal com pounds is an appropriate instrument, qualitatively as well as quantitatively. The quantitative agreem ent m ay appear som ew hat surprising. It has been pointed out earlier that the higher order contributions of the perturbation series can have a similar m agnitude as the low est one.<sup>25</sup> Under such circum stances we would expect that the coupling between next nearest neighbors becom es im portant. Experim entally, how ever, ratios J<sub>2</sub>=J<sub>1</sub> 10<sup>2</sup> are reported.<sup>5</sup> An additional consequence should be that term s of the form  $(S_i, S)$   $(S_k, S)$ can not be neglected. W e are not aware of any experimentalevidence for the importance of such 4-spin terms. The question remains how the good agreem ent between experim ental value and the lowest order results can be understood.




FIG.1. Spin interaction by super-exchange via one empty ligand with one orbital. a) anti-ferrom agnetic case, b) and c) the ferrom agnetic cases. The double arrow represents the direct exchange  $J_H$  that leads to the second H und's rule. b) and c) are di er by the occupation of the spin-free orbital at the m agnetic ion. It is not possible to transform one into the other by a particle-hole transform ation.




FIG.2. a) D irect interaction on a linear chain between two half-led orbitals  $_1$  and  $_2$  at the sites M  $_1$  and M  $_2$  via N unoccupied ligands with one orbital each. Only nearest neighbor hopping is considered. b) Indirect interaction between two half-led orbitals  $_1$  and  $_2$  at the sites M  $_1$  and M  $_2$  involving one unoccupied orbital via N unoccupied ligands with one orbital each which build a linear chain. Only the hopping between nearest neighbors is allowed.




FIG .3. Super-exchange via three di erent paths with three ligands each.




FIG.4. Projection of a Crplane with the corresponding ligands on the ab-plane. The small circles denote the Cr-ions, the large ones the halides. The darker ligand ions lie below the Cr-plane the lighter ones above. The Crplanes are stacked such that the Cr hexagon center successively lies at points A, B and C.




FIG.5. Crystal structure of the tri-halides CrC  $_{\rm b}$ , CrB  $_{\rm f3}$  and CrI<sub>3</sub>. The hexagonal unit cell contains four Crplanes. Large circles denote the halide ions the sm aller circles the Cr atom s. Clusters corresponding to the couplings  $J_1$ ,  $J_2$  and  $J_4$ , see Fig.6, are indicated. Also shown are the position of a ligand octahedron and the corresponding local coordinate system of a Cr ion. The distances d, l and s are given in Tab. III.




FIG.6. Near neighbor coupling constants  $J_1$ ,  $J_2$ ,  $J_4$  and  $J_5$  in CrH  $a_3$ . There exist three couplings  $J_1$ , one  $J_2$ , three  $J_4$  and six  $J_5$  per Cr.
