G eneral solution of the three-site m aster equation and the discrete R iccati equation

Sum m ary: -W e rst obtain by analogy with the continuous (di erential) case the general solution of the discrete R iccati equation. M oreover, we establish the full equivalence between our discrete R iccati equation and a corresponding hom ogeneous second order discrete linear equation. Our results can be considered the discrete analog of M ielnik's construction in supersymmetric quantum mechanics [J.M ath. Phys. 25, 3387 (1984)]. W e present an application to the three-site master equation obtaining explicitly the general solutions for the simple cases of free random walk and the biased random walk.

We consider the continuous Riccati equation (CRE) $y^\circ = a(x)y^2 + b(x)y + c(x)$ with the known particular solution y_0 and let $y_1 = u + y_0$ be the second solution. By substituting y_1 in CRE one gets the Bernoulli equation $u^\circ = au^2 + (2ay_0 + b)u$. Furtherm ore, using v = 1=u, the simple rst-order linear di erential equation $v^\circ + (2ay_0 + b)v \frac{1}{R}a = 0$ is obtained, which can be solved by employing the integration factor $f = e^{2ay_0 + b}$, leading to the solution $v = e^{2ay_0 + b}$ (respectively), where C is an integration constant. Thus, the general solution of CRE is

$$y_{1} = y_{0} + \frac{e^{R_{x}} 2ay_{0} + b}{C R_{x}} y_{0} + \frac{f}{C R_{x}} (af)$$

For the usual nonrelativistic one-dimensional quantum mechanics b = 0 and a = 1, i.e., the integration factor is $f_{qm} = e^{2 x y_0}$. The particular solution y_0 is known as W itten's superpotential [1] in the context of supersymmetric quantum mechanics [2], while the general solution $y_1 = y_0 + \frac{f_{qm}}{c + \frac{f_{qm}}{f_{qm}}}$ may be called M ielnik's superpotential [3]. M oreover, $f_{qm}^{1=2}$ is the ground state wavefunction, $2y_0^{\circ}$ ($\frac{2d^2}{c + \frac{f_{qm}}{f_{qm}}}$) is the D arboux transform part of the Schrödinger potential and $\frac{f_{qm}^{1=2}}{c + \frac{f_{qm}}{f_{qm}}}$ is the ground state wavefunction $2y_0^{\circ}$ ($2y_0^{\circ}$ (and $2y_0^{\circ}$ can be thought of as the general D arboux transform part in the potential. All these relationships make up the core of the \entanglem ent" between R iccati and Schrödinger equations, which has been recently emphasized by H aley [4].

Consider now the discrete R iccatiequation (DRE) $y_{n+1} = a_n y_{n+1} y_n + b_n y_n + c_n$, with known solution y_n^0 . As in the case of CRE, the general solution is chosen of the form $y_n^1 = y_n^0 + u_n$. The discrete equation for the function u_n (discrete B emoulli

equation) will be

$$u_{n+1} = \frac{a_n}{1 - a_n y_n^0} u_{n+1} u_n + \frac{b_n + a_n y_{n+1}^0}{1 - a_n y_n^0} u_n :$$

W e now take $v_n = 1 = u_n$ to get

$$v_{n+1} = \frac{1}{b_n + a_n y_{n+1}^0} v_n = \frac{a_n}{b_n + a_n y_{n+1}^0} = g_n v_n + h_n ;$$

whose solution reads

where D is a positive constant. Thus, the general DRE solution can be written down as follows

$$y_{n}^{1} = y_{n}^{0} + \frac{\sum_{k=0}^{n-1} \left(\frac{b_{k} + a_{k} y_{k+1}^{0}}{1 - a_{k} y_{k}^{0}} \right)}{D \sum_{k=0}^{p-1} \left(\frac{b_{k} + a_{k} y_{k}^{0}}{1 - a_{k} y_{k}^{0}} - \frac{a_{k}}{1 - a_{j} y_{j}^{0}} - \frac{a_{k}}{b_{k} + a_{k} y_{k+1}^{0}} \right)}$$

One can remark the form alanalogy between the CRE and DRE general solutions. Indeed, $f_p = {\begin{array}{c} Q \\ l=0 \end{array}} {\begin{array}{c} p \\ l=0 \end{array}} {\begin{array}{c} b_{l+} a_{1} y_{l+}^{0} \\ 1 \\ a_{1} y_{l}^{0} \end{array}}$ can be thought of as a discrete \integration" factor (D IF), and thus Eq. (5a) can be written in the form

$$y_n^1 = y_n^0 + \frac{f_{n-1}}{D} \frac{p_{n-1} f_{k,a_k}}{k = 0 \frac{f_{k-1}}{b_k + a_k y_{k+1}^0}};$$

from which the analogy (and di erence) with respect to the continuous case is transparent.

We now want to establish a form alequivalence between the DRE and the hom ogeneous second-order discrete equation (H SODE), more exactly, between $y_{n+1} =$ $a_n y_{n+1} y_n + b_n y_n + c_n$ and $c_n^0 x_{n+2} + b_n^0 x_{n+1} + a_n x_n = 0$. In the DRE let $y_n = \frac{x_n}{x_{n+1}} + d_n$. A fler som e easy algebra and with the crucial

choice $d_{n+1} = b_n = a_n$ one gets

$$(c_n + \frac{b_n}{a_n})x_{n+2} \qquad (1 + a_n \frac{b_{n-1}}{a_{n-1}})x_{n+1} + a_n x_n = 0 :$$

T hus, the identi cations are $b_n^0 = 1 = \frac{a_n b_n - 1}{a_n - 1}$ and $c_n^0 = c_n + \frac{b_n}{a_n}$. Vice versa, let us start with the H SO D E and introduce $y_n = x_n = x_{n+1} + (b_n^{\circ} + 1) = a_n$. A gain, after quite simple algebra, one gets the DRE with the following identications $b_n = a_n (1 + a_n)$ b_{n+1}°)= a_{n+1} and $c_n = c_n^{\circ} + (1 + b_{n+1}^{\circ})=a_{n+1}$. These are the inverse identi cations of the rst ones.

O ne m ay foresee m any physical applications of the above m athem atical procedure. Here, we present only one application, namely to write down the general solution of the Herm itian three-site m aster equation written as in [5] and [6]

$$(g_{n+1}r_{n+2})^{1=2}x_{n+2} + (g_{n+1} + r_{n+1})x_{n+1} \qquad (g_nr_{n+1})^{1=2}x_n = 0;$$

where g_n is the transition rate for the jump n ! n + 1 and r_n is the one for the backward jump n ! n 1, while x_n can be thought of as the square root of the site probability. The known stationary solution is [7]

$$\mathbf{x}_{n}^{0} = \mathbf{A} \left(\begin{array}{c} \mathbf{Y}^{n} & \frac{\mathbf{g}_{j \ 1}}{\mathbf{r}_{j}} \\ \mathbf{g}_{j \ 0} & \mathbf{r}_{j} \end{array} \right);$$

where A is a scaling constant, that through the norm alization condition can be xed $\frac{1}{2}$

to be A = $1 + \frac{P_N Q_n}{n=1} \frac{g_{j-1}}{j=1} \frac{g_{j-1}}{r_j}$ (see [8]). The transformation

$$y_n = \frac{x_n}{x_{n+1}} - \frac{1 + g_{n+1} + r_{n+1}}{(g_n r_{n+1})^{1-2}}$$

applied to Eq. (7) leads to the following master Riccati equation

$$y_{n+1} = (g_{h}r_{n+1})^{1=2}y_{n+1}y_{n} \qquad \frac{g_{n}r_{n+1}}{g_{n+1}r_{n+2}} \qquad (1+g_{n+2}+r_{n+2})y_{n} \qquad (g_{i+1}r_{n+2})^{1=2} \qquad \frac{1+g_{n+2}+r_{n+2}}{(g_{n+1}r_{n+2})^{1=2}};$$

with the particular solution

$$y_n^0 = \frac{1 + g_{n+1}}{(g_n r_{n+1})^{1-2}} :$$

However, one can write the general solution corresponding to Eqs. (5a,b), where y_n^0 is substituted by Eq. (11) and $a_k = a_k^M$ $(gr_{k+1})^{1=2}$ and $b_k = b_k^M$

 $\frac{g_k r_{k+1}}{g_{k+1} r_{k+2}}$ (1 + g_{k+2} + r_{k+2}), where the superscript M stands for master. By

introducing the master D ${\rm I\!F}$

$$f_{p}^{M} = \frac{Y^{p}}{\sum_{l=0}^{l}} \frac{b_{l}^{M} + a_{l}^{M} y_{l+1}^{0}}{1 - a_{l}^{M} y_{l}^{0}}; \qquad (12)$$

one can write a compact form of the generalmaster Riccati solution

$$y_{n}^{1} = y_{n}^{0} + \frac{f_{n-1}^{M}}{D} \frac{P_{n-1}}{k=0} \frac{f_{k}^{M} a_{k}^{M}}{b_{k}^{M} + a_{k}^{M} y_{k+1}^{0}} = \frac{1 + g_{n+1}}{(g_{n} r_{n+1})^{1=2}} + \frac{\frac{(g_{0} r_{1})^{1=2}}{g_{n} r_{n+1}} (\frac{x_{1}^{0}}{x_{n+1}^{0}})^{2}}{D} \frac{P_{n-1}}{s=0} \frac{(g_{0} r_{1})^{1=2}}{(r_{s+2} (\frac{x_{1}^{0}}{x_{s+2}^{0}})^{2}} ;$$

where D is a constant. M oreover, using simple discrete algebra, one can obtain the following new general solution of the master equation

$$\mathbf{x}_{n}^{1} = \mathbf{x}_{n}^{0} \prod_{j=0}^{\mathbf{Y} \ 1} \mathbf{1} + \frac{\frac{(g_{0} r_{1})^{1-2}}{r_{j+1}} (\frac{\mathbf{x}_{1}^{0}}{\mathbf{x}_{j+1}^{0}})^{2}}{D \prod_{s=0}^{\mathbf{P} \ 1} \frac{(g_{0} r_{1})^{1-2}}{r_{s+2}} (\frac{\mathbf{x}_{1}^{0}}{\mathbf{x}_{s+2}^{0}})^{2}} ;$$

where x_p^0 is the known product solution Eq. (8) having p factors.

Let us see now the particular case $g_n = c_1$, $r_n = c_2$, where c_1 and c_2 are two real numbers 2 (0;1), such that $c_1 = q$, i.e., $q = \frac{c_1}{c_2} = 1$. Then, the known stationary master solution is $x_n^0 = Aq^{\frac{n+1}{2}}$, the particular R iccati solution is $y_n^0 = -\frac{1+c_1}{(c_1c_2)^{1-2}}$, whereas the general R iccati solution reads

$$y_{n}^{1} = \frac{1+c_{1}}{(c_{1}c_{2})^{1=2}} + \frac{q^{n}}{D q^{1=2} P_{n}^{n} q^{k}} :$$

At this point, we treat separately the two subcases as follows.

(i) For $c_1 = c_2 = \frac{1}{2}$ (free random walk), the particular solution is $y_n^0 = -3$ and the general solution is

$$y_n^1 = 3 + \frac{1}{D n}$$
: (16)

(ii) For $c_1 \notin c_2$ (biased random walk), say, $c_1 = \frac{1}{2}(1)$ and $q = \frac{1}{2}(1 + 1)$ so that $q = \frac{1}{1+1}$, the particular solution is $y_n^0 = -\frac{3}{(1-2)^{1-2}}$ and the general one is the following

$$y_{n}^{1} = \frac{3}{(1-2)^{1-2}} + \frac{q^{n}}{D-q^{1-2}\frac{1-q^{n}}{1-q^{-1}}} = \frac{3}{(1-2)^{1-2}} + \frac{(\frac{1}{1-2})^{n}}{D+\frac{(1-2)^{1-2}}{2}[1-\frac{1}{2}]} :$$
(17)

For ! 0 this solution goes into the above one for the free random walk.

Passing to the master equation one can get in the two subcases the following solutions:

(i) $x_n^0 = A$ and $x_n^1 = A(1 \frac{n}{D+1})$. For the positivity of the solution one should take D > n - 1. One can see that for D - n, at large $n, \frac{1}{4}$ is nought. However, for D = n, where > 1, again at large $n, x_n^1 = A(1 - \frac{1}{2})$ is substantially different from x_n^0 . Finally, for 1 one gets the particular solution.

(ii)
$$x_n^0 = A\left(\frac{c_1}{c_2}\right)^{\frac{n+1}{2}}$$
 and after reabsorbing som e constants one gets $x_n^1 = x_n^0$ $\frac{D \left(\frac{1}{c_2}\right)^{n+1}}{D \left(\frac{1}{c_1}\right)^{\frac{c_2}{c_1}}}$

Inspection of the latter formula shows that for positivity one should take D > $\frac{(1+p)^{n+1}-1}{p}$, where $p = \frac{2}{1}$, which is close to D > n + 1 resulting from the rst order approximation.

In sum m ary, we derived the explicit form of the general solution of the three-site m aster equation based on the corresponding discrete R iccatigeneral solution. In the continuous case it corresponds to M ielnik's procedure in supersymmetric quantum m echanics. Since the steady state solution is always a particular solution, what we have obtained here are either transient solutions [9] or solutions determ ined by some nonequilibrium boundary conditions xing the value of the constant D.
