# No spin di usion in the spin $1/2 \times X \times Z$ chain at T = 1: Num erical asymptotics

#### Abstract

We analyze the recent num erical computations made by Fabricius, Low and Stolze to show that the long time behavior of the zz correlation function of the spin 1/2 X X Z chain at T = 1 is very well t by the form ula t <sup>d</sup>  $[A + Be^{(t t_0)} \cos (t t_0)]$  where d is substantially greater than 1/2. This con m s the conclusion that there is no spin di usion in this model.

### 1. Introduction

The spin 1/2 X X Z chain of N site with periodic boundary conditions specified by the Hamiltonian

where  $_{i}^{j}$  is the y = x; y; z Pauli spin matrix at site i is well known to be an integrable system. As such it is to be expected that all the spin correlation functions should be analytically computable. In the past decade there has been much work done to full lithis prom ise but much still remains to be done. In particular there has been no published work done on the time dependent autocorrelation function at in nite temperature

other than the old result [1] that at = 0

where  $J_0$  (2t) is the Bessel function of order zero.

On the other hand this in nite temperature correlation function is of great interest because of its relation to the theory of spin di usion [2]-[4] which says that in the lim it t ! 1 if spin di usion is present in the system then the asymptotic behavior of S (t; ) should be

In the absence of exact results this asym ptotic behavior has been studied by num erical m ethods for wellover 20 years [5]-[9]. By far the m ost accurate of these num erical studies is the recent work of Fabricius, Low, and Stolze [9] who have published a beautiful high precision study of the time dependent two spin correlation functions at various tem peratures

of the spin  $1/2 \times X \times Z$  antiferrom agnet obtained by extrapolating to the therm odynamic limit a nite size exact diagonalization study of systems of size up to N = 16. From this study the authors were able to give precise estimates of S (t; ) for = 1;cos(3) for the time interval0 t 4:95 and they concluded that no evidence of the asymptotic behavior (1.4) could be seen. This supports the conjecture made by the present author [10] and by others [11] that the integrability of the X X Z chain forbids the spin di usion asymptotic behavior (1.4) and agrees with the absence of di usion at low temperature found by Narozhny [12] for 1 1:

However, in [9] there is no positive statem ent given as to what the true asymptotic behavior of their data might be. Here we show that the num erical results of [9] can be beautifully twith the form

which was rst suggested in [6] with d = 1=2:

To test the validity of the form (1.5) we have computed

$$g(t;d;A) = t^{a}S(t; ) A;$$

where S(t; ) is given by the num erical values of [9] which were generously sent to us in electronic form, and compared the result with




Fig. 1 C om parison of the num erical data of [9] for = 1 with the form (1.5) with d = :698; A = :245; B = :0581; = :7; = 4:36 (t = 1:90: The points are the function g(t;;d;A) (1.6) obtained from the data of [9]. The continuous curve is h(t;B; ; ;t\_0) of (1.7) with B = :0581; = :70; = 4:36; t\_0 = 1:90:




Fig. 2 Comparison of the numerical data of [9] for  $= \cos(3)$  with the form (1.5) with d = :838; A = :210; B = :114; = :354; = 4:06; t<sub>0</sub> = 1:96: The points are the function g(t;;d;A) (1.6) obtained from the data of [9]. The continuous curve is h(t;B; ; ;t<sub>0</sub>) of (1.7) with B = :114; = :354; = 4:06; t<sub>0</sub> = 1:96:

The best results of these comparisons are given graphically in Figs.1 and 2 for = 1 and  $\cos(3)$ : From these comparisons we conclude that for 2.2 t 4:95 the equality

holds to a very high degree of precision where

These results are to be compared with the exact asymptotics of = 0 obtained from (1.3) as

In an attempt to provide some estimate of error in the thing parameters we plot in Fig. 4 a tofthe case =  $\cos(3)$  obtained with

From comparing the ts of Fig. 2 and 4 we conclude that the estimates of and  $t_0$  are very stable while the exponent d varied by :045: How ever because the twhich better ts the points with larger t gives the larger value of twe feel that the conclusion that for t! 1 the exponent d for = cos(3) is de nitely greater the value it has for = 1 is certainly justified.

## 2. D iscussion

The exponent d in (1.9)-(1.12) is always substantially greater that 1/2. Thus, if f (t;d;A;B; ;;t<sub>0</sub>) of (1.5) does indeed represent the true asymptotic behavior of S (t; ) then the spin di usion form (1.4) is de nitely eliminated. This is in agreement with [9] and is the basis for the claim in the title of this paper. However, it must always be kept in m ind that no study for a nite time interval can de nitively claim to have seen the true t ! 1 behavior of a function. This obvious general statement is of particular in portance here because num erical studies on the (nonintegrable) classical (S = 1) Heisenberg m agnet [13]-[16] show that while a form like (1.5) held for times up to the order of 50 with an exponent d de nitely greater than 1/2 that when times up to 100 were considered the exponent d eventually became the spin di usion value d = 1=2: The belieferm bodied in the conjecture of the absence of spin di usion for an integrable m odel is that there will never be a scale at which the spin di usion form (1.4) sets in. W e further

conjecture for the (nonintegrable) XXZ chains of arbitrary spin S 1 that for suitable small times the form (1.5) will be an excellent approximation to the autocorrelation function but that there will exist some time scale such that for times larger than this scale spin di usion will set in. This scale should increase as the spin S decreases and become in nite for the integrable case of S = 1=2: A similar remark holds for the addition of further nearest neighbor interactions to the XXZ chain which also destroy the integrability.

We conclude by remarking that since the data of [9] for T = 1 is so very well t by (1.5) a similar simple thing function must exist for nite T: In addition further numerical study should be able to determ ine the parameters in (1.5) as functions of in the entire range 0 1: As a guide to such a study we suggest that the parameter d() of (1.5) is a monotonic nonincreasing function of and that  $\lim_{n \to \infty} \frac{1}{n} d(n) = 1=2$ :




Fig. 3 C om parison of the exact result (1.3) for = 0 with the form (1.5) with d = 1.0;  $A = B = \frac{1}{2} = :159$ ; = 0;  $= 4:0; \pm \frac{5}{8} = 1:963$ : The points are the function g(t;;d;A) (1.6) obtained from (1.3). The continuous curve is h(t;B; ;;t\_0) of (1.7) with  $B = \frac{1}{2} = :159$ ;  $= 0:0; = 4:0; \pm \frac{5}{8} = 1:963$ :




Fig. 4 Comparison of the numerical data of [9] for  $= \cos(3)$  with the form (1.5) with d = :784; A = :196; B = :104; = :342; = 4:06; t<sub>0</sub> = 1:96: The points are the function g(t;;d;A) (1.6) obtained from the data of [9]. The continuous curve is h(t;B; ; ;t<sub>0</sub>) of (1.7) with B = :104; = :342; = 4:06; t<sub>0</sub> = 1:96:
