# Wilson renormalization of a reaction (di usion process

#### A bstract

Healthy and sick individuals (A and B particles) di use independently with di usion constants D  $_{\rm A}$  and D  $_{\rm B}$  . Sick individuals upon encounter infect healthy ones (at rate k), but m ay also spontaneously recover (at rate 1= ). The propagation of the epidem ic therefore couples to the uctuations in the total population density. G lobal extinction occurs below a critical value  $_{\rm c}$  of the spatially averaged total density. The epidem ic evolves as the diusion {reaction {decay process A + B ! 2B; B! A, for which we write down the eld theory. The stationary state properties of this theory when  $D_A = D_B$  were obtained by K ree et al. The critical behavior for  $D_A < D_B$  is governed by a new xed point. We calculate the critical exponents of the stationary state in an " expansion, carried out by W ilson renorm alization, below the critical dimension  $d_c = 4$ . We then go on to to obtain the critical initial time behavior at the extinction threshold, both for  $D_A = D_B$  and  $D_A < D_B$ . There is nonuniversal dependence on the initial particle distribution. The case  $D_A > D_B$  remains unsolved.

# 1 Introduction and phenom enological analysis

#### 1.1 Introduction

W e study the propagation of an epidem ic in a population of uctuating density, with parameters set such that the epidem ic is close to becoming extinct. The model is as follows. Healthy and sick individuals, also called A and B particles, di use freely and independently on a lattice of dimension d. Their di usion constants D<sub>A</sub> and D<sub>B</sub> are in general unequal. Sick individuals upon encounter infect healthy ones (at a rate k), but m ay also spontaneously recover (at a rate 1= ). The epidem ic therefore tends to propagate in regions of high total population density and to become locally extinct in regions of low density. Below a critical density  $_{\rm C}$  global extinction occurs, and an important question is how the epidem ic evolves near this threshold, which is analogous to a phase transition point in equilibrium critical phenom ena. The role of the order parameter is played by the B particle density  $_{\rm B}$ . In particular, at threshold strong local uctuations are expected, with a potentially decisive in pact on the global critical behavior.

The evolution of the epidem ic may be formulated as the competition between a reaction and a decay process of two di using chem ical species,

in which A and B stand for a healthy and a sick individual, respectively.

Let m<sub>i</sub> and n<sub>i</sub> be the number of A and B particles, respectively, that occupy site i. We write m = fm<sub>i</sub>g and n = fn<sub>i</sub>g for the two sets of occupation numbers and denote by P (m;n;t) the probability that at time t the system is characterized by exactly these sets. The rules of the process formulated above then de ne a master equation for the time evolution of P (m;n;t) with fully speci ed transition rates. The problem depends on the parameters  $D_A; D_B; k; l=$ , and . A fter scaling one may set k = 1.

This problem is but one instance of a large class of such processes that all have the following common features. They are initially formulated in terms of a master equation which is hard, if not impossible, to solve. The traditional approach is to write down rate equations for the space and time dependent densities of the various species. This leads to num erous interesting systems of partial di erential equations (reaction {di usion equations) that continue to be subjects of investigation.

The assumptions that lead to such reaction {di usion equations can be justi ed only in su ciently high spatial dimension d. The reason is that these equations constitute a mean eld description: the reaction terms involve the products of the average densities, rather than the average of the product of the uctuating densities.

The general problem of statistical mechanics is therefore to determ ine the critical dimension  $d = d_c$  below which the mean-eld approach becomes qualitatively incorrect, and to describe the modi cations that then appear. Recent progress on such problem s is due to the application of the renorm alization group (RG) to the form al solution of the master equation, rew ritten as a path integral and cast in the form of a eld theory. This will also be our procedure. It allows one, in an expansion in the small parameter  $d_c = d = "$ , to study the scale invariant regimes of the problem and determ ine the associated exponents.

For the particular process of Eq. (1.1) the upper critical dimension appears to be  $d_c = 4$ . Questions of interest are not of all about the properties of the stationary state and secondly about how the system, prepared in a specified initial state, relaxes towards stationarity. Of particular interest is the initial state with the A and B particles distributed random ly with densities  ${}^0_A$  and  ${}^0_B$ . In that case, and in the limit of an in nite lattice, the m<sub>i</sub> and n<sub>i</sub> are independent Poissonian random variables with averages  ${}^0_A$  and  ${}^0_B$ , respectively.

We now relate our work to existing literature. We shall arrive at a eld theory described by an action S (see Eq. (1.16)) in which

is a key parameter. The stationary state of a special case { viz. with  $D_A = D_B$  { was studied recently by K ree, Schaub, and Schmittm ann [1]. These authors' physical interpretation is di erent: They start from a pair of Langevin equations postulated for the evolution of a population density in a polluted environment. The interest of both this work and of R ef. [1] lies in the coupling between the uctuations of the total density and those of the density of the species that is trying to survive (in our case the B particles). If the uctuations in the total density are suppressed, the full action S becomes independent of and reduces to an action S  $_{DP}$  known to represent both the problem of directed percolation and the Schlogl reaction. S  $_{DP}$  has rst appeared in particle physics as R eggeon eld theory.

This work goes beyond the existing results in the following ways.

(i) The ratio appears to be relevant in the sense of the RG.For < 0 the critical behavior is governed by a new xed point. We determ ine the new exponents to leading order in " = 4 d. For > 0 the RG equations do not have a xed point and we speculate about the interpretation of this fact.

(ii) We consider relaxation to the stationary state at the critical density  $= {}_{c}$ , rst for the action  $S_{DP}$  of directed percolation and then for the full action S both with = 0 and < 0. For asym ptotically long times the order parameter  ${}_{B}$  (t) relaxes towards zero as a power law of time whose exponent is a simple combination (= z in the usual notation) of the stationary state exponents. There is, however, an initial time regime { which in the lim it  ${}_{B}^{0}$  # 0 becomes arbitrarily long { where the order parameter increases as t ${}^{\circ}$ , where  ${}^{0}$  is a new and independent critical initial slip exponent. We

calculate this exponent for an initial state in which the m<sub>i</sub> and n<sub>i</sub> are independent but not necessarily Poissonian random variables. We show that <sup>0</sup> is nonuniversal, as it depends continuously on the width of the distribution. The concept of critical initial slip was introduced by Janssen, Schaub, and Schm ittm ann [2] (see also Janssen [3]) and it is here for the rst time, to our know ledge, that such an exponent is calculated for a reaction {di usion system.

(iii) F inally, we innovate with respect to the existing literature by not following the usual eld-theoretic methods. Instead, we perform a W ilson renorm alization, that is, we successively integrate out shells of large momentum. We employ the dynamical version of W ilson's method developed by H ohenberg and H alperin [4]. This method does not require any advanced know ledge of eld theory. In the course of our work we check that in known special cases earlier results are reproduced.

#### 1.2 M ean-eld theory

The mean eld equations for the densities  $_{\rm A}$  and  $_{\rm B}$  are

By summing them one sees that the total density =  $_{A} + _{B}$  is conserved. The spatially homogeneous solutions of these equations are easily found. The total density appears to have a threshold value =  $_{C}^{mf} = (k)^{1}$  below which the stationary state consists of only A particles. Above this threshold density the all-A state is still stationary but unstable, and the stable stationary state has a nonzero density of B particles. Explicitly, Eq. (1.3) leads to

then one sees that mean eld theory gives = 1. The relaxation to the stationary state at criticality from a hom ogeneous initial state with B -particle density  $\frac{0}{B}$  is easily derived from Eq. (1.3),

Here <sup>0</sup> is the critical initial slip exponent introduced by Janssen et al. [2, 3]. Eq. (1.6) shows that the mean eld values are z = 1 and <sup>0</sup> = 0. In the following sections, after showing that the reaction (di usion process of Eq. (1.1) has upper critical dimension  $d_c = 4$ , we will compute corrections to the mean eld values of these and other exponents to rst order in " = 4 d.

## 1.3 The master equation solved in terms of a path integral

In order to go beyond mean eld theory, one has to start from the master equation de ned in plicitly in subsection 1.1. It is convenient to introduce an orthonorm al basis of states jn ;ni and work in the H ilbert space generated by this basis. The probability distribution P (m;n;t) is then associated with the state

For an appropriately constructed time evolution operator  $\hat{H}$  the master equation for P (m;n;t) is equivalent to the imaginary time Schrödinger equation

all properties of the reaction {di usion system m ay be derived. Eq. (1.1) determ ines in particular in the lim it t ! 1 the stationary state. The combined e orts of m any workers, e.g. [5, 6, 7], have led to m ethods of converting the form al solution of type (1.11) into expressions that can be analyzed. W e shall use here one such m ethod, which has now become common. The rst step is to express  $\hat{H}$  in terms of creation and annihilation operators for the two particle species:  $a_i^y$  and  $a_i$  for the A particles, and  $b_i^y$  and  $b_i$  for the B particles. These operators can be de ned such that they have boson commutation relations. Next, the exponential in (1.11) is subjected to time slicing with the aid of a coherent state representation of the harm onic oscillator operators. As a result, and in the lim it where the site index becomes a continuous space vector x, there appear space and time dependent classical ekls a (x;t); a(x;t) and b(x;t); b(x;t) that are directly associated with the two particle types. The solution (1.11) nally takes the form of a path integral on these ekls, weighted with the exponential of an action S:

The exact way in which such physical quantities as local densities, correlation and response functions can be obtained from the elds is detailed in [7].

1.4 Action and scaling dim ensionalities

Here  ${}^{0}_{A}$  and  ${}^{0}_{B}$  are the initial A and B particle densities, and Poissonian distribution of the initial occupation numbers has been assumed; and the time integral runs through a xed interval [0;T]. The averages with weight e<sup>S</sup> of the elds a(x;t) and b(x;t) are equal [5, 6, 7] to the local densities of the A and B particles. In order to cast Eq. (1.13) in a form suitable to subsequent analysis, we rst change from a and b to the variables

If one om its from the action Eq. (1.16) the initial time term proportional to  $_{\rm B}^{(0)}$ , then the remainder is, for = 0, invariant under the time reversal symmetry

The breaking of this symmetry for  $\frac{6}{5}$  0, that is, when the di usion constants D<sub>A</sub> and D<sub>B</sub> are di erent, will be seen to have far reaching consequences for the critical behavior of this system. The naive scaling dimensionalities of the coupling constants are, in powers of an inverse length,

This shows that  $d_c = 4$  is the upper critical dimension for this problem and that in an expansion around d = 4 we may drop the  $v_i$  vertices.

The term s occurring in Eq. (1.16) m ay be given the follow ing physical interpretation. The g vertex, which involves only the B elds and , accounts for uctuations in the contam ination process A + B! 2B due to uctuations in the B particle density, and as though the A particles form ed a hom ogeneous background. The sum ' + '' m ay be shown to be equal to the uctuating part of the total density. The u vertex couples this to the density of B particles, expressing that the reaction A + B! 2B is also a ected by uctuations of the A particle density.

#### 1.5 A reduced problem : D irected Percolation

If in the action S of Eq. (1.16) we replace the elds ' and - by their mean eld values ' = 0 and - = 0, and drop the fourth order terms that were argued above to be irrelevant, the result is the action  $S_{DP}$  known in particle physics as the Reggeon eld theory and given by

Physically this means that we have constrained the total density to be constraint (equal to ) in space and time. If the B density is much lower than the A density, as is the case near criticality, this constraint means that the B particles interact with a continuous background. The rst link between the action  $S_{DP}$  and statistical mechanics was established by C ardy and Sugar [8], who showed that it describes the problem of directed bond percolation. Subsequently it was shown by G rassberger and Sunderm eyer [9] and by G rassberger and de la Torre [10] (see also Janssen [11]) that this action also describes Schlogl's chem ical reaction [12]. The " expansion for the exponents of the action  $S_{DP}$  was known from eld theory ([13] and references therein) and has been extended by Janssen [11].

The remainder of this article is organized as follows. In Section 2, for a twofold reason, we return to the action  $S_{DP}$ . We consider for the rst time its relaxation from an initial state and calculate the initial critical slip exponent <sup>0</sup>. Secondly, since throughout this work we employ time dependent W ilson renorm alization, we explain our method on the example of the relatively simple action  $S_{DP}$ , after which we apply it with only few extra comments to the full action S of Eq. (1.16).

In section 3 we return to the full action S.W e determ ine its stationary state properties, which are then used to study the relaxation from the initial state. We also study the e ect of non-Poissonian initial particle distributions.

# 2 Directed Percolation: W ilson renormalization and critical initial slip exponent

The stationary state of the action Eq. (1.20) exhibits critical behavior that has been studied by several authors both within the fram ework of an "expansion around its upper critical dimension d = 4. The analysis of the action Eq. (1.20) is usually performed (e.g. (8, 11)) by means of eld-theoretic methods, based upon the perturbative expansion of vertex functions and dimensional regularization, and leading to Callan-Sym anzik equations. In this work, instead, we apply W ilson's dynam ic renorm alization group, that is, successively eliminate short wavelength degrees of freedom. This method has already been used successfully to study the dynam ics of spin system s for instance; it is applied here for the rst time to a reaction {di usion problem.

## 2.1 W ilson's dynam ic renorm alization group

The extension of W ilson's renorm alization procedure to time dependent system s has been described by H ohenberg and H alperin [4]. We recall here how this method works on the example of the action  $S_{DP}$  of Eq.(1.20). For a study restricted to the stationary state the boundary term at t = 0 m ay be suppressed. The action m ay then be written as  $S_{DP} = S_0 + S_{int}$  with the free term  $S_0$  given by

O ne is interested in averages carried out with the weight  $e^{S_{DP}}$ . In W ilson's procedure this weight is rst integrated over the Fourier components of the elds with wavevectors k in a momentum shell de ned by

We denote these elds for brevity by > and > and the remaining elds by < and <. The scale factor b will be taken in nitesimally close to 1, and the momentum space cut-o is of order unity. One obtains an elective action  $S^e_{DP}$

The index c indicates a cum ulant and h:::i<sup>0</sup> stands for an average on the > elds with weight e <sup>S  $\circ$ </sup>. Therefore there rem ain only G aussian integrations to perform .

W ick's theorem ensures that the integrations reduce to pair contractions, and the graphical rules for dealing with these are easily found. It is convenient (see Fig.1) to represent a eld (a eld) by a leg with (without) an arrow. The interaction term  $S_{int}$  is a sum of three-leg vertices of types  $g_1$  and  $g_2$  in Fig.1. The nth order cum ulant in Eq. (2.5) comes from diagram s with n such vertices. An external leg of a diagram will stand for a < eld and an internal line for the contraction of two > elds. Each vertex is integrated over space and time. Only one-particle irreducible diagram s need to be considered. M oreover, any diagram in which one can go around a loop in the direction of the arrow s vanishes by causality. A contraction of any pair of elds at equal times is zero, a property conveniently expressed by the convention (0) = 0 and commented upon e.g. in Ref. [3]. Finally, products of noncontracted elds at di erent times are reduced to single-time expressions by Taylor expansion in the time di erence.

A fler the integration on the momentum shell elds is done one applies to  $S_{DP}^{e}$  a scale transform ation which depends on exponents z; d; and d-still to be determ ined,

and drops the primes of the new variables. The result is a renormalized action whose coupling constants are given in terms of the original couplings. In dimension  $d = d_c$  "the cumulant series in Eq. (2.5) usually corresponds to an expansion in powers of " and upon truncating it at the desired order one has a RG involving only a nite number of coupling constants. If a xed point of the transformation can be found, then scale invariance is a direct consequence and scaling laws follow.

#### 2.2 Stationary state of $S_{DP}$

The time reversal symmetry of Eq. (1.18) in poses that d = d. We write  $d = d - = \frac{1}{2}(d + )$ , where is the anom alous dimension of the elds and . We have applied the renorm alization procedure of subsection 2.1 to  $S_{DP}$ , taking into account all diagram s with two and three vertices. The resulting recursion relations read, with being

# 2.3 Relaxation to the stationary state of D irected Percolation

Relaxation to the stationary state of the directed percolation problem has not been considered before but can be studied by the same techniques. One has to keep the initial time term, with "coupling constant"  $_{\rm B}^{(0)}$ , in the action of Eq. (1.20). This term represents an initial state with Poissonian distribution of the B particles. In the diagram s it will be shown as an arrowed leg starting from a t = 0 vertex indicated by an empty circle (see Fig.1). It is easy to extend the analysis to a non-Poissonian initial distribution of particles. In that case we have to include in the action S<sub>DP</sub> of Eq. (1.20) another initial time term, viz.

H igher order terms in the eld also appear, but are irrelevant under renormalization. The coupling constant in Eq. (2.18) is related to the width of the distribution by

which vanishes for a Poisson distribution. The naive scaling dimension of the term is easily found to be zero. This means that it is marginal and has to be included in the RG calculation. Any other terms generated by these two initial terms are irrelevant. Fig.2 shows the two diagrams that yield renormalization contributions to  $_{\rm B}^{(0)}$  and to which are linear in these quantities. The conclusions of this section may be arrived at on the basis of only these diagrams. Nevertheless we shall complete the calculation to one-loop order by also computing the contributions of the diagram s of Fig.3. The diagram of Fig.3 (a) is the most complicated one to consider and the only one that we shall discuss explicitly. Its expression is

Here  $^{0}$  is the critical initial slip exponent [2]. The fact that it is positive here implies that in an initial time regime (excluding m icroscopically sm all times) the B particle density increases as

The positivity of <sup>0</sup> and the initial rise of <sub>B</sub> (t) have been discussed and interpreted in Refs. [2, 14]. They can be qualitatively understood by the lack of critical uctuations in the initial state. In the case of the reaction { di usion system s considered here the uctuations in the stationary state are responsible for the shift of the critical density to a larger value com pared its mean eld value. This is rejected by the negative <sup>?</sup> obtained in Eq. (2.12). Since the density distribution in the initial state is Poissonian and thus free of long range correlations the system shows qualitatively a mean eld-like behaviour during the initial stage of the relaxation. For = <sup>?</sup> < 0 the density of B-particles therefore increases at (m acroscopically) short times t. Notice, how ever, that this qualitative argument applies generally not to m icroscopically short times [16].

An important point, stressed in Ref.[2] and not apparent from the preceding discussion, is that  $^{0}$  is an independent critical exponent. W hereas in the special case of  $S_{DP}$  considered here it could be expressed as =z (see Eq.(2.31)), that relation does not hold in general. This will be seen, in particular, in Section 3.

# 3 W ilson renorm alization of the full action S

# 3.1 Introduction

The RG procedure applied above to the action  $S_{DP}$  of the D irected Percolation problem can be extended without di culty to the action S given by Eq. (1.16) and describing the full problem de ned in Section 1.1. This action contains a parameter which distinguishes between the di usion constants of the healthy and the sick individuals. It appears to constitute an immediate and natural step beyond the action of D irected Percolation: Led by an interpretation di erent from ours, and starting from a pair of Langevin equations postulated for a problem in population dynamics, K ree, Schaub and Schm ittm ann [1] arrive at the sam e action but specialized to = 0.0 s-ing ekd-theoretic techniques they analyze its stationary state and compute the critical exponents z, , and to order ".

Below we rst derive the stationary state RG equations for the general case € 0. Since appears to be relevant, a new analysis is needed. For < 0 we nd a new xed point and calculate the new critical exponents to lowest order in ".

Next we derive the RG equations for the additional couplings that describe the initial state. We shall, in particular, consider an initial particle distribution which is independent from site to site, but non-Poissonian.

## 3.2 Stationary state of the full action S

Our starting point is the action S of Eq.(1.16). Since our rst interest is in the stationary state, we ignore for the moment the initial time term proportional to  $_{\rm B}^{(0)}$ . As before we write S = S<sub>0</sub> + S<sub>int</sub>. The free part S<sub>0</sub> of the action now includes the term in Eq.(1.16) that is proportional to , and whose presence is due to the di usion constants of the A and B particles being unequal. This term violates the time reversal symmetry of Eq.(1.18) and introduces a nonzero correlator

D iagram m atically this contraction is represented by a solid leg w ith an arrow that connects to a dashed leg w ithout arrow to form an internal line (see Fig.1). As a consequence the symmetry between the  $2^{-1}$  and  $-2^{-2}$  vertices

In order to show that this is the dynam ic scaling exponent not only of the conserved density ' but also of the uctuations of the order parameter, one has to check that the coupling tends to nite nonzero xed point value (see below). However, because of the symmetry breaking discussed above, one has to allow for two distinct anom alous dimensions, and ', of the elds and '.

In checking the linear stability of this xed point in the subspace of  $(g_1;g_2;u;)$  we found two negative eigenvalues of multiplicity two. It is easy to see that this xed point governs the critical behavior of only the stationary state with < 0. Indeed, the unrenormalized ('= 0) value of Z has the sign of ; and from the de nition of Z combined with Eqs. (3.6) and (3.7) one deduces that Z cannot change sign under renormalization; so that the xed point can be reached only if Z ('= 0) is positive just like Z<sup>?</sup>.

## 3.3 A rst-order transition for > 0?

We shall now assume that the stationary state of the system undergoes a rst order transition for > 0. This assumption makes of = 0 a tricritical point. ## 3.4 Relaxation to the stationary state of the full action S

#### 3.4.1 N on Poissonian initial states: general rem arks

W e w ish to consider an initial particle distribution which, as before, is the product on i of identical single-site distributions  $p(m_i;n_i)$ , where  $m_i$  and  $n_i$  count the A's and B's, respectively, on site i. The distribution p is arbitrary. It need not be Poissonian in either  $m_i$  or  $n_i$ , and need not factorize. The interest of studying such initial distributions is that all initial distributions with short-range correlations reduce to them under renorm alization. The general distribution of this class is represented in the action S by the initial time term s

# 4 Conclusion

We have adapted Wilson's renorm alization scheme to the two-species reaction { di usion process A + B ! 2B; B ! A. The stationary state of this process exhibits a second order phase transition at which the B's become extinct. A parameter = 1 $D_B = D_A$  controls the relative strength of the diusion constants  $D_A$  and  $D_B$  of the two species. We have determined the critical behavior of the stationary state for < 0, that is, when the the species subject to extinction (B) di uses faster than the species (A) which it parasites on. Special emphasis has been put on the relaxation from various initial states to the critical stationary state. As happens in magnetic systems, we found an initial relaxation reqime which scales with an independent exponent  $^{0}$ , arising from renormalization of the initial time terms in the action. The reaction {di usion process has an order parameter (the B particle density) that couples to a conserved quantity (the total density). W e have show n that <sup>0</sup> varies continuously with the width of the distribution of the conserved density. The sam e e ect occurs in magnetic system s with a continuous sym m etry of the order param eter, where the sym m etry in plies the existence of a conserved quantity coupling to the order parameter [17].

We found that for positive the renormalization transformation has no stable xed point, which signals the absence of a second order phase transtion. We therefore discussed the possibility of a rst order transition; this scenario is plausible but we lack decisive arguments in its favor. This unresolved point deserves further attention.

A question of great interest concerns the low-dimensional behavior of this reaction (di usion system. The "expansion is meaningful slightly below the upper critical dimension  $d_c = 4$ , and one may imagine that it still gives a fairly good idea of what happens in d = 3. However, the qualitative picture provided by the "expansion may break down below some new critical dimension  $d_c^0$ . Eq.(1.19) shows that the (unrenormalized) action contains terms, neglected in this work, that become relevant with respect to the free (Gaussian) theory when d = 2. It is therefore possible that low dimensions require separate consideration [18]. Even the seem ingly simple one-dimensional version of this model exhibits nontrivial behavior [19] that remains to be elucidated.


Figure 2. Diagrams (a) and (b) renormalize  $B_B^{(0)}$  and , respectively. They are linear in these quantities.


F igure 4. Additional diagram sentering the renorm alization of  $g_1$  for  $\notin 0$  with respect to the = 0 case.











