N on-H erm itean Localization and D e-Localization

A bstract

We study localization and delocalization in a class of non-herm itean H am iltonians inspired by the problem of vortex pinning in superconductors. In various simpli ed models we are able to obtain analytic descriptions, in particular of the non-perturbative emergence of a forked structure (the appearance of \wings") in the density of states. We calculate how the localization length diverges at the localization-delocalization transition. We map some versions of this problem onto a random walker problem in two dimensions. For a certain model, we nd an intricate structure in its density of states.

1 Introduction

Non-herm itean random matrix theory [1] has been applied recently to a number of interesting physical situations. An interesting issue among these physical situations is the study of localization-delocalization transitions in non-herm itean random H am iltonians. The earliest discussion of localization in the context of a non-herm itean hydrodynam ics problem appears to be in [2]. Later on, H atano and N elson [3] have m apped the problem of the vortex line pinning in superconductors to a problem in-volving a non-herm itean random H am iltonian. W hen a current is passed through a superconductor, vortex lines tend to drift in a direction perpendicular to the current, but this tendency is counteracted by in purities on which the vortex lines are pinned. It is expected that at som e critical current the vortex lines becom e unpinned or delocalized. In the sim plest m odel of this problem, the physics is modelled by a quantum particle hopping on a ring, whose rightward (or counterclockw ise) hopping am plitude te^h=2 is di erent from its leftward hopping am plitude te^h=2. Note that ih m ay be thought of as an in aginary gauge ekd. On each site of the ring is a random potential w_i which tries to trap the particle. The H am iltonian

is thus the sum of the determ inistic non-herm itean hopping term

(with the obvious periodic identication i + N i of site indices) and the herm itean random potential term

The number of sites N is understood to be tending to in nity. This problem has been studied by a number of authors [4, 5, 6, 7] following Hatano and Nelson. Note that the Ham iltonian not only breaks parity as expected but is non-herm itean, and thus has complex eigenvalues. It is represented by a real non-symmetric matrix, with the reality in plying that if E is an eigenvalue, then E is also an eigenvalue.




Figure 1: The spectrum of the H am iltonian in Eq. (1) for h = 0.5, t = 2 and N = 400 sites. Shown here is the spectrum for one particular realization of site energies taken from a at distribution with 2 w_i 2. A nite fraction of eigenvalues has clearly snapped onto the real axis. (The coordinate axes have been suppressed to make the appearance of the snapped eigenvalues clearer.)

W ith no impurities ($w_i = 0$) the Ham iltonian is immediately solvable by B loch's theorem with the eigenvalues

tracing out an ellipse. The corresponding wave functions $_{j}^{(n)} \exp 2$ in j=N are obviously extended. Note that in the lim it of zero non-herm iticity (h = 0) the ellipse collapses to a segment on the real axis as expected. W ith impurities present the spectrum can be obtained by numerical work as was done extensively by H atano and N elson and as is shown in Fig. 1.

Two $\$ ings" have emerged out of the two ends of the ellipse. Som e eigenvalues have become real. Evidently, the $\$ become the two wings emerge out of the

ellipse represent a non-perturbative e ect, and cannot be obtained by treating the impurities perturbatively. It is thus something of a challenge to obtain the two wings analytically. In this paper, we address this and other problem s.

As discussed in Section 6 of [5] this behavior could be understood qualitatively by a simple example. In ordinary herm itean quantum mechanics, it is a familiar textbook dictum that nearby eigenvalues repel. In contrast, two nearby eigenvalues in the complex plane, separated along the imaginary direction, attract each other under a herm itean perturbation. To see this consider the 2 2 m atrix

with eigenvalues are $i \frac{p}{2} w^2$. Thus, for w < 0, the original eigenvalues i attract each other, but remain on the in aginary axis. However, as soon as w, they snap onto the real axis and start repelling each other. Let us start with the ellipse in the absence of in purities. Near each tip of the ellipse, there is a pair of eigenvalues separated slightly along the in aginary direction and lying on opposite sides of the real axis. They attract each other and thus approach the real axis, but as soon as the two \friends" arrive on the real axis, they in mediately repel each other (as well as the eigenvalue already on the real axis.) O byiously, this process repeats itself with the next pair of eigenvalues, and thus leads to the form ation of the wings.

Hatano and Nelson emphasized that H_0 has a special property, namely that by a (non-unitary) gauge transformation, all the non-hermiticity can be concentrated on one arbitrarily chosen bond, without changing the spectrum. This leads to an extraordinarily simple argument that the states corresponding to complex eigenvalues are extended, that is, delocalized. Let H = E. A ssume that is localized around some site j. We can always gauge the non-hermiticity to a link which is located arbitrarily far away from the site j, where j j is exponentially small. Thus, if we cut the ring open at that link, the e ect on the Schrödinger equation would be exponentially small, and would vanish completely in the limit N ! 1. It follows from this simple argument that if we replace the periodic boundary condition in solving H = E by an open chain boundary condition, the localized part of the spectrum of (1) would not be a ected. But for H with an open chain boundary condition, the gauge transform ation just mentioned may be used to gauge away the non-herm iticity completely, meaning that the Ham iltonian is in elect herm itean with real eigenvalues. We thus conclude that all localized eigenstates of (1) correspond to real eigenvalues (in the large N limit.) In other words, the states corresponding to complex eigenvalues are extended, that is, delocalized.

R em arkably, non-herm itean localization theory is simpler in this respect than the standard herm itean localization theory of Anderson and others [8]. To understand the localization transition, one has to study only the density of eigenvalues, or equivalently, the one-point G reen's function, rather than the two-point G reen's function.

2 The single impurity case

In this section our philosophy is to nd the simplest version of the hopping model described in the Introduction which we can solve exactly, but yet manages to capture the essential physics involved, including the non-perturbative emergence of the two \w ings" along the realaxis. The desired simplication is to replace the N random im – purities in (3) by a single impurity. W ith this simplication we do not need to specify the precise form of the non-herm itean H₀ beyond assuming that it is translationally invariant. We thus replace the W_{ijj} in (3) by

where w is drawn from some probability distribution P (w).

Our task is to calculate the averaged G reen's function

of the random H am iltonian H = H $_0$ + W , from which we may calculate the eigenvalue density of H .

Away from the location of the spectrum of H $_0$ in the complex z plane we expand (6) in powers of $1=(z H_0)$, and thus obtain

is the G reen's function of H $_{\rm 0}$. D ue to the translational invariance of H $_{\rm 0}$ we have

O beerve that the e ect of the single in purity on the G reen's function is of order 1=N, as should be expected.

W e stress again that up to this point we did not adhere to any speci c translationally invariant H $_0$ nor did we specify any particular probability distribution P (w) in our derivation of (9). W e also note that our derivation is exact for any value of N.

For nite N the singularities of $G_0(z)$ are isolated simple poles located at the eigenvalues of H_0 . The e ect of the single in purity on any of these poles would be to move it around in an amount which depends on the typical scale r of the distribution P (w). Thus, if $z = z_0$ is one of the poles of $G_0(z)$, we expect that for sm all values of the scale r, the full G reen's function G (z) will also have a pole near $z = z_0$. Thus, in the vicinity of $z = z_0$ (ignoring all the other poles) we may approximate

Eq. (11) is nothing but the result of rst order perturbation theory (after all, we ignored the e ect of all states other the eigenstate associated with z_0 .)

We can now understand the non-perturbative emergence of wings under very general circum stances. Evidently, besides the \trivial" poles just mentioned, G (z) also has a pole whenever $wG_0(z) = 1$ with w in the support of P (w). We have

where $_{0}(x;y)$ $(1=N)^{P}_{i}(x \text{ Re } E_{i})$ (y Im E_{i}) is the density of eigenvalues E_{i} of H₀. All we require for the following discussion is that $_{0}(x;y) = _{0}(x; y)$. This is true for all the H am iltonians H₀ considered in this paper. Then on the (positive) real axis G₀(x) is real, and decreasing outside the spectrum of H₀. (Indeed, it is well known that we can interpret the real and in aginary parts of G₀(z;z) as the electrostatic eld $E = (E_{x}; E_{y}) = (R \in G_{0}; Im G_{0})$ generated by the charge density

⁰.) Thus, if the real quantity 1=w lies between $G_0(x_{edge})$ and zero (where x_{edge} denotes the intersection of the edge of $_0$ with the real axis), we will have a pole on the real axis at som e x (w). A veraging over w we thus obtain a wing on the positive real axis. A similar discussion can obviously be given for the negative real axis. It is also clear that there is no solution of w $G_0(z) = 1$ for z outside $_0$ and away from the real axis.

The probability distribution P (w) will in general depend on som e set of parameters fr_ig and for some given fr_ig it is of course possible that 1=w does not lie between G_0 (x_{edge}) and zero. Thus, for some critical values fr_i^cg there will be a transition at which the wings, and hence the localized states associated with them, disappear.

In the N ! 1 limit the eigenvalues of H₀ become dense and will either trace out a curve in the complex energy plane (analogous to the ellipse associated with (4)), or llout a two dimensional region (as for example, in two dimensional hopping problem s.) We now focus our attention at the hopping Hamiltonian H₀ in (2). To make things as simple as possible we let the parameters in (2) tend to the (maximally non-hermitean) limit h ! 1 and t ! 0 such that

(and obviously te^h! 0). In this lim it (4) changes into

and the ellipse associated with (4) expands into the unit circle. Furtherm ore, the full Schrödinger equation (H $_0$ + W) = E becomes simply

from which we extract the localization length of the state simply as

At the points where the wings join onto the circle the localization length diverges as expected.

The Green's function associated with (14)

Note that independently of P (w) the disk inside the unit circle remains devoid of eigenvalues. To get a hold of the correction G (z) (1=z) in the outer region it is instructive to carry out some explicit calculations with particular probability distributions P (w).

A sour rst concrete example, we take

with some scale r. We then nd from (18) that

If r > 1, then G (z) has two new poles on the real axis at z = -r, each with a residue 1=2N. The critical value for r to induce these two new poles is $r_c = 1$. The existence of this critical value is a non-perturbative phenom enon (though its particular num erical value is retrospectively not surprising at all, being set by (14).) From (17) we nd that the localization length of the states associated with these poles is L (r) $1=\log r$, and they thus become extended as $r ! r_c = 1$.

Consider next the box distribution

The eigenvalue density (x;y) (with z = x + iy) is related to the G reen's function by the general relation [5]

As in the previous example, non-perturbative e ects generate a critical value for V, namely $V_c = 1$. For $V > V_c$, the density of eigenvalues develops two symmetric wings of length V V_c such that the fraction of eigenvalues residing in these wings is $\frac{1}{N} (1 \quad \frac{1}{V})$: The localization length L (E) of states that reside in the wings is nite for $\frac{1}{V}$ j> V_c and diverges logarithm ically as $\frac{1}{V}$ j! V_c .

A sour nalexample for this section we consider the Lorentzian distribution

with its long tails extending to in nity. The fraction of realizations in which an impurity potential is stronger than the unit scale set by (14) is (1 =) arctan . We nd that outside the unit circle

Due to the long tails of (25), the wings extend to in nity, and the fraction of states that reside in them is (1=N) arctan , namely, the fraction of strong" in purity realizations divided by N. Note also that there is no critical value for , namely, the wings appear for all values of .

Note that to obtain the analog of (9) in the case of two in purities already involves a non-trivial combinatorial calculation involving G_{ii} ; G_{jj} , and G_{ij} , where i and j denote the locations of the two in purities. (It is clear though, that the results of this section as they stand, are still applicable to the problem with m any in purities, as long as the separation between in purities is larger than the localization length.) Remarkably, however, we show in the next two sections that taking the maximally non-herm itean lim it (13) which restrict the particle to \one way" hopping, we can readily treat the generic problem of m any in purities.

Finally, we stress that our derivation of (9) was not limited to one dimensional hopping. Given $G_0(z)$ for a translationally invariant H_0 in any number of dimensions, G(z) as given by (9) is still valid outside the support of the spectrum of H_0 . In general, the spectrum of H_0 in higher dimensions will lla two dimensional region in the complex energy plane. In order to calculate G(z;z) in that region, and in fact, to see how that region is a ected by the impurity, we might have to resort to the method of H ermitization discussed in [5].

3 Maximal non-herm iticity and many impurities: \One Way" models

In the preceding section, our exact result (9) was obtained for any value of the param – eter h. W e m ay perhaps hope that we can study the m any impurities problem in the particularly symmetric case provided by the limit (13), namely te^h ! 2; te^h ! 0, in which the ellipse of eigenvalues becomes the circle (14). Thus, we will study the case of m axim al non-hermiticity in which H is given by

(with the obvious periodic identi cation i + N i of site indices.) We refer to this class of m odels in which the particle only hops one way, as \one way m odels."

W e have found a particularly simple example in which

We now proceed to calculate the density of eigenvalues E_i in this \one way sign model", using the master form ula

where we de ned z = x + iy (a careful derivation of (30) is given for example in Section 2 of [5].) It is at this point that the simplication associated with taking the large non-herm iticity limit may be appreciated: the determinant of z H for H in (28) is simply

(For arbitrary t and h the corresponding form ula is considerably m ore complicated.) Note that (31) is completely symmetric in the fw_ig , and thus, for a given set of site energies it is independent of the way the impurities are arranged along the ring. A veraging over the impurities we obtain

In the lim it N ! 1, the binom is concerned appearing in (32) is sharply peaked as a function of n around n N = 2, and thus to rst approximation,²

In order to calculate the density of eigenvalues we may now insert (33) (and its counterpart for H y) into (30), but due to the sim plicity of (33) we can avoid doing so and simply identify the branch singularities of the right hand side of (33). These singularities clearly occur at

To sum marize, we see that the original unit circle spectrum of the determ inistic part of (28) is distorted by the random ness (29) into the curve

in the complex z plane. Clearly, $r_c = 1$ is a critical value of r. For r < 1, the curve (35) is connected, whereas for r > 1 it breaks into two disjoint symmetric lobes that are located to the right and to the left of the imaginary axis. The lobe on the right intersects the real axis at $E_{min} = \frac{p}{r^2 - 1}$ and at $E_{max} = \frac{p}{r^2 + 1}$. As r is decreased to $r_c = 1$ the two lobes touch at the origin and merge into a single curve when r becomes smaller than $r_c = 1$.

In the three gures below we have plotted the curve (35) for three values of r in the di erent regimes r < 1; $r = r_c = 1$ and r > 1, on top of the corresponding results of num erical simulations.




Figure 2: The spectrum of the Ham iltonian in Eq. (28). The site energies are taken from (29) for various values of r. Figures (a), (b) and (c) correspond to r = 0.9;1 and 1:1, respectively. The solid curve represents Eq. (35).

The width of the scatter of the num erical results around the analytical curve can be roughly estimated for any given z_0 on (35) by keepping (in addition to the leading term) all terms in the sum (32) with jn (N =2) j N (z_0), where (z_0) is determined by steepest descent. Then the branch singularities on the right hand side of (32) would have been bounded between the curves

(N ote added: In a forthcoming publication [10], it is shown that the width of the scatter vanishes as N ! 1 and that the spectrum of the Hamiltonian in (28) is actually one dimensional.)

4 M any impurities and critical transitions

In this section we push the analysis of the previous section further and replace (29) by a generic probability distribution P (w_i).

Using the determ inant (31) (z) $Q_{k=1}^{N}(z w_{i})$ 1 we write the G reen's function for the \one way" Ham iltonian (28) as

where in each term we average over w against the arbitrary distribution P (w). A sim – ple check reveals that (37) is consistent with (29) and (33). The averages $h(z w)^{k}i$ may be obtained of course by deriving the generating function

It is worthwhile to mention here that a derivation of (37) by expanding in powers of the \one-way" hopping piece $H_0 = {}^P_i$ jiihi + 1 j in (28) has the nice feature that starting from any site i on the chain, the terms that contribute to the trace (even without taking the average) are precisely those in which the particle hopped an integer number of complete revolutions around the chain (which is why the averages in (37) are all raised to the power N .) This observation may provide a physical explanation of why the determ inant (31) is completely symmetric in the site energies w_i : the particle visits all sites equally as it hops, wherever the w_i 's are.

As a concrete application of (37) we now concentrate on the Lorentzian distribution (25) P (w) = (=) (w² + ²) ¹. We have $g(z;z) = (z + i \text{ sgn} (\text{Im } z))^{1}$ and obviously

We would like now to calculate the density of eigenvalues. We rst investigate (x;y) o the real axis. Using (23) ((x;y) = (1 =) (0 = 0z) G(z;z)) we nd

where $!_{\,k}\,=\,e^{2\,\,ik=N}$, and z i in the rst line of (41) correspond to z being in the upper or lower half plane, respectively. The com plex eigenvalues are thus equally spaced along the union of two arcs of a circle of radius one. The upper arc is that part of a sem icircular arc of a unit circle (centered at the origin) that remains in the upper half plane after being pushed a distance dow nw ard along the imaginary axis. (The lower arc is of course the m irror in age of the upper arc.) Each of these arcs is thus of length arc cos (2 2 1) < and carries $n_{\rm arc}$ = (N=2) arc cos (2 2 1) < (N=2) eigenvalues. This means that the arcs exist only as long as $<_{\rm c}$ = 1, which should be contrasted with the situation in (27). There, the single in purity does not perturb the unit circle, which persists for all values of .

The rest of the eigenvalues, which do not have space to live on the arcs, must have snapped onto the real axis and form ed \w ings". The eigenvalue density along the real axis is generated when @=@z hits the step-functions (Im z) in (40) and we nd that it is given by

where we have dened x i e^{i} .

In the large N lim it (42) tends to a particularly simple form . It is clear that this form depends on whether $<_c = 1 \text{ or } >_c$. For > 1

(which again should be contrasted with the one in purity case (27),) while for < 1wing = 0.

We thus see that for $< _{c} = 1$, there are two wings that bifurcate from the arcs at $x = x_{c} = \frac{p}{1 - 2}$. Integrating over (43) we not that the fraction of eigenvalues that reside in the wings is $(n_{wings}=N) = 1$ (2=) arc cos = 1 (1=) arc cos (2² 1), which together with the fraction of eigenvalues $2(n_{arc}=N) = (1=)$ arc cos (2² 1) that reside in the arcs, sum up exactly to 1. As tends to _c, x_{c} becomes smaller, and vanishes at = _c. At this point the two wings touch at the origin and the two arcs disappear completely.

A salready mentioned, there is no critical $_{\rm c}$ in the single in purity case, as perhaps might be expected. The many in purities case is dram atically dierent: the long tail of the Lorentz distribution can overwhelm the non-herm iticity for $> _{\rm c}$, and the spectrum collapses to the real axis. We have carried out some numerical studies. For away from $_{\rm c} = 1$, our analytic results t the numerical data closely, but as approaches $_{\rm c}$, the statistical uctuation between dierent realizations of fw ig becomes larger and larger (at = 0.9 for example, for N as large as 400.) It would be interesting to study the character of the transition in more detail.

It is perhaps worthwhile to remark that although in m any discussions of disordered physics the gaussian distribution is the simplest to deal with, here it leads to a g(z) not given by an elementary function.

Having derived a closed formula (Eq. (37)) for the Green's function of the \oneway" model (28) (with pure clockwise hopping $H_0 = {}^P_i$ jihi + 1), we may now perturb it by adding a term $H = {}^P_i$ ji + 1ihij (with small) which allows the particle to hop counter-clockwise. To rst order in perturbation theory, the correction to the Green's function (37) is now

$$\operatorname{tr} \frac{1}{z w} H_0 \frac{1}{z w} H_1 H \frac{1}{z w}$$

which rejects the fact that the particle has completed one revolution around the chain by performing N + 1 steps counter-clockwise and one step clockwise (which can occur anywhere along the chain.) It is thus possible to study the non-hermitean

Ham iltonian (1) by perturbing both from the herm itean lim it and the maximally non-herm itean lim it.

In [5] we showed that by a herm itization method we can associate with every non-herm itean H am iltonian H a herm itean H am iltonian H. In particular, for the hopping H am iltonians H discussed in this paper, the H am iltonian H involved the hopping of a particle with a binary internal state (call it an "up" or a "down" particle) such that as it hops it ips its internal state. Solving the Schrodinger equation associated with H am ounts to a simultaneous solution of the Schrodinger equations associated with the two herm itean positive H am iltonians H₁ = (z H)(z H)^y and H₂ = (z H)^y(z H). We see that for our \one-way" models H₁ and H₂ involve only nearest-neighbor hopping, while for the non-herm itean hopping models such as (1) or its generalizations described in Section (5), H₁ and H₂ involve next-nearest neighbor hopping³

 $^{{}^{3}}$ T his observation persists in the continuum of course. In the continuum the \one-way" H am iltonian becomes a rst order di erential operator and thus H $_{1}$, H $_{2}$ are second order di erential operators. The generic hopping H am iltonian becomes a second order di erential operator and thus H $_{1}$ and H $_{2}$ are fourth order di erential operators.

5 Continuum \One W ay" models

The discrete 0 ne W ay" models of the two previous sections were solved exactly in the lagre N limit. We now show that their continuum counterparts are also exactly solvable.

Starting with the continuum non-herm itean Schrodinger equation

$$H = (1=m) [\theta_{x} + h]^{2} + W (x)$$
(44)

(with constant h), we reach the $\0$ ne W ay" lim it by letting both h and m tend to in nity with a nite ratio h=m (which we set to 1=2.) In this lim it, H in (44) turns into the rst order non-herm itean operator

$$H = Q_x + W (x); \qquad (45)$$

which is the desired continuum 0 ne W ay" model. C learly, the spectrum of (44) m ay be solved explicitly for any W (x), once the boundary conditions are specified. For example, if (45) is defined over 0 x L with periodic boundary conditions, we have

where n and n are the eigenvectors on the right and on the left, respectively. In posing the boundary conditions we nd $E_n = \frac{1}{L} \int_{0}^{R} dyW(y) + \frac{2i n}{L}$ (n being an integer.) Since we know the spectrum fE_ng explicitly, we can now consider random izing W(x) in (45) and calculate any desired correlation function given any distribution of the random W(x). For example, if W(x) is drawn from the Gaussian distribution P[W] = (1=2g²)_{0}^{R_L} dxW²(x)] we readily nd that the averaged density of eigenvalues is

namely, each of the purely in aginary eigenvalues of $H_0 = Q_x$, is smeared along the real axis by the uctuations of the real potential W(x). The spectrum is thus one dimensional, as in the discrete case.

6 Random hopping models and their mapping onto random walkers

In this section we study a di erent class of models, in which there is no site energy, but the hopping is random and non-herm itean. We consider the Schrodinger equation

$$E_{j} = S_{j j+1} + t_{j 1 j 1}$$
(48)

with the hopping amplitudes s_j and t_j generated random ly according to some prescription.

If the H am iltonian is herm itean, then $s_j = t_j$. This herm itean problem was studied some twenty years ago by Eggarter and R iedinger [9]. They mapped the model onto a random walk problem and were able to show that all the states, except for the one at E = 0, are localized, and furtherm ore, that the localization length diverges like jlogE j as E ! 0. The existence of localized states is in accordance with the arguments of Anderson et al. [8]. In contrast, the appearance of an extended state at precisely E = 0 is not generic and is due to the invariance of the spectrum under E ! E (as one can see by ipping the sign of $_i$ for i odd.) Thus, the extended state at E = 0 is unstable under any perturbation that destroys this symmetry, such as adding random site energy.

Here we extend and generalize the analysis in [9] to the non-herm itean case. Our discussion below serves also as a review of [9], since obviously at any stage we can set s_j equal to t_j . D ividing (48) by j and de ning j $t_{j-1-j-1} = j$ we obtain

where $R_j = s_j t_j$. This equation is of course equivalent to Schrödinger's equation (48) and allows us to solve for j iteratively and hence for the wave function . For a closed chain the obvious boundary condition is N+1 = 1.

Perform ing a gauge transform ation j = j, we not that we can excively transform $s_j = (j_{j+1} = j)s_j$ and $t_j = (j_{j+1})t_j$. A sperhaps expected, R_j is invariant under this transform ation. We see by these considerations that the open chain and the closed chain are quite di erent. For an open chain, we can always use this gauge freedom to set all the t_j equal to 1, say, with no loss of generality (which in the herm itean case would mean setting all the s_j equal to 1 as well, hence getting rid of random ness altogether.) On the other hand, for a closed chain with N sites, we have the boundary condition $_{N+1} = _1$ and hence the constraint $_{N+1} = _1$. The gauge transform ation is not in general useful.

We can of course invent a variety of models. Hatano and Nelson [3] considered $s_j = j e$ and $t_j = j e$ where j is taken from the at distribution P () = $\frac{1}{2}$ (2^{2}). We have studied one particularly simple model which we call the $\clock m odel$ ", de ned by setting s_j and t_j equal to random phases. In some sense, this model is particularly attractive, in that it includes no free parameters. Numerically, we found that the eigenvalues in the clock model are distributed (in what appears to be a uniform distribution) in a disk in the complex plane, centered at the origin and with radius approximately equal to =2. The rotational invariance of the spectrum results from of our freedom to multiply the random Ham iltonian by an arbitrary overall phase.

Recall that the spectrum of any non-herm itean (or herm itean) hopping problem as de ned in (48) is invariant under E ! E. Furtherm ore, in the case of the clock model, the existence of an extended state at E = 0 (provided E = 0 is in the spectrum, which is always the case when the number of sites N is odd) survives the non-herm iticity. This is so because the Schrödinger equation (48) for E = 0 in plies that $j_{j+1}j = \frac{t_{j-1}}{s_j}$ $j_{-1} = j_{j-1}j$ and so this state is obviously extended. We expect the other states to be localized with an energy dependent localization length that diverges as E ! 0. These expectations are supported by the num erical studies we have done.

W e would like now to discuss the divergence of the localization length as E ! 0. W e thus focus on (48) for sm all E, that is E sm all compared to a typical value of i.

In the herm itean case, we have the important observation that $R_j = j_j \hat{j}$ is real and positive. A loo, E is real, and thus by (49) we can take j to be real (for an open




Figure 3: Two representative wave functions in one particular realization of the \clock m odel". The wave function in Fig. (a) corresponds to the eigenvalue closest to the origin E = 0.04 0.14i. It is extended and its participation ratio is 0.75. The wave function in (b) corresponds to the eigenvalue farthest from origin E = 0.78 + 1.57i. It is localized and its participation ratio is 0.01.

chain, of course.) We see from (49) that for E small compared to the typical scale of , the quantities $_{j}$ changes sign from site to site, and hence, as pointed out by Eggarter and R iedinger, it is convenient to iterate (49) twice and write

$$_{j+2} = \frac{R_{j+1}}{R_{j}} + \frac{4 \frac{1 - \frac{E}{j}}{1 + \frac{E(j-E)}{R_{j}}}}{1 + \frac{E(j-E)}{R_{j}}} = j:$$

We can now de ne z_j log j and interpret z_j as the position of a random walker in the complex plane and j as time. Taking the logarithm of (50) we obtain

de ning the motion of the walker.

As noted above, for the herm itean case, R_{i} is real and positive and thus the random walker stays on the real line. In particular, Eggarter and Riedlinger took hlog $(R_{j+1}=R_j)i=0$ and de ned ² h(log $(R_{j+1}=R_j))^2i$. They made the insightful observation that for E 0 the last term in (51) (which would otherwise be too di cult to treat) could be taken into account e ectively as boundary conditions set on the walker. Consider rst the $\log 1 + \frac{E(j-E)}{R_j}^i$ part of that term. When (R_i=E) a large positive number (we can always think of $\ _{1}$ as positive), i the walker's position on the real line (namely, $x_j = \log_j$) decreases rapidly. We can thus e ectively replace the term under consideration by a relecting wall located at log (R = E) (which moves o to in nity as E ! 0), where R is a typical value of $h_{L_{i}}^{h}$ R_j . Consider now the remaining log 1 $\frac{E}{i}$ part of that term . This part becomes important when j = 0 (E), at which point the sequence of j switches sign. We can thus think of a trap (or a \walker-eating monster") located at x logE (which wanders o to 1 as E ! 0.) Eggarter and Reidliger showed that the localization length can be related to the lifetim e of the walker. In a num erical simulation we start with a walker being born at the wall (x + 1); typically he drifts rapidly towards 0, where he executes a random walk in his middle age, and as soon as he drifts х into a substantially negative x region, he rapidly approaches his death at x 1.

It is perhaps satisfying that in going from the herm itean problem to the nonherm itean problem the random walker has escaped from the one dimensional world and wandered o into the complex plane. (Strictly speaking, due to the properties of the logarithm, the walker now lives on a cylinder with circum ference 2 .) The equation (51) describing the two dimensional walker is considerably more di cult to treat. One particularly simple case is given by the clock model in which the fR jg are pure random phases. Thus, separating $z_j = x_j + iy_j$, we see that as long as the term in square brackets in (51) is close to unity, the walker wanders in the y direction, with its x coordinate hardly changing.

We can estim ate the localization length L (E) rather crudely by noting that in the (supposedly) exponential tail of the localized wave function $j_j j$ exp (1=L(E)) and so x_j 1=L(E). Thus we estimate 1=L(E) to be given by some average x coordinate of the walker. In numerical studies, we observe that indeed, with the walker starting at x = 0 he drifts into a random walk around some average < x >, (but then eventually wanders o .)




Figure 4: The spectrum of the hopping sign m odel" for a chain with 400 sites. The amplitudes s and t take on values 1 with equal probability.

O ne m essage of this section is that random (non-herm itean) hopping models appear to be considerably more complicated than random (non-herm itean) site energy models. Indeed, let us mention that another interesting model we have studied, which we call a hopping \sign model", is a restriction of the clock model, in which s_j and t_j are random ly (and independently) equal to 1. This restriction destroys the rotational symmetry of the spectrum of the clock model, reducing it to a four fold symmetry, since eigenvalues must come in quadruplets E; E (the Ham iltonian in this case is real and the symmetry of the spectrum under E! E remains intact.) We obtained the density of eigenvalues numerically, and it exhibits a complicated interesting structure as shown in Fig.(4). It is an interesting challenge to calculate this structure analytically.

The hopping \sign m odel" is the strictest restriction of the \clock m odel". It is thus interesting to investigate how the eigenvalue distribution of the \sign m odel" changes when we allow the hopping am plitudes to take on m ore values. For exam ple,

we studied num erically a Z_4 m odel in which s_j and t_j took on (independently) values from f 1; ig with equal probability. We found that the intricate structure in Fig. (4) was largely washed out towards the uniform disk distribution of the \clock m odel", with some residual ne structure.

At this point we mention a class of hopping models in which the s's and t's in (48) are taken from the same probability distribution P(x) such that x is always real and positive. A lthough the Ham iltonian H is non-herm itean, the eigenvalues, that is, the solutions of det (E H) = 0, are all real for N large. W hile surprising at rst sight, this fact can be easily understood. The crucial observation is that $R_{i} = s_{i}t_{i}$ are all real and positive. For N large, it does not make any dierence whether the chain is closed or open as far as the eigenvalues are concerned, and so we can apply the transformation $s_j ! s_j^0 = (t_{j+1} = t_j)s_j$ and $t_j ! t_j^0 = (t_{j} = t_{j+1})t_j$ mentioned earlier to make $s_j^0 = t_j^0 = q \frac{q}{R_j}$ (which is achieved by choosing $t_{j+1} = t_j = q \frac{q}{t_j = s_j}$.) Thus the model is e ectively herm itean, that is, the eigenvalues (which are gauge invariant, of course) are real. Note that the \gauge" transform ation just mentioned does not preserve the localization property of the wave function i. For instance, in num erical work, it is convenient to study the participation ratio, de ned by 4 P (E) = $1=(N_{jj}^{P}j_{jj}^{4})$, such that P ! 0 for a localized state and P ! 1 for an extended state. Clearly, P is not preserved by the \gauge" transform ation in general, and therefore, say, a localized state m ay be gauged into an extended state (or vice-versa), unless the j are appropriately bounded as a function of the site index j. We thus have to do a case by case study of how the i's behave as a function of j to infer the localization properties of the original wave functions from the gauge transform ed wave functions of the e ectively herm itean problem, which are of course all localized, as predicted by Anderson and others.

Note that the \sign m odel" m entioned in the previous paragraph and the hopping

⁴In general, in addition to the eigenvector on the right corresponding to an eigenvalue E, H = E, there is also the eigenvector on the left, H^Y = E. With the normalization condition j = 1, we can naturally consider the variant de nition of the participation ratio given by P (E) = 1= (N $j j j j j^2$).

H am iltonian H $_0$ in (2) both evade the de ning conditions of this class of crypto-real m odels. An interesting question in m athem atical physics is to calculate the fraction of eigenvalues escaping into the complex plane when the support of P (x) includes negative values of x.

Finally, in connection with the question raised in the last paragraph, we mention here a class of hopping models in which the s's and t's in (48) are of the form $s_j = t + T_j$ and $t_j = t - T_j$, where the independent random amplitudes fT_jg take values in the range $T - T_j$. The according to some, say, even probability distribution (this model is a one dimensional discrete analog of the two dimensional \model I" in [2].) For $t^2 > T^2$ all R j are clearly positive with probability one, and thus the model is \cryptoreal". In general, the eigenvectors of the herm itean gauge transformed H amiltonian would be all localized. Eigenvalues would start migrating into the compex plane only when $t^2 < T^2$.

An amusing exception to the assertion that all states of the herm itean gauge transform ed H am iltonian are localized for $t^2 > T^2$ is provided by the case in which the fT_jg take on values T with equal probabilities. In this case R_j R = t^2 T² is actually determ inistic and site independent and describes free hopping. O bviously, all states of the herm itean H am iltonian are extended, regardless of the m agnitude of disorder T. C learly, p R, and thus all eigenvalues are real when $t^2 > T^2$, and become pure in aginary for $t^2 < T^2$. Thus, for this particular sign distribution, the answer to the question raised above is that for $t^2 < T^2$ all eigenvalues escape into the complex plane (and onto the im aginary axis.)

7 Conclusion

We have studied localization and delocalization in a wide class of non-herm itean H am iltonians. In various simplifying lim its we were able to obtain analytic expressions. Our rst model (9), while it involved only a single impurity, was able to capture the non-perturbative essence of the localization-delocalization transition. It was widely applicable to a generic H₀, in any spatial dimensions. For more explicit expressions, we had to invoke the maximally non-herm itean, or \one-way" lim it, in which the spectrum of H₀ was a circle. (It is di cult to imagine that comparably sim – ple expressions can be obtained when the spectrum of H₀ is an ellipse.) We were then able to analyze the problem of in nitely many impurities, one at each site. Results were given for several representative probability distributions P (w) for the impurity potential energy w. We analyzed the phase transitions as parameters in P (w) were varied.

W e studied non-herm itean random hopping H am iltonians. It has been known that the herm itean one dimensional random hopping problem can be mapped into a random walk problem on the real line. W e found that in going from the herm itean to the non-herm itean problem, the random walker steps of the realaxis and goes wandering o into the complex plane. W e showed by numerical work that for the random phase or \clock model" the density of states appeared to be uniform ly distributed over a disk, while in contrast for the \random sign" model the density of states showed a fascinatingly intricate structure.

The study of non-herm itean H am iltonians opens up a rich area for exploration. We can immediately think of many questions to be answered. For instance, consider the many body problem (see also [3].) In the $\one-way"$ model of (28) the many (non-interacting) ferm ion ground state will be described by a Slater determinant

det $_{i;j}[_{i}(x_{j})]$ which in the large N lim it assumes the form ${}^{Q}_{i>j}$ [eⁱ eⁱ]. The question arises, even before we consider in purities, on what is meant by the lowest energy state of H₀. In other words, as we ll the system with non-interacting fermions, how do we order the energy levels if they are arranged in a circle? These

questions may perhaps be answered by coupling the system to some agent (such as a radiation eld or a heat bath) which can exchange energy with the many body system.

As another set of questions, we can ask how a non-herm itean many body system can be second quantized? W hat are some of the properties of a non-herm itean quantum eld theory, such as a gauge theory in which the gauge potential A is nonherm itean? In a relativistic theory, if the H am iltonian becomes non-herm itean, does Poincare invariance in ply that its other nine generators should become non-herm itean as well?

It is of course a trivial exercise to treat the model in (1) perturbatively in the strength of the random impurity. Denote the eigenvalues of H₀ and H by fE g and fE (w)g respectively. Write H₀ = S ¹ES with E the diagonal matrix with elements fE g (and thus the columns of S ¹ and the rows of S are the right and left eigenvectors of H₀, respectively.) Dene

and so on. It follows that the averaged density of eigenvalues of H is given to O (w 2) by

where we have used only $hw_i w_j i = w^2_{ij}$. The result (A.3) holds for all H_0 (and for nite N .) For the speci c H_0 in (2) and in the large N limit there are drastic simpli cations. We have E $_i = 1$ =N and so Im E $_i = 0$ and P_i (ReE $_i$)² = 1=N. Thus the only non-trivial quantity that com es in is

The sum in (A.5) can be converted to an integral and evaluated in principle. For the $\one way"$ model described in the text the integral is particularly simple and we obtain

To this order in w, the circle has been turned into an ellipse. Of course, we do not see any trace of the wings in perturbation theory.
