# Survival P robability in a $R$ andom $V$ elocity $F$ ield

#### Abstract

The tim e dependence of the survival probability, $S(t)$, is determ ined for di using particles in two dim ensions which are also driven by a random unidirectional zero-m ean velocity eld, $v_{x}(y)$. For a sem i-in nite system with unbounded $y$ and $x>0$, and $w$ ith particle absorption at $x=0$, $a$ qualitative argum ent is presented which indicates that $S(t) \quad t^{1=4}$. This prediction is supported by num erical sim ulations. A heuristic argum ent is also given which suggests that the longitudinal probability distribution of the surviving particles has the scaling form $P(x ; t) \quad t^{1} u^{1=3} g(u)$. H ere the scaling variable $u / x=t^{3=4}$, so that the overall tim e dependence of $P(x ; t)$ is proportional to $t^{5=4}$, and the scaling function $g(u)$ has the lim iting dependences $g(u) /$ const: as $u!0$ and $g(u) \quad \exp \left(u^{4=3}\right)$ as $u!1$. This argum ent also suggests an e ective continuum equation of $m$ otion for the in nite system which reproduces the correct asym ptotic longitudinal probability distribution.

## I. IN TRODUCTION

Consider a di using particle in the sem i-in nite planar dom ain ( $\mathrm{x}>0 ; \mathrm{y}$ ) which is absorbed when $\mathrm{x}=0$ is reached. In addition to the di usion, the particle is driven by a unidirectional random velocity eld in which $\mathrm{v}_{\mathrm{x}}(\mathrm{y})$ is a random, zerom ean function ofy only ( F ig. 1). $T$ his type of stochastic $m$ otion was introduced by $M$ atheron and de $M$ arsily ( $M d M$ ) [1] [1] nam ic dispersion of dynam ically-neutral tracer in a sedim entary layered rock form ation. A lthough the longitudinal bias averaged over an in nite num ber of transverse layers is zero, the typicalbias over a nite num ber of layers is a uctuating quantity which is a decreasing function of the num ber of layers that a random $w a l k$ visits. $T$ his non-vanishing residualbias underlies the faster than di usive transport of the $m$ odel. In an in nite system it has been established that the typical horizontal displacem ent $x_{\text {typ }} / t^{3=4}$ [ $\left[_{2}^{[4}\right]$ and that the con guration averaged distribution of longitudinal displacem ents has the form $P(x ; t) \quad t^{3=4} \exp \left[\left(x=t^{3=4}\right)^{4=3}\right]$. There are also strong uctuations in the probability distribution between di erent samples of the velocity eld, as well as a very slow convergence to the asym ptotic lim it.

W hile much is now understood about transport in the $\mathrm{M} \mathrm{dM} \mathrm{m} \mathrm{odel} ,\mathrm{wew} \mathrm{ish} \mathrm{to} \mathrm{investigate} \mathrm{its} \mathrm{rst} \mathrm{passage} \mathrm{prop-}$ erties. Speci cally, we consider the sem i-in nite twodim ensional system $x>0$ with an absorbing boundary at $x=0$, and study the tim e dependence of the particle survival probability, $S(t)$. The survival probability in a nite system $w$ th absorbing boundaries at $x=L$ and the same unidirectional random velocity eld has been studied previously [ $\left[\begin{array}{l}13 \\ 1\end{array}\right]$; how ever this system exhibits fundam entally di erent behavior than the sem i-in nite system that is treated here.

In the absence of a velocity eld, it is well known that in the sem i-in nite system $S(t)$ asym ptotically decays in time ast ${ }^{1=2}\left[\begin{array}{l}{[5]}\end{array}\right.$. Because the velocity eld in the M dM
$m$ odel has no net longitudinal bias, it is not immediately obvious how the behavior of $S(t)$ will be a ected. $N$ aively, one $m$ ight expect that the dom inant contribution to $S(t)$ w ill arise from those velocity con gurations whose average bias is directed aw ay from the boundary. This is indeed the case, and from this starting point, we present a sim ple argum ent which suggests that the survival probability, averaged over all realization of the velocity eld, is proportional to $t^{1=4}$. This prediction is in excellent agreem ent w ith our num erical results.

Interestingly, a $t^{1=4}$ decay of the survival probabilty has been found previously for di using particles in a sem i-in nite two dim ensional system $w$ ith a unidirectional zero-bias, but determ inistic velocity eld of the form $v_{x}(y)=v_{x}(y)$ [G] $]$. A though the $m$ echanism that leads to $S(t) \quad t^{1=4}$ in this class of velocity elds is di erent than that for the $M \mathrm{dM} \mathrm{m}$ odel, the tw o system s
share the feature that their velocity elds have no average bias in $x$. It would be interesting to determ ine whether at ${ }^{1=4}$ decay of the survivalprobability is characteristic of allsem i-in nite system $s w$ ith a zerom ean longitudinal velocity eld.

In the next section, we give a heuristic argum ent which suggests that $S(t) / t^{1=4} . W$ e then present corroborating num erical sim ulations in Sec. III. We also nd that the spatialprobability distribution of the surviving particles provides insight into the form ulation of a continuum equation of $m$ otion for the longitudinal probability distribution in an unbounded geom etry. T hus in Sec. IV , we infer this equation of $m$ otion and, from its solution, determ ine the correct asym ptotic longitudinal probability distribution in the unbounded geom etry. We conclude w ith a brief discussion in Sec. $V$.

## II. CONFIGURATION-AVERAGED SURVIVAL PROBABILITY

W e rst present our argum ent for the the time dependence of $S(t)$. The basic idea is that the dom inant contribution to this average arises from the subset of all velocity con gurations whose net bias is aw ay from the boundary, i. e., in the $+x$-direction. C onversely, con $g-$ urations w ith a bias along x w ill give individual contributions to $S(t)$ which decay exponentially in tim e and thus should be asym ptotically negligible.

To determ ine which of the positively-biased velocity con gurations give the dom inant contribution to $S(t)$, consider a discrete realization of the $M \mathrm{dM} \mathrm{m}$ odel on the square lattice in which the velocity is either $+\mathrm{v}_{0}$ or $\mathrm{v}_{0}$ w ith equalprobability for a given value ofy ( $F$ ig.1). Periodic boundary conditions in the transverse direction are em ployed, so that the system is a sem i-in nite cylinder consisting of w row s. For concreteness, the initial condition is $p(x ; y ; t=0)=\frac{1}{w} x ;$, i. e., a ring of particles is initially placed at $x={ }^{\text {w }}$, , where ' is the lattice spacing. In this system, the probability that there are $n_{+}$ positively biased row $s$ and $n$ negatively biased row $s$ is $P(m) / \frac{1}{\bar{w}} e^{m^{2}=w}$, with $m=n_{+} n$. In a timet, the num ber of layers visited by a random walk isw / $\mathrm{P} \overline{\mathrm{Dt}}=$, where D is the transverse ( $m$ icroscopic) di usivity. By transform ing from $m$ to the velocity $v=m v_{0}=w$, the distribution of velocities within w layers is

Because this distribution is strongly cut o when the argum ent of the exponential is greater than one, we expect that the dom inant contribution to $S(t) w i l l$ arise from those velocity con gurations whose net bias is w ithin the range $0<\mathrm{v}<\mathrm{V}_{0}\left({ }^{2}=\mathrm{D} t\right)^{1=4}$.

For a positively biased velocity con guration, we now estim ate the residualsurvivalprobability in the long time
lim it under the assum ption that $w$ is nite. In this case, the particle $w$ ill uniform ly sam ple the transverse extent of the system and it is sensible to characterize the bias by its $m$ ean value $v$. If $v$ is $s m a l l$, or $m$ ore properly the Peclet num ber $v x_{0}=D$ is $s m a l l$, then for $t<\beta=v^{2}$ the bias is irrelevant and consequently $S(t) \quad x_{0}=\overline{D t}$, where $x_{0}$ is the initial position of the particle [S]. H ow ever, for $t>D=v^{2}$, convection dom inates and retums to the origin becom e extrem ely unlikely. Hence $S(t)$ should \stick" at the value attained when $t=D=v^{2}$. $T$ his im plies that the asym ptotic behavior of the survival probability is sim ply, $S(t=1) / v_{0}=D$. This same result can also be obtained w th additionale ort from a m ore rigorous approach in which one solves the onedim ensionalconvection-di usion equation on the dom ain $x>0$ w th the initial condition $P(x ; t=0)=\left(\begin{array}{ll}x & x_{0}\end{array}\right)$ and then com putes $S(t)$ by integrating this probability density over all $x>0$.

For the M dM m odel, we now average over all relevant velocity con gurations to detem ine $S(t)$. That is

## III. NUMERICALSIMULATIONS

W e now present num ericalevidence to support the prediction that $S(t) / t^{1=4}$. Forsim ulating the particlem otion, we propagate the probability distribution for each velocity con guration exactly tion is de ned by the rule that in a single tim e step, a particle hops equiprobably by ' in the $y$-direction and by a distance sign $(v(y))$ ' in the $x$-direction on the square lattice, where $v(y)$ is the velocity eld at the $y$-coordinate of the particle before the hopping event ( $F$ ig.1). A ccordingly, the probability that a particle is at (x;y) at tim et evolves according to

For each velocity con guration, probability propagation yields the exact distribution in the presence of the absorbing boundary up to the $m$ axim um time speci ed.

W e have perform ed the average over velocity con gurations in two com plem entary ways $\{$ either an average over a representative sam ple of velocity con gurations, or an exhaustive average over all velocity con gurations for relatively $s m$ all system $s$. The form er is straightforward to implem ent, but the e ect of rare con gurations on the results is unknown. T he latter, on the other hand,
gives the exact result for an in nite system, albeit only for short tim es. This exactness allows one to test for system atic trends in the data, an analysis which is not feasible when averaging over a representative set of velocity con gurations.

A typical result for $S$ ( $t$ ) up to $t=4095$, based on an average over 50 velocity con gurations on a cylinder of width 400, is show n in Fig. 2. The average bias of these 50 con gurationstums out to be 0:004. Beyond approxim ately 50 tim e steps, the data for the survival probability is quite linear and a least-squares pow er law
$t$ to the data in this tim e range yields the exponent of $0: 2491$. Further, the slope betw een successive data points, or local exponent estim ate

deviates from $0: 25$ by less than 0.002 for $t^{>} 50$ (inset). To check that nite width e ects do not substantially a ect the results, we also considered shorter tim es, $t<1600$ and a slightly narrow er system ( $\mathrm{w}=300$ ), and averaged over 250 realizations. T he average bias of these con gurations tums out to be $+0: 002$. This case $y$ ielded a best $t$ exponent of $0: 2503$. These tw o data sets strongly suggest that $S(t) / t^{1=4}$ in the long tim $e$ lim it. H ow ever, because the average is perform ed only over an in nitesim al fraction of all velocity con gurations, it is possible that extrem econ gurations could alter the results. For this reason, we now investigate the exact behavior of $S(t)$ for short tim es by averaging over all velocity con gurations.

In this com plete enum eration, we consider odd values of $w$ for convenience. Because of the periodic transverse boundary conditions, $m$ any of the $2^{W}$ con gurations are identical up to cyclic perm utation and re ection sym $m$ etry. To carry out the enum eration, we rst encode each velocity con guration as a binary sequence. Using bit $m$ anipulation techniques, we identify the \irreducible" representation of this binary sequence, de ned as the sm allest equivalent integer num ber obtained by perform ing all possible cyclic perm utations of the in itial binary sequence. T his sam e procedure is then repeated on the reversed initial binary sequence. Thus to each binary sequence there is a unique irreducible binary sequence. By this mapping, we only need consider the irreducible con gurations and weight each by their degeneracy in perform ing the average over velocity con gurations. For exam ple for $w=23,25,27$, and 29 , the num ber of irreducible con gurations are $92,205,337,594,1,246863$, and $4,636,390$, com pared, e. g., to $2^{29}=536 ; 870 ; 912$. For each irreducible con guration, we then perform the exact probability distribution propagation. This com plete enum eration provides the exact value of $S(t)$ for an innite system up to w 1 time steps, while nite width crossover e ects gradually begin to play a role for later tim es.

W e therefore typically carried out the probability propagation for up to $t \quad 2 \mathrm{w}$ tim e steps and exploited the crossover in $S(t)$ to intenpret our results. A plot of in $S(t)$ versus int should initially show power law behavior, indicative of the in nite system behavior, and then cross
over to a non-zero constant because of nite width effects. Thus a plot of the local exponent $w(t)$ (here dened as the slope betw een every other data point) versus $1=$ t should initially provide an estim ate of the exponent of $S(t)$, while the crossovere ect determ ines the tim e range over which the exact data is relevant for the in nite system. In Fig. 3, this local slope, is plotted versus $1=\mathrm{t}$ for system widths w between 15 and 29. Initially, w ( t ) is decreasing nearly linearly in $1=t$, but subsequently there is the expected crossover to the asym ptotic value of zero. In the regin e where the data is relatively linear, we com pute the intercepts of successive data points at $1=t=0$ as an estim ate of the asym ptotic value of the exponent ( $F$ ig. 4). As w increases, this data exhibits: (i) nonm onotonic trends in the data (e. g., the location of the m inim um ) which disappear only for w 25 , (ii) $m$ ore stable extrapolated values as w increases, and (iii) the $m$ inim um value of the extrapolated exponent \{ which we adopt as the best estim ate of the exponent for a given value ofw $\{$ is increasing system atically in $w$ and appears to be converging to $0: 25$. W hile there is slow convergence to asym ptotic behavior which gives rise to considerable sub jectivity in analysis, we believe that the trends in the data support the hypothesis that $S(t) \quad t^{1=4}$.

> IV. THEPROBABILITY D ISTRIBUTION

In addition to investigating $S(t)$, we also exam ined the probability distribution of the surviving particles. This quantily provides an altemative understanding for the
rst-passage process, as well as usefiul fundam ental insights about the continuum desckiption of $M \mathrm{dM} \mathrm{model}$. Speci cally, we study P $(x ; t) \quad p(x ; y ; t) d y$, the con-
guration averaged longitudinal probability distribution of particles which have not yet been absorbed by tim e $t$. W e expect that this probability distribution can be w rilten in a scaling form

where hxi=hx(t)i is the average longitudinal displace$m$ ent of the survivors at tim e t. M onte C arlo sim ulations clearly indicate that hxi / $t^{3=4}$, as in the case when
 $\int_{0} P(x ; t) d x=S(t)$, we can determ ine the coe cient A by integrating Eq. (S) over $x$ and thereby write

where $F_{0}=\begin{gathered}R_{1} \\ 0\end{gathered} \mathrm{duf}(u)$. Because of the absorbing boundary, $P(x=0 ; t) m$ ust equal zero, leading to the expectation that $\mathrm{f}(\mathrm{u}) \mathrm{w}$ ill vanish as a power law as $u!0$. C onsequently, we w rite

w ith $\mathrm{g}(\mathrm{u})$ ! const: as $u$ ! 0 , and $g(u)$ vanishing faster than any power law for u! 1 .

A plot of the scaling function $f(u)$ versus $u$ is show $n$ in $F$ ig. 4 for $t=255,1023$, and 4095. There is a sm all but system atic variation in the data for di erent tim es, w ith the sm all-u behavior steepening and the large-u tail grow ing for larger tim e. Nevertheless, reasonable data collapse is obtained in which $\mathrm{f}(\mathrm{u})$ qualitatively exhibits the expected power-law and rapid cuto asym ptotic behaviors for sm all and large $u$, respectively. W e attribute the sm all deviation from scaling on slow convergence to the asym ptotic lim it (see below). Such a phenom enon was observed previously_in the probability distribution for an in nite system e ects can be anticipated here as well.

The exponent in Eq. $\left(\overline{7}_{1}\right)$ can be obtained by dem anding consistency betw een the tim e dependence of $(t)$ and that of the rst-passage probability. If $S(t) / t^{1=4}$, then from the general relation ['] between $S(t)$ and the
rst passage probability to the boundary, $F(t)$, we have $\frac{F(t)=d S(t)}{d t / t 5=4}$. On the other hand for a norm alized initial condition, the rst passage probability coincides with the

Since the $u x$ is obtained by perform ing an appropriate spatialderivative of this lim iting probability distribution, an operation which does not a ect the tem poralbehavior, we conclude that $=1=3$ to recover the correct t ${ }^{5=4}$ tim e dependence for the ux.

H ow ever, the data in Fig. 5 does not exhibit this behavior because of nite time ects. For sm all $u$, the num erical value of $g(u)$ at $x=1$ is non-zero but decreasing $w$ ith time. C orrespondingly, the value of $u$ at this rst data point is non-zero but also decreasing $w$ ith tim e. This anom aly in the sm all-u data renders a sim ple power law $t$ inadequate. H ow ever, such a naive $t$ to the data in the range $u<1=2$ gives the estim ates 0.483 , $0.479,0.476,0.470$, and 0.464 , respectively, for the exponent in $P(x ; t)$ for the 5 aforem entioned tim e values. O ther analyses, such as com puting the rst derivative of $f(u)$ (which should diverge as $u^{2=3}$ ) and determ ining the exponent of the sm all-u dependence, lead to a sim ilar quantitative conclusion. W hile the anticipated value
$=1=3$ is not obtained, we believe that better agreem ent w ith theory would em erge if it were practical to extend our $M$ onte C arlo sim ulations to $m$ uch longer tim es.

The existence of this pow er-law prefactor further suggests that in a continuum description, the con guration averaged ux can be obtained via

Such a scale-dependent di usivity can be heuristically justi ed by appealing to a Taylordi usion description of the $m$ otion in the $M d M \mathrm{~m}$ odel [did. In a time $t$, a particle typically explores w $\overline{\mathrm{D} t}$ transverse layers. The typicalbias $w$ ithin this num ber of layers is then proportional to $w^{1=2}$ or $(D t)^{1=4}$. Thus in a time scale $t$, the typical longitudinal distance travelled by a particle is $d v t / t^{3=4}$. Because these segm ents of length $d$ are random ly in the $+x$ or $x$ direction and the tim $e$ interval betw een segm ents is of order $t$, we infer an effective longitudinal di usion (or dispersion) coe cient $D_{j}{ }_{j}^{2}=t / t^{1=2} / x^{2=3}$, as w ritten in Eq. ( $\overline{1}_{1}^{\prime}$ ).

Let us now pursue the consequences of this scale dependent di usion coe cient for the longitudinalm otion. If the longitudinal ux $j(x ; t)$ is indeed proportional to

W e can easily solve this equation by applying scaling. A ssum ing that $P(x ; t) / t^{3=4} h\left(x=t^{3=4}\right)$, we rew rite the partialderivatives in $x$ and $t$ in term $s$ ofa derivative $w$ ith respect to $u \quad x=t^{3=4}$, to recast the equation of $m$ otion as

$H$ ere the prim e denotes di erentiation $w$ ith respect to $u$. O ne integration im $m$ ediately yields

$T$ he constant of integration equals zero because $h(u)!0$ faster than any power law as u! 1 . A second integration then gives $h(u) / \exp \left(u^{4=3}\right)$, from which we conclude that the longitudinal probability distribution has the form

$T$ his functional form coincides $w$ th that obtained previ-
 contribution to the large-u tail ofP ( $x ; t$ ) arises from extrem e \stretched" trajectories in unlikely velocity congurations. Thus the observation of the large-u tail for $P(x ; t)$ from the num ericaldata in $F$ ig. 5 can again be anticipated to be problem atical; m uch m ore extensive sim ulation would be needed.
V.D ISC U SSIO N

W e have investigated the tim e dependence of the conguration averaged survival probability, $S(t)$, in a sem iin nite two-dim ensional system for di using particles which are also driven by a unidirectional random zero$m$ ean velocity eld, $v(y)$. A qualitative argum ent suggests that $S(t) / t^{1=4}$, a prediction which is in excellent agreem ent $w$ ith num erical results. $W$ e also exam ined the longitudinalspatialprobability density of the surviving particles, $P(x ; t)$. Interestingly, although the num ericalevidence supporting the prediction that $S(t) / t^{1=4}$ is strong, the num erical data for $P(x ; t)$ indicates slow convergence to the scaling lim it and som e inconsistency $w$ ith the behavior of $S(t)$ itself. Sim ilar anom alies in the probability distribution occur in the unbounded geom etry $[\underline{[ }[4]$
con gurations in the average. It is surprising that the behavior of $S(t)$ is apparently relatively insensitive to the contribution of such extrem econ gurations.

An interesting byproduct of the spatialdistribution of the surviving particles is that the form $\frac{@ P(x ; t)}{@ x^{1=3}}$ is suggested as the appropriate expression for the particle ux. $T$ his leads to a scale dependent di usion coe cient which is proportion to $x^{2=3}$, as well as the continuum equation ofm otion, Eq. (111), for the longitudinal spatial probability distribution in an unbounded geom etry. The solution to this equation ofm otion is sim ple to obtain and reproduces the known asymptotic form of $P(x ; t)$ in the unbounded geom etry R'\{ [14']. A s an application of this equation ofm otion, we nd new predictions for steady-state transport properties. For exam ple, for a steady input of particles at $\mathrm{x}=\mathrm{L}$ and particle absonption at $\mathrm{x}=0$, the steady solution to Eq. (111) gives a con guration-averaged density pro le which varies as $x^{1=3}$. It w illbe worthw hile to test this prediction and also the general prescription for obtaining an e ective equation ofm otion from the behavior of the particle ux near an absorbing boundary.
$F$ inally, the behavior of $S(t)$ for a sem i-in nite system w ith a longitudinalM dM velocity eld can be easily generalized to arbitrary spatial dim ension d. From classical results $\left.{ }_{[1]}^{1}\right]$, the num ber of distinct longitudinal row s vistited by a random walk in time varies as $t^{(d)} 1{ }^{1)=2}$ for dim ension $2<d<3$ (i. e., transverse spatial dim ension betw een 1 and 2 ), as $t=\ln t$ for $d=3$, and as $t$ for $d>3$. Follow ing closely the approach in Sec. II, this then leads to
