# The periodic Anderson model with correlated conduction electrons

We investigate a periodic Anderson model with interacting conduction electrons which are described by a Hubbard-type interaction of strength  $U_c$ . Within dynamical mean-eld theory the total H am iltonian is mapped onto an in purity model, which is solved by an extended non-crossing approximation. We consider the particle-hole symmetric case at half-lling. Similar to the case  $U_c = 0$ , the low-energy behavior of the conduction electrons at high temperatures is essentially una ected by the f electrons and for small  $U_c$  a quasiparticle peak corresponding to the Hubbard model evolves rst. These quasiparticles screen the f moments when the temperature is reduced further, and the system turns into an insulator with a tiny gap and at bands. The formation of the quasiparticle peak is impeded by increasing either  $U_c$  or the c-f hybridization. Nevertheless alm ost dispersionless bands emerge at low temperature with an increased gap, even in the case of initially insulating host electrons. The size of the gap in the one-particle spectral density at low temperatures provides an estimate for the low-energy scale and increases as  $U_c$  increases.

#### I. IN TRODUCTION

The usual explanation for the formation of heavy ferm ions in compounds with rare-earth or actinide elem ents is based on the K ondo e  $ect^{1,2}$ . Thereby, the characteristic low-energy scale arises from the spin-screening of the local moments by a non-interacting electron gas. The periodic Anderson model is considered as the most promising candidate to at least qualitatively describe the rich physics of these materials. This standard scenario, how ever, fails to explain the heavy-ferm ion behavior found in the electron-doped cuprate  $Nd_2 \times Ce_x CuO_4$ discovered a few years ago.<sup>3</sup> In particular, the estim ated low -energy scale is orders of m agnitude too sm all.4 Since undoped Nd<sub>2</sub>CuO<sub>4</sub> is an antiferrom agnetic chargetransfer insulator<sup>5;6</sup> despite of one hole per unit cell, it has been suggested<sup>4</sup> that this discrepancy is due to the strong interactions among the electrons introduced by doping.

As regards the in uence of correlated conduction electrons on the K ondo e ect, up to now attention has been focused on the case of a magnetic in purity embedded in a correlated host which is either described by a Luttinger liquid in one dimension<sup>7</sup><sup>9</sup> or by some kind of H ubbard m odel in higher dimensions.<sup>10</sup><sup>15</sup> In all of these cases one nds a strong dependence of the low energy scale on the interaction strength of the conduction electrons and its increase with increasing interaction strength. For a lattice of m oments hybridizing with correlated electrons only few results exist.<sup>16;17</sup>

As a rst step towards understanding the e ect of conduction electron interactions on the formation of heavy ferm ions, we consider a lattice of f-electrons that hybridize with conduction electrons which them selves are correlated. These correlations will be described by a Hubbard-type interaction. The resulting m odel com bines a periodic Anderson m odel with a Hubbard m odel. A lim it in which one may obtain sensible results for this locally highly correlated m odel is the lim it of large spatial dim ensions.<sup>18 {20</sup> In this lim it the dynam ics becomes essentially bcal.<sup>19</sup> Hence for any correlated m odel, a single (correlated) site may be chosen and em bedded in an e ective m edium which has to be determ ined self-consistently (\dynam ical m ean- eld theory"): The m odel reduces to an Anderson in purity m odel.<sup>21 {23</sup> In fact, in has been show n that besides the H ubbard m odel<sup>21,24,22,25</sup> the periodic A nderson m odel with uncorrelated conduction electrons is am enable to this lim it.<sup>26 {29</sup>

In the next section we introduce the model and derive the corresponding in purity model. The in purity model is solved numerically by an extended non-crossing approximation<sup>30 {33</sup></sup> which is derived in Sec. II as well. In Sec. III we present results for the particle-hole symmetric case at half lling. A ssuming a paramagnetic ground state we study the in uence of weak correlations on the one-particle spectral density and discuss how the heavy bands emerge. At low temperatures a gap forms which in the free case is related to the K ondo temperature<sup>28</sup> and we discuss how the size of the gap depends on the strength of the correlations of the conduction electrons. We nally conclude in Sec. IV.

#### II.M ODEL AND METHOD

#### A. The lattice H am iltonian

In the following we consider the simplest version of the periodic Anderson model and allow for interacting conduction electrons,

Here,  $f_i^{(y)}$  destroys (creates) an electron in the localized f orbital at site i with spin  $\,$ , and  $U_f$  is the Hubbard interaction of the localized f states ( $_f < 0$ ). The coperators refer to the conduction electrons which are described by a Hubbard model with an interaction  $U_c$  being typically smaller than  $U_f$ . denotes the chemical potential and V measures the mixing between the c and f subsystem s. In the following we will refer to the Ham iltonian (1) as  $\$ 

In what follows we will concentrate on the one-particle spectra in a param agnetic phase. Information on the underlying lattice will enter the dynamical mean-eld equations only via the density of states of the conduction electrons.<sup>20</sup> For simplicity, we therefore consider a sem inircular density of conduction electrons states with width 2D in Eq. (2)

which arises from hopping on a Bethe-lattice of coordination number Z with matrix element  $t = D = (2 \ Z)$  in the limit Z ! 1. We will use D = 1 as unit of energy throughout this paper.

G iven the non-interacting G reen's functions,  $G_0(k;z)$ ,

# B. The impurity model

The dynam icalm ean- eld theory assumes that the selfenergy is a local quantity which is correct in the lim it of in nite dimensions.<sup>18;19;24;20</sup> The lattice model can then be mapped onto an impurity model<sup>20</sup> which is seen as follows: The self energy (8) of the lattice model (1) is given as the derivative of a functional [G] of the full G reen's functions:<sup>34</sup>

Here, i and j are real space coordinates and ; correspond to c and f. If the self-energy of the lattice m odel is local, depends on the local G reen's functions, G (i; i), only. Thus, can be generated from an impurity m odel. Solving the impurity m odel we know and, hence, the self-energy as functional of the impurity G reen's function G: [G] = = G.W e now identify G with the local G reen's function of the lattice,

Note that the k-dependence enters only via  $_{\rm k}$  into G (k;z), thus G  $_{\rm loc}$  (z) can be expressed by an energy integration. From G  $_{\rm loc}$  = G, we define the actual value of from the functional equation

Technically, Eq. (11) determ ines the free G reen's function of the impurity model which is of course not xed by

The Ham iltonian of the impurity model that generates is not unique. Since is the same for both impurity and lattice model, they have the same diagram matic expansion. We therefore embed a single unit cell (a \cf molecule") as impurity (H<sub>loc</sub>) in an elective medium (H<sub>med</sub>) which will be determined self-consistently:

(Formally one can consider the action of the lattice m odel and integrate out the non-local part to arrive at an impurity action which is afterwards modelled by an Ham iltonian.<sup>20</sup>) Note that this choice for the impurity modeldi ers qualitatively from the usual one for the periodic Anderson model at  $U_c = 0.23;26;27$  In the case of free conduction electrons, only a single self energy exists (for the f-electrons) and, hence, only the f-orbital is coupled to an e ective medium. When the conduction electrons are correlated they have a self energy, as well. Therefore, we include a c-orbital in the local part of H  $_{imp}$ . We need only a single e ective medium, H<sub>m ed</sub>, although there are two Hubbard interactions in the originalHam iltonian (1). This is due to the absence of direct f-f hopping: The electrons explore their environment only via the c-orbitals. The two interactions merely show up in the internal structure of the impurity which consists of two orbitals, one of which couples to the medium .

This situation is similar to the one encountered in the extended Hubbard model in R ef. 35.

We show now that the self-consistency equation (11) can be full led by our impurity model (12). The impurity G reen's functions

Equating G to the local G reen's function G  $_{\rm loc}$  of the lattice m odel (10), which one obtains analytically due to the density of states (5), and using that both,  $\sim$  (z) and G (z) 1=z at large jzj we nd:

The medium is determined by the c-G reen's function only, relating that there is no direct f-f hopping.

The parameters in the impurity model (12) is thus xed, in particular the medium  $\sim$  (z) is determined by the solution of the impurity model  $G_c(z) = G_{loc;c}(z)$ .

#### C.Solving the impurity model

We solve the impurity model (12) by extending the non-crossing approximation (NCA)<sup>30;31</sup> to the case of more than two ionic propagators.<sup>32;33</sup> This approach has been applied successfully to the nite-U impurity Anderson model<sup>32</sup> where it has been shown that neglecting vertex corrections slightly underestimates the K ondo tem - perature, and to the Emery model within the dynamical mean-eld theory<sup>33</sup>

Denoting the eigenstates of the local part, H  $_{\rm loc}$  by jn i (with  $n_m = 0$ :::4 particles), the impurity H am iltonian (12) is expressed in terms of H ubbard operators  $X_{mn} = jn$  ilm jas

In the sym m etric, half- led case there are only 6 independent propagators due to particle-hole and spin sym – m etry. The coupled integral equations (23) and (24) are solved num erically by introducing defect propagators<sup>36</sup> and m aking use of the fast Fourier transform ation.<sup>33</sup>

## III. R E SU LT S

In the following we consider the symmetric model ( $_{c} = U_{c}=2$ ,  $_{f} = U_{f}=2$ ) at half-lling ( $n_{c} + n_{f} = 2$ ). Due to particle-hole symmetry the chemical potential is 0.

We chose  $U_f = 5$  in all our calculations so that the f-level is well outside of the conduction band. Our investigations were restricted mostly to those values of  $U_c$  for which the Hubbard model for the conduction electrons is metallic (for the sem ielliptic density of states (5) we found  $U_{\rm crit}$  1.8). The reason is that in deriving the self-consistency equations for the impurity model we assumed a paramagnetic state. Thus we typically chose  $U_c = 0.5:::2.0$  and V = 0:1:::0.4. These values lead to

sm all exchange couplings J 0.01:::0.2 between twoparticle singlet and triplet state of the c-f m olecule (see below). We deliberately chose these sm all values for V in order to obtain \K ondo tem peratures" which are sm all com pared to the bare band-width, see Table I.

#### A.Single-particle spectrum of the molecule

The following discussions focus on the one-particle spectral function. It is instructive to investigate this quantity rst for the local problem given by  $\rm H_{loc}$  in Eq. (12) in the symmetric case. Due to symmetry, we consider the photoem ission spectrum only. Denoting the eigenstates and eigenenergies of H  $_{\rm loc}$  by jn i and E $_{\rm m}$ , the one-particle G reen's function and spectral function are given by ( = 0)

At zero temperature only the ground state contributes to the sum over m . It contains two electrons forming a singlet

The photoem ission spectrum is obtained by removing a particle, hence the nalstates are bonding and antibonding combination of the c- and f-orbital. To low est order in V the transition energies are given by

They correspond to the lower Hubbard bands of the c- and f-subsystem which are shifted by the hybridization  ${\rm V}$  .

The rst excited state is the two-electron triplet state (spin excitation)

At the tem peratures that we investigate in the following (T = 0.5 0.001) only these two states contribute as initial states, in i. The resulting photoem ission spectrum of the m olecule thus consists of two double peaks at  $z_c$ ,  $z_c + E$ , and  $z_f$ ,  $z_f + E$  and the weight of the peaks shifted by E goes to 0 as T ! 0.

# B.Single-particle spectrum of the Anderson-Hubbard model

We rst consider the spectral density of the conduction electrons




FIG .1. Spectral density  $A_c(z)$  for  $U_c = 1, V = 0.2, U_f = 5$  at di erent tem peratures




FIG .2. Spectral weight of the conduction electrons at the chem ical potential,  $A_c$  (0), for  $U_c$  = 1 vs. tem perature

which corresponds to photoem ission and inverse photoem ission spectra. A typical result for  $A_c(z)$  is shown in Fig. 1 for di erent tem peratures ( $U_c = 1, V = 0.2$ ). At high tem peratures (T = 0.5) we obtain two broad m ax- $U_c=2$  which correspond to upper and in a located at lower Hubbard band of the c-subsystem . W hen lowering the tem perature (T . 0:1), a peak at the chem ical potential (z = 0) arises. This is the well-known quasiparticle peak belonging to the Hubbard model of the host electrons,  $H_{c}$ .<sup>22;24;25</sup> In this temperature regime the fand c-subsystem s are alm ost independent. The in uence of the f-states on the c-spectra is given only by the tiny  $U_f = 2 = 2:5$ . The separation of the structure at z two subsystems is indicated in Fig. 2 as well where we com pare the spectral weight at the chem ical potential for di erent values of the c-f hybridization V and the pure c-Hubbard model (V = 0): At high to moderate tem peratures the spectral weight of the Anderson-Hubbard m odel follows the one of the pure Hubbard m odel.

In Fig. 2 we also see that this behavior does not extend to low temperatures. At a certain temperature, which depends on V, the spectral weight no longer follows the quasiparticle peak of the Hubbard model but

drops to zero. A s seen in Fig. 1 indeed a gap occurs and sharp structures emerge close to the chemical potential when the tem perature falls below T . 0.04. This resem – bles the Anderson model with uncorrelated conduction electrons.<sup>28</sup> There, at T < T<sub>0</sub> where T<sub>0</sub> is a characteristic temperature related to the K ondo temperature, the K ondo e ect leads to a resonance at the chemical potential. These dynamically generated local states cross the conduction band with a gap at the position of the resonance. Due to particle-hole symmetry, this feature occurs at the chemical potential and the system becomes an insulator.<sup>39</sup>

A similar behavior is found in the case of interacting conduction electrons. In order to see that indeed at bands occur close to the chemical potential we inspect the k-dependent spectral function








FIG.3. Spectral function  $A_c(k;z)$  for  $U_c = 1, V = 0.2$  and di erent values of (k).a. T = 0.3, b. T = 0.05, c. T = 0.005

Since  $A_c(k;z)$  depends on k only via k, we plot  $A_c(k;z)$  for dierent  $_k = 1:::1$  in Fig.3. A thigh temperatures (T = 0:3, Fig.3a.) the features are very broad and we basically see the Hubbard bands for the c-subsystem at

 $U_c=2$  as well as for the f-subsystem at  $U_f=2$  which weakly adm ix to the c spectra. At interm ediate tem peratures (T = 0:1:::0:02, T = 0:05 is shown in Fig. 3b.) spectralweight is found at the chem ical potential as well and we may trace the quasiparticle band of the Hubbard model. W hen the tem perature is decreased below 0.015 (T = 0:005, Fig. 3c.) these peaks split, a sm all gap opens and the newly emerged peaks show a weak dispersion at the chem ical potential. The transition occurs rather quickly: W hereas at T = 0.015 only the peak at k = 0 is split and the band follows the quasiparticle band of the Hubbard band elsewhere, two separated bands already em erged at T = 0.01. Due to their weak dispersion at the chem ical potential we expect that they will lead to heavy bands upon doping. At higher energies these new bands merge in the previous quasiparticle bands of the Hubbard model.

These ndings t qualitatively to the scenario of the Anderson m odel with uncorrelated conduction electrons described above<sup>28</sup> and to the results of the slaved-boson m ean- eld treatm ent.<sup>40</sup> In the latter, the free conduction bands hybridize with a strongly renorm alized (reduced) coupling to an e ective f-level at the chem ical potential. This leads to weakly dispersive bands at low energies m erging in the original bands at high energies. In the Anderson-Hubbard m odel the new bands m erge in the form er quasiparticle band of the c-Hubbard m odel at high energies. We conclude that these quasiparticles take




FIG.4. Spectral density  $A_{\circ}(z)$  for  $U_{\circ} = 1.5$ , V = 0.2,  $U_{f} = 5$  at di erent tem peratures

the role of the free conduction electrons in the dynam ical screening of the f-m om ents leading to the resonance at the chem ical potential. This interpretation does not contradict previous results on a single in purity embedded in a correlated host.<sup>14</sup> There it turned out that a variational ansatz in the spirit of Varm a and Yafet<sup>41</sup> which uses quasiparticles for the screening of the f-m om ent instead of bare electrons is not su cient to nd the correct K ondo tem perature. This holds due to im portance of the renorm alization of the c-f exchange interaction and does not im ply that the quasiparticle picture is not valid in describing the screening process.

W hen the interaction strength of the conduction electrons is increased to  $U_c = 1.5$ , no qualitative changes occur at rst sight. In Fig. 4 we show the c-spectra at various tem peratures for  $U_c = 1.5$  and V = 0.2. Again, the c- and f-subsystem are separated at high tem peratures and a quasiparticle peak of the c-H ubbard m odel evolves rst. At low tem peratures a K ondo resonance is form ed at the chem ical potential with hybridizes with the quasiparticle band, a gap opens and we ind bands with a weak dispersion. When compared to  $U_c = 1$ , we

nd that the gap has increased. This indicates that the hybridization of the quasiparticle band with the dynam - ically generated states has increased.




FIG.5. Spectral density  $A_{\circ}(z)$  for  $U_{\circ} = 1.5$ , V = 0.3,  $U_{f} = 5$  at di erent tem peratures

However, as demonstrated in Fig. 5, a quasiparticle peak does not always occur in the intermediate temper-




FIG.6. Spectral weight of the conduction electrons at the chem ical potential,  $A_{\circ}(0)$ , for  $U_{\circ} = 1.5$  vs. tem perature

ature range even though the bare conduction electrons are metallic: Increasing the c-f mixing to V = 0.3, the system becomes directly insulating although  $U_c = 1.5 < U_{crit}$ . Figure 6 illustrates that it depends on the value of V whether the quasiparticle peak shows up or not. We conclude that part of the strong correlation on the f-orbital is e ectively inherited by the c-orbital via the hybridization V.A similar e ect has been observed and discussed for a di erent model in Ref. 42.




FIG.7. Comparison of the spectral function  $A_c(k;z)$  of the Anderson-Hubbard model ( $U_c = 1.5, V = 0.2$ , solid lines) to the Hubbard model ( $U_c = 1.5$ , dashed lines, multiplied by 1) at a. T = 0.07 and b. T = 0.04.

A though no quasiparticle peak corresponding to the conduction electrons em erges in Fig. 5, we still recover the Anderson scenario described above when decreasing the tem perature, i.e., a gap opens and peaks arise close to it at low tem peratures T 0:04. It appears that we do not need pre-form ed quasiparticles in order to screen the f-m om ents which in turn leads to the K ondo resonance. Note how ever, that there is nite spectral weight at the chem ical potential. This is better seen in the kresolved spectral function  $A_{c}(k;z)$  in Fig. 7 where we display Ac(k;z) for two di erent tem peratures for the And erson-Hubbard ( $U_c = 1:5; V = 0:3$ ) and the Hubbard model (U = 1:5). For the Hubbard model we nd a peak crossing the chemical potential at T = 0.07 (Fig. 7a.). It corresponds to the quasiparticle peak of the Hubbard m odelbeing form ed at this tem perature. The Anderson-Hubbard model, however, exhibits no structure crossing the chem ical potential. Note that upper and low er Hub-

bard bands of the Anderson-Hubbard model are in agreem entwith those of the pure Hubbard model. At T = 0.04(Fig. 7b.) the Anderson-Hubbard model shows two at bands at the chemical potential. The peaks are most pronounced close to chem ical potential. In contrast to the case of sm all  $U_c$  ( $U_c = 1$  discussed above) the corresponding bands do not merge the quasiparticle band of the Hubbard model. This indicates a large e ective hybridization between quasiparticle and dynam ically generated states at the chem ical potential. To a lesser degree this behavior is also observed for  $U_c = 1.5$  and V = 0.2 $(A_c(k;z))$  not show n). We conclude that the e ective hybridization increases as both U<sub>c</sub> and V increase. Considering again Fig. 7a., we nd that the di erence between Hubbard and Anderson-Hubbard modelat high tem peratures is related to the onset of the heavy bands which are thus already seen at com paratively high tem peratures.




FIG.8. Spectral density  $A_c(z)$  for  $U_c = 2$ , V = 0.3,  $U_f = 5$




FIG.9. Comparison of the c spectral function  $A_c(k;z)$  of the Anderson-Hubbard m odel ( $U_c = 2, V = 0.3, U_f = 5$ , solid lines) to the Hubbard m odel ( $U_c = 2$ , dashed lines, multiplied by 1) at T = 0.065

We nally turn to the case where the bare c-subsystem is insulating, i.e.,  $U_c > U_{crit}$ . For  $U_c = 2$  a shoulder in the spectral function emerges at the edge Hubbard band towards the chemical potential when the tem perature is lowered (Fig. 8). That this feature is indeed caused by the f-subsystem is demonstrated in Fig. 9 where we compare  $A_c(k;z)$  for the Anderson-Hubbard m odel and the pure Hubbard m odel. W hereas the structures corresponding to the H ubbard bands roughly agree, the Anderson-Hubbard model shows an additional peak at the low -energy edge of the Hubbard bands. This is unexpected because the c-subsystem is insulating and provides no quasiparticles which could screen the f-m om ent and the resulting spectra should resemble the one of the c-f molecule described in Sec. IIIA. W e do not believe that this shoulder is spurious since increasing the energy resolution which allows to proceed to lower tem peratures did not change the shoulder. However, we can not exclude a principle failure of the extended NCA as it is well-known that the NCA fails to converge when the system becomes insulating.<sup>43</sup> On the other hand, the spectralweight at the chem ical potential is not exactly zero.

Similar to the case  $U_c = 1.5$ , V = 0.3 discussed above, this small, but nite spectral weight could be su cient to dynam ically generate states at the chem ical potential which result in a heavy band via hybridization as previously. To clarify this situation, it is mandatory to employ other num ericalm ethods for solving the impurity model. If the picture presented above is valid, the elective hybridization must be large compared to the metallic cases so that the new bands are pushed tow ands the Hubbard bands. Note that the new peaks approach, but not m erge in the Hubbard bands whereas they m erged in the quasiparticle bands in the metallic cases ( $U_c = 1$ , and  $U_c = 1.5$ , V . 0.2).

#### C.Hybridization gap




FIG.10. G ap in the spectral density vs.tem perature. The gaps are obtained from the two maxim a in  $A_c(z)$  for  $U_c = 1$  and di erent hybridizations V

In this section we focus on the gap which opens at low tem peratures. We determ ine the size of the gap, , as twice the distance between zero frequency and the rst maximum close to the chemical potential.<sup>28</sup> In Fig. 10, where we plot the gap vs. tem perature for di erent hybridizations V, we observe that the gap opens quickly when the tem perature is reduced and we de ne  $T_0$  as the tem perature where the gap opens. One expects that  $T_0$  is related to the energy di erence, E, of singlet and triplet states in the local problem, see Sec. IIIA. Indeed, we observe in Figs. 4 and 5 that the gap opens




FIG .11. Splitting of the f peak in the m olecule and lattice, and  $T_0 \ vs. U_c \ at V = 0.3$ 

roughly in the same temperature regime where the fpeak at z  $U_f=2$  splits, i.e., where the states j si and j T i become distinguishable in the photoem ission of the lattice. We extract this splitting of the f-peak,  $E_{lat}$ from the spectral function of the lattice model (if visible) and compare it to the corresponding splitting,  $E_{loc}$  for the c f molecule [cf. Eq. (35)] in Fig. 11 for di erent values of U<sub>c</sub> and V = 0:3. Surprisingly we nd that while both splittings are of the same order of magnitude, they depend di erently on U<sub>c</sub>: When U<sub>c</sub> increases,  $E_{lat}$  increases, whereas  $E_{loc}$  decreases.




FIG.12. G ap in the spectral density vs.tem perature. The gaps are obtained from the two maxim a in  $A_c(z)$  for di erent interaction strength  $U_c$  and a. V = 0.2 and b. V = 0.3

In Fig.12 we plot the gap vs.tem perature for di erent values of  $U_c$  and V = 0.2; 0.3. In general, the tem perature  $T_0$  at which the gap sets in increases with  $U_c$ , but deviations occur: W hen V = 0.3,  $U_c = 1.5$  and 1.7 do not t into this scheme. However, one should bear in m ind that the onset of the gap form ation as we measure it, depends also on the shape of the spectrum. As is seen from Fig. 11,  $T_0$  is of the same order of magnitude as  $E_{lat}$  and its general behavior agrees with  $E_{lat}$  and is thus opposed to  $E_{loc}$ .




FIG.13. Gap in the spectral density vs.  $U_{\,\rm c}.$  The gaps correspond to the lowest temperatures reached.

W e now turn to the size of the gap. It has been shown for the Anderson model with free conduction electrons that this quantity determ ines the low -tem perature thermodynamics in the limit of in nite dimensions.  $^{44;45;28}$ The gaps in the local spin and charge excitation spectra were found to be of the sam e order of m agnitude as the gap in the density of states. The latter thus provides a measure of the low-tem perature scale (\K ondo tem perature"). From Fig. 12 we extract that the size of the gap has not yet converged at the low est tem peratures where our extended NCA ceases to converge. Nevertheless, we can draw some qualitative conclusions: The size of the gap increases system atically as U<sub>c</sub> increases. This is also deduced from Fig. 13 where we plotted the gap at the lowest tem perature we could reach for each pair  $(U_c; V)$ vs. the strength Uc of the Hubbard interaction of the conduction electrons. This procedure in plies that the points shown correspond to di erent tem peratures. Note that

the magnitude of  $$varies\,m$  uch stronger with U  $_{\rm c}$  and V compared to T  $_0$  or ~E .

# IV.CONCLUSIONS

In conclusion, we studied the in uence of interactions am ong the conduction electrons on the low-tem perature behavior of the periodic Anderson m odel. In the dynam – icalm ean- eld theory the m odel is m apped onto a generalized Anderson in purity m odel that couples the orbitals of a single unit cell to an e ective m edium which has to be determ ined self consistently. The im purity m odel w as solved num erically by an extended non-crossing approxim ation.

For weakly interacting conduction electrons we found that at high tem peratures the c-and f-subsystem s are alm ost separated as in the case of free conduction electrons. Decreasing tem perature then st leads to the form ation of quasiparticles in the c-subsystem as in the bare Hubbard model. W hen the tem perature is reduced further, the quasiparticle band splits, a tiny gap opens and the system turns into an insulator. As in the case of free conduction electrons, the gap is form ed by the level crossing of the quasiparticle (Hubbard) band and the resonance which arises at the chem ical potential from the Kondolike screening of the f-m om ents. W e observed that the quasiparticles play an essential role in this screening. The resulting two bands have a weak dispersion close to the gap and we expect that they turn into heavy bands upon doping.

W hen the correlations of the conduction electrons become stronger, the low-tem perature gap increases. This can be interpreted as increasing the elective hybridization between the quasiparticle states at the chem icalpotential and the dynam ically generated states which leads to a larger gap and is qualitatively in agreem ent with results found for in purity models. For the latter case, the main elect of the (sm all) interaction was to renorm alize and increase the exchange interaction.<sup>14</sup>

It turned out, how ever, that pre-form ed quasiparticles within the c-subsystem are not prerequisite for the em ergence of heavy bands. When increasing the c-f hybridization, the c orbitals seem to inherit correlations from the f orbitals and a quasiparticle peak is no longer form ed in the spectral density at interm ediate tem peratures, although the spectral weight at the chem ical potential does not vanish. N evertheless, we observed heavy bands at low tem peratures in the one-particle spectra.

E ven when the (bare) c-system is insulating, it is in uenced by the f-system at low temperatures: A shoulder form s at the edge of the H ubbard band which show sweak dispersion. This is surprising since the bare c-system provides no quasiparticles which could screen the f-m om ents and the c spectral weight close to the chem ical potential is sm all. H ow ever, we can not exclude that this result is an artefact of ourm ethod to solve the im purity problem and further investigations are necessary to decide upon this question.

Finally, we investigated the hybridization gap which occurs at low temperatures. When increasing the C oulom b interaction among the conduction electrons the temperature at which the gap opens increases. This temperature is related to the splitting of the f-peak in the spectrum which results from singlet and triplet states in the c-f m olecule. However, we found that this splitting depends oppositely on the interaction strength in the lattice and in the molecule. The low-temperature therm odynamics in in nite dimensions scales with the size of the gap.<sup>28</sup> This quantity therefore provides a measure for the \K ondo temperature." In agreement with impurity m odels, this gap increases as the correlations among the conduction electrons become stronger.
