# Variational approach to interfaces in random media: negative variances and replica sym metry breaking

A Gaussian variational approximation is often used to study interfaces in random media. By considering the 1+1 dimensional directed polymer in a random medium, it is shown here that the variational Ansatz typically leads to a negative variance of the free energy. The situation improves by taking into account more and more steps of replica symmetry breaking. For in nite order breaking the variance is zero (i.e. subextensive).

This situation is rem in iscent of the negative entropies in m ean eld spin glass m odels, which were also elim in ated by considering in nite order replica sym m etry breaking.

The subject of interfaces in random media has many application, such as directed polymers in a random medium, domain walls is dirty magnets, and interfaces in random sponges. Various aspects of this eld and methods of approach have been reviewed, see [1], [2], [3].

As a tool to get a grip on these complicated objects, a Gaussian variational Ansatz has been proposed by Mezard and Parisi [4] to calculate the free energy. It was found that replica symmetry is broken spontaneously. This variational replica-approach reproduces the Flory values for critical exponents, that can be derived by Flory-Imry-Matype of estimates.

In the approach an in nity (k = 1) of replica symmetry breakings occur. Carlucci, de D om inicis and Tem esvarihave shown that the instability of the replica approach at nite k disappear in the  $\lim it k! 1.[5]$ 

The problem of a directed polymer on a random substrate in d=1+1 has received quite some attention. It was pointed out by K ardar [6] that the replicated free energy can be related to the ground state energy of n interacting bosons in one dimension. This problem can be solved exactly by means of the Bethe Ansatz. The depinning of such a polymer or interface from a wall is also solvable exactly, when the elect of the wall potential is described by a derivative condition of the wavefunction at the wall. Various interesting results have been derived from the exact groundstate wavefunction near the depinning transition.

Here we reconsider the d=1+1 problem of a directed polymer of length L in a random potential. The purpose is not to derive the best variational approximation to the exact solution. Having in m ind more complicated models, we wish to test a particular aspect of the variational approach of Mezard and Parisi, that we fully work out for this situation. Due to the one-dimensional character of the problem, we can get the results by studying a quantum Hamiltonian.

In particular we point out that order  $n^2L$  terms of the n-fold replicated free energy  $F_n$  tend to have the wrong sign, so that they tend to predict a negative variance of the physical free energy. This unphysical prediction occurs in case of no replica symmetry breaking and becomes less severe for a nite number of breakings; it seems related to the instability of some uctuation modes. The whole  $n^2L$  term disappears if in nite order replica symmetry breaking is taken into account. The negative variance of the free energy thus plays a role similar to the negative entropy of the SK-model: both vanish only when in nite replica symmetry breaking is taken into account.

The implication of vanishing of the  $n^2L$  term is that the uctuations in the free energy are smaller than  $L^{1=2}$ . We shall then show that the replicated free energy has leading correction  $n^5L$ , which means that the free energy uctuations are of predicted to be of order  $L^{1=5}$ . This is in agreement with the Flory prediction worked out by Mezard and Parisi. Note that the exact order of magnitude is known to be  $L^{1=3}$ .

In section 1 we introduce the model and the variational Ansatz. The simplest cases are considered. In section 2 the problem is solved for in nite order replica symmertry breaking. We close with a summary in section 3.

### I. THE MODEL AND THE VARIATIONAL APPROACH

W e consider an interface z (x) with H am iltonian

where the overline denotes the average over the quenched disorder. We shall study the partition sum

generates the cumulants of F as the expansion coe cients of  $F_n$  for small n. For having a non-negative variance of F the  $n^2$  term of  $F_n$  should be non-positive.

A veraging over disorder one obtains the e ective n-particle H am iltonian

By analog with the Feynman-Kac path integral formulation of quantum mechanics, the replicated free energy can be obtained as

The present problem has an exact ground state wavefunction

To our know ledge, the variational approach to this problem was rst formulated by Honeycutt and Thirum alai [7]. They considered a Hartree variational interface Ham itonian, that we generalize as

The original approach had q = q. The generalized approach is equivalent with the one of M ezard and P arisi, though it is simpler. Indeed, the mapping onto a quantum problem, which can only be done in d = 1 + 1, prevents the introduction of a Fourier wavenum ber.

The variational Hamiltonian is equivalent with considering the Hartree variational quantum Hamiltonian

The exact value would correspond to  $E_n = (n n^3) = 3$ . We shall now consider various choices for the shape of q.

A.D iagonal q

The case  $q = q_i$ ; was studied by Honeycutt and Thirum alai. Optim izing  $E_n$  yields  $q_i = (n - 1)^2$ , so that

which diers in sign from the Honeycutt-Thirum alairesult. Since our  $n^2$  term is positive, we conclude that this result leads to a negative variance of F, and is not acceptable.

B. Translational invariance and o -diagonal q

1. Replica sym m etry

If there is no RSB then we can set  $q = (q_1 q_0)$ ;  $+ q_0$ .

The structure of this expression shows that we only get a well posed problem if we relate  $q_0$  and  $q_1$  in some way. Above we considered  $q_0 = 0$  but the result was unsatisfactory. As we have averaged over disorder, there is translational invariance. One would expect that the physically relevant variational Ansatz rejects the translational invariance of the replicated problem. Hereto we have to impose

This condition is equivalent to staying in the \replicon" or \ergodon" subspace.

im plying here that  $q_i + (n - 1)q_0 = 0$ . This allows to eliminate  $q_i$ , after which we get

The saddle point is  $q_0 = n$ , yielding

This result has  $E_0 = 0$  and variance 1, in both respects better than previous case. But also this result leads to a negative variance, and is not acceptable.

2.0 ne step replica sym m etry breaking

Now we choose

where  $E^{(x_1)}$  is the Parisi 1RSB matrix having  $n=x_1$  diagonal  $x_1$   $x_1$  blocks with elements equal to unity. (Thus  $E^{(1)}$  is the identity matrix, while  $E^{(n)}$  is a matrix with all elements equal to unity.) Due to translational invariance we may eliminate  $q_1$  and get

The inverse reads

The last factor diverges in case of translational invariance. Fortunately, it generally cancels from our expression for  $\mathbb{E}_n$ . We thus obtain

This has the same  $\frac{p}{nq_0}$  behavior as above. Setting

Optim ization yields  $q_1 = x_1 + 0$  (n), so

The  $n^2$  term is smaller that without replica symmetry breaking but still of wrong sign. We must allow for more breakings.

#### II. IN FIN IT E ORDER REPLICA SYM METRY BREAK IN G

Now let us extend the above approach and consider k-step RSB. Let us consider the following representation for a matrix q:

Translational invariance implies 1 = 0. Expressing q in the 's we get

Only the terms in n depend explicitly on n. Using  $r_0 = r_1 + (1 = 0 = 1 = 1) = x_1$ , which follows from (36), the dependence on  $n_0$  has been made explicit. The saddle point w.r.t.  $n_0$  yields

in agreement with previous nding  $0 = nq_0 + n^2$ . We can now expand n in powers of n

With this form for n,  $E_n$  has to be optimized in  $x_1$ ; k; and k; The  $n^2$  term of  $E_n$  has prefactor  $x_1^3$ , which is expected to vanish for k ! 1. So in nite replica symmetry breaking cures the problem of negative variances. We have thus reached the main point of this work. It remains to be shown that the leading term (which is of order  $n^5$ ), has a non-vanishing prefactor. Before doing that we calculate the average free energy.

### A . The average free energy

Let us now calculate the 0 (n) value of  $E_n$  and later the leading correction, that will turn out to be of order  $n^5$ . In the continuum  $\lim$  it one gets from eq. (37)

We search a solution non-constant q(x) for 0 < x < x, while q(x) = q for x < x < 1 for some x. Variation with respect to q(z) yields

Taking two more derivatives one obtains

The average free energy is determined by

This value is approximately 4 times smaller than the exact value =3.

## B.Cum ulants of the free energy

Next we consider the higher powers in n, coded in eq. (42) for  $_n$ . For our purpose we may calculate it using the n=0 expressions for the  $x_i$  and  $_i$ . The terms of order  $n^0$ ,  $n^1$  and  $n^2$  have too many powers of  $x_1$  and vanish for k! 1, where  $x_1! 0$ . The  $n^3$  term yields

U sing the continuum results (51) it can be estimated by setting  $r_1 = r(x_1)$ ,  $r_1 = (x_1)$

The correct approach is to calculate  $r_1$  and  $r_1$  at nite but large k. At  $r_1$  = 0 this can be done quite  $r_1$  and  $r_2$  and  $r_3$  we obtain,

respectively.  $x_2$  can be elim inated, and we get

W e donot need the value of  $x_1$  here, and obtain im m ediately

The prefactor in the estimate (56) has the same sign but is larger by a factor 1:32305. This result thus proves the leading behavior

which has the expected sign. In other words, in the variational approach free energy uctuations are predicted to be of order  $1=L^{1=5}$ .

## III. SUM M ARY

In the present work we have extended the variational approach of H oneycutt and T hirum alai applied to directed polymers in 1+1 dimensional random media. This is a toy model for the more general eld of interfaces in random

media, considered by Mezard and Parisi. In our problem a mapping on a Schrodinger equation is possible, which prevents the need of space-dependent propagators and the occurrence of wavenum bers.

We have reconsidered the variational Ansatz of Honeycutt and Thirum alai. We have shown that it leads to a negative variance of the physical free energy, and thus is not a correct Ansatz.

Next we have extended this Ansatz by allowing o -diagonal components of the matrix q. It was observed that an extra constraint is needed to make the problem well posed. The only natural and realistic candidate is spatial translational invariance of the variational wavefunction in replica space. In doing so, we have seen that both the replica symmetric and one-step replica symmetry broken solutions still lead to a negative variance, though it has become smaller. We observe that more and more breakings improves the matter and that for in nite breaking the variance of the free energy has become zero (to leading order in the system size L). In nite order breaking was also assumed by Mezard and Parisi. We note that the rst non-vanishing cumulant is the fifth one, in plying free energy uctuations of order L with = 1=5, which agrees with the estimate of Mezard and Parisi. Let us recall that this is the F lory or mean eld estimate; loop elects should modify it to yield the exact result = 1=3.

This present situation of negative variances is rem in iscent of the mean eld model of spin glasses, SK-model, where an in nity of breaking was needed to obtain a vanishing zero-point entropy. Both elects are related with disappearence of unstable modes in the limit of in nite breaking.
