## Staggered pairing phenom enology for $UPd_2A$ b and $UNi_2A$ b

W e apply the staggered-pairing G inzburg-Landau phenom enology to describe superconductivity in  $UPd_2A \downarrow_3$  and  $UN \downarrow_2A \downarrow_3$ . The phenom enology was applied successfully to  $UPt_3$  so it explains why these materials have qualitatively dimensional event superconducting phase diagram salthough they have the same point-group symmetry.  $UPd_2A \downarrow_3$  and  $UN \downarrow_2A \downarrow_3$  have a two-component superconducting order parameter transforming as an H-point irreducible representation of the space group. Staggered superconductivity can induce charge-density waves characterized by new Bragg peaks suggesting experimental tests of the phenom enology.

H eavy-ferm ion superconductors<sup>1;2</sup> exhibit m any signs of unconventional superconductivity thus playing an important role in advancing our know ledge of this important subject. One of the clearest signs of this unconventional pairing is a complex phase diagram with multiple superconducting phases. This is clearly the case for UPt<sub>3</sub> which has three distinct superconducting phases.<sup>3</sup> to n the other hand, UPd<sub>2</sub>A b and UN b A b have simple phase diagram s with only one superconducting phase.<sup>6</sup> The crystal structures of UPt<sub>3</sub>, UPd<sub>2</sub>A b, and UN b A b are characterized by the same point group (D <sub>6h</sub>) and the same B ravais lattice (sim ple hexagonal) with di erent numbers of uranium atoms in the basis (two for UPt<sub>3</sub>, one for UPd<sub>2</sub>A b and UN b A b).

So far no com prehensive m icroscopic theory exists for these m aterials. M any phenom enological approaches<sup>7</sup><sup>{10</sup></sup> have tried to explain exotic superconductivity in UPt<sub>3</sub>. M ost of them use a multidim ensional superconducting order parameter transforming as a representation of the point group D<sub>6h</sub> and a G inzburg-Landau free energy invariant under this group. If one tries to apply this approach to describe superconductivity in UPd<sub>2</sub>A  $l_{a}$  and UN  $i_{2}A l_{a}$ , it is necessary to choose an order parameter transforming as a di erent representation of the group D<sub>6h</sub>. No single phenom enology is able to predict satisfactorily the relevant representation for each m aterial.

this In paper, we apply the staggered-superconductivity G inzburg-Landau theory ^11;12 to describe superconductivity in UP  $d_2 A \lg$  and UN iA L. This theory has been successful in explaining the H -P -T superconducting phase diagram of UPt<sub>3</sub><sup>3{5</sup> including the tetracritical point for all directions of the magnetic eld. The distinctive feature of this theory is a superconducting order param eter transform ing as an irreducible representation of the space group characterizing the crystal structure which resides away from the center of the Brillouin zone. Namely, we have nite center-ofm ass or staggered pairing. For  $UPd_2Al_3$  and  $UNi_2Al_3$ , the star in the reciprocal space carrying the representation is determ ined by the negative pair hopping model. W e introduce a two-com ponent H -point superconducting order param eter and w rite a free energy including gradient terms and coupling to a symmetry-breaking strain. M inim izing the free energy in the absence of the magnetic

eld, we nd stability domains in the parameter space, and identify sequences of possible phases for each domain. Application of an external or spontaneous symmetrybreaking strain does not split the superconducting transition. The calculated upper critical eld as a function of the temperature shows no kink. We introduce chargedensity-wave and magnetic order parameters and investigate their possible coupling to the superconducting order parameter. Charge-density-wave order can be induced by staggered superconductivity suggesting a possible experimental test of the phenomenmology. On the other hand, magnetic order cannot be induced.

The motivation for the staggered-superconductivity theory is based upon the theory of odd-in-frequency pairing characterized by a gap function which is an odd function of the frequency.<sup>13;14</sup> This motivation is two-fold: (i) there are strong reasons to believe that an odd-in-frequency superconducting state cannot be stable for pairs with zero center-of-mass momentum, <sup>15;16</sup> and (ii) the two-channel K ondo lattice, which is one candidate theory for heavy ferm ion com pounds, has recently been shown to produce odd-frequency superconductivity in innite spatial dimensions<sup>17</sup> which is likely to be staggered for nite dimensionality. (For a recent review of two-channelK ondo lattice models and related physics, see<sup>18</sup>.)

In consequence, we develop a phenom enology for a non-uniform superconducting state described by a staggered superconducting order parameter and a negative pair hopping energy between uranium sites.<sup>15</sup> We then write a hopping model for Cooper pairs assuming inplane and out-of-plane nearest neighbors. The energy band for this model has a two-fold degenerate minimum for the crystalm omenta located at the opposite comers  $H_1; H_2$  of the Brillouin zone shown in Fig.1. (For UPt<sub>3</sub>, the di erent num ber of uranium atom s in the basism oves the minimum to the M points.<sup>11</sup>) Cooper pairs will con-

dense in states with these momenta so in this picture there are pairs with nite center-ofm ass momenta. The B loch functions  $_1(r)$ ;  $_2(r)$  of these states are uniquely determined by specifying the W annier function. We assume that it transforms as a real one-dimensional representation of the uranium -site point group D  $_{6h}$ . For example, it will transform as  $A_2$  if we use a two-channel quadrupolar K ondo m odel to describe UP  $d_2A \downarrow_2$ .<sup>18</sup> H ow - ever, all the follow ing results do not depend on this speci c choice.

W e introduce a two-com ponent superconducting order parameter  $_1$ ;  $_2$  using the gap function (r) <sup>19</sup> where r is the pair center-ofm ass coordinate:

The choice of the coe cients in front of the B both functions gives the usual transform ation properties under the time reversal transform ation  $1 \\ 1, 2 \\ 2. W$  ith respect to the space group D  $_{6h}^{1}$ , the order parameter transform s as a two-dimensional H-point irreducible representation.

The free-energy density F is required to be invariant under the elements of the space group D  $_{6h}^1$ , the U (1) gauge transformations, and time reversal. We include coupling to the hexagonal-symmetry-breaking strains  $_1 \quad x^2 \quad y^2$ ,  $_2 \quad 2xy$  which transform as the center-of-B rillouin-zone representation E  $_{2g}$ . The bulk part F  $_0$  and the gradient part F  $_g$  are given by

Here (T) =  $a_0$  (T  $T_c$ ) with  $T_c = T_{c0}$   $\frac{2}{1} + \frac{2}{2} = a_0$ ; 1, 2, , and z are phenom enological G inzburg-Landau parameters; p = i@ 2eA =hc (e < 0). j<sub>1</sub> $\frac{2}{7}$ and j<sub>2</sub> $\frac{2}{7}$  enter the quadratic term in the bulk part F<sub>0</sub> with the same coe cient (T) which is valid up to any order in the strains <sub>1</sub>; <sub>2</sub> (the above expression dem onstrating this explicitly up to the second order). This im plies that the presence of any nite symmetry-breaking strains do not split the superconducting transition which is in agreement with experiment in that only one superconducting transition is found (despite the presence of m agnetic order at elevated tem peratures which, at least for UP  $d_2A \downarrow_3$  is not of the sm allm om ent variety found in UP  $t_3$ ).<sup>6</sup>

M inimizing the free energy, we can investigate possible superconducting phases for T < T<sub>c</sub> in the absence of the magnetic edd. There are two regions of stability in the parameter space \_1; \_2 in which the free energy has a stable lower bound. For the region I de ned as \_1 > 0, \_2 > 0 there is only one phase (\_1; \_2) = (i;1) breaking the sym m etry under the time reversal (as favored by the last term in the bulk part F<sub>0</sub>). The region II de ned as \_1 + \_2 > 0, \_2 < 0 is characterized by the phase (\_1; \_2) = (0;1) having only one component of the order parameter condensed.<sup>20</sup>

Let us now discuss the upper critical eld H  $_{\rm c2}$ . M inim izing the free-energy functional with respect to the components of the superconducting order parameter and keeping only terms linear in them, we get two identical decoupled linearized G inzburg-Landau equations. This means that the eld H  $_{\rm c2}$  does not have any kink as a function of the temperature T as observed experimentally (for UPt<sub>3</sub> there are three di erent decoupled equations, and the eld H  $_{\rm c2}$  is given by the largest of the three values generated by each equation so we get a kink corresponding to the tetracritical point<sup>11</sup>). The dependence of H  $_{\rm c2}$  on the direction of the magnetic eld has the same form as the result for a conventional free energy with e ective-m ass anisotropy:

Finally, let us investigate the possibility of chargedensity waves and magnetic order induced by staggered superconductivity. Starting from the staggered gap function (1), we can introduce order parameters for them in a very general way.<sup>21</sup> The gap function (r) does not have the periodicity of the original sim ple hexagonal Bravais lattice; it has the periodicity of a new larger simple hexagonalB ravais lattice of Fig. 2 with  $a^0 = \frac{1}{3}a$ ,  $c^0 = 2c$ . Thus the most general charge and magnetic structures are described by this new lattice and a basis consisting of six uranium atom s. A ssigning di erent charges and m agnetic moments for each element of the basis, we de ne six-component order parameters. The six components can be replaced by three interplanar-bonding com binations and three interplanar-antibonding ones. To sim plify the following discussion, we can ignore the bonding combinations because they do not couple to the superconducting order parameter. Then the basis atom s in a plane and the basis atom s in a neighboring plane have the same charges  $_{1}$ ;  $_{2}$ ;  $_{3}$  and the same magnetic moments 1; 2; 3.

The components 1; 2; 3 of the charge order parameter transform under the space group  $D_{6h}^1$  as a threedimensional reducible representation composed of the totally symmetric irreducible representation (Fig. 1). The totally symmetric combination  $_1 + _2 + _3$  represents the total charge in the large primitive cell which can be put equal to zero in the context of charge-density waves. Then the relevant part of the free-energy density is

where and g are phenom enological G inzburg-Landau parameters. M inimizing this free energy, we nd possible charge-density-wave structures for all the superconducting phases identi ed above. There is no induced charge-density wave for the phase (1; 2) = (i; 1) at the region I. For the phase (1; 2) = (0; 1) at the region II, staggered superconductivity induces a charge-density wave described by the order parameter (1; 2; 3) =(2; 1; 1). The structure is characterized by new B ragg peaks  $\frac{1}{3}n_1; \frac{1}{3}n_1 + n_2; n_3$  where  $n_1, n_2$ , and  $n_3$  are any integers. This in portant experimental prediction can be veri ed using neutron or x-ray scattering.

The components 1; 2; 3 of the magnetic order parameter transform under the space group as the product of the axial-vector representation and the representation for the charge order parameter discussed above. The product is a nine-dimensional reducible representation composed of two center-of-B rillouin-zone irreducible representations. In the free energy there are no invariants coupling the magnetic order parameter linearly to the square of the superconducting order parameter. Staggered super-conductivity does not induce magnetic order (either in-plane or perpendicular-to-plane).

In sum m ary, the G inzburg-Landau theory of staggered superconductivity was applied to UP  $d_2A_{b}$  and UN  $i_2A_{b}$ . Motivated by odd-in-frequency pairing, we found the m in in a of the negative hopping m odel for C ooperpairs at the corners H<sub>1</sub>; H<sub>2</sub> of the Brillouin zone. We introduced a two-component superconducting order parameter  $_{1}$ ;  $_{2}$ transforming as an H-point irreducible representation of the space group. W e constructed the free energy including gradient term s and coupling to symmetry-breaking strains. The superconducting transition is not split by any nite value of the strains. In the parameter space there are two zero-m agnetic-eld regions of stability characterized by the superconducting phases (1; 2) = (1; 1)and (0;1), respectively. The upper critical eld as a function of the temperature has no kink. We de ned charge and m agnetic order param eters and investigated whether the superconducting order parameter can induce them. For the phase  $(_1;_2) = (0;1)$  there is an induced

charge-density wave characterized by new Bragg peaks  $\frac{1}{3}n_1;\frac{1}{3}n_1 + n_2;n_3$  which could be seen by neutron or x-ray scattering.
