Two interacting particles in a disordered chain I: Multifractality of the interaction matrix elements Xavier W aintal and Jean-Louis Pichard

Abstract. For N interacting particles in a one dimensional random potential, we study the structure of the corresponding network in Hilbert space. The states without interaction play the role of the \sites". The hopping term s are induced by the interaction. W hen the one body states are localized, we num erically nd that the set of directly connected \sites" is multifractal. For the case of two interacting particles, the fractal dimension associated to the second moment of the hopping term is shown to characterize the G olden rule decay of the non interacting states and the enhancem ent factor of the localization length.

The wave functions of one particle in a random potential have been extensively studied. In two dimensions within the localization domains [1] the large uctuations of their am plitudes have a multifractal character. In one dimension, the elastic mean free path 1 and the localization length L_1 coincide, preventing a single one particle wave function to be multifractal over a signi cant range of scales. The description of the correlations existing between the localized eigenstates is more di cult. This is quite unfortunate, since a local two-body interaction reorganizes the non interacting electron gas in a way which depends on the spatial overlap of (four) di erent one particle states. W hen one writes the N -body H am iltonian in the basis built out from the one particle states (eigenbasis without interaction), this overlap determ ines the interaction matrix elements, i.e. the hopping terms of the corresponding network in Hilbert space. In this work, we num erically study the distribution of the hopping term s in one dimension, when the one body states are localized. It has been observed [2] that this distribution is broad and non Gaussian. W e give here num erical evidence that this distribution is multifractal. M oreover, since the obtained R enyidim ensions do not depend on L1, sim ple power law s describe how the moments scale with the characteristic length L1 of the one body problem . Since the main applications we consider (Golden rule decay of the non interacting states, enhancem ent factor of the localization length for two interacting particles) depend on the square of the hopping terms, we are mainly interested by the scaling of the second m om ent. For a size L L_1 , we show that, contrary to previous assumptions, the N-body eigenstates without interaction directly coupled by the square of the hopping terms have not a density of the order of the two-body density $_2$ (L₁) / L₁², but a sm aller density $\frac{e}{2}$ (L₁) / L₁^{f((q=2))}. The dimension f((q=2)) (1:75) for hopping term s involving four di erent one body states) characterizes the fractal set of N -body eigenstates without interaction which are directly coupled by the square of the hopping term s.

W e consider N electrons described by an H am iltonian including the kinetic energy and a random potential, plus a two-body interaction:

The operators d⁺ (d) create (destroy) an electron in a one body eigenstate j > of spin .Noting (n) the amplitude on site n of the state j > w ith energy , the interaction matrix elements are proportional to the Q given by:

Therefore, one can map [3] this complex N -body problem onto an Anderson

localization problem de ned on a particular network in the N-body Hilbert space. Since the interaction is two body, only the \sites" di ering by two quantum numbers can be directly coupled. This restriction will not matter [4] for N = 2 and (under certain approximations) may yield a Cayley tree topology [3] for the resulting network, if N is large. We study the additional restrictions coming from one body dynamics.

W e sum m arize a few evaluations of the second m om ent (q = 2) of Qwhich have been previously used. Case (i): The one body Ham iltonian is described by random matrix theory (RMT). The statistical invariance under orthogonaltransform ations 0 (M) in plies that h(Q))²i 1=M ³ where M is the number of one body states. Case (ii): The system is a disordered conductor of conductance g. An estimate [3] based on perturbation theory gives $h(UQ)^2i/(=g)^2$. Since the one particle mean level spacing / 1=M, this perturbative result coincides with the previous RM T results if one takes M q².M oreover, it is valid only if all the one particle states appearing in Eq.(2) are taken from a sequence of g consecutive levels can be neglected. Case (iii): in energy. 0 therw ise, Q The system is a disordered insulator. Shepelyansky [4] in his rst study of the two interacting particles (T IP), assumes a RMT behavior for the M = L_1^d components of the wave function inside the localization dom ain, and neglects the exponentially sm all components outside this dom ain. W hen the dimension d = 1, one gets a term $)^2$ 1=L₁³ for the term s coupling a T IP state j > Q to L_1^2 TP states j >. This estimate for g < 1 diers from the one valid when g > 1 under two important as- L_1^d instead of g^2 , but the condition pects: not only M for a large hopping is entirely di erent. In the insulator, a large hopping term is not given by four one particle states close in energy, but by four states close in real space, i.e. located inside the same localization domain. Ponom arev and Silvestrov have criticized [5] this estimate, using an approxim ate description of a localized state for weak disorder. They note that the density of T IP states coupled by the interaction is sensibly smaller.

For a m ore accurate study of Q in one dim ension, we consider a spin independent one particle Anderson tight binding model with L sites and nearest neighbor hopping 1). The on-site potentials $V_{n}\,$ are taken at random (t in the interval [W, W] and the boundary conditions are periodic. L_1 is estimated from the weak disorder form ula $25=W^2$. The $\frac{1}{2}$ jare calculated using Eq.(2) and L₁ num erical diagonalization of the one particle H am iltonian. , for xed and is a two-dimensional object which is not de ned in the real 2d space, but in the space of two one particle quantum numbers and .Those states j >(and j >) can be ordered in di erent ways: (a) spectral ordering by increasing eigenenergy, (b) spatial ordering by the location n of their maximum amplitude, from one side of the sample to the other, (c) momentum ordering if W = 0.Let us note that ordering (b) becom es m eaningful only in the localized regime $(L > L_1)$.




Fig.1. $p_{0,0}$ jwith $j_{0} >$ taken in the bulk (n₀ = 50) of a sample of size L = L₁ = 100. Spatial ordering (b). The color code goes from red (sm allvalue) to violet (large value) through yellow, green and blue.

We rst study the matrix element Q $_{0,0}$, characterizing two electrons with opposite spins in the same state j $_0$ > hopping to an arbitrary state j > .Hopping is very unlikely over scales larger than L_1 . The L_1^2 large values of the hopping term are concentrated inside a square of size L_1^2 , as shown in Fig.1 for a given sample using ordering (b) and a rainbow color code. Fig.1 is not hom ogeneously colored, but exhibits a complex pattern which reminds us another bi-dimensional object: the one particle wave function in a two dimensional disordered lattice. This suggests us to analyze its uctuations as for the 2d one body states, and to check if this pattern is not the signature of a multifractal structure.


In analogy with the 2d one body problem, we do not expect that this multifractality will be valid in the whole (;) Hilbert space, but only in a limited but parametrically large dom ain.

W e proceed as usual (see references [6,7]) for the multifractal analysis. For L_1 and L_x ed, we divide the plane (;) into $(L=D)^2$ boxes of size D and we calculate the ensemble averaged function for di erent values of q




Fig. 2. Power laws showing that Fig. 1 corresponds to a multifractalm easure in the (;) two dimensional plane. I_q (D) are calculated for a single sample with $L_1 = L = 2500$. 0 in the bulk of the spectrum. The states j i and i are ordered by increasing eigenergy (ordering a). The dashed line corresponds to the RM T prediction (case (i)).

The existence of a multifractal measure dened in the (;)-plane by the interaction matrix elements is established in the next gures. In Fig.2, a single sample has been used and power laws $I_q(D) / D^{(q)}$ are obtained over many orders of magnitude for di erent values of q.

The lim its of validity of these power laws are shown in Fig.3.

On the left side, spatial ordering (b) for di erent values of $\rm L_1$ is used for the states (;). One can see that $\rm I_q$ (D) / D $^{\rm (q)}$, for scales $1 < \rm D < L_1$, as indicated by the arrows. The lower scale is given by the lattice spacing of the (n;n) network in H ibert space. The upper scale $\rm L_1$ is the largest scale compatible with a spatial overlap of the states and , for a xed $_0$. This means that the multifractality of the interaction matrix elements Q $_{_00}$ in the two dimensional H ilbert space (;) has the same parametrically large range of validity as the one body wave function [1] in two dimensions (scale $1 < \rm D < L_1$). Here, multifractality is valid for $\rm L_1^2$ matrix elements as multifractality is valid in the 2d one body problem for $\rm L_1^2$ sites.

On the right side of Fig. 3 spectral ordering (a) is used for the same samples, giving the same power laws as with ordering (b), inside the corresponding energy range ((L₁) < D (L) < 1) indicated by the arrows. (x) / x⁻¹ is the level spacing of a segment of size x, and 1 is the band width. The exponents (q) are independent of the ordering when $L > L_1$ (i.e. when the ordering (b) becomes meaningful) and the small uctuations from sample to sample are rem oved by ensemble averaging.

The corresponding Renyidim ensions

d(q) (q)=(q 1)

are shown in Fig.4 for di erent L and L_1 , using ordering (a) and ensemble averaging.

For an in nite L_1 (no disorder), the eigenstates are plane waves of momentum k and Q \notin 0 only if k + k k k = 0.This gives d(0) = 2 and d(q > 0) = 1 with ordering (c). The dimensions calculated with ordering (a)

are close to this limit. For a nite L_1 , d(q) goes from the clean limit ($L << L_1$) to an L_1 -independent regime when $L >> L_1$. In the crossover regime ($L = L_1$) the d(q) depend on L_1 . In the limit $L >> L_1$, the d(q) (using orderings (a) or (b)) do not depend on L and L_1 . For 0 < q = 3,

with a slope 0:135. The L₁-independence of is shown in the insert of Fig. 4 for L₁ L up to L₁ = 600.


A multifractal distribution has scaling behavior described by the f ()-spectrum , given by the relations:

W e obtain

for q 3, i.e. a parabolic shape f() = 2 (2) $e^{2}=(4)$ around the maximum 2 + ... We have mainly studied the rst positive moments, since we are mainly interested by f ((q = 2)). Indeed, when one uses Ferm i golden rule to calculate the interaction-induced decay of a non-interacting state, one needs to know the density of states directly coupled by the second moment (q = 2) of the hopping term. The fractal dimension of the support of this density is given by f ((q = 2)). For greater values of q, there are deviations around the parabolic approximation, indicating deviations around simple lognorm al distributions. From a study of the large and small

values of $\mathcal{D}_{0,0}$ j one can obtain d(q ! 1). We nd d(+1) = 1:33 and d(1) = 3:15, giving the lim its of the support of f().




Fig. 5. d (g) calculated for $L_1 = 70$ and L = 240 using ordering (a). The lled symbols correspond to = = 0, averaged over 10 consecutive o chosen in various parts of the spectrum : down triangle (130 $_0$ 140), square (120 130), 0 diam ond (145 $_0$ 155) and up triangle (170 180). 0 d(q) is averaged for a few \Leftrightarrow : circle (= 100;123 133), cross (= 80;123133) and plus (101 112 and 123 133)

We have also checked that our results for Q $_{_{\rm O}}$ do not depend on the chosen $_0$ and studied the general case where j > and j > are not the same. In Fig. 5, one can see that the Q $_{_{\rm O}}$ studied for di erent $_0$ give the same curves d(q). Using energy ordering (a) and imposing an energy separation j j> (L $_1$) in order to have a good overlap between the xed states and , we nd also power law behaviors for $\rm I_q$ (D). The corresponding dimensions d(q) are given in Fig. 5, characterized by a slope

Therefore, the multifractal character of Q is less pronounced when j > 6 j >, but remains relevant.

So far, we have discussed the hopping terms of the generalN -body problem .W e now discuss how our results modify previous assumptions for two interacting particles (T IP). As pointed out by Shepelyansky, the interaction induced hopping mixes nearby in energy T IP states $j \ge d_{\#}^{+} d_{\#}^{+} j \ge$. The decay width [8,9,10] of a T IP state j >, built out from two one particle states localized within L₁, can be estimated using Ferm igolden rule. If one assumes RM T wave functions inside L₁ for the one particle states, (case (iii)) the Q U L₁³⁼² couple the T IP state j > to all the T IP states j > inside L₁. A round the band center, they have a density _ (L₁) / L₁²

and Fermigolden rule gives

. We have shown that all the T $\mathbb P$ states which can be coupled by the interaction within the localization domains are not equally coupled. Since the square of the hopping term s appears in the G olden rule, ourm ultifractal analysis gives a reduced e ective T $\mathbb P$ density $\frac{e}{2}$ / $L_1^{f((q=2))}$ which should replace the total T $\mathbb P$ density $_2$ (L₁). The resulting expression

can be compared to the direct num erical evaluation:

of the Golden rule decay.




Fig. 6. (L₁) for three di erent sizes L.D ashed line: $y = 2.55L_1^{-1:65}$. D oted line: $y = 0.5L_1^{-1}$

In Fig.6, we show for three di erent sizes L how the decay rate num erically calculated using Eq.(8) depends on L₁, for a T IP state j > w here is taken in the bulk of the spectrum . From Fig.4, one gets (2) 1:52 and (2) 1:69, and Eq.(4) gives f ((q = 2)) 1:35. For this value, one can see in Fig.6 that Eq.(7) and Eq.(8) give indeed the same L₁-dependence. This observed L₁^{1:65} law

clearly di ers from the $L_1^{\ 1}$ law in plied by the RM T assumption (case (iii)). We can also see that does not depend on L when $L_1 < L$, since there are no signi cant hopping terms for range larger than L_1 .

A nother interesting issue is the enhancem ent of the localization length L2, which is induced by the interaction and characterizes a restricted set of TIP states which have a su cient overlap to be re-organized by a local interaction [11,12]. Using the Thouless block scaling analysis [13], one nds $\frac{L_2}{L_1}$ / (U=L $_1^{3=2}$ (L₁))². If the density ₂ (L₁) of states coupled by the interaction is the total T IP density for a size L_1 , one nds the original estimate [4,13] L_2 / L_1^2 . The multifractality yields a reduced e ective density $\frac{e}{2}$ / $L_1^{f((q=2))}$ instead of the total T IP density. Since the contribution of T \mathbb{IP} states j > w ith dom inates, we use f((2)) = 1.75 valid when $\frac{1}{5}$ and we nd $L_2 / L_1^{1:5}$. This L_1 -dependence is in agreement with recent num erical results [2,14]. So there is an enhancem ent, though weaker than the original estim ate [4] (L_2 / L_1^2) , due to the multifractal distribution of the hopping term s.

In summary, we have studied how one particle dynam ics (one dim ensional localization) can a ect the many body problem through non trivial properties of the distribution of the two-body interaction. In a clean system, one has f((2)) = 1 and the density of states which are e ectively coupled by the interaction is the one particle density 1 / L. The disorder, as it is well known, enhances the e ect of the interaction, since the e ective density $\frac{e}{2}$ / $L_1^{f((2))}$, with 1 < f((q = 2) < 2 for L = L₁. This enhancem ent of the density of states coupled by the interaction inside a system of size L₁ is nevertheless sm aller than the one ($_2$ / L_1^2) given by fully chaotic one body states inside their localization domains. In a second paper [15], a study of the T IP spectral uctuations will be presented, showing that statistics is critical (as for the one body spectrum at a mobility edge) if U is large enough, accompanied by multifractal wavefunctions in the T \mathbb{P} eigenbasis for U = 0. In a third paper [16], a study of the dynam ics of a T \mathbb{P} wave packet will be presented, showing that the center of mass exhibits anom abus diusion between L₁ and L₂. These three studies provide consistent and complementary observations supporting our claim :multifractality and criticality are relevant concepts for a T \mathbb{P} system with on site interaction in one dimension. Our results go beyond the T \mathbb{P} problem and show that oversimplied two-body random interaction matrix models [17,18,19] which ignore multifractality in the hopping cannot properly describe the many body quantum motion in Anderson insulators.
