N eutron di raction study of stripe order in La₂N iO ₄₊ with $= \frac{2}{15}$

We report a detailed neutron scattering study of the ordering of spins and holes in oxygen-doped La₂N iO_{4:133}. The single-crystal sam ple exhibits the same oxygen-interstitial order but better dened charge-stripe order than that studied previously in crystals with = 0.125. In particular, charge order is observed up to a temperature at least twice that of the magnetic transition, $T_m = 110.5$ K \cdot On cooling through T_m , the wave vector , equal to half the charge-stripe density within an N iO₂ layer, jumps discontinuously from $\frac{1}{3}$ to 0.2944. It continues to decrease with further cooling, showing several lock-in transitions on the way down to low temperature. To explain the observed bock-ins, a model is proposed in which each charge stripe is centered on either a row of N ior a row of O ions. The model is shown to be consistent with the l-dependence of the magnetic peak intensities and with the relative intensities of the higher-order magnetic satellites. A nalysis of the latter also provides evidence that the magnetic dom ain walls (charge stripes) are relatively narrow. In combination with a recent study of magnetic- eld-induced e ects, we nd that the charge stripes are all O-centered at T > T_m, with a shift towards N i centering at T < T_m. Inferences concerning the competing interactions responsible for the the temperature dependence of and the localization of charge within the stripes are discussed.

I. IN TRODUCTION

 La_2NiO_4 is a Mott-Hubbard insulator consisting of antiferrom agnetic N iO 2 planes alternating with La2O 2 layers. The NiO₂ planes can be doped with holes; however, contrary to conventional expectations, the material remains nonmetallic up to quite large hole concentrations.^{1;2;3} There is now considerable evidence that the insulating behavior occurs because the dopantinduced holes tend to order them selves in periodically spaced stripes.^{4;5;6;7;8;9;10;11} These charge stripes run diagonally relative to the square lattice de ned by the Ni{O {Nibonds. In the essentially undoped regions between the stripes the Nispins can order antiferrom agnetically, with the charge stripes acting as antiphase domain walls.^{6;7;8;9;10;11;12;13} This behavior represents an excellent example of \topological" doping in a correlated insulator.14

In comparing results obtained on samples doped both by Sr substitution and by addition of excess oxygen, several trends have become clear. In samples where both charge and spin orderings have been observed, the charge generally orders at a higher temperature than the spins.^{7;9;11} (The one apparent exception is the case⁶ of La_2NiD_{4+} with = 0:125. It will be shown in the present paper that, in this com position as well, the charge orders rst.) Furtherm ore, both the charge and spin ordering tem peratures increase approxim ately linearly with the net hole concentration $n_{\rm h}$.^{7;9;10} A lso varying linearly with $n_{\rm h}$ is the low-tem perature spacing between charge stripes, corresponding to a hole density of roughly one per N i site along a stripe.

The observed low tem perature hole density within the stripes is consistent with the mean-eld calculations of Zaanen and Littlew ood.¹⁵ They evaluated an appropriate three-band Hubbard model at zero tem perature and found that electron-phonon couplings tend to reinforce the stability of charged dom ain walls in an antiferrom agnetic background. The num erical calculations yielded a relatively narrow charge stripe centered on a diagonal row of N i atom s. Zaanen and Littlew ood pointed out that the dom ain wall states form a half-led one-dimensional (1D) band, which is unstable to a Peierls distortion. Such a distortion would create a gap at the Ferm i level, thus explaining the insulating behavior.

Despite the apparent success of the Hartree-Fock calculations¹⁵ in describing the low-temperature stripe structure, such an approach runs into di culties at high temperature. In the absence of stripe order, a Hartree-Fock analysis of the doped nickelate would yield a m etal-lic state, whereas num erous studies^{16;17;18;19;20;21} have

shown that even above the charge-ordering temperature the optical conductivity is dominated by midinfrared absorption bands, with no ! = 0 D nude component. Furtherm ore, neutron di raction studies of the ordered state have shown that in some cases the stripe spacing changes with temperature,^{6;9} im plying a variation in the charge density within a stripe. Thus, one cannot rely on a unique stripe charge density to explain the insulating behavior.

It is clear that there are mysteries remaining to be unraveled. For example, what is the nature of the temperature-dependent variation of the stripe spacing? How narrow are the charge stripes, and to what extent are they pinned to the lattice? A re charge stripes actually centered on N i rows, or are other con gurations possible? To address these issues, a well-ordered sample is required.

M uch of the work cited above has focussed on Srdoped La₂N iO₄. That system has the advantage of allowing a continuous variation of the hole concentration by dopants whose random positions are xed at relatively high temperature. The down side is that the disorder of the dopants appears to prevent the development of long-range stripe order.^{4;7;9;11} The alternative is to study oxygen-doped La₂N iO₄₊. The constraint here is that one must work with the phases that nature provides: ordered phases occur only at special values of , and for an arbitrary value of one may observe phase separation.^{8;10;22;23;24;25;26;27} On the positive side, longrange order of interstitials and charge stripes coincide in a com position originally characterized as = 0.125.^{6;8;10;28}

Analysis of neutron di raction measurements on one particular = 0.125 crystal indicated that the ordered interstitial structure actually corresponds to an idealoxygen excess of $=\frac{2}{15} = 0.133$. Thus, the = 0.125 com position is oxygen de cient relative to the ideal phase. As will be explained below, we have prepared a new crystal that appears to correspond much more closely to the ideal value of . The magnetic Bragg peaks measured on this crystal are sharper than those observed with the = $0.125 \text{ crystal}^{6;8}_{\ell}$ thus allowing better sensitivity to the features of interest. We have recently reported results on m agnetic-eld-induced staggered m agnetization29 and on spin excitations in the stripe-ordered phase³⁰ measured on the same crystal. In the present paper we concentrate on various aspects of the static stripe order in zero eld.

In earlier studies^{6;28} of = 0:125 crystals, an apparently discontinuous jump from zero to nite intensity of both the magnetic and charge-order superlattice peaks was observed on cooling below $T_m = 110.5$ K.W ith the

= 0:133 crystalwe observe a sim ilar discontinuous jump in the intensities, but we nd that charge order clearly survives at $T > T_m$ with a jump in the stripe spacing to a value commensurate with a second harm onic of the interstitial order. In the latter regime the charge-order peak intensity decreases exponentially with temperature, so that no clear transition to the disordered state has

been observed.

To obtain a more precise measure of the incommensurate splitting of the magnetic peaks at T < T_m, we measured the temperature dependence of the position and intensity of a third harmonic peak. Where previous work⁶ had provided weak evidence that , which varies with temperature, tends to show lock-in behavior at certain rational fractions, the present results show clear plateaus at $=\frac{2}{7}$ (98 K T 102 K) and $=\frac{5}{18}$ (75 K T 92 K). The lock-ins demonstrate that the charge stripes are coupled to the lattice. To explain the continuous distribution of values found at other temperatures, an analogy is made with the problem of

nding the ground state arrangem ent of integral charges on a one-dimensional lattice at arbitrary lling. From the solution^{31;32} to the latter problem, it appears that a devil's staircase of ordered phases should be possible; how ever, due to entropy, long-range order is observed only for phases with relatively short periods. The fact that varies with temperature indicates that competing interactions must be involved in determ ining the order.⁹

Coupling to the lattice is also evident in the way that the stripes align them selves from one layer to the next. If there were no interaction with the lattice (as was assum ed previously⁸), then the stripes within a layer would be uniform ly spaced, and their positions would be staggered from one layer to the next in order to m in im ize the Coulom b energy. Such a sym m etric stacking of the layers of stripes can lead to forbidden superlattice peaks corresponding to the charge order, sim ilar to the situation for nuclear re ections due to the average body-centered stacking of the N iO₂ layers. However, the pinning of the charge stripes to the lattice means that the shift of the stripe pattern from one layer to the next can only occur in increments of the lattice spacing. As a consequence, the intensities of the magnetic peaks oscillate as a function of the component of the momentum transfer that is perpendicular to the planes. W e show that the modulation of the intensities can be modeled quantitatively in terms of the stacking structure factor when a sm all am ount of stacking disorder is taken into account. It follows that the missing charge-order peaks are not forbidden, but just extrem ely weak.

To characterize the widths of the charge stripes, we have measured the higher harmonic magnetic Bragg peaks. Narrow domain walls give squared-o magnetic domains, and deviations from a sinusoidal modulation are relected in nite Fourier components beyond the rst harmonic. Another contribution to the higher harmonics can come from an alternation of the stripe spacing associated with the pinning to the lattice. We show that although the intensities of the higher harmonics are all quite weak, with the strongest (the third) being < 2% of the rst, they are consistent with narrow charge stripes. Furthermore, the weakness of the harmonics in the case of $= \frac{2}{7}$ indicates that stripes can be centered both on row sofN iatom s and on row sofO atom s. A ssum ing that the stripes are N i-centered at low tem perature, the tem –

perature dependence of $% T_{m}^{2}$ in plies that the stripes become 0 -centered at high temperature. This leads to a prediction of ferrim agnetic correlations in the stripe-ordered regime at $T>T_{m}$, which was recently con $% T_{m}^{2}$ measurements in a magnetic eld_{*}^{29}

The rest of the paper is organized as follows. The next section contains a description of experimental procedures, and it is followed by a brief review of nom enclature and notation. The temperature dependences of the intensities and positions of superlattice peaks are presented and analyzed in Sec. IV. The results relevant to interlayer stacking of stripes are treated in Sec. V. In Sec. V I the intensities of the magnetic higher harm onic satellites are analyzed. The signi cance of these results is discussed in Sec. V II, and a brief sum mary is given in Sec. V III.

II. EXPER IM ENTAL PROCEDURES

The single-crystal sample used in the present study was grown by radio frequency skullm elting as described elsewhere.²⁴ The oxygen concentration was selected by annealing at 464 C for 5 days in $ow ing O_2$ (1 bar) followed by a quench to room tem perature. The annealing conditions were chosen to give a nom inal of 0.150, based on earlier work on the phase diagram .²⁴ An initial neutron di raction study of this crystal in 1993 indicated that the dom inant oxygen-ordered phase is the same as that found previously⁸ in a crystal with = 0:125. There were also weak di raction peaks indicative of a second phase with a di erent ; how ever, these were absent 1:5 years later when the present study was initiated. (One fact that m ight be relevant to the disappearance of the second phase is that the crystal was stored in a He atmosphere, which is relatively reducing, rather than in air.) The room tem perature lattice parameters obtained at that later time are a = 5:461 A and c = 12:674 A. Making use of the calibration established by the earlier X-ray di raction study²⁴ the c=a ratio of 2.3208 indicates = 0:136 0:005, consistent with the ideal value of $\frac{2}{15}$ for the model ordered interstitial structure identies ed^8 in the case of = 0:125.

The neutron di raction m easurem ents were perform ed on the H 4M, H 8 and H 9A triple-axis spectrom eters at the H igh F lux B eam R eactor located at B rookhaven N ational Laboratory. At H 9A, which is on the cold source, neutrons of energy 5.0 m eV were selected. E ective horizontal collim ations of $40^{\circ}-40^{\circ}-20^{\circ}-40^{\circ}$ (from reactor to detector) were used together with a cold Be liter to ellim inate neutrons at shorter harm onic wavelengths. At H 4M and H 8 a neutron energy of 14.7 m eV, horizontal collim ations of $40^{\circ}-40^{\circ}-40^{\circ}$ or $40^{\circ}-40^{\circ}-80^{\circ}-80^{\circ}$ and a pyrolytic graphite (PG) liter were used. At all spectrom – eters the neutrons were m onochrom atized and analyzed by PG crystals set for the (002) re ection.

The cold neutrons at H9A were used to study the

weak higher-order satellites of the magnetic scattering peaks, which are strongest at small momentum transfer Q. The excellent signal to background ratio of H 9A together with the larger scattering angles in the case of cold neutrons compared to higher energy neutrons enabled the determ ination of third-order satellite positions with high precision. The higher energy neutrons at H 4M and H 8 were required to measure the nuclear scattering associated with lattice displacements due to charge order. Except for the third-harm onic measurements, where scans were taken along Q = (h;0;1), integrated intensities were determined from 2 scans.

A llm easurem ents were perform ed w ith the crystaloriented so that the (h;0;1) zone of reciprocal space was in the horizontal scattering plane. (The notation and choice of unit cell are explained in the following section.) The aligned crystal was mounted in an Alcan lled with He exchange gas that was attached to the cold nger of a D isplex closed-cycle refrigerator. The tem perature was m easured with a Sidiode and a Pt resistance therm om eter to an accuracy of better than 1 K.

The ordering kinetics of the oxygen interstitials can be rather slow, and the cooling rate through the ordering transition can a ect whether long-range order is achieved. For example, extrem ely slow cooling is required to optimize the order in the case³³ of = 0.105, and rapid cooling also had measurable e ects in studies^{8;10} of = 0:125. In the present case, no signi cant e ects of cooling rate on interstitial order were observed. On the other hand, the cooling and heating history for T T_m has an in uence on the relative fractions of coexisting magnetic phases, the width of the temperature regions where the magnetic wave vector is locked-in to rational fractions, and the detailed spectral weight of higher order m agnetic satellites and their peak widths. Therefore, the tem perature dependence was studied during slow, careful warming after an initial cooldown to 10 K.

III. NOTATION

In order to describe and explain the data it is st necessary to review the structure⁸ and explain our notation. W ithin the resolution of our instrum ent, the fundam entalre ections of this crystal indicate a tetragonal (HTT) sym m etry (space group I4=m m m) down to at least 10 K, whereas the structural superlattice peaks suggest an orthorhom bic sym m etry. To describe the di raction peaks we will use an indexing based on an orthorhom bic cell (or pseudo-tetragonal F 4=m m m) with a unit cell size ct relative to the basic body-centered 2a_t 2a_t tetragonal cell. Note that in the body-centered tetragonal cell the a and b axes are parallel to the N i-O bonds within the N iO 2 planes, whereas in the larger cell that we use the axes are rotated from the bonding directions by 45 .

Four di erent types of superlattice peaks can be found

in this sample. Two of them correspond to the ordering of the oxygen interstitials and the other two involve ordering of the doped holes and the N i spins. Each set of peaks is characterized by a wave vector g_j such that Q_{SL} , the position of a superlattice peak of type j, is given by

where G is a reciprocal lattice vector corresponding to the average pseudo-tetragonal unit cell. The oxygen order is characterized by two wave vectors,

where wave vector components are specified in reciprocal lattice units of (2 = a; 2 = c). The twinning associated with the interstitial order is described in Ref. 8.

To describe the superlattice peaks associated with stripe order it is necessary to expand the set of reciprocal lattice vectors considered in Eq. (1). The symmetry relationship between the two N iD $_2$ planes per F 4=m m m unit cell leads to forbidden re ections. For example, for reciprocal lattice vectors of the type (H;0;L) one has the requirements that both H and L be even integers. We will show in Sec. V that the stripe patterns in neighboring layers are not related by symmetry, and as a result the relevant reciprocal lattice vectors include the case L odd.

The positions of the m agnetic and charge-order superlattice peaks within the (h;0;1) zone are illustrated in Fig.1(a). The charge order is determined by

with the average distance between domain walls in real space equal to a=2 . The magnetic order involves two modulation wave vectors. Simple antiferrom agnetic order would be described by $g = Q_{\rm AF} = (1;0;0)$. Stripe order results in a second modulation

so that the net wave vector is $g = Q_{AF} g$. In real space the spin structure consists of locally antiferrom agnetic order with an overall modulation period a =, twice that of the charge period, relecting the fact that the hole stripes act as antiphase boundaries for the spin structure. The idealized real-space spin and charge structure for $= \frac{1}{4}$ is presented in Fig.1(b).

O f course, g and g_2 represent only the dom inant sinusoidal components of the magnetic and charge-order modulations, respectively. Deviations from sinusoidal modulations will result in superlattice peaks corresponding to higher Fourier components of the order. The modulation wave vector for the nth harm onic is simply

For the magnetic scattering, only harmonics with n odd will appear, split about Q $_{\rm AF}$. (The absence of magnetic harmonics with n even follows directly from the antiphase nature of the order.) Harmonics with n even correspond to charge order.

IV.TEM PERATURE DEPENDENCE OF STRIPE ORDER

A. Experim ental R esults

The overall tem perature dependence of the stripe order is best characterized by looking at st and second harm onic peaks. Figure 2 presents results for a magnetic superlattice peak at (3+ ;0;1) and a charge-order peak at (4 2;0;1). The upper panel shows the integrated peak intensity normalized with respect to 10 K, while the lower gives the peak position h m easured in a [h;0;0] scan. As found previously,6;28 cooling through T_m = 110:5 K results in a discontinuous jump in intensity of both the magnetic and charge-order peaks, with a concom itant tem perature dependence of the peak positions. The new feature that we have to report is a peak at $=\frac{1}{3}$ for T T_m. Scattering at this position could com e from either magnetic or charge order (or both); how ever, the Q dependence of the structure factor indicates that it. corresponds uniquely to charge order. (The intensity of

 $=\frac{1}{3}$ peaks disappears at sm all Q, where the m agnetic form factor is largest.)

The discontinuity of the transition at T_m is illustrated in Fig. 3. At a tem perature 0.5 K below the transition we observe one peak due to m agnetic order and another corresponding to charge order. R ight at T_m a third peak appears at $=\frac{1}{3}$, coexisting with the previous two. At 0.5 K above T_m only the $=\frac{1}{3}$ charge-order peak survives. In contrast to the behavior at T $< T_m$, the position of the peak remains locked at $=\frac{1}{3}$ while its intensity gradually decreases with increasing tem perature.

The tem perature dependence of the $=\frac{1}{3}$ peak is presented on a logarithm ic scale in the inset of Fig. 2. The linear variation of the intensity for T > 150 K is analogous to a D ebye-W aller like behavior with

and $T_0 = 67$ 5 K. Such a tem perature dependence is in sharp contrast to the usual critical behavior associated with an order-disorder transition. In connection with this, it is useful to note that

so that there is a type of commensurability between the charge stripes in the planes and the interstitial order along one direction of the lattice. The D ebye-W aller-like decay of the intensity suggests that the charge correlations are uctuating about an average ordered con guration determ ined by the ordered interstitial oxygens. It is possible that the charge order does not entirely disappear until the interstitials disorder.

The ordering of the spins at T_m is associated with jumps both in the charge-order intensity and in $% T_m$. Previously 6 it was found that the superlattice peak intensities show simple power-law correlations with the quantity

From the measurements between $T_{\rm m}\,$ and 80 K, we $\,$ nd for the magnetic-peak intensity that

as illustrated in Fig. 4. This result is completely empirical, as there is no theoretical prediction for the connection between the intensity and wavevector.

A prediction does exist for the relationship between the intensities of the magnetic and charge order peaks below T_m . Zachar, K ivelson, and Em ery³⁴ have solved an appropriate Landau m odel for coupled charge- and spindensity-wave order parameters, and S, respectively. They nd that when the charge is the rst to order, it is possible to have a rst-order transition when the spins order, as we observe. At tem peratures below the magnetic transition, the relationship between the order parameters is predicted to be, to lowest order,

where A is a constant and $_0$ denotes the magnitude of

just above the magnetic transition temperature. Since the intensities of the magnetic and charge-order peaks are related to the order parameters by $I_{m\,ag}$ $\ \ j \ j \ , Eq. (11)$ in plies that, for $T < T_m$,

where $I_{\rm ch}~(T_{\rm m}^{\,+})$ is the intensity of the charge-order peak at a tem perature just above $T_{\rm m}$. K exping in m ind that the m odel does not describe the tem perature dependence of the wave vector, so that there m ay be m issing correction term s, we show in Fig.5 that this relationship is at least plausible near the transition.

The step-like structures in the lower panel of Fig. 2 are suggestive of lock-in transitions. To obtain more precise measurements of versus temperature, we studied a third-harm onic magnetic peak, $(1 \quad 3; 0; 1)$. This re-

ection occurs at a relatively low scattering angle, and a scan through the peak along the [h;0;0] direction is nearly transverse to Q. For such conditions the resolution in h is excellent. In our case the resolution was limited by the sample mosaic (0.7). At many tem – peratures the peak shape and width are limited by the asymmetric mosaic distribution of the sample. Representative scans are shown in Fig. 6. At other temperatures we observed either a single broadened peak, or the coexistence of a broadened peak and a mosaic-limited one.

A sum mary of the results is given in Fig.7. In all panels, the dom inant component is represented by the lled sym bols and the secondary component by the open ones. (The exception to this rule occurs in the range between 50 K and 70 K, where the integrated intensity of the broader second component is actually greater than that of the sharper peak.) The top panel shows the integrated intensity, with the total intensity from both components (dashed line) norm alized to one at 10 K. The middle panel and inset show . The bottom panel gives the peak width, divided by 3 (in units of 2 = a), so that it can be compared directly with the middle panel.

The temperature dependence of is rather interesting. A lthough it was measured on warming, it is more convenient to discuss the behavior starting from T_m and considering the changes as the temperature decreases. (Hysteresis e ects should be small as long as one cools succiently slowly.) Initially, jumps from $\frac{1}{3}$ to 0.2944 $\frac{5}{17}$. From there it decreases linearly with temperature until it hits a plateau at 0.286 = $\frac{2}{7}$. (There is also a hint of a plateau at 0.293 = $\frac{12}{41}$, although the stability of this particular value is suprising, as discussed below.) The $\frac{2}{7}$ plateau extends from 102 K down to 98 K. Below this, jumps to another region of linear decrease, until it locks into a value of 0.2778 = $\frac{5}{18}$ near 93 K. From this point down to 10 K a $\frac{5}{18}$ component is always present; how ever, the entire system is locked into this value only down to

75 K.N ear 70 K the third harmonic splits into two peaks: a sharp one at $\frac{5}{18}$ and a broad one centered near 0.275. The integrated intensity of the broad peak dom inates down to 50 K, below which most of the intensity shifts back into the sharp $\frac{5}{18}$ peak. In contrast to what was found⁶ with the = 0.125 crystal, we have not observed any component centered at $\frac{3}{11}$ = 0.2727.

B. Analysis

In order to make sense of (T), we can start with the Zaanen and Littlew ood¹⁵ prediction of charge stripes with a hole density of one per N i site. A ssum ing that all dopant-induced holes go into 0 2p states lying within the N iO₂ layers, one would then expect a domain wall density of = 2 per row of nickel atom s. In our case this gives = $\frac{4}{15}$ = 0.267. It appears that the m easured is approaching this value as the tem perature decreases,

but it never quite gets there. If we assume that all of the holes are indeed ordered in the stripes, then the hole density (per N i site) within a charge stripe, n_s , is given by $n_s = 2 = .$ Even if all holes remain connect to the stripes as the tem perature is raised, the fact that increases im –

plies that $n_{\rm s}$ is decreasing. At 80 K we have $n_{\rm s}$ = 0.960, at 100 K $n_{\rm s}$ = 0.933, and at T $^>$ $T_{\rm m}$ $n_{\rm s}$ = 0.800.

The existence of plateaus in (T) indicates that the stripe order can couple to the lattice; however, the almost continuous variation of between plateaus shows that the stripe density is not restricted to a few special values. To describe the possible stripe arrangem ents, we need consider only the one-dimensional ordering along the charge-m odulation direction [see Fig. 1(b)]. W ithin thism odel, let each row of Nior O atom s be represented by a single site. Thus, there are two N isites per unit cell, separated by $\frac{1}{2}a$, with an 0 between each pair of nickels. The stripes m ay be pinned to particular sites in the lattice, either by electron-phonon coupling or Coulom b interaction with the ordered oxygen interstitials. The inform ation on the particular pinning sites is contained in the phase of the scattered neutron waves, which cannot be detected in our single-scattering measurements. To be de nite, we will assume that a stripe can be pinned to either a Nior an O row. (It will be shown below that this assumption leads to testable predictions.) A lthough it is not necessary for the present discussion, we will also assume that the charge stripes are quite narrow. (The actual charge distribution can be probed by analyzing the intensities of the higher-harm onic superlattice peaks, as will be discussed in Sec. V I.) For a Ni-centered stripe, we assume that there is no static moment on the site where the hole is centered, consistent with experim ent,8 but neighboring nickels have full spins. For an O-centered stripe, we assume that there is no static moment associated with the hole spin.

Since the stripes are charged, they will repel each other. As a result, the stripes will arrange them selves so as to maintain the maximum possible spacing, with the constraint that each stripe is centered on a NiorO site. To understand the possible con gurations, we can consider the equivalent problem of nding the ground state arrangem ent of integral charges on a one dim ensional lattice at arbitrary lling, which has been solved by Hubbard, ³¹ by Pokrovsky and U im in, ³⁵ and by Bak and Bruinsma.³² For any given lling, there will be at most two stripe spacings, which dier by the minimum increment in stripe position. In our case, this increment is $\frac{1}{4}a$, corresponding to a shift from a Nito an O site (or vice versa). The energy is minim ized when the two spacing units are ordered in a periodic fashion. The most stable con gurations are those with a single spacing. In our region of interest, the single-spacing phases occur at $=\frac{1}{4};\frac{2}{7}$, and $\frac{1}{3}$, with stripe separations of $2a;\frac{7}{4}a$, and $\frac{3}{2}a$, respectively.

We can represent these di erent phases using a notation in which an up or down arrow represents a Nispin, a dot represents an O site, and an open circle represents a stripe. Thus, the con guration corresponding to $=\frac{1}{4}$ with Nicentered stripes looks like

For $=\frac{2}{7}$, we get equal numbers of N i-centered and O-centered stripes:

If we drop the requirement of a single spacing, we can have either purely N i-centered stripes:

For our = 0:133 crystal, the magnetic order vanishes when shifts to $\frac{1}{3}$; nevertheless, inelastic scattering m easurem ents show that the spins rem ain correlated.³⁰ In the con guration with 0 -centered stripes, the dom ain walls have m om ents that are in phase with each other. A swill be discussed further in Sec.V I, one might expect the moments of Niions immediately adjacent to an O-centered dom ain wall to be som ew hat reduced com pared to those in the middle of a magnetic domain. If the modulation of the moments de ning the antiphase dom ains were purely sinusoidal, then there would be no net moment in the system; however, any deviation from a pure sine wave would lead to ferrim agnetism . In contrast, the spins all form antiparallel pairs when the stripes are centered on Nirows. Recently we dem onstrated²⁹ that one can induce staggered magnetic order in the $=\frac{1}{3}$ phase by applying a uniform magnetic eld. This result clearly

indicates that the stripes in the high-tem perature phase are centered on 0 rows.

So far we have considered only phases with uniform stripe spacing, whereas the real system appears to pass through a range of m ore com plicated phases. W hile we have emphasized the possibility of two types of charge stripes, it is in portant to note that the observed values of can be explained with a single type of stripe. In that case, the relevant phases of uniform spacing are limited $=\frac{1}{4}$ and $\frac{1}{3}$. To describe the possible intervening to phases it is convenient to introduce a simple notation. F inst note that for $=\frac{1}{4}$, there is 1 spin period in 4 lattice spacings, or, equivalently, 1 charge stripe per 4 row s of N i atom s (with 2 row sper fundam ental unit cell). It follow s that this phase can be denoted in term s of the real-space repeat unit of the charge stripes as h4i. Similarly, $=\frac{1}{3}$ corresponds to h3i. The con guration h43i represents alternating stripe spacings of 4 N i rows and 3 N i rows. This corresponds to 2 stripes per 7 N irow s, or $=\frac{2}{7}$. An arbitrary con quration will consist of n 4-row spacings and m 3-row spacings, giving⁶

For such an arbitrary con guration, the ground-state energy is m inim ized by arranging the stripes in a pattern that is as close to uniform as possible.^{31,35} Som e examples are shown in Table I. Bak and B nuinsm a^{32} have dem onstrated that the possible ground states form a complete D evil's staircase.

O f course, if two types of stripes are considered, then we must include a possible stripe spacing of $\frac{7}{2}$ N i rows. Note that to be commensurate with the Nirrow spacing such units must occur in pairs. Let the number of pairs of $\frac{7}{2}$ -spacings per real space repeat unit be p. Then, in the range $\frac{1}{4}$ $\frac{2}{7}$, the values of are given by

Examples are shown in Table II.

O ne can distinguish between models with either one or two types of stripes by analyzing the intensities of higher harm onic satellites. Such an analysis is discussed in Sec. V I. The proposed pinning of the stripes to particular lattice row shas in plications for the layer to layer stacking of the stripes, as we discuss in the next section.

V. STACK ING OF STRIPES

To minimize the Coulomb repulsion between charge stripes in neighboring planes, the stripes should run parallel to each other with a staggered alignment. Such a body-centered type arrangem ent would maxim ize the spacing between nearest neighbors; however, pinning of the stripes to the lattice would prevent such an idealstaggering. W ithin ourm odel, the stripe pattern should only be able to shift by integral (or possibly half integral) units of the lattice spacing a. W e can distinguish between these two possibilities, symmetric versus integral-shift stacking, by analyzing the 1 dependence of the superlattice intensities.

Consider ist the case of a symmetric, body-centered stacking of the stripes. As discussed in the previous section, a given value of can be written as a ratio of two integers, r=s. The commensurate period of the magnetic structure is then sa, and the period of the charge structure is sa=2. The displacement of the stripe pattern from one layer to the next is then $(\frac{1}{4}s;0;\frac{1}{2})$, in lattice units. The structure factor describing such a stacking is

where the intensity is proportional to f f. For a chargeorder rejection of the type (2n + 2;0;1), where n is an integer, f f is either 4 or 0. In the case of $= \frac{1}{4}$, one nds that f f is equal to 0 for 1 equal to an even integer and 4 for odd 1, independent of n. For the general case of = r=s, however, the value of f f depends not.

case of = r=s, however, the value of f^2 depends not only on 1, but also on r, s, and n. There is a similar variability form agnetic relections. To illustrate this, we have listed values of f^2 for a number of dimension of the erent cases in Table III. Note in particular that the body-centeredstacking model implies zero intensity for the (4 2;0;1) remettion when $=\frac{2}{7}$, which is clearly inconsistent with the results shown in Fig.2. (The tabulated values of $f^2 f^2$ for $=\frac{1}{3}$ have implications for the interpretation of magnetic and charge-order scattering as reported in a recent study¹¹ of La_{1:67}Sr_{0:33}N iO₄.)

A lternatively, if the stripes are pinned to the lattice, then the stripe order in neighboring layers is described by the basis vectors (0;0;0) and $(m a;0;\frac{c}{2})$, where m is an integer number. Taking the simplest case of m = 1, one nds that, for the nth harm onic superlattice peak,

This form ula indicates that, for xed h, the intensities of m agnetic peaks should oscillate as a function of l. It turns out that this is just what is observed.

We measured integrated intensities for 10 nstharmonic peaks at (1;0;1), with l = 0 to 4, at the 80 K and 100 K plateaus, corresponding to $=\frac{5}{18}$ and $\frac{2}{7}$, respectively. To describe the experimental results, it is helpful to express the integrated intensities of the n = 1 m agnetic rejections as

where A is a norm alization constant, and we use the parametrization $f = e^{Q^2 = 2^2}$ to approximate the Ni

m agnetic form factor as well as the Debye-W aller factor. The parameter was determined by a least-squares t to the data. The values of $f_1 f$ extracted from the 80 K m easurements are shown in Fig. 8. The dominant 1 dependence of these results is described by the form ula

where we have kept the notation general by labelling F and B with n, and the scale factor A⁰ is meant to rem ind us that we have not determ ined from the experimental intensities the absolute magnitude of $f_1 f_1^2$. The values of B characterizing the measurements at 80 K and 100 K are listed in Table IV. Equation (24) predicts that B₁ = $\cos(2)$, which yields B₁ = 0.174 at 80 K ($=\frac{5}{18}$), and B₁ = 0.223 at 100 K ($=\frac{2}{7}$).

The model allowing an interlayer oset of the stripe pattern by one lattice spacing gives qualitative agreement with experiment, although the calculated magnitude of the parameter B_1 appears to be systematically too large by 30%. We can get a better to the data if we allow for some disorder in the stacking in terms of di erent osets. The Coulomb energy between charge stripes in neighboring layers is not the same for all possible integral osets. If we allow for two possible osets, a and ma, with relative probabilities 1 and , respectively, then, assuming a random distribution of the osets, the structure factor becomes

In the $\frac{5}{18}$ phase, the Coulomb energy is minimized for m = 1, and also for m = 8. We the measured intensities with this model, varying the parameters and to obtain the results shown in Fig.8. The parameter values and the weighted reliability factor R_w are listed in Table V. For $\frac{2}{7}$, the relevant o sets are m = 1 and 3 (with a shift by 2.5a being equivalent in energy to m = 1). Again, the thing results are listed in Table V. The calculated values of B_1 for both cases are given in Table IV.

O ne can see from Eqs. (24) and (27) that the relative size of the 1-dependent intensity oscillation varies with n, the harm onic order. Thus, another test of our m odel is to apply it to another value of n. We have param etrized m easurem ents of $(1 \ 3 \ ;0;1)$ peaks (l = 1 to 4) in terms of the coe cient B₃, and the results for T = 80 K and 100 K are listed in Table IV. We then calculated values of B₃ using the param eter values already determ ined in the ts to the n = 1 intensities. The calculated values are in very good agreem ent with the m easurem ents. For reference, we have also included in Table IV calculated values of B₂ and B₄.

Before leaving this section, it is of interest to consider the consequences of our model for the n = 2 charge-order peaks. Measurements have not detected any intensity at positions (2n 2;0;1) with leven. Considering just the stacking contribution (that is, ignoring the structure factor due to the atom ic displacement pattern within a single layer), we can calculate the relative intensities of even-l peaks compared to odd-l peaks. Using our results for $=\frac{5}{18}$ gives a ratio of 2%, while for $=\frac{2}{7}$ we obtain 8%. These relative intensities are still quite di cult to detect. For $=\frac{1}{3}$ we calculate a ratio of 33%, which would be detectable except that the peak position overlaps with the second harm onic of g_{01} .

VI. MAGNETIC HARMONIC SATELLITE SPECTRUM

Inform ation on deviations from a sinusoidal modulation is contained in the relative intensities of the higher harm onic superlattice peaks. In particular, we are interested in the degree to which the spacing of the stripes deviates from perfect periodicity as well as the degree to which the charge is con ned within narrow stripes. By reason of their greater absolute intensities, the magnetic harm onics are best suited for quantitative analysis.

For the $=\frac{5}{18}$ phase found at 80 K, there are 9 independent harm onics. Figure 9 illustrates the spectrum of higher order magnetic and charge satellites found in a scan along (h;0;1) for 0 h 1. Because of the weakness of the higher harm onics, the intensity is plotted on a logarithm ic scale. The nth order satellites of magnetic origin are denoted by the subscript m , while those due to charge order are indicated by the subscript c. An oxygen ordering peak at $(\frac{1}{3};0;1)$ (labeled 0) and an unexplained peak close to $n_m = 3$ (labeled *) are also recorded. (The latter very weak peak is probably due to a m isaligned grain.) Because of insu cient cool-down time for this special scan, the rst m agnetic and charge satellites are split in two due to partial coexistence of the $\frac{5}{18}$ and $\frac{2}{7}$ phases. Higher order contributions of the $\frac{2}{7}$ phase could not be observed in this scan.

In order to allow a quantitative analysis, separate m easurem ents (follow ing a m ore careful cooldow n) were performed to obtain integrated intensities for all independent m agnetic harm onics. These were done at 80 K and 100 K to characterize the $\frac{5}{18}$ and $\frac{2}{7}$ phases, respectively. A llpeaks in the range Q = (h;0;1) with 1 < h < 1 were m easured, and values at + h and h were averaged. The results, norm alized to the intensity of the rst harm onic, are listed in Tables VI and VII.

To model the harm onic intensities, we must start with a speci c model of the spin density within a unit cell of the stripe pattern, such as the models shown in Sec. IV B. W ithin such a one-dimensional unit cell, if we number the sites with an integer index m and denote the spin on the mth site as S_m , the discrete Fourier transform of the spin arrangement corresponding to the nth harm onic is then

where N = 36 (14) for $=\frac{5}{18}(\frac{2}{7})$. The intensity of the nth-order satellite is given by

where F_n is given by Eq. (27). Because the measurements span a very small range of Q, the variation of the magnetic form factor and the D ebye-W aller factor can be neglected.

We rst consider the $\frac{2}{7}$ case, because it provides the opportunity to distinguish between three di erent models: (a) equally-spaced stripes centered alternately on Niand 0 rows, (b) stripes with alternating spacings centered only on Nirows, or (c) stripes centered only on O rows. These three possibilities are illustrated in Eqs. (15)-(17), respectively. In each case, all spins are drawn with the sam e m agnitude (unity), suggesting quite narrow charge stripes. To allow for some smoothing of the spin modulation, we treat the relative magnitude of a spin im mediately adjacent to an O-centered stripe as a tting parameter. Since no such sites occur in model (b), in that case alone we take the magnitude of the spins next to Nicentered stripes as the thing parameter. The intensities calculated with each of the models are presented in Table VII, and the tted spin in each model is listed in Table V III. M odel (a), with equally-spaced stripes, gives very good agreem ent with experim ent, and the other two models are ruled out rather convincingly. As a further test ofm odel (a), we allow ed a second param eter, the size of the spin adjacent to a Ni-centered stripe, to vary, and found that it decreased only slightly, from 1.0 to 0.94, while the size of the spin next to an O-centered stripe rem ained unchanged.

To model the results for the $\frac{5}{18}$ phase we considered only a model sim ilar to (a), with both N i-and O -centered stripes, although in this case they are not all equally spaced. The t gives the same value as in the $\frac{2}{7}$ case for the spin magnitude next to an O -centered stripe (see Table V III). The calculated harm onic intensities are listed in Table V I. The R factor is somewhat worse than in the $\frac{2}{7}$ case, but we also have a substantially larger number of harm onics to t. The quality of the t seems quite reasonable given the relative com plexity of the structure and the possible system atic errors in measuring the very weak harm onics.

G iven that the analysis of the magnetic harm onics indicates fairly narrow charge stripes, it is of interest to study the charge-order harm onics. The inform ation obtained about the charge m odulation is still indirect, because the neutrons are only directly sensitive to the induced atom ic displacem ents. Furtherm ore, quantitative modeling is di cult because of the strong Q dependence of the structure factor, even for a single layer.⁸ N evertheless, an attempt was made to detect higher harm onics. Since the lowest-order superlattice peaks for charge order correspond to n = 2, the next harm onic is n = 4. The strongest n = 2 peak within the accessible Q range is at (4 2;0;1). Searching in the nearby region we found nite n = 4 peaks at $(4 \quad 4;0;1)$ with l = 0 and 2. At T = 8 K the intensities of the latter 2 peaks, relative to the strong n = 2 peak, are 1.4(7)% and 2.2(7)%,

respectively.

V II. D ISC U SSIO N

In the Landau model for coupled charge- and spindensity-wave order parameters,³⁴ there are two possible ordering scenarios. If, on cooling, the st ordering transition is driven by the pure charge term in the free energy, then spin ordering will tend to occur at a lower tem perature; otherwise, the spin and charge order will appear simultaneously. Our present results for the = 0:133 phaseof $La_2 N i O_{4+}$ show that charge order appears rst, consistent with the behavior found in $La_2 \times Sr_x N$ iO 4 (R ef. 4, 7, 9, 11, 36) and in $La_{1:6 \times} Nd_{0:4} Sr_x CuO_4$ (Ref. 37, 38). Thus, it is the free energy associated with the charge alone that drives the ordering. Of course, one must keep in m ind that the charge stripes would not be likely to form and order in the absence of the magnetic moments of the N i ions.¹⁵ In the charge-ordered phase at T > T_m , the N ispins rem ain strongly correlated, as dem onstrated by inelastic neutron scattering measurements reported elsew here.30

The exponential decrease of the charge-order peak intensity at high temperatures is unusual, but appears to be associated with a commensurability with the superlattice formed by the interstitial oxygens. This coupling, together with the simultaneous appearance of interstitial order and charge-stripe order as a function of , leads one to wonder whether the energy associated with the charge and spin correlationsm ight in unce the ordering of the interstitial oxygens. Perhaps this connection could be tested in a future experiment.

The rst-order transition at T_m and the concom itant jump in Ich are consistent with the generic Landau m odel.³⁴ The main feature not explained by that m odel is the tem perature dependence of . The sim ilarity of the series of lock-in transitions to what is observed in solutions of an isotropic next-nearest-neighbor Ising (ANNNI) m odels^{39;40} suggests the importance of competing interactions. (Of course, it is likely that competing interactions are also responsible for the very existence of stripes in this system .^{41;42;43;44}) One relevant factor is the longrange part of the Coulomb interaction, which favors a uniform distribution of charge, and hence a large value of $\frac{9;42;43;44}{\cdot}$ A competing factor is the superexchange energy associated with antiferrom agnetic N i spins. This interaction favors wide magnetic domains, and therefore a small value of $\frac{42}{10}$. The competition between these energies will depend on the relative magnitudes of the order parameters and S, resulting in a tem peraturedependent . The observation⁹ of a very sim ilar tem perature dependence (without the lock-ins) in La_{2 x} Sr_xN iO 4 with x = 0.225, where the dopant ions are random ly distributed, dem onstrates that this behavior does not require well ordered dopants.

The lock-in transitions provide evidence for som e cou-

pling to the lattice. We have explained how the values of

observed at lock-in plateaus can be understood in term s of long-period com m ensurate structures. O nly com m ensurate structures with relatively short periods can be stabilized at nite tem perature. Between the plateaus entropy will tend to favor incom m ensurate structures.39 The values of epsilon corresponding to observed com mensurate structures may at st appear to be som ewhat arbitrary rational fractions; however, it is interesting to note that they form the st levels of a Farey tree.45;46 A similar correspondence was observed previously by Shimomura, Hamaya, and Fujii⁴⁷ in an X-ray di raction study of com m ensurate-in com m ensurate transitions in the system $[N(CH_3)_4]_2MC_4$, where $M = Zn_1$ Fe, and Mn. A Farey tree is constructed by evaluating a sequence of Farey m ediants. G iven two rational fractions, n^{0} =n and m^{0} =m, the Farey m ediant is $(n^{0} + m^{0}) = (n + m)$. Starting with the fractions $\frac{1}{4}$ and $\frac{1}{3}$ one obtains the tree shown in Fig. 10. The experimentally observed values of are marked. Farey-tree structures have also been noted in studies of the two-dimensional Falicov-K im ball model in regions of the phase diagram dominated by stripe con gurations.48

It was shown previously⁸ in a neutron di raction study of stripe order in a = 0.125 sample that the ordered N im om ents are quite large, with a maximum am plitude that is > 80% of that observed in undoped $La_2 N$ iD₄. Here we have shown that the observed intensities ofm agnetic harm onics are consistent with fairly narrow dom ain walls. These results, together with the poor conductivity of the nickelates in general, suggest that the dopantinduced holes are strongly localized within relatively narrow charge stripes. The weakness of the higher harm onics relative to the st ham onic peak occurs because of the sm all num ber of atom ic sites between dom ain walls: the di erence in harmonic intensity between a square wave and a sine wave is small when there are only a few lattice sites perperiod. It follows that the absence of strong higher harm onics in m agnetic scattering studies of copper-oxide superconductors such as La_{2 x} Sr_xCuO₄ is not inconsistent with the existence of stripe correlations in those materials.

It is interesting to consider the change in character of the charge stripes with tem perature. As we have shown elsew here,²⁹ the charge stripes in the $=\frac{1}{3}$ phase, above T_m , are centered on oxygen rows. From the analysis of the harm onic intensities, we have shown here that, in the $=\frac{2}{7}$ phase, the charge stripes are half 0 -centered and half N i-centered. Continuing to lower tem perature, the dom ain walls becom e dom inantly Ni-centered. In fact, this shift of the stripes from 0-to Ni-centered is correlated with the evolution of the magnetic order parameter. W e have observed that, at least near the transition, the intensity of the rst magnetic harm on ic is proportional to the square of the quantity q de ned by Eq. (9). O ne can easily show that 3q is equal to the density of N i-centered stripes. The signi cance of this curious correlation is not clear.

A long with the shift in lattice alignment, we have argued that the charge density within the stripes must vary with tem perature. It follows that the insulating nature of the material cannot be explained simply by invoking a Peierls transition in 1D half-lled stripes.¹⁵ Instead, it appears that the electronic localization must be understood in terms of interactions in the direction transverse to the stripes. W hile electron-phonon interactions are often discussed, the tem perature dependence of makes it clear that purely electronic e ects are more important than coupling to the lattice. It has been suggested previously^{49;50} that \m agnetic con nem ent" e ects are relatively strong in nickelates, especially when com pared to cuprates. Perhaps this e ect, associated with the size of the transition-m etalm om ents, is the most im portant feature distinguishing the nickelates from the cuprates.

VIII. SUMMARY

W e have reported a detailed study of stripe ordering in a single crystal of La₂N iO $_{4+}$ with $=\frac{2}{15}$. On cooling, charge order occurs before m agnetic order, although there is a substantial jum p in the charge order param eter at the st-order magnetic transition. No clear chargeorder transition has been observed, as the intensity of a charge-order superlattice peak decays exponentially with tem perature. Below T_m , the value of decreases with tem perature, exhibiting several lock-in transitions. A model in which each charge stripe is centered on either a row of Nior 0 ions has been shown to be consistent with the 1-dependence of the magnetic peak intensities and with the intensities of higher-order magnetic harmonic peaks. M odelling of the latter also indicates relatively narrow magnetic domain walls. With decreasing temperature the charge stripes are initially all centered on O rows, and then begin to shift to N i rows below ${\rm T}_{\rm m}$, with Ni-centered rows dominating at low temperature.




FIG.1. (a) D iagram of the (h0l) zone, showing positions of di raction peaks, with indexing based on space group F4/mmm for the average nuclear structure. Solid circles, fundam ental Bragg peaks; solid triangles, magnetic superlattice peaks; solid squares, nuclear superlattice peaks corresponding to charge order; open squares, allowed but unobserved charge-order peak positions. O xygen ordering peaks are excluded. (b) M odel of spin and hole ordering in a N D_2 plane, as discussed in the text; circles indicate positions of holes (N i centered), arrows indicate correlated N i m om ents. The dashed line outlines a unit cell, and double lines mark positions of dom ain walls.




FIG. 2. Temperature dependences of a magnetic peak at (3 + ;0;1) (open squares) and a charge-order peak a $(4 \ 2 ;0;1)$ (led circles). The upper panel shows integrated intensities normalized with respect to 10 K, the lower give the peak position in h. Inset: logarithm of normalized intensity vs. temperature for the charge-order peak above 110 K. Line through points is a linear t, as discussed in the text.




FIG.3. Elastic scans along Q = (h;0;1). Scans were m easured at tem peratures of 110 K (a), 110.5 K (b), and 111 K (c).




FIG. 4. Normalized intensity of a magnetic peak at (3 + ;0;1) vs. $(1=3 \quad j^2$ for 80 K T T_m. Line through points is a linear t, as discussed in the text.




FIG. 5. Intensity of the (4 2;0;1) charge-order peak, plotted in the form I $_{\rm ch}^{1=2}$ (T) and norm alized to the 10-K value, vs. the norm alized (3 + ;0;1) intensity.




FIG.6. Elastic scans along Q = (h;0;1). Scans were m easured at tem peratures of 108.5 K (a), 101 K (b), and 80 K (c).




FIG.7. Tem perature dependences of third harm onic m agnetic peaks at $(1 \quad 3 ; 0; 1)$. At most tem peratures two components with di erent are coexisting. In all panels, the (usually, see text) dom inant component is represented by the led circles and the secondary by open triangles. The top panel shows the integrated intensity normalized to the total intensity from both components at 10 K. The middle panel and inset show and the bottom panel the peak width, divided by 3 (in units of 2 = a).




FIG.8. Comparison of the structure factors S_1 (1) for the experimental data (corrected for A f²) and least-squares t for the rst-harm onic intensities of the $\frac{5}{18}$ phase.




FIG.9. Spectrum of higher order satellites in the $\frac{5}{18}$ phase at 80 K along Q = (h;0;1). The nth order m agnetic satellites are labeled with subscript m, the ones due to charge order with c. An oxygen ordering peak is labeled 0 and one of unde ned origin with (*).




FIG.10. Farey tree com position rule for wave vectors (densities) between 1/4 and 1/3. The observed rational values for are marked by the symbols and 4 for La_2N iO $_{4:133}$ and La_2N iO $_{4:125}$, respectively.
