On the second-neighbor correlator in 1D XXX quantum antiferrom agnetic spin chain

A bstract

We have calculated the energy per site for the ground state of antiferrom agnetic quantum spin chain with variable range exchange $h(j k) / \sinh^2 a \sinh^2 a (j k)$ in the fram ework of the asymptotic Bethe ansatz. By expanding it in powers of e^{2a} , we have con m ed the value of the second-neighbor correlator for the m odel w ith nearest-neighbor exchange obtained earlier in the atom ic l in it of the Hubbard chain.

At present, there are two main approaches in investigations of spin correlations in the ground state of the quantum Heisenberg antiferrom agnet. The rst one is connected with analysis of the representations of quantum groups [1] and gives some universal prescription of calculation of various correlations via multiple contour integrals. Unfortunately, till now there are no possibilities to reduce these multiple integrals to known transcendents. The second approach consists in noting correlators in the form of Fredholm determinants [2]. However, within this approach there is still no way to analytic evaluation of these Fredholm determinants. A symptotics of spin correlations at large distances between spins has been obtained in the fram ework of conformal eld theory [3], but this theory cannot give the values of correlators at nite distances.

The rst explicit calculation of nearest-neighbor spin correlator $< \sim_j \sim_{j+1} > in$ the therm odynam ic lim it has been made by Hulthen [4] with the use of the Bethe ansatz [5]. Since this correlator coincides with the energy per site in the vacuum state of the model, the problem is equivalent to calculation of this energy for nite number of lattice sites N and taking therm odynam ic lim it N ! 1 . The second-neighbor correlator $< \sim_j \sim_{j+2} >$ has been calculated by Takahashi [6] with the use of perturbation theory in the atom ic lim it of the half-lled Hubbard model. This result has never been con rmed by other scheme of calculations.

In this letter, we perform the explicit calculation of $< \sim_j \sim_{j+2} >$ by using the way which di ers substantially from the way of ref.[6]. Namely, we start from the consideration of the integrable spin chain with variable range exchange and the Hamiltonian [7]

In the nearest-neighbor lim it a! 1 one can decompose (1) into a series

Hence one can write the ground-state energy per site as

where < > means average on the vacuum state of the Hamiltonian (2). Fortunately, in

the rst order approximation (3) one can replace this state to the vacuum state of nonperturbed H am iltonian with the interaction of nearest-neighbor spins, H $_0=\frac{1}{2}^P_j (\sim_j \sim_{j+1} 1)$.

Let us now calculate the ground-state energy per site (3) of the model with the use of the asymptotic Bethe ansatz (ABA) [8]. The wave functions of the states with M down spins can be calculated exactly [7]. Their asymptotic expression in the region $n_1 \quad n_2 ::: \quad n_M$ has the form similar to Bethe one,

where the rst sum is taken over all permutations from the group $_{\rm M}$, fk g is the set of pseudom omenta and (k;k) is the two-magnon phase shift dened by the relations

where $_1$ is the zeta W eierstrass function de ned on the torus $T_1=C=(Z+\frac{i}{a}Z)$. To consider the chains of nite length N in the therm odynam ic $\lim_{} it$ N ! 1 , we adopt the main hypothesis of ABA , i.e. imposing periodic boundary conditions on the asymptotic form of the wave function (4) (it is worth noting here that the exact solution of the problem of nite chains in the model should be based on the treatment of the Ham iltonian with the exchange given by the W eierstrass } function instead of (1), and is not available till now except the cases M = 2;3). Taking $(n_2;:n_M;n_1+N)=(n_1;:n_M)$ and calculating the both sides with the use of the formula (4) results in the ABA equations

The energy of corresponding con guration is given by

We are interested in the antiferrom agnetic vacuum of the model and should take N even, M = N = 2. Taking logarithms of both sides of (7) and choosing the proper branches [9], one arrives at

We adopt usual hypothesis about the distribution of the (half) integers fQ g for antiferrom agnetic vacuum state. Namely, it will be assumed that these numbers form uniform string from Q_{max} , Q_{max} , $Q_{max} = N = 4$ 1=2 without holes. We introduce the rapidity variable by the relation = '(k) and the function () via the relation k = (). The ABA equations (9) now can be written as

Following Hulthen [4], let us go to continuous variable x=Q=N in the lim it N ! 1 and introduce the root density $_N ()$ by the relation $_N () = dx=d$. Differentiating both sides of (10) with respect to $_N ()$, one arrives at the Hulthen-like equation in the lim it N ! 1

Substituting it into (12) yields

Choosing variables as = '(k); 0 ()d = dkand changing the order of integration (it is allowed since the integral over vanishes su ciently fast as pj! 1), one arrives at the main formula

where the functions "(k) and '(k) are determined by (13) and (6). The integrals in (14) cannot be calculated analytically. However, one can see from (6) and (13) that for large a

Substituting (15) and (16) into (14), one can calculate inner integrals up to the order of e^{2a} ,

Now, taking into account the formula ${R_1 \over 0} {p^2 dp \over 1+e^p} = 3=2$ (3), where is the Riemann zeta function, the two leading terms of e_1 are calculated. The comparison of (3) and (14) then gives

which coincides exactly with the expression given by Takahashi [6].

To conclude, we would like to point out that our approach to the calculation of the correlator is based on the hypothesis of the validity of the ABA and uniform distribution of the numbers Q for the antiferrom agnetic vacuum of the model (1). The approach of ref.[6] refers to the perturbation theory in the atom ic lim it of half-led Hubbard model and the integral representation of its ground-state energy in the thermodynamic lim it which is derived under the assumption on uniform distribution of integers in the Bethe ansatz equations for the model. Hence both results are not absolutely rigorous from mathematical point of view, and their coincidence supports the validity of both approaches. Unfortunately, neither our method nor the method of Takahashi [6] can be used for the calculations of higher correlators. It seems that these calculations will be possible if one will not the method of reduction of multiple integrals in general form ulae of [4]. Till now, there is no recipe of doing this even for the second-neighbor correlator (17).
