# SUPERCONDUCTING CONDENSATE FORMATION IN METALLIC SYSTEMSW ITH ARBITRARY CARRIER DENSITY

#### Abstract

This article gives a contemporary and to some extent pedagogical review of the current theoretical understanding of the form ation of the superconducting state in metallic systems with a variable density of carriers. We make an attempt to describe the crossover from the Bose-Einstein condensation type (sm all densities) to the Bardeen-Cooper-Schrie er one (large densities). The functional methods are used throughout the treatment. The most of the results are considered in a review form for the rst time. Some of them (in particular, the possible opening of a pseudogap) are used to explain the experimental data available for high-temperatures superconductors.

# 1 Introduction

#### 1.1 The general form ulation of the problem

It is wellknown that there are two fundam ental limiting descriptions which allow us to understand the equilibrium low temperature "superphenom ena", such as superconductivity and super uidity, in 3D system s:

i) Bardeen-Cooper-Schrie er (BCS) theory [1], in which the norm al state is a degenerate Ferm i liquid that undergoes a cooperative pairing (Cooper) instability at the tem perature  $T_{\rm P}$ . Here two processes, the form ation of Cooper pairs and their condensation (macroscopic occupation of a single quantum state), occur simultaneously at the transition tem perature,  $T_{\rm c}^{\rm 3D}=T_{\rm P}$ .

ii) Bose-Einstein condensation (BEC) of bosons (see e.g. [2]) in another single quantum state at the temperature  $T_B$ . In fact, these bosons (for instance, <sup>4</sup>He) are tightly bound (composite) particles made up of an even number of fermions. The bosonic particles are formed at some high temperature  $T_P$  of their binding (dissociation). However in contrast to the BCS case, these "pre-formed" bosons condense only at  $T_B$   $T_P$ . The abovementioned single quantum states as well as an intermediate case, which we will discuss below in details, are usually described by an order parameter which is hom ogeneous in the 3D case assuming that there are no external edds.

M ost, if not all, of the real 3D systems clearly fall into either category i) or ii). For example,  ${}^{3}\text{H}\,\text{e}$  and essentially all m etallic superconductors that we now understand are Ferm i super uids described by the rst category, whereas  ${}^{4}\text{H}\,\text{e}$  is a Bose super uid described by the second one.

Nevertheless, the general problem of the crossover (or interpolation) from the BCS scenario of superconductivity with cooperative C ooper pairing to the form ation of com – posite (separate) bosons and their BEC has rem ained of great interest for a long time. It is connected primarily with a deeper understanding of the phenom enon of superconductivity even for 3D systems which are clearly closer to the BCS limit.

The signi cance of the problem increases when one tries to reduce the dimensionality of space from 3D to 2D. In such a case the problem acquires not only fundamental signi cance, but also practical importance. The latter, as we shall discuss below, is mainly related to the discovery of the high-temperature superconductors (HTSC) [3]. It is not the only reason for the widespread interest in the problem of the crossover. Even from the theoretical point of view the 2D crossover is farm ore mysterious than the 3D one. At

rst glance the BCS lim it with weak attraction and high ferm ion density is completely di erent from the Bose lim it with strong coupling and low boson density. Indeed, the simplest BCS theory predicts a nite value of  $T_c^{2D} = T_P^{2D}$  while the BEC is forbidden in 2D systems for massive bosons [2] for which  $T_B^{2D}$  0. This is the reason one m ight ask whether it is possible to obtain a 2D crossover.

It is worthwhile to note here that by virtue of the Colem an-M erm in-W agner-H ohenberg theorem [4] a "super-behaviour"  $^1$  with hom ogeneous order parameter (the latter related to breaking of some continuous symmetry) is not possible for pure 2D systems. This is

due to the uctuations of the order parameter (in particular of its phase) destroying the long-range order [5] (see also [6]). Therefore, the temperature  $T_c^{2D}$  of establishing long-range order has to be zero. The statement that  $T_B^{2D} = 0$  is in agreement with this general theorem. In fact the BCS result  $T_P^{2D}$  does not contradict these theorems if one remembers that as a rule the BCS theory presupposes the mean eld (MF) approach. Thus it does not take into account any uctuations and the result only means that  $T_c^{MF(2D)} = T_P^{2D} \notin 0$ , while the temperature  $T_c^{2D}$  of actually establishing the long-range order is zero in this case as well. Such a conclusion, however, results in a general question: how can one study 2D m odels of superconductors with nite  $T_c$  values?

There are at least two ways to answer this question. First, 2D m odels are only a m athem atical idealization and any real system m ust be at least quasi-two dimensional (quasi-2D). This immediately gives  $T_c \in 0$ , although  $T_c < T_c^{M \ F}$ . Second, there is another interesting possibility for 2D systems to pass into the super uid state at a tem perature which is usually denoted by  $T_{B \ K \ T}$ . This corresponds to the so called B erezinskii-K osterlitz-T houless (BKT) phase transition. The BKT super uid state has an inhom ogeneous order parameter and is therefore not forbidden by the above-m entioned 2D theorem s. The form ation of this state is quite di erent from the ordinary superconducting transition and results in a new way of condensation (see Chapter 5).

The possibility for real systems to undergo the BKT transition crucially depends on their spatial anisotropy. Thus, one should study both 2D and quasi-2D cases.

A nother in portant aspect of the crossover problem is related to the following unusual property of the HTSC compounds. A lm ost all the physical characteristics of HTSC's ( $T_c$  included) crucially depend on the itinerant carrier density. This means that the crossover in superconducting systems cannot be studied without taking into account the changing delocalized ferm ion density. We believe that many of the HTSC "anom alies" are caused by the unusual (two-stage) form ation of the superconducting state in 2D and (very probably) quasi-2D systems with an arbitrary carrier density [9].

Hopefully, this short introduction has convinced the potential readers that the superconducting condensate form ation at the di erent densities of interacting ferm ions (in particular, in the BCS and Bose limiting cases) deserves a separate review.

### 1.2 H istory

The idea that the composite bosons (or, as they called, local pairs) exist and de ne the superconducting properties of m etals is in fact m one then 10 years older than the BCS theory. A searly as 1946, a sensational communication appeared saying that the chem istersperim entator 0 gg had observed superconductivity in the solution of N a in NH<sub>3</sub> at 77K [10]. It is very interesting that the researcher m ade an attempt to interpret his own result in terms of the BEC of paired electrons. Unfortunately, the discovery was not commed and both it and his theoretical concept, were soon completely forgotten (for the details see e.g. [11]).

It is appropriate to note that the history of superconductivity has many similar examples. Probably, this explains why Bednorz and Muller named their rst paper "Possible high-T<sub>c</sub> superconductivity..." [3]. And even today there appear many uncon rm ed com – munications about room -tem perature superconducting transitions.

A new step, the developm ent of the local pair concept, was taken in 1954 by Schafroth

who in fact re-discovered the idea of the electronic quasimolecules [12]. This idea was further developed in the Schafroth, B latt and Butler theory of quasi-chem ical equilibrium [13], where superconductivity was considered versus the BEC. Such a scenario, unfortunately, could not compete with the BCS one due to some m athem atical di culties which did not allow the authors to obtain the fam ous BCS results. Then the trium ph of the BCS theory replaced the farm ore obvious concept of the local pairs and their BEC by the C cooper ones and their instability which takes place in the necessary presence of a Ferm i surface (m ore precisely a nite density of states at the Ferm i level). In contrast for the local (i.e. separated) pairs the form ation is not in principle connected to this density of electronic states. A lso unlike the local pairs, the C cooper ones are highly overlapping in real space. Therefore, the C cooper pairing should be understood as a momentum space pairing.

Later experiment reminded us about the local pairs. It was Frederikse et al. [14] who found that the superconducting compound SrT iO<sub>3</sub> ( $T_c$  0:3K) has a relatively low density of carriers and, moreover, this density is controlled by Zr doping. The rst deep discussion of the possibility of the BCS-Bose crossover and pairing above the superconductivity transition temperature for a low density of carriers was carried out by Eagles [15] (see also his et al. relatively recent article [16]) in the context of SrT iO<sub>3</sub>.

The further history of the investigation of the BCS-B ose crossover has been often cited in the current literature. So, we note only that the features of 3D crossover at T = 0 were considered in [17], and its extension to nite temperatures was rst given by Nozieres and Schm itt-R ink [18].

The 2D crossover in super uid  ${}^{3}\text{He}$  was studied in [19], where the very natural and convenient physical parameter "<sub>b</sub>, the bound pair state energy, was rst used.

The discovery of HTSC signi cantly stimulated the interest in the problem of crossover and related phenomena. There are many articles dealing with its study and we can only mention some of them at this point [20, 21, 22, 23, 24, 25, 26, 27, 28, 29, 30, 31] (see also the recent excellent review [32] devoted to other aspects of the BCS-Bose crossover, e.g. lattice models, time-dependent G inzburg-Landau theory, numerical study of norm al state crossover etc., which we because of this shall not discuss). We note only that some historical debates are associated with the parallel (and generally speaking independent) development of the macro- and microphysics of super uidity and superconductivity since their discoveries were touched upon by G inzburg in his new extrem ely comprehensive survey [33].

#### 1.3 Relevance to the high-tem perature superconductors

A swe have already mentioned the crossover problem appears to be relevant to the general problem of the understanding of the HTSC. Indeed, these superconducting compounds have some peculiarities which place them much closer to the Bose or at least to the crossover region than majority of low temperature superconductors. We shall discuss the peculiarities in detail here.

Certainly, it is necessary to point out right away that the crossover phenom ena do not (and cannnot) address the problem of the mechanism for HTSC. The problem of HTSC itself is very di cult and controversial. Nevertheless the treatment of the crossover may shed light on some of the features of HTSC.

A lm ost all HTSC reveal following common properties:

a relatively low and easily varied density of itinerant (appeared ow ing to the doping) carriers;

a 2D, orm one exactly quasi-2D, character of the conductivity and the m agnetism;

the block structure of the crystal lattices, i.e. from 1 to 6 superconducting CuQ layers per unit cell.

Let us consider these item s. The ground state of the copper-oxide based materials form s due to the strong antiferrom agnetic spin uctuations in the proximity of the metal-insulator transition (see e.g. review [34]). It seems plausible that further doping of these materials results in the appearance of weakly interacting (i.e. non-strongly correlated) it inerant carriers (holes). However the exact nature of the ground state including the strong electron-electron correlations is in fact not yet established. The density  $n_f$  of these holes is not as large as in ordinary metals, so the mean distance between them proves to be comparable with a pair size  $_0$  or a coherence length  $^2$ . This situation is signi – cantly di erent from the conventional BCS theory where the parameter  $_0$  greatly exceeds the mean distance between carriers which is  $n_f^{1=2}_f$ . Experimentally the dimensionless value of  $k_{\rm F}$  ( $k_{\rm F}$  is the Ferm imomentum) which describes the ratio of the pair size and the distance between carriers is about 5 { 20 for HTSC while for the low-temperature superconductors it is about 10<sup>3</sup> { 10<sup>4</sup> [20, 34].

It follows from the above that the new materials are likely to be in an intermediate regime between the Cooper pairs and the composite bosons, at least when the doping is not large and the value of  $T_c$  is far from the highest possible (optimal) one. Although there is some evidence [28] that HTSC at the optimal doping are closer to the BCS limit than to the Bose one.

Besides, because the coherence length is less than a lattice spacing in the direction perpendicular to the CuO<sub>2</sub> planes (c-direction), the superconductivity in the copper oxides takes place mainly in the isolated  $CuO_2$  layers (or their blocks). This is the reason why pure 2D m odels of HTSC are commonly accepted. Undoubtedly these cuprate layers are connected even if they are situated in di erent unit cells. The mechanisms for this connection (by coherent or incoherent electronic transport) are not yet known exactly. There is no question, how ever, that one has to take into account the possibility of di erent (for instance, direct or indirect) interlayer hoppings to develop a full theory of H T SC. Therefore, strictly speaking, we need to consider quasi-2D m odels of these superconductors. M oreover, as we have already m entioned, it is necessary to extend the system into a third-dimension in order to have a nite value for T<sub>c</sub>. It can be seen from the anisotropy of the conductivity that the in uence of the third-dimension varies strongly from one family of cuprates to the other. For example, the anisotropy reaches  $10^5$  for the Bi- and T Hoased cuprates, while its value for YBaCu<sub>3</sub>O<sub>6+</sub> compound is close to  $10^2$ . It seems plausible that in the Bi(T 1)-compounds where the transport in the c-direction is incoherent that the scenario with BKT transition is more probable. In the Y-ones this transport is rather

coherent and the superconducting state, at least at high doping, has a 3D character, with a hom ogeneous condensate which appears in the ordinary way.

In general, it is now evident that, depending on the crystal anisotropies (and/or the relationship between the intensity of c-transport and the doping value) the quasi-2D system s can undergo two or even three phase transitions. The rst one is from the norm al phase to another norm al (with a pseudogap) phase with a nite density of incoherent pairs. The second one is from the latter phase to the BKT phase with an algebraic order. The third and nalone is from the BKT phase to the superconducting phase with long-range order. These possibilities will be discussed below.

The role of interplanar e ects inevitably increases when the superconducting planes are situated in the sam e unit cell so that the carriers in the adjacent layers are strongly coupled and can form interplanar pairs. This possibility together with the concentration e ects brings about the simultaneous existence of the C coper and local pairs in the system [35].

#### 1.4 Outline

The remainder of this review is organized as follows. In Chapter 2 we rst describe the model for studying the BCS-Bose crossover, especially in 3D systems. Then in Section 2.2 we introduce in detail the functional integral formalism which will be used throughout. The rest of this Chapter is devoted to applying the methods developed to the 3D crossover.

The zero temperature 2D crossover is discussed in Chapter 3. Considerable attention will be given to the elective potential (see also Appendix A), which allows one to obtain the main equations. The kinetic term s of the elective action are obtained in Section 3.4. This gives one the possibility to investigate the dependencies of the coherence length and the penetration depth on the carrier density.

In Chapter 4 the quasi-2D crossover is studied.

Finally, the nite temperature 2D crossover is addressed in Chapter 5. We describe how it proves necessary to modify the accepted methods to consider the BKT phase formation (refer also to Appendices B and C) and its dependence on carrier density correctly. An attempt to explain some observable normal state anomalies HTSC is also made.

### 2 3D crossover: critical tem perature

It is most convenient for studying the crossover to start with the 3D case where there is no problem with establishing the long-range order below  $T_c^{3D}$ . We shall mainly follow here the paper [26] (see also the review [32]) in which the corresponding results were obtained by applying the more appropriate in this case the functional integral form alism rather than to the original paper [18].

#### 2.1 M odel

Let us introduce a continuum eld model of fermions with an attractive two-body interaction. Our goal is to consider how the critical temperature  $T_c^{3D}$  changes as a function of attraction and to establish the main factors which determ ine it in the BCS and Bose regimes.

The simplest model is described by the Ham iltonian density

where x r; (r is a 3D vector); (x) is the Ferm i eld; m is the ferm ion e ective m ass;

= ";# is the ferm ion spin; V > 0 is the attraction constant. The chem ical potential xes the average density  $n_f$  of the free (bare) carriers. We choose units in which  $h = k_B = 1$  and the system occupies the volum ev.

Since we want to describe the Bose regime in terms of its constituent fermions, we have to allow the magnitude of the attraction V to be arbitrary. In addition, we cannot use a simple BCS-like cuto  $!_{D} = {}_{F}$  (usually  $!_{D}$  is the D ebye frequency) since we must allow the possibility for all the fermions to be a ected by the interaction, not just for a small fraction ( $!_{D} = {}_{F}$ ) in a shell around the Fermi energy  ${}_{F}$ . We shall thus study a dilute Fermi igas in which the range of the attractive interactions can be characterized by a shape independent parameter, the scattering length  $a_{s}$  in three dimensions. We shall describe in Section 2.3 how the "renorm alized" coupling  $a_{s}^{-1}$  replaces "bare" V.

#### 2.2 Form alism

A swas already noted, the functional integral approach along with the M atsubara therm al technique is more appropriate for the problem that is studied here and in the subsequent Chapters. Thus, let us consider the form alism used.

First of all, introducing Nambu spinors for ferm ion elds [36] (see also [1])

If it was possible to calculate the partition function (2.4) one could, in principle, obtain all therm odynam ical functions from the therm odynam ical potential

Using now the auxiliary Hubbard-Stratonovich complex scalar eld in the usual way one can represent (2.4) in an equivalent form :

The main virtue of this representation is a nonperturbative introduction of the composite elds  $(x) = V \quad {}^{y}(x) + (x) = V \quad {}^{y}_{\pi}(x) \quad {}^{y}_{\#}(x), \quad (x) =$

Speci cally, the expression (2.6) turns out to be rather convenient for studying such a nonperturbative phenom enon as, for example, superconductivity. In this case the com – plex Hubbard-Stratonovich eld naturally describes the order parameter arising due to the form ation of the C ooper or the local pairs. The average value of j j( ) is proportional to the density of pairs, on the one hand, and determ ines the gap in the one-particle Ferm i-spectrum, on the other.

The integration over ferm ion elds in (2.6) can be done form ally even though and depend on the spatial and tem poral coordinates. Thus, one obtains (form ally exactly)

is the one-bop elective action. This action includes in itself a series of term s containing derivatives with respect to (x) and (x). In the lowest orders it corresponds to the G inzburg-Landau elective action.

The operation Tr in (2.8) is taken with respect to the space r, the imaginary time and the N am bu indices. The action (2.8) is expressed through the ferm ion G reen function which obeys the equation:

(v; ;T; ; ). The representation (2.7), (2.8) is exact, although to perform the calculation in practice it is necessary to restrict ourselves to some approximation. Below we shall use the assumption, generally accepted in the 3D case (and in some quasi-2D system s), that the approximation including only the quadratic (G auss) uctuations of the elds (x) and (x) (about their equilibrium values which will now also be denoted as ) describes the system quite well <sup>3</sup>.

The therm odynamical potential as well as the partition sum Z now depend on and which play the role of the order parameter. The order parameter appears due to the fact that one uses the elective potential (v; ;T; ; ) instead of the exact potential (v; ;T). Thus, it becomes necessary to write down the additional equations which determ ine the values of and .

M oreover, in some cases it is su cient to use the mean eld approximation as is done in the original BCS theory. Here, however, we include the uctuations also. Therefore, one obtains

Here we use the notation  $T_c^{M\ F}$  rather than  $T_c^{3D}$  because pot describes the system in the mean eld approximation only. In such a case  $T_c^{M\ F}$  does not depend signi cantly on the dimensionality of the space. Besides, as it will be seen, the value of  $T_c^{M\ F}$  may signi cantly exceed  $T_c^{3D}$  (or the tem perature of real condensation) in the strong coupling regime.

Before proceeding further, we need to describe how we regulate the ultraviolet divergence in the gap equation (2.21). The idea is to replace the bare V by the low energy lim it of the two body T-m atrix (in the absence of a medium). In the 3D case we use the form ula [32]

As a function of the bare interaction,  $a_s^{-1}$  increases monotonically from 1 for a very weak attraction to +1 for strong attractive interaction. Above the two-body bound state threshold in vacuum  $(a_s^{-1} = 0)$ ,  $a_s$  in fact is the "size" of this bound state with energy  $E_b = -1 = m a_s^2$ . The dimensionless coupling constant in the dilute gas model is then  $1 = k_F a_s$ , which ranges from

1 in the weak coupling (BCS)  $\lim it to +1$  in the strong coupling (Bose) one.

U sing (2.22) and (2.21) one obtains directly the equation for the introduced transition temperature  $T_c^{M\ F}$  in terms of the renormalized coupling  $a_s$ :

The equations can also be solved analytically in the strong coupling limit, where, however, one observes that the roles of the gap and number equations are reversed: the gap equation (2.23) determines , while the number equation determines  $T_c^{M\ F}$ . In this limit 1=k<sub>F</sub> a<sub>s</sub> ! +1 and one nds tightly bound (separate) pairs with the energy  $E_b$  j=

1=m  $a_s^2$  (and  $f_b j_F$ ). The non-degenerate Ferm i system has here  $f_b j=2$  and its  $T_c^{MF}$  '  $f_b j=2 \ln (f_b j=F)^{3=2}$ . But really such a system can be hardly recognized as a Ferm i system because all the ferm ions are bound in the pairs, so (at least at rather sm all tem peratures) they in fact form Bose (local pair) system.

This unbounded grow th of the "transition tem perature" is an artifact of the approximation and there is, in fact, no sharp phase transition at  $T_c^{M F}$  (outside of weak coupling where  $T_c^{M F} = T_c^{3D}$  ignoring the smalle ects of thermal uctuations). The point is that the mean eld approximation becomes progressively worse with increasing coupling: the eldive potential (2.19) at = 0 can only describe a normal state consisting of essentially non-interacting ferm ions.

W hile this is adequate for weak coupling, in the strong coupling lim it unbound ferm ions exist in the norm all state only at very high temperatures. In this limit, where the system is completely non-degenerate, a simple "chemical equilibrium " analysis (boson ) 2 ferm ions) yields a dissociation (pairing) temperature  $T_{dissoc} = E_b = \ln (E_b = F)^{3=2} (-F_b)$ . We thus get convinced that for strong coupling  $T_c^{M-F}$  is related to the pair dissociation scale rather than the  $T_c^{3D}$  ( $-T_c^{M-F}$ ) at which the coherence is established. As it will be seen below the temperature  $T_p$  has an evident physical meaning in the 2D case: in the region  $T_{BKT} < T < T_p$  (further T) the system does not have a condensate (superconducting state) but its one-particle spectrum acquires some features (in particular, the pseudogap) of superconductivity.

#### 2.4 Beyond the mean eld approximation

As we have seen the mean eld therm odynamical potential (2.13) (or its direct form (2.19)) cannot be used to access the strong coupling limit. Therefore, to achieve this limit we have to include the elects of the order parameter uctuations. It was already shown in Section 2.2 that treating the uctuations at the Gaussian level is done by the partition function (2.12). It allows to incorporate the uctuation into both the gap (2.20) and number (2.24) equations by adding the uctuation correction to  $_{pot}(v; ;T; ;)$ . As discussed in [18, 32] in the 3D case it is su cient, however, to take into account the uctuation elects through the number equation only. That is why we do not need the correction 0 ( $_{pot})=0$  j =  $_{0}=0$  to the gap equation.

Consequently, we can restrict ourselves to calculation of the partition function at the critical tem perature given by (2.21) that follows from (2.14) only. This perm its us to get the uctuation correction to the number equation (2.24). Thus, one nally obtains from (2.14) that

One sees from (2.30) that the system of fermions is separated into two coexisting and dynamically bounded subsystem s: Fermi particles, or unbound fermions with density  $n_F$  ( $;T_c^{3D}$ ), and local pairs, or bosons with density  $n_B$  ( $;T_c^{3D}$ ). Such an interpretation is possible and natural on the critical line only, when the nite density of condensate j j is not included nonperturbatively in  $n_F$  (;T). Besides, as we shall demonstrate in Chapter 5, if the order parameter has a nonzero value, one can study the num ber equation without taking into account the bosonic contribution.

The tem perature  $T_c^{3D}$  at which hom ogeneous long-range order is established is de ned by the solution of (2.23) together with (2.30). At weak coupling (large  $n_f$ ), the results are essentially una ected by the inclusion of G aussian uctuations in the number equation and  $T_c^{3D}$  is the same as the mean eld  $T_c^{MF}$  obtained above (see (2.26)).

In fact the equations can be solved in the Bose limit too. >From (2.23) we nd  $(T_c^{3D}) = f_b = 2$ , which is one-half the energy required to break a pair. Further, (2.31) can be simplied because the inequality j = T 1 is satisfied. From this inequality it follows that the isolated pole of (!;K) on the real axis is situated far from the branch cut. The pole and the cut represent a two-body bound state with the center-ofm ass momentum K and the continuum of two-particle fermionic excitations, respectively. The low energy physics for T  $T_c^{MF}$  is thus dom inated by this pole, and one can approximate the phase at the pole by (!;K)' (!  $K^2=4m + 2 + f_b$ ), so that

Sum marizing the underlying physics in these limiting cases it is necessary to stress the following [18]:

i) The value of  $T_c^{3D}$  in the weak coupling lim it results from therm al excitations of individual particles.

ii) In strong coupling case,  $T_c^{3D}$  results from therm alexcitations of collective modes. These excitations are outside the range of mean eld theory. That is one of the reasons why we took into account the uctuations.

The physics is thus quite di erent in the two limits considered: the pair breaking in the rst case and the motion of bound pairs in the other.

The results of the numerical solution of the equations are presented in [26] (see also [32]). It may be worth commenting that the numerical result for  $T_c^{3D}$  is a non-monotonic function of 1=k<sub>F</sub> a<sub>s</sub> with a maximum value at intermediate coupling which is slightly larger than the BEC value. The last is independent of the coupling constant. The situation is completely di erent for the discrete (lattice) model of the 3D crossover [18] where  $T_c^{3D}$  decreases as the coupling increases. So, certainly there is an optim alvalue of the coupling for  $T_c^{3D}$ . The latter will also take place for the quasi-2D model which is in fact discrete in the third direction. We shall discuss such a model in Chapter 4.

# 3 2D crossover: T = 0

A swe discussed in Introduction the 2D case has attracted much attention partly because its possible relevance to the layered  $\rm H\,T\,SC$  .

To avoid the above-mentioned problem of how to determ ine the  $T_c$  value correctly in the strictly 2D system it is worthwhile to start with the zero temperature case. The problem thus becomes, due to the integration over frequency (which replaces the summation over M atsubara frequencies), electively a 3D one. Therefore, the 2D theorem s [4] are not applicable to this case and one can speak about long-range order in the 2D system s at T = 0.

We shall follow here the paper [24] (see also its extended version in [37, 38]) where the most general functional methods were used throughout. However, it is more convenient to go to the lim it T = 0 in the expressions from the previous C hapter rather than use the zero tem perature technique as it was done in [24].

#### 3.1 M odel

The model H am iltonian that we shall consider coincides with (2.1) with one very im – portant exception: the dimensionality of the space here d = 2. This fact is crucial in the choice of the parameter which one has to change to trace the crossover. The fact is that 3D bound states in vacuum are known to form only if the corresponding coupling constant V exceeds some threshold. Thus, for the real cases one cannot achieve the Bose regime even at very low carrier densities if the attraction is not strong enough. This is the main reason why we have studied the 3D crossover as the function of the "renorm alized" coupling  $a_s^{-1}$  which corresponds to the "size" (radius) of the bound state at  $a_s^{-1} = 0$  only.

A thresholdless bound state formation in the 2D space [39] leads us to the important conclusion that one can reach the Bose regime by decreasing the density  $n_f$  of bare

ferm ions at any coupling. So, to study the 2D crossover it is convenient and quite natural to regulate the density of carriers, or the Ferm ienergy  $_{\rm F}$ , which is the same for 2D m etals with the simplest quadratic dispersion law:  $_{\rm F}$  =  $n_{\rm f}$ =m . In doing so, the coupling V should be replaced by its renormalized value  $"_{\rm b}$  which is the energy of the bound state in vacuum . We stress here once again that this parameter can be dened in the 2D case at any bare coupling V. The dimensionless coupling constant in the 2D case { the physical analog (see above) of  $1=k_{\rm F}\,a_{\rm s}$  in 3D { is thus given by the ratio  $_{\rm F}=j"_{\rm b}j$  which changes from 0 (in the Bose lim it  $n_{\rm f}$ ! 0) to 1 (in the BCS lim it when  $n_{\rm f}$ ! 1).

#### 3.2 The E ective Action and Potential

A swe have already noted in the general case, (2.8) is in possible for dependent on x. However, if one assumes the gradients of and to be small the action (2.8) can be naturally divided into kinetic and potential parts

The analytic solution of the problem for the 2D case that we consider here is easier than the 3D one. Indeed, after performing the integration over k in (3.2) one directly obtains that

<sup>&</sup>lt;sup>4</sup>There is another transform ation (when the sign of the phase is defined by the fermion spin rather than the charge) under which the Ham iltonian (2.1) (or (2.3)) is also invariant. Such a transform ation proves to be important for fermion-fermion repulsion (i.e. V < 0), or for the fermion-antiferm ion (electron-hole) channel of pairing. Apart from this difference the physics for the case of a repulsive interaction is identical to that under consideration. The complete set of gauge transform ations for the Ham iltonian under consideration were originally given by Nam bu [36].

Equations (3.6) and (3.8), which were obtained in the mean eld approximation which is quite su cient at T = 0, make up a set for noting the quantities and as functions of W and <sub>F</sub> (or  $n_f$ ). It diers from the similar set of [20] by the explicit dependence on W that, in principle, can be important for the case of narrow or multi-band system s [35].

It should also be noted (see also the discussion after the equation (2.24)) that the necessity to utilize the system of equations in order to nd self-consistently and has been known for a long time (see [1]). However, the ferm ion density in real 3D m etals is virtually unchanged in practice so that, as a rule, the equation for is trivialized to the equation  $=_{\rm F}$  and only the value is regarded as unknown. The importance of the second equation for sm all particle densities was earlier pointed out in the papers [15, 17].

Equations (3.6) and (3.8) allow, along with the trivial solution ( = 0, =  $_{\rm F}$ ) the nontrivial one:

The introduction of the expression (3.10) enables one to take the lim it W  $_{\rm F}$  and thus justiles to a certain degree the use of the parabolic dispersion law. Second the thing parameter " $_{\rm b}$  is more physically relevant. For example it is well-de ned even for potentials with repulsion. We stress that the introduction of " $_{\rm b}$  instead of V also allow s us to regulate the ultraviolet divergence, which is in fact present in the gap equation (3.6). So, this step is quite similar to the step from equation (2.21) to (2.23).

It should be mentioned that, in a dilute gas model, the existence of a two-body bound state in vacuum is a necessary (and su cient) condition for a Cooper instability [19, 20, 32]. This statement becomes nontrivial if one considers two-body potentials V (r) with short-range repulsion (e.g., hard-core plus attraction), so that one has to cross a nite (but really very weak [39]) threshold in the attraction before a bound state form s in vacuum.

Thus, by making use of (3.10) it is easy to simplify (3.9) [19, 20, 32]:

To understand the physical signi cance of these remarkably simple results we look at the two limits of this solution. For very weak attraction (or high density) the two-particle binding energy is extremely small, i.e.  $\mathbf{j}_{b}^{r}\mathbf{j}_{b}$ , and it is seen that we recover the well-known BCS results with strongly overlapping in r-space Cooper pairs. The chemical potential  $'_{F}$ , and the gap function  $_{F}$ .

In the opposite limit of very strong attraction (or a very low particle density) we have a deep two-body bound state  $\mathbf{j}^{r}_{b}\mathbf{j}_{F}$ , and nd that we are in a regime in which there is BEC of composite bosons, or "diatom ic molecules". The chem ical potential here

'  $j_b^* \neq 2$ , which is one half the energy of pair dissociation for tightly bound (local) pairs.

It should also be kept in m ind that in the local pair regime ( < 0) the gap  $E_{gap}$  in the quasiparticle excitation spectrum equals not (as in the case > 0) but rather  $P \frac{2}{2} + \frac{2}{2}$  (see [17] and the review [32]).

We note here that for the 3D case this repulsion was obtained in [25] using a diagram matic technique. In the region of high  $n_{\rm f}$ , where > 0, the  $_{\rm pot}$  cannot be represented as a series even for small , which rejects the specific properties of the elective potential in 2D system s.

If, proceeding from (3.4) and (3.9), we not the therm odynamic potential di erence of the trivial and non-trivial solutions, we can easily obtain the result that it takes form

Nevertheless, it can be shown, just as in [20], that the superconducting phase has the lowest internal energy. In addition, the relevant di erence is proportional to  $v (_{F})^{2} ((_{F}) = m = 2)$  being the density of states, which is energy independent in the 2D case); in other words, we arrive at the standard result of the BCS theory [1], which is clearly valid for all values of the ratio  $_{F} = J_{b}^{*}j$ .

#### 3.4 The gradient term s of the e ective action

Now we calculate the terms  $_{kin}$  which contain the derivatives in expansion (3.1). As before, we shall assume the inhomogeneities of and to be small having restricted ourselves only to the terms with lowest derivatives. For simplicity we shall also consider the stationary case and calculate the terms with the second-order spatial derivatives only, which makes it possible to determ ine the coherence length and the penetration depth <sub>H</sub> of the magnetic eld in a 2D superconductor.

W ith these restrictions, taking into account the invariance of (v; ;; ) (see equation (2.8)) with respect to the phase transform ations (3.3) one can write a general form for the kinetic part of the action:

where there are no item s with a total derivative since the boundary e ects are regarded as unessential, and the coe cients T  $_{1,2}$  (j j<sup>2</sup>) are assumed to be unknown quantity. It follows from (3.16) that in the second approximation in derivatives the variations in both the direction (phase) of the eld and its absolute value are taken into account.

Consequently the correct interpretation of  $_0$  is the pair size (in presence of the Ferm i sea (3.30)) rather than the coherence length. The form er in the extrem e Bose regime is much smaller than the mean interparticle spacing, since  ${}_{0}k_{\rm F}$ 1, while always k 1. The meaning of is indeed the coherence length because it remains nite and comparable with the mean interparticle spacing even when  $J_{b}$  jgoes to in nity. This situation is consistent with the case of <sup>4</sup>He where the coherence length is nonzero and comparable with the mean inter-atom ic distance although J'b j (or energy of nucleonnucleon binding) is really extremely large. This means that 2D metals with low  $_{\rm F}$  (so called underdoped case) turn out to be very strongly type-II superconductors. parameter decreases and in the lim it  $_{\rm F}$   $j'_{\rm b}j$  (strongly overdoped case) it is possible (in principle) to obtain the value <1 or in the other words, to change the type of the superconductor.

# 4 Crossover in the quasi-2D system s

A swe have already mentioned in the introduction there are many ways which allow one to extend the zero-temperature analysis of the 2D model from the previous Chapter to the case T  $\leq$  0. Every way has some advantages as well as disadvantages. So, di erent generalizations of the model are to be investigated. Here we shall study a quasi-2D extension, which m ight be relevant for HTSCs with a relatively low anisotropy of the conductivity as, for example, is present in the Y-based cuprates. On the other hand, the quasi-2D model can be considered as an extension of the 3D model from Chapter 2. Our treatment is based on the paper [31] (see also its detailed versions [45, 46]).

#### 4.1 M odel

The simplest model Hamiltonian density for the carriers in the quasi-2D system reads

where x ;  $r_z$  (with  $r_2$  being a 2D vector); (x), and V are already determined; m<sub>2</sub> is an carrier elective mass in the planes (for example, CuO<sub>2</sub> ones); m<sub>z</sub> is an elective mass in the z-direction; d<sub>z</sub> is the interlayer distance.

The H am iltonian proposed proves to be very convenient for study of uctuation stabilization by weak 3D one-particle inter-plane tunnelling. The extension of the 2D system in the third-direction could give rise to a possibility that it may undergo the 3D superconducting transition with the establishment of hom ogeneous long-range order. This transition does not contradict the 2D theorem s [4]. We om itted in (4.1) the two-particle (Josephson) tunnelling considering it here to be smaller than the one-particle already taken into account. There can how ever be situations when Josephson tunnelling becomes more essential then the one-particle coherent one. In addition some authors consider that the most important mechanism for H T SC is the incoherent inter-plane hopping (through, for instance, the impurity (localized) states or due to the assistance of phonons.)

It is signi cant that the large anisotropy of the conductivity cannot be identi ed with the sim ilar anisotropy of the e ective masses m  $_z$  and m  $_2$ . In particular, HTSC with

rather large anisotropy in z-direction do not display the usual metal behaviour at low temperatures. It means that interplane motion of the fermions is incoherent and the BKT transition could take place before the 3D superconducting transition (see the next Chapter). But, as will be seen, for justi cation of approximations used below the modest value of the ratio  $m_z = m_{?}$  10<sup>°</sup> is already su cient. Such a value is present for instance in the HTSC YBa<sub>2</sub>Cu<sub>3</sub>O<sub>6+</sub> (1-2-3). Because of this we shall study the simplest case of tunnelling which is described by the second term in (4.1).

The method for the study of the H am iltonian (4.1) mainly coincides with that used for the 3D model (2.1). So, we shall often refer to the sim ilar form ulae from Chapter 2.

#### 4.2 The mean eld approximation

The e ective potential (2.19) obtained in Appendix A is in fact model independent. Thus, one has to use it together with the dispersion law

It is necessary to emphasize that fot the tem peratures of interest, the band width in the z-direction is  $m_z {}^1d_z {}^2 = T_c^{M} {}^F$ , i.e. the system is really a quasi-2D one. As for the last inequality, it is easy to see, that at  $m_z = 10^2 m_e$  and  $d_z = 10$ A-the value  $h^2 = (m_z d_z^2 k_B)$  10K is really far less then the usual critical tem peratures in HTSC compounds.

Now we need to describe how one can regulate the ultraviolet divergence in the gap equation (2.21). As has been already noted in Section 2.1 for the case of the local-pair superconductivity the cuto of BCS type cannot be applied. Moreover, the regularization by the 3D scattering length  $a_s$  (see the de nition (2.22)) is unsuitable for the quasi-2D system. It turns out that in order to elim inate the divergences in (2.21) it is convenient to introduce, as in the 2D case, the energy of the two-particle bound state (com pare with (3.10))

This expression, except for the second term, is identical to the result described in Section 2.3. Its follows from (4.8) that we obtain a similar result to that in Section 2.3: for xed  $_{\rm F}$ , the value of  $T_{\rm c}^{\rm M\,F}$  grows rapidly as the coupling constant V increases. Thus, for the case of sm all carrier density, the tem perature  $T_{\rm c}^{\rm M\,F}$  is not connected to the critical one  $T_{\rm c}$ , but in fact corresponds to the tem perature of composite boson dissociation (compare with Section 2.3).

## 4.3 The role of G aussian uctuations

In order to investigate the e ects of composite bosons formed in the system, one should again take into account the order parameter uctuations. A swas discussed in the previous Section, one can simply use the expressions from Chapter 2 with (k) determined by (4.2). Thus, the expressions (2.27) and (2.28) may be used directly if one applies the ultraviolet regularization by the energy (4.3) as has been done in Section 4.2. Once again, from (2.27), we arrive at the "conservation law" (2.30).

Let us consider now the in uence of  $n_B$  (;T) determ ined by (2.31) on the behaviour of the system as the carrier density changes. We should solve self-consistently the system of equations (2.21) and (2.30).

At high enough carrier density the contribution of  $n_B$  ( ;T) to (2.30) is negligible, and one arrives at the equality  $T_c$  '  $T_c^{M\ F}$ , where  $T_c^{M\ F}$  is given by (4.5).

Recall (see Section 2.4) that in a more consistent scheme one should take into consideration the correction  $(\ _{pot})=(\ to the gap equation (2.20), and consequently the uctuations modify the equation. This correction may be especially in portant in the quasi-2D case. However, because of the conditions = <math>_{\rm F}$  T<sub>c</sub> and m<sub>z</sub>d<sub>z</sub><sup>2</sup>T<sub>c</sub> 1, one can convince oneself that this correction changes T<sub>c</sub> rather weakly [47] (see also [48]).

Note that the consideration of the correction to the gap equation (2.20) should be very interesting because based on the general 2D theorem s one knows that  $T_c$ ! 0 when  $m_z$ ! 1 (2D case) even though '<sub>F</sub>. To trace this limit the above-mentioned correction must be taken into account. From the other side, when  $m_z$ ! 1 the BKT scenario will take place at any density  $n_f$  and we have to modify the approach from C hapter 2 used here to study the form ation of the inhom ogeneous BKT phase. The latter will be accurately done in the next C hapter.

Turning back to the equality  $T_c$  '  $T_c^{M \ F}$  one can see, using (4.5) (the  $T_c^{M \ F}$  coincides with the expression obtained in [37] for a pure 2D superconductor due to the band narrowness in the  $k_z$ -direction), that  $T_c$  increases with the growth of coupling constant V. This behaviour of  $T_c$  is just as in the 3D case (see (2.26)).

At small concentrations, such that  $j \neq T_c$  1 taking into account the de nition (4.3) in the lim it W ! 1 one obtains from (2.28) that

It is easy to see that the boson e ective mass for its motion in the plane retains the value  $2m_2$ . As for the motion between the planes, the elective boson mass increases considerably:  $2 J_{\rm b}^{\rm 2} j_{\rm z}^{\rm 2} d_{\rm z}^{\rm 2}$  (  $m_z$ ). It can be stressed that this increase has a dynamical character as is testiled simply by the presence of  $J_{\rm b}^{\rm 2} j_{\rm b}$  Physically, it is ensured by the

one-particle character (see equation (4.1)) of the tunnelling between planes which only takes place through the virtual breakup of a pair for which the energy loss is of the order  $J'_{\rm b}$ .

Now, using the formula for the BEC of an ideal quasi-2D Bose-gas [49] (see also the review [43]), it is easy to write down an equation for  $T_c$ , which here takes the simple form

The last equation describes the characteristic properties of a quasi-2D superconductor with small carrier density:

i) rstly, the critical tem perature  $T_c = F$ , or (see above)  $T_c = n_f = 2$ , or the number of the composite bosons, as it should be in 2D case (recall that in a 3D one  $T_c = n_f^{2=3}$  (see (2.33)), in contrast to the MF approximation 2D  $T_c^{MF} = \frac{p}{n_f} = T_c$  [37] (see also (3.11) because usually  $T_c^{MF}$ );

ii) secondly, contrary to the case of the 3D superconductor where  $T_c$  does not depend on V at all (see (2.33)), in a quasi-2D system  $T_c$  does depend on V, namely:  $T_c$  decreases with the growth of V. As was stated above, the reason for this is the dynam ical increase of the composite boson m ass along the third direction. Thus, the growth of  $J_b^r$  (or of V, which is the same) "m akes" the system m ore and m ore two-dimensional even for the simplest case of a quasi-2D m etal with a local four-ferm ion interaction.

It is interesting to note that a decreasing  $T_c$  can also take place in the case when the local pairs are bipolarons [50]; then, the increasing of coupling with phonons, which makes the pairs more massive, also leads to  $T_c$  decreasing, (rather than increasing) as the electron-phonon coupling grow s.

The main results here are not only the expressions (4.5) and (4.12) for  $T_c$  in the di erent limiting cases, namely the cases of large and small V. No less in portant is the comparison of these expressions which show that for a given density of fermions (i.e. a given  $_F$ ) there are two essential regions. If  $\mathbf{j}'_{bj}$   $_F$ , then even in the case of small (by absolute value  $n_f$ ) densities the BCS form ula is valid and  $T_c$  grows with increasing  $\mathbf{j}'_{bj}$  (see (4.5)). In the opposite case,  $\mathbf{j}'_{bj}$   $_F$ ,  $T_c$  decreases with the growth of  $\mathbf{j}'_{bj}$ . It shows that in the case of quasi-2D systems (it seems that the HTSC belong to this case)  $T_c(\mathbf{j}'_{bj})$  has a maximum. Consequently, there is a region (for xed  $\mathbf{j}'_{bj}$ ) of values of  $_F$  for which  $T_c$  increases. If we also take into account the two-particle tunnelling in (4.1), then the previous result will only be a lower bound for  $T_c$  for large  $\mathbf{j}'_{bj}$ . The region of  $_F$   $\mathbf{j}'_{bj}$  inceds special study (see e.g. [6, 51]) because of the presence of both strongly developed uctuations and the possible distinction of properties of such a Ferm i-liquid from the Ferm i-liquid of Landau type.

# 5 2D crossover: nite tem perature

We have already studied the nite temperature (or more exactly  $T_c$ ) crossover for the 3D and quasi-2D models. The 2D crossover at T = 0 crossover was addressed also. So, we are ready to discuss the 2D crossover at  $T \in 0$ . As was stressed in the Introduction (see also [32]) an analytical treatment of the nite T crossover problem in 2D is quite a di cult task. This is primarily related to the necessity to treat  $T_c$  as the BKT temperature  $T_{BKT}$  below

which there is an algebraic (power decay) order and a nite super uid density [8] (see also the review [52] and the book [53]). Nevertheless, some insight into the peculiarities of the form ation of the BKT has been gained [9].

#### 5.1 M odel and Form alism

M ost of previous analyses [54, 55, 56] of the behaviour of the 2D systems at T  $\leq$  0 have been based on a Nozieres-Schm itt-R ink approach [18]. As shown above, this is simply the G aussian approximation to the functional integral which perhaps explains the di culties faced in these calculations. On the one hand, G aussian uctuations destroy long-range order in 2D and if one searches for the  $T_c^{2D}$  at which the order sets in one should get zero in accordance with the above-mentioned theorem s [4]. On the other hand, taking into account G aussian uctuations is completely inadequate to describe the BKT transition.

N onetheless, several steps have been made even in this direction. For example, the BKT transition in the relativistic 2+1-theory was studied in [57], and even the crossover from superconductivity to super uidity was considered in [22] (see also [58]) according to the value of the carrier density  $n_f$  (recall that  $n_f = m_F =$ ). However, the method employed in [22] to the temperature  $T_{BKT}$  has a number of drawbacks.

Speci cally, the equation for  $T_{BKT}$  was obtained neglecting the existence of a neutral (real) order parameter , whose appearance at nite T, being due to the breaking of only a discrete symmetry, is consistent with C olem an-M erm in-W agher-H ohenberg theorem [4]. A swe shall see below, gives the modulus of a multivalued complex order parameter of a 2D system as a whole, and only the modulus determ ines the possibility of the form ation of nonuniform (including vortex) con gurations in the system.

However, as a result of allowing for a neutral order parameter, a region where decays gradually to zero appears in the phase diagram of the system. This region separates the standard norm all phase with = 0 from the BKT phase, where there is the power decay of correlations. D expite of the exponential decay of the correlations in it, this new region of states very likely possesses unusual properties, since appears in all expressions in the same m anner as does the energy gap in the theory of ordinary superconductors, though to calculate the observed single-particle spectrum, of course, the carrier losses due to scattering of carriers by uctuations of the phase of the order parameter and, in case of real system s, by dopants m ust be taken into account [59]. The possible existence of such a phase, which is also in some sense norm al, m ight shed light of the frequently anom alous (see, for example, the review s [34, 60]) behaviour of the norm al state of HT SC, speci cally, the tem perature dependencies of the spin susceptibility, resistivity, speci c heat, photoem ission spectra, and so on [61, 62, 21], for the explanation of which the idea of a pseudogap (and also spin gap) in the region T > T<sub>c</sub> is now widely employed.

Thus, our objective in this Chapter is to calculate  $T_{BKT}$  and T (T is the tem perature at which ! 0) as functions of  $n_f$  and to establish a form of this new region, which lies in the tem perature interval  $T_{BKT} < T < T$ . Besides, we will try to demonstrate using the example of the static spin susceptibility that this phase m ay really be used to explain the above-m entioned anom abus properties of the HTSC. That is the reason why the phase was called the "anom abus norm al" phase.

There is no need to write down the model H am iltonian which is studied here, because it is identical with that of described in Chapter 3.1. The desired phase diagram consisting from normal, anomalous and superconducting phases was calculated rstly in [9] employing the Hubbard-Stratonovich method (see Section 2.2, the equations (2.6) { (2.8)). In the 2D case, however, instead of using the accepted method for calculation the partition function Z (v; ;T;) (see (2.6)), one must to perform the calculation in modulus phase variables. This prevents us from the subsequent treatment of the phase uctuations at G aussian level only. Thus, we will be able to take into account the phase degree of freedom with needed accuracy.

The modulus-phase variables were introduced in accordance with [63], where the parametrization

The representation (5.7) allow some to get a full set of the equations which are necessary to nd out  $T_{BKT}$ ,  $(T_{BKT})$  and  $(T_{BKT})$  at given  $_{F}$  (or, for example, (T) and (T) at given T and  $_{F}$ ). #### 5.2 The equation for $T_{BKT}$

If our model were reduced to a some known model describing the BKT phase transition, we would be easily write the equation for  $T_{BKT}$ . Indeed, in the lowest orders the kinetic term (5.8) coincides with so called classical XY model [52, 53] which has the following continuum Hamiltonian

D expite the very simple form  $^8$  of the equation (5.13), it was derived [8] (see also [52, 53]) using the renorm alization group technique, which takes into account the non-single-valuedness of the phase . A lthough m athem atically the problem reduces to a well-known problem, the analogy is incomplete. Indeed, in the standard XY model (as well as the nonlinear model) the vector (spin) subject to ordering is assumed to be a unit vector with no dependence  $^{10}$  on T. In our case this is fundamentally not the case, and a self-consistent calculation of  $T_{\rm B\,K\,T}$  as a function of  $n_{\rm f}$  requires additional equations for and , which together with (5.18) form a complete system .

Note that these equations coincide with the system which determ ines  $T_c^{(2D)MF}$  and  $(T_c^{(2D)MF})$ (see [37]). This is evidently related with mean-eld approximation used here. There is, however, a crucial di erence between these values. Namely, if one takes into account the uctuations, the value of  $T_c^{2D}$  should go to zero, while the value of T should stay nite. That is the reason why the tem perature T has its own physical meaning: the incoherent (bcalor Cooper) pairs begin to be form ed form ed below T . At higher tem peratures there are these pair uctuations only (see e.g. [51]).

#### 5.4 The phase diagram

The num erical investigation of the system s (5.18), (5.22), (5.21) and (5.24), (5.25) gives the following very interesting results, which are displayed graphically.




Figure 1: T<sub>BKT</sub> and T versus the free ferm ion density. The dots represent the function ( $_{\rm F}$ ) at T = T $_{\rm BKT}$ . The regions of the norm alphase (NP), anom alous norm alphase (ANP) and BKT phase are indicated.

a) The anom alous phase region (see Fig.1) in the present model is commensurate with the BKT region. But it has not been ruled out that in the case of the quasi-2D m odel this region will disappear as nf increases. For example, in the case of an indirect interaction it was shown [65] that the anom alous phase region really exists at the low carrier density only, i.e. it shrinks when the doping increases.

b) For low  $_{\rm F}$  (  $J'_{\rm b}$ ) the function  $T_{\rm BKT}$  ( $_{\rm F}$ ) is linear, as it also con m ed by the analyticalsolution of the system (5.18), (5.22) and (5.21), which gives  $T_{BKT} = F = 2$ . Surprisingly such behaviour (although for T<sub>c</sub>) is copied in di erent fam ilies of non-conventional ("exotic") superconductors (HTSC including) with comparatively small Fermi energy [21].

W e note that in this lim it the tem perature  $T_c$  of form ation of a hom ogeneous order parameter for the quasi-2D model (see Chapter 4, the equation (4.12)) can be written in the following form [65] (see also [21])

This shows that when  $T_c < T_{BKT}$  the weak three-dimensionalization can preserve (in any case, for low  $n_f$ ) the regions of the anom about and BKT phases, which, for example, happens in the relativistic quasi-2D model [66]. At the same time, as the three-dimensionalization parameter  $t_{jj}$  increases, when  $T_c > T_{BKT}$  the BKT phase can vanish, provide, however, that the anom about phase region and both temperatures  $T_q$  and  $T_c$  are preserved. It follows from (5.26) that the BKT phase vanishes when  $t_{jj} > 2 J_b j_F (= )$ .




Figure 2: (T) for di erent values of  $_{\rm F} = J_{\rm b}$ ; 1 | 0.05; 2 | 0.2; 3 | 0.45; 4 | 0.6; 5 | 1; 6 | 2; 7 | 5. (For > 0 and < 0 the chem ical potential was scaled to  $_{\rm F}$  and  $J_{\rm b}$ ; respectively.) The thick lines bound regions of the BKT, anom alous norm al and norm al phases.

c) Figure 2 shows the values  $n_f$  for which di ers substantially from  $_F$  and, in other words, the Landau Ferm i-liquid theory becomes inapplicable form etals with low or intermediate carrier density. As expected, the kink at T = T, experiments on observation which were discussed in [67] and have been interpreted for the 1-2-3 cuprate [68], becomes increasingly less pronounced as  $_F$  increases. But in the present case it is interesting that in the approximation employed it happens at the norm al-anom alous phases boundary or before superconductivity really appears. Therefore it would be of great interest to perform experiments which would reveal the temperature dependence (T) especially for strongly anisotropic and relatively weakly doped cuprates.

d) It follows from curve 3 in Fig. 2 that the transition (change in sign of ) from local to

Cooper pairs is possible not only as  $_{\rm F}$  increases, which is more or less obvious, but also (for som e n<sub>f</sub>) as T increases.




Figure 3: 2 =  $T_{BKT}$  and 2 = T versus the free ferm ion density.

e) Finally the calculations showed (see Fig. 3) that the ratio  $2 = T_{BKT}$  is always greater than 4.4. The value  $2 = T (= 2 = T_c^{MF})$  is, however, somewhat lower and reaches the BCS theory limit of 3.52 only for  $F_{T}$  j<sup>T</sup><sub>b</sub>j. It is interesting that this concentration behaviour is consistent with num erous measurements of this ratio in HTSC [69, 70]. Note that the divergencies of  $2 = T_{BKT}$  and 2 = T at F! 0 are directly related with the denition (5.23).

D iscussing the phase diagram obtained it can be emphasized that the qualitative ideas about the crucial in portance of phase uctuations for underdoped HTSC was, to our know ledge, rst discussed by Em ery and K ivelson [6]. These authors, starting from the experimental data of U em ura et al. [21] and some others (see the Refs. cited in [6]), and from the well-known general observation the superconducting state is characterized by a complex order parameter, introduced the temperature T at which phase order can occur. They have also argued that at low superconducting carrier density and poor screening (i.e. in bad metals) phase uctuations become more signi cant than all other uctuations, so that the classical XY-model is suitable for underdoped cuprate oxides. W hen  $T_c = T^{max}$  ( $T^{max}$  is the temperature at which the phase order disappears if the disordering e ects of all the other degrees of freedom are ignored), phase uctuations must be relatively unimportant and the observable  $T_c$  will be close to the  $T_c^{M-F}$  predicted by BCS-Bogolyubov theory. Otherwise,  $T_c = T^{max} < T_c^{M-F}$ , and  $T_c^{M-F}$  is simply the temperature at which local pairing occurs.

Undoubtedly, the approach developed in this Chapter is self-consistent and a moreor-less complete (in the hydrodynamical approximation) extension of the sem iqualitative results presented in [6, 21]. At the same time there is only one difference (but in our opinion an essential one) between the behaviour of the function we obtain for  $T_c^{MF}$  ( $n_f$ )

T  $(n_f)$  in the lim it  $n_f ! 0$  and the function sketched for  $T_c^{M F}$  in [6]. It is clear from the gure (see Fig.1) (and can be shown analytically) that in our case the zero density lim it is T (0) = 0, in contrast to Refs. [6, 21] where  $T_c^{M F}$  grows when  $n_f$  decreases.

On the other hand, the lim it T ( $n_f ! 0$ ) ! 0 (the same argument also applies to  $T_{dissoc}$  in Section 2.3) cannot be considered su ciently regular due to the strong increase,

for smalln<sub>f</sub>, of the neutral order parameter uctuations which were not taken into account in the approximation used. From the physical point of view perhaps the most consistent lim it for this, extremely low (when < 0) fermion density, region is: T (n<sub>f</sub> ! 0) ! T<sub>P</sub>  $2^{\frac{1}{2} + \frac{2}{2}}$   $J_{b}^{*}j$  (see (5.23) and Fig.2).

#### 5.5 "Spin-gap" behaviour in the anom alous norm alphase

It would be very interesting to study how a nonzero value of the neutral order param eter a ects the observable properties of the 2D system. Does this really resemble the gap opening in the traditional superconductors, except that it happens in the norm alphase? Or, in other words, does the pseudogap open?

W e shall dem on strate this phenom enon taking, as a case in point, the param agnetic susceptibility of the system  $^{11}$ .

To study the system in the magnetic eld H one has to add the param agnetic term




Figure 4: (T) for dimensional dimensional for the second state of  $F = J_{b}^{*} j : 1 | 0.2; 2 | 0.6; 3 | 1; 4 | 5; 5 | 10; 6 | 20.$ 

The results of num erical study of the system (5.34), (5.22) and (5.21) are presented in Fig. 4. One can see that the kink in happens at T = T as in the dependence of on T.Below T the value of (T) decreases, although the system is still norm al. This means that the spin-gap (pseudogap) opens. The size of the pseudogap region depends strongly on the doping ( $_{\rm F} = J_{\rm b}$ ), as it takes place for the real HTSC [61, 62, 60]. For sm all values of  $_{\rm F} = J_{\rm b}$  this region is large (T >  $2T_{\rm BKT}$ ), while for the large ratio it is sm all.

## 6 Concluding rem arks

To sum m arize we have discussed the crossover in the superconducting transition between BCS- and Bose-like behaviour for the sim plest 3D, quasi-2D and 2D m odels with s-wave direct nonretarded attractive interaction. It has been pointed out that optim ally doped HTSC are still on the BCS side of this crossover, although they are certainly far away from the standard BCS description.

Above we emphasized the model description which in our opinion proves to be the most suitable for the clari cation of the diverse physical properties peculiar to electronic systems with changeable carrier density in any dimension. While there is still no generally accepted microscopic theory of HTSC compounds and their basic features (including the pairing mechanism), it seems to us that this approach, although in a sense phenom enological, is of great interest since it is able to cover the whole region of carrier concentrations (and consequently the whole range of coupling constants), temperatures and crystal anisotropies. It, as we tried to demonstrate, allows one not only to propose a reasonable interpretation for the observed phenom ena caused by doping but also to predict new phenom ena (for example, pseudogap phase form ation as a new therm odynam ically equilibrium norm al state of low dimensional conducting electronic system s).

Evidently there are a number of in portant open questions. They may be divided into two classes: the stone concerns the problem of a better and more complete treatment of the models them selves. The second class is related to the problem of to what extent these model are applicable to HTSC compounds and what are the necessary ingredients for a more realistic description.

Regarding our treatment of the 3D and quasi-2D models, it is obvious that one has to take into account the interaction between the bosons also. In particular the G aussian approximation is not su cient to give reliable results for T<sub>c</sub> at intermediate coupling when the "size" of the bosons is comparable with the mean distance between them. As for the 2D model, there is some uncon rmed numerical result [71] based on a fully self-consistent determination of a phase transition to a superconducting state in a conserving approximation, which state that the superconducting transition is not the BKT transition. Besides, it would be very interesting to obtain the spectrum of the anom alous norm al phase.

Concerning the question to which them odels considered are really applicable to HTSC, it is obvious that most of the complexity of these systems is neglected here. We did not take into account an indirect nature of the interaction between the ferm ions and d-wave pairing. Note, however, that some attempts to study the crossover for these cases were made [72, 73, 58] (for general review see [34]).

A lot of peculiarities of HTSC are now connected with stripe structure of  $CuO_2$  planes, which, according to m any experiments (see [74] and references therein), are divided onto bands of the norm all and superconducting bands. There is interesting and important problem how to investigate these system s.

The problem of the crossover from BEC to BCS (especially for 2D systems) is such a rich one that without doubt will bring us a lot of surprises in the near and far future. One of them is perhaps the united theory of superconductivity and magnetism [75] which has already excited a lot of interest and criticism (e.g. [76]).
