Transverse Spin Di usion in a Dilute Spin-Polarized Degenerate Ferm i Gas

We re-exam ine the calculation of the transverse spin-di usion one cient in a dilute degenerate spin-polarized Ferm i gas, for the case of s-wave scattering. The special feature of this lim it is that the dependence of the spin di usion one cient on temperature and eld can be calculated explicitly with no further approximations. This exact solution uncovers a novel intermediate behaviour between the high eld spin-rotation dominated regime in which D_2 / H^2 , D_k / T^2 , and the low-eld isotropic, collision dominated regime with $D_2 = D_k / T^2$. In this intermediate regime, $D_{2,k} / T^2$ but $D_2 \in D_k$. We emphasize that the low-eld crossover cannot be described within the relaxation time approximation. We also present an analytical calculation of the self-energy in the s-wave approximation for a dilute spin-polarized Ferm i gas, at zero temperature. This emphasizes the failure of the conventional Ferm i-liquid phase space arguments for processes involving spin ips. We close by reviewing the evidence for the existence of the intermediate regime in

experim ents on weakly spin-polarized ${}^{3}\mathrm{He}$ and ${}^{3}\mathrm{He}$ 4 He m ixtures.

I. IN TRODUCTION

The unusual features of spin dynam ics in spin-polarized quantum systems have been intensively studied since the pioneering paper of Leggett and Rice [1] on spin di usion in normal liquid ³He. The main e ect arises from the observation that the presence of a molecular eld (induced by the applied magnetic eld) leads to an additional precession of the spin-current which in steady state acquires a component perpendicular to the magnetization gradient; through the continuity equation this results in an anomalous reactive component (damped spin-wave) to spin transport. This \spin-rotation" e ect is also present in the case of spin-polarized Boltzmann gases [2].

From a microscopic point of view, it was expected that a number of qualitatively novel phenomenam ight arise in the case of succently high polarizations [3]. A natural suggestion, made by Meyerovich [4], was that low-temperature spin-diusion becomes highly anisotropic for nite polarizations. More precisely, processes involving spin-ips make use of the phase-space volume between the two distinct Fermi surfaces (for \up" and \down" spins) leading to a nite scattering rate in the limit of T! 0. This is in contrast with processes involving scattering in the vicinity of each of the Fermi surfaces which are subject to the phase-space restrictions of unpolarized Fermi liquids and are thus characterized by the conventional Fermi-liquid behaviour of scattering rates, / T^2 [5]. Meyerovich's suggestion was recently supported by measurements of the transverse spin-diusion coecient in weakly polarized liquid 3 He [6]. Theoretically, D_2 was calculated in the dilute gas $\lim_{n \to \infty} \mathbb{T}_n$ and u the only available estimates are based on a variational solution of the Boltzmann equation [7,9], or on a phenomenological Mathiessen-type rule [10].

In this paper we present the analytical calculation of the nite tem perature behaviour of D_2 for a dilute Ferm i gas in the s-wave approximation, by solving the appropriate kinetic equations exactly. While at H $\stackrel{>}{}$ Tour results for D_2 agree with those of previous work [7,9], in the opposite case of T $\stackrel{>}{}$ H the exact solution of kinetic equation results in a qualitatively new behaviour of D_2 . We show, that the crossover between the high-eld and

low – eld behaviours is described by two dimensionless parameters rather than only one as implied in Refs. [7,9,10]: The rst is the ratio H=T, which determines whether the phase space that is available for interparticle scattering is due to the eld-induced splitting of the Fermispheres (H=T) or to the temperature smearing of the Fermi distribution function (H=T). The distribution coescient is, roughly speaking, inversely proportional to the square of the available phase space volume; and hence in the two limits we obtain D_2/H^2 and D_3/H^2 , respectively. The second parameter,

(a is the s-wave scattering length and $_{\rm F}$ and $_{\rm F}$ are Ferm i energy and momentum in the absence of magnetic eld) is the ratio of two frequency scales appearing in the kinetic equations for transverse spin di usion, $= !_1 = !_2$. The scale $!_2$ is determined by the thermal term in the transverse relaxation rate, $!_2 = 1 = _{\rm T} = m \, a^2 T^2$, where m is particle mass; while $!_1 = ap_1 H$ is the molecular eld contribution to the precession frequency of the transverse spin current. (Its origin is the spin-dependent exchange scattering amplitude of two particles interacting through a spin-independent interparticle potential [1]). Thus, the value of measures the number of oscillations of the spin current during a collision time. For 1 the \spin-rotation" e ect strongly a ects the spin di usion process, which remains anisotropic even for H T: in this case, we obtain D? 0.89D_k. The crossover to isotropic behaviour occurs for 1, so that D? D_k only once 1.

We note that the crossover between isotropic and anisotropic behaviours of D_{? ik} at 1 has already been discussed previously [11,12]. However, the qualitative changes in the collision integral which occur at H T were overlooked. Similarly, the subtleties that arise in the solution of Boltzmann equation at 1 have not been noticed in Refs. [7,9,10], which however provide the correct results for 1. In the present paper, we will give the complete description of eld and temperature dependence of D_? for a dilute gas (within the s-wave approximation for the two-body scattering) which is valid for any value of H provided that the gas remains degenerate for both values of spin projection,

where $p_{";\sharp}$ are the Ferm im omenta for spin-up and spin-down particles:

N $_{";\#}$ are the numbers of spin-up and spin-down particles per unit volume, M $_k$ is the longitudinal magnetization per unit volume induced by the eld H , and N is the density of the gas. A short account of the present work was already published in Ref. [13].

W e emphasize that throughout this paper we concentrate on the hydrodynam ic regime de ned by nite longitudinal and transverse relaxation times, 2, k, which, in principle, satisfy the condition D_{?k}k²_{?k} 1, where k 1=L! 0 (L is the size of the system) is the characteristic wavevector of magnetization uctuations. The T! 0 lim it of our calculations leads to di erent physics from that of the strict T = 0, collisionless regime discussed by I. A. Fom in [14]. Indeed, one should interpret our T = 0 results as describing uctuations with su ciently long wavelength, and at low but nite temperatures, T the hydrodynam ic condition is satisfed (note that D $_{\rm k}$ and $_{\rm k}$ diverge at T $\,!\,$ 0). The interesting issue of the validity of the linearized Boltzm ann equation approach in the context of spin-polarized Ferm i gases at low temperatures, raised in Refs. [14,15], is left for future investigations. Here, we lim it ourselves to the linearized equations, which should be valid even for T H as long as the external probe used to drive the system out of equilibrium is weak enough and su ciently slowly varying in space.

The plan of the paper is as follows: In Section II we discuss the zero tem perature \lim it of the kinetic equations derived more generally in Appendix B. To get a better feeling for the physical content of these equations we begin with an analysis of the relaxation \lim e approximation. We then solve the T ! 0 equations exactly and recover the variational result of Ref. [7]. This is followed in Section III with the discussion of the nite tem perature equations in the \lim it of \lim all polarization, \lim if \lim is followed in Section III with the resulting exact solution for the discussion coefficient. Since the results of Section III are valid everywhere in the region

Tour expressions are thus covering the entire range of eld and tem perature values in the degenerate regime, T_F . This analysis uncovers the two crossovers already discussed above. In Sect. IV, our results are compared with the available experimental data in 3 He 4 Hem ixtures [16,17,18,19] and in 3 He [6]. The derivation of the self-energies (which are used as an input into the Boltzmann equations) is relegated to Appendix A. The calculations are instructive as they uncover the simple phase-space origin of the nite value of D_7 at T_7 = 0. Throughout we use the units with $R_8 = R_9 = R_7$ where R_8 is Boltzmann constant and

Throughout we use the units with $k_B = 0 = h = 1$, where k_B is Boltzm ann constant and 0=2 is the magnetic moment of a particle; also we take the volume of the system, V=1.

II.TRANSVERSE SPIN DIFFUSION AT T! OAND THE TRANSVERSE RELAXATION TIME

We begin with the kinetic equations for the transverse (o -diagonal in spin space) com - ponent of the density matrix in the rotating fram e, $n_{"\#}$ (t;r;p) (see Appendix B):

where is the chemical potential and $^{(2)}_{"";\#}$ denote the contributions in Eqns. (A 5{A 14}) quadratic in the scattering length a; similarly, the transverse self energy, $^{(2)++}_{"\#}$ t; $r; \frac{p^2}{2m}$; p, is given by Eqn. (B 32). In the T ! 0 limit, the Fermi distribution functions for spin-up and spin-down particles, $n_p^{"}$ and $n_p^{\#}$, can be approximated by $(p_{;\#} p)$.

It is easy to verify that the r.h.s. of Eqn. (4) does not m ix dierent Legendre components of the quantity $n_{\#}$ (t;r;p) as a function of momentum. Therefore, we will search for the solutions of the form

where is the angle formed by vector p and the x axis. It turns out that in the s-wave approximation the higher Legendre harmonics do not contribute to $n_{"\#}$ (t;r;p) (see below). Eqn. (5) in plies that, in the rotating frame, the transverse magnetization and spin current are given, respectively, by

where the indices x and y refer to spin space.

To not the transverse spin di usion coe cient D $_{?}$ one has to calculate the value of the spin current $J_{?}$ induced by a slow spatial variation of the transverse magnetization. We will assume, without loss of generality, that \tilde{r} M $_{?}$ is uniform and is directed along the x axis:

The value of D $_{?}$ should then be found from the macroscopic constitutive relation [1,20], which can be written as

where the quantity is referred to as the spin-rotation parameter. The non-zero imaginary part of the denominator in (9) rejects the fact that, due to the spin-rotation elect, the spin current is not parallel to the driving magnetization gradient.

Substituting Eqns. (5) and (8) in the Boltzmann equation (4) and separating the Legendre harmonics, we obtain two coupled kinetic equations:

The sim plest way of understanding the physical meaning of the kinetic equations (10 $\{11\}$) is to appeal to the relaxation time approximation for the collision integrals, Eq. (14),

Them ain feature of Eqn. (17) is the precession of the spin current around them obscular eld ($^{(1)}$ + $^{(2)}$) originating from the exchange contributions to the single-particle self-energies. This does not appear in the equation for magnetization (Eqn. (16)) which only precesses at the bare Larm or frequency. In the simple case taken here, $QM_2 = Qt = QJ_2 = Qx = 0$ and the solution to Eqn. (17) reads:

Having used the relaxation time approximation to illustrate the physical content of our kinetic equations (10{11) for the transverse density matrix we now proceed with the exact solution of these equations.

For the purpose of computing the spin di usion coe cient it is su cient to consider the steady-state solution (5) with a time-and coordinate-independent functions f(t;x;p) = f(p) and $g_0(t;p) = g(p)$. In this case, the rst two terms on the l.h.s. of Eqn. (10) vanish along with the rst term on the l.h.s. of (11) \(^1\). With the help of Eqns. (A 5{A 6}) one can easily check that Eqn. (10) is then solved exactly by

This proves that the result originally reported as variational in Ref. [7] is in fact exact in the appropriate \lim it (we note that this result has been substantiated earlier through the numerical evaluation of the expressions in Ref. [8]). The detailed results for the spin di usion time, $_{\rm D}$, are plotted in Fig. 1 (dashed line) together with variational bounds, $_{\rm 2}$, on the relaxation time, $_{\rm 2}$, which appears in the relaxation time approximation [21].

III.TRANSVERSE SPIN DIFFUSION AT FINITE TEMPERATURES AND SM ALL POLARIZATIONS

In this section, we extend our results to the case of nite tem peratures in weakly polarized lim it, within the degenerate regime, T F. The appropriate Boltzmann equation is derived in the Appendix B (see Eqn. (B33)). The only dierence from the T! 0 case of Eqns. (5 { 14) is in the form of collision terms,

Note that while the value of D $_{?}$ in (70) can be obtained from the -approximation formula (20) with $_{?}$ = $_{k}$ (see Eqn. (51)), spin-rotation parameter is not given by $^{(1)}$ $_{k}$.

The crossover between Eqns. (69) and (70) at 1 cannot be properly accounted for within the relaxation-time approximation (Eqns. (20)) because the relaxation operator I_{rell} on the r.h.s. of Eqn. (43) (see also Eqns. (44{45})) does not depend on the magnetic eld for H T. This is in contrast with the interpretation of the low eld crossover as a result of the competition between two different terms in the relaxational part of the collision operator [25]. As illustrated in Fig. 4, what changes at 1 is the form of the solution, f (p), to the steady-state equation (43). It is this change in f (p) which is not accounted for within the relaxation time approximation, hence the absence of the second crossover in that approach [10].

Although quantitatively our considerations apply only to the degenerate case (T $_{\rm F}$), there is no reason to doubt that the crossover at $_{\rm T}$ 1 should also be present in the case of H $_{\rm T}$ 2 (ap $_{\rm F}$ 3) $_{\rm F}$ 4 and T $_{\rm F}$ 7, in the presence of higher partial waves, or in a system with stronger interactions. Since the separation of scales of the two parameters is provided by the factor ($_{\rm F}$ =T)=(ap $_{\rm F}$) 1 in Equation (1), in both of these cases the intermediate region between the two crossovers should shrink. In the next section, we will discuss the experimental results that support this point of view .

IV.D ISCUSSION OF EXPERIMENTAL RESULTS

Som e comments are in order concerning the possible relevance of our ndings to experim ent. Even though, strictly speaking, our analysis does not apply to the strongly interacting case, it is worth noting that the available experimental data in weakly polarized ³He [6] deviate system atically from the simple theoretical twhich uses a single adjustable param eter (T_a in [6]) to cover the entire tem perature range including both > 1 and < 1. Much better agreement is obtained by restricting the t to the 1 region with an overall prefactor sm aller than the one im plied by thing to the value of D k in the low eld, high tem perature regime (in re-analyzing the data we use the value A 7:7 $10\sec^2K^2$ instead of 5:8 10 sec=cm 2K2 for the inverse overall prefactor in Eqn. (2) of Ref. [6]; we also take the value 12.5 m K instead of 16.4 m K for the \anisotropy tem perature" Ta). This is consistent with our picture, with D $_2$ < D $_k$ for $^>$ 1 (i.e. $^>$ 1) and T $^-$ H . In addition, although it appears that the region between the two crossovers cannot be clearly identied { most likely due to large Ferm i liquid renorm alization e ects { the isotropic lim it is indeed reached in the regime < 1 [6]. We also note the system atic deviations from the quadratic t of Ref. [10] visible in the measurements of D $_{?}$ in a 6:4% 3 He $\{^{4}$ He m ixture [16] in the interm ediate region between T T_a and j j 1. However, the interactions in this system are still too strong for our theory to be applicable. The fact that in both cases of Refs. [6] and [16] the intermediate region appears to be rather narrow is in line with our expectations

(see Sect. III). In principle, our calculations should be more relevant to the measurements in dilute ³He {⁴He m ixtures. A lthough in the available data (for 18% ³He) the crossover to the isotropic lim it occurs for 1 with H T, the temperature is not su ciently far below $_{\rm F}$ and, moreover, the polarization is somewhat high, 25%. Nevertheless, for > 1 $D_{?}$ / D_{k} with the ratio $D_{?}$ = D_{k} slightly less than unity [17,18]. A lso, the measured T dependence of the \spin-rotation" param eter, , near the crossover to the isotropic (\low-eld") lim it is qualitatively consistent with our results in both the data of Reference [17] and those obtained in the degenerate regime of more concentrated solutions (2:6% ³He) [19] with lower polarization (2%). In both situations, the crossover to the isotropic regime can be clearly distinguished. However, in the former case the polarization was again rather high (25%) and the \low - eld" crossover itself occurs beyond the degenerate lim it. A lso, there is a large discrepancy in the magnitude of the shift of T2 in the latter case (see Fig. 5) which can be attributed to Ferm i liquid renormalizations anticipated in high concentration solutions. The deviations of at 1 from the predictions of Ref. [9] are also seen in the data for the dilute (95% and 1% ³He) mixtures of Ref. [16], in which case due to the high polar-1 corresponds to T _F . Again, our results do not apply quantitatively to this ization situation. In addition, the data points are somewhat too scattered for a clear identication of the crossover. To sharpen the identication of two crossovers the data of reference [19] should be extended to lower temperatures (to study the H =T 1 behaviour). Quantitative com parisons could be made only in the more dilute case of references [17,16] where lower eld and lower tem perature experim ents should be perform ed.

APPENDIX A:ON THE DYNAM ICS OF QUASIPARTICLES IN A SPIN-POLARIZED FERMIGAS

In this Appendix, we derive the imaginary parts of quasiparticle self-energies at T=0 which are used as input into the kinetic equations.

We start with a spin-polarized gas of neutral ferm ions interacting via a repulsive potential $U(jrr^0j)$. In the dilute limit, $N^{1=3}r_0$ 1, where r_0 is the range of the potential, the leading contribution comes from the s-wave scattering between spin-up and spin-down particles. Then the natural small parameter is provided by $N^{1=3}a$, where a is the s-wave scattering length. We will keep term sup to the second order in $N^{1=3}a$; within this accuracy, the scattering is fully described by a two-body T-matrix which obeys the Bethe-Salpeter equation:

Equations (A9) and (A14) coincide with those reported in Ref. [8]. The expressions (A10 (A13) are presented here for the 1st time.

The singularity at $q^2 = p_m^2 + p_\#^2$, which is present at Eqns. (A 9(A 10) corresponds to a process in which an incoming particle excites a particle of opposite spin from within the Ferm is phere. At $q > (p_m^2 + p_\#^2)^{1-2}$, the incoming particle has enough energy to excite any particle of opposite spin. Geometrically, this singularity corresponds to the exterior tangency of the shifted Ferm ispheres, and it is already present in the unpolarized case [26].

In the spin-polarized case there is one more singularity at $q^2 = p_m^2$ pp² (see Eqns. (A11) and (A13)), associated with the interior tangency between the two Ferm ispheres. In this case, the corresponding virtual process is a recombination of the incoming spin-up hole, followed by an excitation of spin-down particle; at $q < (p_m^2 - p_p^2)^{1-2}$, the hole has enough energy to excite any of the spin-down particles from within the spin-down Ferm isphere.

The functions $\operatorname{Im}_{---}(q)$ and $\operatorname{Im}_{---}(q)$ change their signs at $q=p_{--}$ and $q=p_{+-}$ respectively. The new feature of the above results, relevant for the transverse spin dynamics, is that, due to the availability of the scattering phase space between the two Ferm i surfaces, the lifetimes of spin-down particles and spin-up holes in the intermediate region $p_{+} < q < p_{--}$ are nite.

The transverse spin processes are described by the W igner transform of the transverse component of the density matrix, $n_{"\#}$ (t; r; q), which obeys the Boltzmann equation of a peculiar type (see Sect. II(III). In the appropriate linearized approximation su cient for the calculation of transport coe cients the transverse components decouple from the longitudinal ones, enabling one to discuss the transverse and longitudinal spin dynamics separately [20]. By rotational symmetry, the transverse deviations from the equilibrium (uniform) polarization must be small at any point in p space, i.e.

This also respects the fact that the eigenvalues of the density matrix are between zero and unity.

The fact that the quasiparticle relaxation rates (A 11 (A 12) also dier from zero within this region results in the nite relaxation time $_{2}$ of the transverse spin current even at T ! 0 (see Sect. II).

We note that from the viewpoint of longitudinal spin dynamics the system behaves as a conventional Ferm i liquid: the non-equilibrium terms in the diagonal components of density matrix are connect to the respective Ferm ispheres, where the imaginary parts of the quasiparticle spectrum vanish. As expected [28], the imaginary part of the oscillation energy at the Ferm isurface behaves as

We note that Eqns. (B33{B35) are in complete agreement with the appropriate limit (see inequalities (B10) above) of the kinetic equation of Ref. [30]³. Upon integration of Eqn.

(B33) over the momentum space the two terms on the r.h.s. (\direct" and \exchange" terms) cancel each other, and, according to Eqns. (6{7), we are left as expected with the continuity equation (16).

In the limit of low temperatures and small polarizations, when T;H , only the electrons from the vicinity of the Ferm ispheres m ay participate in the scattering. Therefore, in the expression (B 36) we may assume that p p^0 (2m p^0 and w max(T;H)=T. Moreover, it is easy to check that the contribution of backward and forward scattering regions (where the product sum ay be arbitrarily small) is negligible, so one can also assume that suT max(T;H).

W ith this assumptions, we obtain Eqn. (33) for A $(p;p^0)$. The quantity B $(p;p^0)$ at T;H is given by Eqn. (34).








- FIG. 1. The upper and lower bounds of the relaxation time functional $_{?}$ as functions of $d = p_{\#} = p_{\#}$. Solid lines correspond to the functions $a^2 p_{\#}^4$ $_{?}$ (d)=m . The dashed line represents the di usion time $_{D}$ (see Eqn. (29)).


FIG. 8. (a). Bethe { Salpeter equations for the auxiliary T-m atrices T_0 and T_0^{++} . (b). The diagram m atrices for the T-m atrices T and T $^+$. The series for T^{++} and T $^+$ can be drawn in a similar way. Within the second order in N $^{1=3}$ a only the rst terms in these diagram matrices should actually be taken into account.











