W e report measurements of the surface in pedance  $Z_s = R_s + iX_s$  of (P r<sub>x</sub>Y<sub>1 x</sub>)B a<sub>2</sub>C u<sub>3</sub>O 7

(x = 0; 0:15; 0:23; 0:3; 0:4; 0:5). Increasing P r concentration leads to some striking results not observed in samples doped by non-magnetic constituents. The three principal features of the R<sub>s</sub> (T) data - multiple structure in the transition, a high residual resistance and, at high P r concentrations, an upturn of the low T data, are all characteristic of the in uence of magnetic scattering on superconductivity, and appear to be common to materials where magnetism and superconductivity coexist. The low T behavior of (T) appears to change from T to T<sup>4</sup> at large P r doping, unlike that reported for N i and Z n substitutions, and is further evidence of the in uence of magnetic pairbreaking of the P r.

In the 123 class of cuprates where Y is replaced by lanthanide elements such as La,Ce,Pr,Nd,Gd,Dy, etc., the compound P rB  $a_2$ C  $u_3$ O<sub>7</sub> is insulating while all the other members of the family show a superconducting transition in the vicinity of 90K . Superconductivity in (P  $r_x Y_{1 x}$ ) B  $a_2 C u_3 O_7$  is suppressed rapidly as the P r content is increased and the system undergoes a transition to an insulating state at x 0:55 0:6 [1,2]. Since superconductivity in the cuprates is mainly associated with the Cu O planes, the exact role of Pr (which substitutes for Y in the 123 structure) in the T<sub>c</sub> suppression is of fundam ental interest. This also makes the Pr doped system distinct from the other transition m etal doped 123 com pounds where dopants like N i; Z n; F e are substituted at the C u sites and thus directly a ect the superconductivity in the planes. Two mechanisms for the decrease of  $T_{c}$ with Pr concentration x have been proposed: (1) annihilation of m obile holes in the C uO<sub>2</sub> planes by the P r ions (hole depletion mechanism), and (2) superconducting electron pairbreaking (pairbreaking mechanism) [2]. Superconducting electron pair breaking could be produced by potential scattering of m obile holes by the Pr ions if  $Y B a_2 C u_3 O_7$ is a d-wave superconductor and by spindependent exchange scattering of the mobile holes by the Prions, which carry well-de ned magnetic moments, if  $Y B a_2 C u_3 O_7$  is an s-ord-wave (spin-singlet) superconductor [3]. Both of these mechanisms have been incorporated into a phenom enologicalm odel which provides a sem iquantitative description of the striking variations of  $T_{\rm c}\,w$  ith x and y in the (C  $a_x\,P$   $r_y\,Y_{1\ x\ y}\,$  )B  $a_2\,C\,u_3O_7\,$ system for 0 x;y 0:2 (here, m obile holes are generated by C a and annihilated by P r [2,4] and the pressure dependence of  $T_c$  in the (P  $r_x Y_{1 x}$ ) B  $a_2 C u_3 O_7$  system for x 0:5 [5,6]. The hole-depletion and pair breaking 0 m echanism s are assumed to originate in the hybridization of the localized P r4f states and the C uO<sub>2</sub> valence band

states. The existence of Pr4f CuO<sub>2</sub> valence band hybridization was rst proposed on experim ental grounds to account for the anom alous pressure dependence of  $T_c$ of ( $Pr_xY_1 \times Ba_2Cu_3O_7$ system [5,6], in analogy with the anom a bus behavior of T<sub>c</sub> under pressure in superconductors containing C e im purities such as  $La_{1 x} C e_{x}$  [7]. To the extent that pair breaking is responsible for the depression of  $T_{\rm c}$  in the (P  $r_x\,Y_{1\ x}$  )B  $a_2C\,u_3O_7$   $\,$  system , it would be necessary to invoke P r4f C uO<sub>2</sub> valence band hybridization in order to generate a su ciently strong coupling of the P r ions to the mobile holes in the C  $uO_2$ planes. Except for Ce, the other lanthanide (Ln) ions with partially-lled 4f electron shells do not depress the  $T_c$  of Y B  $a_2$  C  $u_3$  O  $_7$  by a measurable amount; evidently, the Ln 4f  $CuO_2$  valence band hybridization and, in tum, the exchange coupling of the Ln ions to the holes in the CuO<sub>2</sub> planes is small. It is interesting to note that such a hybridization-induced exchange interaction is antiferrom agnetic and should produce a K ondo e ect, resulting in a depression of T<sub>c</sub> with impurity concentration (here, Pr) that deviates from the prediction of the theory of A brikosov and G or kov (AG) in a manner that depends on the ratio of the K ondo tem perature  ${\rm T}_{\rm K}~$  to the  $T_c$  of the host superconductor (in this case, YBCO) [7]. M easurem ents of the low tem perature specic heat in the range 0 < x 0:5 reveal a broad anom aly in the speci c heat [8,9]. This anom aly can be described by the sum of a term of the form  $C_e(T) = T$  with an enormous \heavyferm ion-like" value of of 240m J=m olPr K<sup>2</sup> and a contribution  $C_M$  (T) that has been described by a spin 1/2 K ondo anomaly with a value of  $T_K$  that increases with x [9] or an anom aly associated with antiferrom agnetic ordering of the P r ions [10]. It has been shown that the detailed  $T_{\rm c}~vs\,x$  curve of the (P  $r_x\,Y_{1~x}$  )B  $a_2C\,u_3O_7$ system does not conform to the AG theory, but can be described by the aforem entioned pheom enologicalm odel based on both hole depletion and pair breaking in the range 0  $\times$  0.2 [11]. M any experiments have indicated P r to be predom inantly in a 3+ valence state, although a mixed valence state cannot be ruled out.

There are several anomalies observed in transport and magnetization experiments which indicate that Pr<sub>x</sub>Y<sub>1 x</sub> Ba<sub>2</sub>Cu<sub>3</sub>O<sub>7</sub> has a ground state with unusual electronic properties, and which has been proposed theoretically to account for the insulating nature of PrBa<sub>2</sub>Cu<sub>3</sub>O<sub>7</sub> [12]. Neutron scattering experiments indicate long range AFM ordering of the Prm om ents in the insulating compound PrBa<sub>2</sub>Cu<sub>3</sub>O<sub>7</sub> with an unusually high Neel temperature T<sub>N</sub> of 17K [1]. Overall the Pr<sub>x</sub>Y<sub>1 x</sub> Ba<sub>2</sub>Cu<sub>3</sub>O<sub>7</sub> system represents the ideal candidate to explore the e ects of pair-breaking and magnetic scattering in the superconducting state.

M icrowave experiments have been shown to be unique probes of the superconducting state. M easurements of the T dependence of them icrowave surface impedance  $Z_s$  and penetration depth can reveal important inform at ion regarding the gap parameter and the quasiparticle density of states. The linear behavior of at low T observed in YBCO [13] and BSCCO [14] is consistent with nodes in the in-plane gap. It is of interest to exam ine the role of impurities in this context, since the in uence of impurities are expected to be strikingly di erent for a d-wave superconductor compared to the conventional s-wave type as discussed above.

In this paper, we report on com plex surface in pedance (Z<sub>s</sub> = R<sub>s</sub> + iX<sub>s</sub>) measurements on a series of P r<sub>x</sub>Y<sub>1 x</sub> B a<sub>2</sub>C u<sub>3</sub>O<sub>7</sub> single crystals with x ranging from 0 to 0.5. Our experiments reveal novel structure in the superconducting transition region not seen in dc or low frequency probes of resistivity and magnetization. In the following sections we present the surface resistance R<sub>s</sub>(T) and the low temperature penetration depth (T) data and discuss our results in terms of enhanced magnetic scattering.

## I.EXPERIMENT

The single crystals were grown using a ux-growth m ethod described in an earlier publication [15]. The P r concentration x of the single crystals was inferred from their m easured  $T_c^{0}s$  and the  $T_c$  vs x curve of polycrystalline P r<sub>x</sub>Y<sub>1 x</sub> B a<sub>2</sub>C u<sub>3</sub>O<sub>7</sub> samples reported in ref. [11]. Typical crystals used in our experiments were of size 0:7 x 0:7 x 0:05 m m<sup>3</sup>. Surface in pedance m easurements were done in a superconducting N b cavity resonator operating at a frequency of 10 G H z. The samples were mounted on a sapphire rod and a "hot nger" technique was employed to monitor the temperature dependence of the complex surface in pedance from 4K to 300K [16]. This cavity perturbation m ethod has been extensively validated in precision m easurements of R<sub>s</sub> and

 $X_s$  in single crystals of cuprate  $[\![4,21,22]\!]$  and borocarbide superconductors  $[\![17]\!]$ . The N b cavity is maintained either at 4.2K or below 2K and the typical background  $Q_b$  of the cavity can be as high as  $10^8$ . The surface resistance  $R_s(T)$  is measured from the temperature dependent Q using  $R_s(T) = [D^{-1}(T) \quad Q_b^{-1}(T)]$  and the penetration depth using  $(T) = [f(T) \quad f_b(T)]$  where the geom etric factors are determ ined by the cavity mode, crystal size and location within the cavity. In the present setup, all measurem ents were done in the TE  $_{011}$  m ode with the sam ple at the micpoint of the cavity axis where the microw ave magnetic elds have a maximum and the microw ave electric elds are zero. In all cases, the sam – ples were oriented with H  $_{\rm rf}$  kc and currents only ow in the ab plane.

## II. RESULTS AND DISCUSSION

In Fig.1, the surface resistance  $R_s(T)$  for  $Pr_xY_{1} = Ba_2Cu_3O_7$  with x = 0:0;0:15;0:23;0:3;0:4;0:5 are shown. The data are normalized at  $R_s$  (100K) to highlight the systematic variation of the surface resistance with increasing Pr concentration. The norm al state R  $_{\rm s}$  (100K ) values range from 0.2 to 0.8 as x ! 0 to 0:5. The overall tem perature dependence of the surface in pedance in the norm al state is consistent with the expected skin depth limited response given by  $R_n = 1 + 0 = 2$  where n is the norm all state dc electrical resistivity. This is also well represented in the upturn in  $R_n$  clearly seen for the x = 0.5 sample before the superconducting transition occurs. At x = 0.5, the Pr-doped system is on the verge of a metal-insulator transition and dc electrical resistivity m easurem ents indicate that this transition occurs for x 0:55 0:6. This transition from a linear normal state resistivity in the metallic case to a Mott Variable Range Hopping (VRH) type behavior in the insulating regime is mirrored in the surface resistance data of Fig.1. In particular the change in sign of dR<sub>s</sub>=dT from positive to negative just above the superconducting transition is evident as x increases from 0:4 to 0:5. The transition is sharpest for the undoped YBCO sample with a width T  $_{\rm c}$  which increases rapidly with Pr substitution. R andom substitution of Y atom s by P r which increases the disorder in the system combined with the magnetic scattering due to free Pr ions is the likely cause for the broad transition.




FIG.1. Surface Resistance of Pr<sub>x</sub>Y<sub>1</sub>  $_x$ Ba<sub>2</sub>Cu<sub>3</sub>O<sub>7</sub> . The superconducting T<sup>0</sup><sub>c</sub>s for x = 0.0, 0.15, 0.23, 0.3, 0.4, 0.5 are 92K, 82K, 71K, 58K, 46K, and 22K, respectively.

An interesting feature of the data of Fig.1 is the remarkable ne structure seen in the transition region. This is particularly accentuated in the  $R_s$  data for x = 0.23 and x = 0.3 (m arked by arrow s). A distinct change in slope at a characteristic tem perature close to m idpoint of the transition width occurs and is reproducible in several P r-doped crystals investigated. It is to be noted that for the same concentrations, the dc resistivity and susceptibility m easurements do not show any signature of

multiple features in the transition. We propose that this two-slope structure is a consequence of a discontinuous change in quasiparticle scattering in the superconducting state at characteristic tem peratures. This is seen clearly in our high frequency experiments as we probe both the norm al and super uid response in the superconducting state.

The residual surface resistance at low temperatures shows an increasing trend with Pr doping, and there is alm ost an order of magnitude jump between x = 0.4 and 0:5. The most striking aspect of the x = 0.5 sample is the uptum in  $R_s$  for T 18K and the tem perature dependence alm ost m im ics the norm al state data just above the superconducting transition. This is an important observation which we believe for the rst time qualitatively captures the competing e ects of magnetism and superconductivity in cuprates as revealed in surface in pedance m easurem ents. It should also be pointed out that the presence of exchange interactions due to the P r4f m oments could also result in enhanced electron-electron interaction e ects. In this case, m any body corrections to the low tem perature quasiparticle conductivity have to be taken into account and this can lead to the uptum in the  $R_s$  (T) seen for higher Pr doping.

It is to be pointed out that all the anom abus characteristics seen here for the P  $r_x Y_{1 x}$  B  $a_2 C u_3 O_7$  system have been observed by us in our m icrow ave experiments of borocarbide class of magnetic superconductors [17]. In general, a high residual surface resistance, multiple structure in the transition and the low temperature uptum in R<sub>s</sub> all seem to be standard electrodynamic characteristics of system s exhibiting co-existence of magnetism and superconductivity. System atic high frequency experiments on known magnetic superconductors would help further understand the implication of these features.




FIG.2. Surface R eactance X  $_{s}$  of P  $r_{x}\,Y_{1}$   $_{x}\,B\,a_{2}C\,u_{3}O_{7}$  .




FIG.3. Low temperature penetration depth (T) vs reduced temperature t =  $T = T_c$ . For x = 0.15 and 0.4 the data follows a t<sup>4</sup> dependence. Inset shows the data for x = 0.4 (solid line) along with a t<sup>4</sup> curve (dashed line) for comparison. An approximate  $_0$  is added to each data.

The normalized surface reactance  $X_s$  (T) is shown in Fig.2. The overall trend is similar to the corresponding R<sub>s</sub> (T) data with som e di erences particularly for the x = 0.5 sample. Two peaks are present in the vicinity of the superconducting transition and a third feature at least 15K higher in tem perature. It is not clear whether these features are related to coherence e ects. The surface reactance also shows an upturn at low temperature but the onset of this is about 10K lower than the corresponding onset in R<sub>s</sub>. The change in reactance is directly related to the change in penetration depth via the relation  $X_s = 0!$ . In Fig.3, the low tem perature penetration depth extracted from the surface reactance is plotted as a function of reduced tem perature  $(T=T_c)$ . M easurem ent of the absolute value of the penetration depth is not possible with the cavity perturbation technique. However, an estimate can be obtained by setting  $R_s = X_s$ in the norm al state assuming local electrodynamics. An estimated London penetration depth  $_0$  is added to each set of data in Fig.3.

For the undoped YBCO sample (x = 0), the penetra-

tion depth is linear in tem perature. This linear dependence seen both in YBCO and BSCCO class of cuprates has been considered as evidence for an order parameter sym m etry having nodes in the gap [13,14]. W ith Prdoping, the tem perature dependence of changes to a power law behavior. For the x = 0.15 and 0.4, the best t to the data is obtained with a T<sup>4</sup> term . It is important to note that the data do not show a T<sup>2</sup> behavior reported in thin lm s of Y B C 0 [18] and Z n-doped Y B C 0 single crystals [19]. The change over from T to  $T^2$  dependence in Zn and Nidoped YBCO has been interpreted as due to a crossover from a pure d wave state to a gapless superconducting state. There are also a num ber of di erences in  $R_s$  between the (Zn; Ni) and Pr doped YBCO. In the case of Zn or N i doped samples, although the norm al state R<sub>s</sub> increases with doping, there is negligible change in the low tem perature residual surface resistance. On the contrary, the norm alstate and residualR s increase with P r concentration in P  $r_x Y_1 \times B a_2 C u_3 O_7$ Nomultiple structure is seen in the transition for Zn or N i doped samples. Thus there is every indication that enhanced scattering presum ably of magnetic origin plays a major role in the surface in pedance characteristics of PrdopedYBCO.

In a recent paper, it has been theoretically proposed that in layered superconductors it is possible to have a novel phase transition governed entirely by the scattering rate 1= provided the order parameter reverses its sign on the Ferm i surface but its angular average is nite [20]. According to this, the excitation energy spectrum which is gapless at a low level of scattering can develop a gap as the scattering rate exceeds som e critical value; i.e., 1 = > 1 = .0 ur surface in pedance data on the P r doped crystals seem to be remarkably consistent with this scenario.W ith increasing Pr concentration, not only are we introducing pair-breaking magnetic ions but also increasing the scattering rate. W hile the T<sub>c</sub> suppression can be thought of as due to hole depletion and m agnetic pair-breaking, the enhanced scattering rate may result in the kind of transition proposed by this theory. Both the two-slope feature in the transition region and change in the tem perature dependence of the penetration depth from linear to power-law shown in Fig.1 and Fig.3 can be reconciled as a manifestation of a transition from a gapless state to a superconducting state with a nite gap.

Finally, we would like to remark about the case of mixed state order parameter symmetry like s + d in the 123 system. In this case, where the order parameter has line nodes on the Ferm i surface, elastic scattering suppresses the  $T_c$  vigorously and has a dominant in uence over spin- ip scattering. The transition for a linear T to T<sup>4</sup> dependence in can be interpreted as the suppression of the d-part of the order parameter, whereas insensitive to the inpurities, s-wave survives. It is to be noted that our recent m icrow ave experiments on high quality Y B  $a_2C u_3O_7$  single crystals grown in B  $a_2 rO_3$ 

crucibles indicate evidence for a multi-com ponent order param eter sym m etry [21,22].

In conclusion, we have presented the m icrowave surface in pedance for (Pr $_x$ Y<sub>1 x</sub>) B a<sub>2</sub>C u<sub>3</sub>O<sub>7</sub> single crystals with x ranging from 0 to 0.5. Both the surface resistance and penetration depth data indicate strong scattering e ects. Novel structure in the superconducting transition region and the temperature dependence of the penetration depth m ay be consistent with a phase transition from a gapless to nite-gap state governed by the scattering rate.
