## H igh eld study of norm all state m agneto-transport in $T_{2}Ba_{2}CuO_{6+}$

We present a study of in-plane norm all state m agneto-transport in single crystal T  $\lg Ba_2 C uO_{6+}$  in 60T pulsed m agnetic elds. In optimally doped samples (T<sub>c</sub> 80K) the weak-m agnetic eld regime extends to elds as high as 60T, but in overdoped samples (T<sub>c</sub> 30K) we are able to leave the weak eld regime, as shown by the behavior of both the magnetoresistance and the H all resistance. D ata from samples of both dopings provide constraints on the class of model necessary to describe norm all state transport in the cuprates.

M easurem ents of the electrical transport properties of the high-T<sub>c</sub> cuprate superconductors have proved to be one of the most useful ways of probing their anom abus normal state properties. Studies of the Hall e ect in  $YBa_2Cu_3O_7$ [1] show that near optimum doping, the resistivity () has an approximately linear temperature dependence, while the inverse Hallangle (cot  $_{\rm H}$ ) varies nearly quadratically with tem perature. System atic m easurem ents of these properties have been m ade in m any cuprate m aterials, as a function of disorder and carrier concentration. A lthough som e exceptions have been reported, the experim ental picture which has emerged is that cot H continues to vary approximately quadratically in tem perature even when changes its tem perature dependence from linear on underdoping or overdoping.

M ost attempts to understand this intriguing behavior fall into two broad classes. In the rst (the \two-lifetim e" m odels), the experimental observations are taken to indicate the existence of two separate and essentially decoupled scattering times governing longitudinal transport and H all transport, often referred to as  $_{\rm tr}$  and  $_{\rm H}$  respectively [2,3]. These two intrinsic lifetimes are assumed to co-exist at all points on the Ferm i surface (FS). Theories constructed from this starting point are intrinsically non-Ferm i liquid in nature. The more conventional class of m odels (the \anisotropic" m odels) exploits the fourfold anisotropy of the cuprate Ferm i surfaces and postulates the existence of an anisotropic scattering rate whose m agnitude and temperature dependence is di erent on di erent parts of the FS [4[6].

To date, alm ost all norm all state m agnetotransport studies on the cuprates have been performed in m agnetic elds of less than 20T, in the weak- eld regime (!\_\_\_\_\_\_1, where !\_\_\_\_ is the cyclotron frequency and <sup>1</sup> is the scattering rate). In this regime, the m agnetoresistance is parabolic in B [7{10}, and the H all voltage is linear in B. R ecently, H arris et al. [7] pointed out that the m agnitude of the weak- eld (VW F") orbital norm al state M R ( $= {}^{W F}$ ) is proportional to the variation of the bcal H all angle around the Ferm i surface. Observations on YBa<sub>2</sub>Cu<sub>3</sub>O<sub>7</sub> and optim ally doped La<sub>2 x</sub> Sr<sub>x</sub>CuO<sub>4</sub> have shown that the tem perature dependence of the M R agrees with that of the square of the H all angle, favoring two-lifetim e m odels for which H exists at all points on the FS [7].

Here, we report magnetotransport results on single crystals of T  $l_2$  B  $a_2$  C uO  $_{6+}$  in 60T pulsed m agnetic elds. In samples near optimum doping ( $T_c$ 80K), the weakeld regime is seen to extend to nearly 60T, and we see behavior similar to that observed in  $YBa_2Cu_3O_7$ and optim ally doped La2 x SrxCuO4. In strongly overdoped samples (T<sub>c</sub> 30K), however, we are able to observe signi cant deviations from the weak eld form s of  $_{xx}$  (B) and  $_{xy}$  (B). We nd that the high eld m agnetotransport provides an independent way of estimating an im portant parameter,  $!\,{}_{\rm c}\,$  , and thus provides additional constraints to the existing transport m odels. A nalysis of our data favors the general class of two-lifetim e m odels to describe norm al state transport in the cuprates.

Tetragonal single crystals of Tl2Ba2CuO<sub>6+</sub> were grown using a Cu-rich ux. W ith  $T_{1}Ba_{2}CuO_{6+}$ , degradation of the surface quality on annealing is a persistent problem, leading to poor quality electrical contacts for the transport m easurem ents. In our experience, the best way of making contacts to samples with elevated  $T_c$  is to evaporate gold contact pads onto the as-grown sample. The desired T<sub>c</sub> values were then achieved by annealing using various combinations of annealing tem perature, atm osphere and time. The anneal also di uses the gold into the sam ple, providing a low -resistance contact to which gold wires are attached using a silver paint (Dupont 4929) which hardens in air at room tem perature. C are was taken when evaporating the gold to ensure that it covered the sides of the sam ple. The resistivity for op-




FIG.1. The resistivity in zero magnetic eld of optimally doped ( $T_c$  80K) and overdoped ( $T_c$  30K) single crystals of T  $_2$  B  $_2$  C uO  $_{6+}$ . The inset shows a comparison of magnetoresistance (M R) measurements in d.c. (circles) and pulsed (solid line) magnetic elds at T 115K for an overdoped sample. The M R in this range can be well tted with a quadratic eld dependence (dashed line). The pulsed eld M R data were multiplied by a factor of 1.015 to correct for a sm all di erence in the temperature at which the pulsed and d.c. measurements were made.

tim al (T  $_{\rm c}$   $\,$  80K ) and overdoped (T  $_{\rm c}$   $\,$  30K ) sam ples is shown in Fig.1.

A resistive d.c. magnet in G renoble was used for M R m easurements in elds up to 20 tesla, using a standard four term inal a.c. technique with a 32 Hz excitation frequency. Temperature stability of 1 part in  $10^4$  was achieved using a capacitance sensor which is insensitive to eld. The temperature was measured in zero eld before and after each sweep, to check for possible tem – perature drift. The longitudinal M R was also measured at several tem peratures and found to be at most 5% of the total M R. The total measured transverse M R is thus dom inated by the orbital M R for all of the data in the gures.

P recise m easurem ent of norm al state m agnetotransport in a pulsed eld presented a considerable challenge, due to the higher noise levels and the relatively low resistances of the T  $\lg Ba_2C \sqcup O_{6+}$  crystals (as little as 10m below 50K). A fter som e experim entation, voltage sensitivity of better than 1 V could be achieved at excitation currents of 5-10m A. The tem perature was stabilized and measured in zero eld. Comparison of up-and down-sweeps was used to check for eddy current heating, which was largely avoided due to the very small sample sizes (typically 300 100 15  $m^3$ ). A lso, all the data shown in this paper are at su ciently high tem peratures that the MR is dominated by normal state orbital contributions rather than superconducting uctuations.

Given the di culty of using a pulsed eld to measure small M R e ects in low resistance samples, we rst es-




FIG. 2. The MR of an optimally doped crystal of  $T \downarrow_{\rm B} a_2 C \amalg O_{6+}$  ( $T_c = 80 K$ ) at a series of temperatures between 130K and 280K. Data at di erent temperatures have been o set for ease of view ing. The dashed lines are parabolic ts to the data.

tablished, using four di erent sam ples, that the results using d.c. and pulsed techniques are consistent. As an exam ple, in the inset to Fig. 1 we show the resistivity at 115K of one of the overdoped sam ples measured as a function of magnetic eld up to 20T in the resistive d.c. eld (circles). The data measured in the pulsed magnetic

eld at Bell Labs (solid line) overlays the d.c. eld data very well.

Fig. 2 contains pulsed eld M R data from a sam ple near optim al doping ( $T_c$  80K). For this sam ple, the M R is small (only 3% at 60T and 130K) and the eld dependence is basically quadratic for T > 130K (dashed line in the gure) over the whole eld range. This is good evidence that the weak eld regime is applicable in elds as high as 60T in optim ally doped T  $l_2Ba_2CuO_{6+}$ .

Since a single isotropic band has zero MR, the parabolic MR in Fig. 2 m ight result from an isotropy, whether the scattering rate varies around the FS [4[6]]or the \local cyclotron e ective mass" m (proportional to  $1=v_F$  ) varies due to the local geom etry of the FS [7]. Interestingly, it is also possible to construct two-lifetime models in which neither norm are anisotropic, yet there is a non-zero MR. In one such model  $[\beta]$ , fast and slow relaxation rates exist at all & points. In term softhe MR, this is roughly analogous to a two uid picture, and a quadratic weak- eld MR results even for a parabolic band. Thus, the model-speci c part of the data in Fig.2 is not the parabolicity, = <sup>W F</sup> = B<sup>2</sup>, rather it is the interpretation of the prefactor in terms of the lifetim es (ormasses).

At optimal doping, the Halle ect in  $T_{2}Ba_{2}CuO_{6+}$ 

gives a very clear example of two-lifetim e behavior, with and  $\cot_{H}$  following linear and quadratic temperature dependences to an accuracy that poses a challenge to any




FIG.3. The M R of an overdoped crystal of T  $\frac{1}{2}Ba_2CuO_{6+}$ (T<sub>c</sub> 30K) at a series of temperatures between 40K and 150K. The ts (solid lines) are produced by a general expression for orbital M R beyond the weak eld limit (Eq.1). The inset shows the same data tted to Eq.2 with !<sub>c tr</sub> xed by the resistivity data of Fig.1.

theory of the cuprate norm al state [11]. Harris et al. [7] have shown that in YBa<sub>2</sub>Cu<sub>3</sub>O<sub>7</sub> and La<sub>2 x</sub> Sr<sub>x</sub>CuO<sub>4</sub> near optim aldoping, the weak eld M R obeys a special form of K ohler's rule in which (cot <sub>H</sub>)<sup>2</sup> = scale at different tem peratures, while the traditional K ohler scaling

=B<sup>2</sup> is violated. This is also the case for the M R data from the optim ally doped  $T \downarrow_2 B a_2 C \sqcup O_{6+}$  of Fig. 2. As discussed in Ref. [7] and above, this observation favors two-lifetime models in which lifetimes with two dimension temperature dependences exist at all points of the FS.

Because the 60T magnetic eld reveals a strictly parabolic M R in the optimally doped sample, we turn our attention to overdoped samples with lower resistivity to better reach the high magnetic eld regime. The M R of the overdoped samples is much larger, and deviates signi cantly from a quadratic eld dependence at high elds and low temperatures. Going beyond the weak eld limit in any of the models discussed above leads to a modi ed general expression of the form

$$- = \frac{B^2}{1 + (B)^2}$$

where is a second constant, principally related to the overall scale of  $!_c$ . This expression accounts for the data in Fig. 3 quite well, as shown by the curve ts, so our observations are consistent with the onset of MR saturation as we have the weak eld regin e [12].

To determ ine whether the high eld MR can constrain which general class of models is applicable to the cuprates, we exam ine the physical origin of weak- and strong- eld MR in more detail. As discussed above, in conventional models, the weak eld MR is a measure of anisotropy around the FS, although its magnitude is not easy to interpret. However, the onset of saturation is m uch easier to interpret, because it arises once the quasiparticles orbit a signi cant fraction of the Ferm i surface between scattering events. Thus  $ehm = i^{1}$ , where

is the scattering lifetime and hi denotes a FS average. The product B gives the value of !  $_{\rm c}$  determ ined from the high eld M R.

The di erent classes of model for the cuprate normal state make very di erent predictions for the relationship between this high eld value of  $!_c$  and those that can be estimated from the resistivity and weak eld Halle ect. If the Halle ect and resistivity are to be understood in terms of an anisotropic model [4{6], the fast and slow relaxation rates which lead to  $_{\rm tr}$  and  $_{\rm H}$  exist on di erent parts of the FS [13]. When  $!_c$   $_{\rm tr}$  is estimated from and  $!_c$   $_{\rm H}$  is estimated from  $_{\rm H}$ , we nd that  $!_c$   $_{\rm H}$  >  $!_c$   $_{\rm tr}$  for all tem peratures below room tem perature. Since high

eld M R saturation would be expected to be dom inated by those regions with the highest scattering rate, the value of  $!_{\rm c}~$  estimated from the high ~ eld M R would be expected to be close to  $!_{\rm c}~{\rm tr}$  (and not to  $!_{\rm c}~{\rm H}$ ). We shall show that this is apparently not the case for our data.

The opposite conclusion, that the high eld MR is determ ined by ! c H , is reached for two-lifetime models, two of which we shall consider here. In the picture discussed in Refs. [1,2] and [7],  $_{\rm H}$  governs all responses to a magnetic eld. Since  $_{\rm H}$  is constant around the FS in this model, some  $v_F$  anisotropy is necessary for the appearance of a non-zero MR.Models of the FS of most cuprates show that  $v_F$  is smallest in the regions of highest FS curvature, so the high eld MR would be expected to give  $!_{c}$  with the tem perature dependence of  $_{H}$  and a m agnitude which is determ ined primarily by the curved parts of the FS. Since a weak eld measurement of the Hall angle contains an even stronger weighting to areas of large FS curvature [14], the value of ! obtained from high-eld measurements would be expected to be similar to that determ ined from weak eld Hall measurements at all tem peratures.

In the form ulation of a two-lifetim e m odel described in Ref. [3], a simple analytical expression can be derived for the M R in term s of the quantities  $!_{c\ tr}$  and  $!_{c\ H}$ , if FS anisotropy is neglected:

$$---=\frac{!_{c H}(!_{c H} !_{c tr})}{(1 + !_{c H}^{2})}; \qquad (2)$$

In both two-lifetime models, then, high-eld saturation is expected to probe  $!_{\rm c\ H}$ . Our data support this expectation. The value of tted from the data at 40K where the saturation is largest corresponds to  $!_{\rm c}$  of 0.9 at 60T. At that temperature the weak eld Hall angle per tesla is 0.01 T  $^1$  giving an estimated value for  $!_{\rm c\ H}$  of 0.6 at 60T. The measured can be used to estimate  $!_{\rm c\ tr}$  for a large FS (corresponding to  $k_{\rm F}$  0:7A  $^1$  [15]) using the expression  $!_{\rm c\ tr} = 2$  dB =ek $_{\rm F}^2$ , where d is the




FIG.4. The Hall resistivity  $_{xy}$  for the T<sub>c</sub> 30K crystal at 50K and 150K. The ts (solid lines) to Eq.3 were m ade with both !<sub>c</sub> t<sub>r</sub> and !<sub>c</sub> H xed by the ts to the MR data in Fig.3. The inset shows the value of !<sub>c</sub> H obtained using this procedure (squares joined by solid line) com pared with m easurements of !<sub>c</sub> H from the weak- eld Hall angle (triangles) and !<sub>c</sub> tr from the resistivity (circles).

interplane spacing of 11:6A.At 60T,  $!_{c tr}$  is only 0.3, so the MR value for  $!_c$  derived from high elds certainly seem s to be in better agreem ent with  $!_{c H}$ .

In the m odel of R ef.  $\beta$ ], it is also possible to derive an analytical expression for the H all resistivity

$$_{xy} = \frac{m !_{c}!_{c H}}{ne^{2}!_{c tr}} \frac{1 + !_{c H}^{2}}{(1 + !_{c H}^{2})}; \qquad (3)$$

where n is the carrier concentration. If we neglect the m ild  $v_F$  anisotropy round the FS that probably exists, we can reduce Eq.2 to a single parameter t for  $!_{c \ H}$  by estimating  $!_{c \ tr}$  at each temperature from the resistivity data of Fig.1. The resulting ts are shown in the inset of Fig.3. Using these values for  $!_{c \ H}$ , ts using Eq.3 are reduced to a single free parameter: an overall scale factor related to n. The  $_{xy}$  data of Fig.4 are tted using Eq.3 with both  $!_{c \ tr}$  and  $!_{c \ H}$  xed. The constrained ts to the MR data are poorer than those in the main panel of Fig.3 (possibly because of our neglect of the anisotropy), but the ts to  $_{xy}$  are very good.

In the inset to Fig. 4, we show the tted values of  $!_{c H}$  (solid line), along with the values of  $!_{c tr}$  (circles) that were used to constrain the ts. A lso included are the values of  $!_{c H}$  (triangles) obtained from the weak

eld Hallangle. Again, we nd that the scattering time determ ined from the high eld M R agrees better with the  $_{\rm H}$  determ ined from the weak eld Hallangle than with the  $_{\rm tr}$  determ ined from the resistivity.

Given the approximations used, we do not claim to favor the particular two-lifetime model of Eqs. 2 and 3. Rather, the combination of data from the weak eld regime in the optimally doped sample and the high eld regim e for the overdoped sam ple does favor som e kind of two-lifetim em odel for the cuprate norm alstate. It would be very interesting to analyze high eld M R saturation in cuprates at optim al doping, where separate tem perature dependences of the two scattering times are observed; how ever, this would require m uch higher m agnetic elds than are currently available.

In summary, we have succeeded in studying normal state magnetotransport of single crystal T  $\frac{1}{2}Ba_2CuO_{6+}$  in 60T pulsed magnetic elds to obtain new constraints on the scattering mechanisms in the cuprates. In optimally doped samples, the weak-magnetic eld regime reaches to elds as high as 60T. In overdoped samples, we leave the weak- eld regime, as shown by the behavior of both the MR and the Hall resistance. Analysis of the MR and Halle ect for both the optimally doped and overdoped samples gives evidence in support of those models for the normal state of the cuprates in which two scattering lifetimes exist at all points on the Ferm i surface.
