Spatial Correlations in Compressible Granular Flows

Abstract

For a freely evolving granular uid, the buildup of spatial correlations in density and ow eld is described using uctuating hydrodynam ics. The theory for incompressible ows is extended to the general, compressible case, including longitudinal velocity and density uctuations, and yields qualitatively dierent results for long range correlations. The structure factor of density uctuations shows a maximum at nite wavenum ber, shifting in time to smaller wavenum bers and corresponding to a growing correlation length. It agrees well with two-dimensional molecular dynamics simulations.

In most studies of rapid granular ows, also called the granular gas regime [1], the inelasticity of granular collisions is assumed to be the most important feature that distinguishes these ows from usual liquid or gas ows. The dynamics is modeled by a single inelasticity parameter = 1 2, where is the coecient of normal restitution. As a consequence a granular ow can only be maintained in driven systems, where energy is put into the systemeg. by gravity, shear or in vibrated layers [1]. Also quite some work has been done on the freely evolving granular uid [2{6}, which has been shown to be linearly unstable (onset of clustering instability) with respect to spatial uctuations in density, n(r;t) = n(r;t) hni [2]. In Ref. [7], an analytic description has been given of the buildup of equal time spatial correlations in the oweld,

of a system initialized in a spatially hom ogeneous state. The theory is based on uctuating hydrodynam ics and the assumption of incompressible low, r=u=0. This theory yields predictions, including long range tails r^d , that for nearly elastic particles (<0.2) agree well with 2-D molecular dynamic simulations up to large distances. Here we will extend the theory to the general, compressible case, allowing us to calculate longitudinal velocity and density uctuations. In fact, the structure factor corresponding to density uctuations, $S_{nn}(k;t) = V^1 h n(k;t) n(k;t)i$, has been analyzed before by Deltour and Barrat [4]. The difference between compressible and incompressible ow is best appreciated in Fourier space, where velocity correlations are described by the tensor S(k;t). Both G(r;t) and its Fourier transform $S(k;t) = V^1 h u(k;t)u(k;t)u(k;t)i$ are isotropic tensors and can be decomposed into two scalar isotropic functions in the following way:

where carets denote unit vectors. In a system of elastic hard spheres (EHS) for times larger than the mean free time t_0 , the correlation functions are given by the equilibrium values, i.e. G (r;t) = [T = mn] (r), containing self-correlations only, and G_{nn} (r;t) = n $(r) + r^2[g(r) 1]$, where g(r) is the pair distribution function in them all equilibrium. For convenience we substract self-correlations and introduce the functions G^+ (r;t) G (r;t) [T(t)=mn] (r) and S^+ (k;t) S (k;t) [T(t)=mn] N ote that T (t) is measured in energy units $(k_B = 1)$. The structure factor of transverse velocity uctuations, S_+^+ (k;t), was calculated analytically in Ref. [7] and shown to yield a long range r^d tail in G_+ (r;t) and G_+ (r;t) in case the uctuations in the owell are incompressible, i.e. S_+^+ (k;t) = 0.

In this Letter the structure factors S $\,$ (k;t) and S_{\rm nn} (k;t) and corresponding spatial correlation functions G $\,$ (r;t) and G_{\rm nn} (r;t) will be calculated and compared with 2-D molecular dynamics simulations for inelastic hard disk systems. We show in particular by explicit calculation that for small inelasticity ($^<$ 0.2) S_k^+ (k;t) is essentially vanishing for all wavenumbers except at very small k values (k $^<$ 1= $_k$), where the assumption of incompressible unuctuations, made in Ref. [7], breaks down. Consequently, the most important role of S_k^+ (k;t) is to provide an exponential cuto for the r detail at the largest scales r $^>$ 2 $_k$. At larger inelasticities the contributions from S_k^+ (k;t) modify G_k (r;t) and G_2 (r;t) significantly at all distances.

The hydrodynam ic equations for the unforced inelastic hard sphere (IHS) uid possess an exact solution, the hom ogeneous cooling state (HCS), with a hom ogeneous density n and temperature T (t), and vanishing ow eld. Energy is dissipated at a rate 2 $_0$! T, where $_0$ = =2d and where the collision frequency ! = $_d$ (n)n $_d$ T = m is calculated from the Enskog-Boltzm ann equation [8] for a dense system of hard disks or spheres (d = 2;3). Here $_d$ = 2 $_d$ = (d=2) is the surface area of a d-dimensional unit sphere, and m the sphere diameter and mass, both of which are set equal to unity, and (n) the pair correlation function at contact. For detailed de nitions and derivations we refer to [2]. In the following, we will assume that IHS hydrodynamics can be described by the standard hydrodynamic equations supplemented by an energy sink term, which is evaluated in the local hom ogeneous cooling state. The equations of change for the macroscopic elds then become

where all elds and uxes depend on (r;t). A possible justication of these equations to lowest order in can be found in Ref. [9], as well as a discussion of higher order term s. The pressure tensor = $_0+$ $_1$ is given by $_0=$ pI = nT (1+ $_d$ n $^d=2d)$ I, with I the identity matrix, and $_1=$ 2 fr ug (r u)I, with fr $y_1g=\frac{1}{2}(r$ u + r u 2 r u=d), and the heat ow J = r T. Here , and are, respectively, the shear viscosity, bulk viscosity and heat conductivity, given by the Enskog theory for EHS with temperature T (t) still depending explicitly on time to account for the homogeneous cooling [7]. The equations of change for them esoscopic elds are obtained from the above equations by adding uctuating terms to the pressure tensor and heat ow, denoted by $\hat{}$ and $\hat{}$ respectively [10]. They are characterized by a vanishing average and correlations which are local in space and time, the strength of which is assumed to be determined by the standard uctuation—dissipation theorem:

with transport coe cients depending on T (t). We are interested in the buildup of correlations between spatial uctuations in a system that is prepared in a hom ogeneous state at an initial temperature T_0 and reaches the HCS within a few mean free times $t_0=1=!$ $[n;T_0]$. Therefore, we can linearize the above equations around a hom ogeneous density n and a temperature T (t) = $T_0=[1+_0t=t_0]^2$, and a vanishing ow eld. At this point it is convenient to make the change of variables, d=! [n;T] (t) [dt], where is the average number of collisions a particle has suered within a time t, n(r;t)=n (r;t)=n (r

of change for the mesoscopic Fourier modes (k;), w (k;) and (k;) become ordinary dierential equations with time independent coe cients (valid for kl₀ < 1 where $l_0 = 2T$ (t)=! [h;T (t)] is the time independent mean free path):

Here we have introduced the time independent correlation lengths $_{?}$, $_{1}$ and $_{T}$, de ned by $_{?}^{2}$ = =! $_{0}$ with = =m n the kinematic viscosity, $_{1}^{2}$ = [2 (d 1)=d+ =m n]=! $_{0}$ and $_{T}^{2}$ = 2 =dn! $_{0}$, and the isothermal compressibility $_{T}$ = (@n=@p) $_{T}$ =n. The subscript in the equation for w $_{?}$ refers to any of the (d 1) directions perpendicular to k, and the subscript 1 denotes the longitudinal direction along k. To calculate the structure factors we also need the Fourier modes with k replaced by k.

Since the transverse velocity w_2 is decoupled from the other modes, its structure factor $S_2(k;t) = hu_2(k;t)u_2(k;t)u_3$ (k;t) i=V can be obtained in the analytic form [7]

which is valid for kl_0 < 1. The same result has been obtained from a more microscopic approach, using ring kinetic theory [11].

The density, longitudinal velocity and temperature modes are coupled and their equations of change can be written in matrix representation as

where is the column vector with components $_1 =$, $_2 =$ w $_1$ and $_3 =$, and the hydrodynamic matrix M and the noise vector $\hat{\mathbf{f}}$ are given by Eqs. (5). Note that the elements M $_{31}$ (k) and M $_{33}$ (k), entering the temperature equation, depend on the energy dissipation term. In this notation the equal time correlations obey the equation of change

where ; ;:::= 1;2;3 label the components , w_1 and . These equations constitute a set of 3 linear ordinary dierential equations, of which only 6 are independent. The matrix of

noise strengths C (k), de ned through hf (k;)f (k; $^{\circ}$)i = C (k) ($^{\circ}$), has only two nonvanishing components, namely $C_{22} = 2V_0k^2_1^2 = n$ and $C_{33} = 4V_0k^2_T^2 = dn$. We have solved the above set of equations num erically, starting from initial equilibrium correlations, of which the only nonvanishing ones are $h_1(k;0)_1(k;0)i = VT_T, h_2(k;0)_2(k;0)i =$ V=n and $h_3(k;0)_3(k;0)_i = 2V=dn$ (for $k \in 0$). The most important new results with respect to R ef. [7] are the structure factors S_k (k;t) and S_{nn} (k;t), and the correlation function G_{nn} (r;t). In Fig. 1, we show the results for these structure factors, including $S_{?}$ (k;t), for a system with area fraction = 0.245 and = 0.9 together with the results from a molecular dynam ics simulation of 50000 inelastic hard disks. We observe that S_k (k! 0;t) = S_2 (k! 0;t), implying for large distances an asymptotic behavior G S, (k! 0;t) (r;t) and thus the absence of algebraic long range correlations on the largest scales (r Therefore, we can already conclude that the asymptotic behavior of G_2 (r;t) and G_k (r;t) cannot be rd. Instead the rd tail obtained in Ref. [7] describes intermediate behavior which is exponentially cut o at a distance determ ined by the width of S_k^+ (k;t). This width can be estimated from the eigenvalues of the hydrodynamic matrix, more precisely from the dispersion relation of the heat mode [3], which is a pure longitudinal velocity w_1 for k ! 0. To second order in k its dispersion relation is given by z_H (k) = $_0$ (1

Note that $_k$ 1= for small inelasticity, whereas $_2$ $_1$ $_T$ 1= $_T$ [see Fig. 2(c)]. To a good approximation S_k (k;t) for small wavenumbers is given by expression (6) with $_2$ replaced by $_k$. This approximation is excellent up to wavenumbers where the exact numerical result for S_k (k;t) shows a little dip (see Fig. 1, = 19:4, k ' 0:1). At about the same wavenumber the structure factor S_{nn} (k;t) reaches its maximal value, which grows in time. The exact position of this maximum shifts in time to smaller wavenumbers corresponding to a growing correlation length. This can be explained by the following argument: for k! 0 density uctuations n (k;t) are decoupled from the heatmode and we expect that S_{nn} (k! 0;t) remains at its initial equilibrium value; at small, but nonvanishing k, n (k;t) couples in 0 (k) to the unstable heat mode and the maximum of k exp [Z_H (k)] shifts in time to smaller wavenumbers.

The estim ate for S_{nn} (k;t) ' S_{nn} (k;0) exp [2 z_H (k)], used in Ref. [4], diers in two aspects from our predictions: (i) it neglects the wavenum ber dependence of the coupling of density uctuations to the heat mode, giving for S_{nn} (k;t) a decreasing function of k, and therefore cannot explain the growing correlation length; (ii) it neglects the uctuating parts of the pressure tensor and heat ow, causing only numerical deviations from our prediction. Note that seven out of the eight sets of data points shown in Fig. 9 of Ref. [4] are in the crossover or nonlinear time regime, which is estimated in Ref. [7] to occur at $_{cr}$ ' 65 for = 0.9 and = 0.4 and where our linear theory breaks down.

U sing the above approximation for S_k (k;t), the structure factor S^+ (k;t) can be written as

where $s=2_0$. If the system is thermodynamically large (L 2_k), G_k^+ (r;t) = $f f G^+$ (r;t) and G_2^+ (r;t) = ($f f G^+$ (r;t)=(d 1) can be obtained by perform ing integrals over k space; the resulting G_k^+ (r;t) and G_2^+ (r;t) can then be expressed as integrals over simple functions. Here we only quote the results for d=2. Using

for =k;?, where x=r=, $m_k=1$ and $m_?=1$. The approximation of incompressible uid ow of Ref. [7] is obtained in the lim it $_k$! 1. It is consistent with the thermodynamic concept of incompressibility, i.e. $_T=0$ in (9), implying an in nite speed of sound. Fig. 2 shows $g_k(x_?;s)=[n_?^2=T(t)]G_k^+(r;t)$ and $g_?(x_?;s)=[n_?^2=T(t)]G_?^+(r;t)$ in the above approximation for different ratios $_k=?$ at s=2. In order to see r^d behavior the second term of (12) should dominate over the rst. For $_k^2=?$, $\exp(-x_?^2=4s^0)$ can be neglected with respect to $\exp(-x_k^2=4s^0)$, and the second term behaves algebraically if $x_k^2 \le 4s$. Restricting ourselves to $1 \le s \le 10$ (i.e. moderate times where the correlations have grown above noise level), we can estimate that the range of algebraic decay is restricted to $r \le 2_k$, where the factor 2 is chosen for convenience. For $r \ge 2_k$, the remaining exponent cuts of the r^d

The predicted spatial velocity correlations G_k (r;t) and G_2 (r;t) have been obtained by num erically perform ing inverse Bessel transform ations on the num erical results for S_k (k;t) and S_2 (k;t). The result for G_k (r;t) corresponding to Fig. 1 includes an intermediate r^2 tail and is shown in Fig. 3(a). Fig. 3(b) shows the corresponding spatial density correlation G_{nn} (r;t) obtained num erically from S_{nn} (k;t). It can me sthat the present theory correctly predicts the buildup of density correlations, including a negative correlation centered around a distance which grows in time as

At small inelasticity ($^{<}$ 0.2) the functions $G_k(r;t)$ and $G_2(r;t)$, calculated here from the full set of hydrodynam ic equations, di er for $r^{<}$ 2 $_k$ only slightly from the results for incompressible ow elds (see discussion in Ref. [7]). However, the algebraic tails r^d in $G_k(r;t)$ and $G_2(r;t)$, derived in Ref. [7] for $r^{>}$ 2 $_2$, are exponentially cut of for $r^{>}$ 2 $_k$. As the correlation lengths $_2$ $_1$ and $_k$ $_1$ are well separated for small [see Fig. 2 (c)], there is an intermediate range of r values where the algebraic tail r^d in $G_k(r;t)$ can be observed.

At higher inelasticity $_k$ and $_?$ are not well separated and, as a consequence, there does not exist a spatial regime in which the longitudinal uctuations in the ow eld can be neglected and the regime of validity of the incompressible theory of Ref. [7] has shrunk to zero. Fig. 3 (c) compares results from incompressible and compressible uctuating hydrodynamics with simulation data for $G_?$ (r;t) at = 0.6 and = 0.4 and con rms the validity of

the compressible uctuating hydrodynam ics description up to reasonably large inelasticities. Note that $G_{\,\mathrm{nn}}$ (r;t) can only be calculated from the compressible theory.





Title: Spatial Correlations in Compressible Flows A uthors: TPC. van Noije, MH. Ernst and R. Brito


