# Test of Guttm ann and Enting's con jecture in the eight-vertex 

## m odel

#### Abstract

W e investigate the analyticity property of the partially resum $m$ ed series expansion (P R SE ) of the partition function for the eight-vertex m odel. D eveloping a graphicaltechnique, we have obtained a rst few term sof the PRSE and found that these term s have a pole only at one point in the com plex plane of the coupling constant. This result supports the con jecture proposed by Guttm ann and Enting conceming the \solvability" in statistical mechanical lattice $m$ odels.


Recently Guttm ann and Enting introduced a new point of view into the study of the solvability of lattioe $m$ odels in the statisticalm echanics, including $m$ odels for com binatorial problem s $\left.{ }_{[1]}^{[1]}\right]$. Their approach is based on a study of the connection between the solvability of lattioe $m$ odels by use of the inversion relation and the analyticity properties of their associated series expansion, which is called the partially resum m ed series expansion (PR SE ). For exactly solvable $m$ odels, the inversion relation for the partition function was derived using the star-triangle relation [2], [3] . Subsequently, it w as show $n$ to hold true for the partition function of (so far) unsolved models and other physical quantities as well $\overline{[ }]$ ]. Thus the inversion relation can be used for clarifying the di erence betw een exactly solved quantities and unsolved ones in statistical lattice $m$ odels.

The im portance of the analyticity properties of the PRSE was rst pointed out by Baxter [5]. He considered the PRSE for the reduced free energy ln ( $\mathrm{f}_{1} ; \mathrm{t}_{2}$ ) of the
zero- eld anisotropic Ising model on the square lattice, $\ln \left(t ; t_{2}\right)={ }^{P} R_{n}\left(t_{1}^{2}\right) t_{2}^{2 n}$, and showed that the functions $R_{n}\left(t_{1}^{2}\right)$ can be determ ined recursively from the inversion relation, ln $\left(t_{1} ; t_{2}\right)+\ln \quad\left(t_{1}^{1} ; t_{2}\right)=\ln \left(1 \quad t_{2}^{2}\right)$, and the symmetry relation $\quad\left(t_{1} ; t_{2}\right)=\left(t_{2} ; t_{1}\right)$, provided $R_{n}\left(t_{1}^{2}\right)$ have singularities only at a single point in the $t_{1}^{2}$-com plex plane. This realization led to a series of investigations on the partial sum $s R_{n}\left(t_{1}^{2}\right)$ for unsolved quantities such as the partition function of the 2D Ising model in a eld '[इ], non-critical 2D Potts
 results for these quantities indicate that in nitely $m$ any poles appear in partial sum $s R_{n}$ in the lim it n! 1 in clear contrast with the solvable case.

The new approach of Guttm ann and Enting to the solvability of lattice models is as follow s. They de ned a given quantity to be solvable if its solution can be expressed w ith a D - nite function! ['] ] as a function of the coupling constant. D - nite functions are de ned as functions which satisfy a linear ordinary di erentialequation of nite order w ith polynom ial coe cients. The de nition of the solvability was extended so that solvable quantities do not necessarily have a closed form solution. H ow ever, it is restrictive in the sense that those quantities which are expressible with the solution of a nonlinear di erential equation are classi ed as \unsolvable" ones.

G uttm ann and Enting further put forw ard a criterion which determ ines whether a given quantity is solvable or not in the sense ofD - niteness. First, generalize the $m$ odel such that it possesses tw o (orm ore) anisotropic coupling constants $t_{1}$ and $t_{2}$. Let the wanted quantity be $f\left(t_{1} ; t_{2}\right)$. O ne can calculate exact coe cients of the series expansion of $f, f\left(t_{1} ; t_{2}\right)=$ x
$a_{m} n t_{1}^{m} t_{2}^{n}$ (to a considerably high order with sophisticated techniques). Then, perform ing the in nite sum with respect to, say, $t$ rst, one obtains the PRSE, $f\left(\frac{1}{l} ; t_{2}\right)={ }^{x} R_{n}\left(t_{1}\right) t_{2}^{2}$. Let us assum e that the poles in $R_{n}\left(t_{1}\right)$ all lie on the unit circle in the $t_{1}$-com plex plane (th is is not essential, how ever). Their con jecture on the criterion is stated as follow s : (i) If the num ber of poles of $R_{n}$ rem ains nite as $n!1$, then $f\left(\frac{1}{4} ; t_{2}\right)$ is a $D$ - nite function of $t$ $w$ th $t_{2}$ being $x e d$. (ii) If there appear in nitely $m$ any poles densely distributed along the unit circle as n! 1 , then $f\left(t_{1} ; t_{2}\right)$ cannot be expressed in term sofD - nite functions only.

It is illum inating to look at the spontaneousm agnetization $M$ of the 2D Ising $m$ odelas an exam ple of the case (i). The closed form solution is given asM (u; v) = (1 16uv=(1)u $)^{2}(1$ $\left.v)^{2}\right)^{1=8}$ in the low tem perature phase, where $u=\left(\begin{array}{ll}1 & t_{1}\end{array}\right)=\left(1+t_{1}\right)$ and $v=\left(1 \quad t_{2}\right)=\left(1+t_{2}\right)$. O ne can calculate a rst few term sof the Taylor expansion $M(u ; v)={ }^{P}{ }_{n} \quad 0_{0} R_{n}(u) v^{n}$ by directly taking derivatives of the above expression. But this would soon becom e undoable. A concise way to calculate the coe cients is to $m$ ake use of the di erentialequation satis ed by M (u;v). By extending the argum ent in [8] $]$ one arrives at

$T$ his show $s$ that the spontaneous $m$ agnetization is $D$ - nite. It is then determ ined im plicitly from the recursion relation for $\mathrm{R}_{\mathrm{n}}$

From this recursion relation, it is clear that the partial sum $\mathrm{sR}_{\mathrm{n}}$ have poles only at $\mathrm{u}=1$. W e should note that the recursion we have derived above from $D$ - niteness is di erent from that discussed by B axter [1] ] and $m$ entioned earlier. In the latter case, to calculate the term $R_{n}$ one needs all $R_{k}$ prior to $R_{n}$. By contrast, in the form er case, only a xed nite number of term $s$ is su cient to obtain the term $R_{n}$ no $m$ atter how large $n$ is.

Exam ples of the case (ii) are the zero- eld susceptibility of the 2D anisotropic Ising m odel and generating functions for self-avoiding polygons on the square and hexagonal lattioes. Guttm ann and Enting argued using the nite-lattice $m$ ethod'[ $[9]$ that in nitely $m$ any poles w ill appear in partial sum sfor those quantities in the lim it $n!1$ [inill.

The few analyses $m$ entioned above already indicate that $G$ uttm ann and Enting's conjecture unravels a new aspect of exactly solvable m odels, the connection of the solvability to the distribution of poles and $D$ - niteness of the solution. The con jecture deserves a further and detailed study. In particular, it is very im portant to exam ine whether $G$ uttm ann and Enting's con jecture has general applicability to a broad class of statistical m echanical
system $s$. The eight-vertex m odel is particularly suited to this end. It can be regarded as a nontrivial generalization of the 2 D Ising m odel. It has three coupling constants and can be com pared w th the previous analyses of the zero- eld 3D Ising model and the 2D Ising modelin a eld.

W e adopt the spin-type $m$ odel description of the eight-vertex $m$ odel. The spin variable a placed on each site of the square lattice consisting of $N$ faces(F ig.1) takes the values 1. The localB oltzm ann weight is de ned on each face $f$ in the lattioe and depend on the spin con guration around the face $f \mathrm{f}=(\mathrm{a} ; \mathrm{b} ; \mathrm{c} ; \mathrm{d}) \mathrm{as}$

The partition function is given by
where the sum $m$ ation is over all spin con gurations on the lattice sites and the product is over all faces in the lattice. The lattice is assum ed to have the periodic boundaries. This $m$ odel can be regarded as a pair of Ising $m$ odels $w$ th anisotropic coupling constants $K$ and L , each living on one of the sublattioes and coupled by the four-spin coupling M .

The localB oltzm ann weight can be rearranged as

$w$ ith $t_{1}=\tanh K, t_{2}=\tanh L, t_{3}=\tanh M . z_{1}, z_{2}, z_{3}$ are high-tem perature variables and is the norm alization factor. Let us represent each term in RHS of ( as show $n$ in $F$ ig 2. $W$ e call the bonds show $n$ in (b), (c), (d) of Fig $2 z_{1}-, z_{2}-, z_{3}$-bonds.

Substituting ( $(\underset{1}{ })$ into ( $\overline{4}$ ) and expanding the products yields all possible bond con gurations over N faces in the lattice. The sum m ation over spin con gurations leaves only those
in which an even num ber of bonds are incident to each lattice site, i.e., closed graphs. The reduced partition function, ${ }_{N}\left(Z_{1} ; Z_{2} ; z_{3}\right)=(2)^{N} Z_{N}(\mathbb{K} ; L ; M)$, also plays the role of the generating function for the enum eration of closed graphs in the lattioe. They are classi ed in term $s$ of the num bers of the $z_{1}-z_{2}-, z_{3}$-bonds, $1 ; m ; n$. Then ${ }_{\mathrm{n}}$ can be written as

where $\mathrm{P}_{\mathrm{mn}}(\mathbb{N})$ is the number of the closed graphs and is a polynom ial in $N$. De ne the reduced partition function per face in the therm odynam ic lim it by $\left(z_{1} ; z_{2} ; z_{3}\right)=$ $\lim _{N!}\left({ }_{N}\left(z_{1} ; z_{2} ; z_{3}\right)\right)^{1=N}$. Then the expansion of $\left(z_{1} ; z_{2} ; z_{3}\right)$ in the connected closed graphs is given by

Our aim is to see whether or not $\ln \left(z_{1} ; z_{2} ; z_{3}\right)$ possesses the property conjectured by Guttm ann and Enting. W e begin by looking at the inversion relation for the eight-vertex $m$ odel [⿶凵1 $]$, which reads in the variables $z_{1} ; z_{2} ; z_{3}$ as

$N$ ote that if one sets the four-spin coupling $M$ to zero, i.e. $z_{3}=z_{1} z_{2},(\underline{1} \overline{0})$ reduces to the inversion relation for the anisotropic Ising $m$ odel. Since ( $(\underline{1} \mathbf{1} 0)$ ) involves the inversion of two variables, $z_{1}$ and $z_{3}$, one has to take the double in nite sum $w$ ith respect to both to com pare the series ( $\overline{9})$ w ith ( $(\overline{1} \overline{0})$ ). In practice this tums out to be a hard task. Fortunately, one can circum vent the di culty by a slight change of variables as $v_{1}=z_{1} ; v_{2}=z_{2}$ and $v_{3}=z_{3}=z_{1}$. Then (

In this case, only $\mathrm{v}_{1}$ is inverted and one has only to take the partial resum $m$ ation $w$ ith respect to $\mathrm{v}_{1}$, which we write as

N ote that $Q_{m n}$ depends only on $R_{k l} w$ ith $k+1$ no greater than $m+n$. The relation (1 gives constraints on the partial sum $s R_{m n}\left(v_{1}^{2}\right)$ and is used in the later analysis of the PRSE .

O nem ight think that it is im m ediate to obtain the P R SE ( 1 İ $\overline{2}$ ) for the eight-vertex $m$ odel, since we have the exact solution at hand. H ow ever, the expression of the exact solution in term s of the elliptic param eters is very im plicit. So far we have not been able to derive the PRSE from the exact solution and to nd out the location of poles in the partial sum $s$ in $v_{1}^{2}$.

Instead we em ploy a graphical approach to calculate $R_{m n}\left(v_{1}^{2}\right)$ in the series expansion (1] $\overline{2}$ ). The closed graphs w th $2 m \quad z_{2}$ toonds, $2 n z_{3}$-bonds and an arbitrary number of $z_{1}$ bonds contribute to $R_{m n}$. Because of the presence of the four-spin coupling constant, there appear vastly $m$ any types of closed graphs even at low orders. W e have developed a schem e to classify the graphs by introducing the notion ofm inim al graph, the graph $w$ ith the least num ber of $\mathrm{z}_{1}$-bonds am ong those in one class. The derivation of our $m$ ethod is lenghty and w ill be presented in a separate paper. Here we report the results of our analysis of a rst few term $s$ of the expansion:

The rem aining graphs are obtained by successively adding a pair of $z_{1}$-bonds vertically, which we call $v_{1}^{2}$-extension. $T$ he weights of the $v_{1}^{2}$ extended graphs in (a) of $F$ ig. 3 are $v_{1}^{2} v_{2}^{2}, v_{1}^{4} v_{2}^{2}, v_{1}^{6} v_{2}^{2}$ and so on. Their contribution to $R_{10}$ sum s up to $v_{1}^{2}=\left(\begin{array}{ll}1 & v_{1}^{2}\end{array}\right)$.
$m=1 ; n=1 \quad$ There are two classes of graphs $w$ th two $z_{2}$-bonds and two $z_{3}$-bonds which contribute to $R_{11}$. O ne of them is shown in (b) of $F$ ig. 3. Its $m$ inim al graph can be extended in three ways. It has two $v_{1}^{2}$-extensions, extending either of the two squares independently. The third is a sim ultaneous extension of the two squares (see the third graph of $F$ ig. 3 (b)), which we call $v_{1}^{4}$-extension. The weights of the graphs in (b) of $F$ ig. 3 are thus $v_{1}^{4} v_{2}^{2} v_{3}^{2}, v_{1}^{6} v_{2}^{2} v_{3}^{2}, v_{1}^{8} v_{2}^{2} v_{3}^{2}$ and so on. The contribution from these graphs sum $s$ up to $2 \mathrm{v}_{1}^{4}=\left(\begin{array}{lll}1 & \mathrm{v}_{1}^{2}\end{array}\right)^{2}\left(\begin{array}{ll}1 & \mathrm{v}_{1}^{4}\end{array}\right)$, where the factor 2 takes account of em beddings of graphs and their re ection. The contribution from the other class to $R_{11}$ is given by $2 v_{1}^{6}=\left(\begin{array}{lll}1 & v_{1}^{2}\end{array}\right)^{2}\left(1 \quad v_{1}^{4}\right)$. $m=2 ; n=0 \quad$ There are six classes ofgraph $w$ th four $z_{2}$-bonds and zero $z_{3}$-bonds which contribute to $\mathrm{R}_{20}$. F ive of the corresponding $m$ inim algraphs consist of connected graphs and the other of a disconnected graph $w$ th two squares. These graphs have only $v_{1}^{2}$-extensions.
$m=1 ; n=2$ There are tw elve classes of graphs which contribute to $R_{12}$. In each class the $m$ inim al graph can be extended in $m$ any di erent ways. Som e of the twelve $m$ in $m$ al graphs are show $n$ in $F$ ig. 3 (c)-(e). The graphs of the class (c) are obtained from the $m$ in im al graph (c) by two ways of $v_{1}^{2}$-extension and three ways of $\mathrm{v}_{1}^{4}$-extension. Their contributions yield $2 v_{1}^{6}=\left(\begin{array}{lll}1 & v^{2}\end{array}\right)^{2}\left(\begin{array}{ll}1 & v_{1}^{4}\end{array}\right)^{3}$. The contributions of the graphs of the class (d) and (e) can be found by sim ilar argum ents: $4 \mathrm{v}_{1}^{8}=\left(\begin{array}{lll}1 & \mathrm{v}^{2}\end{array}\right)^{2}\left(\begin{array}{ll}1 & \mathrm{v}_{1}^{4}\end{array}\right)^{3}$ and $2 \mathrm{v}_{1}^{10}=\left(\begin{array}{lll}1 & \mathrm{v}^{2}\end{array}\right)^{2}\left(\begin{array}{ll}1 & \mathrm{v}_{1}^{4}\end{array}\right)^{3}$ respectively. The sum of the contributions from the tw elve classes tums out to take a surprisingly sim ple form, $3 v_{1}^{6}\left(1+v_{1}^{2}\right)=\left(1 \quad v_{1}^{2}\right)^{5}$, which is free from the pole at $v_{1}^{2}=1$.

To sum $m$ arize the above analysis, we have obtained the follow ing expressions for the rst four term s of the PRSE:

The corresponding term $\operatorname{sof} Q_{m n}\left(v_{1}^{2}\right)$ can be easily obtained from these results as explained previously.

There are a few im portant points to be noted. $F$ irst, we have checked that $\mathrm{R}_{\mathrm{m} \mathrm{n}}\left(v_{1}^{2}\right)$ and $Q_{m n}\left(v_{1}^{2}\right)$ satisfy the perturbative form of the inversion relation (1]in). This is a highly
nontrivial check that the result ( structure of $R_{m n}\left(v_{1}^{2}\right)$. A s rem arked above, $R_{10}\left(v_{1}^{2}\right)$ and $R_{20}\left(v_{1}^{2}\right)$ have a pole only at $v_{1}^{2}=1$ for a graphical reason. A s for $\mathrm{R}_{11}\left(v_{1}^{2}\right)$, both of the contributions from the two classes have poles at $v_{1}^{2}=1$ and $v_{1}^{2}=1$. Curiously, the extra pole at $v_{1}^{2}=1$ cancels out in the sum of two contributions, leaving the pole term $1=\left(\begin{array}{ll}1 & v_{1}^{2}\end{array}\right)^{3}$. It is even $m$ ore $m$ iraculous that, as noted above, the sam e kind of cancellation of the poles at $v_{1}^{2}=1$ takes place for $R_{12}\left(v_{1}^{2}\right)$, leaving the pole term $1=\left(\begin{array}{ll}1 & V_{1}^{2}\end{array}\right)^{5}$.
$W$ e think that the absence of extra poles at $v_{1}^{2}=1$ in the rst four term sof the PRSE is not a pure accident but that it has a raison d'Atre. It should be counted as a strong indication that poles in $R_{m n}\left(v_{1}^{2}\right) w$ ill not appear at other values than $v_{1}^{2}=1$ for higher $m$ and $n$, supporting the con jecture of $G$ uttm ann and Enting.

It is illum inating to com pare the present result on the PRSE for the eight-vertex m odel w th that for the 3D Ising m odel [这]. The latterm odelalso has three coupling constants. The inversion relation and the PRSE in this model read as $\ln \left(t_{1} ; t_{2} ; t_{3}\right)+\ln \left(t_{1}{ }^{1} ; t_{2} ; t_{3}\right)=$ $\ln \left(1 \quad t_{2}^{2}\right)$ and $\ln \quad\left(t_{1} ; t_{2} ; t_{3}\right)={ }_{m n}^{x} R_{m n}\left(t_{1}^{2}\right) t_{2}^{2 m} t_{3}^{2 n}$. N ontrivial results start to appear from $R_{12}\left(L_{1}^{2}\right)\left(R_{m} 0\left(v_{1}^{2}\right)=R_{0 m}\left(v_{1}^{2}\right)\right.$ coincide w ith $R_{m}\left(t_{1}^{2}\right)$ of the $2 D$ Ising $m$ odel, $R_{11}\left(L_{1}^{2}\right)$ has no poles other than at $t_{1}^{2}=1$ for a straightforw ard graphical reason). Indeed, $R_{12}\left(t_{1}^{2}\right)$ was found to have poles of the form $1=\left(\begin{array}{ll}1 & t_{1}^{2}\end{array}\right)^{5}\left(1+t_{1}^{2}\right)$. A n extra pole at $t_{1}^{2}=1$ already appears at the third order $(m+n=3)$ term of $R_{m n}\left(t_{1}^{2}\right)$. It is a sign that an in nite num ber of poles w illappear in the lim it m in! $1 . W$ e note a clear di erence in the pole structure of $R_{m n}$ ( $t$ ) between the eight-vertex $m$ odel and the 3D Ising $m$ odel even at low orders. P robably this di erence re ects the fact that the form er model is solvable while the latter is not.

Finally, we postulate the form of the partial sum $R_{m n}\left(v_{1}^{2}\right)$ at all orders by extending our results at low orders and exam ine the role of the inversion relation regarding the exactly solvable partition function in the approach of the PRSE. Let us assume that the partial sum s of the eight-vertex reduced partition function have only ( $m$ ultiple) poles at $v_{1}^{2}=1$. By a graphical consideration, one can guess the general form of the partial sum $s: R_{m n}\left(v_{1}^{2}\right)=$
$P_{m n}\left(v_{1}^{2}\right)=\left(1 \quad v_{1}^{2}\right)^{2(m+n)} 1$, where $P_{m n}\left(v_{1}^{2}\right)$ is a polynom ialin $v_{1}^{2}, P_{m n}\left(v_{1}^{2}\right)={ }_{k=0}^{2\left(m X^{n}\right)} \quad C_{m n k} V_{1}^{2 k}$. Then $P_{m n}\left(v_{1}^{2}\right)$ can be determ ined recursively from the inversion and sym $m$ etry relations as follow s. Suppose that $\mathrm{R}_{\mathrm{kl}} \mathrm{w}$ th $\mathrm{k}+\mathrm{l}<\mathrm{L} 1$ are known. Then from the sym $m$ etry, ln $\left(\mathrm{v}_{1} ; \mathrm{v}_{2} ; \mathrm{v}_{3}\right)=\ln \left(\mathrm{v}_{2} ; \mathrm{v}_{1} ; \mathrm{v}_{1} \mathrm{v}_{3}=\mathrm{v}_{2}\right)$, we have the system of linear equations,
 we cients only, we have a half of the coe cients $f_{C_{m k}}: m+n=L ; 0 \quad k \quad L \quad 1 g$. From the inversion relation (ī1) we have

which determ ine the other half of the coe cients $f q_{m k}: m+n=L ; L \quad k \quad 2 L \quad 1 g$. Thus the solution for the eight-vertex partition function is reproduced by extending the $m$ ethod which was rst used for the 2D Ising m odelby B axter![[]]. The rst few term softhis solution agree w ith (1). M oreover, it reduces to the PRSE for the O nsager solution in the Ising lim it. This rem arkable coincidence further supports our argum ent on the pole structure of $R_{m n}$ for the eight-vertex partition function.
