## D am ping of H ydrodynam ic M odes in a Trapped Bose G as above the Bose-E instein Transition Tem perature

We calculate the damping of low -lying collective modes of a trapped Bose gas in the hydrodynamic regime, and show that this comes solely from the shear viscosity, since the contributions from bulk viscosity and therm al conduction vanish. The hydrodynamic expression for the damping diverges due to the failure of hydrodynamics in the outer parts of the cloud, and we take this into account by a physically motivated cuto procedure. Our analysis of available experimental data indicates that higher densities than have yet been achieved are necessary for investigating hydrodynamic modes above the Bose E instein transition temperature.

In recent experim ents on m agnetically-trapped atom ic vapors, alkali atom s [1{3] have been cooled to tem peratures at which they are degenerate and indeed Bose-Einstein condensation has been observed in them . Frequencies and dam ping rates of collective m odes in these systems have been investigated, both above and below the Bose-E instein transition temperature,  $T_c$  [4[6]. In this Letter we shall focus on properties above T<sub>c</sub>. One can distinguish two regimes, the hydrodynam ic one, for which the characteristic mode frequency is small com pared with the collision frequency and the wavelength of the mode is large compared with the atom ic mean free path, and the opposite lim it, the collisionless one, for which collisions are relatively unimportant. The frequencies of m odes in the hydrodynam ic reqime have been calculated in Ref. [7], and here we calculate their dam ping.

W e begin by giving a simple derivation of the basic hydrodynam ic equations. Our treatment is essentially that of Ref. [8] generalized to take into account the potential of the trap, and, since we are interested in small oscillations, we shall consider the linearized equations. The Euler equation for the uid velocity v (r;t) is

where m is the mass of the atom s, n (r;t) is the particle density,  $n_0(r)$  is the equilibrium particle density, p(r;t) is the pressure and f is the force per unit mass due to the external potential  $U_0(r)$ ,  $f = r U_0(r) = m .$  In equilibrium, where the pressure is  $p_0(r)$ , Eq. (1) in plies that r  $p_0(r) = m n_0(r)f$ . Taking the time-derivative of Eq. (1) and using the continuity equation, one nds

We calculate the statem on the right hand side of Eq. (2) by using the energy conservation condition [8],

where is the mass density and and w are, respectively, the internal energy and the enthalpy of the uid per unit m ass. Since we assume local therm odynamic equilibrium and neglect contributions to the energy due to interparticle interactions, we may use the results p = (w) and = 3p=2, and nd that

C om bining Eqs. (2) and (4), and using the fact that r  $n_0$  (r) is proportional to r  $U_0$  (r), we obtain for the equation of motion for v (r;t),

$$\frac{\theta^2 v}{\theta t^2} = \frac{5}{3} \frac{p_0(r)}{m n_0(r)} r [r v] + r [v f] + \frac{2}{3} [r v] f: (5)$$

E quation (5) has previously been derived by G ri n et al. [7] using kinetic theory.

In our present discussion we assume that the potential is axially symmetric,

$$U_{0}(\mathbf{r}) = \frac{1}{2}m !_{0}^{2}(\mathbf{x}^{2} + \mathbf{y}^{2} + \mathbf{z}^{2}); \qquad (6)$$

where  $!_0$  is the frequency of the trap in the x y plane;

 $!_{z}^{2}=!_{0}^{2}$  { where  $!_{z}$  is the frequency along the z-axis { expresses the anisotropy of the trap. M ost experiments on oscillations have been done in such traps, but our results m ay be generalized to the case of traps with no axis of symmetry. As shown in Ref. [7], in the lowest m odes, which in a spherical trap correspond to m onopole and quadrupole vibrations, the velocity eld has the form v (r;t) = v (r) cos(!t), where v (r) = a (x $\hat{x} + y\hat{y}$ ) + bz2. H ere a and b are constants, and the frequencies, !, of the two m odes are

and b=a =  $3!^2 = 2!_0^2$  5.

W e turn now to the dam ping of these m odes. W e adopt the standard approach of evaluating the rate of change of the m echanical energy,  $E_{m ech}$ , associated with the m ode, which is given by [9]

where is the therm al conductivity, is the rst, or shear, viscosity, is the second, or buk, viscosity and T is the temperature. Because the system is inhom ogeneous, the transport coe cients are generally spatially dependent. Next we show that the shear viscosity is the only source of damping of the low-lying modes described above. The contribution from therm al conduction vanishes because there are no temperature gradients for these modes, and the contribution from the bulk viscosity vanishes because vanishes. To demonstrate the absence of temperature gradients, we observe that for the modes under consideration, which have the velocity

eld given above, r  $v = (2a + b)\cos(!t)$  is independent of position. Thus, from the continuity equation, v = 0, it follows that (dn=dt)=n is also dn=dt + nr constant. For an adiabatic process in a free monatom ic gas, n / T<sup>3=2</sup>, and therefore the deviation of the tem perature from its equilibrium value is spatially independent. Consequently there are no tem perature gradients generated by the mode, and hence no dissipation due to therm al conduction. As to the second viscosity, this vanishes because a spatially-hom ogeneous, non-relativistic monatom ic gas in equilibrium subjected to a slow uniform dilation (r! r) remains in equilibrium, but at a di erent tem perature. This result is independent of the statistics of the atom s and of the degree of degeneracy, and it is discussed in Ref. [10]. Inserting into Eq. (8) the expression for the velocity eld, we arrive at the follow ing simple expression for the time-average of the rate of loss of m echanical energy:

Equation (9) implies that  $hE_{mech}i$  vanishes for the monopole mode for the isotropic case ( = 1).

The next task is to calculate the st viscosity. At the low energies of interest in experiments, the scattering of two atoms is purely s-wave, and the total cross section is  $= 8 \text{ a}_{\text{scat}}^2$ , where  $a_{\text{scat}}$  is the scattering length. We consider the viscosity in the classical limit, since we expect the classical limit to be quantitatively accurate, even at T very close to T<sub>c</sub>, from comparison to the known e ects of degeneracy on the heat capacity. The viscosity has the general form [10]

A simple relaxation-time approximation, with a scattering rate equal to  $n_0$  (r) v, where  $v = (2 = m)^{1=2}$  is the particle velocity and is the single-particle energy, leads to the result  $C = 2^{7=2} = (15^{1=2}) = 0.426$ , while a variational calculation gives  $C = 5^{1=2} = 2^4 = 0.554$ .

An important feature of the expression for the viscosity is its independence of the particle density. Consequently, the integral in Eq. (9) form ally diverges at large distances from the center of the trap. The reason for this is that hydrodynam ics fails, because in the outer parts of the cloud, particle mean free paths are too long for hydrodynam ics to be applicable. To solve this problem, one should treat the outer parts of the cloud using kinetic theory, rather than hydrodynam ics, but to obtain a rst estimate of the e ects we shall assume that the hydrodynam ic description holds out to a distance such that an atom incident from outside the cloud has a probability of nom ore than 1=e of not su ering a collision with another atom . In the parlance of radiative transport, this corresponds to an optical depth of unity. M athem atically, this condition is

where the local mean free path is  $l(r) = [n_0(r)]^{-1}$ , and  $r_{0;s}$  is the cuto , which depends on direction. The integral in Eq. (11) is to be performed along the path for which the density gradient is steepest, that is along r U<sub>0</sub>, and ds is the corresponding line element. For a classical distribution,  $n_0(r) = n (0)e^{U_0(r) = k_B T}$ , where n (0) is the density at the center. Since  $dU_0 = r U_0$  jds, Eq. (11) can be written as

For large values of the dimensionless parameter  ${}^{1=2}N a_{scat}^2m !_0^2 = k_B T, Eq. (12)$  gives

where is the angle of  $r_{0;s}$  with respect to the z-axis. The dimensionless quantity  $_{s}$  () is essentially the total optical depth at the center of the cloud

The density at the center of the cloud is  $n(0) = N^{1=2} (m!_0^2 = 2 k_B T)^{3=2}$ . The volume of the atom is cloud

is given by integrating  $r_{0,s}^3 = 3$ , Eq. (13), over the solid angle. Equation (9) with the variational estimate for the viscosity (C = 5  $^{1=2}=2^4$ ) can then be written as

$$hE_{mech}i = \frac{5^{1-2}}{2^{7-2}3^2} (a - b)^2 \frac{(k_B T)^2}{m!_0^3 a_{scat}^2} f(; 0): (16)$$

The function  $f(; _0)$  is de ned as

We expect the leading term (/  $[\ln_0]^{3=2}$ ) to be asymptotically exact for large  $_0$ , but the value of the cuto in the logarithm will depend on the detailed kinetic-theory solution to the boundary-layer problem.




FIG.1. We plot f (; \_0) from Eq. (17) as function of the number of particles N, for = 8,  $a_{scat}$  = 53 A, \_0 = 129 Hz, and T = 1:3T<sub>c</sub>, which are the parameters in the experiment of Ref. [6]. A symptotically, for \_0 = 1, f (= 8; \_0) = 2^{-122} [ln (\_0^{-122})]^{3-2} = 0:53 [ln (\_0^{-122})]^{1-2}.

To calculate the dam ping rate we need to evaluate the mechanical energy of the cloud,  $E_{mech}$ . In any oscillator the time-average of  $E_{mech}$  is equal to the maximum kinetic energy in the mode, so

$$hE_{m ech} i = \frac{1}{2}^{Z} m n_{0} (r)v^{2} (r)dr; \qquad (18)$$

and therefore,

$$hE_{m ech}i = N \frac{k_B T}{!_0^2} a^2 + \frac{b^2}{2}$$

We can now introduce the amplitude damping rate  $\frac{1}{\dim p}$  (as opposed to the energy damping rate, which is twice the amplitude damping rate), given by the absolute value of the ratio  $kE_{mech}$  i=2 $kE_{mech}$  i,

In order to elucidate the origin of the dam ping of the modes given by Eq. (7), we remark that when the viscosity is taken to be constant, the non-equilibrium stress tensor is constant in space, and therefore does not give rise to any force on a uid element. The dam ping is caused by the entropy generated by the non-equilibrium energy current density, which has a constant, non-zero divergence.

Let us now turn to the experiments on sound propagation that have been performed to date. A necessary condition for hydrodynam ics to be applicable is that the m ean free path be sm all com pared with the characteristic length scale of the mode. For the low modes we are studying here, this is equivalent to the requirem ent that the optical depth  $_{\rm s}$  ( ) be large compared with unity in all directions. For the M IT experiment [4], for which < 1, this condition implies that  $1^{-2}$  0 1. In terms of the characteristic lengths,  $R_z = (2k_B T = m !_z^2)^{1=2}$  and  $R_2 = (2k_B T = m !_0^2)^{1=2}$ , which measure the spatial extent of the cloud along the z-axis and perpendicular to it, the condition 1=2 1 is seen to be equivalent to the requirem ent  $R_{?}$ 1(0), where 1(0) is the mean free path in the center of the cloud. For the parameters of this experim ent [4], the m in im um num ber of particles that is required for this condition to be satis ed is 3 190. whereas the number of particles at  $T = 2T_c$  is found to be N 5 10 [11]. For the parameters in the JILA experiment [5,6], the minimum value of  $_{s}$  () is  $_{0}$ , since > 1. In this case the condition  $_0$ 1 is equivalent to R<sub>z</sub> 1(0). Therefore, for the JILA experiment, the minimum number of particles required to attain hydrodynam ic conditions is  $1 \quad 10^{\circ}$  at  $T = 13T_{c}$ , which is to be compared with the experim entalvalue N 8 10 at T 1:3 T<sub>c</sub> [6]. Figure 1 shows  $f(;_0)$  as function of N, with all the other param eters equal to the ones of Ref. [6] and  $T = 1:3T_c$ . The lowest value of N is chosen to be N = 1:1  $10^7$ , i.e., the one for which  $_0 = 1$ .

Now we estimate for the MIT and JILA experiments the magnitude of the characteristic lengths  $R_z$  and  $R_2$ , and compare them with the mean free path in the center of the cloud. The transition tem perature is obtained from  $k_B T_c = 0.94 N^{1=3} h (!_0^2 !_z)^{1=3}$ . For the M IT experim ent N 2:5  $10^{\circ} \text{ at } T_{c}$  [11], while  $!_{0}$  2 250 Hz 5.8 10<sup>3</sup> [4]. At T =  $2T_c$  the particle number and is 5 10, resulting in  $R_z$  380 m and  $R_2$ 29 m. The corresponding value of the central density n(0) = $N = ({}^{3=2}R_z R_z^2)$  is 2:9 1 $b^3$  cm <sup>3</sup>. W ith the scattering 1:9 10  $^{12}$  cm  $^2$  (a<sub>scat</sub> 28A) [12], we cross section obtain  $l(0) = [n(0)]^{1}$  180 m, which is less than  $R_{z}$ , but much larger than R<sub>2</sub>. The other condition for hydrodynam ic behaviour is that the frequency of the mode be sm all com pared with an average particle scattering rate. A single particle undergoes collisions at a rate  $n_0$  (r)  $v_{th}$ , where  $v_{th} = (8k_B T = m)^{1=2}$  is the average particle velocity. The average scattering rate in the cloud is thus

For the JILA experiment  $!_0$  2 129 Hz = 8 10 [6]. At and the particle number at  $T_c$  is N 4 8 10, we obtain  $R_z$  $T = 13 T_{c}$ , where N 4 m and R<sub>?</sub> 10 m, while the central density is n (0) 3:7  $10^{13}$  cm  $^{3}$ . The mean free path 1(0) is estimated to be 38 m corresponding to a scattering cross section 7 10<sup>12</sup> cm<sup>2</sup>. Finally the dimensionless parameter ! scat is 19.W e should mention that using Eq. (20) we nd that for N = 1:1 10, the amplitude damping times for the JILA experiment are 8 ms and 47 ms at T = $13 T_c$  for the m odes which correspond to m onopole and quadrupole vibrations in a spherical trap, respectively.

We thus conclude that even though in the M IT experiment  $l(0)^{<} R_{z}$ , there are as yet no experiments with which we can directly compare our calculation of the damping. To obtain a sem i-quantitative description, we adopt a phenomenological interpolation formula for the frequency and the damping rate of the modes. This has the usual form,

characteristic of relaxation processes. Here  $!_{\rm C}$  is the frequency of the mode in the collisionless regime and  $!_{\rm H}$  in the hydrodynam ic regime, and is a characteristic relaxation time, which we anticipate will be of order the scattering time. Equation (21) gives the qualitatively correct limiting behaviour for ! 1 and ! 1. The imaginary part of the above equation gives for the damping rate

The amplitude damping time in the MIT experiment [4] is measured to be  $80 \text{ m} \text{ s at } T = 2 \text{ T}_c$ . The frequency  $_{\rm C} = 2_{\rm z}$  38 H z; Eq. (7) gives for <sub>H</sub> (12=5)<sup>1=2</sup> z 30 Hz. Using these numbers and Eq. (22), we can solve for ! to get the two solutions 3.6 and 3.6  $^1$  0.28. We regard the larger solution as being the physically relevant one, since it is close to our estimate of ! scat 22. The real part of Eq. (21), with ! = 3:6, in plies that the 37:5 Hz, which is consistent oscillation frequency is with the experim ental value of 35 4 Hz. For the JILA experiment [6], the amplitude damping time is 50 m s at T  $13T_c$ . Since c 258 Hz and  $_{\rm H}$ 221 Hz, Eq. (22) implies that ! 10:6 or 10:6<sup>1</sup>. Again we consider the larger value to be the physical one, since it is close to our theoretical estim ate above, ! scat 19. W e thus conclude that dam ping of the modes in clouds of bosons above T<sub>c</sub> is in good agreem ent with theoretical expectations.
