# Cu-Au, Ag-Au, Cu-Ag and Ni-Au intermetallics: First-principles study of phase diagrams and structures

The classic m etallurgical systems { noble m etal alloys { that have formed the benchm ark for various alloy theories, are revisited. First-principles fully relaxed general potential LAPW total energies of a few ordered structures are used as input to a mixed-space cluster expansion calculation to study the phase stability, therm odynam ic properties and bond lengths in Cu-Au, Ag-Au, Cu-Ag and Ni-Au alloys. (i) Our theoretical calculations correctly reproduce the tendencies of Ag-Au and Cu-Au to form compounds and Ni-Au and Cu-Ag to phase separate at T=0 K . (ii) Of all possible structures,  $Cu_3Au$  ( $L1_2$ ) and CuAu ( $L1_0$ ) are found to be the most stable low-tem perature phases of C  $u_{1-x}$  A  $u_{x}$  with transition temperatures of 530 K and 660 K, respectively, compared to the experim ental values 663 K and 670 K. The signi cant im provem ent over previous rst-principles studies is attributed to the m ore accurate treatm ent of atom ic relaxations in the present work. (iii) LAPW form ation enthalpies demonstrate that L12, the commonly assumed stable phase of CuAu3, is not the ground state for Au-rich alloys, but rather that ordered h100i superlattices are stabilized. (iv) We extract the non-con gurational (e.g., vibrational) entropies of formation and obtain large values for the size m ism atched system s:  $0.48~k_B$  /atom in N  $i_{0.5}Au_{0.5}$  (T = 1100~K),  $0.37~k_B$  /atom in  $\text{Cu}_{0:141}\text{Ag}_{0:859}$  (T = 1052 K), and 0.16  $k_{\text{B}}$  /atom in  $\text{Cu}_{0:5}\text{Au}_{0:5}$  (T = 800 K). (v) U sing 8 atom /cell special quasirandom structures we study the bond lengths in disordered Cu-Au and Ni-Au alloys and obtain good qualitative agreem ent with recent EXAFS measurements.

# I. IN TRODUCTION: CHEM ICAL TRENDS IN NOBLE METAL ALLOYS

Noble metal alloys are, experimentally, among the most studied intermetallic systems.  $^{1}$ {24} In addition, the Cu-Au system has been considered the classic paradigm system for applying dierent theoretical techniques of phase diagram and phase stability calculations. $^{25}$   $^{63}$  M ost notably, this system has been considered as the basic test case for the classic Ising-ham iltonian statistical-mechanics treatment of alloys. 25 {32 M ore recently, noble m etalbinary alloys have been treated theoretically via empirical tting of the constants in Ising ham iltonians,  $2^{5}$   $3^{4}$  sem iem pirical interatom ic potentials, 35 {47 and via rst-principles cluster expansions.48 {55 The essential di erence in philosophy between the classical application of Ising models to  $CuAu^{25{30;33}}$  and more modern approaches based on the density functional form alism 64 is that in the form er approach the range and magnitudes of the interactions are postulated at the outset (e.g., rst or second neighbor pair interactions), while the latter approaches make an e ort to determ ine the interactions from an electronic structure theory. However, despite recent attempts, 48 {54 it is still not clear whether the noble metal alloys can be essentially characterized as systems with short-range pair interactions, or not.

Now that rst-principles cluster expansion approaches 65;66 have advanced to the stage where both

T = 0 ground state structures and nite-tem perature therm odynam ic quantities can be predicted without any empirical information, it is interesting to take a global bok at the noble m etal alloy fam ily. Table I sum m arizes som e of the salient features [4;14;15;18;67 69] of the four binary systems Cu-Au, Ag-Au, Cu-Ag and Ni-Au. We  $a_B j = ja_A + a_B j$  between the consituents, 67 the electronegativity di erence = A  $_{\rm B}$  on the Pauling scale, 68 the mixing enthalpy of the equiatom ic alloy, 2;18 the sign of the calculated nearest neighbor pair interaction  $J_2$  (present study), the structural identity of the lowtem perature phases 1 {4;67} and the order-disorder transition (or m iscibility gap) tem peratures<sup>2;69</sup> T<sub>c</sub>. Som e interesting observations and trends which we will attempt to reproduce theoretically, are apparent from this general

(i) D espite a large (12%) size m ism atch in Cu-Au, and a sm all ( 0%) size m ism atch in Ag-Au, both system s form ordered compounds at low temperatures and have negative m ixing enthalpies, suggesting attractive (\antiferrom agnetic") A {B interactions. Thus, when the dierence in the electronegativity of the constituent atom s is su ciently large, as it is in CuAu and AgAu, size m ism atch apparently does not determ ine ordering vs. phase separation tendencies.

(ii) Despite a similar size m is match (12%) in Cu-Au and Cu-Ag, the former orders while the latter phase-separates. Thus, the existence of large electronegativity

di erence in Cu-Au (as opposed to the small di erence in Cu-Ag), seem s to induce ordering tendencies.

(iii) Cu-Ag and Ni-Au both phase-separate (and have positive H  $_{\rm m~ix}$ ) as they have large size m ism atches. Yet, Ni-Au having a large electronegativity di erence, shows an ordering-type nearest-neighbor pair interaction (J<sub>2</sub> > 0), just like the compound forming Cu-Au and Ag-Au, while Cu-Ag has a clustering-type nearest-neighbor interaction (J<sub>2</sub> < 0). Thus, the sign of J<sub>2</sub> does not recet the low temperature ordering vs. phase separation.

(iv) The amount  $S_{XS} = S_{tot}^{expt}$   $S_{ideal}$  by which the measured entropy  $S_{tot}^{expt}$  deviates from the ideal congurational entropy  $S_{ideal} = k_B [x \log x + (1 - x) \log (1 - x)]$ , is unexpectedly large in Cu-Ag and Ni-Au, indicating a large non-congurational entropy of form ation.

O ther interesting facts about the noble metal binary intermetallics include:

(v) D expite num erous studies,  $^{1}{^{4;7;8;10}}{^{12}}$  the structure of the ordered phases in Au-rich Cu-Au is not well established yet. It is often assum ed  $^{1}{^{4}}$  that the stable Au-rich low-tem perature phase is CuAu3 in the L  $^{12}$  structure, but direct experiments  $^{7;8;10}$  below the order-disorder transition temperature  $T_{c}(x=\frac{3}{4})$  500 K are dicult because the di usion rates are very low and even the best ordered samples contain signicant disorder. Possible further thermodynamic transformations at lower temperatures may be kinetically inhibited.

(vi) The trends in bond lengths vs. composition are non-trivial. Traditionally, all coherent-potential-approxim ation based theories  $^{70}$  (72 of interm etallic alloys have assumed that the nearest-neighbor bond lengths are equal,  $R_{A\,A}=R_{A\,B}=R_{B\,B}$ , and proportional to the average lattice constant. Recent theories  $^{73}$  (75 suggested, however, that bond lengths relax in the alloy to new values, and this has a signicant electronic structure.  $^{53}$ ;76;77 Recent EXAFS experiments on NiAu²3

and  $CuAu^{24}$  show distinct  $R_{AA} \notin R_{AB} \notin R_{BB}$  bond lengths, which need to be explained.

In this work we will analyze the above mentioned trends in terms of a rst-principles mixed-space cluster expansion,  $^{65,66}$  based on modern local density approximation (LDA) total energy calculations. We reproduce the observed trends (i)-(vi) in ordering preferences, mixing enthalpies H  $_{\rm mix}$ , transition temperatures T  $_{\rm c}$  and interatom ic bond lengths. In addition, we predict new, hitherto unsuspected ordered phases in Au-rich Cu-Au alloys.

#### II.BASIC IDEOLOGY AND METHODOLOGY

There are many problems in solid state physics that require know ledge of the total energy E ( ) of a lattice with N sites as a function of the occupation pattern of these sites by atoms of types A and B. This information is needed, for example, in the ground state search problem,  $^{72}$  where one seeks the conguration with the lowest energy at T = 0 K.fE ( )g is also needed for calculating the temperature—and composition—dependent therm odynamic functions and phase diagrams of an A $_{1}$   $_{\rm x}$ B $_{\rm x}$  alloy.

A direct, quantum  $\neg m$  echanical calculation of the total energy E  $_{\rm direct}$  ( ) = h jH j i  $\rightarrow$  j i=h j i (where is the electronic ground state wave function and H is the many-electron H am iltonian) is possible only for a  $\rightarrow$  limited set of con gurations . This is so because (i) the computational e ort to solve the Schrodinger equation for a single con guration scales as the cube of the number of atom sper unit cell, so that only small unit cells can be considered, (ii) there are  $\rightarrow$  con gurations, and (iii) for each con guration, one has to not the atom ic relaxations  $\rightarrow$  u<sub>m in</sub> ( ) which minimize the total energy. Consequently, one searches for a \cluster expansion" (CE) that

accurately reproduces the results of a direct, quantum – m echanical (e.g., LDA) calculation

w ithout the unfavorable scaling of the computational cost with the size of the unit cell.

In designing a cluster expansion, there are few choices of independent parameters. For example, one could choose to obtain a cluster expansion for the volume-(V) dependent equation of state  $E_{\rm direct}(\ ;V)$  [see, e.g., Refs. 52, 78, 79], or to nd a cluster expansion for the energy at the volume  $V_{\rm m}$  in ( ) that m in in izes  $E_{\rm direct}(\ ;V)$ . We choose the latter possibility. Furtherm ore, for each con guration , we wish to reproduce the total energy corresponding to the fully relaxed cell shape and atom ic positions f  $u_{\rm m}$  in ( )g. In other words, we choose to represent

Note that by focusing on the equilibrium energy of each con guration, we give up the possibility of studying nonequilibrium geometries (e.g., bond lengths) and equations of state. Instead, for each occupation pattern , we can not the total energy E ( ) of the atom ically relaxed and volume e-optimized geometry.

The best-known cluster expansion is the generalized Ising model in which the equilibrium total energy of an arbitrary con guration is expanded in a series of basis functions de ned as pseudospin products on the crystal sites:

where in binary  $A_{1}$   $_{x}B_{x}$  alloys  $S_{i}=+1$  or 1, depending on whether the site i is occupied by an atom of type A or B . Equation (3) is valid whether the lattice is relaxed ot not, as long as a one-to-one correspondence exists between the actual positions of atoms and the ideal fcc sites. The practical usefulness of the cluster expansion Eq. (3) rests on the assumption that the elective cluster interactions (EC I's),  $J_{ij}$ ;  $J_{ijk}$ ; :::; are rapidly decreasing functions of the number of sites and intersite separation, so that only a nite number of terms has to be kept in Eq. (3) for the desired accuracy. In this case, we can write the form ation enthalpy of structure

where  $E_{\,A}\,$  and  $E_{\,B}\,$  are total energies of the pure constituents A and B , as the following cluster expansion (CE):

Here N  $_{\rm f}$  is the number of nonzero elective interactions and  $^-_{\rm f}$  ( ) are lattice averages of the spin products in conguration .

Sanchez, Ducastelle and Gratias have shown that there is a set of composition-independent interactions for Eq. (3) which can exactly reproduce the directly calculated total energies of all con gurations . This statement is strictly true if all possible clusters are included in Eq. (3), and should hold for the truncated series Eq. (3) if the cluster expansion is well converged. Several methods  $^{81;82}$  yield concentration-dependent effective interactions, providing in principle equally valid schemes for representing H  $_{\rm direct}$ ( ) in terms of a cluster expansion. In the present work, we select composition-independent interactions, since these can be directly compared to previous Ising model treatments  $^{25 \left\{34;48 \right\}}$  of the noble metal alloy phase diagrams.

A number of issues arise in trying to construct a cluster expansion that satis es Eq.(2):

(i) The number of interactions and their types (pair, multibody) cannot be decided arbitrarily, but must be constrained by a microscopic electronic-structure theory according to Eqs. (1) and (2).

(ii) In most con gurations , atom s move away from the ideal lattice sites, which not only lowers the total energies  $E_{\rm direct}$  ( ), but also slows down the convergence of the expansion Eq. (3). The solution is to have a cluster expansion with many interaction term s N  $_{\rm J}$  that can represent such situations. We accomplish this by using a reciprocal space form ulation, form ally equivalent to an in nite number of real-space pair interactions.

(iii) Some cluster expansions  $^{78}$  require that the number of interactions N  $_{\rm J}$  must equal the number of congurations N whose total energies need to be evaluated via the direct electronic-structure method. The number of such calculations may be excessive in view of (ii). We thus introduce a method in which N  $_{\rm J}$ . Furthermore, interactions that are not needed to satisfy Eq. (2) are automatically discarded.

(iv) 0 ne has to deal w ith the m acroscopic elastic strain leading to a k! 0 singularity in the Fourier transform of the pair interactions,

where D  $_{\rm j}$  is the number of fR  $_{\rm i}$ ; R  $_{\rm j}$ g pairs per lattice site. As shown by Laks et al.  $^{65}$  (see also the discussion below), in size m ism atched systems the correct  $J_{\rm pair}(k)$  depends on direction  $\hat{k}$  in the long-wavelength limit k! 0. To solve this, we express  $J_{\rm pair}(k)$  as a sum of two parts,

where  $J_{SR}$  (k) is an analytic function of k and can be obtained from short-ranged real space pair interactions, while  $J_{CS}$  (k) contains the nonanalytic behavior around

k=0 and depends only on the direction  $\hat{k}$ . To explain this singularity, we consider the energy of a coherent  $A_nB_n$  superlattice, formed by a periodic stacking of n layers of A and n layers of B in direction  $\hat{\Phi}$ . By introducing the structure factor,

the total pair interaction energy in Eq. (3) can be expressed as a reciprocal space sum:

A<sub>n</sub>B<sub>n</sub> superlattice has nonzero structure factor at  $k = \frac{1}{2n} \dot{\Theta}$ , and therefore its energy is determined by  $J_{\text{pair}}(\frac{1}{2n} \mathring{\mathfrak{G}})$  . As n ! 1 its form ation energy is given by a sum of the epitaxial deformation energies of pure constituents needed to bring them to a common lattice constant in the plane perpendicular to 🗗 . Since the epitaxial deform ation energy of pure constituents is direction dependent (e.g., it is easier to stretch Cu in [100] planes than in [111] planes, see Sec. IIIB), the form ation energy H ( $A_1 B_1$ ) is also direction dependent. Therefore,  $\lim_{k \to 0} J_{pair}(k)$  must depend on the direction of approach to the origin, proving that Jpair (k) is singular. Physically, the nonanaliticity of Jpair (k) is caused by long-range interactions via m acroscopic elastic strain and cannot be reproduced using nite-ranged real-space pair interactions, but must be accounted for explicitly in reciprocal space. If the singularity is neglected, then as explained in Ref. 65, the cluster expansion fails not only for long-period (n ! 1 ) superlattices A<sub>n</sub>B<sub>n</sub>, but also for those short-period (n > 2) superlattices which have not been explicitly included in the constraint Eq. (2). We em phasize that although the contribution of  $J_{sing}$  (k) to the form ation energy is nonzero only in size-m ism atched system s, it is not related to the atom ic relaxation energy for a particular structure in any simple way (except if itself is a long-period superlattice).

The singularity in  $J_{\text{pair}}(k)$  is similar to the singularity in the dynam ical matrix D  $(^{0}k)$  of polar crystals in the long-wavelength limit,  $^{83}$  caused by long-range electrostatic interactions via macroscopic electric eld. In lattice dynamics, D  $(^{0}k)$  is expressed as a sum of regular and singular parts, D  $(^{0}k) = D^{\sin g}(^{0}k) + D^{reg}(^{0}k)$ , where D  $^{reg}(^{0}k)$  (analytic as k : 0) is due to short-range force constants. The singular part D  $^{\sin g}(^{0}k)$  gives rise to LO/TO splitting of the zone-center optical frequencies ! in polar crystals, and also leads to a directional dependence of ! (k) in uniaxial crystals (e.g., CuPt-type GaInP2). These phenomena cannot be reproduced by any set of nite-ranged microscopic force constants, but have to be calculated explicitly using the macroscopic Maxwell equations.

In summary, we seek to nd a function  $E_{\,C\,E}\,$  ( ) which accurately reproduces the LDA total energies

 $E_{\,\mathrm{LDA}}$  [ ;  $\, u_{m}$  in ( );  $V_{m}$  in ( )]  $E_{\,\mathrm{LDA}}$  ( ) at the atom ically relaxed geometry and equilibrium volume of conguration . The function  $E_{\,\mathrm{CE}}$  ( ) we consider includes composition—and volume—independent interactions, so as to maintain maximum similarity with the classical Ising model. The number and type of interactions are not decided arbitrarily, but are constrained by the electronic structure theory used (here, the LDA). Relaxation is treated accurately by including long—range pair interactions in the reciprocal space representation. The k! 0 singularity, a ecting both short and long-period superlattices, is dealt with explicitly.

The above requirements are satisfied by the mixed space cluster expansion (MSCE):

We have separated out the so-called equilibrium constituent strain energy term, E  $_{\text{CS}}($  ), which accounts for the k! O singularity.  $^{65}$  In Eq. (10) we do not need to calculate E  $_{\text{CS}}($  ) for each con guration , but only for the directions  $^{1\!\!R}$  of the wave vectors with nonzero S (k; ). In fact, it is constructed to coincide with the elastic strain energy of coherent superlattices in the long-period lim it:  $^{65}$

where S (k; ) is the structure factor from Eq. (8). The quantity E  $_{CS}^{eq}(x;k)$  depends only on the direction k, and will be given in Sec. IIIB. Equation (11) is exact for long-period superlattices, but represents a choice for short-period superlattices and non-superlattice (e.g., L  $1_2$ ) structures. It has been found  $^{65}$  that the choice Eq. (11) in proves the cluster expansion predictions also for short-period superlattices.

Equation (10) is a generalized Ising model description of the form ation energy of any relaxed con guration , even if a direct LDA calculation for this is impractical. The cluster interaction energies  $fJ_{\rm pair}(k)g$  and  $fJ_fg$  are obtained by tting Eq. (10) to the LDA form ation energies. An additional smoothness requirement is imposed on  $J_{\rm pair}(k)$ , which ensures that the pair interactions are optimally short-ranged in real space. Namely, we minimize the sum

where and tare free parameters and is a normalization constant. Typically we choose = 4 and t = 1, but the t is not sensitive to this choice.

This approach solves the four problems indicated above in the sense that (i) the tting process itself automatically selects the pair interactions that are essential to obtain a good t (process still does not select multibody gures), (ii) the pair interactions can be of arbitrary long range, facilitating treatm ent of system swith large elastic relaxations, (iii) the number of pairs can be much larger than the number of ordered structures in the t, and (iv) the directly calculated constituent strain energy E CS contains the k! O singularity. Unlike all CPA-based m ethods,  $^{70;71}$  the present approach includes full account of atom ic relaxation and local environm ent e ects. Unlike the classical Ising descriptions,  $^{25;27\,\{33\}}$  the interaction energies are determined by the electronic structure rather than being guessed. Finally, unlike the computational alchemy linear response approach, 85 multibody term s are included here.

Having written the expression for the total energy of arbitrary con guration, Eq. (10), we can evaluate its constants from a limited number of LDA calculations on small unit cell (N  $_{\rm atom\ s}$  < 10) ordered structures with fully relaxed atom ic positions. Equation (10) can then be employed in simulated annealing and M onte Carlo calculations  $^{86;87}$  yielding T = 0 ground states and T > 0 statistical and therm odynam ic properties. Further details of the method are given in Sec. III.

III. DETAILS OF THE METHOD

#### $A \cdot T = 0$ energetics

The calculations of T = 0 total energies employ the full-potential linearized augm ented plane wave method88 (FLAPW). The basis set consists of plane waves in the interstitial region, augmented in a continuous and dierentiable way with the solutions of the radial Schrodinger equation inside the non-overlapping mu n-tin spheres. Non-spherical potential and electronic charge density terms are calculated in all space and included in the Ham iltonian matrix. Core states are treated fully relativistically and recalculated in each self-consistency iteration. The wave equation for the valence states includes all relativistic e ects except the spin-orbit interaction, i.e., they are treated scalar relativistically. FLAPW is the most accurate all-electron method, superior to the m ethods em ploying overlapping atom ic spheres (atom icspheres approximation (ASA) and/or shape approximations to the potential.

W e use the W igner exchange-correlation functional. As a check, we have perform ed several calculations using the Perdew-Zunger parametrization of the Ceperley-Alder functional and the generalized gradient approximation of Perdew and Wang. We not (see Sec. IV A 1) that the various exchange-correlation functionals change the enthalpies of form ation of ordered Cu-Au compounds by a negligible amount (less than 2 meV/atom).

The total energies of the ordered structures and endpoint constituents are obtained keeping all computational param eters exactly equal. Specically, we always use the same basis sets (RK  $_{m\ ax}$  = 9), charge density cuto s ( $RK_{max} = 19$ ), mu n-tin radii  $R_{Au} = 2.4a_0$ ,  $R_{Aq} = R_{Cu} = R_{Ni} = 22a_0$ , maximum dierence in the angularm om enta in the nonspherical Ham iltonian term s  $(l_{max} = 4)$ , maximum angularmom enta in the nonspherical charge densities and potentials inside the mu n-tin spheres  $(l_{max} = 8)$ , and equivalent k point sets<sup>93</sup> in the evaluation of Brillouin zone integrals. When the unit cell vectors of the ordered compound permit, we choose a k mesh equivalent to the 60 special points 8 mesh. Several structures (e.g., those of A2B or AB2 stoichiom etry) have reciprocal unit cell vectors which are incommensurate with the 8 8 8 m esh. In these cases we calculate the total energies of the com pounds and foc constituents with a nerk point grid. This procedure ensures that, due to systematic cancellation of errors, the form ation enthalpies H ( ), Eq. (4), converge m uch faster than the total energies. Indeed, the tests for Cu-Au described in Sec. IV A 1 show that with our choice of param eters H ( ) are converged to within 2 m eV /atom.


The atom ic positions are relaxed using quantum mechanical forces obtained at the end of the self-consistency iterations. Minimization of the total energy with respect to the cell-external degrees of freedom is done by distorting the shape of the unit cell and tracing the decrease in the total energy. We estimate that the formation enthalpies are converged to at least 5 meV/atom with respect to all relaxational degrees of freedom.

Table II and its caption de nes our small-unit-cell ordered structures. Many are actually superlattices along (100), (110), (111), (201) and (311) directions. Table III gives the calculated LDA form ation energies Eq. (4)] for these Au-Ag, Cu-Au, Cu-Ag and Ni-Au compounds.

# B . The constituent strain energy

It is well known<sup>66</sup> that real-space cluster expansions with nite-ranged interactions incorrectly predict zero form ation enthalpies per atom for coherent long-period  $A_pB_q$  superlattices, while the correct answers are nonzero and depend on the superlattice direction  $\Theta$ . The constituent strain energy term  $E_{CS}($ ) in Eq. (10) is speci cally designed to reproduce these superlattice energies, which are calculated directly from the LDA as follows.

In the long-period limit pq! 1 the interfacial energy becomes negligibly small (O (1=p)) in comparison with the elastic strain energy needed to deform the constituents to a common in-plane lattice constant  $a_s$ . <sup>55;96</sup> Therefore, the formation energy per atom of  $A_1$   $B_1$  superlattice along  $\Phi$  with composition x is given by the constituent strain energy  $E_{CS}(x;\Phi)$ , defined as the equilibrium (eq) value of the composition-weighted sum of the

energies required to deform bulk A and B to the epitaxial geom etry with a planar lattice constant  $a_s$ :

Here  $E^{epi}(a_s; ^{\textcircled{e}})$  is the strain energy of the material epitaxially stretched to the lattice constant  $a_s$  in the direction orthogonal to  $\overset{\textcircled{e}}{\bullet}$ , and then allowed to relax along  $\overset{\textcircled{e}}{\bullet}$ .  $E^{epi}(a_s; \overset{\textcircled{e}}{\bullet})$  is related to the bulk equation of state  $E^{bulk}(a_s)$  via the epitaxial softening function  $q(a_s; \overset{\textcircled{e}}{\bullet})$ :

where E  $_{\rm A}^{\rm bulk}$  ( $a_{\rm s}$ ) is the energy required to hydrostatically deform a bulk solid to the lattice constant  $a_{\rm s}$ . Figure 1 illustrates the concept of epitaxial softening:  $^{97}$  when the bulk solid is deformed hydrostatically from  $a_{\rm eq}$  to  $a_{\rm s}$   $\oplus$   $a_{\rm eq}$ , its energy rises. Energy can then be lowered if we keep  $a_{\rm x}=a_{\rm y}=a_{\rm s}$  but relax the third lattice vector to its equilibrium value.  $q(a_{\rm s}; \Theta)$  measures the relative energy lowering.




FIG.2.  $q(\Phi)$  of fcc Cu for principle directions as functions of the substrate lattice parameter  $a_s$ . Directly calculated LDA values are represented by open symbols, lines show the tusing the expansion of  $(\Phi)$  in Kubic harmonics.

Figure 2 shows the calculated LDA q's for Cu, obtained by m in in izing the total energy with respect to the lattice constant c parallel to  $\ref{P}$  for each value of the substrate lattice parameter  $a_s$ . As explained in Ref. 96, this treatment neglects the so-called shear strain terms, but is exact for the high symmetry directions (100), (111) and (110). The calculated  $q_{cu}$  ( $a_s$ ;  $\ref{P}$ ) is seen to be a nontrivial function of the substrate lattice parameter  $a_s$  and direction  $\ref{P}$ . In contrast, the harm onic elasticity theory,  $q_s$ ?  $q_s$

routinely used for sem iconductor system  $s_r^{97;100;101}$  gives q's which do not depend on  $a_s$ :

and K  $_{1}$  are the K ubic harm onics of angular m om entum 1. Figure 2 shows that the harm onic approximation manifestly breaks down for large epitaxial strains in metals since there are several in portant qualitative di erences between the behavior in Fig. 2 and that predicted by the harm onic elasticity. First, q(as; 9) strongly depends on the substrate lattice constant, while the harm onic q<sub>nam</sub> (\$) does not. Second, the harm onic expression gives a de nite order of q(b) as a function of the direction, i.e., either (100) is the softest and then (111) m ust be the hardest, or vice versa. This order does not hold for large deform ations. For instance, (201) becomes the softest direction for as  $a_0$  and (110) is the hardest a<sub>0</sub> in Cu. Finally, q(100) exhibits a particularly dram atic softening for as a<sub>0</sub>, which has important consequences for the constituent strain energy and stability of superlattices along this direction.96

The above mentioned properties of  $q_{\rm cu}$  can be described by generalizing Eq. (17) for to higher Kubic harmonics and strain-dependent expansion coecients:

which has the property that in the harmonic limit  $(a_s \ ! \ a_0)$  all expansion coe cients with angular momenta higher than 4 tend to zero, reproducing  $_{harm}$  from Eq. (17). Due to the cubic symmetry, only terms with 1=0;4;6;8;10;12;:::enter in this expansion. Detailed discussion of the nonlinear epitaxial strain properties of elementalm etals will be given in a separate publication.  $^{96}$




FIG . 3. Equilibrium constituent strain energies for Cu-Au, N iAu and Cu-Ag. The constituent strain energy of Ag-Au is negligibly small and therefore not shown.

The constituent strain energy  $E_{CS}^{eq}(x; \Phi)$  is calculated num erically from Eq. (14) using the direct LDA values of E  $^{\rm epi}(a_{\rm s}; \mbox{$^{\circ}$})$  for six principle directions. The obtained E  $_{\text{CS}}^{\text{eq}}$  for these directions are shown in Fig. 3, illustrating several properties of the constituent strain which cannot be reproduced by the harm onic theory. 65 First, the curves in Fig. 3 are skewed to dierent sides, while the harm onic E  $_{\text{CS}}^{\text{eq}}$  must be all skewed to the same side. Second, the calculated E  $_{\text{CS}}^{\text{eq}}$  cross for dierent directions, a property not allowed by the harm onic functional form. These crossings lead to (201) as the softest direction below x 02, and (110) as the hardest for Au-rich superlattices, while the harm onic theory gives E  $_{\text{CS}}^{\text{eq}}$  (111) as the highest and E  $_{\text{CS}}^{\text{eq}}$  (100) as the lowest constituent strain for all compositions of the studied noble m etalalbys. The behavior of E  $_{\text{CS}}^{\text{eq}}$  for (100) is particularly interesting, since the curves in Fig. 3 abruptly 0:15 and have very low values change slope around x for  $x > \frac{1}{4}$ . As we show in Ref. 96, this is a manifestation of the low energy cost of deforming foc Cu into the bodycentered tetragonal structure along the epitaxial Baines path. Sm all constituent strain of (100) superlattices has profound in uence on the predicted ground states of Cu-Au (see Sec. IV A 1).

The constituent strain energy for arbitrary direction is then obtained by interpolating between the principle directions using the following expansion in Kubic harmonics:

We have taken  $l_{max}=10$ , which gives ve composition-dependent thing coe cients determined from a t to the directly calculated values Eq. (14)] for six principle directions. The characteristic errors of this t at the equiatom ic composition are 1 2 m eV /atom. Equation (19) is then used in Eqs. (11) { (12).

#### C.Constructing the Cluster Expansion

Once we have a closed-form expression for the equilibrium constituent strain energy E  $_{CS}$  () and a set f H  $^{\rm LD\,A}$  ()g of T = 0 form ation enthalpies, we determine the unknown cluster interactions of Eq. (10) in the following two-step process:


First, the total energies of all structures from Table III are used in the t to investigate the behavior of the rootm ean-square (mm s) error  $_{\text{rm s}}$  of the t, Eq. (13), as a function of the number of real-space pair and multibody interactions. Reciprocal space CE allows to add pair interactions system atically in the order of increasing intersite separation, up to any number of near-neighbor shells. The k-space smoothness criterion in Eq. (13) autom atically selects optim ally short-ranged interactions and chooses physically important pair interactions which are essential to produce a good t to the directly calculated LDA energies. The dependence of the ms error on the number of pair and multibody interactions is shown in Fig. 4. Figure 4(a) is obtained by xing the number of multibody interactions, and varying the number of pair interactions. It shows that in all systems the cluster expansion is well converged using 10 to 20 pair interactions. The convergence rate is fastest for A g-A u and slowest for Ni-Au, which we attribute to increasing size mismatch going from Ag-Au to Ni-Au, with Cu-Ag and Cu-Au exhibiting intermediate convergence rates.

Selection of important multibody interactions is more delicate. The number of pair interactions is xed to a converged value (20 or m ore), and a large set of 3-to 4body gures is tested as to whether it improves the mms error of the overall t. It is retained in the CE only if  $_{
m m~s}$  decreases considerably. During the tting process, we also m on itor the overall stability of the CE, as measured by a change in other multibody interactions upon the addition of a particular gure. Unstable behavior usually signals of linear dependencies in the chosen set of clusters and an ill-conditioned inverse problem, necessitating a dierent choice of  $fJ_fg$ . Figure 4(b) shows the convergence of the CE with respect to the number of multibody interactions, keeping N  $_{\mbox{\scriptsize pairs}}$  equal to their converged values. An important thing to notice is that the multibody interactions produce a decrease in the rms error which is of the same magnitude as that due to the pair interactions. Furtherm ore, the e ect of multibody interactions is largest in Ni-Au, and decreases in order of decreasing size m ism atch, becom ing negligible in Ag-Au.

In the second step we test the stability of the t and its predictive power. Using the trial set of gures obtained in the previous step, we exclude several structures which are trather well (e.g.,  $\mathbb{Z}$ 2, 2, and  $\mathbb{L}$ 1<sub>2</sub> in N i-A u), and repeat the t, obtaining new values of the e ective cluster interactions. These values are used to predict the total energies of the structures excluded from the t. If the change in H CE ( ) is not acceptable (more than few meV/atom), we return to the rst step to search for a better set of interactions. The most severe test is to exclude structures with the poorest to their form ation enthalpies, e.g.,  $SQS14_a$  and  $SQS14_b$  in Ni-Au. If the predicted form ation energy does not change signi cantly, the chosen set of gures is considered to be stable and predictive. The nal cluster expansion is produced by using this set of gures and all structures from Table III.

Figure 5 shows the calculated pair interactions as func-

# **Convergence of Cluster Expansion**






FIG. 4. Root-mean-square errors ms of the cluster expansions for Ag-Au, Cu-Ag, Cu-Au and Ni-Au as functions of the num ber of pair and multibody interactions.

tion of the near-neighbor foc shell. There are several noteworthy trends in the four alloy system s:

(i) Only in Ag-Au and Cu-Au are the nearest-neighbor pair interactions dom inant: in Cu-Ag the 1-st and 3-rd neighborpair interactions are of similar magnitude, while the 3-rd neighbor interaction dom inates in Ni-Au.

(ii) The dominant interactions have signs consistent with the observed phase diagrams: Ag-Au and Cu-A u have positive (\antiferrom agnetic") nearest-neighbor pair interactions  $J_2$ , corresponding to the tendency towards complete miscibility and ordering at low temperatures. The behavior of Ni-Au, in spite of positive 1-st and 2-nd neighbor pair interactions, is dom inated by the \ferrom agnetic" 3-rd neighbor interaction L2 (which causes phase separation at low temperatures). Both dominant 1-st and 3-rd neighbor pair interactions in Cu-Ag are negative, implying a miscibility gap. The constituent strain energy  $E_{CS}^{eq}$  is always positive and therefore increases the propensity for incoherent phase separation.

(iii) A Ithough the nearest-neighbor pair interaction is clearly dom inant in Cu-Au, other pair interactions show a long-ranged oscillatory behavior extending over approxim ately 15 shells. As found in other system s,65,85 this is a direct consequence of the atom ic relaxation caused by the constituent size m ism atch between Cu and Au. The pair interactions are slowly decaying in Cu-Ag and NiAu, too.


The calculated multibody interaction energies are shown in Figure 6.  $J_1$  is the point interaction,  $J_3$ ,  $K_3$ ,  $N_3$ , ..., are triplets and  $J_4$ ,  $K_4$ , and  $L_4$  are four-point clusters in increasing order of interatom ic separation (see Lu et al. 54 for a full description of the clusters). Figure 6 illustrates the importance of the multibody terms in our Ham iltonian.


## D.F inding the T = 0 ground states and T > 0properties


Having parametrized the con gurational energies in terms of the mixed-space cluster expansion Eq. (10), we can use it with established statistical methods to predict various structural properties: T = 0 ground states, order-disorder transition temperatures, con gurational entropies, free energies, phase stabilities and atom ic short-range order param eters. Due to the presence of both reciprocal and real space term s in the H am iltonian (10), traditional techniques, e.g., the Cluster Variation M ethod, are not readily applicable. M onte Carlo simulations must be used instead to calculate statistical properties at nite temperatures. The basic computational algorithm is as follows. We adopt the Metropolis algorithm in the canonical ensemble (xed composition). For each attempted spin ip, the change in the multiplet interaction energy is evaluated in the real space. To obtain the reciprocal space energy (constituent strain and pair interaction energies), the Fourier transform of the spin function S (R i; ) is needed. It can be calculated eitherwith the help of the Fast Fourier Transform (FFT) or evaluated directly taking advantage of the specialm ethod described in Ref. 87, which is much more economical: if the total number of sites in the sim ulation box is N , a full **EFT** has to be done only once after approxim ately every N accepted spin ips, which makes the whole compu-

tationale ort for this special method scale as N 1:5.

A simulation box of N = 4096 atom s (16) used to calculate all therm odynam ic properties presented in this paper. The transition temperatures are computed by cooling the system from high tem peratures and monitoring the discontinuities in the average energy and peaks in heat capacity. To elim inate possible hysteresis e ects, the resulting low-tem perature con gurations are gradually heated up past the transition point. The former

process provides the lower bound on the transition temperature,  $T_1$ , while the latter gives the upper bound,  $T_2$ . The heating and cooling rates are such that  $T_1$  and  $T_2$  dier by no more than 20K, an insignicant uncertainty compared to the inaccuracies of the LDA calculations and the terrors of the cluster expansion. 1000 ips/site and a temperature decrease of 2% for each Monte Carlo step are usually su cient, although in a few cases the results are checked using 2000 ips/site and 0:5% temperature change.

Zero tem perature ground states are found by cooling the system to T=0 and checking whether the energy of the nal con guration lies on the convex hull. This process is repeated for several random number seeds and starting tem peratures, always yielding con gurations with similar (usually identical) energies. We explore many equally spaced compositions with an interval x=0.95. The number of possible con gurations for each x is  $N_{conf}=\frac{N!}{(xN)!(N-(1-x))!}$ .

C on gurational entropy of the disordered alloys at -nite T is computed from the energy vs. temperature curves obtained by cooling the system from very high (T = 1 ") temperatures. The following them odynamic formula gives the congurational entropy at temperature T:

where =  $1=k_B$  T and S  $_{ideal}$  =  $k_B$  [x  $\log x$  + (1 x)  $\log (1 - x)$ ] is the con-gurational entropy of an ideal solid solution.

#### IV . R E SU LT S

#### A.T = 0 G round States

#### 1. Ground states of Cu-Au




FIG.7. T = 0 K ground state lines for Cu-Au and Ag-Au obtained from simulated annealing calculations. L1 $_2$  CuAu $_3$  is not only above the ground state line, but also has a higher form ation enthalpy than other structures at the same composition, e.g. LDA calculations place the form ation enthalpy of Z 3 below that of L1 $_2$ . Plots for Cu-Ag and Ni-Au are not shown since these systems phase separate at T = 0 K.

Figure 7 shows the calculated T = 0 ground state lines of Cu-Au and Aq-Auwhichwere obtained from simulated annealing quenches of a 16 16 system . In Cu-Au, we nd the L12 (Cu3Au) and L10 (CuAu) structures as the stable ground states of Cu-rich alloys, in agreem ent with the existing phase diagram data.  $^{1}$  {4 These data also list  $L1_2$  as the stable low-tem perature phase of  $CuAu_3$ . However, we nd new, previously unsuspected ground states of Au-rich compounds, all belonging to the fam ily of (001) superlattices. At  $x = \frac{2}{3}$  we not a stable 2 (CuAu<sub>2</sub>) phase (prototypeM oSi<sub>2</sub>), which is a Cu<sub>1</sub>Au<sub>2</sub> superlattice along (001). At  $x = \frac{3}{4}$ , our cluster expansion predicts that a complex  $Cu_1Au_4Cu_1Au_4Cu_1Au_2Cu_1Au_2$ (001) superlattice falls on the convex hull, although its energy is less than 2 meV below the tieline connecting 2 (CuAu<sub>2</sub>) and Au. Furtherm ore, even the directly

calculated LDA enthalpy of formation of Z3 (which is a  $Cu_1Au_3$  (001) superlattice) is considerably lower than that of L $1_2$  CuA $u_3$ .

We carefully checked whether the predicted new LDA ground states for Au-rich Cu-Au alloys artifacts of some approximation in our LDA calculations or the terror of the cluster expansion. The latter possibility was quickly dismissed, since the directly calculated LDA enthalpies of formation for L10, 2, L12 and Z3 agreed with the values derived from the cluster expansion to better than 2 meV/atom (see Table III), while the new (100) SL ground state is 14 meV/atom below L12. To address the former possibility, we performed careful convergence tests for L10, 2, L12 and Z3 with respect to the plane wave cuto and number of k points in the rst Brillouin zone. The cuto was increased from RK max = 9 to RK max = 11 and the density of the Brillouin zone

mesh was doubled from 8 8 8 to 16 16, an eightfold increase in the total number of k points. These tests showed that the formation enthalpies of  $L1_0$ , 2 and L12 were converged to within 1 meV/atom with respect to the size of the basis set and the number of k points. Further, we checked how the choice of mu ntin radii a ected H . Varying R  $_{\text{M T}}$  (Au) between 2:3a $_{0}$ and 2:5a<sub>0</sub> changed the form ation enthalpies by at most 2 m eV /atom and did not shift the relative stabilities of phases. Finally, we repeated these calculations using the Perdew-Zunger90 parametrization of the Ceperley-Alder LDA functional, as well as the generalized gradient approximation (GGA) of Perdew and Wang,92 and found insignicant (about 2 meV/atom) changes in the form ation enthalpies. Inclusion of the spin-orbit interaction in the second variation procedure 104 changed the form ation enthalpy of  $L1_0$  (CuAu) by only 3:7 m eV /atom 51:9), indicating that it is not im -482 to portant for the energetics of Cu-Au. This conclusion is in line with the ndings of Ref. 105 that the spinorbit interaction in uences the band structure but has little e ect on equilibrium lattice properties. Therefore, we conclude that state-of-the-art rst-principles density functional calculations do not predict  $L1_2$  to be a stable T = 0 ground state of  $CuAu_3$ . It is possible that van der W aals interactions, om itted by the LDA and im portant for large, polarizable atom s such as Au, can a ect the formation energies and hence the ground states of Cu-Au.

W e next analyze the possibility that the correct T =0 ground state around  $x = \frac{3}{4}$  is not L1<sub>2</sub> as has been assumed in the literature before. Although most com pilations 14 of binary alloy phase diagram s give L 12 as the stable structure of  $CuAu_3$ , the experimental evidence $^{7;8;10}$  seems inconclusive because of the diculties in obtaining equilibrated long-range ordered sam ples. X-ray studies<sup>8</sup> have found superlattice peaks consistent with the cubic  $L1_2$  structure, but only very broad loworder re ections have been observed. These superlattice lines could not be sharpened by any heat treatment.8 It is not clear to us if the X-ray re ections can be reindexed according to some other non-L12 phase. It is also possible that at elevated (T 500 K) tem peratures L 12 is stabilized by the entropy (con gurational and vibrational), while another transform ation to the low-energy structure should occur but is kinetically inhibited below 500 K. The biggest experimental obstacles to verifying our predictions seem to be low di usion rates below the ordering tem perature of  $CuAu_3$ ,  $T_c$ 500 K.

Next we discuss the experimental signatures of the new LDA ground state structures. MoSi $_2$ -type 2 CuAu $_2$  has a superlattice rejection at  $(\frac{2}{3}00)$ , but CuAu $_3$  (100) superlattice has rejections at (100) and  $(\frac{1}{3}00)$ . These rejections also manifest them selves in the predicted atom is short-range order of the disordered alloys (for details see Ref. 103).

### 2. G round states of Ag-Au, Cu-Ag and Ni-Au

The ground state line of A g-A u is shown in F igure 7 (b), exhibiting L  $1_2$  (A  $g_3$ Au), L  $1_0$  (A gAu) and L  $1_2$  (A gAu $_3$ ) stable low-tem perature phases. Experim entally, these alloys are known to be completely miscible,  $^2$ 4 and there are several indications  $^6$ 9 that they would order below 200 K if not for the very low di usion rates. Theoretical transition temperatures and short-range order patterns, as well as a complete discussion are given by Lu and Zunger.  $^{54}$ 

The calculated ground states of Cu-Ag and N i-Au are found to be phase separation, in agreement with the experimental enthalpy data. Neither alloy has a single ordered or disordered structure with negative enthalpy of formation and therefore there are no stable T=0 ground states except the phase-separated alloy.

#### B.M ixing enthalpies

It is interesting to compare the calculated mixing enthalpies of disordered Cu-Au alloys with the available theoretical and experimental data. Table IV summarizes the values of H  $_{\rm mix}$  (x;T) for the completely random (T = 1), short-range ordered (T = 800 K) and completely ordered (T = 0 K) Cu-Au alloys at compositions x =  $\frac{1}{4}$ ,  $\frac{1}{2}$  and  $\frac{3}{4}$ . Several important points are apparent from this table:

(i) Studies  $^{50;48;62}$  which have completely neglected atom ic relaxations predict a substantially positive enthalpy of formation for the completely random alloy. In our calculations, relaxations in the random alloy reduce H  $_{\rm m~ix}$  (T = 1 ) by a large amount, bringing it down to essentially zero.

(ii) C om parison of the present results for the T = 1 random alloys with those of W ei et al.  $^{51}$  shows the inuence of the number of structures included in the cluster expansion. Since W ei et al. used the same FLAPW m ethod  $^{88}$ , but included a set of only ve high-sym m etry ordered structures [A1 (Cu), L12 (Cu3Au), L10 (CuAu), L12 (CuAu3) and A1 (Au)], the atom ic relaxation e ects were included incompletely. Indeed, their treatment gives much larger mixing enthalpies of the random Cu-Au alloys than the present work employing approximately 30 low-sym metry structures with large relaxations. Therefore we conclude that the Connolly-Williams set of veordered structures cannot correctly capture the large decrease of the mixing enthalpy of random Cu-Au alloys caused by the atom ic relaxations.

(iii) The good agreement between the relaxed (this study) and \unrelaxed" (W ei et al.  $^{51}$ ) values of H  $_{\rm m~ix}$  at T = 800 K suggests that the short-range order in Cu-Au tends to decrease the role of the atom ic relaxations. This e ect can be qualitatively explained on the basis of the ordering tendency towards high-symmetry structures

which have little or no relaxation energy (L1 $_2$  and L1 $_0$  in Cu-rich alloys).

(iv) The mixing enthalpies of the random alloy calculated by W einberger et al.  $^{58}$  using the coherent-potential approximation (CPA) dier strongly not only from those obtained using the cluster expansion methods,  $^{51}$ ;  $^{50}$ ;  $^{48}$  but also from the numbers given in the CPA work of Ruban, Abrikosov, and Skriver.  $^{62}$  Since the CPA of Weinberger et al.  $^{58}$  neglects the (a) atom is relaxation, (b) charge transfer and (c) short-range order, which all lower the form ation energies, the negative values obtained by Weinberger et al.  $^{58}$  are very puzzling.

(v) There are signicant discrepancies between the best calculated and experimentally measured 15;14;2 values of H  $_{m ix}$  at both T = 0 K and T = 800 K.At present these discrepancies are hard to explain since the available general potential LDA calculations<sup>51;52;57</sup> of H (L1<sub>2</sub>) and H ( $L1_0$ ) agree with each other reasonably well. On the other hand, form ation energies in Cu-Au are num erically very small and present a severe test for any rstprinciples model of electronic exchange-correlation. It is noteworthy that several less accurate rst-principles calculations, using the atom ic-sphere approximation (ASA), have achieved better agreement with the experimental enthalpies of formation than the state of the art general potential techniques. We consider this to be fortuitous. In all cases, LDA calculations correctly predict the relative m agnitudes of H for L1  $_2$  and L1 $_0$ , as well as reproduce m easured asymmetry in formation enthalpies towards more negative values of H  $_{\rm mix}$  for Cu-rich alloys.

#### C.Order-disorder transition temperatures

Order-disorder transitions have been investigated at com positions (x =  $\frac{1}{4}$ ,  $\frac{1}{2}$ ,  $\frac{2}{3}$  and  $\frac{3}{4}$ ) using the M onte C arlo simulation technique described in Sec. IIID. The resulting transition temperatures, Tc, are given in Table V. All transitions are found to be rst order, involving discontinuities in the energy and correlation functions. At  $x = \frac{1}{4}$  we nd a transition from the disordered state to long-range ordered  $L1_2$   $Cu_3Au$  at  $T_c = 530$  K, which is only 130 K lower than the experim entally observed transition temperature. For the equiatom ic alloy at  $x = \frac{1}{2}$ the calculated and experim ental transition temperatures agree to a few degrees Kelvin. However, we do not nd the CuAu II phase which exists in a narrow temperature range between 658 K and 683 K. This phase is stabilized by the free energy dierences between  $L1_0$  and long-period superstructures of  $L1_0$  which are as small as 1 m eV /atom 56 and therefore beyond the accuracy of selfconsistent LDA calculations.

For  $x=\frac{3}{4}$  we obtain a sequence of transform ations, the rst one occurring at T=750 K from the disordered A 1 phase to a coherent two-phase m ixture of 2 and A 1. Then a subsequent transition at T=635 K takes C uA u<sub>3</sub> into the long-range ordered (100) superlattice which is predicted to be the stable T=0 ground state at that composition (see Sec. IV A 1). The calculated transition

at  $x=\frac{2}{3}$  goes straight into the 2 phase at  $T=735~\rm K$ . Therefore, a two-phase 2+A1 eld is predicted to exist at tem peratures som ewhere between 635 K and 730 K and around  $x=\frac{3}{4}$ . These predictions re ect the LDA. As stated in Sec. IV A1, corrections to the LDA m ight be signicant.

#### D.Non-con gurational entropy

The e ect of the non-con gurational entropy (electronic, vibrational, etc.) on the alloy phase stability has recently attracted considerable interest.  $^{106}$  for instance, it has been suggested  $^{108}$  first that there are large di erences in the vibrational entropies of ordering  $S_{\rm disord}^{\rm vib}$ , which should manifest them selves in shifts of the order-disorder transition temperatures. There is another important class of them odynamic properties where the vibrational entropy may play a role, and which has often been overlooked. Namely, it is the entropy of form ation with respect to the pure constituents, de ned in analogy with H in Eq. (4):

where S (A;T) is the total entropy of the pure constituent A at temperature T. It is often assumed that the congurational entropy is the dominant contribution to

S  $_{\rm tot}^{\rm form}$  (A<sub>1 x</sub>B<sub>x</sub>;T) because all other contributions cancel out in Eq. (21). The non-con gurational entropy of form ation,

contributes to such important quantities as mutual solubility limits and miscibility gap temperatures.

Noble metalalloys are excellent cases to test the values of S  $_{\rm non~conf}^{\rm form}$  since accurate experim ental data on the entropies of formation,  $S_{tot}^{form}$ , are available, and the con gurational entropy S conf can be calculated accurately using the therm odynam ic integration technique described in Sec. IIID. Table VI gives the measured entropies of form ation for disordered solid solutions  $A_{1}$   $_{x}B_{x}$ ,  $S_{tot}^{form}$  (x;T), the maximum attainable con gurational entropy S ideal, as well as the theoretically calculated con gurational entropy S calc and the derived value for the non-con gurational entropy of form ation, S  $_{\mathrm{non\ conf}}^{\mathrm{form}}$  . It shows that the size-m ism atched noble m etal system s have large am ounts of S  $_{\rm non~conf}^{\rm form}$  in the disordered solid solution. Since it is unlikely that these values of S  $_{\rm non~conf}^{\rm form}$  are of electronic or m agnetic origin, we suggest that the excess entropy in the disordered solid solutions of Ni-Au, Cu-Ag and Cu-Au is vibrational. It is possible that the atom ic relaxations lead to a softening of lattice vibrations, although the physical mechanism of this softening is unclear at present.

Sanchez et al.  $^{49}$  in their study of the Cu-Ag system noted that even a very crude model of the vibrational entropy markedly improved the agreement with the experimental solubility data. In the case of Ni-Au, which exhibits the largest S  $_{\rm non}^{\rm form}$   $_{\rm conf}$ , it is possible to reconcile the experimentally measured and theoretically calculated miscibility gap temperatures only by taking into account the non-congurational entropy of formation.  $^{117}$ 

The fact that Cu-Au also has a positive S  $_{\rm non\ conf}^{\rm form}$  has little qualitative e ect on the phase diagram since Cu and Au are completely miscible from total energy and con gurational entropy considerations alone. A g-Au is calculated to have a negative S  $_{\rm non\ conf}^{\rm form}$ , but its value is close to the experimental uncertainty in the measurement of S.

#### E.Bond lengths in random alloys

Since recent experimental measurements of the composition-dependence of interatom ic bond lengths in Cu-Au<sup>24</sup> and Ni-Au<sup>23</sup> have found several unusual features, it is interesting to address these trends from rst-principles LDA calculations. In the present work we model the atom ic positions in the random alloys using special quasirandom structures<sup>118</sup> (SQS). These periodic structures are designed to reproduced the pair and multibody correlation functions of the perfectly disordered con guration as closely as possible. It has been shown 118 that even small unit cell SQS's can give rather accurate representation of the properties of random alloys. We have performed LDA calculations for 8 atom /cell SQS's at  $x = \frac{1}{4}$  (SQS14a),  $x = \frac{1}{2}$  (SQS8a;SQS8b) and  $x = \frac{3}{4}$  (SQS14b). The atom ic positions and cell coordinates

have been fully relaxed to m in in ize the total energy. The results for Cu-Au and Ni-Au interatom ic bond lengths are shown in Fig. 8. The main features are:

- (i) In spite of the di erent phase diagram properties (N i-A u phase separates and C u-A u orders at T=0~K), the calculated behavior of bond lengths is very sim ilar, which we attribute to the sim ilar size m ism atch in both system s (12% in C u-A u and 15% in N i-A u).
- (ii) Our calculations give three distinct bond lengths at all compositions, which is also observed experimentally. Probably the most interesting feature in Fig. 8 is the crossing of  $R_{B\,B}$  (x) and  $R_{A\,B}$  (x) curves at x =  $\frac{3}{4}$  in both systems. The measurements for Cu-Au²4 and Ni-Au²3 indicate that this may indeed be correct, since the deduced values around this composition are very close and have large error bars.
- (iii) A nother important feature, observed experimentally and reproduced by our SQS results, is that A A bonds change much more as x varies from 0 to 1 than B B bonds when x varies from 1 to 0, suggesting that the compressed bonds become increasingly sti and the expanded bonds weaken. This behavior can be explained by the asymmetry in the interatom ic potential curves, which are rapidly hardening upon compression and softening upon expansion. However, our results for RAAA at  $x = \frac{3}{4}$  and RBBB at  $x = \frac{1}{4}$  are obtained from an average of only 4 m inority bonds in the SQS14 structures, and perhaps are not representative of a wider statistical sample.
- (iv) It is interesting to note that the predicted bond lengths between unlike atom  $s\,R_{A\,B}\,$  do not follow the linear relation  $R_{A\,B}\,=\,R_{A\,A}\,+\,x\,(R_{B\,B}\,\,$   $R_{A\,A}$ ).

#### V.SUMMARY

We have showed that accurate rst-principles studies of alloys with large size m ism atches are now feasible using the mixed-space cluster expansion method. This method has been applied to noble metal alloys where vast amounts of experimental data and many theoretical studies are available.

- (i) The mixed-space cluster expansion has been generalized to include the e ects of nonlinear strain on the form ation energies of long-period superlattices. We not that the elastic energy, required to lattice-m atch Cu and Nito (100) surfaces of Au and Ag, is anomalously low, leading to a very low constituent strain energy of (100) superlattices. This e ect is partly responsible for the stabilization of new LDA ground states of Au-rich Cu-Au alloys.
- (ii) In Au-rich Cu-Au, we predict new T=0 K ground states. Our LDA results place L1<sub>2</sub> (CuAu<sub>3</sub>), previously thought of as the stable T=0 state of CuAu<sub>3</sub>, higher in energy than a family of superlattices along (100) direction. In particular, MoPt<sub>2</sub>-type CuAu<sub>2</sub> [Cu<sub>1</sub>Au<sub>2</sub> superlattice along (100)] and a compli-

cated  $Cu_1Au_4Cu_1Au_4Cu_1Au_2Cu_1Au_2$  (100) superlattice are found to be the LDA ground states.

- (iii) There are signi cant discrepancies (up to 50%) between the experimentally measured and calculated LDA mixing enthalpies for Cu-Au alloys. This is surprising since the experimental mixing enthalpies of Ni-Au and Ag-Au are reproduced very well.  $^{54;117}$
- (iv) The calculated order-disorder transition temperatures are in an excellent agreement with experiment. For instance,  $T_c^{\rm calc}\,(x=\frac{1}{4})=530~{\rm K}$  and  $T_c^{\rm calc}\,(x=\frac{1}{2})=660~{\rm K}$ , compared with  $T_c^{\rm expt}\,(x=\frac{1}{4})=663~{\rm K}$  and  $T_c^{\rm expt}\,(x=\frac{1}{2})=683=658~{\rm K}$ .
- (v) From the experimentally measured entropies of formation S  $_{\rm tot}^{\rm form}$  and the calculated con gurational entropies S  $_{\rm conf}^{\rm form}$ , we obtain large non-con gurational (probably vibrational) entropies of form ation in the sizem ism atched system s, S  $_{\rm non}^{\rm form}$   $_{\rm conf}$  = S  $_{\rm tot}^{\rm form}$  S  $_{\rm conf}^{\rm calc}$ . These entropies allow one to reconcile the experimental miscibility gap temperature and formation enthalpies of N i-A u with the theoretical LDA values.  $^{117}$
- (vi) Bond length distributions in NiAu and Cu-Au have been studied via supercell calculations em-ploying the special quasirandom structure technique. The important qualitative features of recent EXAFS measurements  $^{23;24}$  are correctly reproduced: existence of distinct A A, B B and A B bond lengths at all compositions, possible crossing of  $R_{\rm AA}$  (x) and  $R_{\rm AB}$  (x) around  $x=\frac{3}{4}$  (where x is the composition of the larger constituent), softening of the shorter bond as x ! 1, and deviations of the bond length  $R_{\rm AB}$  (x) between unlike atoms from the linear Vergard's law .
