A coustic attenuation in a type-II superconductor at high m agnetic elds

We have calculated the longitudinal acoustic attenuation in a type II superconductor in high m agnetic elds within a mean-eld BCS theory. We predict two new features in the corresponding attenuation signal as compared to that of the M eissner state. Our analytical calculations predict the existence of oscillations in the attenuation as the external magnetic eld is varied-this e ect is associated with the Landau level structure of the electron states and is analogous to the well-known de H aas van A lphen oscillations in them ixed state. The attenuation directly probes the quasiparticle energies; the presence of gapless points in the quasiparticle spectrum, which is characteristic of type-II superconductors at high magnetic elds, show s up in the frequency ! and tem perature T dependence of the attenuation in the lim it of low ! and and low T respectively. At low T there is no analogue to the discontinuity in the attenuation observed in the M eissner state when h! = 2, where is the quasiparticle energy gap. This result opens up the possibility of experimentally determ ining the existence and nature of the gapless points in the quasiparticle spectrum of a type-II superconductor in high magnetic elds.

I. IN TRODUCTION

The problem of understanding type-II superconductivity in high magnetic elds has been a lively topic for some years now. When $k_B T < h!_c$, where $!_c = eH = m c$ is the cyclotron frequency, the Landau level quantization of the electron levels become important. This gives rise to a number of interesting e ects.¹ One such e ect is the existence of magnetic oscillations in the free energy of the superconductor in the mixed state. These de Haas-van A lphen (dH vA) oscillations was observed over 20 years ago² and have since been observed in a number of materials. O ne important theoretical consequence of the Landau level quantization is the presence of gapless points in the quasiparticle spectrum. Theoretical investigations have show n^{3;4} that the quasiparticle spectrum of the mixed state in high magnetic elds is characterized by a set of gapless points in the magnetic B rillouin zone (M BZ). These gapless point leads to an algebraic tem perature dependence of the therm odynam ic functions and an algebraic voltage dependence in the tunneling conductance.⁴ It has been suggested⁵ that the existence of the dH vA oscillations in the mixed state is a consequence of these gapless points. It turns out how ever, that it is rathered i cult to develop a simple, yet consistent theory for the dH vA -oscillations since both the oscillatory behaviour of the ground state energy and the gapless nature of the quasiparticle energies need to be taken into account.⁶ The interpretation of the experimental results for the dH vA -oscillations is consequently som ew hat unclear and does not, in our opinion, give a com pletely unam biguous signature for the presence of gapless m odes.

In this paper we consider the attenuation of longitudinal acoustic waves in them ixed state where the order parameter is assumed to form a vortex lattice. Since the absorption of the phonons is due to quasiparticle excitations, the experim ent directly probes the quasiparticle density of states. For clean m aterials, theoretical results have proved rather di cult to obtain since an expansion in powers of the order parameter does not converge 7 and the sem iclassical approximation leads to unphysical results.⁸ Since we consider the superconductor at high magnetic elds, it is crucial to take into account the Landau level quantization of the electronic levels. It turns out that by including this e ect, one avoids the di-culties encountered in the sem iclassical approximation as predicted by Schamberg. 8 W e calculate analytically the attenuation in two lim its: k_B T h! and $k_B T$ h! where ! is the frequency of the sound wave and T is the tem perature. We predict that the attenuation will be an oscillatory function of the external magnetic eld due to the Landau level structure, in analogy with the usual dH vA oscillations. The frequency and tem perature dependence of the attenuation is determ ined by the existence and the nature of the gapless points in the quasiparticle spectrum for $k_{\rm B}$ T h! and $k_{\rm B}$ T h! respectively. This in principle gives an experimental tool for probing the nature of the quasiparticle energies in the mixed state. Our analytical theory is supported by essentially exact num erical calculations for the attenuation.

As the analysis in this article will show, the existence of the gapless points in the quasiparticle spectrum has signi cant consequences on the longitudinal sound attenuation. We would therefore expect that this should also hold for system s with intrinsic gapless points even for no external eld such as high-tem perature superconductors (high- T_c 's), which seem s to have a d-wave gap symmetry. Hence a similar analysis of the acoustic attenuation in

these high- T_c 's as the one presented in this paper for type-II superconductors in high magnetic elds would be very interesting, and we will return to this in a future publication.

II.GENERAL THEORY

W e consider a weak-coupling superconductor in three dimensions (3D) described within mean eld theory by the following H am iltonian:

where the order parameter is de ned as $(r) = gh_{*}(r)_{*}(r)i$, g is the coupling strength and is the chemical potential. Our theory describes longitudinal ultrasonic waves in clean samples for high magnetic elds. We have for simplicity conned our theory to the case when q k H where q is the wavevector of the sound wave and H is the magnetic eld. This simplies our calculations since the coupling between the collective modes associated with uctuations of the order parameter and the longitudinal phonons can be neglected to a good approximation.^{9;10} The attenuation of sound waves is given by the imaginary part of the retarded phonon self energy. To low est order in the electron-phonon coupling we get for the attenuation (!):¹¹

where D^{R} (q;!) is the retarded density-density correlation function

and $n(x;t) = \hat{n}(x;t)$ h $\hat{n}(x;t)$ is the operator describing density uctuations. This function is evaluated as the analytical continuation of the therm alcorrelation function. We will in this paper for simplicity ignore the electronic Zeem an elect. The electron a nite spin splitting on the magnetic oscillations is well understood both in the norm al state¹² and in the mixed state.⁶ Hence ignoring the spin splitting we obtain

where G (r;r⁰;!) and F (r⁰;r;!) are the one-particle G reen's functions for the superconductor. The sym bol $_{cell} d^2r$ in plies integration over one vortex lattice cell in the x y plane whereas d^3r^0m eans integration over the whole crystal. By treating the electron-phonon m atrix element as an overall factor in our form alism (i.e. its frequency dependence ! is included as a prefactor in Eq.(2)) we have m ade use of the fact that the screening for longitudinal m odes is essentially the same e as in the norm alphase.¹³ Since the order parameter is assumed to form a vortex lattice, we can use a set of single particle states $_{nkk_z}$ (r) characterized by a Landau level index n, a wavevector $k = (k_x; k_y)$ in the M BZ, and a wavevector k_z along the z-direction. These basis states were introduced by N orm an et al.³ In this basis there is no m ixing between di erent k's since the sound wave travels along the z-direction. Expanding the G reen's functions in this basis and using the k-space symmetry of the problem due to the presence of the vortex lattice,³ we obtain the follow ing expression for the ultrasonic attenuation in the m ixed state of a type-II superconductor:

Here U $U_{kk_z}^n(\mathbf{r}), V$ $V_{kk_z}^n(\mathbf{r}), U^0$ $U_{kk_z+q}^{n^0}(\mathbf{r})$ and V^0 $V_{kk_z+q}^{n^0}(\mathbf{r})$ are the Bogoliubov functions. The quasiparticle energies are given by E $E_{k_z}^n(\mathbf{k})$ and E^0 $E_{k_z+q}^{n^0}(\mathbf{k})$; $f(E) = 1 = (\exp(E = k_B T) + 1)$ and the ^-product means integration over the xy-plane. The quasiparticle energies and associated wavefunctions can be found by solving the corresponding Bogoliubov-de Gennes (BdG) equations.¹⁴ We have set up a program that solves the BdG equations self-consistently in 3D such that we get the Bogoliubov functions as a function of H. The method for solving these

equations numerically in 2D is described in detail elsewhere.^{3,6}The extension to 3D is straightforward although it is computationally significantly more demanding. We choose the normal state dispersion law along the z-direction to be either the plane wave form $(k_z) = k_z^2 = 2m$, or more suitable for layered structures, the tight-binding form $(k_z) = t\cos(k_z a_z)$ where a_z is the distance between the planes.

In order to develop an analytical theory for the attenuation we need to make some approximations. Near the upper critical eld H $_{c2}$ and for quasiparticle levels close to the Fermi energy we can, as a rst approximation, ignore the o -diagonal pairing (i.e. the so-called diagonal approximation). The quasiparticle energies are then given by¹⁵

and the corresponding Bogoliubov functions are given by

Here $_{n}(k_{z}) = nh!_{c} + (k_{z})$. It should be noted that this approximation is only valid for energy levels close to the Ferm i energy. Further away from the Ferm i level there are degeneracies between electron and hole states belonging to di erent Landau levels, hence our approximation will eventually breake down. However, for low frequencies and temperatures one can show that only levels for which Eq.(6) and Eq.(7) hold will contribute to the damping described by Eq.(5). A closer examination shows the requirement for the diagonal approximation to hold to be max (k_B T;!) [<] h!_c=4. This follows because mixing with hole levels become important for levels with E $h!_c=4.^{6;16}$ D ukan et al^{4;15} argued that the o -diagonal pairing does not change the qualitative behavior of the superconductor in a high magnetic eld for elds not too far below H $_{c2}$, and that the quasiparticle spectrum remains essentially the same when the o -diagonal term s are included. From the diagonal approximation, it directly follows that there are gapless points in the M BZ (i.e. (k) = 0). Even when the diagonal approximation breaks down, there will still be points in the M BZ where the gapless behaviour occurs away from its diagonal approximation value (k_{zf}) = 0.⁴ Eventually, true gapped behaviour sets in when the superconducting order is strong enough to increase the energies of the quasibound states in the vortices above h! $_{c.}^{3}$

In Fig. 1 we have plotted the lowest quasiparticle energy, calculated num erically, along the M direction in k-space for two di erent values of the order parameter (r) at a low tem perature. The two points = $(=4a_x; =2a_y)$ and $M = (3 = 4a_x; = 2a_y)$ are two of the corners in an irreducible triangle rejecting the symmetry of the BdG -equations in k-space.³ Here $a_x = 1(\frac{r}{3} = 2)^{1=2}$ as we have chosen a triangular symmetry for the vortex lattice, $a_y = 1^2 = a_x$ and $l^2 = hc=eH$ is the magnetic length. We have chosen the size of the system such that =(2a_x k_x) = 50 where k x = 2 = L x and L x is the extend of the system in the x-direction. The dashed lines give the diagonal approximation to the energies and the solid lines the exact num erical result. The two highest-lying curves are calculated with h (k)i' 0:3h! c and the two lowest lying curves are with h (k)i' 0:05h! c. Here h (k)im eans the k-space average of the diagonal matrix element in the BdG equations. There are 10 Landau levels within the pairing width and the dispersion law along the z-direction is $(k_z) = t\cos(k_z a_z)$. The value of k_z is chosen such that $(k_z) = 0$. As can be seen, the diagonal approximation predicts two gapless points along this k-space direction, both with a linear dispersion law. For a sm all pairing param eter there is good agreem ent between the diagonal approxim ation and the full calculation. For a larger pairing parameter, i.e. h (k)i' 0:3h! c, the approximation is less precise-indeed the gapless points predicted by the diagonal approxim ation disappear in the full self-consistent calculation. This is due to the o -diagonal pairing which become increasingly in portant as the pairing interaction increases deeper into the m ixed state. The gapless points are now at a di erent value of kz. W e expect our theory to be valid reasonably close to the transition line such that we can ignore the o -diagonal pairing. As will be shown later, the major contribution actually com es from the gapless points where the diagonal approximation is most valid. We will now calculate the attenuation in two lim its using this approximation.

III.LOW FREQUENCY

We will rst treat the case ! $k_B T$. In this limit we can focus on the rst two delta functions in Eq.(5) which describe the scattering of a quasiparticle. We will outline the calculation for the dispersion law $(k_z) = k_z^2 = 2m$. Making the approximation ${}^0=E{}^0' = E$ which is valid for h! $k_B T$ the rst two terms of Eq.(5) become:

Here $k_z(n;k)$ is the solution to the equation $E_{k_z+q}^n(k) = \frac{1}{k_z} + \frac{1}{2} = \frac{1}{2}$. From the Poisson formula we have the identity

where $_{x}(k_{z}) = xh!_{c} + (k_{z}) = (x + h_{z})h!_{c} + (k_{z})$. Here $n_{f} = h!_{c}$ 0.5 is the Landau level index at the chem ical potential. We have extended the Landau level sum to go from 1 as the low levels do not contribute anyway. Making the variable substitution $_{x}(k_{z}) = zh!_{c}$ we end up with

where $E_z(k) = (\frac{2}{z} + (k))^{1=2}$. We have approximated k_z as the corresponding normal state solution (i.e. it is independent of n). This approximation which is only necessary when we calculate the oscillations of the attenuation (i.e. the terms in Eq.(10) with $j \in 0$), should be good close to the gapless points and is equivalent to ignoring any phaseshift in the oscillations due to the superconducting order. The 0'th harm onic is given by the j = 0 term. We get

U sing an ansatz of a form al similarity between a pure type II superconductor in high magnetic elds and a currentcarrying superconductor M ak l^{17} arrived at the following expression for the ratio s = N between longitudinal attenuation in the mixed state and in the norm al state:

where ² hj (r) j^2 i is the real space average of the gap. A s M aki used a sem iclassical approximation he did only calculate the 0'th harm onic. To compare with this result we expand Eq.(11) to rst order in (k). We get:

where hj (k) ji_k is the k-space average of j (k) j. We see that our theory for the 0'th ham onic, which is exact within the diagonal approximation produces a term linear in for the ratio s = N as does M aki's conjecture. This linear term is somewhat surprising as the G or'kov expansion of the G reen's functions would seem to imply that the rst correction term is quadratic in . However, even in the zero edd BCS-state one obtains 13 $_{S} = N = 2 = (\exp(=k_B T) + 1)$ which cannot be expanded in 2 . So our theory con rm sM aki's ansatz of a linear correction term for the damping. Thus the non-perturbative linear term in the quasiparticle energy Eq.(6) com ing essentially from the degeneracy of the Landau levels shows up in the attenuation result, making a calculation based on the G or'kov expansion questionable. This is in contrast to the case of the expansion of the therm odynam is potential where contrary to earlier claim s, 18 it can be proven that these non-perturbative term s cancel, thus m aking the G or'kov expansion of the therm odynam is potential correct. 19 O ur result substitutes M aki's real space average = (hj (r) j ² i)¹⁼² with the k-space average of j (k) j.

For conventional superconductors in the M eissner state we know that the nite gap for all k supresses the attenuation by a factor 2= (exp ($=k_B T + 1$). We expect that the existence of gapless points will now change this result signi cantly. We therefore split the MBZ into two qualitatively dierent regions: the \gapped" region where we assume (k) = h (k)i where h (k)i is the k-space average of (k), a the \gapless" region where we assume (k) = k . We furtherm ore assume that this latter dispersion law holds for all (k) $\leq k_B T$. This is a slight generalization of the m odel used by D ukan and Tesanovic⁵ in their theory for the dHvA oscillations. We assume that the gapped region takes up a fraction F of the MBZ. The contribution (q;!)_{0,gap} to the attenuation from the gapped region is then

where h = h2. As expected the attenuation from the gapped part of the spectrum is strongly supressed due to the 2=(exp(h (k)i=k_BT) + 1) factor. This result for the 0'th harmonic of the attenuation from the gapped part

of the spectrum in the mixed state is the same as for the total attenuation in the M eissner state of a conventional superconductor. The qualitative new feature comes from the presence of the gapless points. Solving the 2-dimensional k-space integral in Eq.(11) using the assumed dispersion law, we obtain the contribution $(q;!)_{gl}$ from the gapless part as

where Q_{g1} is the number of gapless points in the MBZ.Here (x) is Riemann's zeta function and (x) is the gamma function. For a linear dispersion around the gapless points we especially obtain

The relative size of the contributions from the gapped and gapless parts of the spectrum is determined by h (k)i=k $_B$ T, F and . For h i $^{>}$ 3k $_B$ T the contribution from the gapped part can be ignored and the attenuation is given by Eq.(15). Since the normal state attenuation is given by (q;!)_{0,N} = m²!²=h²qh we get

This calculation is valid in the clean case where the momentum is conserved during the scattering process. As a rst approximation to the dirty limit we can assume that there is no momentum conservation in the scattering process and take k_z and k_z^0 as free variables¹¹ (i.e. $k_z^0 \in k_z + q$). As in the M eissner state, this relaxation does not alter the result stated in Eq.(17). This is due to the fact we are boking at energies close to the Ferm i level such that we can assume that the normal state density-of-states is constant. It has been show n²⁰ that for small in purity concentrations and weak scattering potentials the density of states behaves essentially in the same way as for the pure case. We therefore believe that our results are somewhat insensitive to the presence of in purities.

The Landau level structure of the norm alstate electron energies in plies that there will oscillations in the attenuation as the external eld varies. The oscillatory term s are given by the $j \in 0$ term s in Eq.(10). We end up with the following expression for the rst harmonic (q;!)_{gl;1} of the attenuation from the gapless part of the spectrum :

This integral can be solved in the case of a linear spectrum around the gapless points (i.e. = 1). In this case we obtain for the 1st harm onic of the attenuation

For low temperatures this goes as T^2 . In the case of a general dispersion law around the gapless point given by (k) = k, the leading term for the 1st harm onic goes as $(T =)^{2^{-}}$. This should be contrasted to the M eissner state, or the contribution from the gapped part of the spectrum, where the oscillatory term s will again be damped by a factor 2= (exp (h $(k)i=k_B T) + 1$). In the case of the normal state, the 1st harm onic is

which is independent of T for low tem peratures. In the case of a dispersion law along the z-direction given by $(k_z) = t \cos(k_z a_z)$ we have to substitute m =q by 2=ta_z jsin $(k_z a_z)$ sin $(k_z + q)a_z$ jin Eq.(15) and m cos(2 (n_f (k_z)=h!_c))=q by $_{i=1;2} \cos(2 (n_f (k_{z}_i)=h!_c))=ta_z$ jsin $(k_z a_z)$ sin $((k_z + q)a_z)$ jin Eq.(19)-(20) where $k_{z;i}$ are the two solutions of the equation $t \cos((k_z + q)a_z)$ tcos $(k_z a_z) = h!$.

In Fig. 2 we show an example of the acoustic attenuation calculated num erically for two di erent coupling strengths as a function of nf. We have solved the BdG equations self-consistently in 3D as a function of the external magnetic eld at constant chem ical potential. In this paper we have chosen to work with a constant chem ical potential. The di erence between holding the chem ical potential constant and holding the num ber of particles constant is negligible in 3D for the norm al state.¹² Even in 2D it can be shown that the superconducting order tends to suppress the di erence between the two cases in the mixed state.⁶ The attenuation is calculated via Eq.(5). We have chosen parameters such that $!_{D} = !_{C} = 5$, $k_{B} T = h!_{C} = 0.05$ and $! = !_{C} = 0.01$ when $n_{f} = 12$, where $!_{D}$ is the usual cuto of the pairing interaction around the Ferm i surface. The solid curve is the norm al state attenuation which is continued into the mixed state to facilitate comparison with the mixed state attenuation; the dashed curve corresponds to the coupling strength $g=h!_cl^3 = 7.85$ while the dash-dot curve corresponds to $g=h!_cl^3 = 8.7$. The dispersion law along the z-direction is $(k_z) = t\cos(k_z a_z)$ where t=h! c = 0.4. In Fig. 3 we have plotted the corresponding order-parameter which in the lowest Landau level approximation for the pairing (which is valid close to H_{c2})¹ can be characterized by the dimensionless number $_0$ / (k). The connection between $_0$ and (k) or (r) is given by an obvious generalisation to 3D of the results by Norm an et al.³ The phase transition between the norm al and the mixed state occurs for n_f ' 7:6 with g=h! $_cl^3$ = 8:7 and for n_f ' 9:5 with g=h! $_cl^3$ = 7:85. As can be seen from Fig. 2, the oscillations of the attenuation due to the Landau level quantization persist into the mixed state, although they are dam ped as compared to the normal state oscillations. Eventually the oscillations die out when the o -diagonal pairing becomes dominant and the diagonal approximation breakes down. This happens for $n_f^{>}$ 11 with g=h!_cl³ = 8.7. C om paring the attenuation for the two coupling strengths in the region 10 $n_{\rm F}$ 11 we get $_0$ (7:85)= $_0$ (8:7) ' 1:9 and (7.85) = (8.7) ' 2.4 where (g); is the i'th harm onic of the attenuation for the coupling strength q. Since h (k)i can be calculated ³ directly from o, and the coe cient in the dispersion law around the gapless points is proportional to q₀, we can compare the num erical results with the analytical predictions outlined above. If the quasiparticle spectrum is essentially gapped, Eq.(14) predicts that $_0(7.85) = _0(8.7) = f(h_{7.85}i) = f(h_{8.7}i) ' 8.8$. If the attenuation is primarily originating from gapless points in the quasiparticle spectrum, Eq.(15) predicts that $_{0}$ (7:85)= $_{0}$ (8:7) = (8:7) = (8:7) = 7:85 $_{0}$ (7:85))²⁼. This gives 2:5 for = 1 and 1:6 for = 2. Hence the num erical calculation (0.7:85) = 0.8:7 '1:9) in ply (i) that the gapless points dom in the attenuation in agreement with our analytical results and (ii) that the dispersion law is somewhere between = 1 and = 2, since the gapless predictions agree reasonably well with the num erical results while the gapped predictions are qualitatively wrong. We cannot how ever make a quantitative num erical determ ination of the dispersion law around the gapless points. This is due to the fact that in order to reduce the computation load, which is high in this 3D case, we have to choose a k-m esh with a rather large spacing between the points. (the mesh consists of 100 50 points) This means that the gapless regions in the quasiparticle spectrum are only probed by a few k-vectors, thereby prohibiting a quantitative determ ination of the dispersion law. Likewise, the analysis above predicts that $_1(7.85) = _1(8.7)$ equals 2.5 and 1.6 for = 1 and = 2 respectively. The = 1 prediction of 2.5 agrees well with the num erical result $_1$ (7.85)= $_1$ (8.7) ' 2.4. Again, any quantitative comparison would require a much nerk-mesh. A further complication is that due to the number

of Landau levels participating in the pairing (approx. 10), the oscillations in the attenuation are quickly damped and the diagonal approximation is only valid over relatively few oscillations. This problem could be avoided if we were to perform the calculations for experimentally realistic parameters, where there are many more Landau levels in the pairing region; however we have not been able to run the programs for such parameters due to the intense computation load. The above example does show however that the numerical calculations support our analytic theory. In short, the norm all state oscillations in the attenuation continue into the mixed state and the damping is dominated by gapless points not too far into the mixed state.

Hence we have calculated the 0'th and the 1st harmonic of the acoustic attenuation in the mixed state. The presence of gapless points enhances the acoustic attenuation above the conventional value for the M eissner state. When h i $> 3k_B T$ such that we can ignore the contribution from the gapped part of the spectrum, the tem perature dependence of the attenuation is a power law given by $/T^{2=}$. Furthermore, we predict that one should observe oscillations in the signal as the external eld is varied. The magnitude of these oscillations should have the same tem perature dependence as the average value of the signal. Hence, by looking at the tem perature dependence of the attenuation one should be able to detect the presence of the gapless points and to extract the dispersion law around these points. From the diagonal approximation it follows that $/hi where \frac{h i is the k-space}{1}$ (or real space) average of the gap. Hence close to the upper critical eld H_{c2} we expect $/\frac{1}{1}$ H =H_{c2}. This would mean that (q;!) / (1 H =H_{c2})¹⁼ close to H_{c2}.

IV.LOW TEMPERATURE

We will now consider the limit where $k_B T$ h!. In this limit only the third delta function in Eq.(5), which describes the creation of two quasiparticles will contribute to the damping. We rst calculate the 0'th harm onic of the attenuation. Using the Poisson identity, making a substitution of variables and using the fact that v_s !=q v_f (v_f is the Fermi velocity) we obtain the 0'th harm onic of the attenuation, when (k_z) = k_z^2 =2m, as

Here E (k) is the complete elliptic integral of the second kind. The existence of the gapless points again gives rise to a qualitatively dimensional for the ultrasonic attenuation in the mixed state as compared to the M eissner state. This is most easily understood by the observation that there will always be attenuation for any frequency in the mixed state since there are always quasiparticle states with (k) h!=2. Hence the phonon will always have enough energy to create two quasiparticles. This is in contrast to the M eissner state, where there is no attenuation for h! < 2.²¹ Thus a direct experimental signature of these gapless points would be the absence of the discontinuity in the attenuation which is present in the M eissner state²¹, when h! = 2, and the presence of acoustic attenuation in the mixed state as ! 0. We again assume that the dispersion law around the gapless points to leading order is given by (k) = k (k = jkj) in the region that contributes to the attenuation (ie for (k)) h!=2. U sing this we obtain

Since the attenuation for the norm all state is $(q;!)_{0,N} = m^2!^2 = 2 h^3 q$ we have

For the same reasons as for the h! $k_B T$ case, we expect Eq.(24) to also be valid in the dirty limit. The remaining integral in Eq. (23) can be solved for various . We obtain, for instance, $I_1 = 2=3$, $I_2 = {}^2=16$, $I_{1=2} = 32=45$ etc. A gain the attenuation has an oscillatory behaviour as a function of the magnetic eld H 1 . From the Poisson identity we get for the 1st harm onic

We have not been able to solve this integral exactly. However, in the region where the diagonal approxim ation holds (ie for $! < h!_c=4$) one can expand the factor $e^{il = h!_c}$ to a good approximation. This immediately yields that, to leading order in $!=!_c$, the amplitude of the rst harm onic varies as $!^{2= +2}$. The next correction term will go as $!^{2= +4}$.

So we see that the existence of the gapless points in the MBZ implies that there is a nite attenuation for any frequency of the sound wave. There will be no discontinuity in the attenuation as a function of the sound wave frequency. As the external eld is varied one should observe oscillations in the attenuation. The dependence of the attenuation on frequency is algebraic and the power-law is determined by the dispersion law around the gapless points. If (k) = k we obtain $/ !^{2= +2}$. The absence of the discontinuity and the frequency dependence of the attenuation should in principle provide the possibility of experimentally determining the existence and dispersion law for the gapless points. Again we expect $(q; !) / (1 H = H_{c2})^{1=}$ close to H_{c2} . By making the same substitutions as in the h! $k_B T \lim_{k \to \infty} t_{k_B} T$

V.CONCLUSION

In this paper we have considered the acoustic attenuation in a type IIBCS superconductor at high magnetic elds using both numerical and analytical methods. We have shown that away from the sem iclassical regime where the Landau level structure of the electronic states is in portant, the attenuation will in general be an oscillatory function of the external magnetic eld. Furtherm ore, since the attenuation probes the quasiparticle density of states, the presence of gapless points in the quasiparticle spectrum makes the attenuation qualitatively di erent as compared to the M eissner state attenuation. For $k_B T = h!_c$ the attenuation is an algebraic function of the frequency and there is no discontinuity as opposed to the M eissner state attenuation. For $k_B T = h!_c$ the attenuation is an algebraic function of the gapless points. This behaviour should in principle be experimentally detectable; such an experiment would provide con rm ation of the existence and nature of the gapless points.




Figure 2 (Bruun, prb)




Figure 3 (Bruun, prb)
