Optim ized e ective potential method with exact exchange and static RPA correlation

Abstract

W e present a new density-functional method of the self-consistent electronicstructure calculation which does not exploit any local density approximations (LDA). We use the exchange-correlation energy which consists of the exact exchange and the correlation energies in the random -phase approximation. The functional derivative of the correlation energy with respect to the density is obtained within a static approximation. For transition metals, it is shown that the correlation potential gives rise to a large contribution which has the opposite sign to the exchange potential. Resulting eigenvalue dispersions and the magnetic moments are very close to those of LDA's and the experiments. 71.10.-w, 71.15Mb, 71.45.Gm

The optim ized-e ective-potential (OEP) m ethod for the electronic-structure calculations was nst applied to atom s by Talm an and Shadwick [1], who recognized it as a kind of restricted m inimum search for the Hartree-Fock total energy. In the m ethod, the variational space was restricted to the space of the local one-particle potential, which generates all the eigenfunctions, or to the space of the corresponding density. From the view of the density-functional (DF) theory, their calculations are recognized as the Kohn-Sham (KS) exact exchange (EXX) -only DF calculations. In the last years, we have extended their m ethod to be applicable for solids [2]- [4], where we add the correlation energy in the local density approximation (LDA). As was shown there, the results admittedly were not satisfactory from the view point of comparison with experiments. Especially for transition m etals such as iron [3], the m ethod gave the occupied d bands which were too deep relative to the s bands and also gave rise to too large m agnetizations. This indicates that the LDA correlation is poor when we combine it with EXX, and that the true correlation should give rather large contributions cancelling large EXX.

There are two kinds of way to take into account the correlation energy more precisely. One is the multiple-con guration extension [5], which is a widely-used idea in the quantum chem istry. The other is based on the DF theory, to utilize the implicit DF for the correlation energy based on the KS orbitals, in addition to the EXX energy. A long the second, G arbo and G ross tried a new DF for correlation, which applied to atom s and m olecules [6].

In this Letter, we present a new method for solid along the second line. We use an exchange-correlation (XC) energy functional, which consists of the EXX energy and a correlation energy in the random phase approximation (RPA). The correlation potential, which is the functional derivative of the correlation energy with respect to the density, is evaluated within a static approximation; the static screened-C oulomb interaction, which is used for the evaluation of the RPA correlation, is calculated by use of the product-basis method developed by A ryasetiawan and G unnarson [7]. We denote our method as EXX+RPA in the following.

Form ally, the XC energy $E_{xc}[n]$ as a DF is given by use of the coupling-integral method:

where $\hat{}$ denotes the electron eld operator, and h:::i_n; indicates the vacuum expectation value with respect to the system with the given density n (r) and the coupling e^2 . Note that the given density is kept unchanged for any by applying the -dependent external potential. The EXX energy $E_x[n]$ as a functional of the density is de ned as the e^2 term of $E_{xc}[n]$. A sa correlation energy functional $E_c[n]$, we only take the RPA contribution included in the expression of Eq.(1):

where the trace is taken for index 1 rt (in Eq.(2), we suppress a factor $1 = {K_1 \atop 1}$ dt for sim – plicity). v is de ned as v (1;2) = e^2 ($t_1 t_2$) ${}_1 {}_2 = jr_1 r_2 j$ and v denotes v ${}_{=1}$. Form ally Eq.(2) is the same as that for the RPA correlation energy of the hom ogeneous electron gas [3] except that E^{RPA} should be treated as a functional of density n (r) through the Lindhard dielectric function D⁰, which is spin-diagonal and constructed from the eigenfunctions ⁱ (r) satisfying

Under the assumption of one-to-one correspondence between n (r) and V^e (r) (we de ne V^e so that the chemical potential is included in it), we can treat ⁱ (r), and hence E^{RPA} , as a functional of n (r). The approximation of Eq.(2) was suggested by G ross, D obson and Petersilka in Ref. [9] (we om it the term f_{xc} corresponding to the vertex correction).

The derivative E_c with respect to D^0 can be written as

where v_{sc} $(1 \quad vD^{0})^{1}v$ denotes the dynam ical screened C oulom b interaction in RPA. We evaluate E_{c} in a static approximation, i.e., we replace $W_{p}(r_{1};r_{2};t_{1} t_{2})$ with $W_{p}^{!=0}(r_{1};r_{2})$ $(t_{1} t_{2})$, where we de ne $W_{p}^{!=0}(r_{1};r_{2})$ ${}^{R_{1}}_{1}$ dt $W_{p}(r_{1};r_{2};t)$. This approximation is justiable if the relaxation time of the dynam ical screening v_{sc} , typically the plasm a oscillation time-scale, is su ciently shorter than that of the density uctuation iD 0 . We know iD ${}^{0}(r_{1};r_{2};t_{1} = t_{2}) = n$ (r_{1}) $(r_{1} r_{2})$ $[n (r_{1};r_{2})]^{2}$.  E_{c1} and E_{c2} correspond to the correlated part of the screened exchange and the C oulom bhole terms, respectively (see p.40 in Ref. [10]). As for E_{c1} , we can calculate its functional derivative $E_{c1} = V^{e}$ (r) from $W_{p}^{!=0}(r_{1};r_{2})$, n $(r_{1};r_{2})$ and n $(r_{1};r_{2}) = V^{e}$ (r) through Eq.(8). Then we obtain $E_{c1} = n$ (r) by the same inversion method as was used to obtain $E_{x} = n$ (r) [2] (see Eq.(11)). If we evaluate E_{c} from Eq.(6) without the static approxim ation, we obtain the result essentially equivalent to Eq.(27) in Ref. [11], which was used by G odby, Shluter and Sham to discuss the eigenvalues of the density functional theory beyond LDA.

In order to calculate all the related quantities, we exploit the atom ic sphere approxim ation (A SA). Any points in the space are denoted by (r;R), where R is the index for atom ic sphere (A S) and r = (r; ;) is a vector denoting the position in each A S. W e consider $E_{xc}[n^{s}]$ as a functional of $n^{s}(r;R)$, where $n^{s}(r;R)$ denotes the spherically-averaged density. $W_{p}^{!=0}$ are calculated by the product-basis m ethod [7] as

where $B_i(r)$'s form the product basis (see Ref. [7] for notation). In the method of the LM TO -A SA [12], the non-local density n $(r_1; R_1; r_2; R_2)$ is given as a functional of $V^e(r; R)$ through the potential parameters and radial basis functions. Therefore $E_{c1} = V^e(r; R)$ can

be evaluated by use of the derivative chain rule in the same manner used for E_x [2]. Now, we can calculate the contribution to the correlation potential V^{cl} (r;R) E_{cl} [n^s] = n^s (r;R) by the inversion equation,

Eq.(11) is essentially the same as the one for E_x in Ref. [2]. Adding spin-independent $V^{c2}(r;R)$ (the spherically-averaged $W_p^{!=0}(r;R;r;R)$), we obtain the RPA correlation potential V^c . Since we treat only metals, we can determ ine constant parts of V^x and V^{c1} uniquely (note that V^e includes the chemical potential). We have developed a code to perform the non-relativistic self-consistent calculation with V^c together with V^x . This is done by combining two codes, one calculating W_p and the other LM TO-A SA EXX code; the form er is a part of the GW program [13] [14] provided by A ryasetiawan, and the latter is developed starting from LM TO-4 [15].

We show results for Cu (fcc), Ni(fcc), Fe(bcc), and Co (fcc) with the lattice constants determ ined by LDA, 6.76, 6.55, 5.27, and 6.54 a.u. [16], respectively. For the evaluation of E_x and E_c , we take all the pairs (R_1 ; R_2) within the second nearest neighbors and treat 4s, 4p, and 3d as valence orbitals. For the calculation of $W_p^{!=0}$, we use 35-k points in the irreducible Brilbuin zone, with the Lorenzian broadening = 0.02 Ry. in Eq.(3). We used 90 optimum product basis B_1 's, where all the core eigenfunctions are used to generate them.




Fig.1(a) Jun 18 1997 3:37 pm

In Fig.1, we show the self-consistent $V^{xc} = V^x + V^{c1} + V^{c2}$ for Cu, N i and Fe. Constant parts of V^x and V^{c1} are properly xed for presentation. We nd that the large dips of V^x and the large di erences between up-and down-spin components of V^x are strongly reduced by adding V^c. As a result the nal V^{xc} obtained by EXX+RPA gets much closer to those by LDA [17] than it was for V^x obtained by EXX.V^{c2}, which corresponds to the screening length [18], has considerable structures but its contribution to V^c is largely cancelled by V^{c1} in the vicinity of the core region. This can be explained by the fact that $n(r_1;r_2)$ is su ciently short-ranged for given n(r) near the core region, which allows us to evaluate E_c approximately by use of W $_p^{!=0}(r_1;r_1)$ instead of W $_p^{!=0}(r_1;r_2)$ in Eqs.(8-9): By this replacement, we have $E_{c1} + E_{c2} = 0$ because of $R dr_1 D^0 (r_1; r_2; t_1 = t_2) = 0.0 n$ the other hand, we see a rather large cancellation between V^x and V^{c1} out of the core region (r > 1.0 a.u.). This is because the main contribution to E_{c1} in Eq.(8) comes from the integral out of the range of $v_{sc}^{!=0}$, where we expect the behavior of $W_p^{!=0}$ is $W_p^{!=0} (r_1; r_2)$ $1=jr_1$ r_2j .




Fig. 2 Jun 18 1997 3:40 pm

The eigenvalue dispersions are shown in Fig.2 together with those calculated by usual LDA, and EXX. Results by EXX+RPA are very close to those obtained by LDA, and are much di erent from the results by EXX. The magnetic moments shown in Table I are also in good agreement with the LDA's and experiments. To obtain numerically accurate values of the magnetic moments, it is necessary to extrapolate the series of fully converged (about the number of k points) results for dierent towards = 0. This, however, seems too time-consuming in the present stage of our unoptimized computer code, and we only show the results for = 0.04 Ry. with 35-k points in Table I for reference.

Let us discuss som e possible sources of the di erence between our results and those of the true DF. These are (1) the product-basis expansion, (2) RPA, and (3) static approximation for RPA. As for (1), our test for a model interaction $v_{sc} = \exp((r) = r)$ (in this case we can obtain accurate results without using the product-basis expansion) indicates that the potential V_c is poorer when getting closer to the AS's center. The oscillation of V_c near the nucleus seems to be an artifact due to the method of expansion. However, this fortunately little a ects on the energy bands and the magnetic moments (we will show the details in the subsequent paper). To take into account the e ects beyond RPA, (2), we have to treat $f_{\rm xc}$ in Ref. [9], which corresponds to the vertex correction. Som e parts of the contribution due to f_{xc} m ight be taken into account by LDA -like approximations; one of the simple ways is to add the di erence between the LDA XC calculated by RPA [17] and the one calculated by a m ore accurate scheme [19]. We tried the above method but the correction turned out to be rather sm all; the magnetization of Fe enhanced by $0.05_{\rm B}$ (this value is similar to the corresponding LDA case). However, we are not so con dent whether the correction is really m eaningful or not. As for (3), the dynam ical e ects will be simulated in e ect by making $v_{sc}^{!=0}$ closer to v (no relaxation limit). It should reduce the magnitude of V_c. Therefore the position of d band relative to s band should be som enow pushed down for Cu case (See Fig.1). Contrary, this estimation concerning (3) is opposite in the case of LDA. In the case of LDA, we can rather easily show that d bands calculated by LDA in the RPA [17] are pushed up from those obtained by its static approximation. In conclusion, it seems rather di cult to evaluate (3) based on the LDA idea; we have not succeeded in giving any reasonable evaluations for the magnitude of errors due to (2) and (3).

It sometimes have been claimed that the itinerant-magnetism is a sensitive problem where the higher-order electron-correlation [20] beyond RPA screening might be essential in determining the magnetic moments or the ground states. Our results, however, indicate that the essential part determining the magnetic moments might be well accounted for by the correlation within the RPA screening, even though the higher-order correlations are certainly in portant for excitations as was discussed in Ref. [13]. Incidentally, as for the the higher-order correlations, we as well can extend the OEP method to include other classes of correlation diagram s included in Eq.(1) and to evaluate their contributions in an ab-initio way. For example, the exchange diagram s of order e^4 that is in portant to cancel the self-interaction of order e^4 can be included. Further, the ladder types of diagram s that include the free energy due to the spin wave should be taken into account in the case of nite temperatures.

O urm ethod determ ines not only V^e, but also W_p^{!=0} in a self-consistent m anner. W_p^{!=0} calculated from the LDA eigenfunctions (and eigenfunctions) seems reasonable for transition m etals: For example, the m agnetic m om ents 2.07 _B of Fe, which is calculated with a xed W_p^{!=0} calculated from the LDA eigenvalues, is very close to the self-consistent value 2.04 _B in Table I. However, such results obtained by the LDA eigenvalues are not expected to be su cient for solids like transition-m etal oxides. In Ref. [14] for N iO, it is shown that the GW calculation with W_p constructed from the LDA eigenvalues gives poor results because of the too sm alla LDA band gap, and that the self-consistency of GW is essentially needed. The fully self-consist calculation of GW seems very hard m ainly due to the program ing di culties and the lack in computational power. From such a point of views, our self-

consistent calculation ${\tt m}$ ight be a good substitution of the self-consistent ${\tt GW}$.

We have not developed the code to calculate E_c^{RPA} itself yet. We only treated its functional derivative $E_c^{RPA} = n^s$, and the static approximation is not applicable for the total energy calculation. To our know ledge, none have done the ab-initio calculation of E_c^{RPA} . It requires to treat unoccupied states precisely. It might be a little di cult in LM TO -A SA scheme. However, we have to try such calculations for determining lattice constants and other cohesive properties.




