# O verscreened multi-channel SU (N) K ondo model: large-N solution and conform al eld theory

#### A bstract

ThemultichannelK ondomodelwith SU (N) spin symmetry and SU (K) channelsymmetry is considered. The impurity spin is chosen to transform as an antisym m etric representation of SU (N), corresponding to a xed number of  $f^{y}f = Q$ . For m ore than one channel (K > 1), and Abrikosov fermions all values of N and Q, the model displays non-Ferm i behaviour associated with the overscreening of the impurity spin. Universal low-temperature therm odynam ic and transport properties of this non-Ferm i liquid state are com puted using conformal eld theory methods. A large-N limit of the model is then considered, in which K = Nand Q = Nq are held xed. Spectral densities satisfy coupled integral equations in this lim it, corresponding to a (tim e-dependent) saddle-point. A low frequency, low-tem perature analysis of these equations reveals universal scaling properties in the variable !=T, in agreem ent with conformal invariance. The universal scaling form is obtained analytically and used to compute the low-temperature universal properties of the model in the large-N  $\lim$  it, such as the T = 0 residual entropy and residual resistivity, and the critical exponents associated with the speci cheat and susceptibility. The connections with the \non-crossing approximation" and the previous work of Cox and Ruckenstein are discussed.

#### I. INTRODUCTION AND MODEL

Multichannel Kondo impurity models [1,2] have recently attracted considerable attention, for several reasons. First, in the overscreened case, they provide an explicit example of a non-Ferm i liquid ground-state. Second, these models can be studied by a variety of controlled techniques, and provide invaluable testing grounds for theoretical methods dealing with correlated electron systems. One of the most recent and fruitful development in this respect has been the conformal eld-theory approach developed by A eck and Ludwig [4 {6]. Finally, multichannel models have experimental relevance to tunneling phenomena in quantum dots and two level systems [3], and possibly also to some heavy-ferm ion compounds [2].

In this paper, we consider a generalisation of the multi-channel K ondo model, in which the spin sym metry group is extended from SU (2) to SU (N). In addition, the model has a SU (K) sym metry among the K \channels" (avours) of conduction electrons. We focus here on spin representations which are such that the model is in the non-Fermi liquid overscreened regime. We shall derive in this paper several universal properties of this SU (N) SU (K) K ondo model in the low-temperature regime. Specically, we obtain: the zero-temperature residual entropy, the zero-temperature impurity resistivity and T-matrix, and the critical exponents governing the leading low-temperature behaviour of the impurity specic heat, susceptibility and resistivity.

These results will be obtained using two di erent approaches. It is one of the main motivations of this paper to compare these two approaches in some detail. First (Sec.III), we apply CFT methods to study the model for general values of N and K. Then, we study the  $\lim_{n\to\infty} f$  and K, with K = N = 1xed. This lim it was previously considered by Cox and Ruckenstein [7], in connection with the \non-crossing approximation" (NCA). There is a crucial di erence between our work and that of Ref. [7] however, which is that we keep track of the quantum number specifying the spin representation of the impurity by imposing a constraint (on the Abrikosov ferm ions representing the impurity) which also scales proportionally to N . As a result, the solution of the model at large N follows from a true saddle-point principle, with controllable uctuations in 1=N. Hence, a detailed quantitative com parison of the large-N limit to the CFT results can be made. The saddle-point equations are coupled integral equations similar in structure to those of the NCA, except for the dierent handling of the constraint. The T = 0 in purity entropy and residual resistivity are obtained for the rst time in analytical form in this paper from a low-energy analysis of these coupled integral equations and shown to agree with the large-N limit of the CFT results. We also demonstrate that the spectral functions resulting from these equations take a universal scaling form in the limit!;T! 0, which is precisely that expected from the conform al invariance of the problem.

The Hamiltonian of the model considered in this paper reads:

In this expression,  $c_{pi}^y$  creates an electron in the conduction band, with m omentum p, channel (avour) index i=1; ;K and SU(N) spin index =1; ;N. The conduction electrons transform under the fundamental representation of the SU(N) group, with generators  $t^A$  (A = 1;  $^2$ ;N1). They interact with a localised spin degree of freedom placed

at the origin,  $S = fS^A$ ; A = 1;  $S^A = 1$ ;  $S^A =$ 

In the one-channel case (K=1), and when R is taken to be the fundam ental representation, this is the Coqblin-Schrie erm odel of a conduction gas interacting with a localised atom ic level with angular momentum j (N=2j+1) [9]. In this article, we are interested in the possible non-Ferm i liquid behaviour associated with the multi-channel generalisation (K>1) [1] [2]. We shall mostly focus on the case where R corresponds to antisymmetric tensors of Q indices, i.e the Young tableau associated with R is made of a single column of Q indices. In that case, it is convenient to use an explicit representation of the localised spin in terms of N species of auxiliary ferm ions f (F = 1; F ), constrained to obey:

so that the N  $^2$  1 (traceless) components of S can be represented as: S = f  $^+$  f  $\frac{Q}{N}$ . For these choices of R, the H am iltonian can be written as (after a reshu ing of indices using a Fierz identity):

In a recent paper [10], the case of a sym metric representation of the impurity spin (corresponding to a Young tableau made of a single line of P boxes) has been considered by two of us. In that case, a transition from overscreening to underscreening is found as a function of the \size" P of the impurity spin. In contrast, the antisym metric representations considered in the present paper always lead to overscreening (except for K = 1 which is exactly screened), as shown below. As long as only the overscreened regime is considered, the analysis of the present paper applies to sym metric representations as well, up to some straightforward replacements.

#### II.STRONG COUPLING ANALYSIS

It is easily checked that a weak antiferrom agnetic coupling  $(J_{K}>0)$  grows under renorm alisation for all K and N , and all representations R of the local spin. W hat is needed is a physical argument in order to determ inew hether the R  ${\cal G}$  ow takes  $J_{K}$  all the way to strong coupling (underscreened or exactly screened cases), or whether an intermediate non-Fermi liquid xed point exists (overscreened cases).

Following the Nozieres and Blandin [1] analysis of the multichannel SU (2) model, we consider the strong-coupling xed point  $J_K = +1$ . In this limit, the impurity spin binds a certain number of conduction electrons (at most N K because of the Pauli principle). The resulting bound-state corresponds to a new spin representation  $R_{sc}$  which is dictated by the minimisation of the K ondo energy. For the species choices of R above, we have proven that:

In the one-channel case (K = 1) and for arbitrary N and Q,  $R_{\rm c}$  is the \singlet" representation (of dimension d ( $R_{\rm sc}$ ) = 1). It is obtained by binding N Q conduction electrons to the Q pseudo-ferm ions f. The impurity spin is thus exactly screened at strong-coupling.

For all multi-channel cases (K = 2, arbitrary N and Q), the ground-state at the strong-coupling xed point is the representation R  $_{sc}$  characterised by a rectangular Young tableau with N = Q lines and K = 1 columns. Its dimension d (R $_{sc}$ ) (i.e the degeneracy of the strong-coupling bound-state) is larger than the degeneracy at zero coupling, given by d (R) =  $_{0}^{N}$  N  $\rightleftharpoons$  Q )!.

The Young-tableau associated with the strong-coupling state in both cases is depicted in Fig.1. The detailed proof of these statem ents and the explicit construction of  $R_{\rm sc}$  are given in Appendix A. These properties are su cient to establish that:

In the multi-channel case, a direct R  $\mathcal{G}$  ow from weak to strong-coupling is im possible, thereby suggesting the existence of an intermediate coupling xed-point (\overscreen-ing").

The connection between these statem ents and the above results on the nature and degeneracy of the strong-coupling bound-state is clear on physical grounds. Indeed, it is not possible to ow under renormalisation from a xed point with a lower ground-state degeneracy to a xed-point with a higher one, because the elective number of degrees of freedom can only decrease under R.G. Hence, no low away from the strong-coupling xed point is possible in the one-channel (K = 1) case since the strong-coupling state is nondegenerate. Also, no direct low from weak to strong coupling is possible for K  $= 2 \sin \alpha \, d(R_{sc}) > d(R)$ . These statements can be made more rigorous [6] by considering the impurity entropy defined as:

Where  $S_{bulk}$  denotes the contribution to the entropy which is proportional to the volume V (and is simply the contribution of the conduction electron gas), and care has been taken in specifying the order of the in nite-volume and zero-temperature limits. At the weak coupling xed point  $S_{imp}$  ( $J_K=0$ ) =  $\ln d(R)$ , while  $S_{imp}$  ( $J_K=1$ ) =  $\ln d(R_{sc})$  at strong-coupling.  $S_{imp}$  must decrease under renormalisation [6], a property which is the analogue for boundary critical phenomena to Zamolodchikov's \c-theorem " in the bulk. This suggests a R.G. ow of the kind indicated above. This conclusion can of course be con med by a perturbative calculation (in the hopping amplitude) around the strong-coupling xed-point [1].

The value of  $S_{im\ p}$  will be calculated below at the intermediate xed-point in the overscreened case, and found to be non-integer (as in the N = 2 case [6]).

#### III. CONFORM AL FIELD THEORY APPROACH

Having established the existence of an intermediate xed-point for K 2, we sketch some of its properties that can be obtained from conformal eld-theory (CFT) methods. This is a straightforward extension to the SU (N) case of A eck and Ludwig's approach for SU (2) [4,5]. The aim of this section is not to present a complete conformal eld-theory solution, but

 $\sin p \ln t$  to derive those properties which will be compared with the large-N explicit solution given below.

In the CFT approach, the model (1) is rst mapped at low-energy onto a 1+1-dimensional model of N K chiral fermions. At a xed point, this model has a local conformal symmetry based on the Kac-Moody algebra  $\$U_K$  (N) $_s$   $\$U_N$  (K) $_f$   $t^9$  (1) $_c$  corresponding to the spin-avour-charge decomposition of the degrees of freedom. The free-fermion spectrum at the weak-coupling xed point can be organised in multiplets of this symmetry algebra: to each level corresponds a primary operator in the spin, avour and charge sectors. A major insight [4] is then that the spectrum at the infra-red stable, intermediate coupling xed point can be obtained from a \fusion principle". Specifically, the spectrum is obtained by acting, in the spin sector, on the primary operator associated with a given free-fermion state, with the primary operator of the  $\$U_K$  (N) $_s$  algebra corresponding to the representation R of the impurity spin (leaving unchanged the avour and charge sectors). The \fusion rules" of the algebra determine the new operators associated with each energy level at the intermediate xed point.

This fusion principle also relates the impurity entropy  $S_{im\;p}$  as dened above to the \m odular S-m atrix"  $S_0^R$  of the  $S_0^IU_K$  (N) algebra (this is the matrix which species the action of a modular transformation on the irreducible characters of the algebra corresponding to a given irreducible representation R). Specically, denoting by R=0 the trivial (identity) representation:

The expression of the modular S-matrix for  ${}^{g}U_{K}$  (N) can be found in the litterature [11]. We have found particularly useful to make use of an elegant formulation introduced by Douglas [12], which is brie y explained in Appendices A and B. For the representations R associated to a single column of length Q (corresponding to (2)), one nds using this representation:

It is easily checked that indeed  $S_{im\ p} < Ind(R)$  for all values of N , Q and K . Note also that this expression correctly yields  $S_{im\ p} = 0$  in the exactly screened case K = 1 (for arbitrary N;Q).

The low-tem perature behaviour of various physical quantities can also be obtained from the CFT approach. At the intermediate coupling xed point, the local impurity spin acquires the scaling dimension of the primary operator of the  $\text{$^{5}$U}_{\text{K}}$  (N) algebra associated with the (N  $^2$  -1 dimensional) adjoint representation of SU (N). Its conformal dimension so (such that < S (0)S (t) >  $-1=^{2}$  s at T = 0) reads:

Integrating this correlation function, this implies that the local susceptibility  $_{loc}$  /  $_{0c}^{R_{1}=T}$  < S (0)S ( ) > d (corresponding to the coupling of an external eld to the impurity spin only) diverges at low temperature when K N, while it remains nite for K < N:

Exactly at the xed point, the singular contributions to the speci c heat and impurity susceptibility  $_{\text{im p}} = _{\text{bulk}}$  (de ned by coupling a magnetic eld to the total spin density) vanish [4,13]. Indeed, the singular behaviour is controlled by the leading irrelevant operator compatible with all symmetries that can be generated. An obvious candidate for this operator is the spin, avour and charge singlet obtained by contracting the spin current with the adjoint primary operator above,  $J_1 \sim .$  It has dimension  $1 + \frac{N}{N+K} = 1 + \frac{1}{s}$ . This leads to a singular contribution to the impurity susceptibility (arising from perturbation theory at second order in the irrelevant operator [4,13]) of the same nature than for  $\frac{1}{N}$  given in (8):

A nother irrelevant operator can be constructed in the avour sector in an analogous manner, namely  $\mathcal{J}^f_{\ 1}$  f. This operator has dimension K=(N+K), which is thus lower than the above operator in the spin sector when K< N. This operator could a priori contribute to the low-tem perature behaviour of the specic heat, which would lead to a divergent specic heat coe cient C=T for both K>N and K< N. On the basis of the explicit large- M calculation presented below, we believe however that this operator is not generated for model (1) when the conduction band  $d \circ S$  is taken to be perfectly at and the cuto is taken to in nity (conform al limit), so that the specic heat ratio has the same behaviour than the susceptibilities above: C=T  $d \circ K$  if the model is extended to an impurity spin with internal avour degrees of freedom, this operator will however show up (leading to C=T  $d \circ K$   $d \circ$ 

#### IV.SADDLE-POINT EQUATIONS IN THE LARGE-N LIM IT

We now turn to the analysis of the large-N lim it of this model. This will be done by setting:

$$K = N ; J_K = \frac{J}{N} (9)$$

and taking the lim it N ! 1 for xed values of , and J, so that the number of channels is also taken to be large. In Ref. [7] (see also [2]), Cox and Ruckenstein considered this lim it while holding Q xed (Q = 1). They obtained in this lim it identical results to those of the \non-crossing approximation" (NCA) [8]. Here, we shall proceed in a dierent manner by taking Q to be large as well:

This insures that a true saddle-point exists, with controllable uctuations order by order in 1=N. It will also allow us to study the dependence on the representation R of the local spin, parametrised by  $q_0$  [14]. The approach of Ref. [7] is recovered in the limit  $q_0$ ! 0 (or 1). The action corresponding to the functional integral formulation of model (3) reads:

In this expression, the conduction electrons have been integrated out in the bulk, keeping only degrees of freedom at the impurity site.  $G_0(i!_n)$   $_p 1=(i!_n _p)$  is the on-site G reen's function associated with the conduction electron bath. In order to decouple the K ondo interaction, an auxiliary bosonic eld  $B_i()$  is introduced in each channel, and the conduction electrons can be integrated out, leaving us with the electrons cation:

The quartic term in this expression can be decoupled formally using two bi-local elds Q (;  $^0$ ) and  $\overline{Q}$  (;  $^0$ ) conjugate to  $^p_{i}B_{i}^{y}(^0)B_{i}(^0)$ ) and  $^p_{i}$  fy () f ( $^0$ ) respectively, leading to the action :

The B and f elds can now be integrated out to yield:

This nalform of the action involves only the three elds Q,  $\overline{Q}$  and , and scales globally as N thanks to the scalings K=N and  $Q=q_N$ . Hence, it can be solved by the saddle-point method in the large-N limit. At the saddle-point,  $_{sp}()=i$  becomes static and purely imaginary, while  $Q_{sp}=Q$  (  $_{0}^{0}$ ) and  $\overline{Q}_{sp}=\overline{Q}$  (  $_{0}^{0}$ ) retain time-dependence but depend only on the time difference  $_{0}^{0}$  (they identify with the bosonic and ferm ionic self-energies, respectively).

The nal form of the coupled saddle-point equations for the ferm ionic and bosonic G reen's functions  $G_f()$  < Tf()f(0) > ,  $G_B()$  < TB()B(0) > and for the Lagrange multiplier eld read:

In these expressions  $!_n = (2n+1) = \text{ and }_n = 2n = \text{ denote ferm ionic and bosonic } M$  atsubara frequencies. Let us note that the eld B ( ) is  $\sin p \lg a$  commuting auxiliary eld rather than a true boson (its equal-time commutator vanishes). As a result  $G_B$  ( ) is a periodic function, but does not share the usual other properties of a bosonic G reen function (in particular at high frequency).

Finally, is determined by the third saddle point equation:

These equations are identical in structure to the usual NCA equations, except for the last equation (17) which implements the constraint and allows us to keep track of the choice of representation for the impurity spin.

#### V.SCALING ANALYSIS AT LOW FREQUENCY AND TEMPERATURE

#### A . G eneral considerations

The analysis of the NCA equations in Ref. [15] can be applied in order to  $\,$  nd the behaviour of the G reen's functions in the low temperature, long time regime dened by:  $T_{\kappa}^{1}$ 

! 1 (where  $T_K$  is the K ondo tem perature). In this regime, a power-law decay of the G reen's functions is found:

The overall consistency of (15,16) at large time also constrains the product of amplitudes  $A_fA_B$  (Eq.(C8) in Appendix C) and dictates the behaviour of the self-energies (denoting by  $_0 = -$  Im  $G_0$  (i0 $^+$ ) = the conduction bath density of states at the Ferm i level):

The expression (19) of the scaling dimensions  $_{\rm f}$  and  $_{\rm B}$  is in complete agreement with the CFT result. Indeed, the fermionic eld transforms as the fundamental representation of the  $\rat{SU}$  (N) $_{\rm K}$  spin algebra, while the auxiliary bosonic eld transforms as the fundamental representation of the  $\rat{SU}$  (K) $_{\rm N}$  avour algebra, leading to: 2  $_{\rm f} = \frac{N^2 - 1}{N \cdot (N + K)}$  and 2  $_{\rm B} = \frac{N^2 - 1}{N \cdot (N + K)}$  and 2  $_{\rm B} = \frac{N^2 - 1}{N \cdot (N + K)}$ 

 $\frac{K^2-1}{K(N+K)}$ , which agree with (19) in the large-N lim it. Also, the local impurity spin correlation function, given in the large-N lim it by hS (0)S ( )i /  $G_f$  ( )G $_f$  ( ) is found to decay as  $1=\frac{2}{3}$ , with  $_S=2$   $_f=1=(1+1)$  in agreement with the CFT result (7).

As will be shown below however, these asymptotic behaviours at T=0 do not provide enough information to allow for the computation of the low-temperature behaviour of the impurity free-energy and to determ ine the T=0 impurity entropy (4). One actually needs to determ ine the G reen's functions in the lim it; ! 1, but for an arbitrary value of the ratio = (i.e to analyze the low-temperature, low-frequency behaviour of (15,16) keeping the ratio !=T xed [17]). It is easily seen that in this lim it the G reen's functions and their associated spectral densities  $_{f;B}$  (!)  $^{\frac{1}{2}}$  Im  $_{f;B}$  (! +  $_{f}$  io bey a scaling behaviour:

In these expressions,  $g_{f;B}$  and  $_{f;B}$  are universal scaling functions which depend only on and  $q_0$  and not on the speci c shape of the conduction band or the cuto . These scaling functions will now be found in explicit form .

#### B. The particle-hole sym m etric representation $q_0 = 1=2$

We shall rst discuss the case where the representation R has Q = N = 2 boxes ( $q_0 = 1 = 2$ ), for which there is a particle-hole symmetry among pseudo-ferm ions under  $f^y$  \$ f . The expression of the scaling functions  $g_{f,B}$  in that case can be easily guessed from general principles of conformal invariance. The idea is that, in the limit  $T_K^{-1}$  with = -xed, the nite-temperature G reen's function can be obtained from the T = 0 G reen's function by applying the conformal transformation  $z = \exp(i2 - z)$  [16]. Applying this to the z = 0 power-law decay given by (18), one obtains the well-known result for the scaling functions (z = 0):

It is an interesting calculation, perform ed in detail in Appendix C, to check that indeed these scaling functions do solve the large-N equations (15,16) at nite temperature in the scaling regime. That NCA-like integral equations obey the nite-temperature scaling properties dictated by conform al invariance has not, to our know ledge, been pointed out in the previous litterature.

#### C.G eneral values of $q_0$

#### 1. Spectral asym m etry

Let us move to the general case of representations with  $q_0 \in \frac{1}{2}$  in which the particle-hole sym metry between pseudo-ferm ions is broken. The exponent of the power-law singularity in the T=0 spectral densities is not a ected by this asymmetry. It does induce however an asymmetry of the prefactors associated with positive and negative frequencies as! ! 0. We introduce an angle to parametrize this asymmetry, defined such that:

The therm all scaling function for the ferm ionic spectral density  $_{\rm f}$  and the bosonic one  $_{\rm b}$  are plotted in Fig.(2) for various values of the asymmetry parameter . We also note the expression for the maximally asymmetric case ! 1 (corresponding, as shown below, to  $q_0$ ! 0, i.e. to the limit Q N as in the usual NCA).

The reader interested in the details of these calculations is directed to Appendix C.

At this stage, the point which remains to be clarified is the explicit relation between the asymmetry parameter and the parameter q specifying the representation. This is the subject of the next section.

Before turning to this point, we brie y comment on the CFT interpretation of the asymmetry parameter (or ) associated with the particle-hole asymmetry of the fermionic elds. The form (23) of the correlation functions at nite temperature in the scaling limit can be viewed as those of the exponential of a compact bosonic eld with periodic boundary conditions. The asymmetric generalization (29) corresponds to a shifted boundary condition on the boson (i.e to a twisted boundary condition for its exponential).

#### 2. Relation between qo and

Let us clarify the relation between the spectral asymmetry parameter , and the parameter  $q_0$  specifying the spin representation. That such a relation exists in universal form is a remarkable fact: indeed is a low-energy parameter associated with the low-frequency behaviour of the spectral density, while  $q_0$  is the total pseudo-ferm ion number related by the constraint equation (17) to an integral of the spectral density over all frequencies. The

situation is similar to that of the Friedel sum rule in impurity models, or to Luttinger theorem in a Fermi liquid, and indeed the derivation of the relation between  $q_0$  and follows similar lines [19]. It is in a sense a Friedel sum rule for the quasiparticles carrying the spin degrees of freedom (namely, the pseudofermions f).

We start from the constraint equation (17) written at zero-tem perature as:

In this expression, the bosonic part (which vanishes altogether) has been included in order to transform further the terms involving derivatives of the self-energy, using analyticity. This transformation is only possible if both fermionic and bosonic terms are considered. This is because the Luttinger-W ard functional [19] of this model involves both G reen's functions. It has a simple explicit expression which reads:

## VI.PHYSICAL QUANTITIES AND COMPARISON W ITH THE CFT APPROACH

A. Im purity residual entropy at T = 0

The impurity contribution to the free-energy (percolour of spin)  $f_{imp} = (F F_{bulk}) = N$  reads, at the saddle point:

This expression can be derived either directly from the saddle-point e ective action (in which case the last term arises from the quadratic term in Q and  $\overline{Q}$ ), or from the relation between the free-energy and the Luttinger-W ard functional.  $F_{\text{bulk}} = N^2$  TTrlnG<sub>0</sub> is the free energy of the conduction electrons. In (47) the formulas TrlnG are ambiguous. We must precisely de newhich regularisation of these sums we consider: the actual value of the sums depends on the precise de nition of the functional integral. For the ferm ionic eld,

the standard procedure of adding and substracting the contribution of a free local ferm ion, and introducing an oscillating term to regularize the M atsubara sum holds:

The situation is somewhat less familiar for the bosonic eld. As pointed out above, the latter is merely a commuting auxiliary eld (rather than a true boson). We have found that the correct regularisation to be used is:

The factor of J takes into account the determ inant introduced by the decoupling w ith B, and a sym m etric de nition of the (convergent) M atsubara sum has been used. Some details and justic cations about these regularisations are given in Appendix (D).

We shall perform a low-tem perature expansion of Eq.(47), considering successively the particle-hole sym m etric (q<sub>0</sub> = 1=2) and asym m etric (q<sub>0</sub>  $\pm$  1=2) cases, which require rather dierent treatments.

### 1. The particle-hole sym m etric point $q_0 = \frac{1}{2}$

In this case = 0, so that the rst term in Eq.(47) does not contribute. Let us consider the last term in (47). Using the spectral representation of  $G_f$  and the de nition of  $G_f$  we obtain easily (for = 0):

W e substract the value at T = 0:

In the second term, we can replace  $_{\rm f}$  by its scaling lim it. So this term is of order O (T  $^{2-{\rm f}^{+}}$ 1). We know the asymptotics of  $_{\rm f}$ :  $_{\rm f}$ (x)  $_{\rm x!~1}$  C  $_{\rm 1}$ x  $^{2-{\rm f}}$   $^{1}$  + C  $_{\rm 2}$ x  $^{2-{\rm f}}$   $^{3}$ . We conclude that (T) = (0) + O (T  $^{2-{\rm f}^{+}}$ 1), so that the last term in (47) does not contribute to the zero-tem perature entropy in the particle-hole symmetric case.

Let us express the remaining terms in (47) as integrals over real frequencies, using the regularisations introduced above. As detailed in Appendix D, this leads to the following expression, involving the argument of the (nite-temperature) retarded G reen's functions:

At this point, it would seem that in order to perform a low-tem perature expansion of the free-energy, one has to make a Sommerfeld expansion of the Fermi and Bose factors. This is not the case however, for two reasons: i) the argument of the Green's functions appearing in (52) are not continuous at !=0, so that a linear term in T does appear (as expected from the non-zero value of  $S_{imp}$ ) ii) the Green's functions have an intrinsic temperature dependence, and the full scaling functions computed above must be used in (52). More precisely, when computing the dierence  $f_{imp}(T) = f_{imp}(T=0)$ , the leading term is obtained by replacing the Green's function by their scaling form (33).

These considerations lead to the following expression of the impurity entropy (per spin colour)  $s_{im p} = S_{im p} = N$  at zero-tem perature for  $q_0 = \frac{1}{2}$ :

This coincides with the large-N  $\lim$  it of the CFT result, Eq.(6), in the particle-hole sym m etric case.

#### 2. The general case $q_0 \in 1=2$

For  $q_0 \in \frac{1}{2}$ , the rst term in Eq.(47) also contributes to the entropy. Indeed, as shown below, the Lagrange multiplier (T) at the saddle-point has a term which is linear in temperature. This stems from a very general thermodynamic relation, which is derived by taking the derivative of Z with respect to  $q_0$  in the functional integral, leading to:

We shall directly use this equation in order to compute the residual entropy, by calculating the linear correction in T to , and then integrating over  $q_0$ . This method shortcuts the full low-tem perature expansion of the free-energy (as done in the previous section), which actually turns out to be quite a dicult task to perform correctly for  $q_0 \in 1=2$  [22]. In order to calculate this linear correction, we shall relate to the high-frequency behaviour of the ferm ion G reen's function. As  $f(i!_n) = 0$  when  $f(i!_n) =$

Hence, following the same reasoning than for above, the term in (65) is of order const.+ O (T  $_{f}$   $_{$

where A = @ g(0^+) + @ g( ) is the discontinuity of the derivative @ g. A re ects the particle-hole asymmetry of g and thus vanishes in the scaling limit. A ctually the derivative  $\frac{@A}{@T}$  also vanishes as T ! 0 as we now show. Consider rst sending the bare cuto to in nity (along with J) so as to keep the K ondo temperature xed. In this limit A takes the form: A = T f  $\frac{T}{T_K}$ . The low energy scaling limit, in which Eq. (29) holds, can be reached by xing T and sending  $T_K$  to in nity. Since g must become particle-hole symmetric in this limit, this implies that f(x) vanishes at small x. Hence, taking a derivative with respect to temperature, of A = T f  $\frac{T}{T_K}$  we not that  $\frac{@A}{@T}_{T=0}$  = 0. Thus we nally obtain:

A plot of the residual entropy and of the asymmetry parameter as a function of  $q_0$  is displayed on Fig.3.  $s_{\text{im }p}$  is maximal at  $q_0 = 1$ =2 and vanishes as  $q_0$ ! 0 as expected.

In this section, we have discovered that the spectral asym metry parameter (\twist") shares a fairly simple relation with the residual entropy, given by Eq.(67). These are two universal quantities, characteristic of the xed-point. Remarkably, also coincides with the term proportional to T in (while itself is non-universal, its linear term in T is). It is tempting to speculate that a deeper interpretation of these facts is still to be found.

#### B. Internal Energy and Speci c Heat

The low-tem perature behaviour of the internal energy in the large-N lim it can be obtained by two dierent methods. We shall brie y describe both since they emphasize dierent and complementary aspects of the physics.

In the rst method, we use the elective action in the form (11), before the decoupling with the auxiliary bosonic eld  $B_{\rm i}$ () is made. We thus have a quartic interaction vertex between the conduction electrons at the origin and the Abrikosov ferm ions representing the quasiparticles in the spin sector, which reads:

One can then perform a skeleton expansion of the free-energy functional in terms of the interacting G reen's functions for the pseudo-ferm ions and the conduction electrons,  $G_{\rm f}$  () and  $G_{\rm c}$  (). The rst-order (Hartree) contribution to this functional vanishes because the spin operator in (69) is written in a traceless manner. The next contribution, at second order, yields the most singular contribution at low temperature and reads:

At the saddle-point, the interacting conduction electron G reen's function is  $G_c()$  /  $G_f()G_B()$ , and hence its dominant long-time behaviour is:  $G_c()$  1= . Inserting this, together with  $G_f()$  1=  $^2$  f in (70), we see that the leading low-temperature behaviour to the energy reads  $E/c_1T^{4-f+1}+c_2T^2+$ , and hence to the specic heat coe cient:

which agrees with the CFT result described above. We note that there is a quite precise connection between this calculation and the CFT approach: the operator appearing in the K ondo interaction (69) acquires conformal dimension  $2(c_c + c_f) = 1 + 2c_f$  and has the appropriate structure of the scalar product of a spin current with the operator S (transforming as the adjoint). Therefore, it is the large-N version of the leading irrelevant operator associated with the spin sector, as described in Sec.III. It is satisfying that the leading low-T behaviour comes from the second-order contribution of this operator in this formalism as well. We note that for the simple K ondo model (1), in the scaling limit, the analogous irrelevant operator in the avour sector does not show up in the calculation of the energy in the large-N solution. We shall comment further on this point below.

The second method to investigate the internal energy is to push the low-tem perature expansion of the free-energy to higher orders. To this end, we need to compute higher-order terms in the expansion (22a) of the Green's functions in the scaling regime. This computation is detailed in Appendix C 3, and leads to:

Let us emphasize that the exponents appearing in this expansion are not symmetric between the bosonic and fermionic degrees of freedom. This is because we are dealing with the Kondo model for which the auxiliary eld (bosonic) propagator has no frequency dependence in the non-interacting theory. Also, the expansion given in (72) assumes a perfectly at conduction band in the limit of an in nite bandwith (conformal limit). Using this expansion into the expression (52) of the free-energy leads to a special heat coefficient: C = T  $c_0 T^{2-f-1} + c_1 T^{4-f-1} + c_2 + c_1 T^{4-f-1} + c_2 + c_1 T^{4-f-1} + c_2 + c_2 + c_3 T^{4-f-1} + c_3 T^{4-f$ 

We also note that this behaviour of the speci c heat is modi ed when an Anderson model version of the present model is considered (as in Ref. [7]). Because the non-interacting slave boson propagator has a frequency dependence, the exponents of the second-order terms as written in (72) are only correct for > 1 for the Anderson model. For < 1, the term  ${}^4 \ {}^f g_f^{(2)}(=)$  is replaced by  ${}^1 g_f^{(2)}(=)$ , while  ${}^1 g_B^{(2)}(=)$  is replaced by  ${}^4 \ {}^b g_B^{(2)}(=)$ . As a result, one nds a diverging speci c heat coe cient in both cases, with C=T T  ${}^{(1-1)=(+1)}$  for > 1 and C=T T  ${}^{(1-1)=(+1)}$  for < 1. The behaviour for < 1 is due to the leading irrelevant operator in the avor sector. Similarly, for < 1 in the Anderson model, the susceptibility associated with the avour (channel) sector  ${}^f$  is found to diverge [7], so that a nite W ilson ratio can still be de ned as T  ${}^f$ =C for < 1.

#### C.Resistivity and T-m atrix

In order to discuss transport properties, we de ne a scattering T -m atrix for the conduction electrons in the usual manner (for a single impurity):

where G and  $G_0$  denote the interacting and non-interacting conduction-electron G reen's functions, respectively. Taking a at particle-hole symmetric band for the conduction electron and denoting by  $_0$  the local non-interacting density of states, this yields the local conduction electron G reen's function in the form:

Following Ref. [5], we parametrize the zero-frequency  $\lim$  it of the T-m atrix in terms of a scattering amplitude  $S^1$  as:

 $S^1 = 1$  corresponds to no scattering at all, while  $S^1 = 1$  corresponds to maximal unitary scattering (i.e. =2 phase shift and vanishing conduction electron density of states at the

in purity site). In the overscreened case, as noted in [5],  $S^1$  is in general such that [5] j< 1, re exting the non-Ferm i liquid nature of the model, and the fact that the actual quasiparticles bear no resemblance to the original electrons. In addition here, we shall not a new feature: namely that  $S^1$  is in fact a complex number for non particle-hole symmetric spin representations (i.e  $q_0 \in [1-2)$ ).

We rst derive an expression for  $S^1$  for arbitrary N, K and spin representation  $Q = N q_0$  by generalizing to SU(N) the CFT approach of Ref. [5]. There, it was shown that  $S^1$  can be expressed as a ratio of elements of the modular S-matrix S, of the  $\$U(N)_K$  algebra. Denoting by 0 the identity representation, by F the fundamental representation (corresponding to a Young tableau with a single box) and by R the representation in which the impurity lives (Young tableau with a single column of Q boxes), one has [4,5]:

The evaluation of these elements of the modular S-matrix can be done along the same lines than the conformal eld theory calculation of the entropy, described above. Some details are given in Appendix B. The result is:

Notice that  $S^1$  has both real and imaginary parts in the absence of particle hole symmetry  $q_0 \notin \frac{1}{2}$ .

Let us take the large-N  $\lim$  it of this expression, with K = N = xed. This reads, to rst non-trivial order:

We now show how to recover this expression from an analysis of the integral equations of the direct large-N solution. Coupling an external source to the conduction electrons in the functional integral formulation of the model, it is easily seen that the conduction electron T-m atrix is given, in the large-N lim it, by:

We note that, in this scaling limit, the particle-hole asymmetry of the impurity G reen's function has been lost altogether: has cancelled completely in the dependence of G in this limit and is only present in the prefactor. Thus, only  $ReS^1$  can be extracted from the scaling limit, while  $Im S^1$  requires a more sophisticated analysis. Eq. (84) implies  $Im G = A_f A_B$ , and hence  $ReS^1 = 1 = 2^2 A_f A_B = 0$ . We make use of the expression (C8) derived in Appendix C for the product of amplitudes  $A_f A_B$  and obtain:

The details of these calculations are provided in Appendix E.

Combining (91,90,87,83) we nd agreement with the large N  $\lim$  it of  $S_1$  in Eq. (80).

For a dilute array of im purities (of concentration  $n_{\text{im p}}$ ), the conduction electron-selfenergy is given by  $(!+i0^+)'$   $n_{\text{im p}}T$  (!), to low est order in  $n_{\text{im p}}$ . As shown above, T (!) is given in the large-N approach by the Fourier transform of  $G_f$  ( ) $G_g$  ( ). The expansion (72) yields the long-time behaviour  $G_f$  ( )  $A_f = 2^{-f} + A_f^{(2)} = 4^{-f} + A_f^{(2)} = 4^{-f} + A_g^{(2)} = 4^{-f}$ 

From the fact that 2  $_{\rm f}$  + 2  $_{\rm B}$  = 1, this im plies: G  $_{\rm f}$  ( )G $_{\rm B}$  ( ) 1= + 1= $^{1+2}$   $_{\rm f}$  + . Hence the resistivity behaves as:

Where u is the impurity resistivity in the unitary limit. For the same reasons as above, the Anderson model result would lead to an exponent 2 u in the regime u < 1 [7].

D. The lim it of a large number of channels (! 1)

We nally emphasize that all the expressions derived above greatly  $\sin p$  lify in the  $\lim it$  of a large number of channels! 1. This is expected, since in this  $\lim it$  the non-Ferm i liquid intermediate coupling x and y point becomes perturbatively accessible from the weak-coupling one [1,24]. The physics of the x and y point can be viewed as an y almost free spin of x of the entropy (53), the G reen function y and the twist (46) are:

#### VII.CONCLUSION

In this paper, we have focused on the non-Ferm i liquid overscreened regime of the SU (N) SU (K) multichannel K ondo model. This model has actually a wider range of possible behaviour, which become apparent when other kinds of representations of the impurity spin are considered. In a recent short paper [10], two of us have studied fully symmetric representations corresponding to Young tableaus with a single line of P boxes. (This amounts

to consider Schwinger bosons in place of the Abrikosov ferm ions used in the present work). It was demonstrated that, in that case, a transition occurs as a function of the \size" P of the impurity spin, from overscreening (for P < K) to underscreening (for P > K), with an exactly screened point in between (P = K). The large-N analysis of the overscreened regim eP < K is essentially identical to that presented in the present paper for antisym m etric representations.

O bviously, an interesting open problem is to understand the physics of the model for more general impurity spin representations, involving both \bosonic" and \fem ionic" degrees of freedom (corresponding respectively to the horizontal and vertical directions in the associated Young tableau). CFT methods are a precious guide in achieving this goal. In particular, the form ulas and rules given in Appendices A and B allow for an easy derivation of the impurity T = 0 residual entropy and zero-frequency T-matrix, using A eck and Ludwig's fusion principle and the identication of these quantities in terms of modular S-matrices.

An open question which certainly deserves further studies is to identify which of these more general spin representations are such that a direct large-N solution of the model can be found. This question has obvious potential applications to the multi-impurity problem and K ondo lattice models.

During the course of this study, we learned of a work by A Jerez, N Andrei and G Zarand on the same model using the Bethe Ansatz method. Our results and conclusions agree when a comparison is possible (in particular for the impurity residual entropy and low-temperature behaviour of physical quantities).

#### APPENDIX A: THE STRONG COUPLING STATE

We now describe in more details the proof of the statements in Sec.(II) about the nature and degeneracy of the strong-coupling state R  $_{\rm SC}$ . For a general reference on the group theory material used in this appendix, the reader is referred e.g to R ef. [18]. Let us note N  $_{\rm Y}$  the number of electrons brought on the impurity site and by Y the Young tableau with N  $_{\rm Y}$  boxes associated with the representation in which the conduction electrons on the impurity site combine. Because of the Pauli principle, the length of any of its lines must be smaller than K (and hence N  $_{\rm Y}$  must be smaller than N K ). Indeed, we must antisymmetrise the wave function separately for each avour.

The Kondo energy is given by:

in which f denotes the pseudo-ferm ion and c the conduction electrons at the impurity site. W e can introduce the linear combinations:

in which  $C_2$  (Z) denotes the quadratic C asim ir operator of the representation Z. The representation  $R_{sc}$  is the speci c component of Y. R associated with the bound-state formed by the impurity spin and the conduction electrons at strong-coupling. We recall that R is a column of length Q in this paper.

We have to minimize E over all possible choices of Y and of  $R_{\rm sc}$ .

First let us recall that for a general representation Y ,  $C_2$  is given by :

(A 7) can be given a simple interpretation in terms of N \particles" occupying a set of fermionic levels. This interpretation was introduced in a slightly dierent form by D ouglas [12]. A simple construction of all allowed Young tableaus appearing in the tensor product Y R [18] can be given in this ferm ionic language. Starting with the diagram associated with Y, we choose Q particles and raise each of them by one level beginning with the one in

the highest level. (We note that, in the ferm ionic interpretation, adding a box to line i corresponds to raising the i-th particle up by one level). An example is given in Fig.(5). Let us denote by  $p_i$  the positions of the N \particles" in Y, and by  $p_i^0$  the new positions in a given allowed component of Y R. The K ondo energy is given by:

Thus the lowest energy is achieved for the smallest possible value of P. Since a given shift p ! p + 1 can only appear once in the sum (because double occupancies are forbidden and a given particle cannot be raised twice), the absolute minimum is obtained when we sum on all the lowest Q shifts. This implies that the diagram associated with Y has Q particles on the Q lowest levels (from Q to Q 1) and none on the Q-th level.

The upper part of the diagram (above level Q) is then determ ined by the maxim isation of N  $_{\rm Y}$ . Going back to the language of Young tableaus, the minimum is thus achieved when Y is a rectangle of height N Q and width K, and R $_{\rm SC}$  is given by the same tableau with the rst column removed.

Two cases must thus be distinguished:

For (K = 1) and for arbitrary N and Q ,  $R_{\rm sc}$  is the trivial (singlet) representation (of dim ension d (R  $_{\rm sc}$ ) = 1).

For (K = 2, arbitrary N and Q) the dimension d(R) is is larger than the dimension of R. Indeed, denoting by  $d_K$  (R<sub>sc</sub>) the dimension R<sub>sc</sub> for K-channels, we have the recursion relation (from the \hook law " [20]):




FIG.1. Young tableau corresponding to the strong-coupling state




FIG .2. Plot of  $_{\rm f}$  and  $_{\rm b}$  as a function of  $_{\rm t}$  for dierent values of the asym m etry parameter : = 0; 2; 5; 1 (  $_{\rm f}$  = :3)




FIG.3. Residual entropy  $s_{\text{im p}}$  and  $vs. q_0$  for = 1.5




FIG.4. An example of an SU (N ) Young tableau (for N = 5) and its associated ferm ionic representation




FIG.5. An example of the general composition rule explained in the text. We show the ferm ionic diagram associated with Y, the resulting ferm ionic diagrams and their transcription in terms of Young tableaus. (N is arbitrary in this example as evidenced by the  $\dots$ )
