# O verscreened multi-channelSU (N) K ondo m odel: large-N solution and conform al eld theory

#### Abstract

T hem ultichannelK ondo m odelw ith SU (N) spin sym m etry and SU (K) channel sym $m$ etry is considered. The im purity spin is chosen to transform as an antisym $m$ etric representation of $S U(\mathbb{N})$, corresponding to a xed num ber of A brikosov ferm ions ${ }^{P} f^{y} f=Q$. Form ore than one channel $(K>1)$, and all values of N and $Q$, the $m$ odel displays non Fe m i behaviour associated $w$ ith the overscreening of the im purity spin. U niversal low tem perature ther$m$ odynam ic and transport properties of th is non Ferm i liquid state are com puted using conform al eld theory $m$ ethods. A large $N$ lim it of the $m$ odel is then considered, in which $K=N \quad$ and $Q=N \quad Q$ are held xed. Spectral densities satisfy coupled integral equations in this lim it, corresponding to a (tim e-dependent) saddle-point. A low frequency, low -tem perature analysis of these equations reveals universal scaling properties in the variable $!=T$, in agreem ent w ith conform al invariance. The universal scaling form is obtained analytically and used to com pute the low -tem perature universal properties of the $m$ odel in the large-N lim it, such as the $T=0$ residualentropy and residual resistivity, and the critical exponents associated w ith the speci cheat and susceptibility. The connections w the thon-crossing approxim ation" and the previous work of $C$ ox and Ruckenstein are discussed.

## I. IN TRODUCTION AND M ODEL

M ultichannel K ondo im purity m odels $[\underline{1} \mathbf{1} \mathbf{1}, \underline{2}] \quad$ have recently attracted considerable attention, for several reasons. First, in the overscreened case, they provide an explicit exam ple of a nonFerm i liquid ground-state. Second, these $m$ odels can be studied by a variety of controlled techniques, and provide invaluable testing grounds for theoretical m ethods dealing w ith correlated electron system s . O ne of the m ost recent and fruitfuldevelopm ent in this respect hasbeen the conform al eld-theory approach developed by A edk and Ludw ig [4] in 6 IT. Finally, m ultichannel m odels have experim ental relevance to tunneling phenom ena in quantum dots and two level system s $\stackrel{\substack{3}}{-1}$, and possibly also to som e heavy-ferm ion com pounds $[\stackrel{[2}{2}]$.
In this paper, we consider a generalisation of the $m$ ulti-channel $K$ ondo $m$ odel, in whidh the spin sym m etry group is extended from $S U(2)$ to $S U(\mathbb{N})$. In addition, the m odelhas a SU (K ) sym m etry am ong the $K$ \channels" ( avours) of conduction electrons. W e focus here on spin representations which are such that the $m$ odel is in the non $F e r m$ i liquid overscreened regim e. W e shall derive in this paper several universal properties of this $S U(\mathbb{N}$ ) $\quad$ SU (K ) K ondo m odel in the low -tem perature regim e. Speci cally, we obtain: the zero-tem perature residual entropy, the zero-tem perature im purity resistivity and $T \mathrm{~m}$ atrix, and the critical exponents goveming the leading low -tem perature behaviour of the im purity speci c heat, susceptibility and resistivity.
$T$ hese results $w i l l$ be obtained using tw o di erent approaches. It is one of the $m$ ain $m$ otivations of this paper to com pare these two approaches in som e detail. First (Secin̄in ), we apply CFT m ethods to study the $m$ odel for general values of $N$ and $K$. Then, we study the lim it of large $N$ and $K$, $w$ ith $K=N=x e d$. This lim it was previously considered by Cox and Ruckenstein [T̄i], in connection w th the \non-crossing approxim ation" (NCA). $T$ here is a crucial di erence between our work and that of Ref. we keep track of the quantum number specifying the spin representation of the im purity by im posing a constraint (on the A brikosov ferm ions representing the im purity) which also scales proportionally to N . A s a result, the solution of the m odel at large N follow sfrom a true saddle-point principle, w ith controllable uctuations in $1=\mathrm{N}$. Hence, a detailed quantitative com parison of the large N lim it to the CFT results can be $m$ ade. The saddle-point equations are coupled integralequations sim ilar in structure to those of the NCA, except for the di erent handling of the constraint. The T = 0 im purity entropy and residual resistivity are obtained for the rst tim e in analytical form in this paper from a low-energy analysis of these coupled integral equations and shown to agree with the large N lim it of the CFT results. W e also dem onstrate that the spectral functions resulting from these equations take a universal scaling form in the lim it!;T! 0, which is precisely that expected from the conform al invariance of the problem.
The $H$ am iltonian of the $m$ odel considered in this paper reads:

In this expression, $\mathrm{c}_{\mathrm{pi}}^{\mathrm{y}}$ creates an electron in the conduction band, with m om entum p , channel ( avour) index $i=1 ; \quad ; K$ and $S U(\mathbb{N})$ spin index $=1 ; \quad ; N$. The conduction electrons transform under the fiundam ental representation of the $S U(\mathbb{N})$ group, with generatorst ${ }^{A}(A=1 ; \quad 2 ; N 1)$. They interact w ith a localised spin degree of freedom placed
at the origin, $S=f S^{A} ; A=1 ; \quad 2$; N1g which is assum ed to transform under a given irreducible representation $R$ of the $S U(\mathbb{N})$ group.
In the one-channel case ( $K=1$ ), and when $R$ is taken to be the fundam ental representation, this is the C oqblin-Schrie er m odel of a conduction gas interacting with a localised atom ic level with angular $m$ om entum $j(\mathbb{N}=2 j+1)$ $\bar{q}]$. In this article, we are interested in the possible non Ferm i liquid behaviour associated w ith the multi-channel generalisation ( $\mathrm{K} \gg 1$ ) [1] [1] [ tensors of $Q$ indices, i.e the Young tableau associated $w$ ith $R$ is $m$ ade of a single colum $n$ of $Q$ indioes. In that case, it is convenient to use an explicit representation of the localised spin in term sof species of auxiliary ferm ions $f(=1 ; \quad ; N)$, constrained to obey:

so that the $\mathrm{N}^{2} \quad 1$ (traceless) com ponents ofS can be represented as: $\mathrm{S}=\mathrm{f}^{+} \mathrm{f} \frac{\mathrm{Q}}{\mathrm{N}}$. For these choioes ofR , the H am iltonian can be w ritten as (after a reshu ing of indioes using a Fierz identity):

In a recent paper $[1] 0]$, the case of a sym $m$ etric representation of the im purity spin (corresponding to a Young tableau $m$ ade of a single line of $P$ boxes) has been considered by two of us. In that case, a transition from overscreening to underscreening is found as a function of the \size" $P$ of the im purity spin. In contrast, the antisym $m$ etric representations considered in the present paper always lead to overscreening (except for $\mathrm{K}=1 \mathrm{which}$ is exactly screened), as show n below. As long as only the overscreened regim e is considered, the analysis of the present paper applies to sym $m$ etric representations as well, up to som e straightforw ard replacem ents.

## II. STRONG COUPLING ANALYSIS

It is easily checked that a weak antiferrom agnetic coupling ( $\mathrm{J}_{\mathrm{K}}>0$ ) grow s under renorm alisation for all $K$ and $N$, and all representations $R$ of the local spin. W hat is needed is a physical argum ent in order to determ ine whether the R .G ow takes $J_{K}$ all the way to strong coupling (underscreened or exactly screened cases), or whether an interm ediate non Fe er i liquid xed point exists (overscreened cases).
Follow ing the N ozieres and B landin [ī] analysis of the multichannel SU (2) m odel, we consider the strong-coupling xed point $J_{K}=+1$. In this lim it, the impurity spin binds a certain num ber of conduction electrons (at most N K because of the Pauliprinciple). The resulting bound-state corresponds to a new spin representation $\mathrm{R}_{\mathrm{sc}}$ which is dictated by the $m$ in'm isation of the $K$ ondo energy. For the speci c choioes of $R$ above, we have proven that:

In the one-channel case ( $K=1$ ) and for arbitrary $N$ and $Q, R_{c}$ is the \singlet" representation (ofdim ension $d\left(R_{s c}\right)=1$ ). It is obtained by binding $N \quad Q$ conduction electrons to the $Q$ pseudo-ferm ions $f$. The im purity spin is thus exactly screened at strong-coupling.

For all multi-channel cases (K 2, arbitrary $N$ and $Q$ ), the ground-state at the strong-coupling xed point is the representation $\mathrm{R}_{\text {sc }}$ characterised by a rectangular Young tableau with $N \quad Q$ lines and $K \quad 1$ colum ns. Its dim ension $d\left(R_{c}\right)$ (i.e the degeneracy of the strong-coupling bound-state) is larger than the degeneracy at zero coupling, given by $d(R)={ }_{Q}^{N} \quad N!=Q!(\mathbb{N} \quad Q)!$.

The Young-tableau associated w ith the strong-coupling state in both cases is depicted in Fig'ㄱ․ T T he detailed proof of these statem ents and the explicit construction of $R_{\text {sc }}$ are given in A ppendix 'Ā.'. These properties are su cient to establish that :

In the one-channel case, the strong coupling xed point is stable under R.G., and hence the im purity spin is exactly screened by the $K$ ondo e ect.

In them ulti-channel case, a direct R G ow from weak to strong-coupling is im possible, thereby suggesting the existence of an interm ediate coupling xed-point (\overscreening").

T he connection betw een these statem ents and the above results on the nature and degeneracy of the strong-coupling bound-state is clear on physical grounds. Indeed, it is not possible to ow under renorm alisation from a xed point with a lower ground-state degeneracy to a xed-point w th a higher one, because the e ective num ber of degrees of freedom can only decrease under R.G.Hence, no ow aw ay from the strong-ooupling xed point is possible in the one-channel ( $K=1$ ) case since the strong-coupling state is nondegenerate. A lso, no direct ow from weak to strong coupling is possible for $K \quad 2 \operatorname{since} d\left(R_{s c}\right)>d(R)$. These statem ents can be $m$ ade $m$ ore rigorous [ $\left[\frac{\bar{\sigma}}{}\right]$

W here $S_{\text {bulk }}$ denotes the contribution to the entropy which is proportional to the volum e V (and is sim ply the contribution of the conduction electron gas), and care has been taken in specifying the order of the in nite-volume and zero-tem perature lim its. At the weak coupling xed point $S_{\text {im }}\left(J_{K}=0\right)=\ln d(R)$, while $S_{\text {im }}\left(J_{K}=1\right)=\operatorname{lnd}\left(R_{\text {sc }}\right)$ at strongcoupling. $S_{\text {imp }}$ must decrease under renom alisation [-ब̄], a property which is the analogue forboundary criticalphenom ena to Zam olodchikov's \c-theorem " in the bulk. This suggests a R.G ow of the kind indicated above. This conchusion can of course be con m ed by a perturbative calculation (in the hopping am plitude) around the strong-coupling xed-point ${ }_{-1}^{1 i 1}$ ].
T he value of $S_{\text {im }} \mathrm{p}$ ill be calculated below at the interm ediate $x e d$-point in the overscreened case, and found to be non-integer (as in the $N=2$ case 恛]).

## III. CONFORMALFIED THEORYAPPROACH

Having established the existence of an interm ediate $x e d$-point for $K$ 2, we sketch som e of its properties that can be obtained from conform al eld-theory (CFT) methods. This is a straightforw ard extension to the $S U(\mathbb{N}$ ) case of A eck and Ludw ig's approach for SU (2) [4],15]. T he aim of this section is not to present a com plete conform al eld-theory solution, but
sim ply to derive those properties which w ill be com pared w ith the large N explicit solution given below .
In the CFT approach, the model ( $\overline{1}_{1}^{1}$ ) is rst $m$ apped at low-energy onto a $1+1$-dim ensional $m$ odelof K chiral ferm ions. At a xed point, this $m$ odel has a local conform al sym $m$ etry based on the K acM oody algebra $S_{K} U_{K}(\mathbb{N})_{s} \quad S_{U_{N}}(\mathbb{K})_{\mathrm{f}} \quad$ 抱 (1) corresponding to the spin-avour-charge decom position of the degrees of freedom. The free-ferm ion spectrum at the weak-coupling xed point can be organised in $m$ ultiplets of this sym $m$ etry algebra: to each level corresponds a prim ary operator in the spin, avour and charge sectors. A m a jor insight $\left[\begin{array}{l}{[\overline{4}}\end{array}\right]$ is then that the spectrum at the infra-red stable, interm ediate coupling xed point can be obtained from a \fusion principle". Speci cally, the spectrum is obtained by acting, in the spin sector, on the prim ary operator associated with a given free-ferm ion state, w ith the prim ary operator of the $\mathcal{S}_{\mathrm{K}}(\mathbb{N})_{\mathrm{S}}$ algebra corresponding to the representation R of the im purity spin (leaving unchanged the avour and charge sectors). The \fusion nules" of the algebra determ ine the new operators associated w ith each energy level at the interm ediate xed point.
$T$ his fusion principle also relates the im purity entropy $S_{\text {im }}$ as de ned above to the $\backslash m$ odular S-m atrix" $S_{0}^{R}$ of the $S_{K}(\mathbb{N})$ algebra (this is the matrix which speci es the action of a modular transform ation on the irreducible characters of the algebra corresponding to a given irreducible representation R). Speci cally, denoting by $R=0$ the trivial (identity) representation:

 have found particularly usefulto $m$ ake use of an elegant form ulation introduced by D ouglas
 to a single colum $n$ of length $Q$ (corresponding to $(\underline{2}(\underline{2})$ ), one nds using this representation:

It is easily checked that indeed $\mathrm{S}_{\text {im }}<\operatorname{lnd}(\mathrm{R})$ for all values of $N, \mathrm{Q}$ and $\mathrm{K} . \mathrm{N}$ ote also that this expression correctly yields $S_{\text {im }}=0$ in the exactly screened case $K=1$ (for arbitrary N; Q).
The low -tem perature behaviour of various physical quantities can also be obtained from the CFT approach. At the interm ediate coupling xed point, the local im purity spin acquires the scaling dim ension of the prim ary operator of the $S_{U_{K}}(\mathbb{N})_{\mathrm{s}}$ algebra associated w ith the $\left(\mathbb{N}^{2} \quad 1\right.$ dim ensional) adjinint representation of $S U(\mathbb{N})$. Its conform aldim ension $s$ (such that $\langle S(0) S(t)\rangle \quad 1=t$ s at $T=0$ ) reads:

Integrating this correlation function, this im plies that the local susceptibility loc $/{ }_{0}^{\mathrm{R}_{1=\mathrm{T}}}<$ $S(0) S()>d \quad$ (corresponding to the coupling of an extemal eld to the im purity spin only) diverges at low tem perature when $\mathrm{K} \quad \mathrm{N}$, while it rem ains nite for $\mathrm{K}<\mathrm{N}$ :


Exactly at the xed point, the singular contributions to the speci $c$ heat and im purity susceptibility imp $=$ bulk (de ned by coupling a magnetic eld to the total spin density) vanish [4in]. Indeed, the singular behaviour is controlled by the leading irrelevant operator com patible $w$ ith allsym $m$ etries that can be generated. A $n$ obvious candidate for this operator is the spin, avour and charge singlet obtained by contracting the spin current with the adjoint prim ary operator above, $\mathcal{J}_{1} \sim$. It has dim ension $1+\frac{\mathrm{N}}{\mathrm{N}+\mathrm{K}}=1+\mathrm{s}$. This leads to a singular contribution to the im purity susceptibility (arising from perturbation theory at second order in the irrelevant operator [
im $\mathrm{p} \quad \mathrm{loc}$.
A nother irrelevant operator can be constructed in the avour sector in an analogousm anner, nam ely $\mathcal{J}^{\ddagger}{ }_{1} \sim_{£}$. This operator has dim ension $K=(\mathbb{N}+K)$, which is thus lower than the above operator in the spin sector when $\mathrm{K}<\mathrm{N}$. This operator could a priori contribute to the low -tem perature behaviour of the speci c heat, which would lead to a divergent speci c heat coe cient C=T for both $\mathrm{K}>\mathrm{N}$ and $\mathrm{K}<\mathrm{N}$. On the basis of the explicit largeN calculation presented below, we believe how ever that this operator is not generated for model (İ1) when the conduction band d.os is taken to be perfectly at and the cuto is taken to in nity (conform al lim it), so that the speci c heat ratio has the sam e behaviour than the susceptibilities above: $\mathrm{C}=\mathrm{T} \quad \mathrm{loc} \quad \mathrm{im} \mathrm{p}$. If the m odel is extended to an mpurity spin with intemal avour degrees of freedom, this operator $w$ ill how ever show up (leading to $\left.C=T \quad T^{(N} K\right)=(\mathbb{N}+K)$ for $K<N$ ). It also appears (see below) if an A nderson $m$ odel generalisation ofm odel ( $(\underline{1})$ ) is considered aw ay from particle-hole sym m etry.

## IV. SADDLEPOINTEQUATIONS IN THELARGE-N LIM IT

W e now tum to the analysis of the large N lim it of this m odel. $T$ his w ill be done by setting:

They obtained in this lim it identical results to those of the \non-crossing approxim ation" (NCA ) [GQ]. H ere, we shall proceed in a di erent m anner by taking $Q$ to be large as well:

This insures that a true saddle-point exists, w ith controllable uctuations order by order in $1=\mathrm{N}$. It will also allow us to study the dependence on the representation $R$ of the localspin,
 $T$ he action corresponding to the functional integral form ulation ofm odel ( $(\overline{3})$ reads:

In this expression, the conduction electrons have been integrated out in the bulk, keeping only degrees of freedom at the impurity site. $G_{0}\left(i!_{n}\right) \quad{ }_{p} 1=\left(i!_{n} \quad{ }_{p}\right)$ is the on-site $G$ reen's function associated w ith the conduction electron bath. In order to decouple the $K$ ondo interaction, an auxiliary bosonic eld $\mathrm{B}_{\mathrm{i}}(\mathrm{)}$ is introduced in each channel, and the conduction electrons can be integrated out, leaving us w ith the e ective action:

This nal form of the action involves only the three elds $Q, \bar{Q}$ and , and scales globally as N thanks to the scalings $\mathrm{K}=\mathrm{N}$ and $\mathrm{Q}=\mathrm{qN} . \mathrm{H}$ ence, it can be solved by the saddle-point $m$ ethod in the large N lim it. At the saddle-point, sp ( ) = i becom es static and purely im aginary, while $Q=Q\left(\quad{ }_{s p}\right)$ and $\bar{Q}_{s p}=\bar{Q}\left(\quad{ }^{0}\right)$ retain tim e-dependence but depend only on the tim e di erence ${ }^{0}$ (they identify w ith the bosonic and ferm ionic selfenergies, respectively).
The nal form of the coupled saddle-point equations for the ferm ionic and bosonic G reen's functions $G_{f}()<T f(\not) f(0)>, G_{B}()<T B() B(0)>$ and for the Lagrange multiplier eld read:

In these expressions $!_{n}=(2 n+1)=$ and $n=2 n=$ denote ferm ionic and bosonic $M$ atsubara frequencies. Let us note that the eld B ( ) is simply a commuting auxiliary eld rather than a true boson (its equal-tim e com $m$ utator vanishes). A $s$ a result $G_{B}()$ is a periodic function, but does not share the usual other properties of a bosonic $G$ reen function (in particular at high frequency).
Finally, is determ ined by the third saddle point equation :

These equations are identical in structure to the usual NCA equations, except for the last equation ( $\left(\overline{1} \overline{-1} \bar{i}_{1}\right)$ which im plem ents the constraint and allow s us to keep track of the choiae of representation for the im purity spin.

## V.SCALING ANALYSISAT LOW FREQUENCYAND TEMPERATURE

## A. G eneral considerations

The analysis of the NCA equations in Ref. [1] [1] can be applied in order to nd the behaviour of the $G$ reen's functions in the low tem perature, long tim e regim e de ned by: $\mathrm{T}_{\mathrm{K}}{ }^{1}$

## 2. Relation between $q_{0}$ and

Let us clarify the relation between the spectral asym $m$ etry param eter , and the param eter $\mathrm{g}_{\mathrm{p}}$ specifying the spin representation. That such a relation exists in universal form is a rem arkable fact: indeed is a low-energy param eter associated w th the low-frequency behaviour of the spectral density, while $q_{b}$ is the total pseudo-ferm ion num ber related by the constraint equation ( $\overline{1}_{1} \overline{1}_{1}$ ) to an integral of the spectral density over all frequencies. The
situation is sim ilar to that of the Friedel sum rule in im purity m odels, or to Luttinger theorem in a Ferm i liquid, and indeed the derivation of the relation between $q_{b}$ and follow $s$ sim ilar lines [1] $\overline{1}]$. It is in a sense a Friedel sum nule for the quasiparticles carrying the spin degrees of freedom (nam ely, the pseudoferm ions f ).

At this point, it would seem that in order to perform a low -tem perature expansion of the free-energy, one has to $m$ ake a Som m erfeld expansion of the Ferm iand B ose factors. T his is not the case how ever, for tw o reasons: i) the argum ent of the $G$ reen's functions appearing in $(\overline{5} \overline{2})$ are not continuous at $!=0$, so that a linear term in $T$ does appear (as expected from the non-zero value of $S_{\text {im }}$ ) ii) the $G$ reen's functions have an intrinsic tem perature dependenœe, and the full scaling functions com puted above $m$ ust be used in ( helin $^{2}$. M ore precisely, when com puting the di erence $f_{\text {imp }}(T) \quad f_{i m p}(T=0)$, the leading term is obtained by replacing the G reen's function by their scaling form ( $\overline{3} \overline{3} \overline{-1}$ ).

In this section, we have discovered that the spectralasym m etry param eter (\tw ist") shares a fairly sim ple relation $w$ ith the residual entropy, given by Eq. ( $\overline{6} \bar{\prime} \bar{\prime})$. These are two universal quantities, characteristic of the xed-point. Rem arkably, also coincides with the term proportional to $T$ in (while itself is non-universal, its linear term in $T$ is). It is tem pting to speculate that a deeper interpretation of these facts is still to be found.
B. Internal Energy and Speci c Heat
$T$ he low -tem perature behaviour of the intemal energy in the large N lim it can be obtained by two di erent $m$ ethods. W e shallbrie $y$ describe both since they em phasize di erent and com plem entary aspects of the physics.
In the rst $m$ ethod, we use the e ective action in the form (11), before the decoupling w th the auxiliary bosonic eld $\mathrm{B}_{\mathrm{i}}(\mathrm{)}$ ) is m ade. W e thus have a quartic interaction vertex between the conduction electrons at the origin and the A brikosov ferm ions representing the quasiparticles in the spin sector, which reads:

It is satisfying that the leading low -T behaviour com es from the second-order contribution of this operator in this form alism as well. $W$ e note that for the sim ple $K$ ondo $m$ odel $\left.\underline{1}_{1}^{1}\right)$, in the scaling lim $i$, the analogous irrelevant operator in the avour sector does not show up in the calculation of the energy in the large-N solution. W e shall com $m$ ent further on this point below .
$T$ he second $m$ ethod to investigate the intemalenergy is to push the low -tem perature expansion of the free-energy to higher orders. To this end, we need to com pute higher-order term s in the expansion ( $2 \overline{2} \overline{2} \bar{a})$ ) of the $G$ reen's functions in the scaling regim $e$. This com putation is detailed in A ppendix ' $\mathrm{C} \bar{I}_{1}^{\prime} 3$, and leads to:

Let usem phasize that the exponents appearing in this expansion are not sym $m$ etric between the bosonic and ferm ionic degrees of freedom. This is because we are dealing $w$ th the $K$ ondo m odel for which the auxiliary eld (bosonic) propagator has no frequency dependence in the non-interacting theory. A lso, the expansion given in (ī2̄) assum es a perfectly at conduction
band in the lim it of an in nite bandw ith (conform al lim it). U sing this expansion into the expression ( $\overline{5}-\overline{2}$ ) of the free-energy leads to a speci c heat coe cient: $\mathrm{C}=\mathrm{T} \quad \mathrm{C}_{0} \mathrm{~T}^{2} \mathrm{f}^{1}+$ $\mathrm{C}_{1} \mathrm{~T}^{4}{ }^{1}+\mathrm{C}_{2}+\quad . \quad$ The coe cientactually vanishes, so that the behavior in ( $\mathrm{IV}_{1}$ ) ${ }^{1}$ ) is recovered. The vanishing of $c_{0}$ was clear in the rst approach, where it followed from the absence of H artree term s . In the CF T approach, it is associated w ith the fact that the leading irrelevant operator does not contribute to the free energy at rst order. The vanishing of $\mathrm{C}_{0}$ im plies non trivial sum rules relating the scaling functions $g_{f ; B}$ and $g_{f ; B}^{(2)}$ (which we have not attem pted to check explicitly).
$W$ e also note that this behaviour of the speci $c$ heat is $m$ odi ed when an A nderson $m$ odel version of the present m odel is considered (as in Ref. $\left[\begin{array}{l}\eta \\ \hline\end{array}\right)$. Because the non-interacting slave boson propagator has a frequency dependence, the exponents of the second-order terms as written in (1̄2̄) are only correct for > 1 for the A nderson model. For < 1, the term $\quad{ }^{4}{ }_{\mathrm{f}}^{\mathrm{g}} \mathrm{g}_{\mathrm{f}}^{(2)}(=)$ is replaced by ${ }^{1} g_{f}^{(2)}(=)$, while ${ }^{1} g_{B}^{(2)}(=)$ is replaced by ${ }^{4}{ }^{\mathrm{b}} \mathrm{g}_{\mathrm{B}}^{(2)}(=)$. A s a result, one nds a diverging speci cheat coe cient in both cases, w ith $\mathrm{C}=\mathrm{T} \quad \mathrm{T}\left({ }^{1)=(+1)}\right.$ for $>1$ and $\mathrm{C}=\mathrm{T} \quad \mathrm{T}^{(1)}{ }^{(1+1)}$ for $<1$. The behaviour for $<1$ is due to the leading irrelevant operator in the avor sector. Sim ilarly, for $<1$ in the A nderson model, the susceptibility associated with the avour (channel) sector f is found to diverge [ī], so that a nite $W$ ilson ratio can still be de ned as $\mathrm{T}_{\mathrm{f}}=\mathrm{C}$ for $<1$.

## VII. CONCLUSION

In this paper, we have focused on the non Ferm i liquid overscreened regim e of the $\mathrm{SU}(\mathbb{N}$ ) SU (K ) multichannel K ondo m odel. This m odel has actually a wider range of possible behaviour, which becom e apparent when other kinds of representations of the im purity spin are considered. In a recent short paper [1]-10], two of us have studied fully sym $m$ etric representations corresponding to Y oung tableausw ith a single line ofP boxes. (T his am ounts
to consider Schw inger bosons in place of the A brikosov ferm ions used in the present w ork). It was dem onstrated that, in that case, a transition occurs as a function of the \size" P of the impurity spin, from overscreening (for $P<K$ ) to underscreening (for $P>K$ ), with an exactly screened point in between ( $\mathrm{P}=\mathrm{K}$ ). The large N analysis of the overscreened regim $e P<K$ is essentially identical to that presented in the present paper for antisym m etric representations.
O bviously, an interesting open problem is to understand the physics of the $m$ odel for m ore general im purity spin representations, involving both \bosonic" and \ferm ionic" degrees of freedom (corresponding respectively to the horizontal and vertical directions in the associated Y oung tableau). C F T m ethods are a precious guide in achieving this goal. In particular,
 rity $T=0$ residualentropy and zero-frequency $T-m$ atrix, using $A$ eck and Ludw ig's fusion principle and the identi cation of these quantities in term $s$ ofm odular $S-m$ atrioes.
A n open question whidn certainly deserves further studies is to identify which of these m ore general spin representations are such that a direct large-N solution of the model can be found. This question has obvious potential applications to the m ulti-im purity problem and K ondo lattioe m odels.
D uring the course of this study, we leamed of a work by A Jerez, N A ndreiand G Zarand on the sam e m odel using the B ethe A nsatz m ethod. O ur results and conclusions agree when a com parison is possible (in particular for the im purity residual entropy and low tem perature behaviour of physical quantities).

It is a rather strong constraint on the scaling function $f$ that this equation should hold, and it is satisfying that the explicit form obtained for $f$ does satisfy ( $\left.\overline{\mathrm{C}} \overline{1}_{1} \overline{\mathrm{~B}}_{1}\right)$. This proves that f is really a solution of the full system (15,16,17) in the scaling regim e at xed F .
