E ective eld theory approach to Bose { E instein condensation

A bstract

We consider the low-energy collective excitations at nite temperature of Bose(Einstein condensed gases (and liquids as well). A most general model-independent elective Lagrangian is written down according to a prescription obtained from the breakdown of the global symmetry U (1). To show how the theory predicts easily, we derive the momentum and temperature dependence of the damping of excitations by means of power counting as an example.

1 Introduction

Bose{Einstein condensation (BEC) was achieved in 1995 in a remarkable series of experiments on atomic vapors [1, 2], and has tremendously boosted both theoretical and experimental studies (for an up-to-date review, see, e. q., Dalfovo et al. [3]). Among others, the study of collective excitations in BEC gives us a great test on the nite-tem perature manybody theory of interacting Bose gases that has been developed over last several decades. It is well known that excitations associated with BEC have been well studied in the context of liquid ⁴He [4]. The sem i-phenom enological Landau hydrodynam ic theory is very successful, but it essentially leans on an ad hoc postulated Hamiltonian and the roles of Bose condensation and broken symmetry are not clear there [5]. This theory was justiled in a sense of microscopic arguments by Feynman [6]. On the other hand, beginning with the work of London [7], a m icroscopic theory of super uid ⁴He using eld theoretical m ethods has also been extensively investigated through a weakly interacting gas model [4]. The most important results obtained from this model are based on the presence of a Bose condensate, which breaks down the global symmetry U (1) of the system. In fact, the concept of broken symm etry originated in particle physics has been brought into the low temperature phenomena of super uidity and superconductivity rst by Anderson [8], and now it is believed that it controls much of dynamics of many-body systems.

In the m icroscopic study of a Bose condensed gas, one usually needs a detailed model like that of Bogoliubov, Beliaev [9], or Gross-Pitaevskii to explain the mechanism for a Bose condensate, and as a basis for approximate quantitative calculations, but not to derive the most important exact consequences of the spontaneous symmetry breakdown. (Of course, such a microscopic model itself is an approximation.) Yet, if the general features are in fact model independent consequences of the spontaneous breakdown of the U (1) symmetry, why can't we derive them directly from this breakdown by noting the most general exceptive Lagrangian of the system? An answer to this question is provided by a standard technique of modern quantumed held theory [10], called the exceptive eld theory approach to the symmetry breaking. It was applied to superconductivity [11, 12] where the fundamental properties of conventional superconductors such as Meissner except and ux quantization are derived directly from the spontaneous breakdown of electromagnetic gauge invariance without using a detailed model like that of Bardeen-Cooper-Schrie er (BCS) theory.

This paper aims to show that many important properties of low-energy excitations in a generic homogeneous Bose system can be essentially determined as the exact consequence of spontaneously broken symmetry without introducing unnecessary approximations. Assuming the U(1) invariance is spontaneously broken, we shall derive the most general elective Lagrangian of the system by performing procedures very much analogous to that of pion-nucleone ective eld theory [13] in quantum chromodynamics. The present paper gives an alternative derivation of the Popove ective Lagrangian that we used for calculating the damping rate of the excitation [14, 15]. As we shall see, the whole procedure is incredibly simple and straightforward, but also gives a feasible way of predicting some experimental observables. An example on the damping rate shall be given to show how the theory works easily. The purpose of the present work is twofold. First, it overs a deep way of justifying the Landau theory of quantum hydrodynamics and explaining why a weakly interacting gas

m odel can yield some meaningful results for strongly interacting super uid ${}^4{\rm H\,e.}$ Second, it shows a simple, powerful elective eld theory approach to investigating the excitation dynamics of a homogeneous Bose condensed system.

2 E ective Lagrangian

We start by considering a simple nonrelativistic many-body problem of spinless bosonic particles at nite temperature. In units of h 1 and h 1, its Euclidean action functional is given by [16, 17]

where = 1=T denotes the inverse of temperature. Here, we write x = (x;) and is the imaginary \time". All elds full the boundary conditions as of (x; +) = (x;). Obviously, the action (1) is Galilean-invariant, and is invariant under the global phase transform ations of group U (1),

with an arbitrary constant. This sym metry is known to be completely broken below some critical temperature T_c , i.e., a Bose{Einstein condensate appears with h i \in 0 [18]. The particle density and current associated with the sym metry are $J=(i=2m)({}^{y}r$ r ${}^{y})$, $J_4=i{}^{y}$ i, with the current conservation i@+r J=0:

A coording to our general understanding of spontaneously broken symmetries [10], any system described by an action with symmetry group G, when in a phase in which G is spontaneously broken to a subgroup H, will possess a set of G oldstone M odes, described by elds that transform under G like the coordinates of the coset space G=H. In our case, there will be a single G oldstone M ode described by a (M assless) real scalar eld (M) that transform sunder G=U (1) like the phase itself. The group U (1) has the M ultiplication rule G (M) will undergo the transform ation

In low tem perature physics, the Goldstone mode is accompanied with another excitation, known as the density (order parameter) uctuation, which we will see to have nearly zero frequency in the long-wavelength limit. Both together form a non-trivial irreducible linear representation of the group U (1). To see the theory must involve the Goldstone elds, we may write allordinary complex elds as [19]

If the U (1) sym m etry is broken, we have $_0$ jh $_{\dot{1}}\dot{j}$ $\stackrel{?}{=}$ 0 where h $_0$ indicates the expectation value over the ground state. It follows that we may write $(x) = _0 + _0 + _0 (x)$, where the eld describes density uctuations, known also as collective modes. The elective Lagrangian for and then reads

where we have ignored all total derivatives. For later use, we record the current conservation in terms of and explicitly:

Here is an important point: to derive Eq. (6) it was not really necessary to start with the model Lagrangian (2). Indeed, according to our understanding of spontaneously broken sym m etry, we did not need to start with any speci c theory. A fam iliar example in particle physics is the e ective theory of pion-nucleon interaction with SU(2) SU(2) spontaneously broken to SU (2). The important thing is that Eq. (6) is invariant under the U (1) transform ation. The general theory of broken symmetries (see, for example, Weinberg [10]) tells us that, for sym metry group U (1), the most general form of the e ective Lagrangian for the density uctuation eld and the Goldstone eld must be constructed solely from the ingredients , r , @ , r and @ together with higher derivatives of these objects. There are also two additional rules that the Lagrangian must obey. The rst rule is the Galilean invariance for a non-relativistic system such that the combination of ill $(r)^2=2m must$ always appear together in the e ective Lagrangian and likewise il (1=m)r This has been understood through investigations by Takahashi [21] and G reiter et al. [22]. The second rule is the time-reversal symmetry such that the action is invariant under the transform ation

This is observed from the action (1). This symmetry requires that only the even powers of the Galilean invariant [iii (1=m)r r] be included in the Lagrangian. For instance, the possible lowest power of it is [iii (1=m)r r^2 .] This is equivalent to have terms of [($_0$ +) $_r^2$ =m] by making use of the current conservation (7) [23].

Hence, according to the above prescription the most general U (1)-invariant action functional takes the following form

The term s indicated by will contain higher powers and/or derivatives of the and/or elds. Any term of a total derivative has been ignored. The coe cients F; F0; F

which is one form of the Landau-Khalatnikov hydrodynam ic Hamiltonian [26]. Hence, the Landau quantum hydrodynam ics is the exact consequence of the breakdown of the U (1) symmetry.

3 Power Counting

M any-body properties can be studied through propagators (or G reen's functions). In the following, we write and elds into a real 2-component scalar

The calculation of propagators is simplied by transforming to momentum basis via the following Fourier transformation

We shall consider the low momentum-energy region such that k k_0 k_0

with the phonon velocity c $(1=m)^q \frac{q}{F} c_2 = (1 F^0 c_2)$. Notice that the energy spectrum is linear in k, vanishing as k ! 0.

In the calculation of Feynm an diagram s at nite tem peratures in Euclidean eld theory, one encounters the sum mation over discrete Matsubara frequencies. A standard technique (see, for example, [27]) is available to perform such a Matsubara summation. The trick is

to use a contour integral in the complex energy plane. Let h(!) be a function of complex variable !, analytical on the line Re! = 0, which decreases faster than 1=j! jas j! j ! 1. We then have

and the C is a contour in complex !-plane encircling all poles of function h(!) in a positive sense (but those of function f(!) in a negative sense).

Now consider a general process involving arbitrary numbers of the Goldstone eld and the density uctuation eld. We suppose that their energies and momenta and the thermal energy (T) are all at most of some order K, which is small compared with k_0 dened above. Even though Lagrangians like (9) are not renormalizable in the usual sense, we saw in, for example, the pion-nucleon theory [10] that such Lagrangians can yield nite results as long as they contain all possible terms allowed by symmetries, for then there will be a counterterm available to cancel every in nity. If we denote the renormalized values of the constants F; F^0 ; $F^$

Each derivative in each interaction vertex contributes one factor of K to the order of m agnitude of the diagram; internal propagators $_{11}$ (k), $_{12}$ (k) (= $_{21}$ (k)), and $_{22}$ (k) contribute factors of K 2 , K 1 and a unit, respectively; and each integration volume d^4k ($d^3kd!$) associated with the loops of the diagram contributes a factor of K 4 . So a general connected diagram make a contribution of order K , where

Here d_i is the number of derivatives in an interaction of type i, V_i is the number of interaction vertices of type i in the diagram, I and I are the numbers of internal lines and – cross lines, respectively, and L is the number of loops. There is a familiar topological relation for connected graphs:

where $_{\rm i}$ is the number of Goldstone elds in interactions of type i and E is the number of external lines. Elim inating the quantity I , the two topological equations above give

The important point here is that the coe cient d_i in the rst term is always positive or zero. Hence, with the numbers of loops and external—lines xed, the leading terms are those graphs of d_i is 0. The interactions that satisfy this condition are of no derivatives




Figure 1: Feynm an diagram s of propagators, vertices, and the one-loop selfenergy . Notations are k = (k; !) and y = (;) with G reek indices ; ; = 1;2.

of the $\,$ eld, noticing that the G oldstone $\,$ elds always appear with derivatives. Next, we shall see the power counting (21) provides us a tool that ensures that only $\,$ nite number of term s of L $_{\rm e}$ $\,$ are necessary.

4 Low-energy Excitation Spectrum

Let us now apply thism ethod to the calculation of higher order corrections to the propagator,

where the matrix (k) denotes the self-energy connected graphs. The lowest order correction shall be from the graphs of one loop with L=1 in Eq. (21), to which only cubic interactions of the Lagrangian (9) contribute. The following are all cubic interactions that concern us:

(The vertices and the one-loop diagram of are depicted in Fig. 1.) In the following, we will show how some fundamental low temperature properties of low energy excitations can be easily derived without complicated calculations.

The spectrum of excitations is given by the poles of the exact propagators (G reen's functions) that are solutions to the following equation

From this expression, the spectrum can be obtained by analytically continuing it to values of! that are not M atsubara frequencies by doing i! ! ! + i (0), but of course this shall only be done after the M atsubara frequency sum . From the free propagator expression (16), the (real) leading term of the spectrum is obviously given by ! = (k), and we shall approximate Re! = (k) as far as only the lowest corrections are concerned. Thus the spectrum is given in the following form

Now our task is to not the leading order of the imaginary part of the spectrum, called the damping rate \cdot . A flor some elementary algebras, keeping only leading order in k, Eqs. (15) and (23) yield

with $_{12}$ (k) = $_{21}$ (k). One can verify that Eq. (25) can reduce to the speci c forms previously presented in Refs. [19, 14]. Rather than go on to really calculate all elements of the self-energy matrix, we shall try to quickly derive the temperature and momentum dependences of the damping by using the power counting formula (21).

At T = 0, the typical momentum scale K is just the momentum k of a excitation that is carried into graphs through external lines. From the expression (21), we nd

We therefore have determ ined (k) up to some coe cient that only depends on something other than k (e.g., the interaction strength). Expression (26) agrees with the well-known result rst derived by Beliaev in 1958 [9] for a weakly interacting dilute gas model by calculating the Green's function till the second order approximation. However, our result has been derived without assuming a weak coupling, so it is valid for general Bose condensed liquids including super uid ⁴He.

For tem perature such that ck T ck_0 , we can follow the same arguments as we had for T=0, but some additional examination on diagrams is demanded in order to get the correct k and T dependences of . Each self-energy element carrying a momentum k yields a contribution of order K, which for $T \in 0$ can be decomposed into $K = k^l T^{-l}$ (l=0;1;;). For tem perature regime concerned here, the k-dependence of the arises only from those vertices that are associated with external (input) momenta after taking of the -function dependence from the vertex expression (22). Hence, k^l can be determined by simply counting the power of external (input) momenta from each vertex. In other words, l is equal to the number of external lines attached to each graph. Thus,

Again, in the context of a weakly interacting dilute Bose gas model, this remarkable result was rst implied by Mohling and Morita [28] and explicitly obtained by Hohenberg and Martin [29] and by Popov [19]. However, our result is universally true for a generic system of scalar bosons in low temperature and low energy, free of the assumption of weak coupling and low density. That implies that the result (27) also holds for liquid ⁴He.

The low-energy excitation spectrum (24) is called phonon spectrum and has an important property: the excitation frequency is equal to zero for zero m om entum to all orders in interactions, which means that the spectrum does not exhibit an energy gap. This is known as the Hugenholtz-Pines theorem [30] that was proved in perturbation eld theoretical analysis. It has played a crucial role in the early study of super uidity. Here we gain another understanding of this property. It is known from both microscopic theories [31, 32] and super uid hydrodynam ics [29] that, if $T < T_c$, the quasiparticle excitations have exactly the sam e spectra as collective excitations (described here by the eld) in the long wavelength lim it. Further, the e ective Lagrangian (9) dictates that the Goldstone mode collective mode possess the same pole structure up to all orders in all interactions allowed by symmetries. This statement is implied by Eq. (23). For the Goldstone theorem protects all kinds of excitations in low temperature and low momentum limit from having energy gap, their spectrum must be of phonon type. In this point of view, the Hugenholtz-Pines theorem can be simply understood as the equivalent statement of the nonrelativistic version of the Goldstone theorem [33, 34] for the special case of a dilute Bose gas.

We conclude here that the elective eld theory approach to the study of collective excitations in BEC makes the role of the Bose (Einstein condensate (or broken U (1) symmetry) evident, and gives us a model-independent elective action that can immediately predict results for experiments. We expect the approach to be very productive and fundamental if one can conduct it for trapped alkalivapors that are currently under extensive investigation. Yet, the inhomogeneity of the systems due to a trap potential shall alter our results.

A coordingly, there would be a term of (ii) 2 appearing in the quadratic e ective action (11) below, which would lead to an additional! 4 -term in evaluating the energy spectrum from Eq. (15). However, such a quartic term could be eliminated in comparison with quadratic terms since we are considering the lowest energy excitations. Thus, we would still have a linear spectrum and would derive the same power counting rule as (21). However, the rule would tell us that we do not need include any derivatives of from the beginning at all.
