# M etastable States in CA m odels for Tra cF low

A bstract. M easurem entsoftra c ow show the existence of m etastable states of very high throughput. These observations cannot be reproduced by the CA m odel of N agel and Schreckenberg (N aSch m odel), not even qualitatively. Here we present two variants on the N aSch m odel with m odi ed acceleration rules ('slow-to-start' rules). A lthough these m odels are still discrete in tim e and space, di erent types of m etastable states can be observed.

#### 1 Introduction

Simulation results of the CA model for trac ow introduced by Nagel and Schreckenberg [1] (NaSch model, for a detailed explanation see [1,2]) show a reasonable agreement with experimental data, although the model de nition includes only a few simple update rules. Due to its simplicity it can be used very e ciently for computer simulations, but also an analytical treatment is possible [2].

One important experimental result [3] which cannot be gained from the NaSch model is the occurance of metastable states near the density of maximum ow.Very recently such states have been found in a modied version of the NaSch model where a limited braking capacity of the cars and a continuous space is considered [4]. The continuous space allows very smallam plitudes of the uctuations compared to the discrete NaSch model. Therefore one could ask if a continuous space is necessary to obtain metastable states.

Here we present the results of a num erical investigation of two variants on the N aSch m odelw ith m odi ed acceleration rules, which are still discrete in time and space. First, we assigned a larger braking probability to stopped cars and second, we analysed the m odi cation suggested by Takayasu and Takayasu [5]. It turns out that m etastable states can be found in both cases.

## 2 NaSch model with 'slow-to-start' rule

In this part of the investigation we consider the NaSch model with maximum velocity  $v_{m ax} = 5$  and braking probability p = 0.01 of the moving cars. In

contrast to the originalm odel, a higher value  $p_s = 0.5$  of the braking probability is assigned to stopped cars.




Fig.1.Fundam entaldiagram of the modi ed N aSch model ( $v_m a_x = 5, p_s = 0.5, p = 0.01, L = 10000$ ).

We perform ed simulation runs for periodic systems containing L = 10000 lattice sites. This system size is su cient to exclude nite size e ects for the chosen set of parameters. Fig. 1 shows the fundamental diagram of the modi ed


m odel.O by iously the average ow J() can take two values in the density interval between  $_1$  and  $_2$  dependent on the chosen initialisation. The larger values of the average ow can be obtained using a hom ogeneous initialisation of the system. The lower branch is obtained starting from a complete jammed state. Moreover varying the particle number adiabatically, one can trace a hysteresis loop. One gets the upper branch by adding cars to the stationary state with  $< _1$  and the lower one by removing cars from the stationary state with  $> _2$ . For a xed value of p,  $J = J(_2) - J(_1)$  depends linearly on  $p_s$  for wide a range of parameters.

The m icroscopic structure of the jam m ed states in the m odi ed m odeldi ers from those found in the N aSch m odel. W hile jam m ed states in the N aSch m odel contain w ith an exponential size-distribution [2], one can nd phase separation in the m odi ed m odel. The reason for this behaviour is the reduction of the out ow from a jam. Therefore the density in the free ow regime is smaller than the density of m axim um ow and cars can propagate freely in the low density part of the lattice. D ue to the reduction of the density in the free ow regime, no spontaneous form ation of jam s is observable in the stationary state, if uctuations in the free ow regime are rare.

This picture can be con med by a simple phenom enological approach.0 bviously the ow in the hom ogeneous branch is given by  $J_h = (v_{m \ ax} \ p) = v_{f}$ , because every car can move with its desired velocity  $v_{f}$ . A ssum ing that the high density states are phase separated, we can obtain the second branch of the fundam ental diagram . The phase separated states consist of a large jam and a free ow regime, where each carm oves with velocity  $v_f$ . The density in the free ow regime  $_f$  is determined by the average waiting time  $T_w = \frac{1}{1 p_s}$  of the rst car in the jam and  $v_f$ , because neglecting interactions between cars the average distance of two consecutive cars is given by  $x = T_w v_f + 1 = _f^{-1}$ . U sing the norm alisation  $L = N_J + N_F x$  (N  $_F$  (J) number of cars in the free ow regime (jam)) we not that the ow is given by

Obviously  $_{\rm f}$  is precisely the branching density  $_1$ , because for densities below  $_{\rm f}$  the jam length is zero. It should be noted that this approach is only valid if (p\_s  $_{\rm p}$ ) and v\_m\_{\rm ax} > 1 holds. Sm all values of p have to be considered in order to avoid interaction between cars due to the velocity uctuations and v\_m\_{\rm ax} > 1, because otherw ise cars can stop spontaneous in the free ow regime and therefore initiate a jam.

M easurements of the average ow show that the lower branch of the fundamental diagram is not stable near the density  $_1$ . Therefore we performed a more detailed stability analysis of the homogeneous and the jammed state near  $_1$  and  $_2$ . Near  $_1$  the large jam present in the initial conguration resolves, the average length decays exponentially in time (Fig. 2). It should be noted that this behaviour is not the consequence of a continuous "melting" of the large jam. In contrast, the jam length is strongly uctuating without any systematic time-dependence. Once a homogeneous state without a jammed car is reached, no jam appears again. Therefore the homogeneous state is stable near  $_1$ .




Fig.3. Space-time diagram of the modi ed NaSch model for = 0:15;L = 400;p = 0:01 and  $p_s = 0:5$ . The hom ogeneous initial state is not destroyed in - mediately, but after approximately 90000 lattice updates. In the out ow regime of the jam the density is reduced compared to the average density.

A nalogous to the m etastable jam m ed states near  $_1$ , hom ogeneous initialisations for densities slightly above  $_2$  lead to m etastable hom ogeneous states with short lifetim es. F ig. 3 shows the spontaneous form ation of jams due to velocity uctuations. The nite lifetim es of the hom ogeneous states are the qualitative di erence between this model and the cruise-control lim it [6], where the tim e evolution of hom ogeneous states at low densities is completely determ inistic.

# 3 $T^2 m odel$




Fig.4. Fundamental diagram of the T<sup>2</sup> model ( $v_{m ax} = 1, p = 0.5, p_t = 1$ ) for two system sizes. For densities slightly above = 0.5 the stationary state could only be reached for the small system.

Takayasu and Takayasu ( $T^2$ ) [5] suggested a cellular autom aton m odel with another type of a slow-to-start rule, which is de ned as follows: A standing car with exactly one empty cell in front of it accelerates with probability  $q_t = 1$  p, while all other cars accelerate determ inisticly. The other update rules of the N aSch m odel are unchanged. D ue to this modi cation already for  $v_{m ax} = 1$  the particle-hole symmetry is broken. In Fig. 4 we show the fundamental diagram for  $v_{m ax} = 1$ , p = 0.5 and  $p_t = 1$ , i.e. stopped cars can only move if there are at least two empty cells in front of it. O bviously completely blocked states exist for densities 0.5, where the number of empty cells in front of each car is smaller than two. Since uctuations are absent in those states, they have an in nite lifetime. Therefore the ow in the stationary state is zero.

A lthough the states with a nite ow are not stationary, typically one has to perform an extrem ely large number of update steps until the ow vanishes for large system sizes and densities slightly above = 0.5, because the number of blocked con gurations is very sm all compared to the total number of con g-

urations. Precisely at = 0.5, the blocked state is unique and the typical time to reach this state diverges exponentially with the system size. Therefore we used very sm all system s in order to obtain the lower branch of the fundamental diagram.

Another interesting feature is the form of the fundam ental diagram. There is some experimental evidence that in certain situations the shape of the fundam ental diagram diers from the standard convex form. This behaviour of the average ow can be easily obtained tuning the parameter  $p_t$  [2,7].

### 4 Sum m ary

The numerical analysis of two modi cations of the NaSch model shows that metastable states can also be found in CA models for trac ow.

The N aSch m odel with 'slow-to-start' rule shows the coexistence of phase separated and hom ogeneous states in a density interval near the density <sub>2</sub> of m axim um ow.Near <sub>2</sub> interactions between cars become important and one can nd spontaneous form ation of jams. Therefore the reduction of the density in the out ow regime of a jam leads to stable phase separated states. The reduction of interactions between cars in the free ow regime can be con rm ed by a phenom enological approach, which gives very accurate results. In contrast to the cruise-control lim it of the N aSch m odel [6], where also m etastable states can be found, uctuations are present in both coexisting states. Finally we mention that this modi ed version of the N aSch m odel can reproduce the fundam ental diagram of the spacecontinuous approach by K rau et.al. [4].

In the  $p_t = 1$  lim it of the T<sup>2</sup> model we nd metastable states for densities beyond = 0.5.For & 0.5 states with a nite ow have very large lifetimes, but if the system reaches a blocked state these states are stable because of the absence of uctuations. Therefore the  $p_t = 1$  lim it of the T<sup>2</sup> m odel is complementary to the cruise-control lim it of the NaSch m odel, where one nds the absence of uctuations for hom ogeneous states at low densities.

These modi cations of the NaSch model show that CA models for trac can reproduce a broad spectrum of experim ental results although the update rules oversim plify the individual behaviour of the drivers.
