Phase diagram of a stochastic cellular automaton with long-range interactions

A stochastic one-dimensional cellular autom aton with long range spatial interactions is introduced. In this model the probability state at time to fagiven site depends on the state of all the other sites at time to 1 through a power law of the type 1=r, r being the distance between sites. For ! 1 this model reduces to the Domany-K inzel cellular automaton. The dynamical phase diagram is analyzed using M onte Carlo simulations for 0 1. We found the existence of two dierent regimes: one for 0 1 and the other for > 1. It is shown that in the rst regime the phase diagram becomes independent of . Regarding the frozen-active phase transition in this regime, a strong evidence is found that the mean eld prediction for this model becomes exact, a result already encountered in magnetic systems. It is also shown that, for replicas evolving under the same noise, the long-range interactions fully suppress the spreading of damage for 0 1.

I. IN TRODUCTION

The D om any-K inzel cellular autom aton 1 (D K herein) has been vastly studied in the last years. Its combined simplicity and rich dynam ical behavior make it a prototype for studying and testing dierent theoretical aspects of complex systems, such as dynam ical critical properties 2 , directed percolation $^{1;3}$ and spreading of damage $^{4;5}$ properties. The D K model consists in a one dimensional lattice with binary variables associated to each site i ($S_i = 0$: \dry " or \death" state and $S_i = 1$: \active state). The system evolves at discrete time, with the state of each site depending stochastically on the congulation of its two nearest neighbor sites at the previous time, independent of the other sites at the same time. In other words, the interactions in the D K model are local or short ranged both in space and time. Then, the dynamics of the model is dened by four independent parameters, namely, the transition probabilities corresponding to the four dierent congulations of the nearest neighbors of any site.

A simple version of the model is obtained by equaling to zero the probability of any site to be in the active state given that its neighbors were both in the death state (which de nes a so-called \legal" rule of evolution), and considering only one value for the probability of the site to be in the active state given that only one of its neighbors were in the active state, independent of which one. This leads to a two-param eter model which contains most of the com plex behavior of the model. Dom any and Kinzel showed that this model presents a continuous transition between a \frozen" phase where all the sites are in the death state (this is an absorbing state from which the system cannot scape once it is reached) and an \active" phase with a constant average fraction of sites in the active state. Som e years after M artins et al showed⁴, using the spreading of dam age technique, that the active phase is divided two regions: one in which the system presents sensitivity to the initial conditions and one in which it does not. Such regions were interpreted as dynamical phases and the transition between them was shown to be a continuous one. The sensibility to initial conditions is studied by looking at the time evolution of the Hamming distance between two replicas of the system (i.e., two identical systems with dierent initial con qurations) under correlated noise 4. Recently, Hinrichsen et alshowed that the active phase is actually subdivided into three dynam ical phases which depend on the correlations between the dierent types of stochastic noise used for each replica. The phases are the following: (i) one in which the dam age spreads for all possible types of correlations, which coincides with the so called chaotic phase founded by M artins et al; (ii) one in which the dam age spreads for som e type of noise but it does not others and (iii) one where dam age heals always.

The phase diagram of this model was calculated using dierent techniques, such as mean eld 6 and M onte Carlo^{2,5;9}.

In this work we introduce a generalization of the above model, in which the state of any site depends on the state of all the rest of the sites at the previous time through a distance dependent transition probability. In this case the interaction between a pair of sites separated by a distance r decays with a power law of the type 1=r (0). In other words, the interactions are long ranged in space. Microscopic long-range interactions appear in dierent physical contexts (see Ref. 10 and references therein) but, until now, most of the theoretical analysis has been concentrated into the equilibrium properties of such kind of systems. Hence, it is of interest to analize system atically the in uence of long range interactions in a dynamical model, such as a cellular autom aton.

II. THE MODEL: LONG-RANGE CELLULAR AUTOMATON

Let us consider a stochastic one-dimensional lattice with N + 1 sites. The congurations of the system are described in terms of a set of occupation variables $S_i = 0;1$ with i = 0;1;:::;N. Let S_i^t the state of the site i at the discrete time t. We denote by S^t of S_i^t the state of the complete system at time t. We consider periodic boundary conditions, so that

The system evolves in time according to a spatially global rule, but without memory elects, that means, the state of the site i at time to depends on the state of all the rest of the sites S^{t-1} at the previous time to 1. However, the in uence of a site j at time to 1 over the site i at time to decays with the distance between sites with a power law ji ji with 0. Before establishing explicitly the evolution rule we introduce an auxiliary function $p^0(S_3 \ S_1; S_2)$ of three binary variables $S_1; S_2$ and S_3 , such that

Notice that $p^0(S_3;S_1;S_2)$ has the properties of a conditional probability for the variable S_3 given the values of S_1 and S_2 . Now, we consider a parallel dynamics, so that all the sites are updated simultaneously and independent of the rest of the sites at the same time. Then, the transition probability $W(S^t;S^{t-1})$ from state S^{t-1} to S^t is given by

where w $(S_i^t)^{t-1}$) is the probability that the site i, at time t, has the value S_i^t given that, at time t 1, the system was at S^{t-1} .

The model is then de ned by the expression:

where N is assumed an even number for simplicity and 0. Note that the interactions are symmetric on both sides of site i and that, together with the periodic boundary conditions (1) every interaction is counted just once on a ring of length N + 1, as schematized in Fig.1. The sum $\frac{P}{n=1} \frac{1}{n}$ that appears in the denominator of Eq.(6) ensures the correct normalization of the conditional probability w $(S_1^{t} \tilde{F}^{t-1})$. It is also related 1 to some function N () that provides the correct scaling of the thermodynamic functions of magnetic models for 1, where these kind of interactions are non integrable.

From Eqs.(2)-(4) is easy to verify the following properties:

and the model reduces to the DK cellular autom aton¹. For nite values of the transition probability for the site i depends on all the rest of the sites. For small values of the interaction strength tends to become independent of . This is exactly the case for = 0 where the system lost its dimensionality. In the lim it N ! 1 this model (= 0) can also be thought as an in nite dimensional one. In magnetic systems the mean eld approximation becomes exact in the lim it of in nite dimensionality. Moreover, in a recent study of the one-dimensional Ising model with long-range interactions of the type 1=r it has been shown that the mean eld behaviour is exact, not only in the in nite dimensional case = 0 (which corresponds to the Curie-Weiss model) but in the full range of interactions 11 0 1. This result suggests that mean eld behaviour could be an universal property of systems with long-range interactions, from which the in nite dimensional case = 0 is just a particular case. Therefore, it is interesting to investigate whether or not this property is shared by dynamical models with long-range interactions, like the present

In a very broad sense (and perhaps a rather vague one) a m ean eld approximation is one in which uctuations are neglected. Dierent systematic mean eld approaches has been proposed for the DK cellular automaton $^{6;8;7}$. They all coincide (at least qualitatively) in the prediction for the shape of the frozen-active transition line, but they dier in the prediction of the damage spreading transition line. Hence, it is of interest to analize the behaviour of the long-range cellular automaton for small values of , where some kind of mean-eld type behaviour can be expected, by analogy with the magnetic models.

Let P_t(S) be the probability of state S at time t. The time evolution of this function is given by the equation:

We are mainly interested in the asymptotic behaviour of this model for t! 1. Since this behaviour is not expected to depend on the initial state (except for some very special cases, for instance, $S_i^t = 0.8i$, where the solution is trivial), we consider, without loss of generality, the following initial state:

The mean activity is then de ned as

Since we are considering an hom ogeneous system $P_t(S_i)$ is independent of the site i. Then, dening $P_t(1)$ $P_t(S_i = 1)$ we have that

This kind of system is expected to present two type of hom ogeneous stationary states for t! 1: one with $S_i = 0$ 8i, which do not not state the so-called \frozen" or \dry" phase, and one with a nite fraction of active sites $S_i = 1$, which do not not have the \active phase. The order parameter for this phase transition is given by

From Eqs.(5), (11) and (16) the time evolution of a_N (t) is given by the equation:

for an arbitrary site i. Let $P_t(S_i; S_j)$ the joint marginal probability for S_i and S_j . From Eqs.(3), (6) and (18) we have that

III. THE FROZEN-ACTIVE PHASE TRANSITION

Before proceeding with the mean-eld and M onte Carlo calculations we can obtain a few analytical properties of the phase diagram in the $(p_1; p_2)$ space, regarding the frozen-active phase transition.

First of all, notice that, from Eqs.(3) and (6), the absorbing state $a_N=0$ ($S_i=0.8i$) is always a xed point of the dynam ics for all values of and N . That m eans, a_N (t) = 0 implies that a_N (t + 1) = 0. This state is expected to be an attractor of the dynam ics for low values of p_1 , as occurs in the D K autom aton (= 1).

On the other hand, for the particular case $p_2=1$ the fully occupied state $a_N=1$ ($S_i=1$ 8i) is also a xed point of the dynam ics for all values of and N . If we now perform a \particle-hole" transform ation, by de ning a new set of variables $S_i^0=1$ S_i 8i, we obtain, from Eqs.(2)-(6) and Eq.(8), an equivalent system with parameters $p_2^0=1$ and $p_1^0=1$ p. We also see that $a_N^0=1$ a_N . Therefore, if the system presents a frozen-active phase transition for $p_2=1$ then the critical value of p_1 has to be $p_1=p_1^0=1$ 2. Moreover, in the active phase $a_N=1$ and the phase transition will be a discontinuous one. These results will be verified by both the mean-eld and Monte Carlo calculations.

A.M ean- eld solution

From Eq.(19) we see that the time evolution of a_N (t) depends on higher order correlation functions between sites. A simple dynam ical mean-eld approximation can be obtained by neglecting such correlations⁶, that is,

This equation is independent of and N , and it is the same already encountered (with the same approximation) for the D K automaton 6. The xed point equation a_N (t+ 1) = a_N (t) = a_N derived from Eq.(22) gives the critical line $p_1^c = 1 = 2 \ 8p_2$ with

We can now develop a system atic improvement of this mean-eld approximation, by neglecting the pair correlations only between sites located at a distance greater than K of site i, for some integer value K, that is,

For large lattice sizes N 1 the sum $P_{n=1} = \frac{1}{n}$ diverges for 0 1, while

where () is the Riemann Zeta function. Hence, for any nite value of K, Eq.(25) reduces to Eq.(22) in the limit N! 1, for 0 1. This fact suggests that the mean eld solution becomes exact for an in nite lattice when 0 1, while a departure from such solution should be expected for > 1, a behaviour that has already been observed in the ferrom agnetic Ising model with long-range interactions, as was mentioned in the preceeding section. In fact, the M onte C arlo simulations of the next subsection con rm such conjecture.

B . M onte C arlo results

We performed a Monte Carlo simulation for several system sizes, N = 100, 200, 400 and 800, and for dierent values of . It is worth mentioning that the computational complexity of the algorithm implied by the long-ranged transition probability (6) is $O(N^2)$.

We calculated the transition line between the frozen and active phases, founding a continuous transition for all values of in the full plane $(p_1;p_2)$, except for $p_2=1$, where the numerical results verify the prediction of the beginning of this section. That is, for $p_2=1$, the transition point always occurs at $p_1^c=1=2$ for all values of N and , and the transition is a discontinuous one at that point. The typical shapes of the transition lines between the frozen (left part of the diagram) and active (right part of the diagram) phases are shown in Fig.2 for N = 800 and dierent values of . The curves show all the same qualitative shape as the corresponding one for the short-range model = 1 (DK model). We can observe that, for running from = 1 to = 1 the curves move smoothly to the left of the diagram . All the curves with between 0 and 1 are indistinguishable inside the error intervals of the calculation (the error bars in the p_1 direction are approximately of the order of the symbol size; there are no error bars in the p_2 direction). This behaviour was veried for all the values of N used in the simulation.

For each checked value of > 1 the corresponding curves show a fast convergence into an asymptotic one for increasingly higher values of N . On the other hand, for 0 1 the curves show a slow convergence towards the $p_1 = 1 = 2$ vertical line, as depicted in Fig.3 for = 0. In fact, we veriled for several values of p_2 the asymptotic behaviour p_1^c 1 = 2 A p_2 N p_2 for high values of N , where A p_2 is some continuous function of p_2 with A p_2 is a function of p_3 as a function of p_4 as a function of p_4 as a function of p_4 and a particular value of p_4 . The circles in that gure correspond to a numerical extrapolation for N p_3 ! 1.

In Fig.5 we show a numerical extrapolation for N $\,!\,$ 1 of the full critical lines for dierent values of $\,.\,$

Finally, in Fig.6 we show a numerical extrapolation for N ! 1 of the mean activity $a = \lim_{N \to 1} a_N vs p_1$ curves (symbols) for three dierent values of p_2 and 0 1 (the activity curves for dierent values of in this range are indistinguishable). The solid lines are the mean eld prediction of Eq.(23). The excellent agreement between these results con mut the conjecture of the preceeding subsection.

IV.SPREAD ING OF DAM AGE

To study the spreading of dam age in this model we have to create a replica of the system with an initial \dam age", by ipping random by a fraction p of sites⁴. Then we let both replicas to evolve under correlated noise and analize the long time evolution of the normalized Hamming distance between replicas. If the Hamming distance evolves to zero it is said that the dam age \heals"; otherwise, the dam age \spreads".

In a recent work, H inrichsen⁵ et al have shown that the dam age can spread in the DK autom aton for di erent kinds of correlated noise. In this work we let the replicas evolve under the identical realizations of the stochastic noise, which was the most studied case in the DK autom aton^{4,6;9;8;3}. This corresponds, according to H inrichsen et al de nition, to maximally correlated noise, at least for the DK autom aton⁵ (= 1). It is expected this property to be valid for all, as long as in this case a single random number is generated for every site in both replicas. Other types of correlated noise are very dicult to simulate in the long-range model, because they involve, in principle, the generation of O (2^N) random numbers for every site at every time step.

We perform ed this M onte Carlo simulation for N=100, 200 and 400 founding that, for 0=1, the dam age spreading is suppressed for all values of $(p_1; p_2)$. For >1 a small region where the dam age spreads appears in the lower right corner of the diagram. The transition line m oves continuously towards the DK one for =1.

In Fig.7 we show the transition lines between the healed and the \chaotic" regions, for dierent values of > 1 and N = 400.

V.CONCLUSIONS

We introduced a one-dimensional stochastic cellular autom aton which allows to analyze dierent ranges of interactions through a single parameter. We everied that this model reproduces, for high values of most of the known results of the D K model (= 1).

We found two dierent regimes, according to the range of values of .

For > 1 the dynam ical phase diagram shows the same qualitative aspects of the one corresponding to the DK model, that is, three dierent regions: a frozen and an active phase, with the last one divided in two regions, one where the dam age spreads (\chaotic" phase) and one where the dam age heals, when the replicas evolve under the same noise. The transition lines between these regions continuously vary when decreases from = 1 to = 1.

For 0 1 the phase diagram becomes independent of , even for nite N . No damage spreading were found in this case, at least for replicas evolving under the same noise. Regarding the frozen-active phase transition, we presented a strong evidence that the mean eld theory is exact in the limit N ! 1 . The fact that the same behaviour appears in the thermodynamics of the one-dimensional Ising model with similar interactions of mean suggests the existence of some universal relationship between mean eld theories and very long ranged interactions (0 d, where d is the space dimension).

It is worth noting that mean eld calculations of the H am ming distance dynamics between replicas evolving under two dierent types of correlated noise $^{6.9}$ predicts a spreading of dam age transition in the D K model. It is a general heuristic argument (based on the equilibrium behaviour of magnetic systems) that mean eld approximations of short range models (= 1) show the same behaviour as the corresponding fully connected models (= 0). We have shown that this is not true for the spreading of damage transition in the D K model. This variance between the two phenomena in the cellular automata is telling us that the spreading of damage transition is of dierent nature, at least in some of its properties, than other cooperative phenomena like the frozen-active or the ferromagnetic phase

Finally, there is recent conjecture of Grassberger³ which states that all continuous transitions from an \absorbing" state to an \active" one with a single order parameter are in the universality class of directed percolation, provided that some conditions are full led, among others, short-range interactions in space and time. Both transitions in the present model fall into this category, except for the range of the interactions for small values of . Hence, having a model which allows to interpolate between long and short range regimes, and for which the long range behaviour is known exactly may be a good candidate for testing the above conjecture.

- FIG.7. Transition lines between the healed (left part of the diagram) and the \chaotic" (right part) phases, for dierent values of > 1 and N = 400.













