A moment based approach to the dynam ical solution of the K uram oto model

W e exam ine the dynam ics of the K uram oto m odel with a new analytical approach. By de ning an appropriate set of m om ents the dynam ical equations can be exactly closed. W e discuss som e applications of the form alism like the existence of an e ective H am iltonian for the dynam ics. W e also show how this approach can be used to num erically investigate the dynam ical behavior of the m odel without nite size e ects.

The study of the dynam ical behavior of system swith a very large num ber of mutual interacting units is a longly debated subject. It is a topic with interest in many different interdisciplinar elds. The cooperation between the members of a population may lead to very rich dynam ical situations ranging from chaos, periodicity, phase locking, synchronization to self-organized critical states, just to cite a few [1,2]. In the presence of disorder such interaction can be frustrated and this yields new types of behavior. In the realm of disordered systems much work has been devoted to the study of models with relaxational dynam ics, for instance spin-glass models [3]. In those cases there exists an Ham iltonian function which governs the dynam ics of the system . A large body of inform ation can be obtained by using the tools of statistical mechanics. One of the main results at equilibrium is that the uctuation-dissipation theorem is obeyed. But it is de nitely interesting to study the dynam ical behavior of dissipative systems in the presence of external driving forces.

A sim plem odel of this type was proposed by K uram oto to analyze synchronization phenom ena in populations of weakly nonlinearly coupled oscillators [4]. It has become the subject of extensive studies in recent years due to its applications to biology, chem istry and physics [5]. The purpose of this letter is to present a new analytical approach to the Kuram oto model based on the de nition of a suitable hierarchy of m om ents. It allows to reproduce previous known results and, in addition, gives a new insight into the nature of the problem . Here, we will present the method and consider its potential applications leaving detailed analysis for future work. Through this form alism it is possible to analyze some aspects of the model that deserve special attention. As an example, it has been suggested that, under certain conditions, it is possible to de ne a suitable Ham iltonian function from which it is possible to compute stationary properties of the system within the usual therm odynam ic form alism

such as ground states and universality classes at zero tem perature [6] and equilibrium Boltzm ann distribution in the more general case at nite tem perature [7]. Our method can answer this question in a simple way. We will also show how our approach can be used to numerically investigate the behavior of the Kuram oto model free of nite size elects. Particular results will be obtained for the bim odal distribution case.

O ur form alism com plem ents other recent theories developed to analyze the K uram oto m odel. In particular, it is worthwhile to m ention the order function approach [8] useful for studying properties of the stationary states of the system as well as the critical exponent of the order param eter at the onset of entrainm ent. A nother interesting m ethod was proposed in [9] based on kinetic theory and suitable to deal with questions related to the tim e dependence of the probability density of the system.

The K uram oto m odel is de ned by a set of N oscillators whose state can be specified in terms of only one degree of freedom, the phase. Each phase f $_{i}$;1 i N g follows the dynam ical equation

where !_i is the intrinsic frequency of the oscillator random ly chosen from a distribution of density g(!), K₀ is the strength of the coupling which, as in the original case, we will consider ferrom agnetic although m ore com – plex situations have been analyzed in the literature [10]. Finally, _i(t) denotes a gaussian independent white-noise process

W ithout any other ingredient there is a competition between the coupling, which tends to synchronize all the oscillators, and the noise (frequencies plus therm alnoise) which breaks the coherence. For a critical K $_{\rm c}$ there is a spontaneous transition from incoherence to a new state where a macroscopic number of units are synchronized. To solve the dynamics of the K uram oto model we de ne the the following set of moments,

where i stands for the imaginary unit and k;m are integers in the range (1;1);[0;1) respectively. The averages < () > and () indicate averages over the noise and frequencies distribution respectively. The denition of this set of moments is the basis of the new dynam ical approach we are proposing. Note that H_k^m is the more natural object we can construct which is invariant under the local transformation $_i ! _i + 2$. This is also the local symmetry of the dynam ical equations (1). It is possible to show that the moments H_k^m are self-averaging with respect to the thermal noise . The equation of motion for H_k^m can be easily derived using the eq.(3),

where we have de ned the $h_k = H_k^0$. The term $k^2 T H_k^m$ can be simply obtained using the G aussian representation for the noise i, doing an integration by parts and using the regularisation condition $\frac{\theta}{\theta} \frac{(t)}{(t)} = 1=2$. In this form the equations are closed because the time operator $\frac{\theta}{\theta t}$ acting on the moment H_k^m generates always new moments of the same type. If we dependent equations dependent generating function $g_t(x;y) = \frac{1}{k=1} \frac{1}{m=0} \exp(-ikx) \frac{y^m}{m!} H_k^m$ (t) it is easy to check from eq.(4) that it satis es the following di erential equation,

where

and we have expressed $h_1 = h_1 = rexp(i)$ where r is the parameter which measures the coherence (synchronisation) between oscillators. By substituting eq.(3) in the de nition of the generating function it is straightforward to check that $g_t(x;y) = \frac{1}{N} \prod_{j=1}^{N} (j x) \exp{(y! j)}$. For y = 0 this is nothing else than the probability density of one oscillator to have phase x. In this way we recover the results obtained by B onilla [11] using the path integral form alism . The hierarchy of equations (4) only depends on the time evolution of the moment h_1 ($h_1 = h_1$) which is the order parameter of the problem . The full set of moments are self-consistently computed using the conditions h_1 (t) = $\frac{1}{2} \prod_{0}^{R_2} \exp{(ix)g_t(x;0)}dx$ and $H_0^m = \overline{1^m}$. In this way, we have reached a dynamical solution of the problem identical to that found in some mean - eld glassy models where dynamical equations can be exactly closed [12].

Once we have presented the formulation we present its applications. The method furnishes a transparent way to show why a static description based on conventional equilibrium statistical mechanics cannot give reliable inform ation about the long-tim e properties of the K uram oto model (like the existence of stationary states). Let us stress from the beginning that our approach deals with the dynam ics of the model once the therm odynam ic lim it N! 1 is taken rst than the lim it t! 1. Our results are meaningful in this case. In the other dynam ical approach one does the therm odynam ic lim it N ! 1 after solving the dynamics in the long-time limit t! 1. This yields quite di erent results. These considerations interest specially to the results reported in [6] where the last situation has been analyzed. W hich of the two approaches is valid relies on the tim escales one is able to observe. Because the crossover time which matches the two approaches grows extremely fast with the system size, our approach (which, on the other hand, is the most conventional one) is more suited to investigate what can be observed in m acroscopic systems in realistic tim escales.

Let us consider the following ${\rm H}\,{\rm am}$ iltonian function,

where the phases $_{i}$ are restricted to the interval [;) in order H $_{eff}$ to be bounded from below. This H am iltonian function is the only candidate which generates the equations (1) in the Langevin dynam ics $_{-1} = \frac{(\theta H - eff}{\theta} + i$. We will show that the equilibrium solutions of (7) are not stationary solutions of the dynam ics eq.(1) even at zero tem perature. To prove this result we compute the partition function of eq.(7) at tem perature T = $\frac{1}{2}$ and evaluate the m om ents H $_{k}^{m}$ (eq) in equilibrium. The com – putations are quite simple since the disorder in H $_{eff}$ is only site dependent. For sake of sim plicity we will consider here the case in which the disorder distribution is symmetric (g(!) = g(!)). It is easy to obtain the equilibrium values of the di erent m om ents. We obtain H $_{k}^{m}$ (eq) = F $_{k}^{m}$ (eq) exp (ik) where is an arbitrary phase

The derivation of this result comes from the fact that a probability density of oscillators can be de ned for the Kuram oto model, see Strogatz and M irollo in [5].

 $^{\rm y}$ and the F $^{\rm m}_{\rm k}$ (eq) are given by

where the $\overline{A(!)} = {R \atop k} d! g(!) A(!)$ is the average over the frequency distribution and $R_k^! (x) = {J_k^! (x) \over J_0^! (x)}$. The $J_k^! (x)$ are generalized Bessel-like functions de ned by,

where r is xed by the condition $r = F_1^0$ (eq) = $R_1^!$ (K_0r).

To check if the $F_k^{\mbox{ m}}$ (eq) are stationary solutions of the dynam ics we plug them in eq.(4) and use the recursion relation,

obtaining after som e m anipulations,

Due to the symmetry property of the g(!) it is easy to check that the $v_{\mbox{\scriptsize m}}$ always vanishes for $\mbox{\scriptsize m}$ even. But it never does for odd m . In the high tem perature regime ! 0 it is possible to show that $v_{2m-1} = \overline{!^{2m}} + O(^{3})$. In the limit T ! 0 it is easy to check that v_{2m-1} = $!^{2m} + 0$ $(\frac{1}{2})$. The general result is that odd m -m om ents violate stationarity^z. We conclude that the time derivative of the equilibrium moments H_k^m (eq) with odd m get an imaginary contribution proportional to $i = \exp(i_{\overline{2}})$ which is transverse in the complex plane to the H_k^m (eq) itself. Note that the term v_m is the angular velocity or time derivative of the global phase for all the moments which only depends on the numberm. In the case of the bin odal distribution $g(!) = \frac{1}{2}((! !_0) + (! + !_0))$ allm om ents reduce to two di erent m om ents (see below) depending if m is even or odd. In gure 1 we show the

 $v_{\rm odd}$ as a function of the tem perature in the bim odal distribution for di erent values of K $_0$ $^{\rm x}$. This proves that equilibrium states of H $_{\rm eff}$ at nite tem perature and also the ground states of H $_{\rm eff}$ are not stationary states of the dynam ics. Note that we cannot discard the fact that bcalm inim a (but not global) of H $_{\rm eff}$ at zero tem perature are xed points of the dynam ics.




FIG.1. v_{odd} as a function of T for the bin odal distribution for three values of K₀ = 0.5;1;2 from bottom to top. The cusp in v_{odd} m oves to higher tem peratures as K₀ increases.

Now we want to show how equations (4) can be used as a powerful tool to investigate the dynam ical behavior of the K uram oto m odel. We will consider the case of the bin odal distribution because the phase diagram of the m odel is very rich. We have checked the situation for other distribution of frequencies and the results have been always very satisfactory. In this case the full set of m om ents H_k^m reduces to two di erent sets, $f_k = H_k^m$ for m even and $g_k = H_k^m$ for m odd. The full set of dynam ical equations read in this case,

^zAn exception to this nule are them om ents H $_0^m$, am ong them the average frequency, because k = 0 and therefore the right hand side of eq.(11) vanishes.

By dening $(x) = \frac{1}{2} P_{k=1}$; exp(ikx) $(f_k + g_k)$ $\int_{k=1}^{1} \exp(ikx)(f_k - g_k) \text{ we observe}$ $(x) = \frac{1}{2}^{r}$ and that these are the probability densities of having one oscillator with phase x and natural frequencies + 1 and 1 respectively. By adding and substracting both equations (13), (14) we obtain dynam ical equations for two sets of dynam ical hierarchies, each set characterized by a population of oscillators with a given natural frequency (+1 or -1). Note that the two sets of oscillators are also coupled one to each other through the term s ikg_k and ikf_k in (13),(14). These equations also can be used to analytically compute stationary states and perform stability analysis as has been done in [13]. In this last case it can be shown that the fundam entalm odelk = 1 decouples form the rest of the modes in a natural way. Here we follow a di erent strategy and use the m ethod to numerically solve the set of equations for a given number 2L + 1 of terms in the hierarchy $ff_k; q_k; L$ k Lg. W e stress that L is not the number of oscillators in the system which is already in nite from the beginning. To reduce possible dependences on the value of L we consider periodic boundary conditions $f_{L+1} = f_{L}$; $f_{L-1} = f_{L}$ and do the same for the g's. In our num erical solution we have taken L = 100 and we have checked that the results are the same by including more terms in the hierarchy. Equations have been solved using a second order Euler algorithm. We have also started from an initial condition of the type shown in eq.(8) with = 0 in order to check they are not stationary solutions. Depending on the values of the parameters K $_{\rm 0}$ and T there are dierent regim es [13].

In gures 2,3,4 we show the trajectory of the system in the plane $(Re(f_1); Im(g_1))$ for three di erent regimes (the incoherent, the critical and the coherent regimes). Note that according to eq.(12) all the trajectories depart from the Im (g₁) in the direction $i = \exp(\frac{3}{2})$. The rst regime (g2) corresponds to the region where the incoherent solution is stable. In this case the order param eter r (r = $(f_1 f_1)^{\frac{1}{2}}$) oscillates with an amplitude which decays to zero exponentially in time. The second regime is shown in gure 3 and corresponds to the the critical boundary line $T = \frac{K_0}{4}$ where the incoherent solution becomes unstable. In this case r oscillates and its am plitude decays to zero algebraically like t $\frac{1}{2}$ as expected for mean-eld models at the critical point. In the region T < $\frac{K_0}{4}$ the incoherent solution is unstable and the system reaches a oscillating stationary solution (see gure 4) in agreem ent with the results analytically found by Bonilla et al [13,14]. Note that this type of solutions cannot be computed from any theory based on an e ective Ham iltonian (EH) like that given by eq.(7). Therefore, the assumption of the existence of an e ective Ham iltonian not only implies to consider solutions which are not stationary but also to m iss another set of them that are explicitly time dependent.




FIG.2. Trajectory of the system in the (Re(f_1);Im (g_1)) plane at T = 0.5, K $_0$ = 1 in the incoherent regime.




FIG.3. The same as in gure 2 at T = 0.25, $K_0 = 1$ in the critical boundary. The area of the central hole decreases like 1=t.

W e have also observed the existence of stationary xed points for enough large values of K $_0$ as expected when the ferrom agnetic coupling is strong enough. In this case

the equilibrium solution within the EH approach albeit incorrect is closer to the true stationary one (in the lim it $K_0 \mid 1$ the EH approach is recovered).




FIG.4. The same as in gure 2 at T = 0.05, K $_0 = 1$ in the synchronized regime.

Finally, a comparison between the present theory (eqs.(13,14) for the bin odal case) and the B row nian sim – ulations is shown in gure 5. Simulations have been performed by solving eq.(1) with an Euler method with a time step t = 0.005 and for a population of N = 50.000 oscillators. Despite some small di erences there is remarkable agreement between the simulation and analytical results.

In sum m ary, we have presented an approach to the analytical solution of the K uram oto m odel which is simple in its form ulation and suitable for analytic and num erical com putations. W e have shown that the EH approach fails in predicting the stationary states of the system as well. as the ground states of the energy function eq.(7). We can give a an explanation for this result. It has been suggested [6] that if a m in im um of the energy function eq.(7) can be localized in the interior of the region [;) then this should be asymptotically stable. In the Kuramoto model it seems that this condition is indeed not satised, at least for the ground states of eq.(7). As shown in eq.(12) the ground states of eq.(7) are not stationary states of the dynam ics. The quantitative violation of the stationarity property has been also analitically com puted in eq.(12). The reason for the discrepancy of our results with those reported in [6] relies on how the order of the limits N ! 1 and t ! 1 are taken.




FIG.5. Analytical solution (lines) versus Brownian sim – ulations (points) in the oscillationg regime with parameters T = 2.5; K₀ = 1=4. Brownian simulations were performed with 50000 oscillators and one realization of the noise.

The limit t! 1 concerns particularly to the properties of the stationary states. W hen the $\lim it N ! 1$ is taken st then all ground states of H eff become dynam ically unstable. The reason is that in this lim it a nite density of oscillators in the ground state touch the boundaries where the e ective H am iltonian eq.(7) is discontinuous. O by jourly this is not true if the lim it t ! 1 is taken rst. Then, for nite N, the phases i of the oscillators do not touch the borders (because it has zero m easure) and the ground states are stationary. As said before, the order of limits (rst N ! 1 and latert ! 1) is the one expected to describe the relevant asymptotic dynam ics. W e have used equations (4) to investigate the dynam icalbehavior of the K uram otom odel free of nitesize e ects. Particular results have been obtained for the bim odal distribution but the method can be generally applied to any other distribution. It would be very interesting to use this approach to study the spectrum of correlation and response functions of the model as well as to investigate the presence of other dynam ical regimes.
