# R enorm alization group for renorm alization-group equations tow ard the universality classi cation of in $n$ ite-order phase transitions

#### Abstract

W e derive a new renorm alization group to calculate the nontrivial critical exponent of the divergent correlation length thereby giving a universality classi cation of essential singularities in in nite-order phase transitions. This $m$ ethod thus resolves the vanishing scaling $m$ atrix problem. $T$ he exponent is obtained from the $m$ axim al eigenvalue of a scaling $m$ atrix in th is renom alization group, as in the case of ordinary second-order phase transitions. We exhibit several nontrivial universality classes in in nite-order transitions di erent from the well-known Berezinski K osterlitz$T$ houless transition.

## I. IN TRODUCTION

The Berezinski K osterlitz-T houless (BKT) transition is well-known as an in nite-order phase transition [ill]. The correlation length has an essential singularity at the critical coupling param eter $g$

w ith the critical exponent $=1=2$ or 1 . In $\mathrm{c}=1$ conform al eld theory (C F T ) [2]1, there are in nitely many $m$ odels where in nite-order phase transitions can occur. A ny of them show s the sam e universality as the BK T transition.

 out that an in nite-order phase transition $w$ ith a critical exponent $=\frac{N}{N+2}$ occurs by an $S U(\mathbb{N}$ ) sym m etry-breaking m arginal operator. In the $\mathrm{N}=3$ case, this corresponds to the gapless H aldane gap phase transition in a spin 1 isotropic antiferrom agnet in one dim ension. In a problem of dislocation-m ediated $m$ elting, som e curious num bers were observed by Young, N elson and H alperin $[\underline{4}]$. They obtained $=1=2$ for a m odel on a square lattice, $=2=5$ for a sim pli ed $m$ odel on a triangular lattice and a non-algebraic num ber $=0: 36963::$ for a generalized m odel. In R ef. [⿶凵T], B ulgadaev studied topologicalphase transitions in c> 1 CFT w ith non-abelian sym $m$ etry, where non-abelian vortioes play an im portant role. They belong to special classes of in nite-order phase transitions and several series of dependent on the sym $m$ etry of the system, were found. Though there have been several studies for those som $e$ di erent types of $m$ odels $w$ ith in nite-order phase transitions including BK T type, the universality classi cation by this critical exponent still rem ains a challenging problem.

In this paper, we study the universal nature of the criticalexponent in in nite-order phase transitions. W e show that the critical exponent is determ ined from the operator product coe cients of the $m$ arginal operators which cause the in nite-order phase transition. It is show $n$ that a $m$ arginally irrelevant operator can also a ect the value of the critical exponent .

The criticalexponent of the correlation length is extracted from a long-distance asym ptotic form ofrunning coupling constants, whose leading term is determ ined by the $m$ otion of the coupling constants near a xed point. In an ordinary nite-order phase transition, we linearize the renorm alization-group equation ( $R G E$ ) around the xed point and can derive the exponent exactly. N am ely, we can show that the inverse of the exponent is equal to the m axim aleigenvalue of the scaling $m$ atrix de ned by the derivative of the beta function at the xed point. O ne does not have to solve the di erential equation exactly in order to obtain the exact critical exponents in this case. In the in nite-order phase

[^0]transition how ever, the scaling $m$ atrix vanishes since the phase transition is driven only by $m$ arginal operators. So far, one has had to solve the di erential equations explicitly to obtain the critical exponent, although RGEs w ith $m$ ultiple variables are generally non-integrable due to their non linearity except for som e fortunate cases like the BK T transition. This di culty is one of the reasons why the universality classi cation of in nite-order phase transitions by the critical exponent in eq. '(1-1) has never been successfully done.

In order to resolve th is problem, we apply another renorm alization group (RG) method developed in Refs. "G ind to studying the long-distance asym ptotic behavior of the solution of the originalnon-integrable RGE.ThisRG m ethod is starting to be recognized as a generaltool for asym ptotic analysis. C hen, G olden feld and O ono $[\underline{1}]$ of RG to singular perturbation theory and gave a uni ed treatm ent. A ccording to Briam ont, K upiainen and Lin the RG transform ation for a partialdi erentialequation is de ned as a sem i-group transform ation on a space of initial data, which is generated by a scaling transform ation com bined with tim e evolution. K oike, H ara and A dachi used this generalm ethod practically in the study of the critical phenom enon in the $E$ instein equation of the gravitational collapse w th form ation ofblack holes [ equations of $m$ otion in $N$ ew tonian gravity were analyzed [g].
 w ithout solving the nonlinear di erential equation explicitly. The new RGE regards the straight ow line solving the originalRGE as a xed point, where the derivative of the beta function in the new RGE has non-zero value in general. In Sec'III, we show that the inverse of the $m$ axim al eigenvalue of the scaling $m$ atrix derived from the new RGE gives the critical exponent. In Sec' $\overline{\underline{I}} \bar{V}^{\prime}$ ', we also study asym ptotic behavior of the running coupling constants in a m assless phase and extend the well-known form ula for a logarithm ic nite-size correction to the case ofm ultiple running coupling constants. In Sec ${ }_{l}^{N}$,', we exhibit severalnontrivialexam plesm otivated by antiferrom agnetic quantum spin chains. Finally, we give a sum $m$ ary and discussions in Sec ${ }^{N}$

## II. RGE FOR RGE

## A. Form alism

Let us begin with the RGE for a given set of $n m$ arginaloperators

where $g=\left(g_{1} ; \quad n\right.$ gis a set of coupling param eters and $t=l o g l w$ th $l$ being a length scale param eter. Since the operators are all m arginal, the right-hand side is expanded as

where $C_{k}^{i j}$ is proportional to the operator product coe cients of the operators. First we neglect the higher-order term so( $g^{3}$ ), and later we discuss irrelevance of those neglected term s.

In general, we nd severalcritical surfaces where the RG ow is absorbed into the origin. A phase transition occurs if the initial coupling constants cross one of the critical surfaces. T hese critical surfaces divide the coupling param eter space into several regions which are phases. In the next section, we consider one $m$ assive phase surrounded by a set of critical surfaces, where there are severalm arginally relevant coupling param eters. In this region, we have a nite correlation length, which becom es larger as the coupling param eter approaches the critical_surface.

W e are going to study the long-distance asym ptotic behavior of solutions for the RGE (2) which is non-integrable in general. To this end, let us introduce the RG $m$ ethod explained in the introduction. $W$ e de ne a renorm alization group transform ation on $n \quad 1$ dim ensional sphere which form $s$ a set of initial values. $W$ e denote the solution $g$ of eq. $(\underline{\overline{2}}) \mathrm{w}$ ith the initial condition $\mathrm{a}_{0}=\left(\mathrm{a}_{01} ; \quad\right.$ orid as

nam ely, $g\left(0 ; a_{0}\right)=a_{0}$. The finction $\mathrm{g}\left(\mathrm{e} t ; \mathrm{a}_{0}\right)$ is a solution of the RGE $\overline{(2)}$ ) as well, because of its scale invariance. Let $S$ be the $n 1$ dim ensional sphere whose center is at the origin $w$ th the radius $\dot{a}_{0} j \quad a_{0}$. We de ne a new renorm alization-group transform ation $R \quad: S$ ! $S$ as follow $s:$

 of the new RGE near the xed point determ ines the universal behavior of the in nite-order phase transition, as in the ordinary RGE for a nite-order one. Near a xed point, a ( ) m oves slower as its tra jectory tends to a critical surface. This im plies that the tim e a ( ) spent in a neighborhood of the xed point is a singular function of the initial condition $a_{0}$. This singularity can occur only at xed points of the new RGE, which allow s us to analyze its singular behavior by a linearization near the xed points.

From eq. (11), one nds that $a$ is de nitely a xed point if $P(a) V(a)=0$ and $a \quad V(a) \in 0$. In this case, since V (ka) is parallelto a for all realnum bers $k$, $a$ is on a straight ow line of the originalRGE( $\overline{(1)}$ ). Straight ow lines are put into two classes. If an arbitrary point a on a straight ow line satis es a $V(a)<0$, it is said to be an incom ing straight ow line because $a$ is carried tow ard the origin in tim e evolution. On the other hand, if $a \operatorname{V}$ ( $a$ ) $>0$ for all a on a straight ow line, it is called an outgoing straight ow line. If a xed point a of eq. (10) is on an incom ing straight ow line, $a$ is a xed point on an outgoing straight ow line.
$W$ hat happens if $P(a) V(a)=a \quad V(a)=0$ ? In this case, $V(a)$ itself vanishes. It $m$ eans that $a$ is $a$ xed point of the original RGE (2,). M oreover, since $V$ is hom ogeneous, $k$ a is also a xed point for all $k 2 R$. Nam ely, the
 a non-vanishing scaling $m$ atrix even though the coupling constants are all $m$ arginal at the trivial xed point $g=0$. Therefore, we can directly analyze the original RGE near a point on the xed line and can show that the phase transition generally becom es of nite order in this case.

Here, we give a couple of rem arks on the global nature of the new RG transform ation $R$ de ned by ( $\overline{\mathrm{F}} \mathrm{I})$. First, there could be a tuming point $g$ where $V(g) g=0 w$ th $V(g) \in 0$. Let

Second, if $g\left(t ; a_{0}\right)$ has tuming points, $a()$ and $s()$ becom em ulti-valued with respect to . For exam ple, in Figh 12 , $g\left(t ; a_{0}\right)$ has a tuming point at $g$. Suppose that $j^{(1)} j=j^{(2)} j=b$ and choose $=l o g a=b \quad 0$. Then $R{ }_{0} a_{0}$ has two im ages, $\mathrm{e}^{0} \mathrm{~g}^{(1)}$ and $\mathrm{e}^{0} \mathrm{~g}^{(2)}$. In this case we distinguish the im ages as $\mathrm{a}^{(1)}(0)$ and $\mathrm{a}^{(2)}(0)$. Sim ilarly, $\mathrm{s}(0)$ also has the sam emultiplicity, which is distinguished in a sim ilar way. In $F$ ig ${ }^{\prime \prime}$, the in age of $R$ starting at $a_{0}$ reaches a branch point $e g$. W e denote the solution from $a_{0}$ to $e g$ by $a^{(1)}()$. The rem aining part is called $a^{(2)}()$. B oth $a^{(1)}()$ and $a^{(2)}()$ are absorbed into the branch pointge, which indicates the fact that $g$ gives a $m$ in im um distance from the origin. If a tuming point corresponds to a $m$ axim um distance, the two solutions $w$ illescape from the branch point.
B.Exam ple \{ the 2D classicalXY m odel

Here we exhibit the new RGE for the 2D classicalXY m odel as an ilhustrative exam ple. The originalRGE for the XY m odel is given by [10 $\left.{ }^{1} \mathbf{1}^{\prime}\right]$

 points are denoted by the black circles. The new RGE is not de ned at the white circles which correspond to a xed line or tuming points in F ig ${ }^{1} \mathrm{~T}$ (a).

Therge (1-1) has tw o straight ow lines $g_{1} \quad g_{2}=0$ and one xed line $g_{2}=0$. It is well know $n$ that each point on the xed line corresponds to the theory of a 2D massless free boson that is param etrized by a com pacti cation radius of the boson eld $\left.\mathbb{R}^{\prime}\right]$. The shaded region in $F$ ig ${ }^{\prime}$ In (a) is a massless phase since ow in this region is nally absorbed into a point on the $g_{2}=0$ xed line. The incom ing straight ow line, $g_{1} g_{2}=0 \mathrm{w}$ ith $g_{2} \quad 0$ form s the phase boundary. As an initial coupling approaches the phase boundary from the $m$ assive phase, the correlation length becom es divergent

N ow wetum to the new RGE for the XY m odel, which is given by eqs. $\left(\underline{1} \underline{1} \underline{1}_{1}^{\prime}\right)$ and $(1 \underline{1} \underline{1})$ w th the condition $a_{1}^{2}+a_{2}^{2}=a_{0}^{2}$ ( $a_{2} 0$ ). It is explicitly represented as

Evaluating $\mathrm{V}(a)$ a at those points, it tums out that $\left(a={ }^{\mathrm{P}} \overline{2} ; \mathrm{a}_{0}=\bar{p} \overline{2}\right)$ is on an incom ing straight ow line while ( $a_{0}=\overline{2} ; a_{0}=\overline{2}$ ) on an outgoing straight ow line. The rem aining points $\left(a_{0} ; 0\right)$ are found to be on a xed line. N ote that $V(a) \quad 0$ and $V(a) \quad a=0$ when $a=(0 ; a)$. This $m$ eans that $\left(0 ; a_{0}\right)$ corresponds to tuming points on tra jectories generated by the originalRGE.The ow of the new RGE cannot be de ned at the points $\left(0 ; a_{0}\right)$ and ( $\left.a_{0} ; 0\right)$. Since the exam ple is a sim ple two-param eter system, we can understand qualitative aspects of the global ow in the new RGE. See Fig $\underline{W}_{1}^{\prime}(\mathrm{b})$.

In the last part of the next section, we will continue the analysis of this $m$ odel and derive from the beta function in eq. (19). Before perform ing that, we need to know a representation of the correlation length in term s of the new RGE.

## III. CRITICALEXPONENT OF THECORRELATION LENGTH IN A M ASSIVE PHASE

In this section, we explain how to evaluate the criticalexponent of the correlation length in a $m$ assive phase from the beta function ( $\left.\overline{1} \mathbf{D}_{1}^{\prime}\right)$.
$W$ e rst de ne a correlation length $\left(a_{0}\right)$ by the follow ing form ula:

N am ely, $\log \left(a_{0}\right)$ is the tim $\mathrm{e} g\left(t ; a_{0}\right)$ spent in the perturbative region. $W$ e note that $\left(a_{0}\right)$ de ned above changes as

under the original RG transform ation, which should be satis ed by an intrinsic length scale of the $m$ odel. The di erential form of this equation is obtained by eq.( $\overline{(2)}$ )

which is well-known as an equation for an invariant length scale ( g ). Further, eq. $\overline{4}\left(2 \frac{2}{4}\right)$ is a natural generalization of the correlation length used in the 2D classicalX Y m odel.

W e consider the case where the running coupling constants are in the perturbative region $\dot{j}\left(t_{;} a_{0}\right) j<1$. In this section, we study in particular the long-tim e asym ptotics of a ow that once approaches the origin and then leaves for the non-perturbative region $\dot{j}\left(t_{i} a_{0}\right) j \quad 1$, as the ow in the region $g_{2} \quad \dot{g}_{1} j$ in the $X Y \mathrm{~m}$ odel. $G$ enerally, a quadratic di erentialequation such as eq. (2) adm its a ow qualitatively di erent from that investigated here. In section $\overline{\mathrm{V}} \overline{\mathrm{I}}$, we discuss such an exceptional case.

if in eq. (1- 1 apparent as discussed in the previous section. "In '1 The rst term in the righthand side of eq. (25.') diverges due to e in the integrand when goes to in nity. The second tem contributes to the correlation length w th the sam e order as the rst term. Hence, we can evaluate ( $a_{0}$ ) by eq. (2G), which translates singular behavior of ( $a_{0}$ ) into that of .
Next, we evaluate the divergent by using the polar-coordinate expression eq. (11 $1 \mathbf{1}$ ) of the new RGE. It is obvious that diverges if the initial coupling constant $a_{0}$ is on an incom ing straight ow line. It im plies that grow swhen a ( ) passes near a xed point a on the incom ing straight ow line.

So far, we have studied solutions of RGE (2, in a m assive phase. O ur m ethod is also applicable to studying asym ptotic behavior of a solution in a $m$ assless phase. In this section, we study the logarithm ic dependence of the m ultiple running coupling constants in a m assless phase.

It is im portant to clarify nite-size corrections in a system with marginally irrelevant operators. For exam ple, a num erical sim ulation in a spin system can calculate energy levels only for sm all degrees of freedom. A theoretical form ula for the nite-size correction is useful to extrapolate num erical data to those in the in nite system. If the system can be described in a critical theory with marginally irrelevant perturbations, physical quantities acquire logarithm ic nite-size corrections. Here we are interested in a system with a nite volum e $L^{D}$ described by a theory $w$ ith $m$ arginally irrelevant coupling constants $g$, where $D$ is the space dim ension. C onsider the situation where we have a critical theory $w$ ith $g=0$ which describes the system $w$ ith an in nite volume. In the system with a nite volum e $L^{D}$, we can calculate physical quantities $w$ ith a nite size correction in the critical theory $w$ ith a sm all perturbation of the coupling $g$ obeying RGE $(\underset{\sim}{(1)})$. If $w e$ have an in itial coupling $a_{0}$ at a lattice spacing 1 , the running coupling at the scale $L$ becom es $g\left(\log L ; a_{0}\right)$, where $g\left(1 ; a_{0}\right)=0$. In the case of a single $m$ arginally irrelevant coupling constant $g$, the original beta function is given by

H ence the $1=(\log L)^{2}$ contribution that belongs the next-to-leading term in $X\left(\log L ; a_{0}\right)$ gives sub-leading contribution. This im plies that, if we can determ ine $g^{3}$ term $s$ in the originalRGE (5\%), universallog $\log L=(\log L)^{2}$ dependences can be obtained in this exam ple. N am ely, they are classi ed into the tw ice unstable xed points $\mathrm{c}_{1} ; \mathrm{C}_{2} ; \mathrm{C}_{5}$, the onœ unstable xed points $\mathrm{C}_{3} ; \mathrm{c}$ and the stable xed point $c_{4}$. The critical exponents determ ined by the once unstable xed points $c_{3}$ and $c$ are respectively

which $m$ ust be observed $m$ ost likely in thism odel. In order to detect other exponents, ne tuning of the initialcoupling param eters to the tw ice unstable xed points is necessary as in the multi-criticalbehavior of ordinary second-order phase transitions.

Logarithm ic dependence of the running coupling constants is controlled by the stable xed point $c_{4}$. Since the largest eigenvalue at the xed point is less than 1 , the sub-leading contribution is $1=(\log L)^{2}$ in this case.

It is helpful to study the new RGE for eq. (67) num erically in order to better understand our results. F ig ' ${ }^{\prime}$ G exhibits the seven xed points $\mathrm{C}_{1}$; ; in polar coordinates

$T$ he destination of a tra jectory, tow ard the outside of this region is a point on the curve a $V(a)=0$. This implies that a ow of the originalRGE (671) corresponding to this ow on $S$ approaches the origin once and escapes from it. N am ely, those points belong to a m assive phase. On the other hand, a ow that term inates at the stable xed point $\mathrm{C}_{4}$ corresponds to a ow of the originalRGE absorbed into the origin along the incom ing straight ow line. The set of those points $m$ oving tow ard the xed point $c_{4}$ is in a $m$ assless phase.

In general, we have tw o cases corresponding to $m$ assive and $m$ assless phases described above. H ow ever, there are exceptional points which lie on the solutions starting at one of the tw ioe unstable xed points $\mathrm{c}_{1}, \mathrm{c}_{2}, \mathrm{C}_{5}$ and arriving at one of the once unstable xed points $\mathrm{C}_{3}, \mathrm{c}$. These exceptional solutions correspond to critical surfaces that give the phase boundary determ ined in the originalRGE.M ore precisely, the set of points on the exceptional tra jectories is the intersection betw een a phase boundary determ ined by the originalRGE and the sphere $S$. It should be noted that the phase boundary in the coupling space $f\left(g_{1} ; g_{2} ; g_{3}\right) g$ form $s$ a conical surface because $V(g)$ is hom ogeneous.

 consider divergent behavior of the correlation length. Suppose that an initial value $a_{0}$ changes tow ard the phase boundary betw een $c_{1}$ and $c_{2}$ such as the dashed line A. As $a_{0}$ tends to the phase boundary, the ow starting at $a_{0}$ passes near the xed point $C_{3}$ and spends a long tim e there. T he result eq. (6d) indicates that the criticalexponent detected in this case is $3 / 5$. Sim ilarly, if $a_{0}$ varies along lines such as B or C , one observes $=8=(4+\quad \overline{631})$ since the solution starting at $a_{0}$ goes through a neighborhood of the xed points $C_{+}$or $c$.

Finally, we com $m$ ent on the logarithm ic dependence of the coupling constants in this exam ple. Fighill im plies that a generalm assless ow is controlled by the tw ice stable xed point $c_{4}$. The universal features considered in sec' $\overline{1} \overline{\mathrm{~V}} \mathrm{~N}_{1}$ are valid if the in itial value $a_{0}$ is su ciently far from the phase boundary. H ow ever, as a opproaches the phase boundary from a m assless side, the solution is gradually a ected by the once unstable xed points. M ore profound investigation w ill be needed in this case.

## VI.SUMMARYAND D ISCUSSION

In this paper, we rst showed an algebraic way of nding the critical exponent in eq. (1, إ. ), which was so far com puted by integrating RGE explicitly. T he procedure is sum $m$ arized as follow s:

(ii) $F$ ind straight ow lines in the originalRGE, which correspond to xed points of the new RGE.
(iii) C om pute the scaling $m$ atrix at a xed point on an incom ing straight ow line and diagonalize it.
(iv) If the scaling $m$ atrix has the unique relevant $m$ ode, the correlation length indicates singular behavior by oneparam eter ne tuning and the exponent is equal to the inverse of the relevant eigenvalue. If the scaling $m$ atrix has m ultiple relevant m odes, we can observe m ulticriticalbehavior.

Second, we derived the logarithm ic dependence of running coupling constants in a m assless phase where all the coupling constants are m arginally irrelevant. It w as found that the coe cient of the leading log term is universalin the sense that it does not depend on an in itial value of the running coupling constants, which is the sam e result as in the case of a single $m$ arginally irrelevant coupling constant. H ow ever, coe cients of subleading term $s$ are non-universal. They could disturb the universalnature of subleading term $s$ which com efrom higher-loop corrections to the original beta function.

W e obtain both results by applying the RG transform ation $\overline{-1})$ to the original RGE $\overline{(2)}$ ), which was m otivated by the recent developm ents of RG transform ations to non-linear di erential equations [idin $\left\{\frac{1}{1}\right]_{1}^{-1}$.

It should be noted that our study is focused when we derive the rst result on $\bar{a}$ ow that goes onge tow ard the origin and then leaves for a non-pertunbative region. In general, the quadratic di erential equation (2,') w ith eq. (3, $\mathbf{N}^{\prime}$ ) could have a ow qualitatively di erent from those we considered. For exam ple, we num erically nd that the equation

N am ely, the equation has solutions that rst escape from the origin and then tum back to it. In this case we cannot directly apply the result eq. (32'). E ven in that case, as we show in the follow ing, the beta function in eq. (1] ${ }^{(1)}$ ) is helpful for understanding a qualitative picture of these solutions. In fact, we rst notioe that there are only four straight ow lines on $g_{1}=0$ or on $g_{2}=0$. Next let us com pute the scaling $m$ atrix in eq. (2d) at the xed points ( $a_{0} ; 0$ ) and ( 0 ; $a_{0}$ ) of the new RGE ( $10_{1}^{\prime}$ ). We nd that it has eigenvalues $1 q$ at ( $a_{0} ; 0$ ) and 0 at ( $0 ; a_{0}$ ). If $q>1$, solutions for the RGE near ( $a_{0} ; 0$ ) is absorbed into the xed points. The integral curve does not change the direction at the other xed points $\left(0 ; a_{0}\right)$ because the eigenvalue of the scaling $m$ atrix vanishes at those points. T herefore, by continuity, we conclude that there $m$ ust be at least tw o branch points on $S$.

The study of the universality classi cation of in nite-order phase transitions is now in progress. In two dim ensions, it should contribute to the analysis of the c>1CFT. In higher than two dim ensions, a nontrivial exponent in an
in nite-order phase transition $m$ ight be observed experim entally in som e phenom ena.
